(57) **CLAIM**

The ornamental design for a bumper surface, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated front right perspective view of a bumper surface showing our new design, the broken line showing being for illustrative purposes only, and forms no part of the claimed design.

FIG. 2 is an elevated front right perspective view of the bumper surface design of FIG. 1.

FIG. 3 is a plan view of the bumper surface design of FIG. 1.

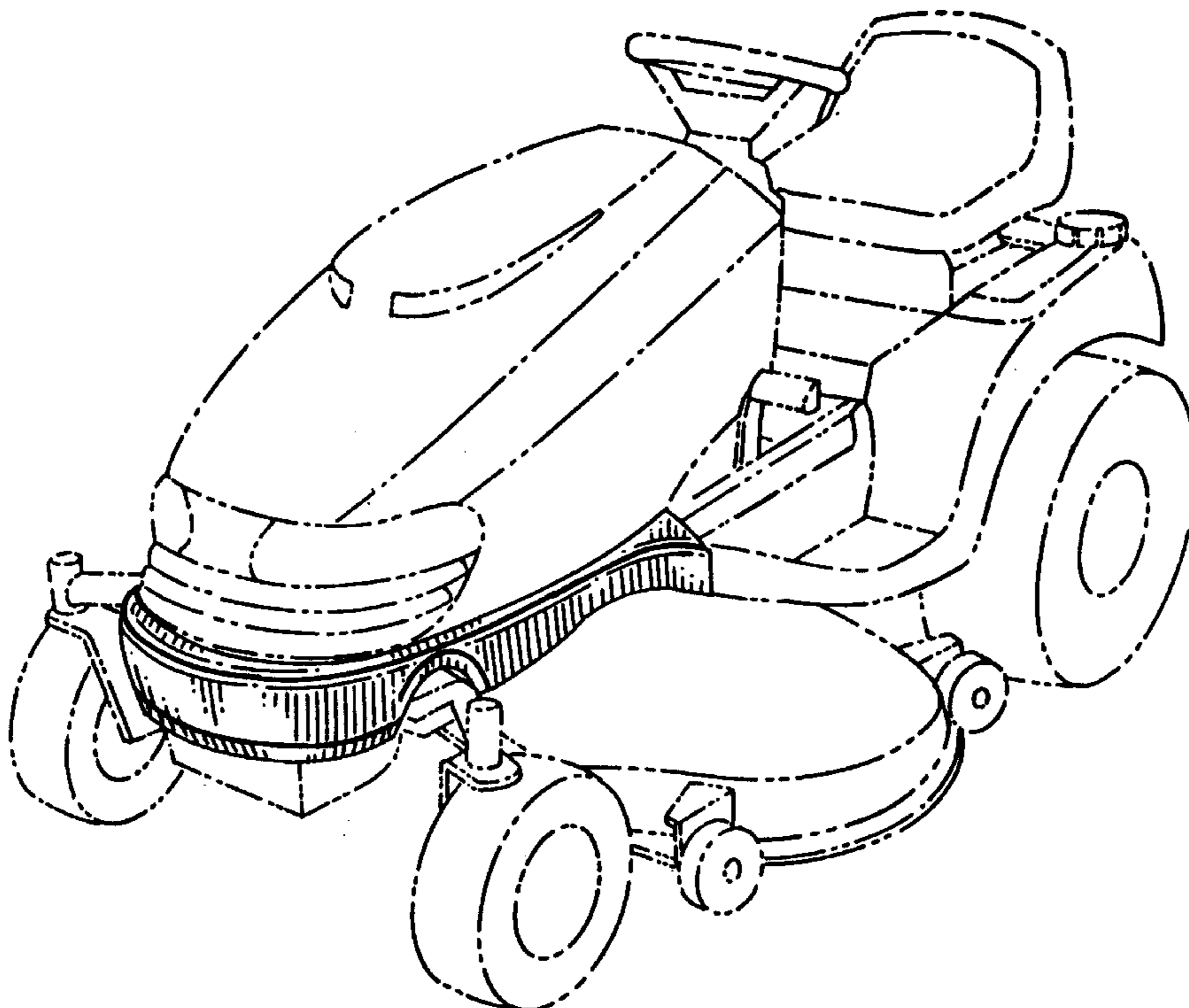
FIG. 4 is a bottom view of the bumper surface design of FIG. 1.

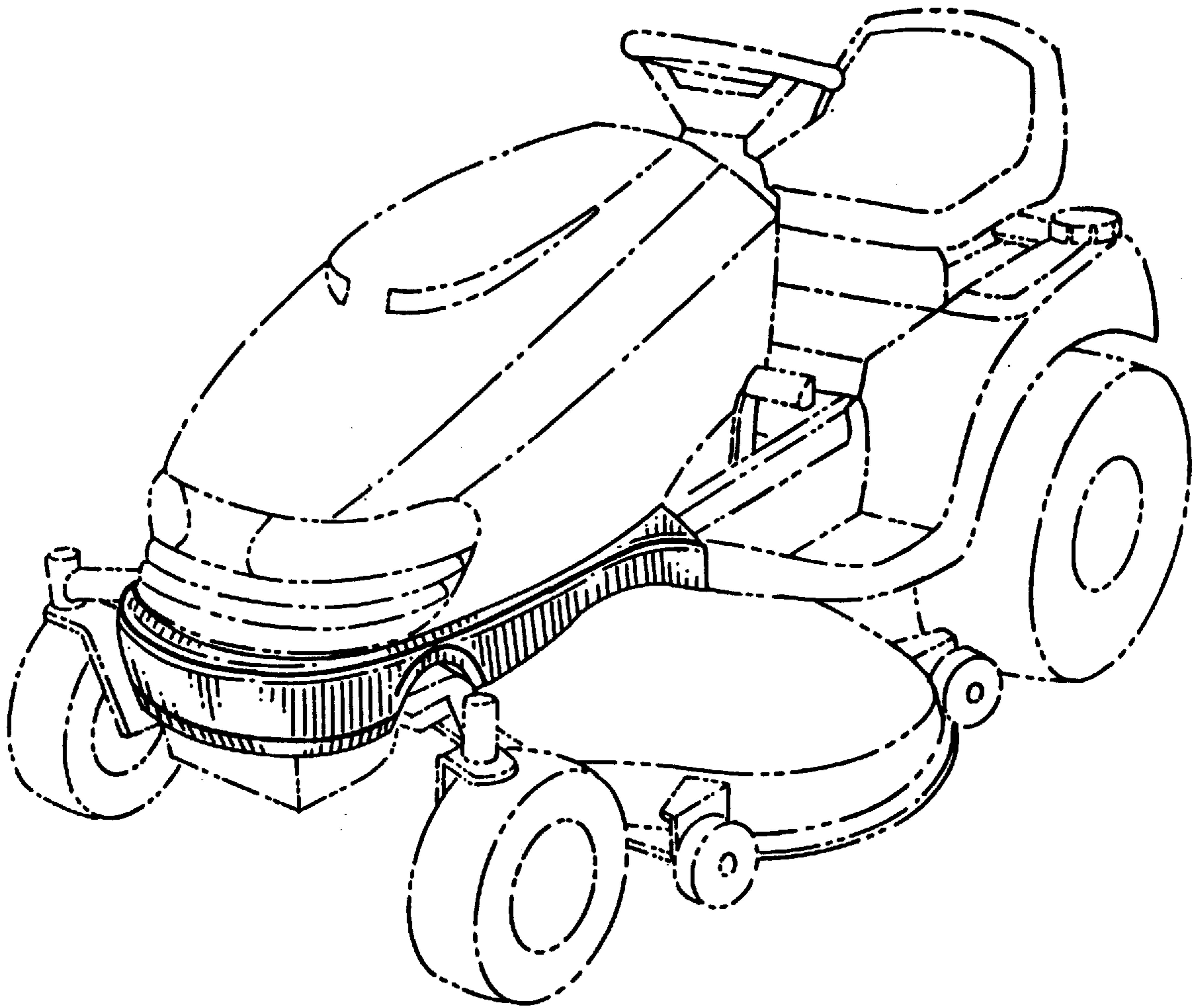
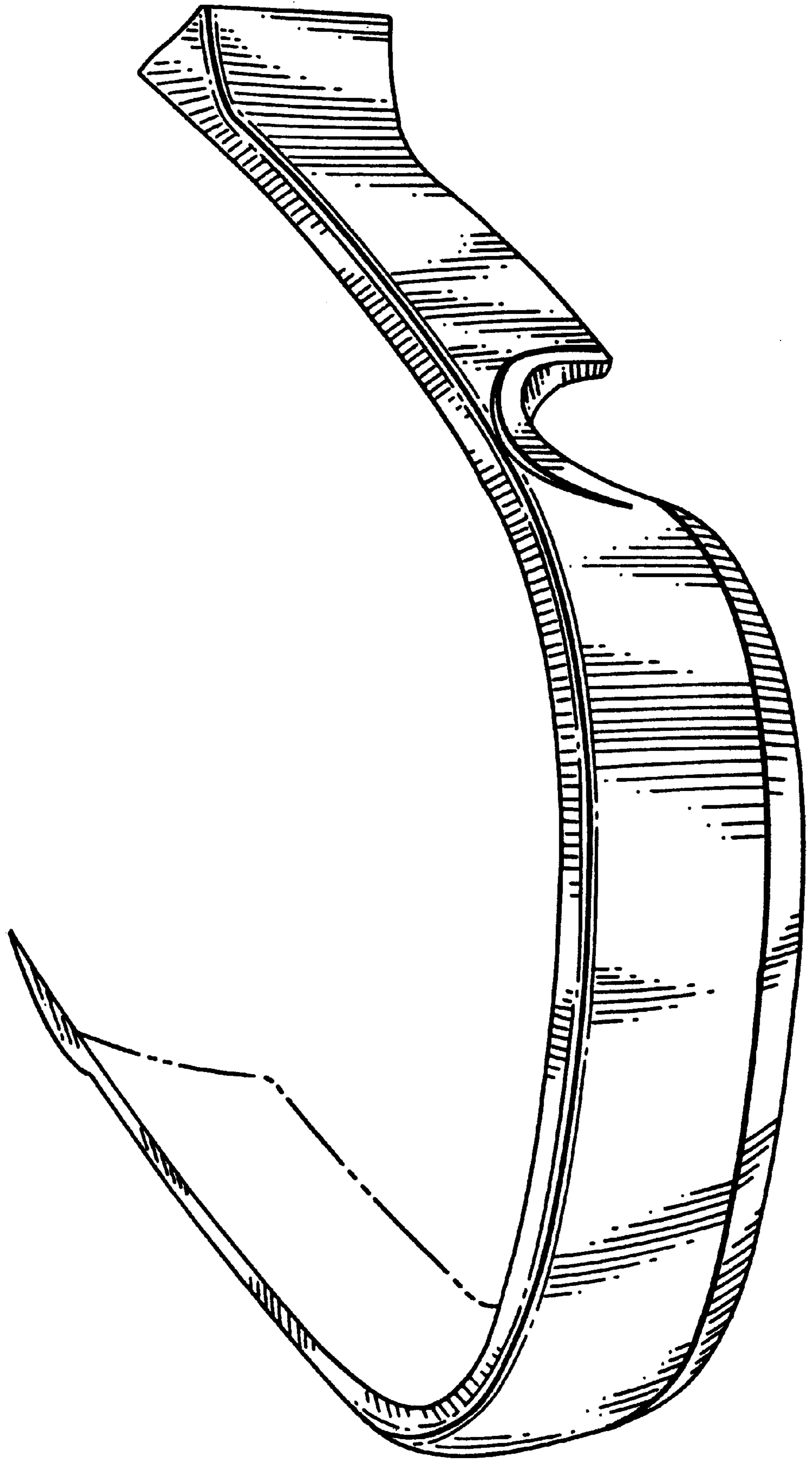

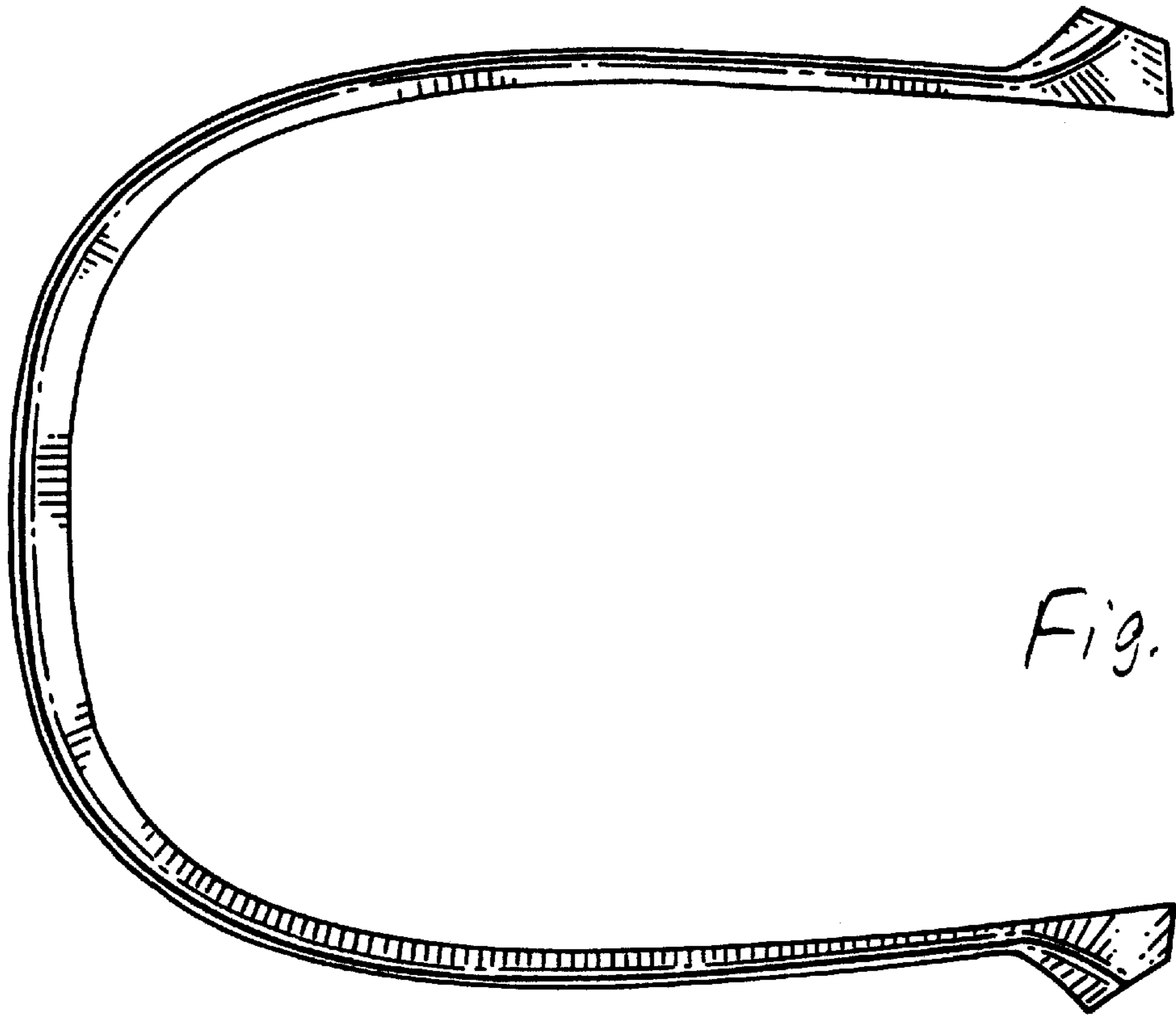

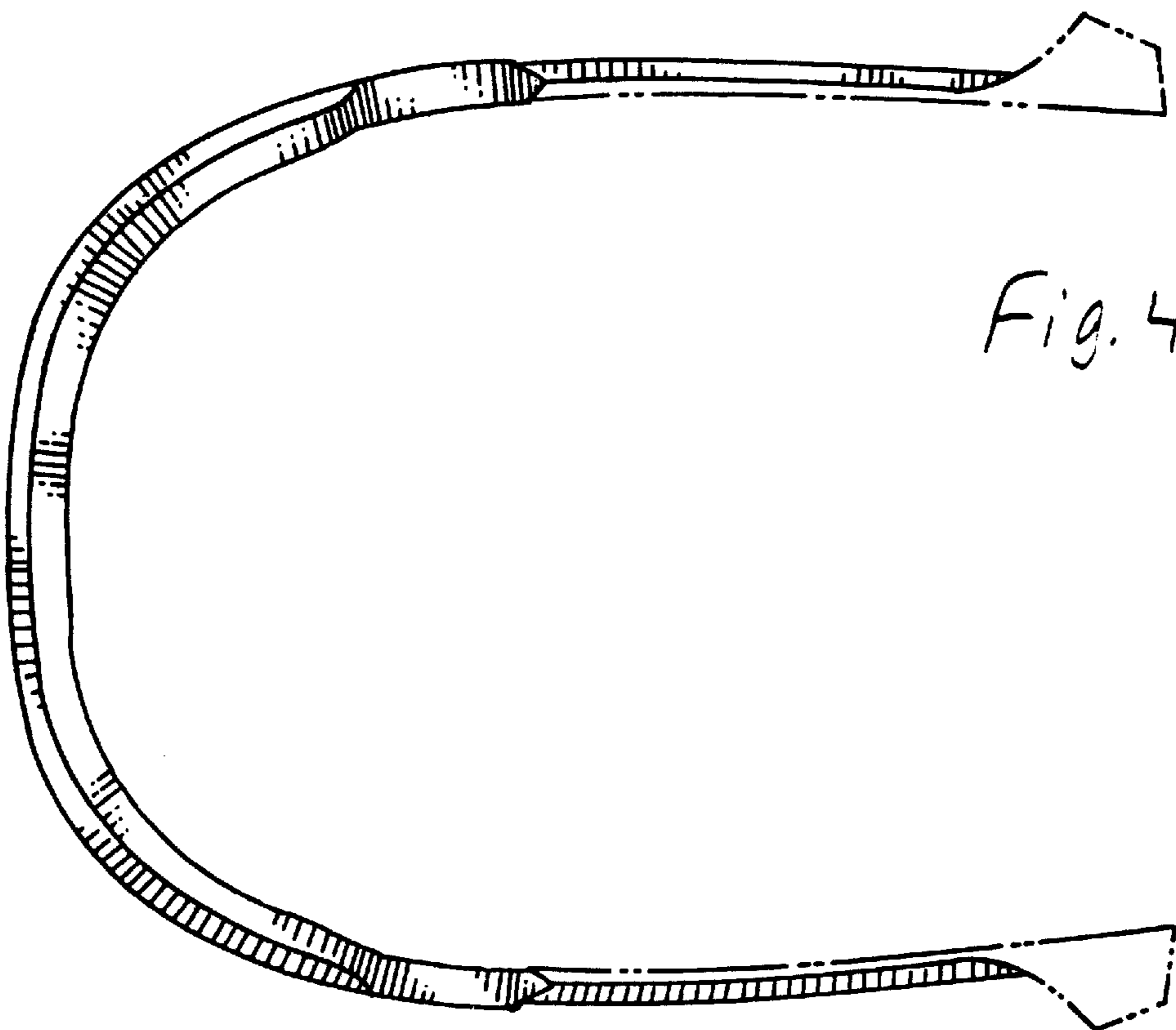

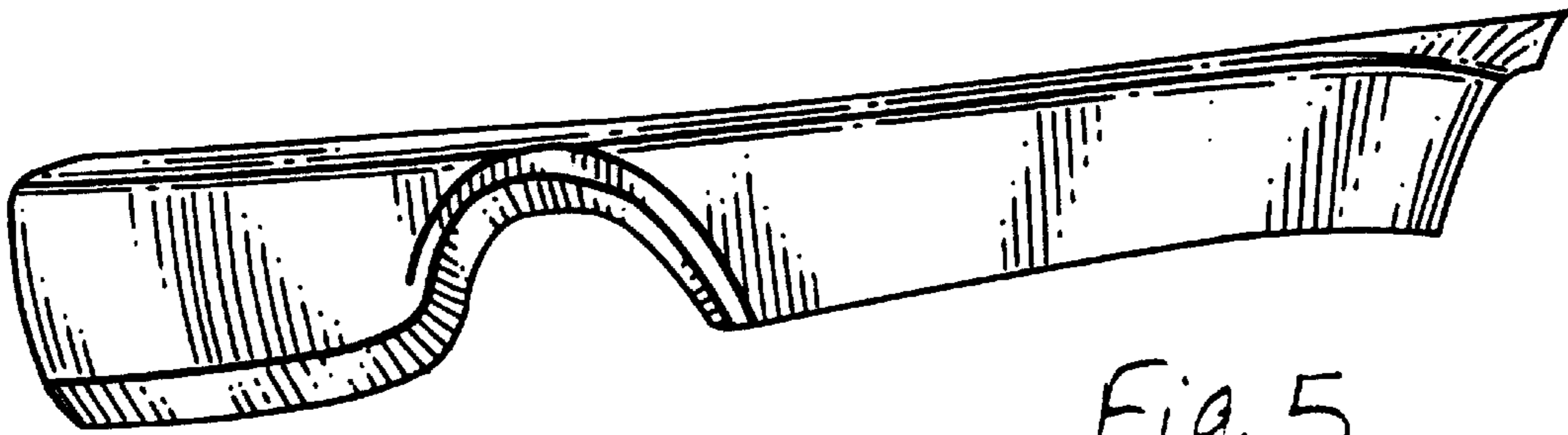

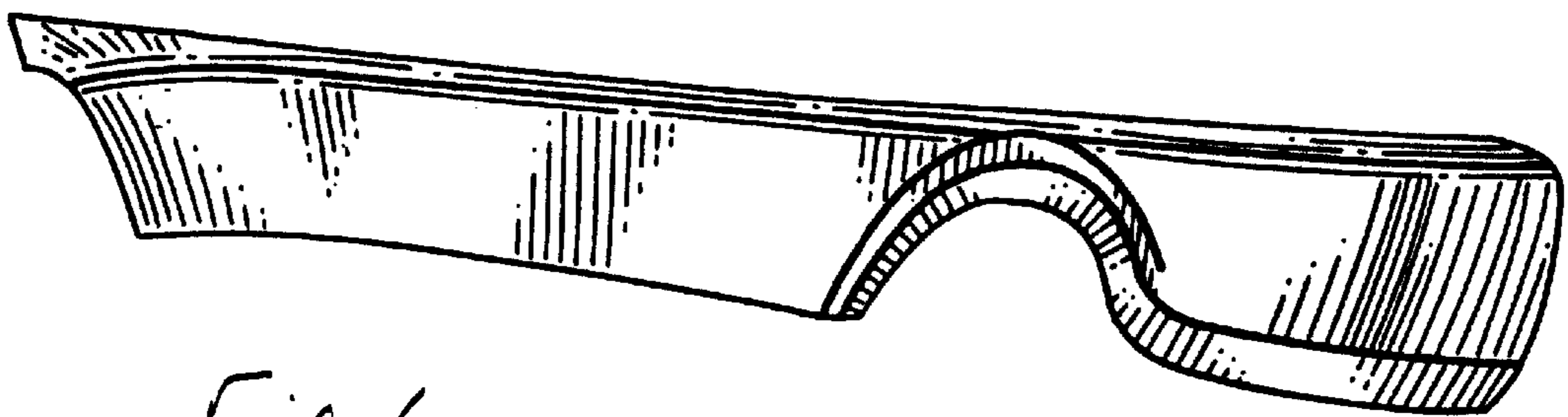

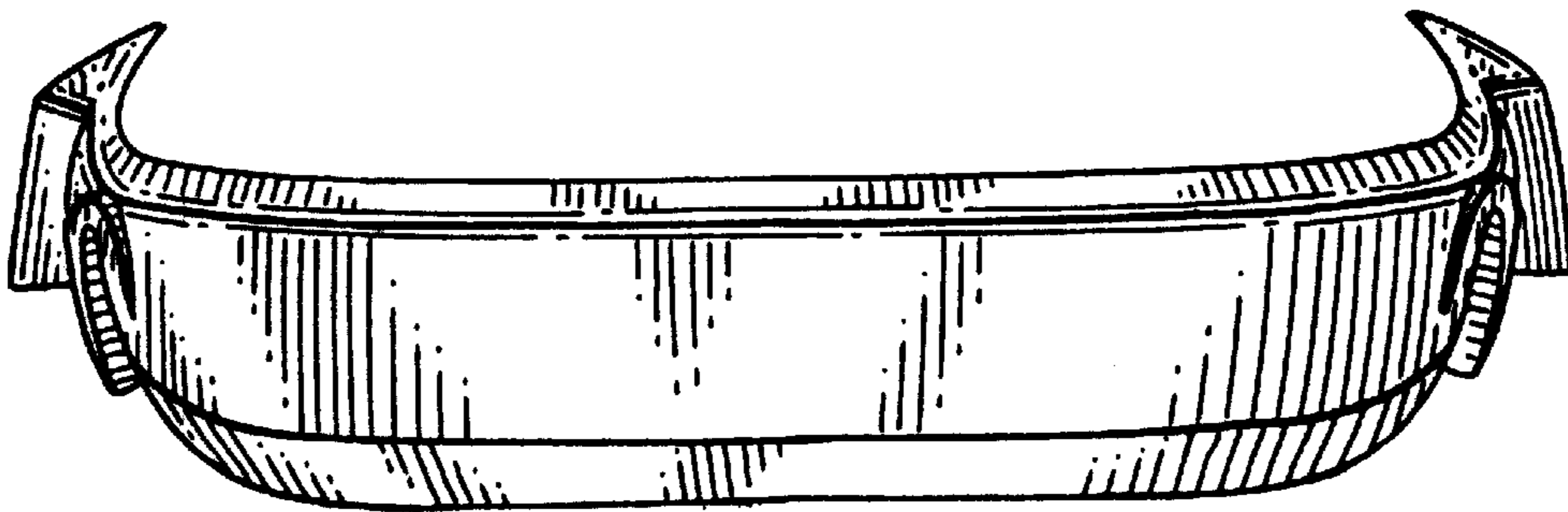
