FIG. 2 is a front elevational view thereof;

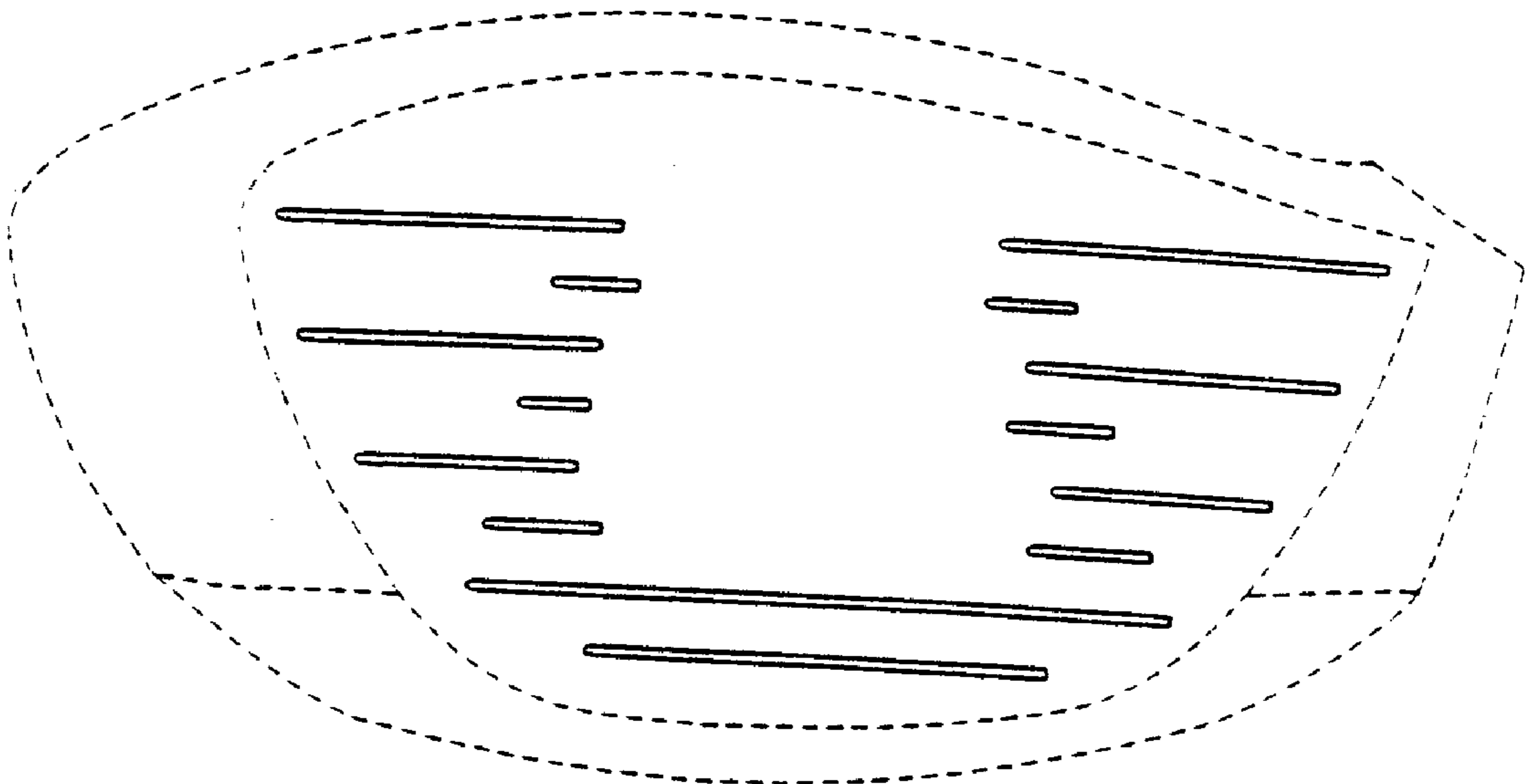
FIG. 3 is a top plan view thereof;

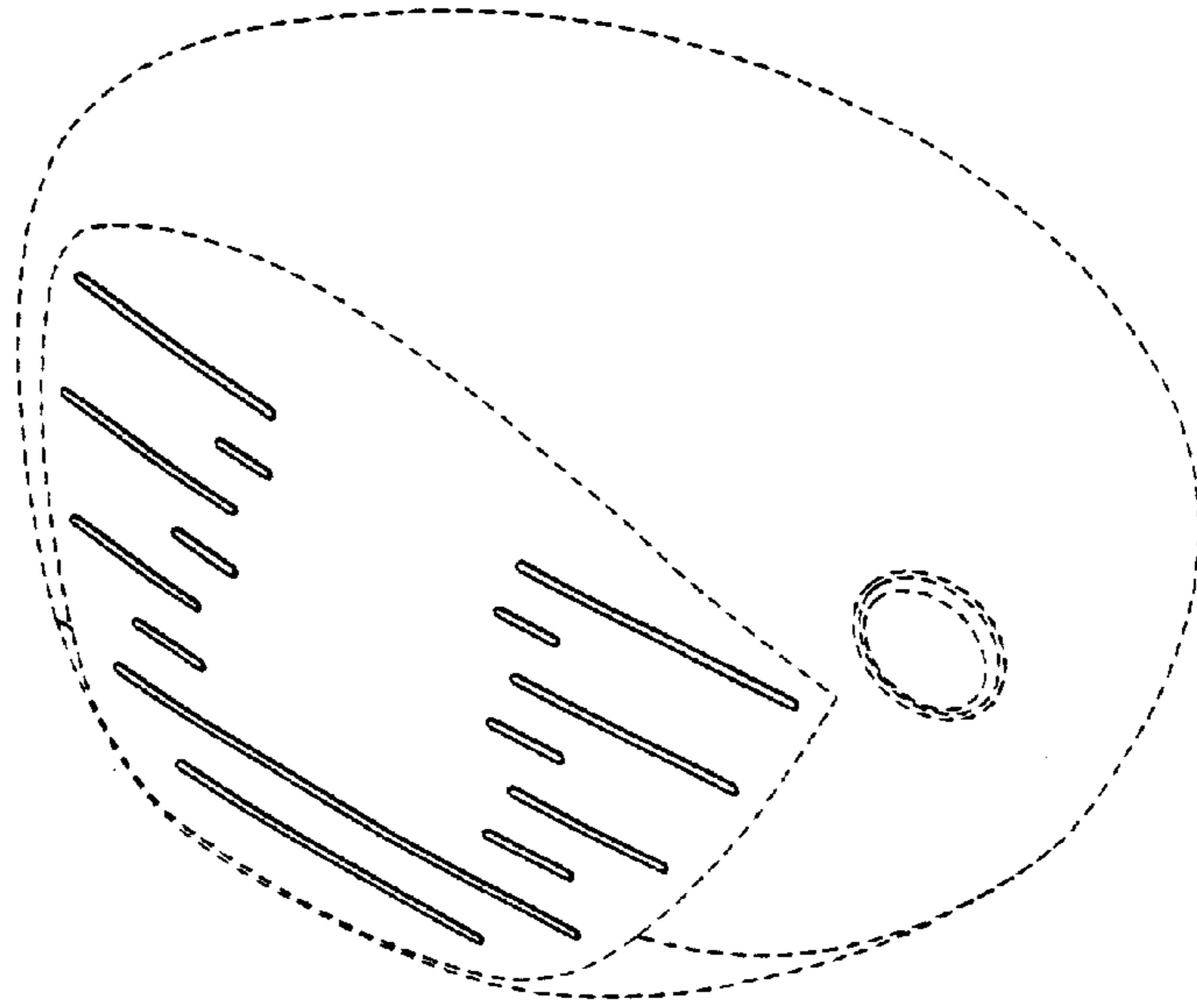
FIG. 4 is a toe end view thereof;

FIG. 5 is a heel end view thereof.

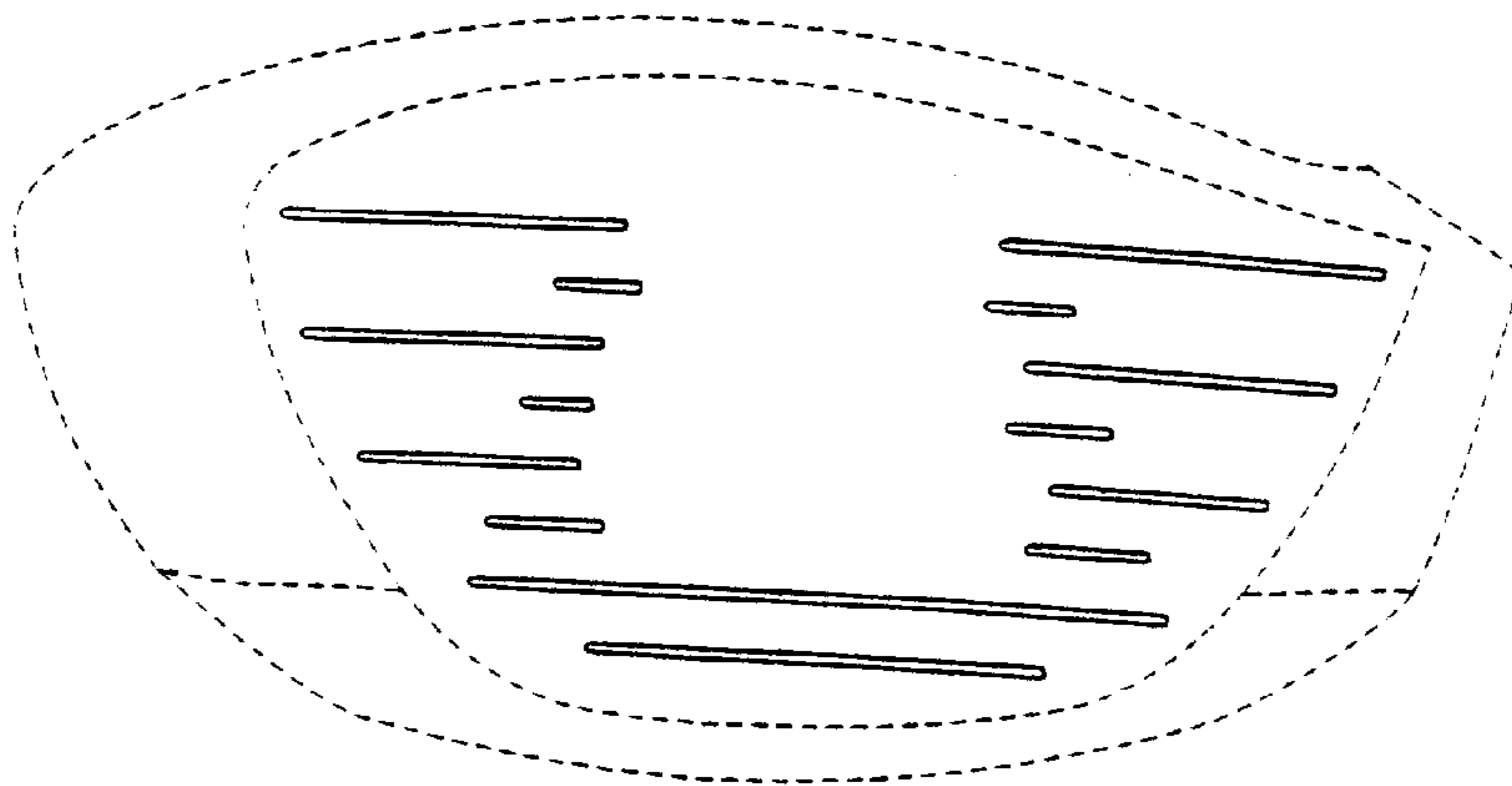

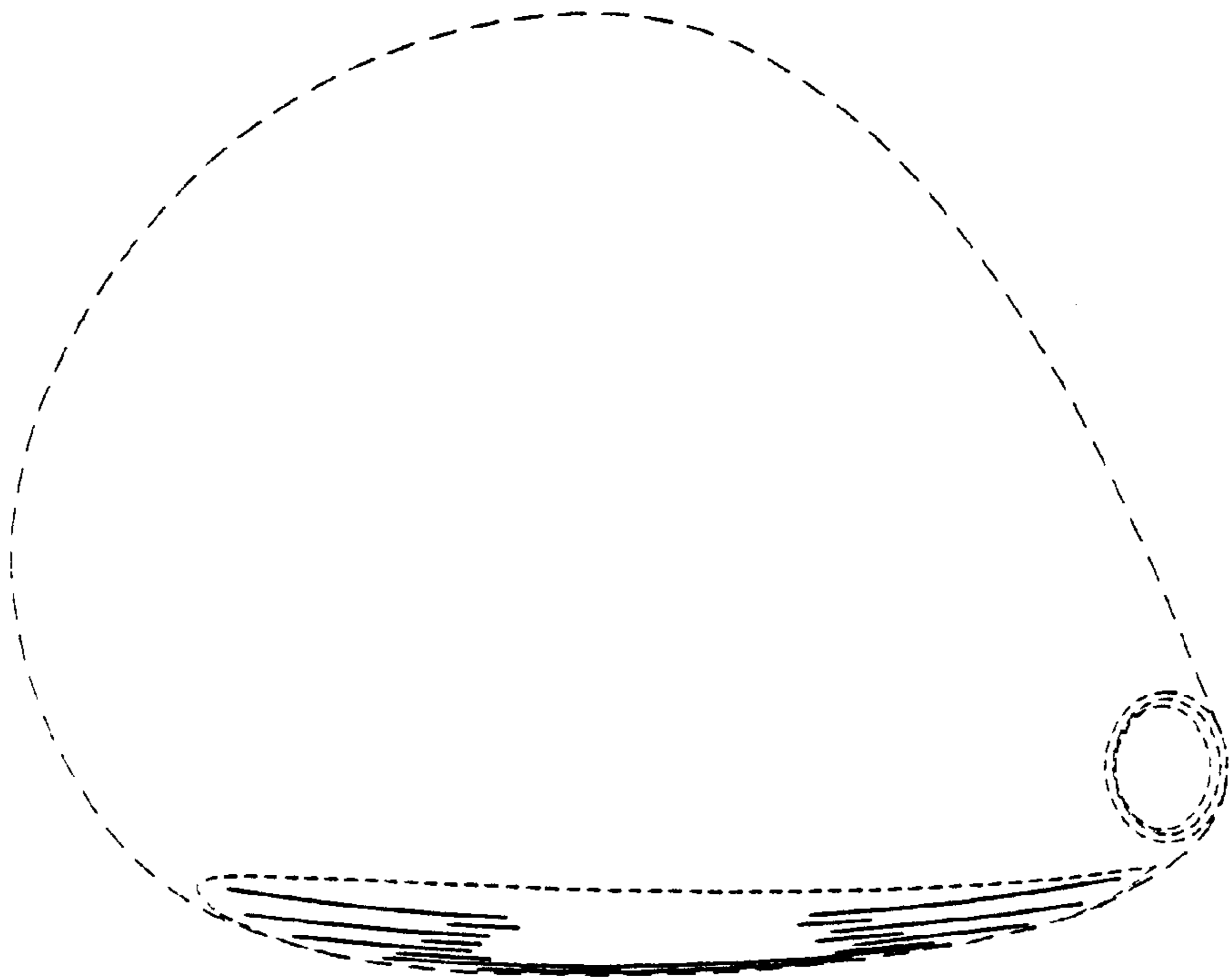




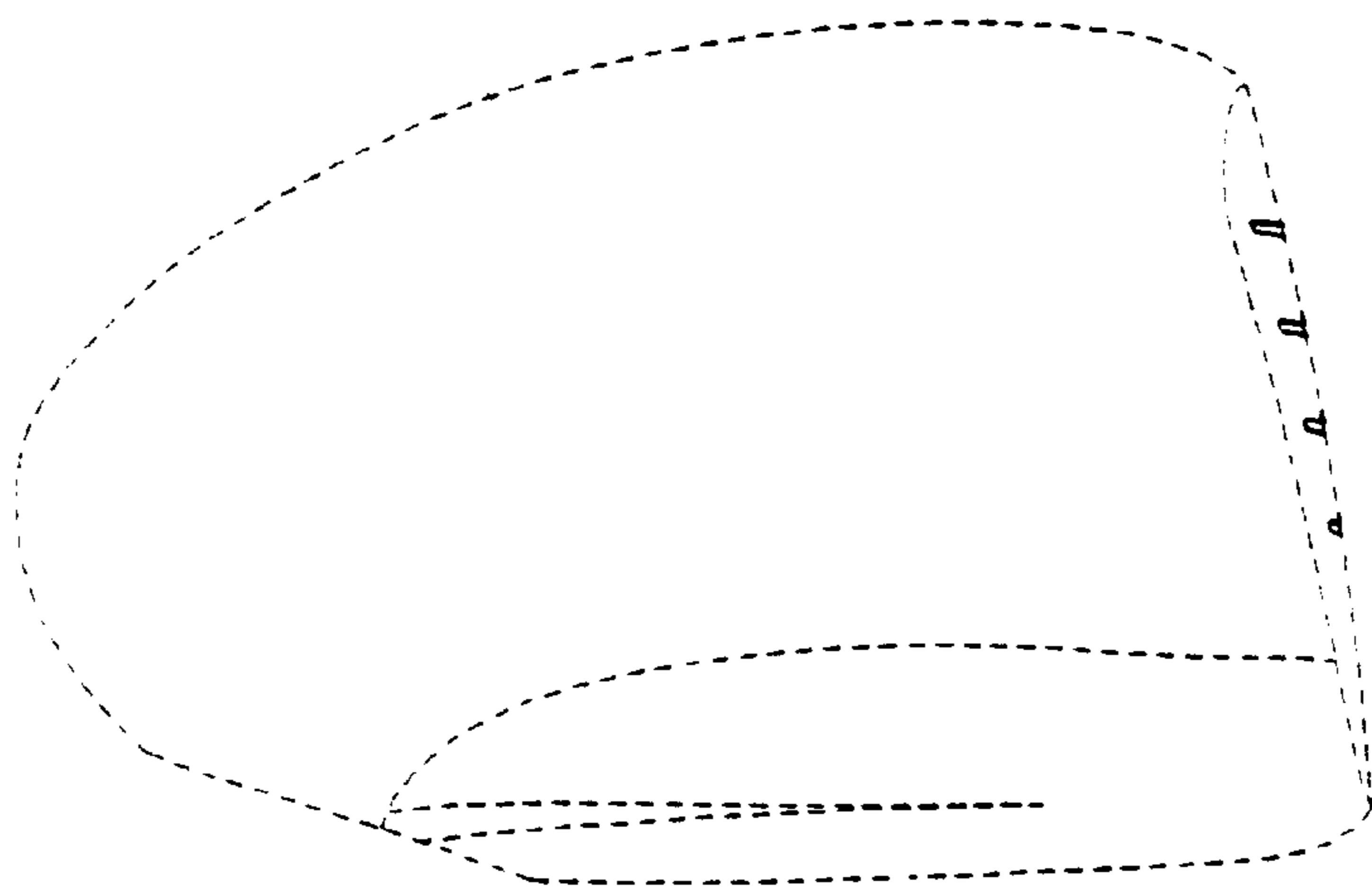

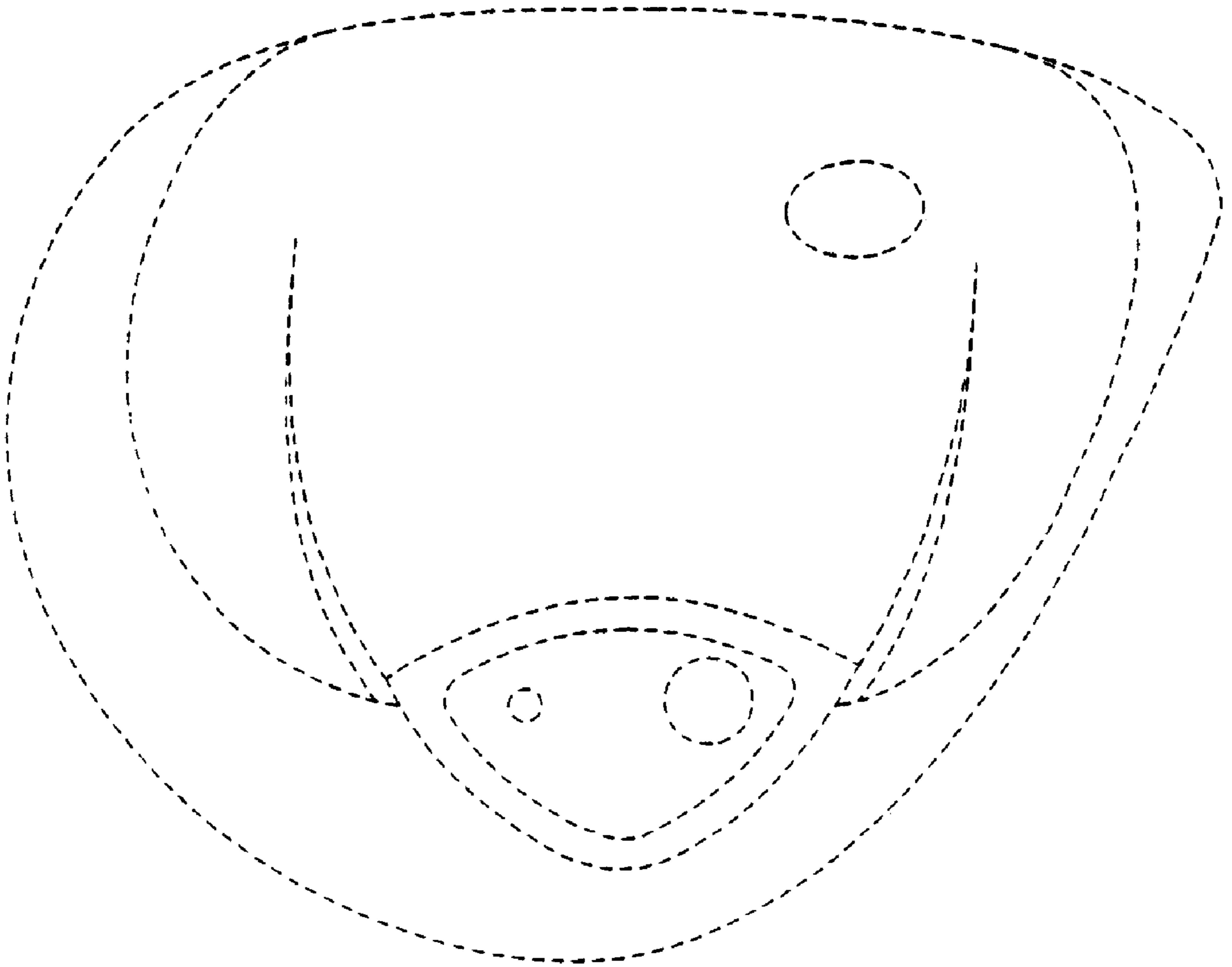
