The ornamental design for a helmet, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a helmet showing our new design;

FIG. 14 is a bottom plan view of FIG. 10;

FIG. 15 is an isometric view of a fourth embodiment thereof;

FIG. 16 is a right side view of FIG. 15;

FIG. 17 is a front end view of FIG. 15;

FIG. 18 is a rear end view of FIG. 15;

FIG. 19 is a top plan view of FIG. 15;

FIG. 20 is a bottom plan view of FIG. 15;

FIG. 21 is an isometric view of a fifth embodiment thereof;

FIG. 22 is a right side view of FIG. 21;

FIG. 23 is a front end view of FIG. 21;

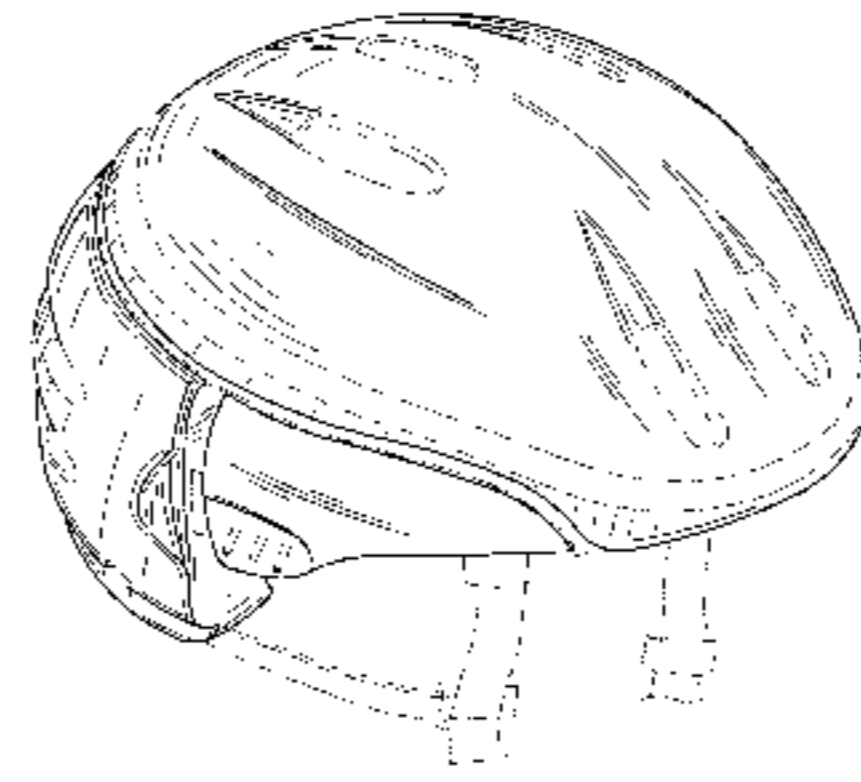
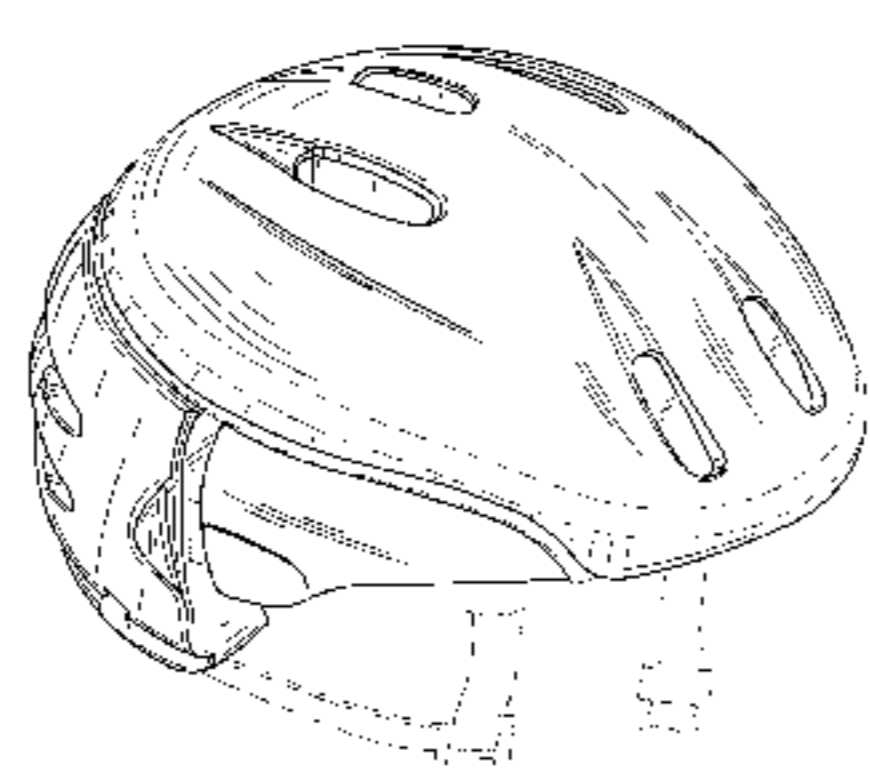
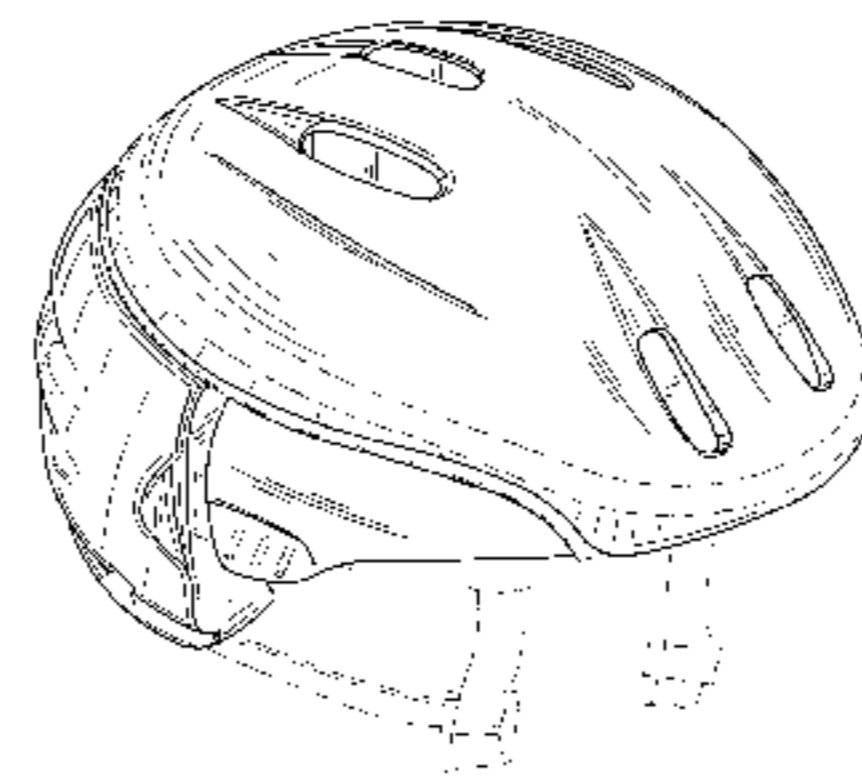
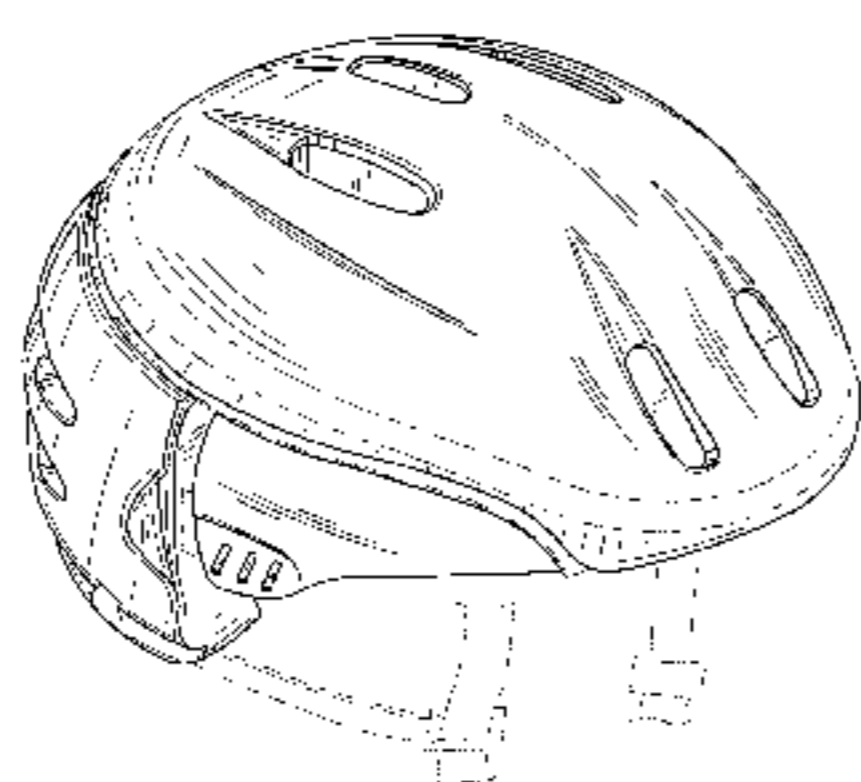
FIG. 24 is a rear end view of FIG. 21; and,

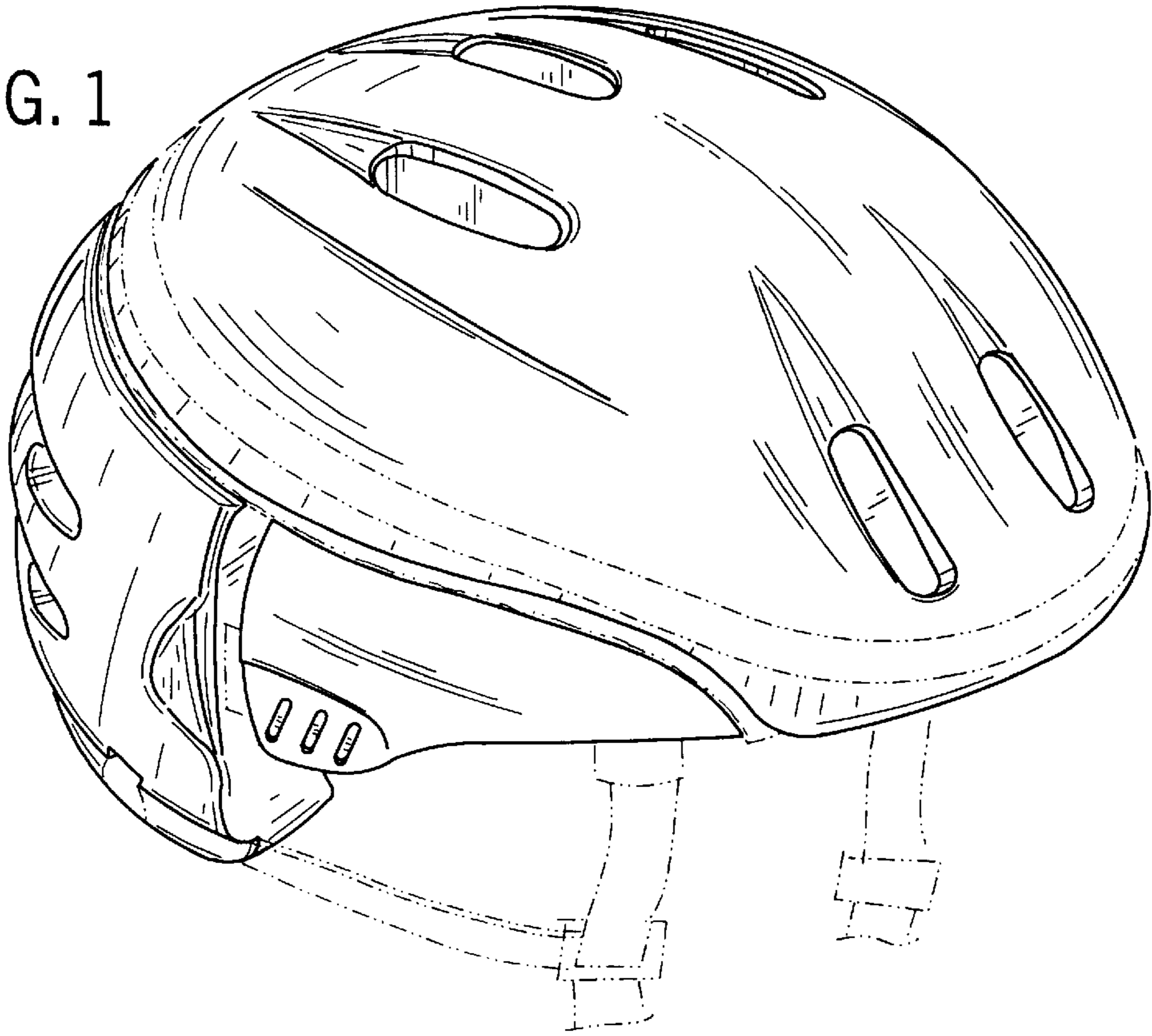

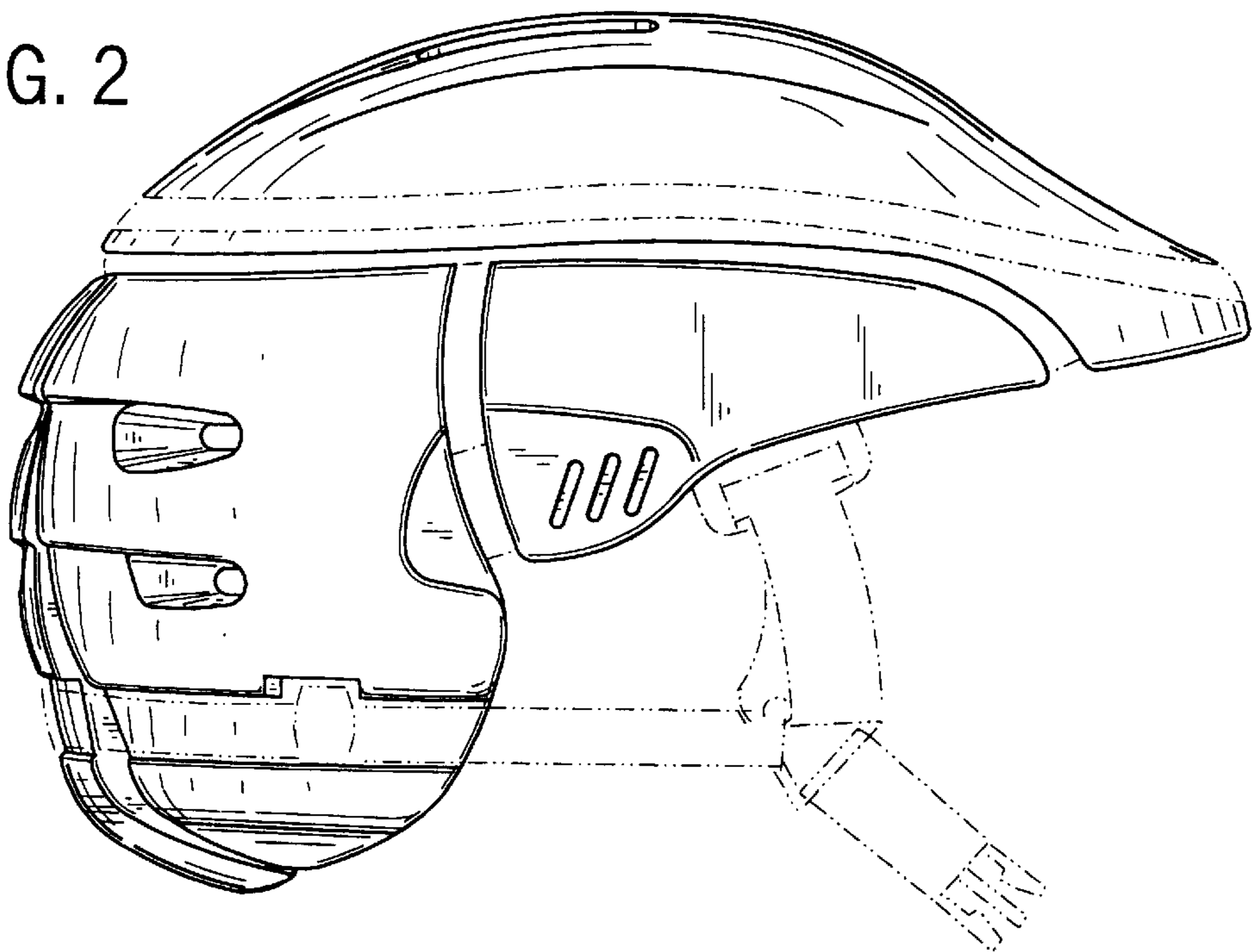

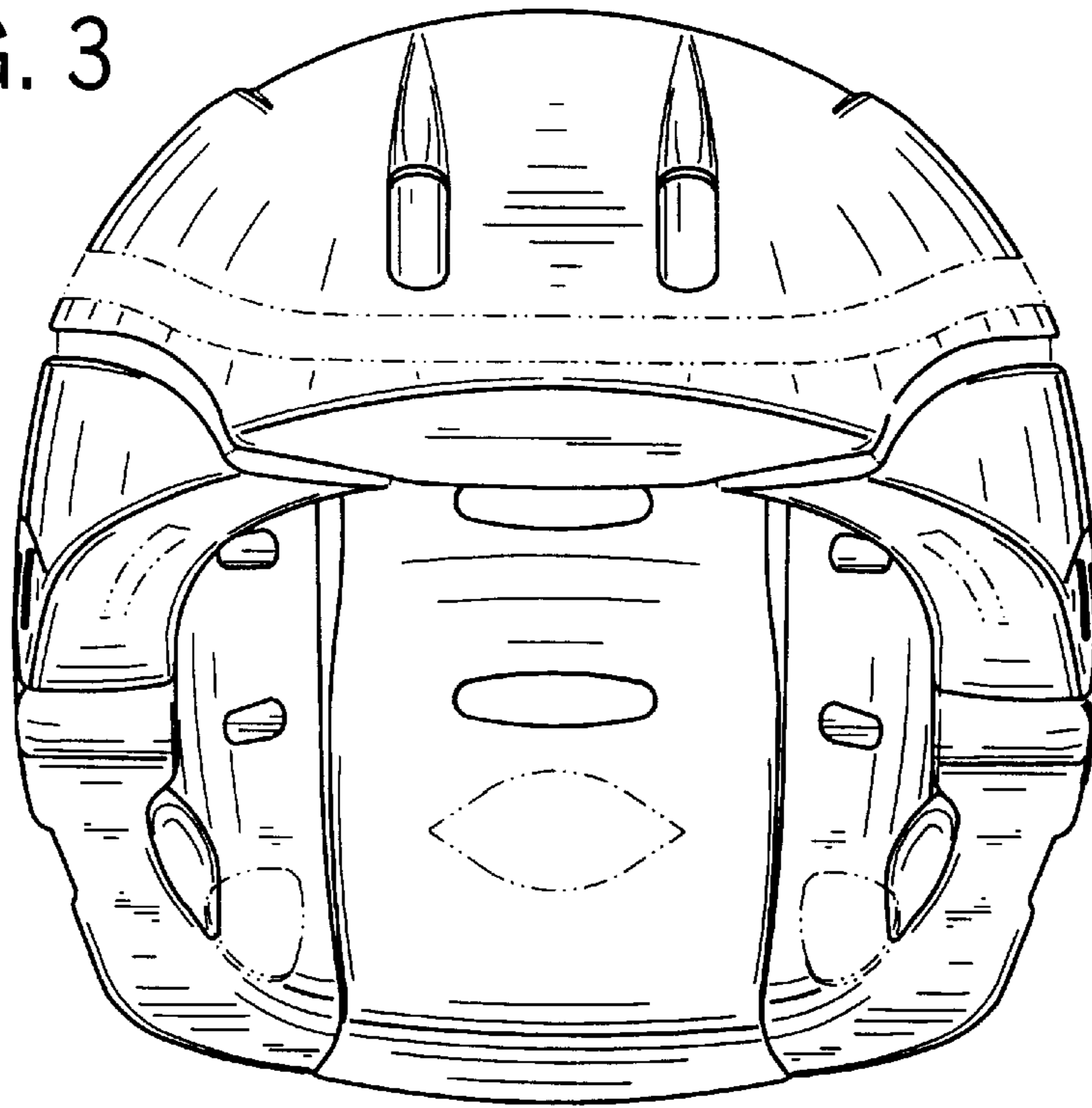

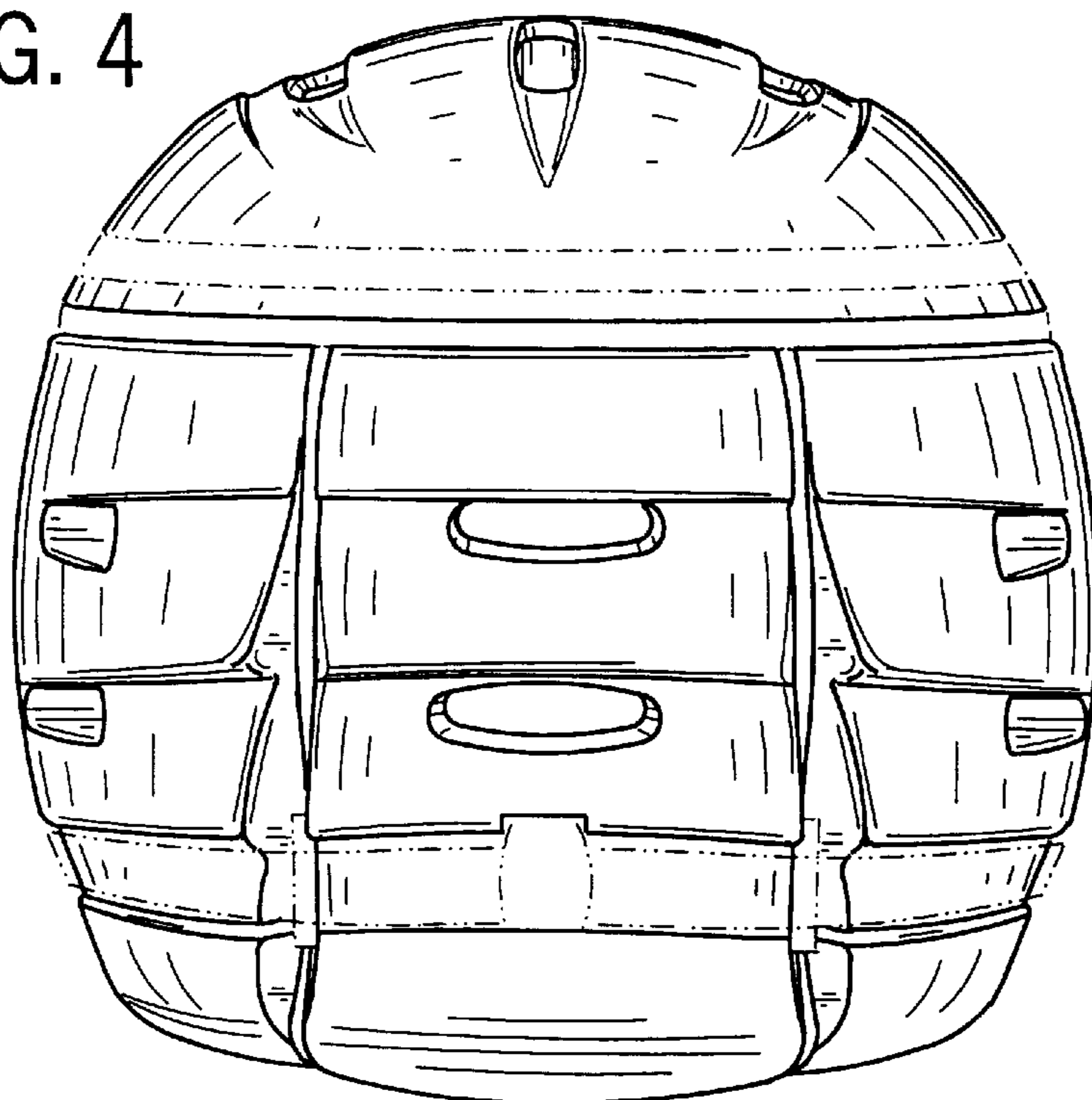

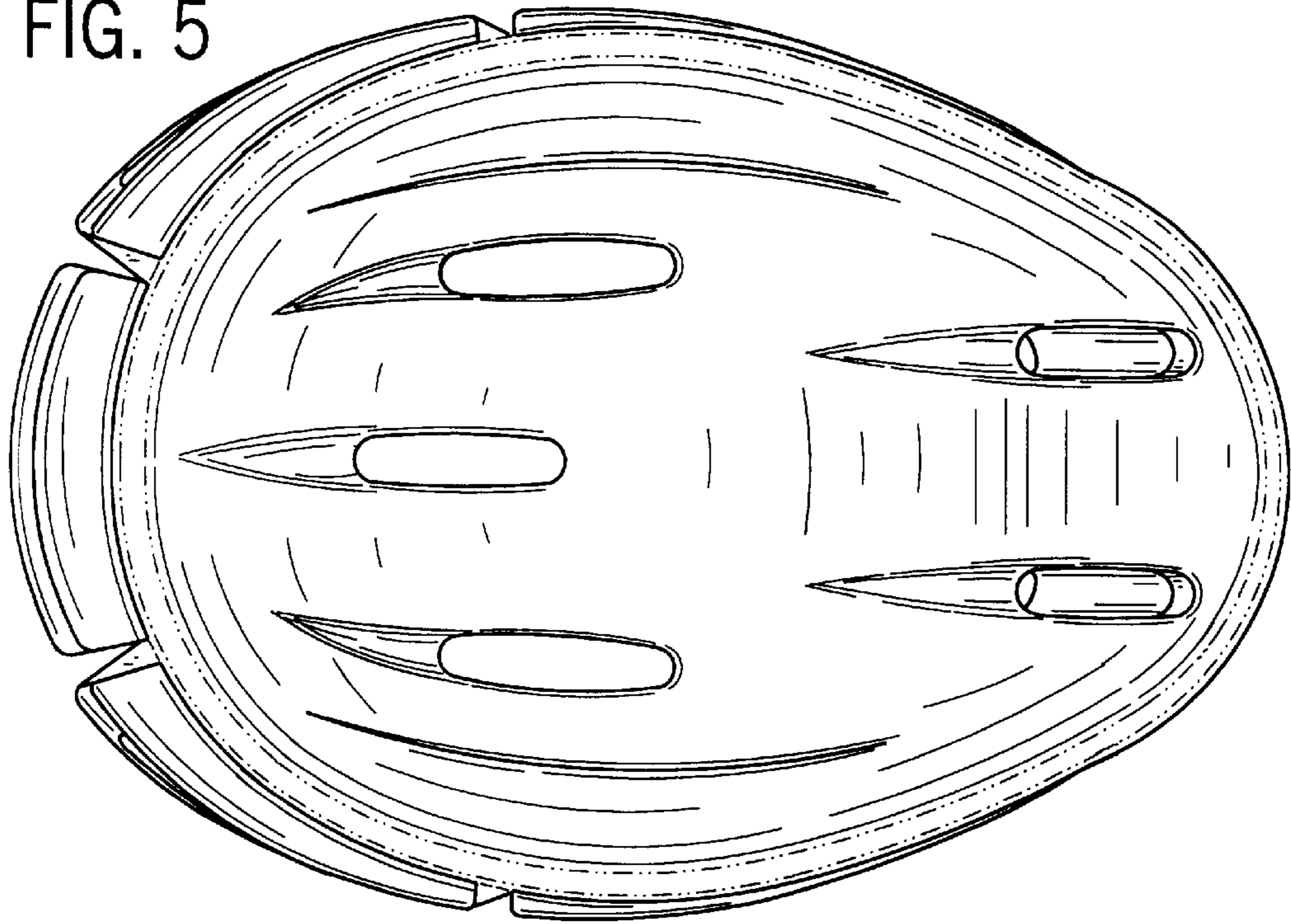

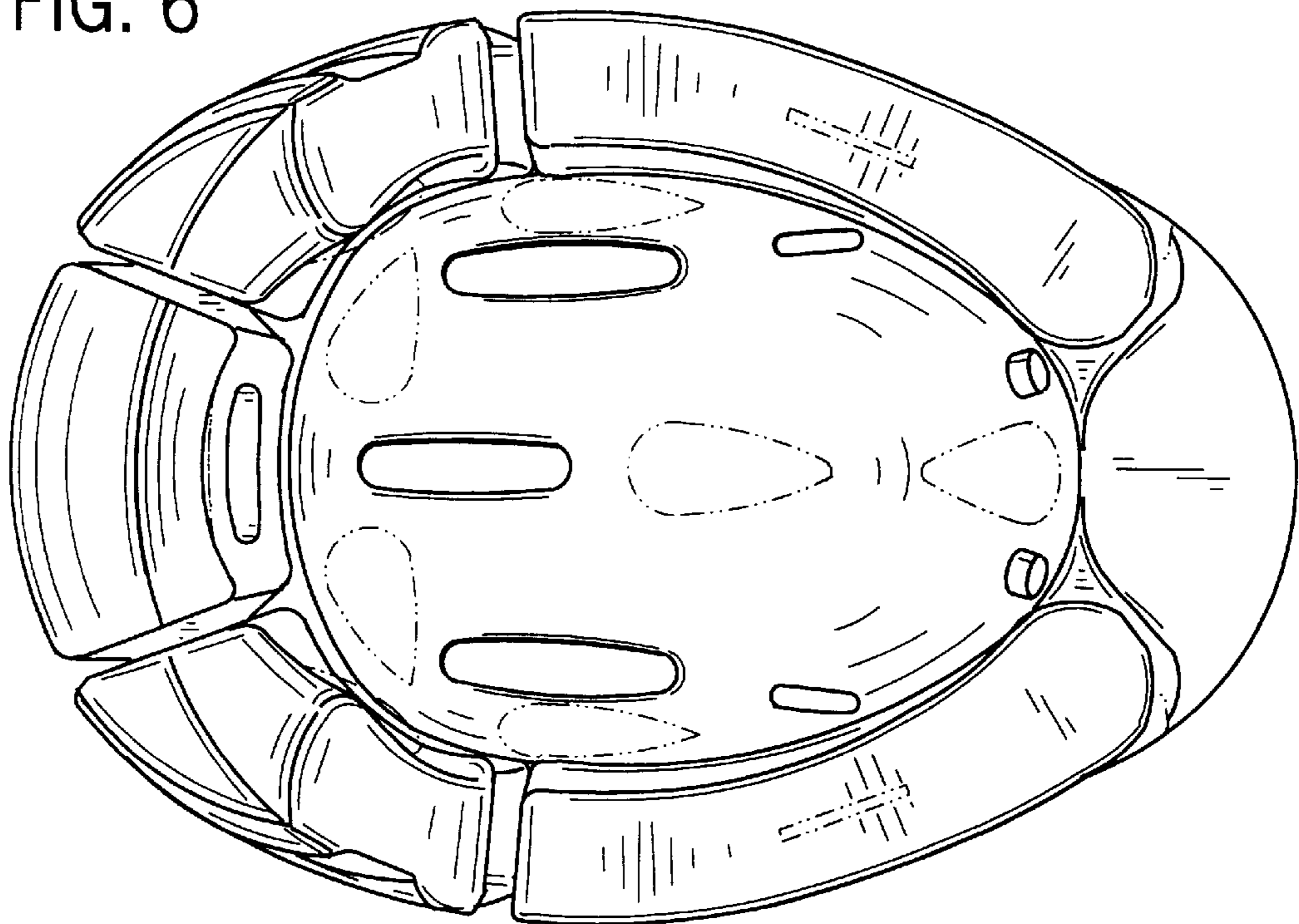

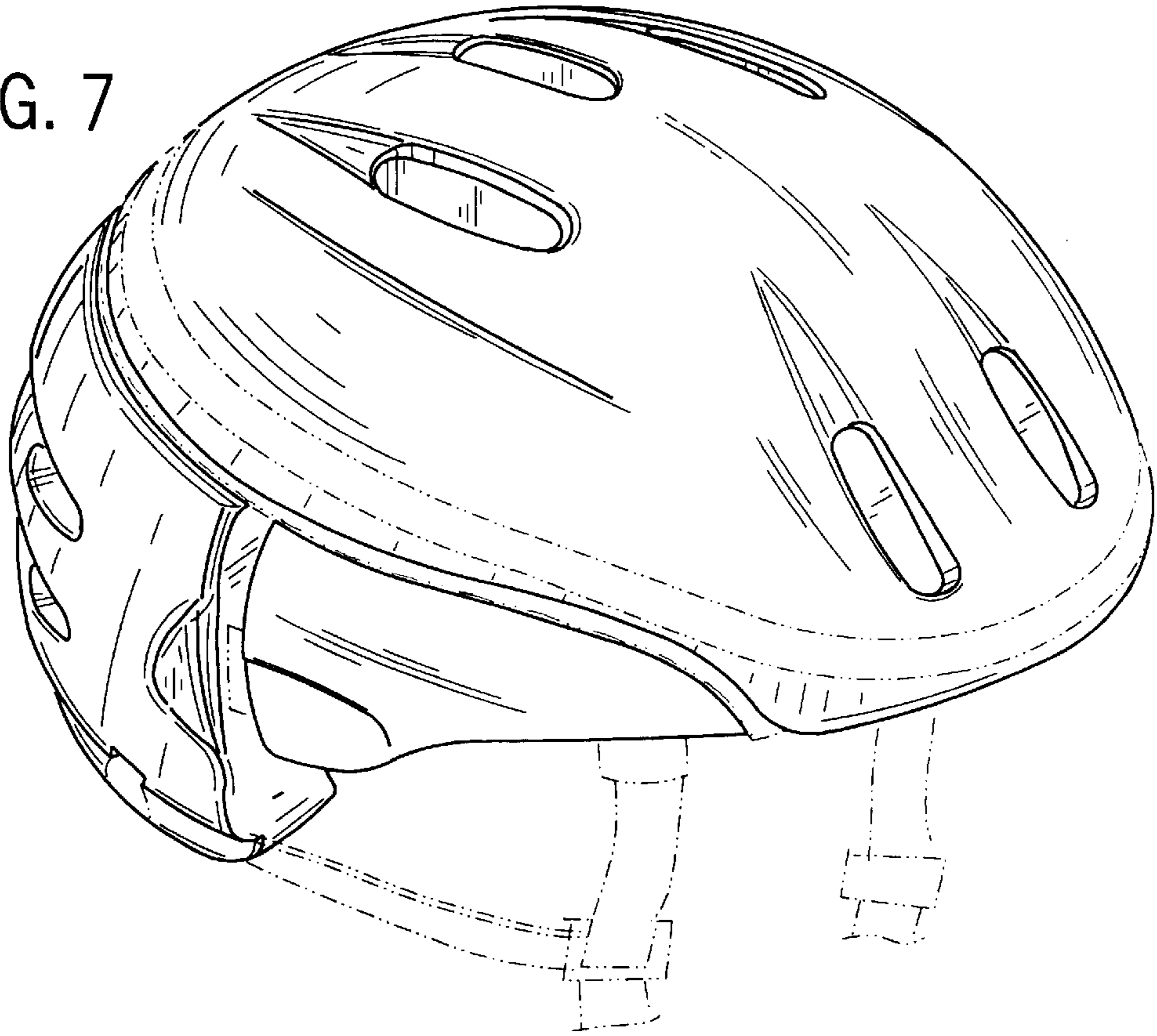

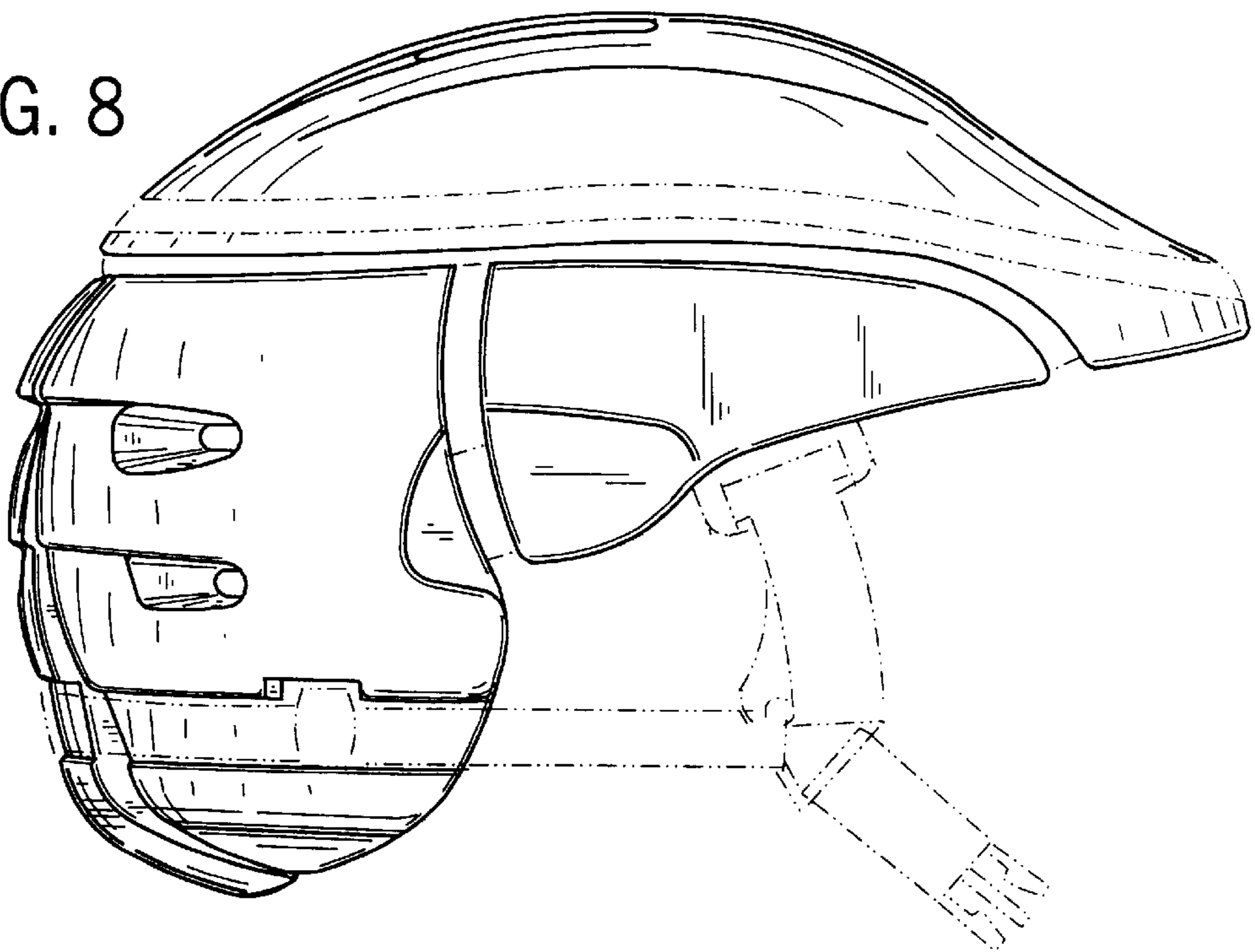

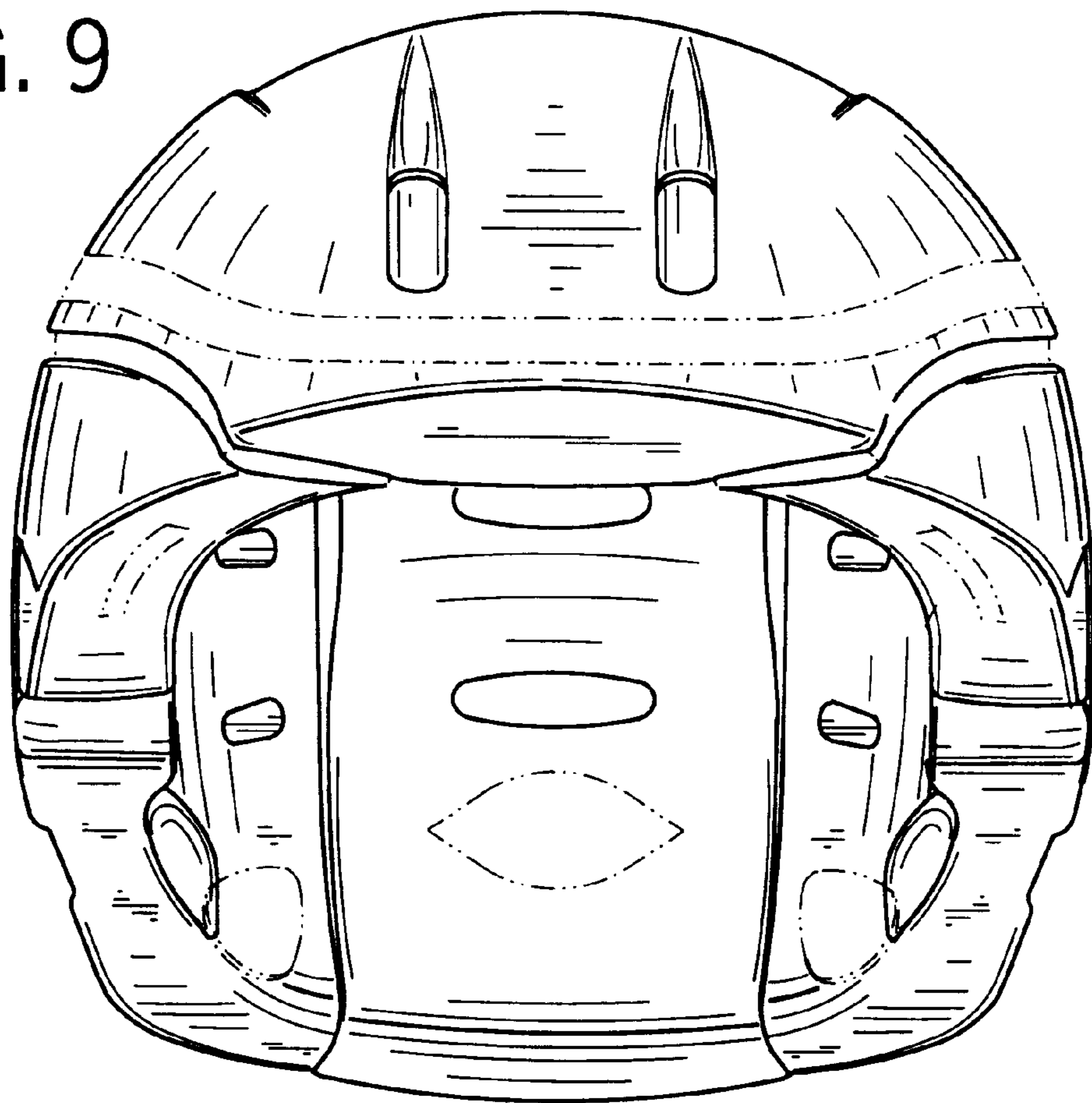

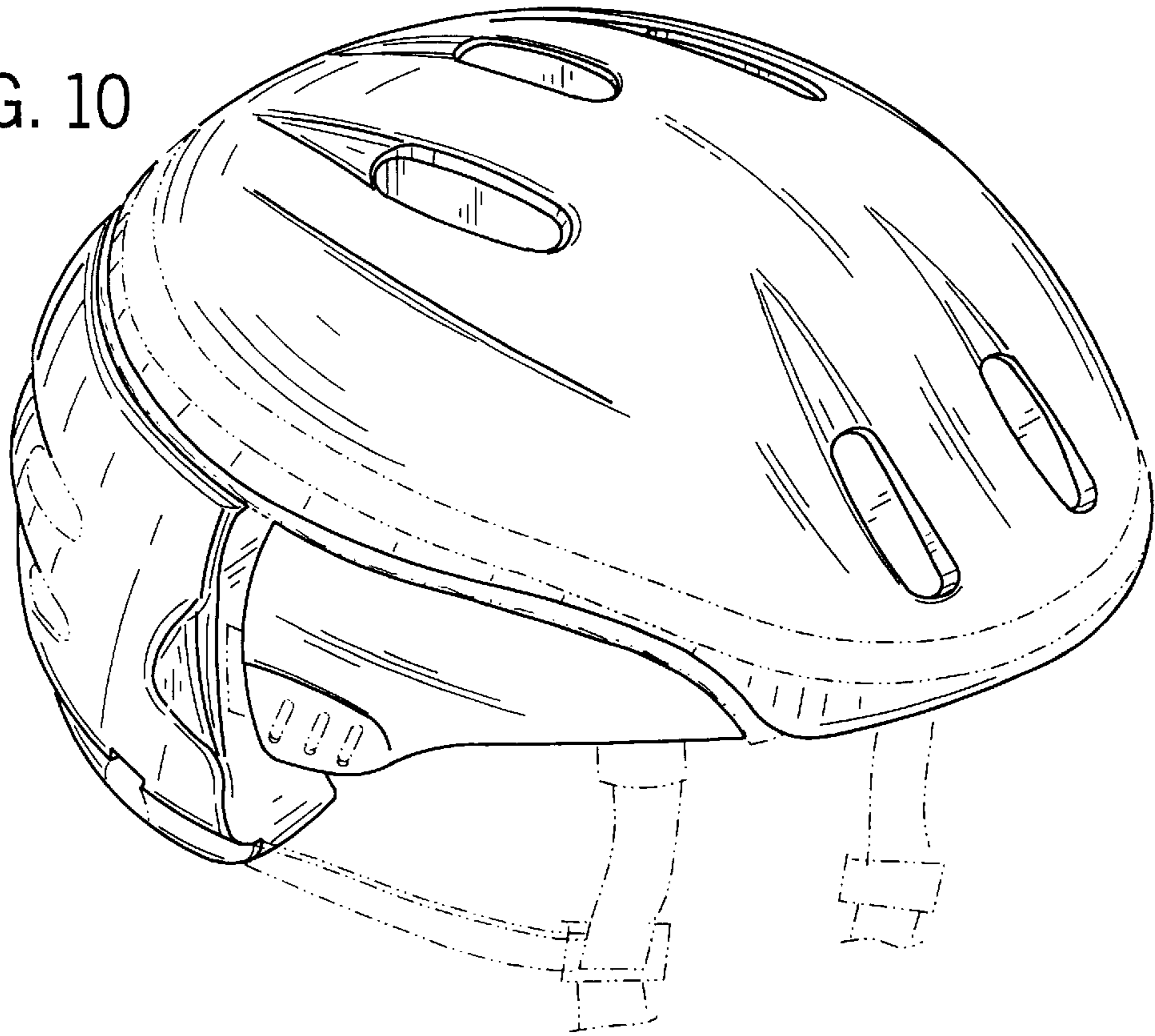

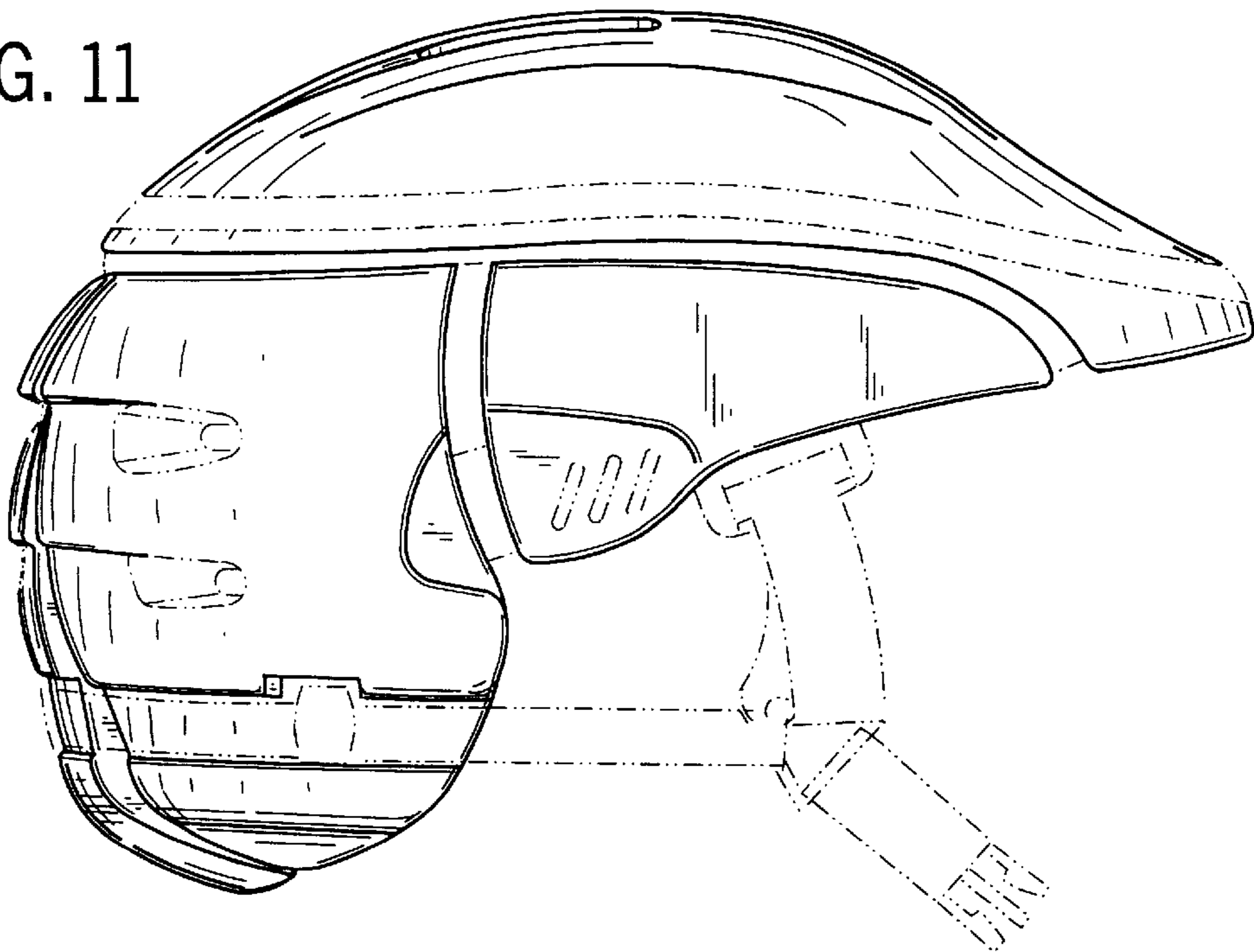

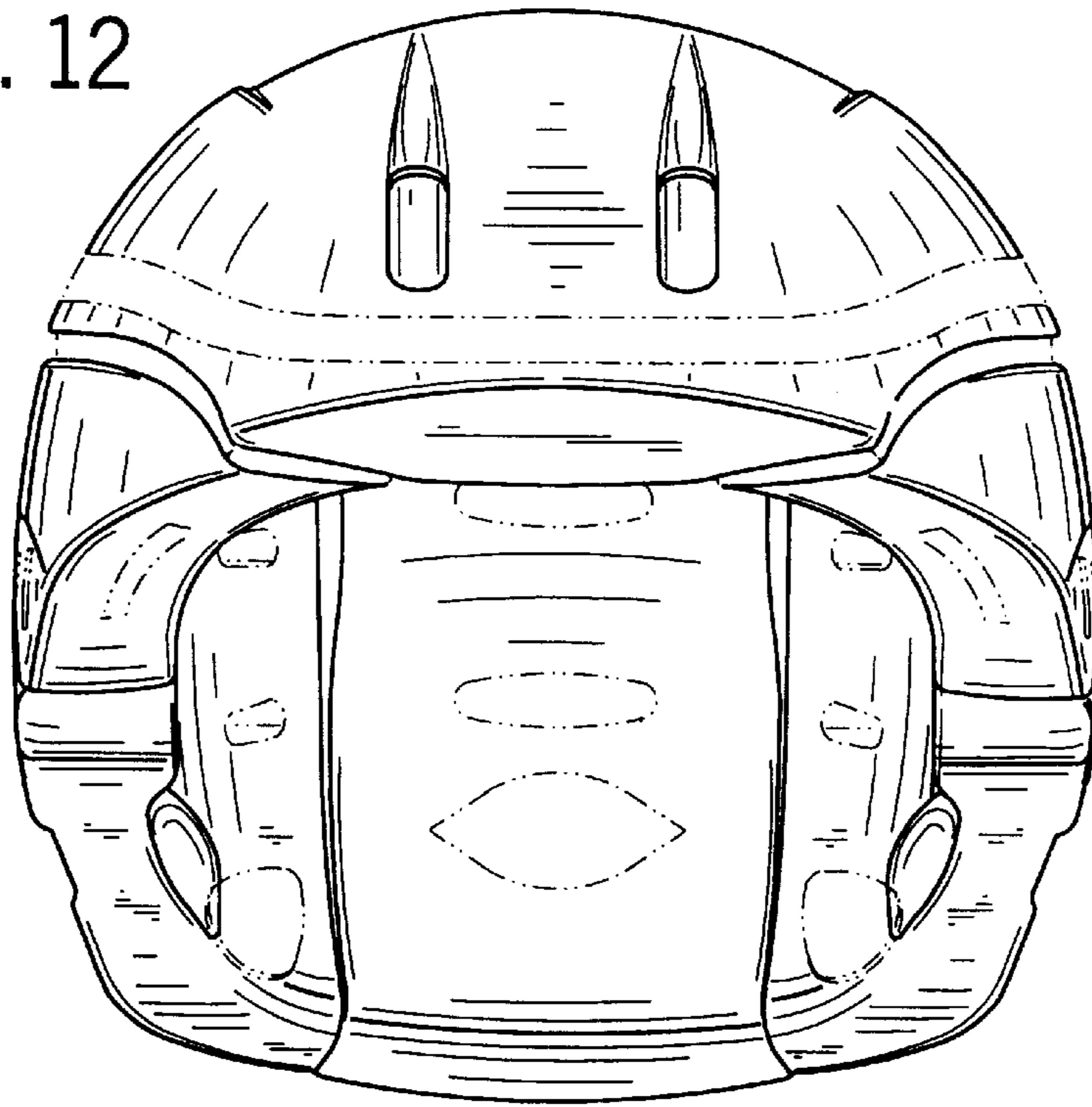

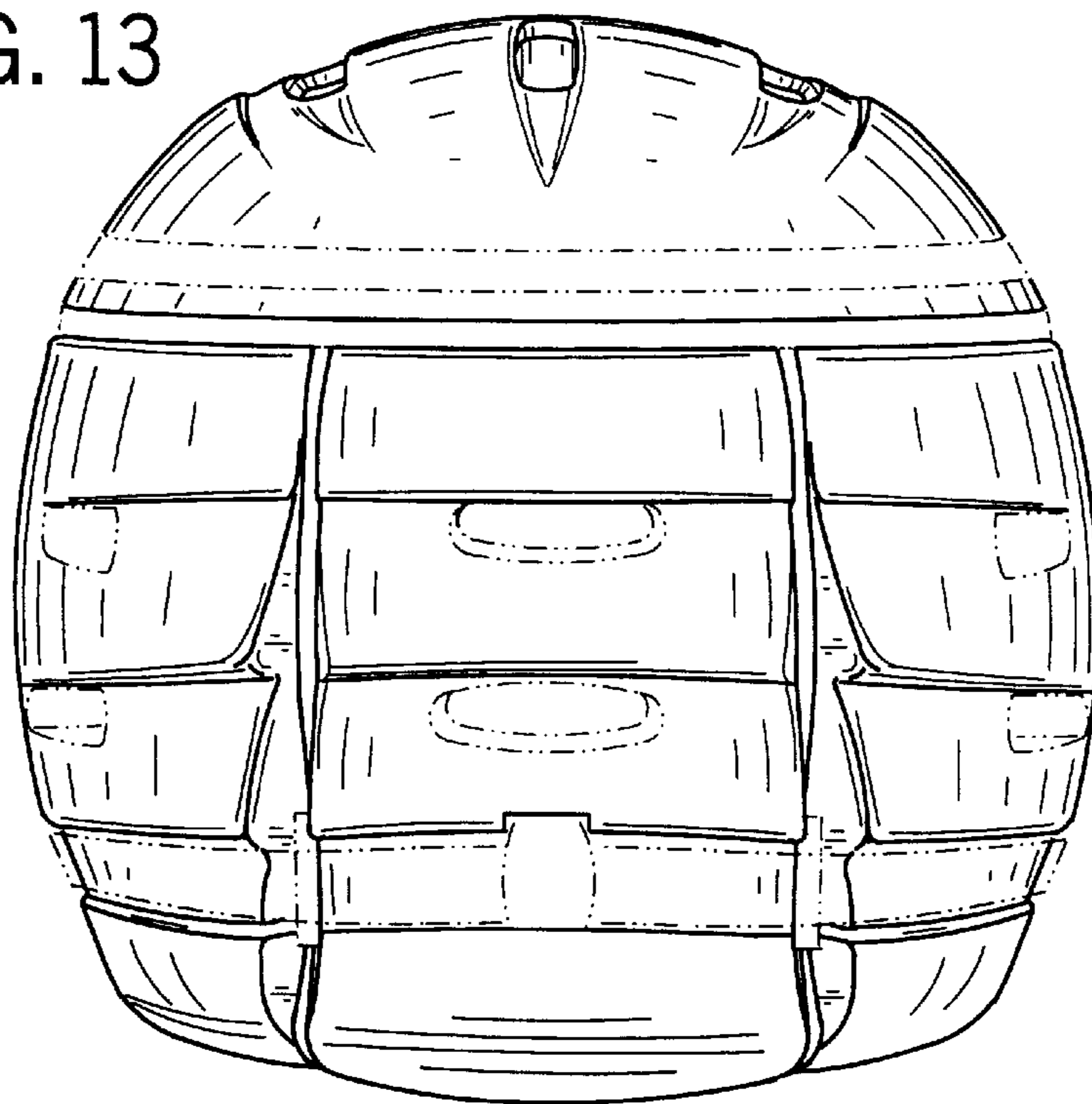

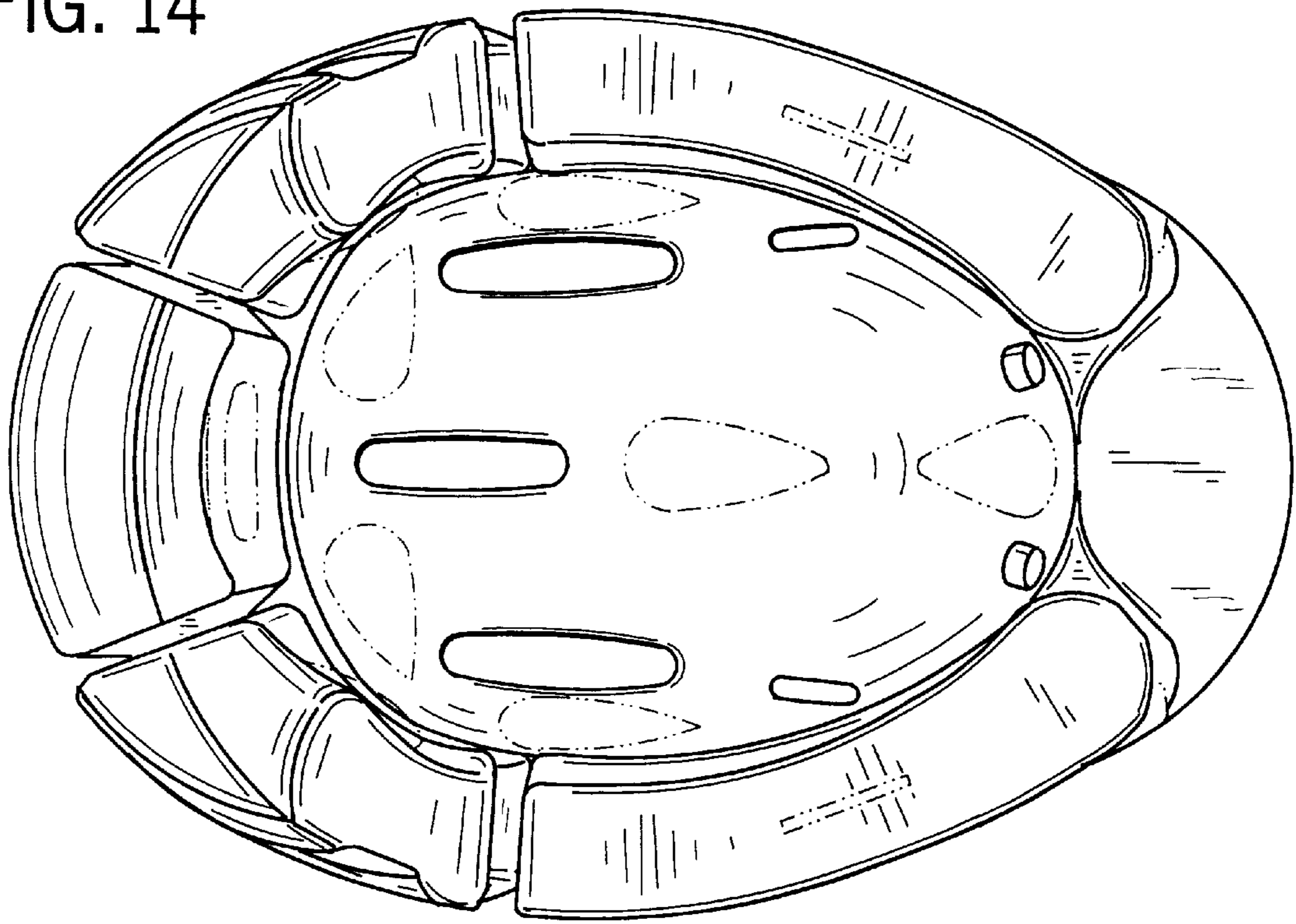

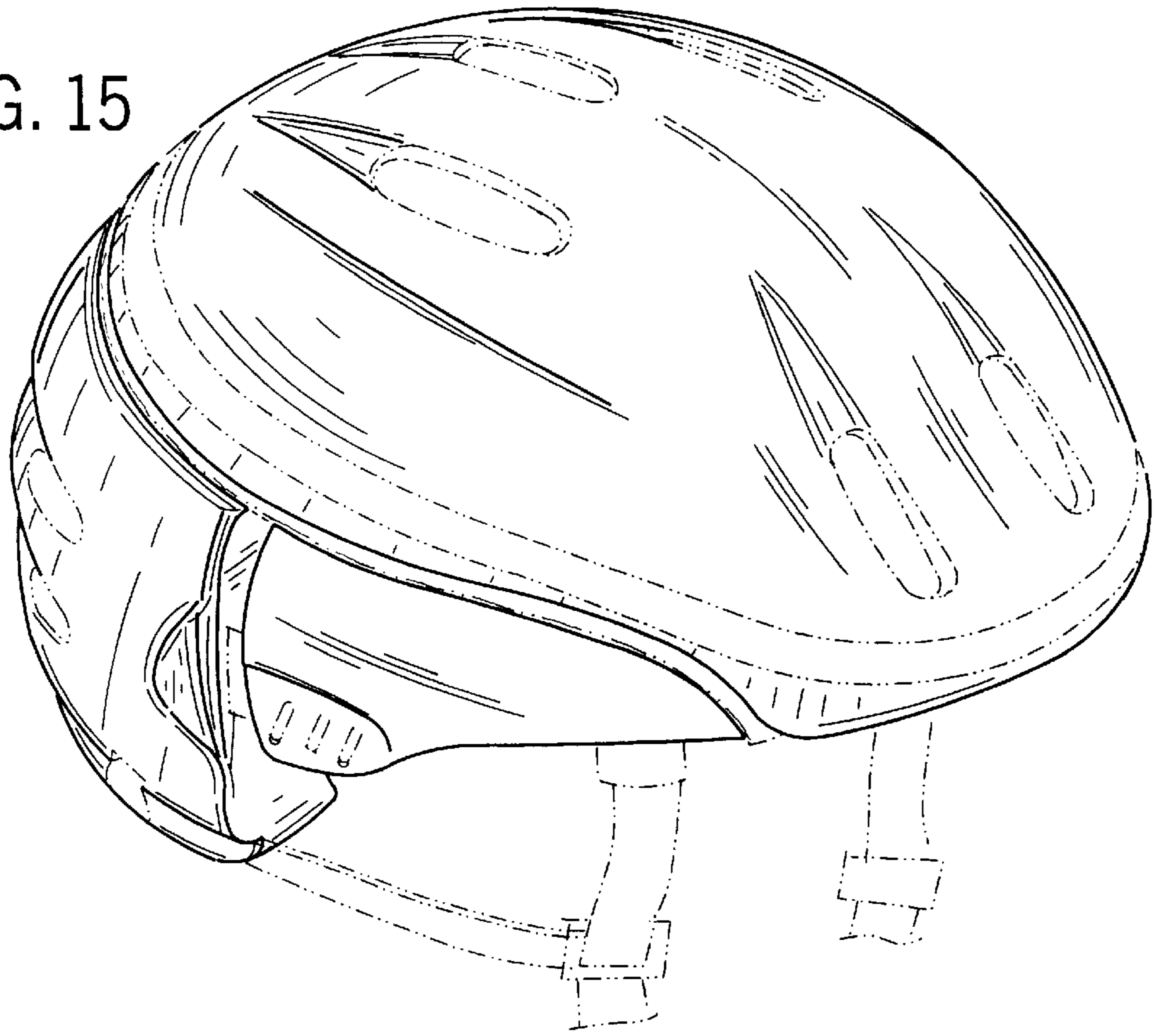

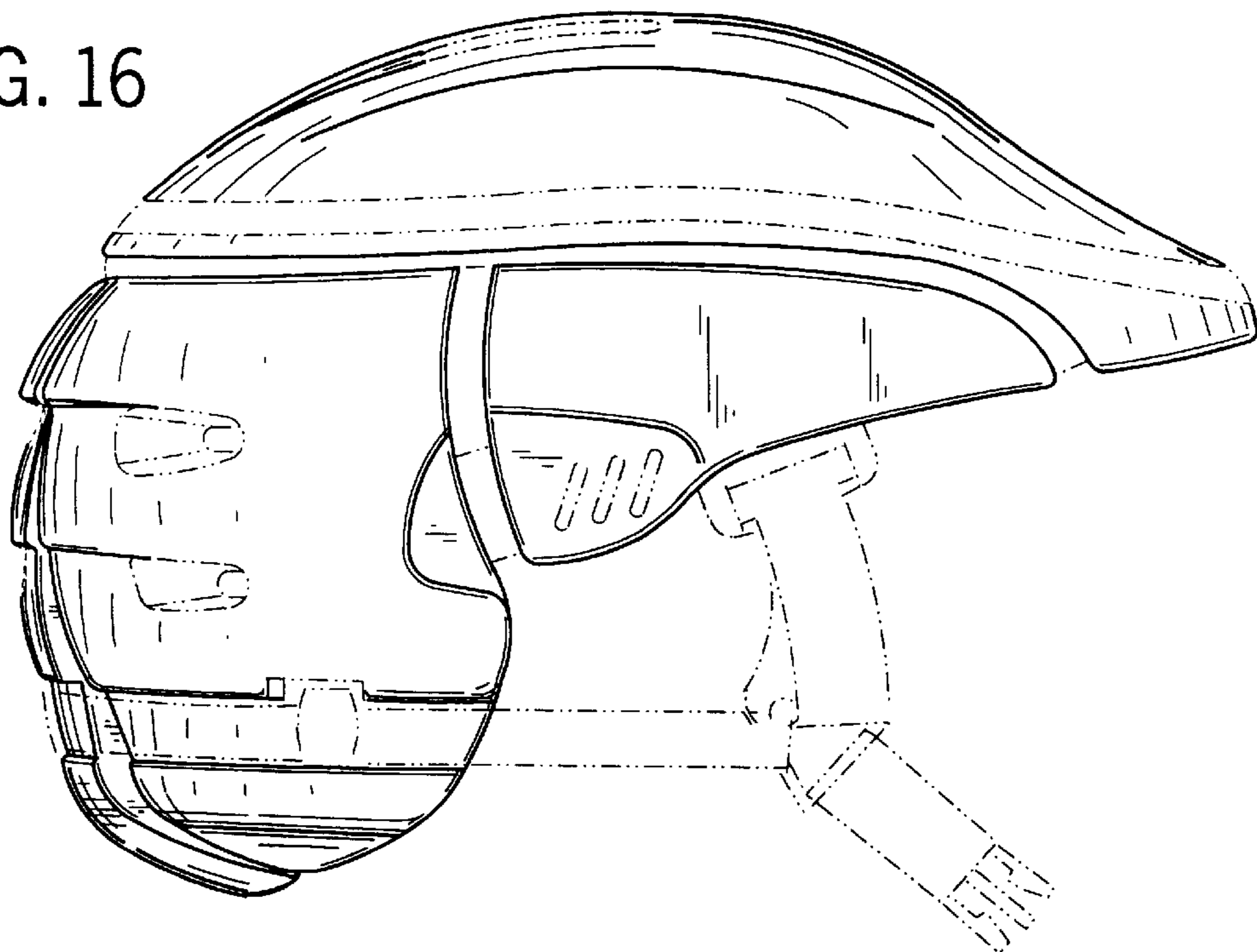

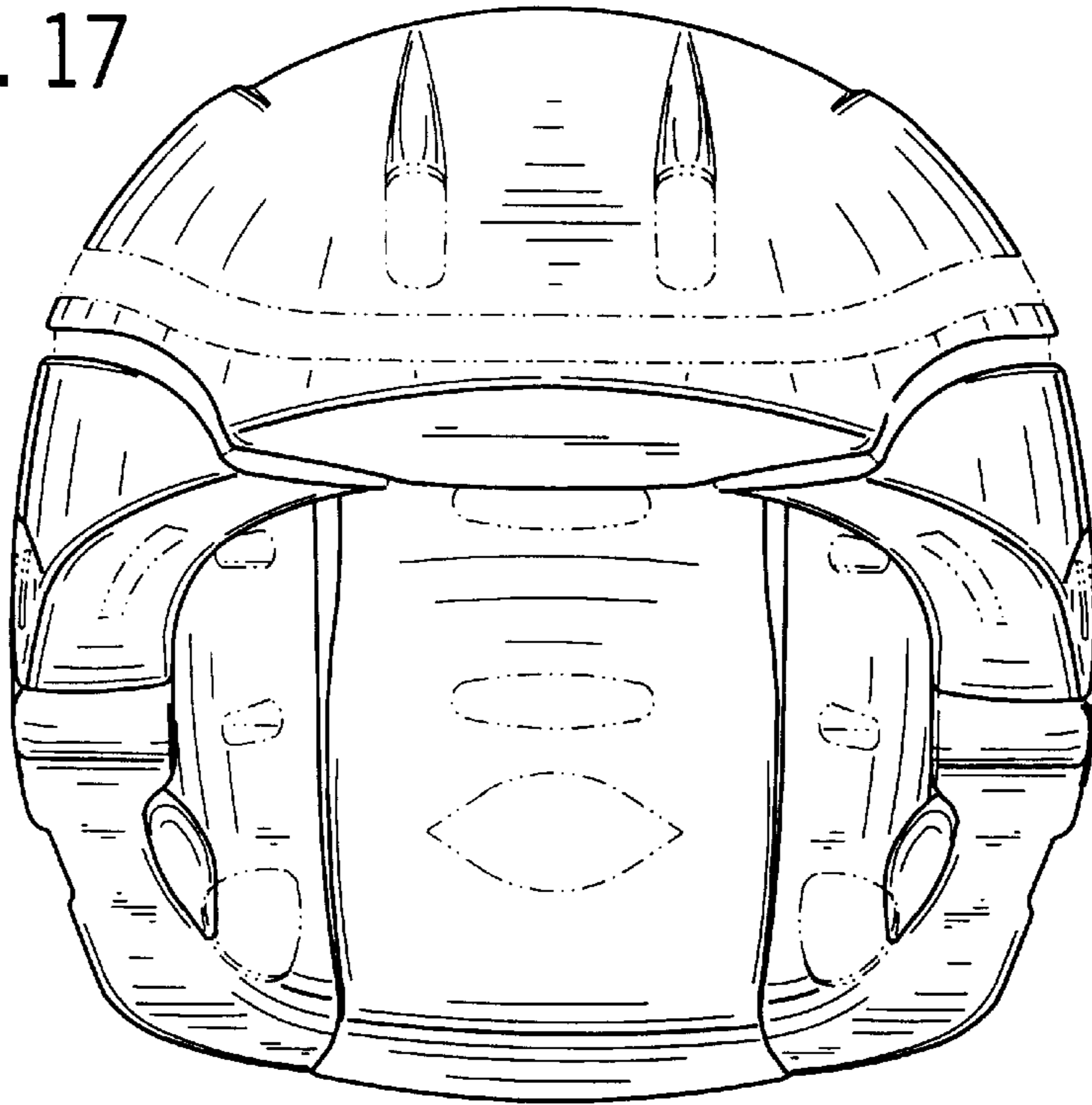

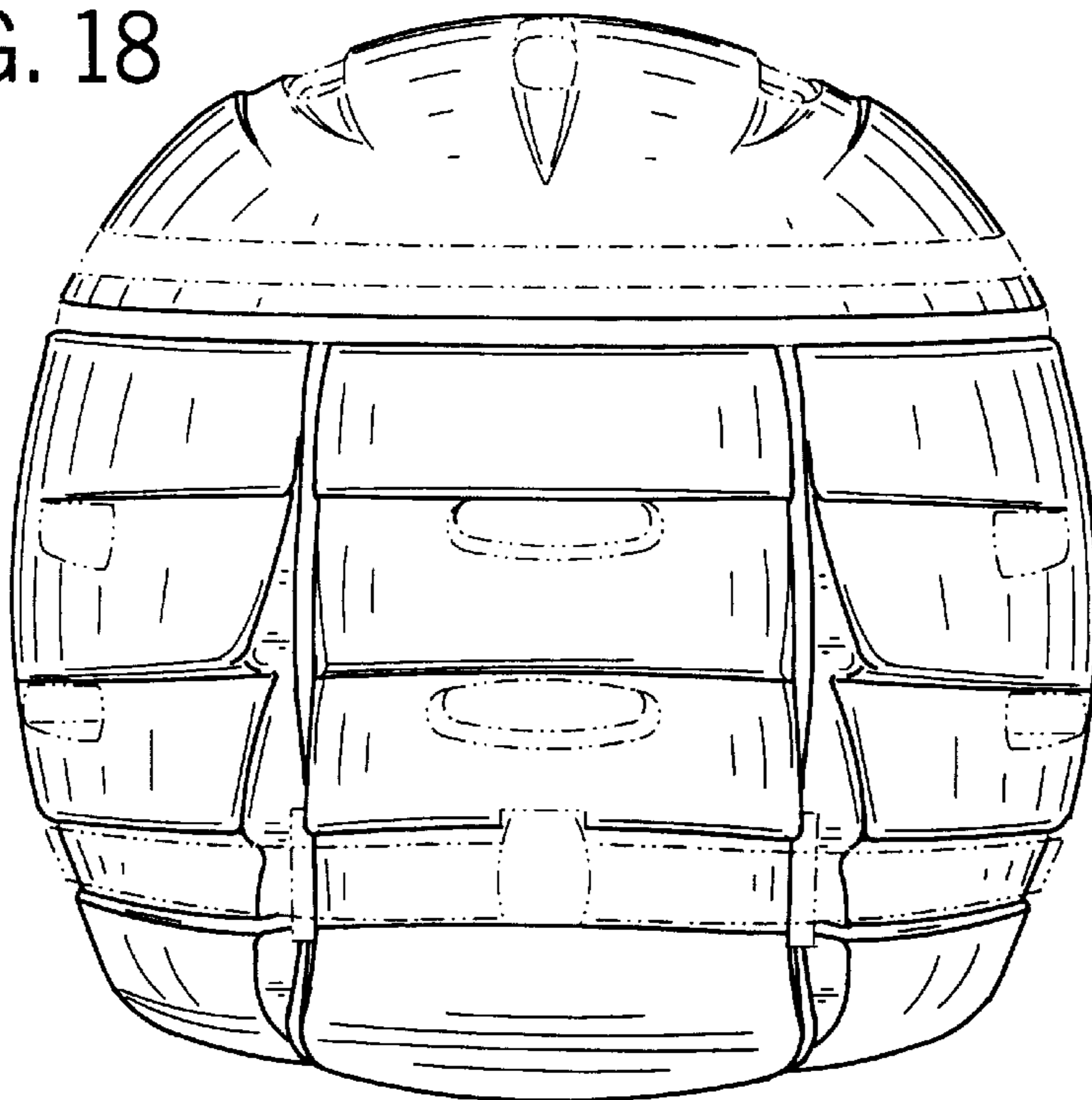

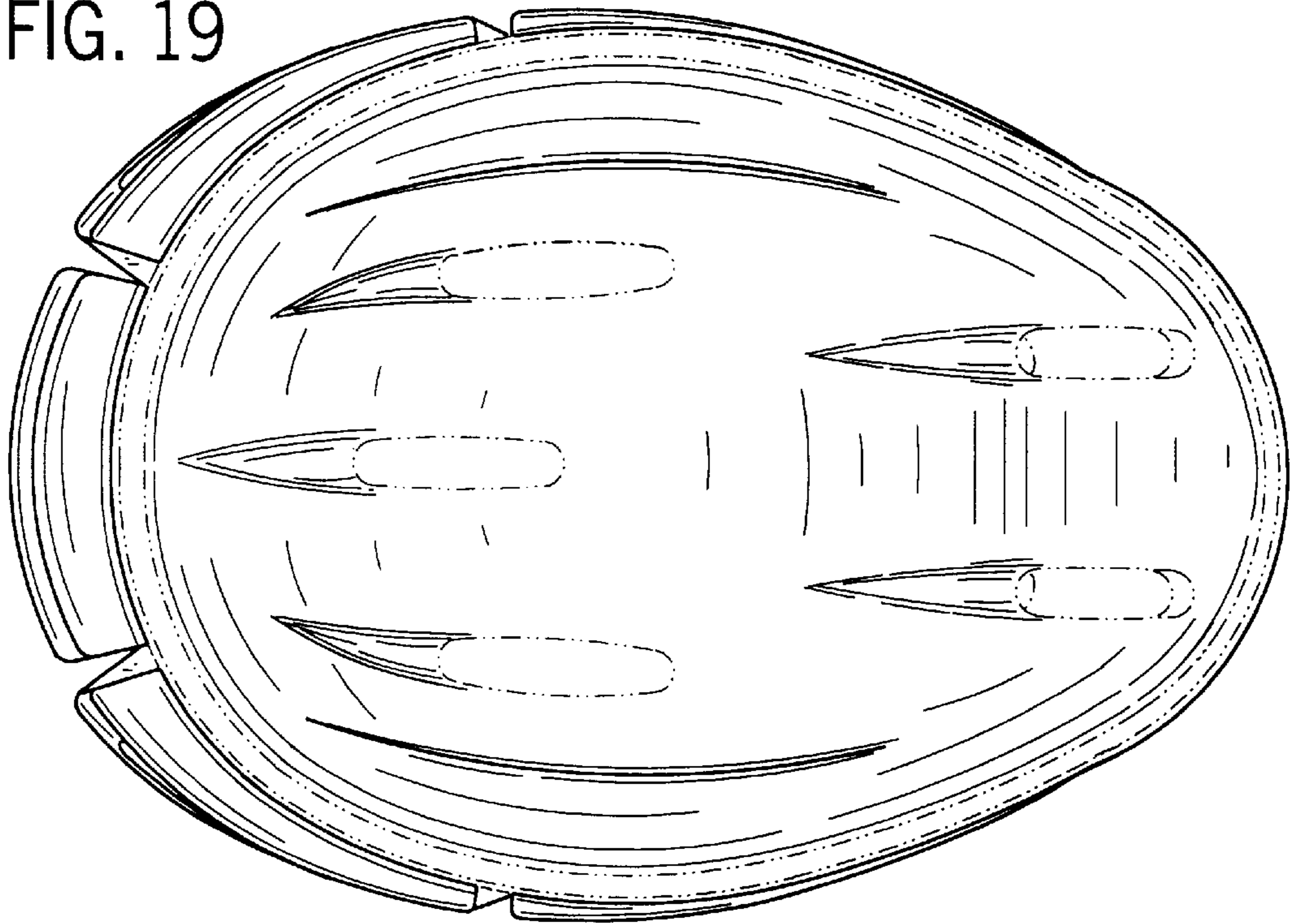

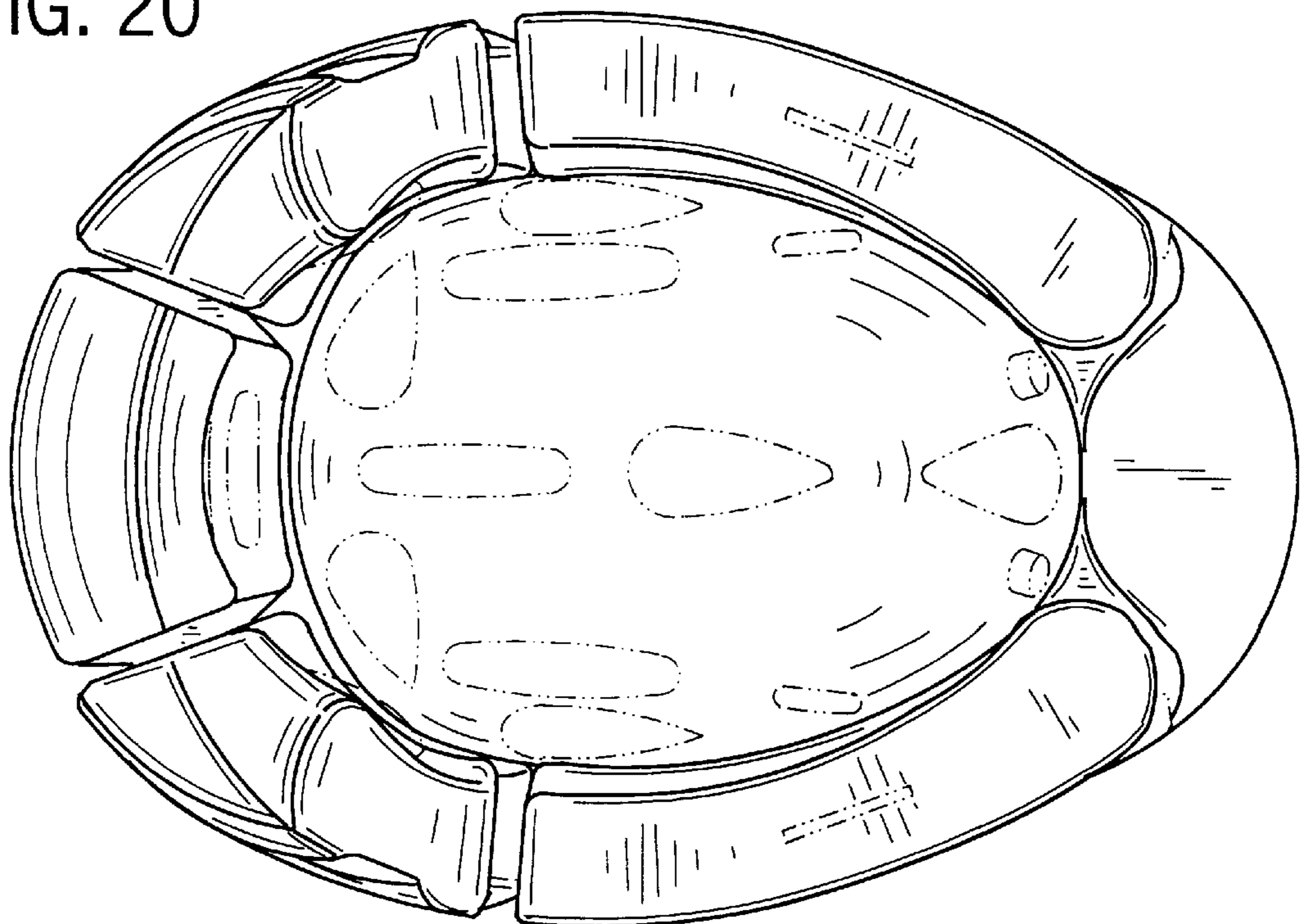

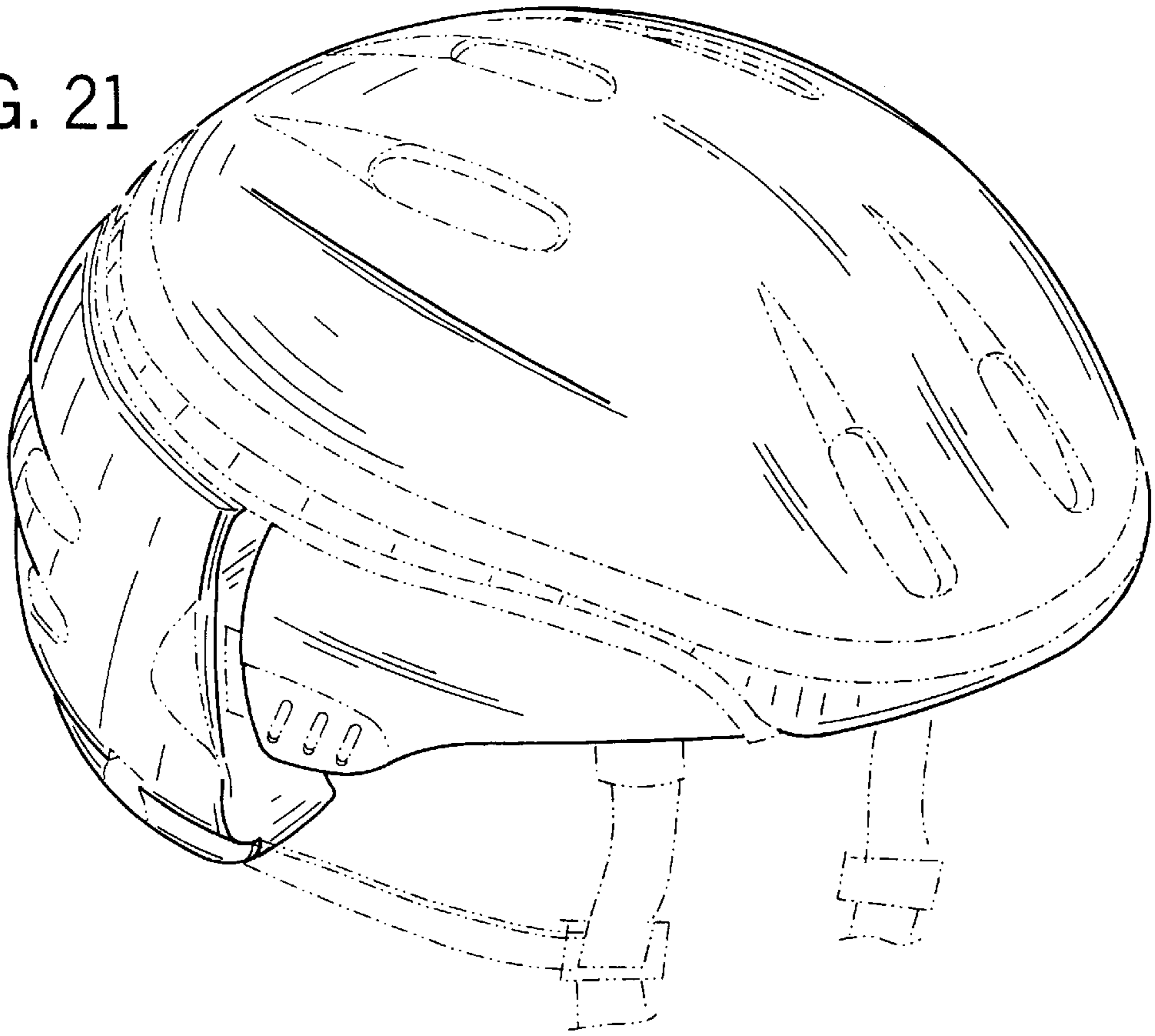

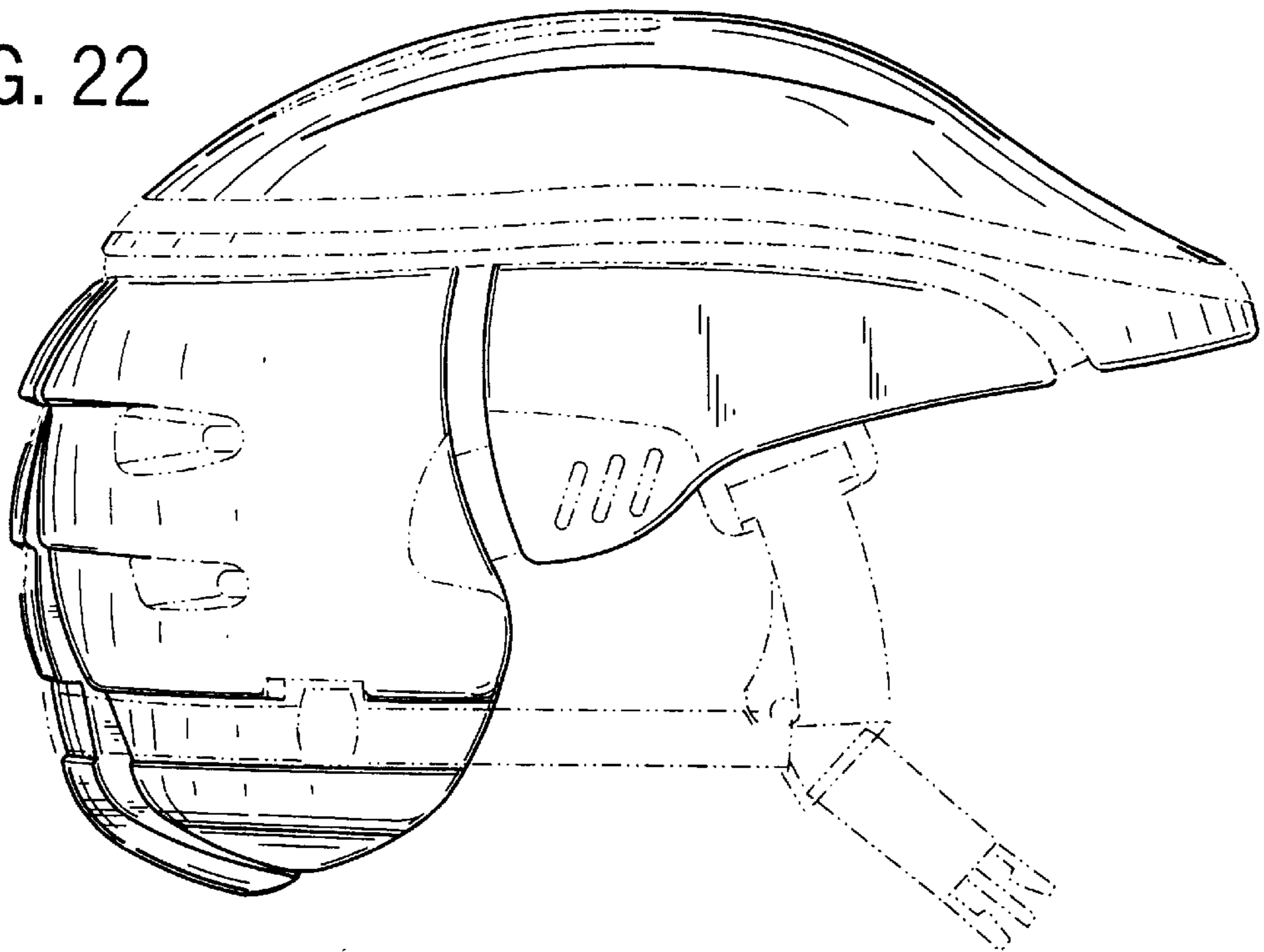

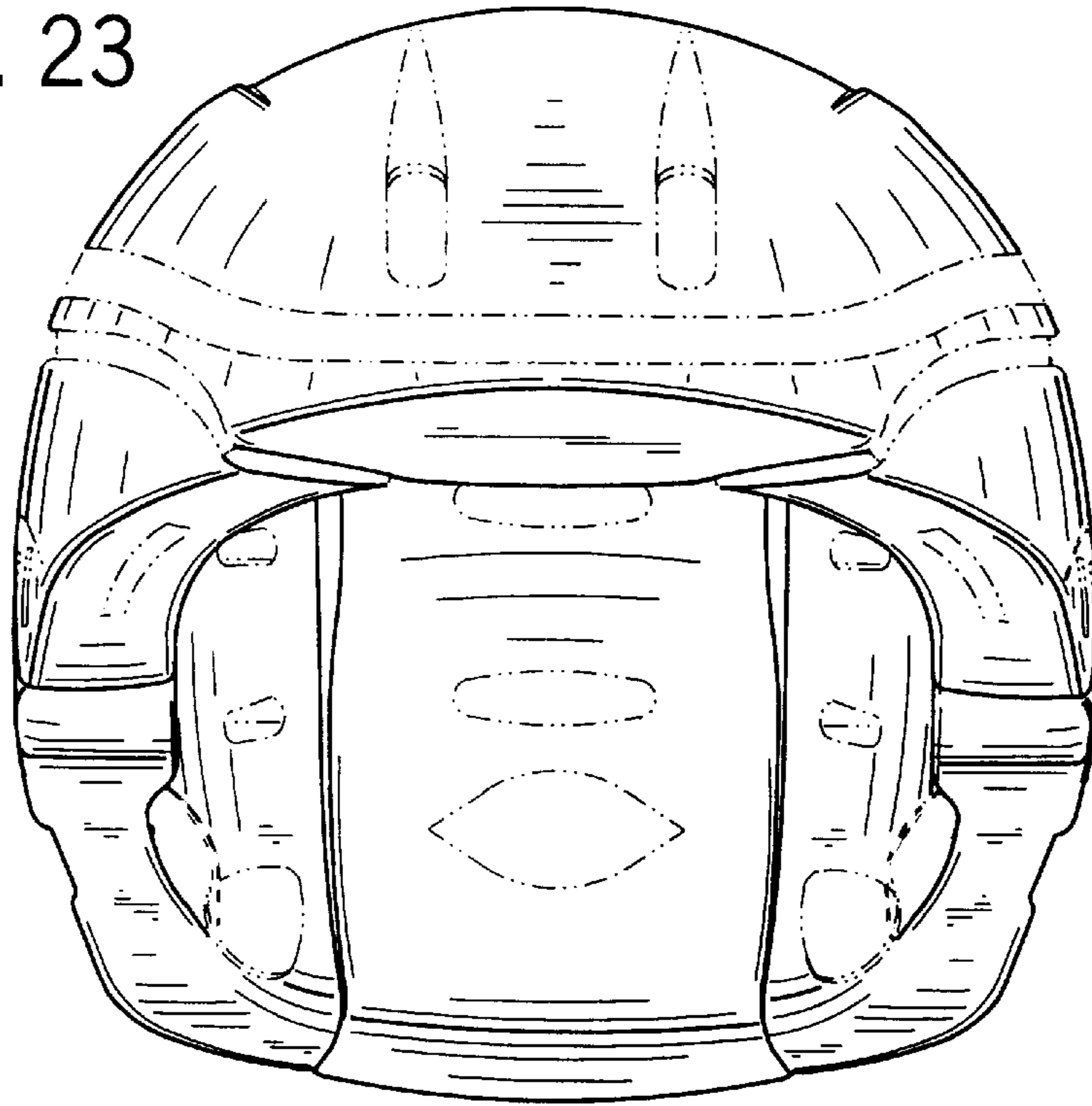

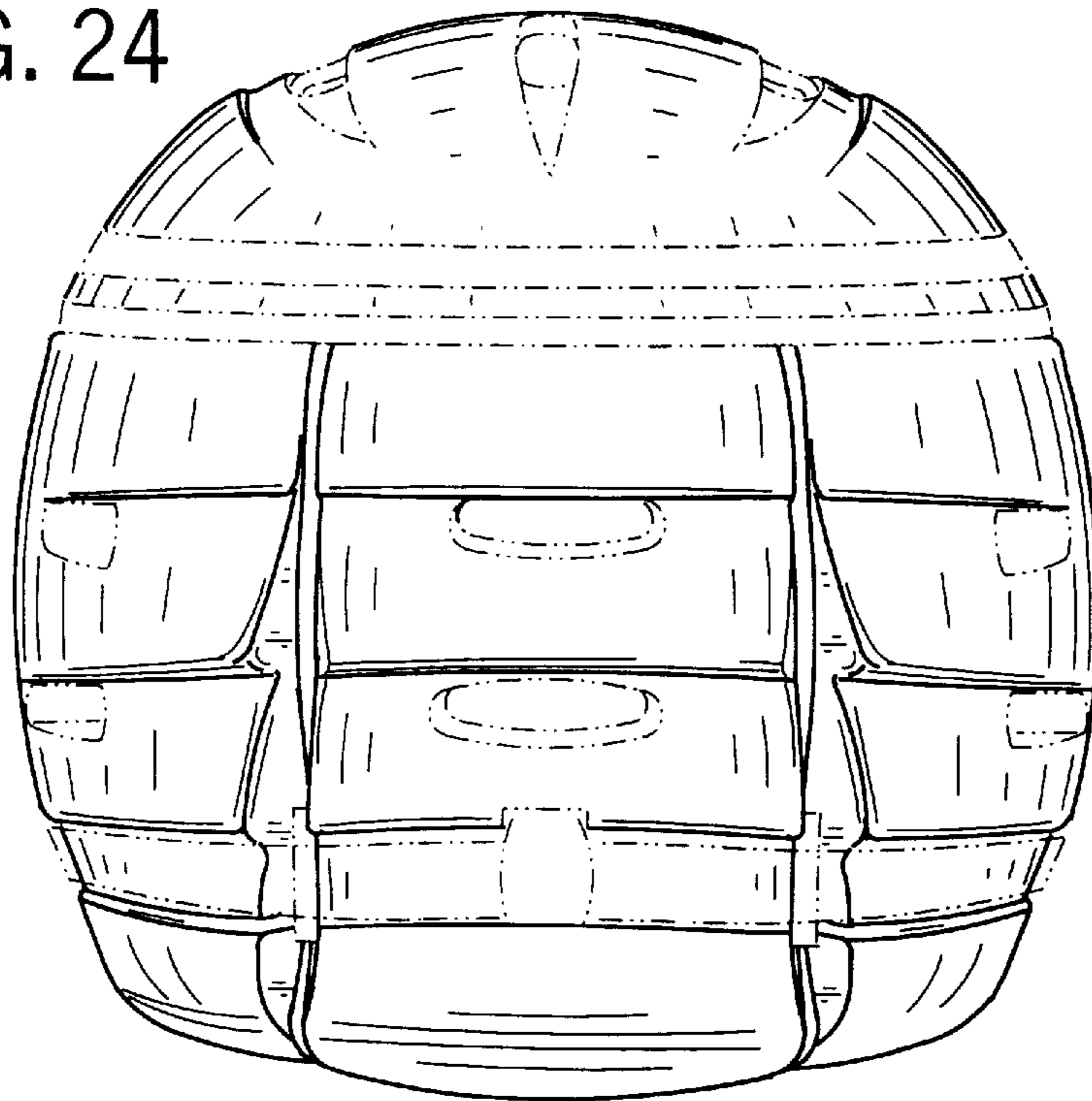
