(57) **CLAIM**

We claim the ornamental design for a school supply box, as shown and described.

**DESCRIPTION**

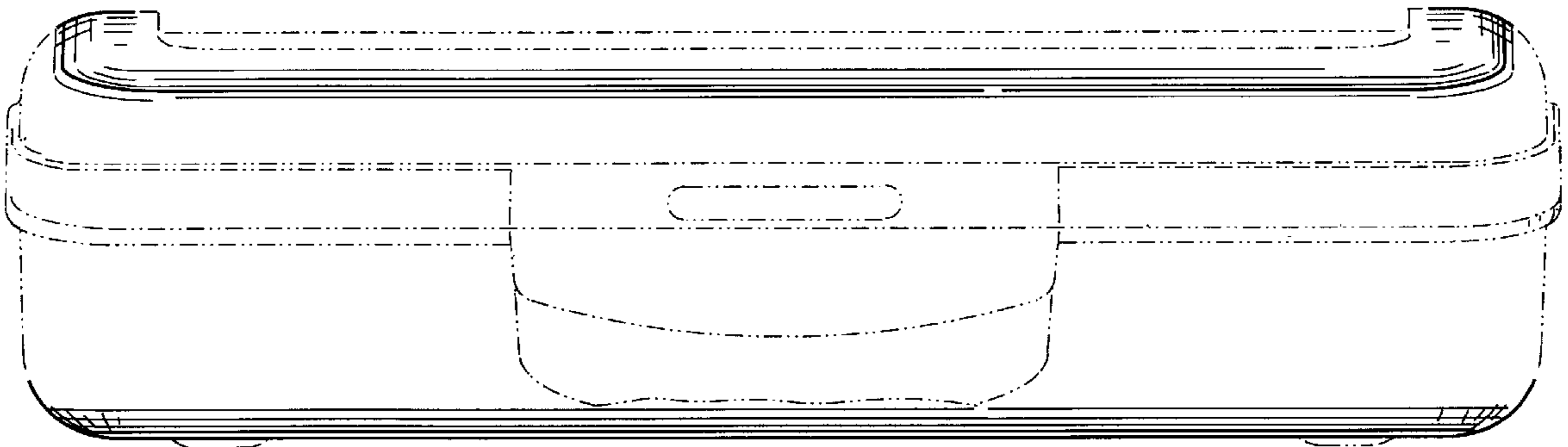
FIG. 1 is a side view of the school supply box with portions of the school supply box shown in broken lines, the opposite side of the school supply box being the same as that shown in FIG. 1;

FIG. 2 is a top view of the school supply box shown in FIG. 1 with portions of the school supply box shown in broken lines; and,

FIG. 3 is a front view of the school supply box shown in FIG. 1 with portions of the school supply box shown in broken lines.

The broken lines showing portions of the school supply box in FIGS. 1, 2, and 3 are for illustrative purposes only and form no part of the claimed design.

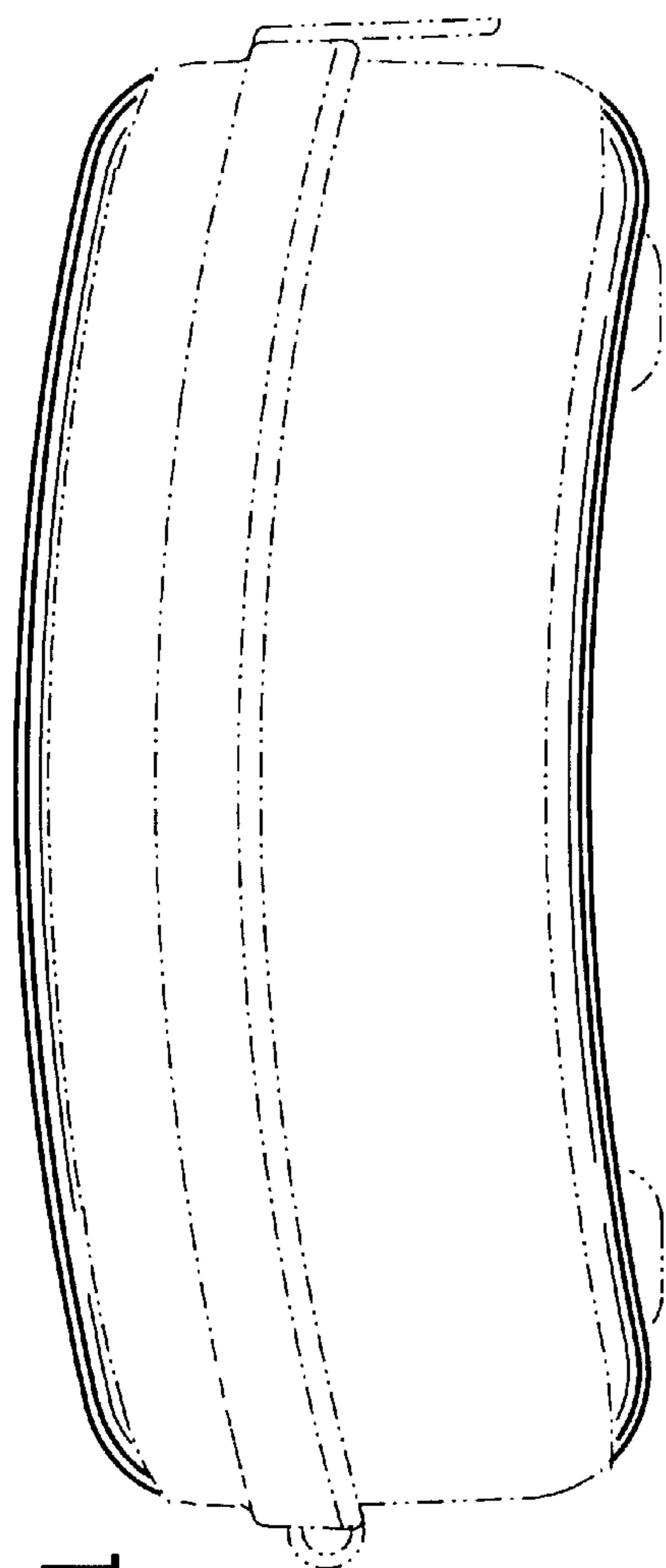

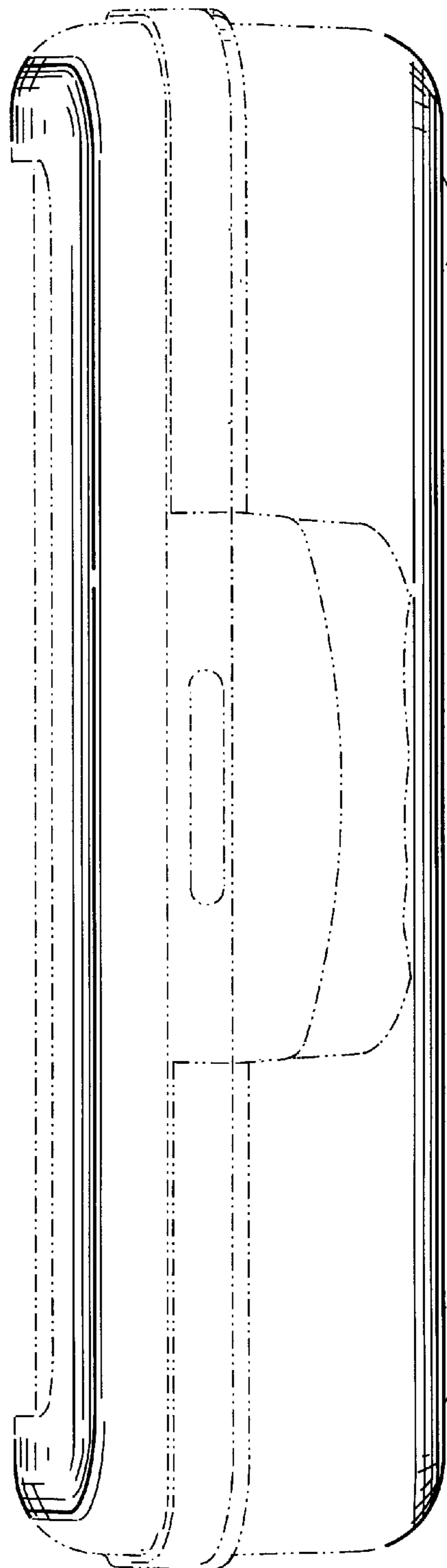

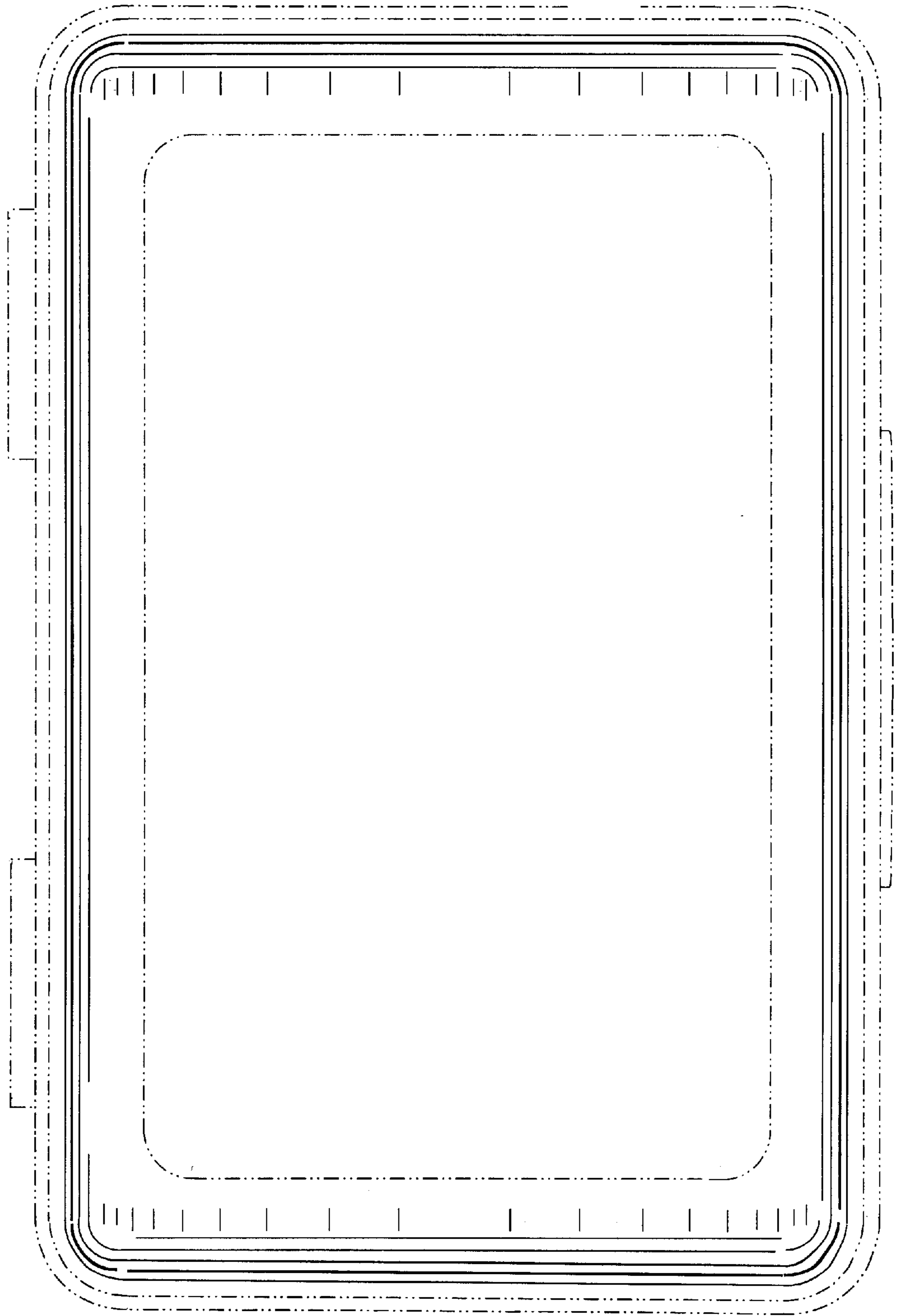
