The ornamental design for a brush handle, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a first embodiment;
 FIG. 2 is a side elevational view of the embodiment shown in FIG. 1;
 FIG. 3 is a top plan view of the embodiment shown in FIG. 1;
 FIG. 4 is a side elevational view of the embodiment shown in FIG. 1;
 FIG. 5 is a bottom plan view of the embodiment shown in FIG. 1;
 FIG. 6 is a front elevational view of the embodiment shown in FIG. 1;
 FIG. 7 is a rear elevational view of the embodiment shown in FIG. 1;
 FIG. 8 is an isometric view of a second embodiment;
 FIG. 9 is a side elevational view of the embodiment shown in FIG. 8;
 FIG. 10 is a top plan view of the embodiment shown in FIG. 8;
 FIG. 11 is a side elevational view of the embodiment shown in FIG. 8;
 FIG. 12 is a bottom plan view of the embodiment shown in FIG. 8;
 FIG. 13 is a front elevational view of the embodiment shown in FIG. 8; and,
 FIG. 14 is a rear elevational view of the embodiment shown in FIG. 8.

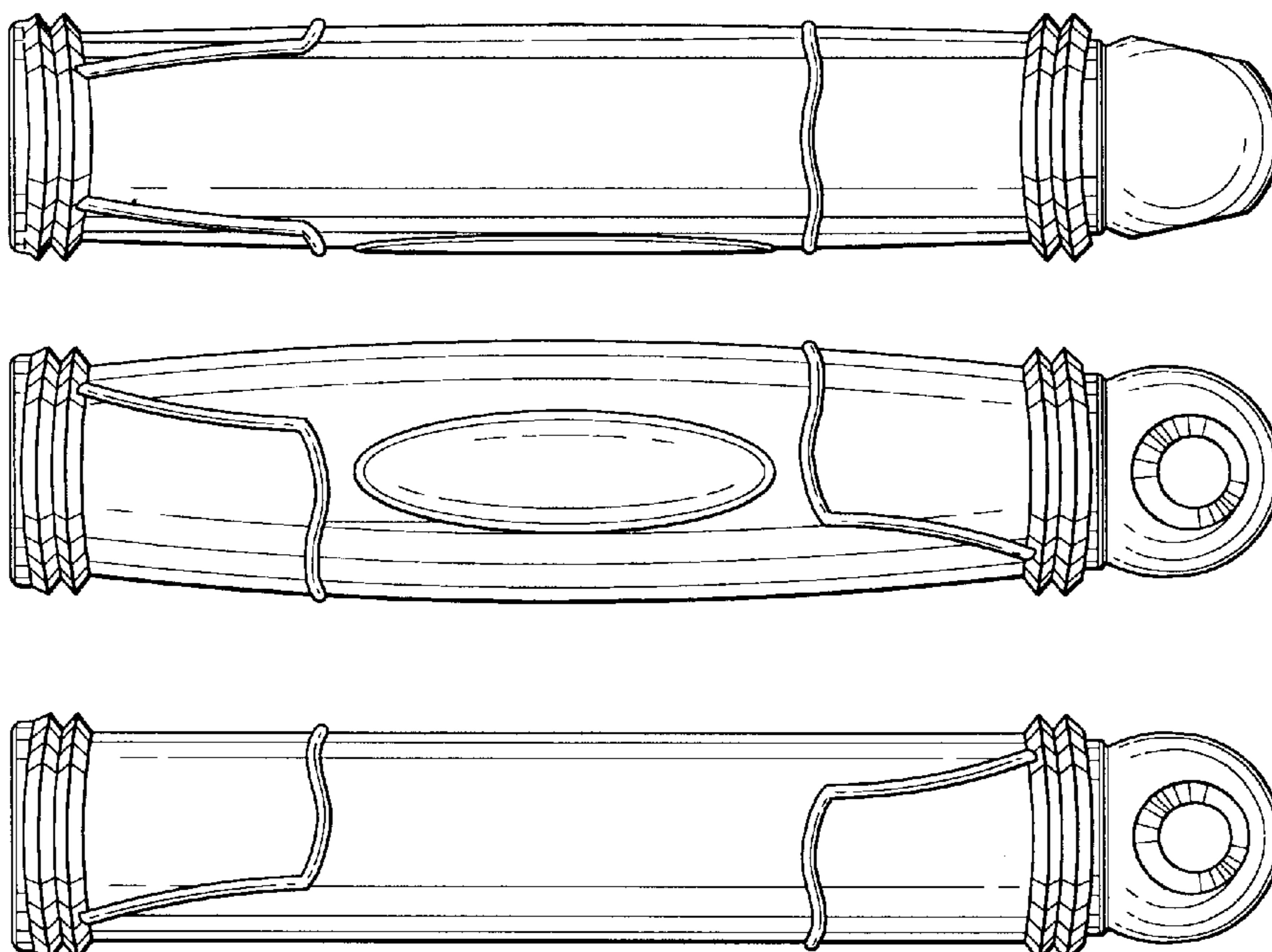

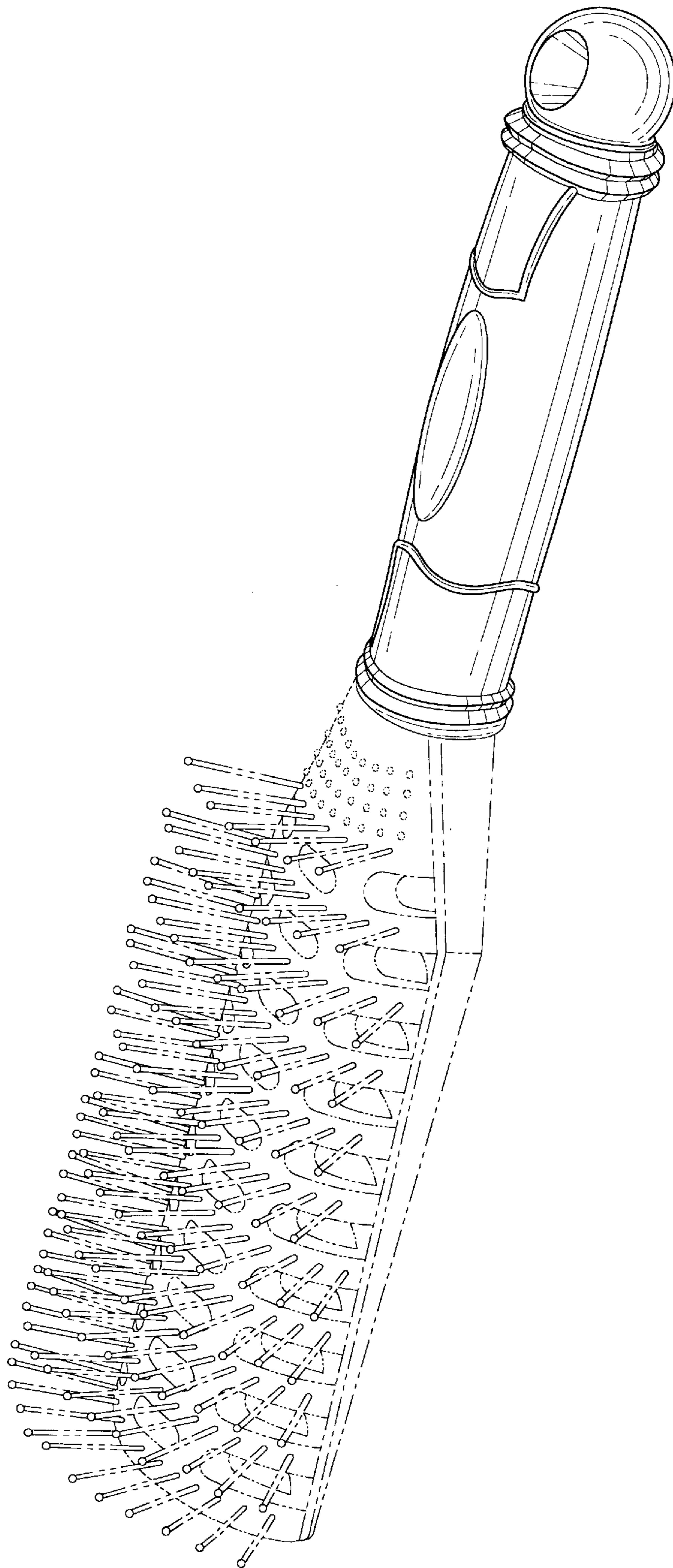

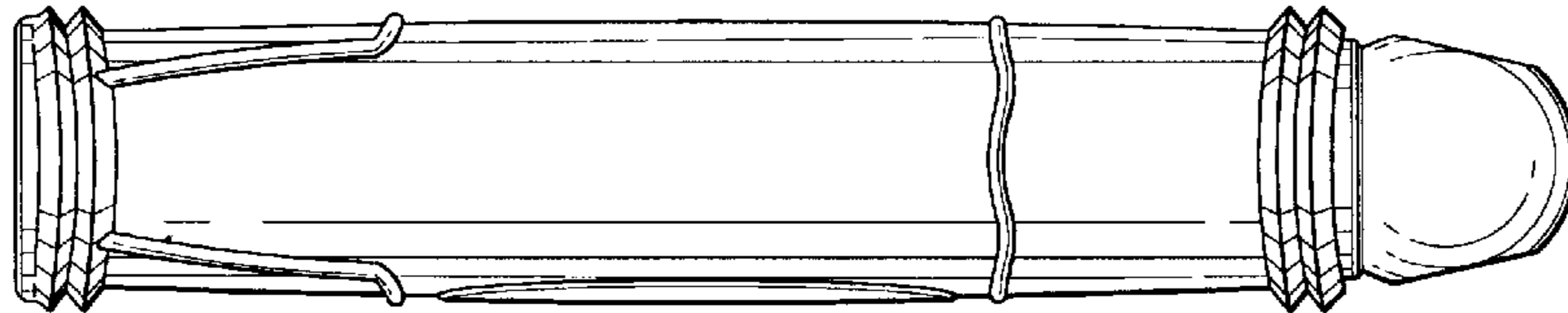

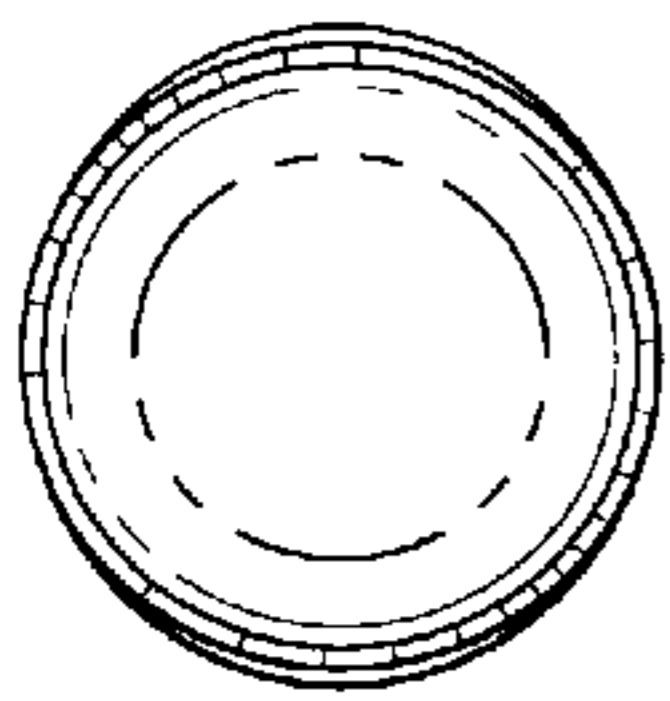

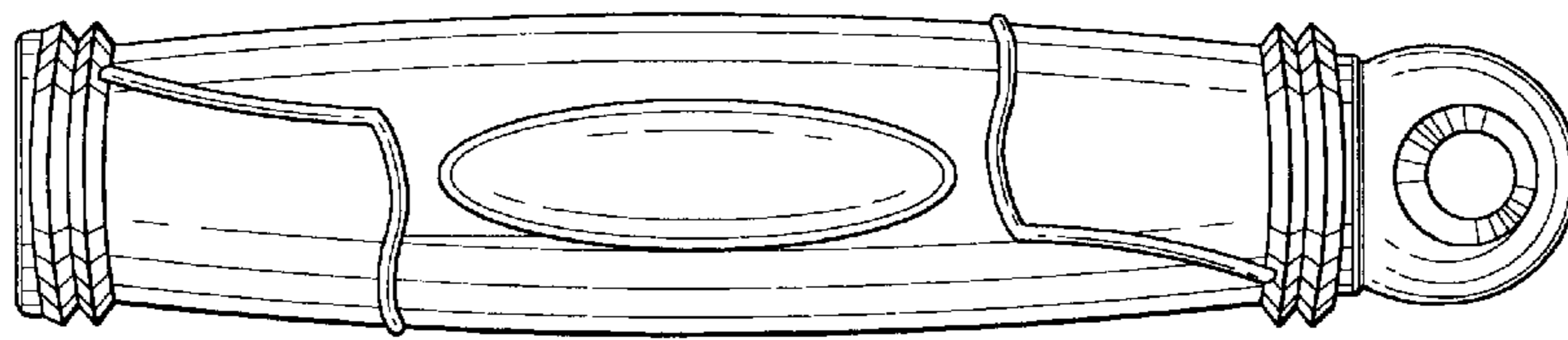

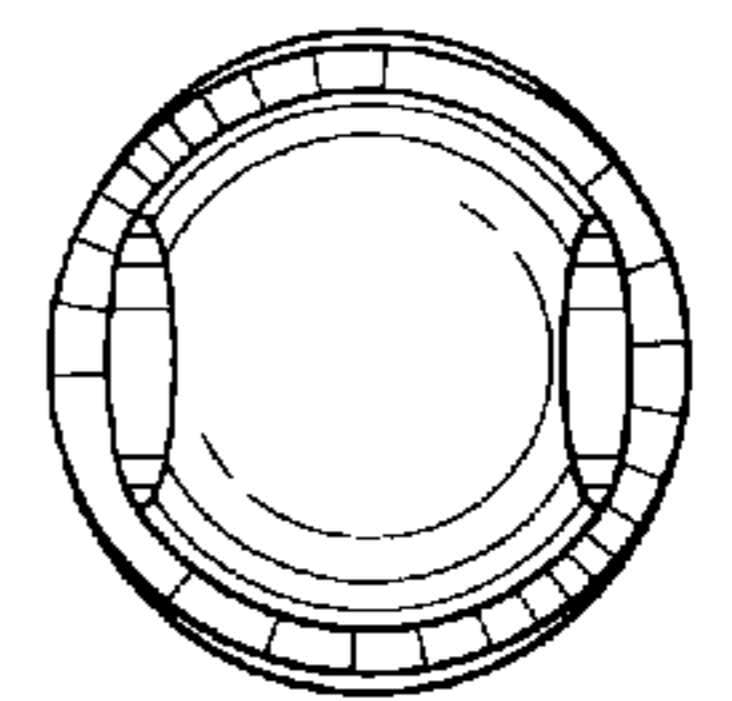

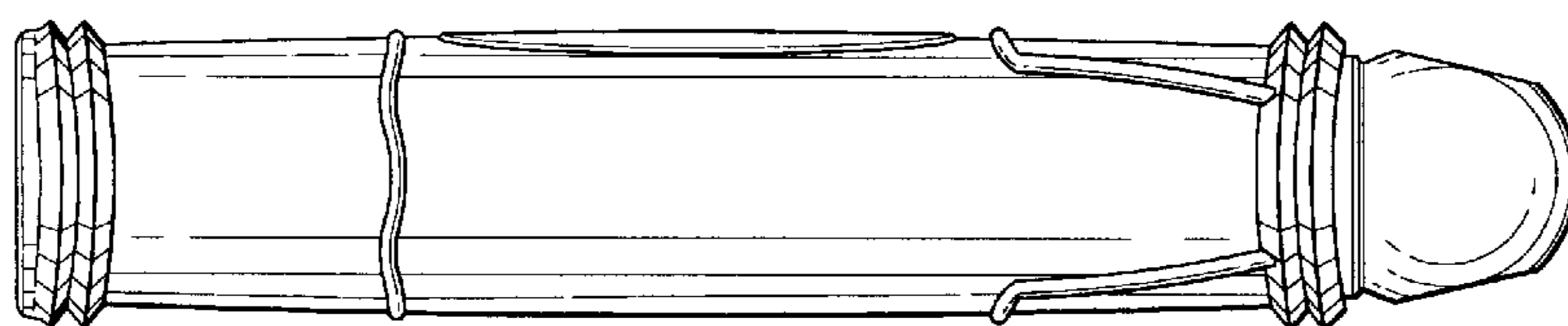

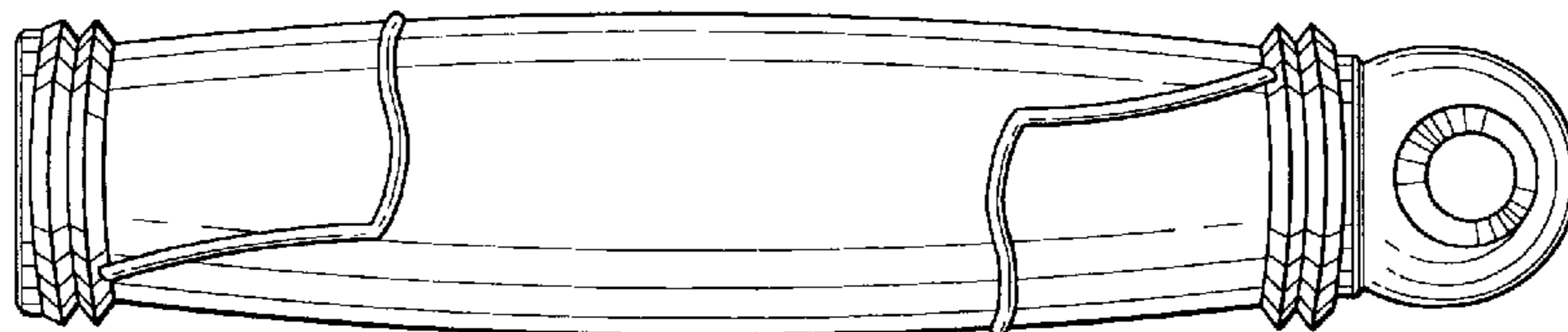

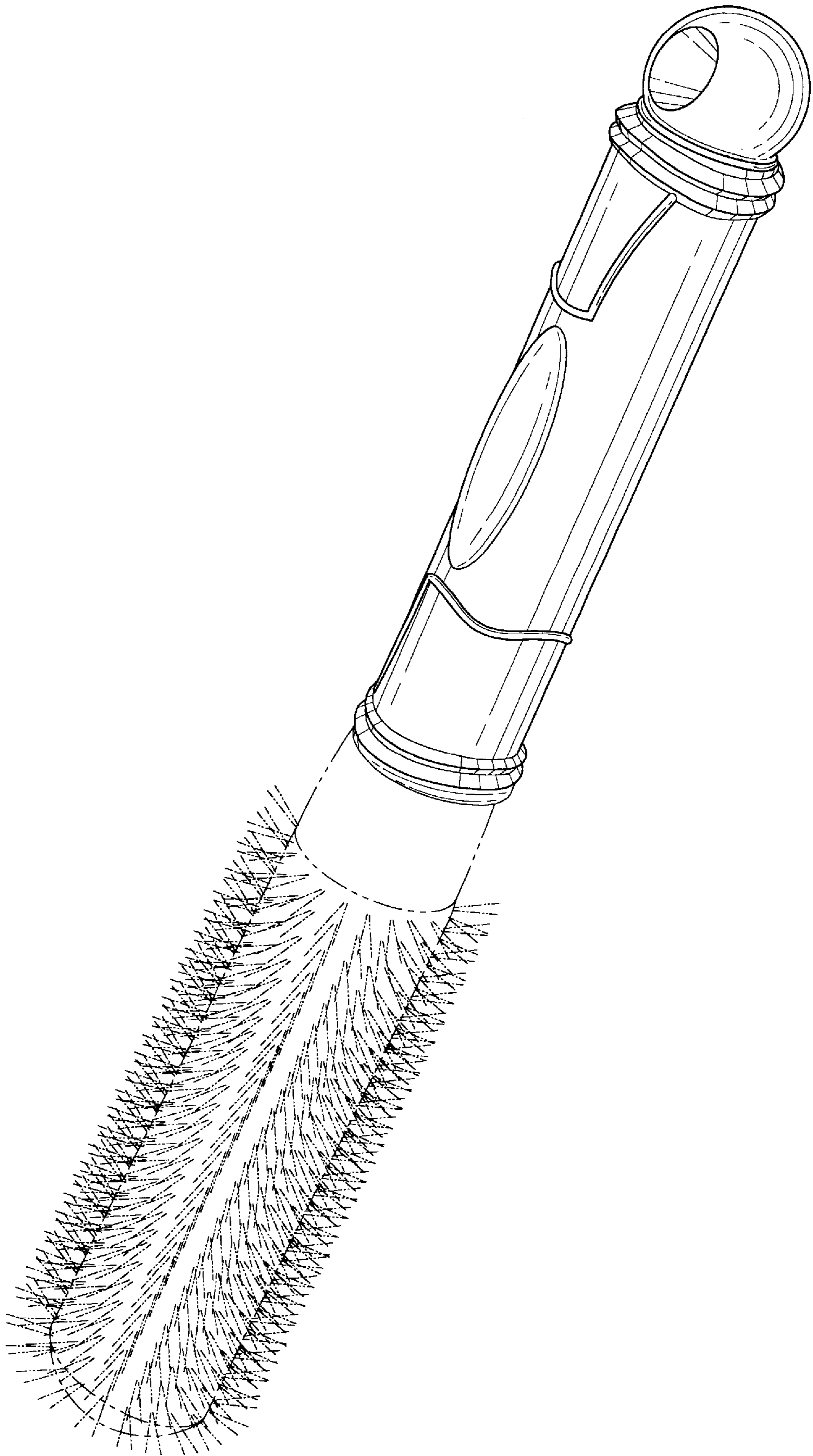

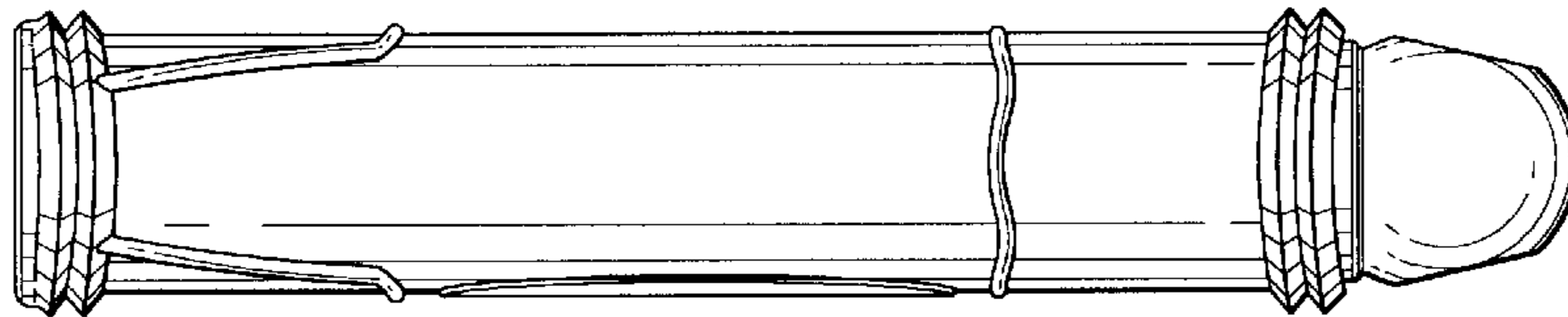

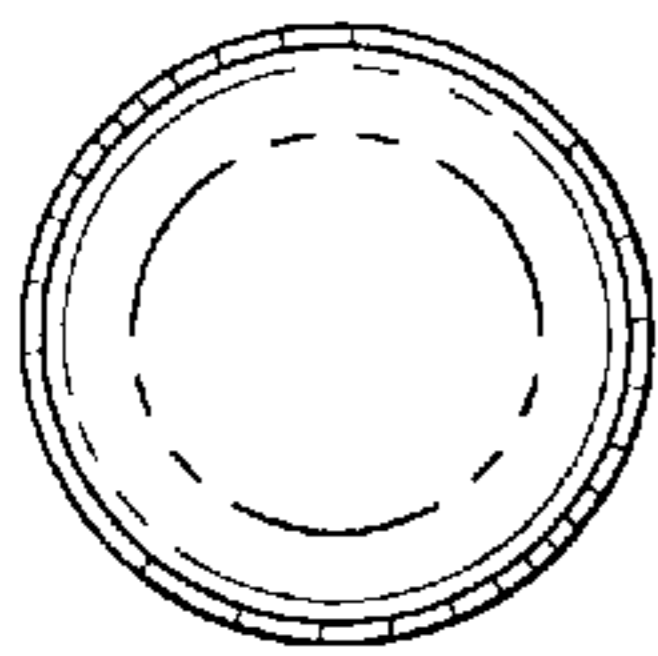

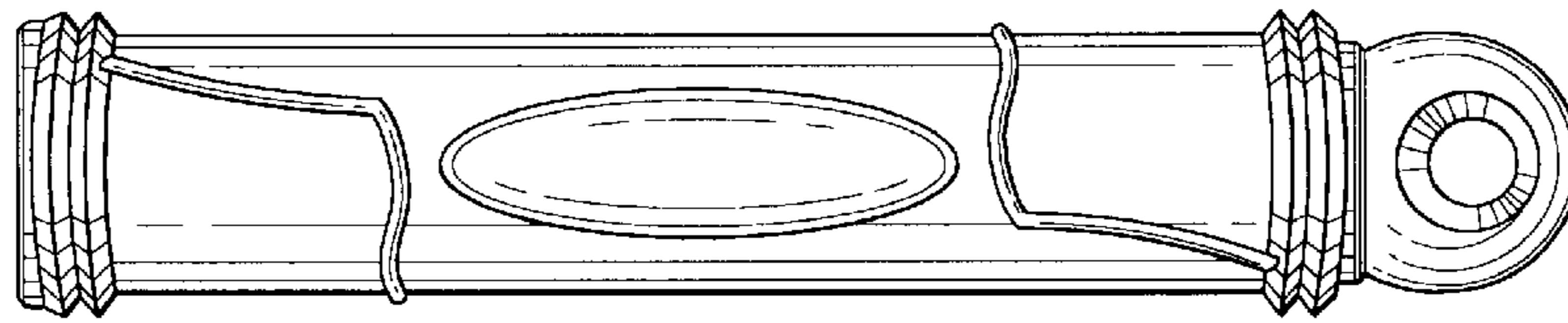

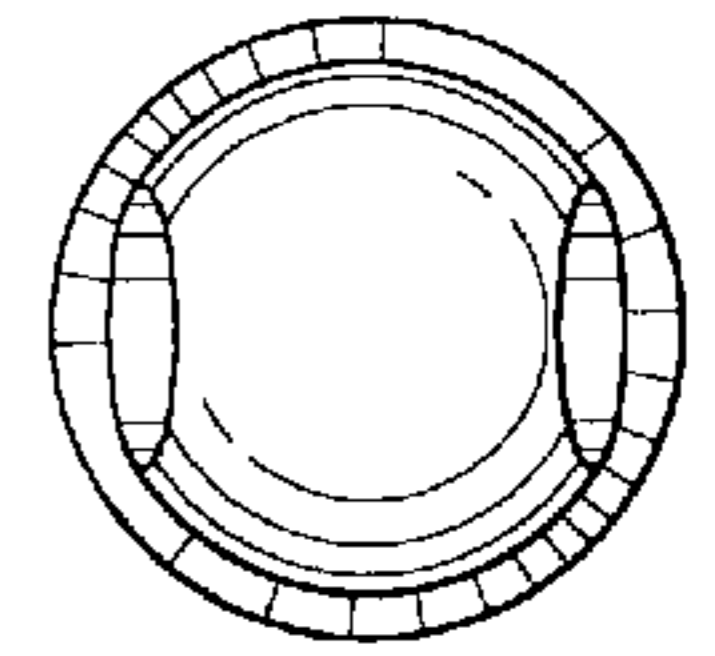

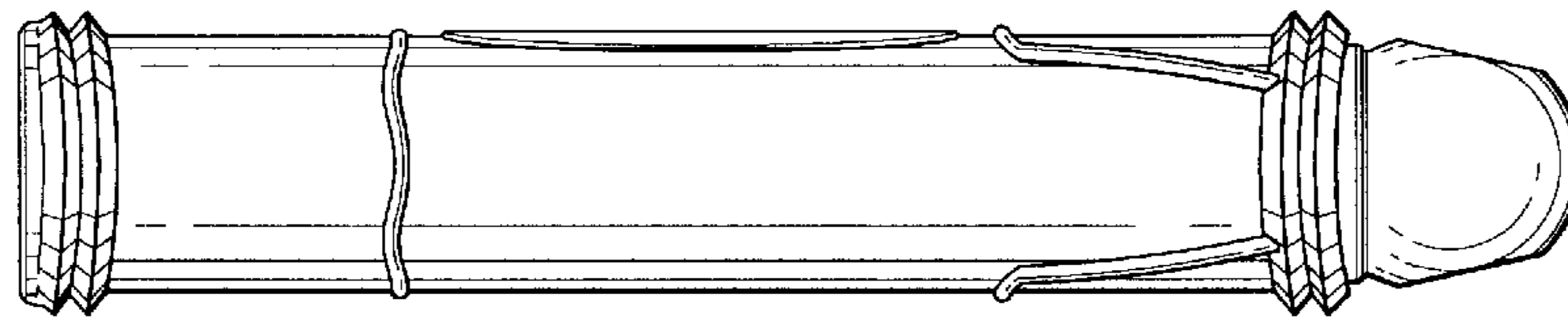
