DESCRIPTION

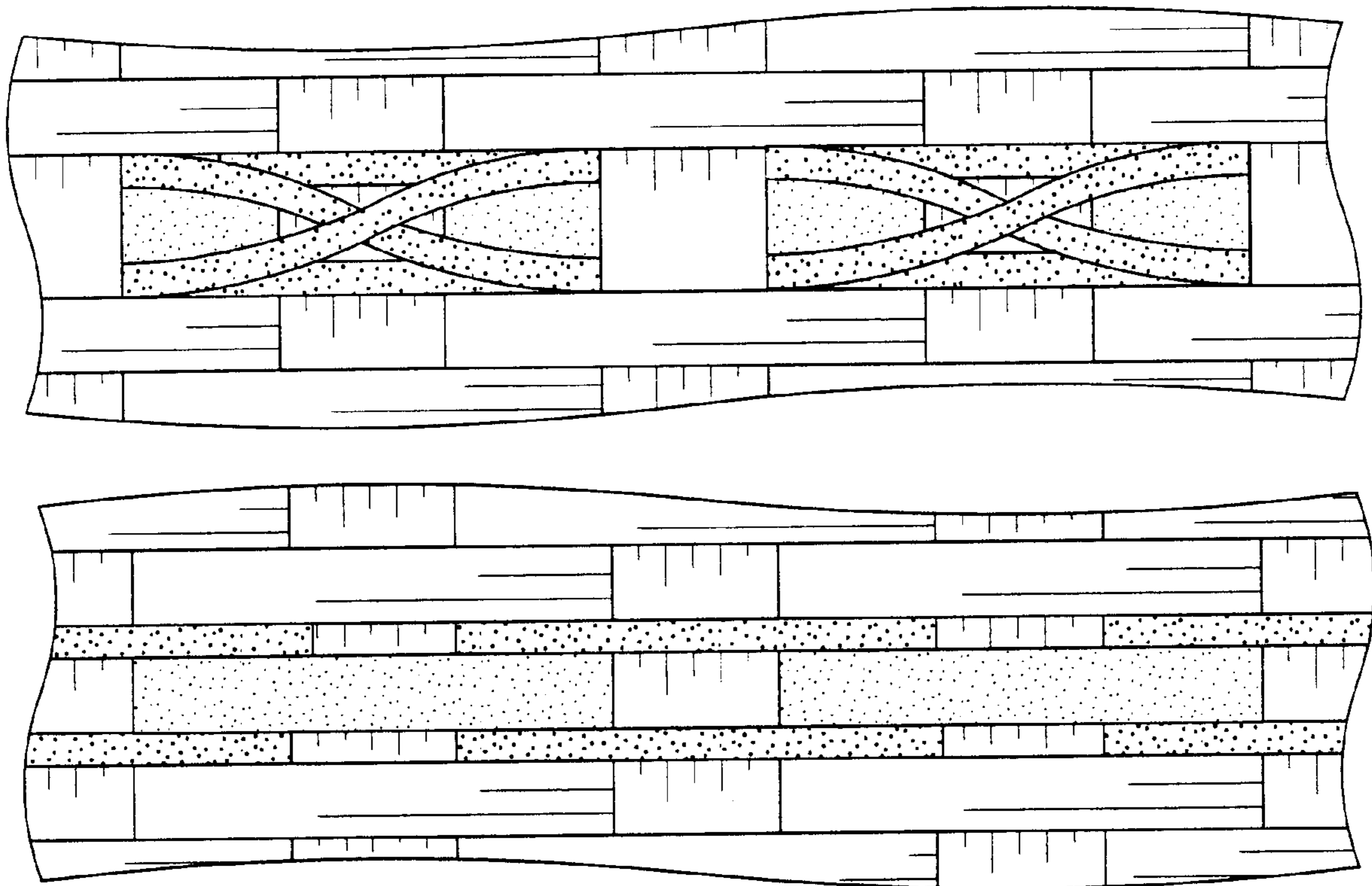
FIG. 1 is a front view of the woven panel showing our new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a front view of another embodiment of our design, having an appearance identical to that of the first embodiment except for the presence of color contrast indicated by stipple shading; and,

FIG. 4 is a rear view thereof.

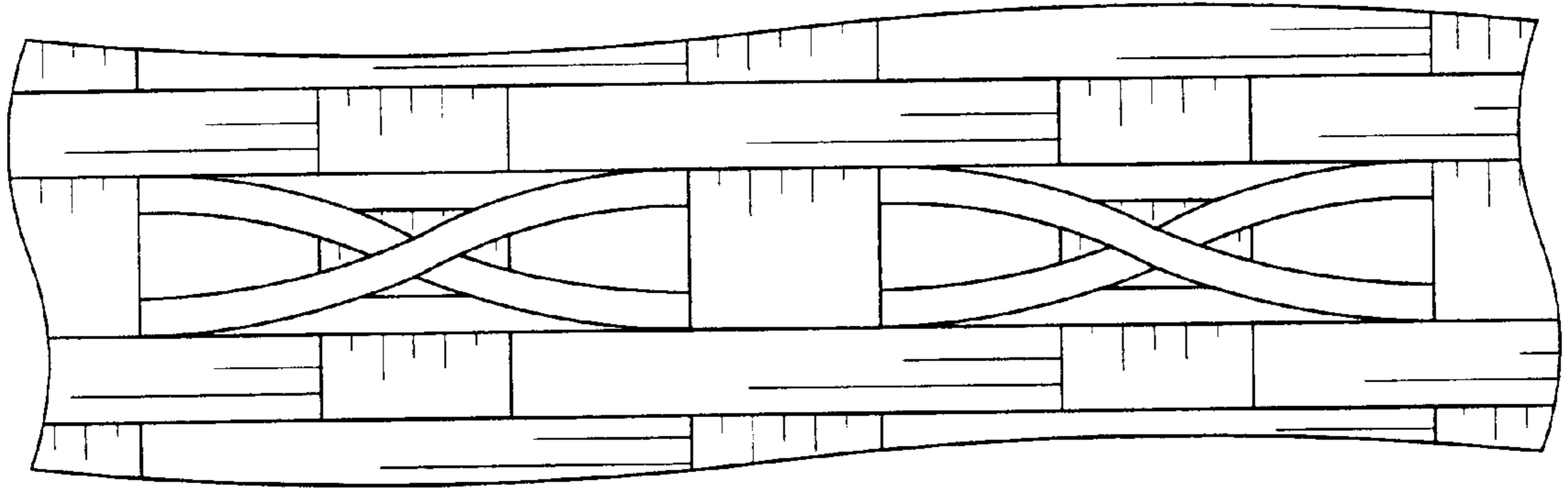

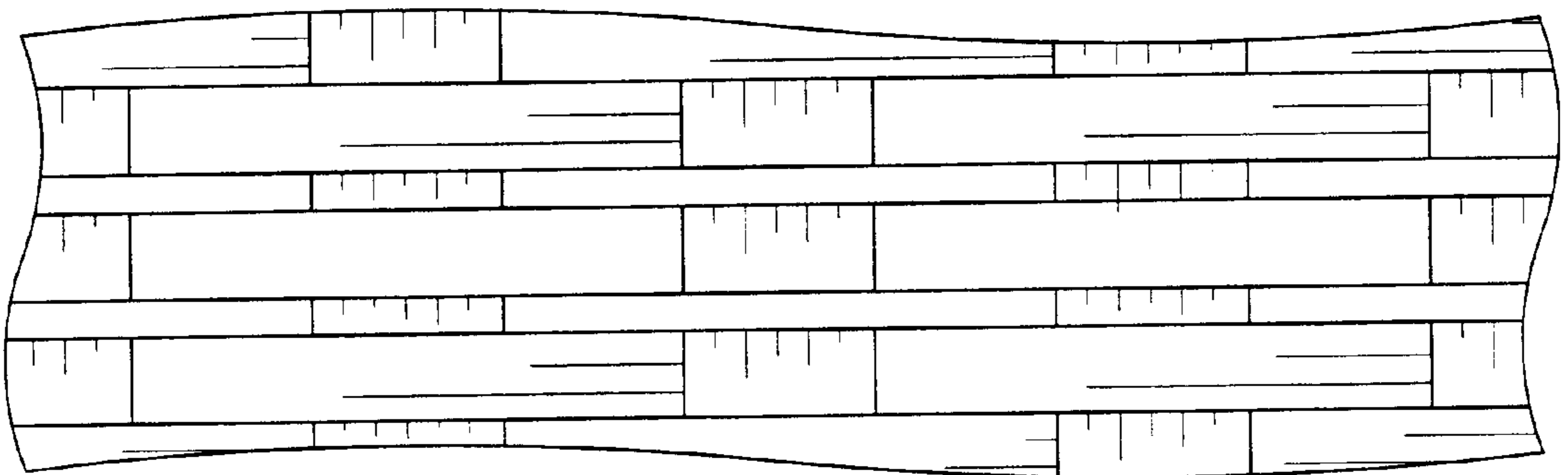

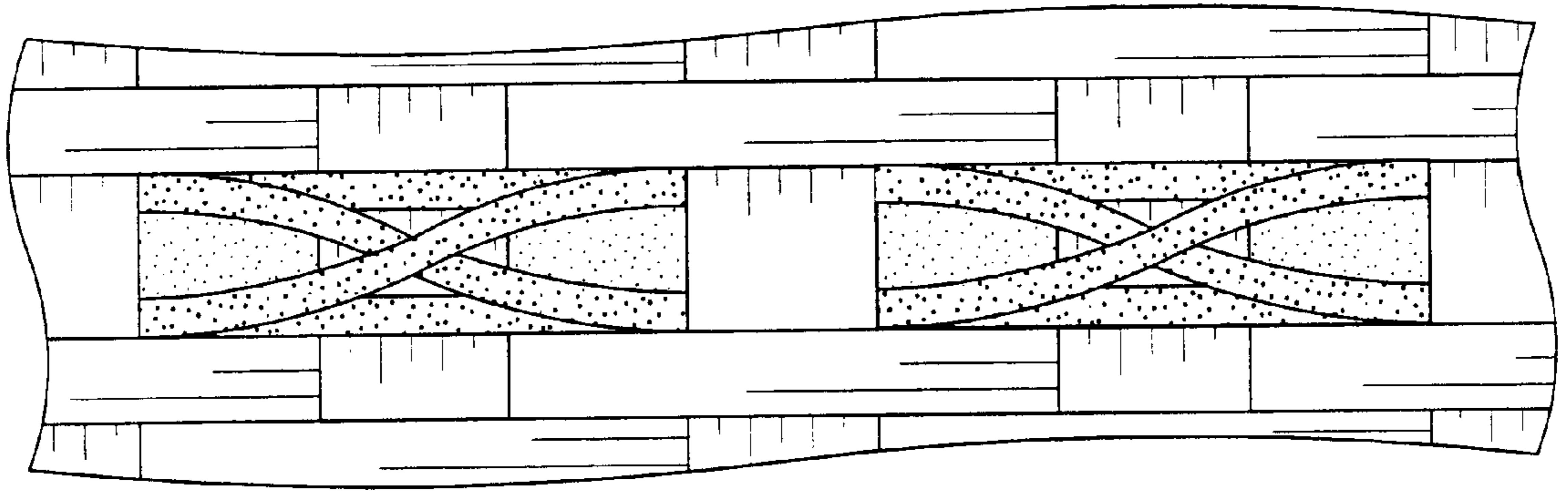

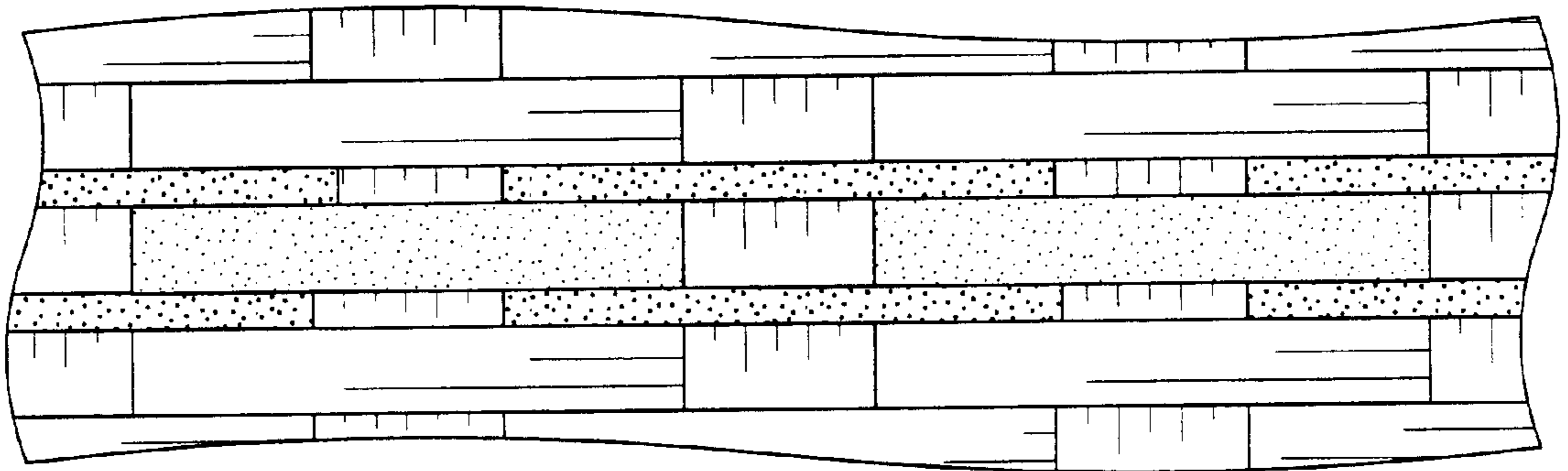
