(57) **CLAIM**

The ornamental design for an egg box, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view, showing an egg box in accordance with my invention;

FIG. 2 is a bottom perspective view of the egg box shown in FIG. 1;

FIG. 3 is a top perspective view of the egg box according to FIGS. 1 and 2, with the two parts shown pivoted to an open position;

FIG. 4 is a bottom perspective view according to FIG. 3;

FIG. 5 is a perspective view of the base middle sheet forming a holder for the removable cups;

FIG. 6 is a perspective view according to FIG. 5, showing the base middle sheet seen from the opposite side;

FIG. 7 is a top perspective view of a single upper cup, removed from base middle sheet;

FIG. 8 is bottom perspective view of the single cup shown in FIG. 7;

FIG. 9 is a top perspective view of a single lower cup, removed from base middle sheet; and,

FIG. 10 is a bottom perspective view of the single cup shown in FIG. 9.

The elements in FIGS. 5–10 are shown separately for clarity of illustration only.

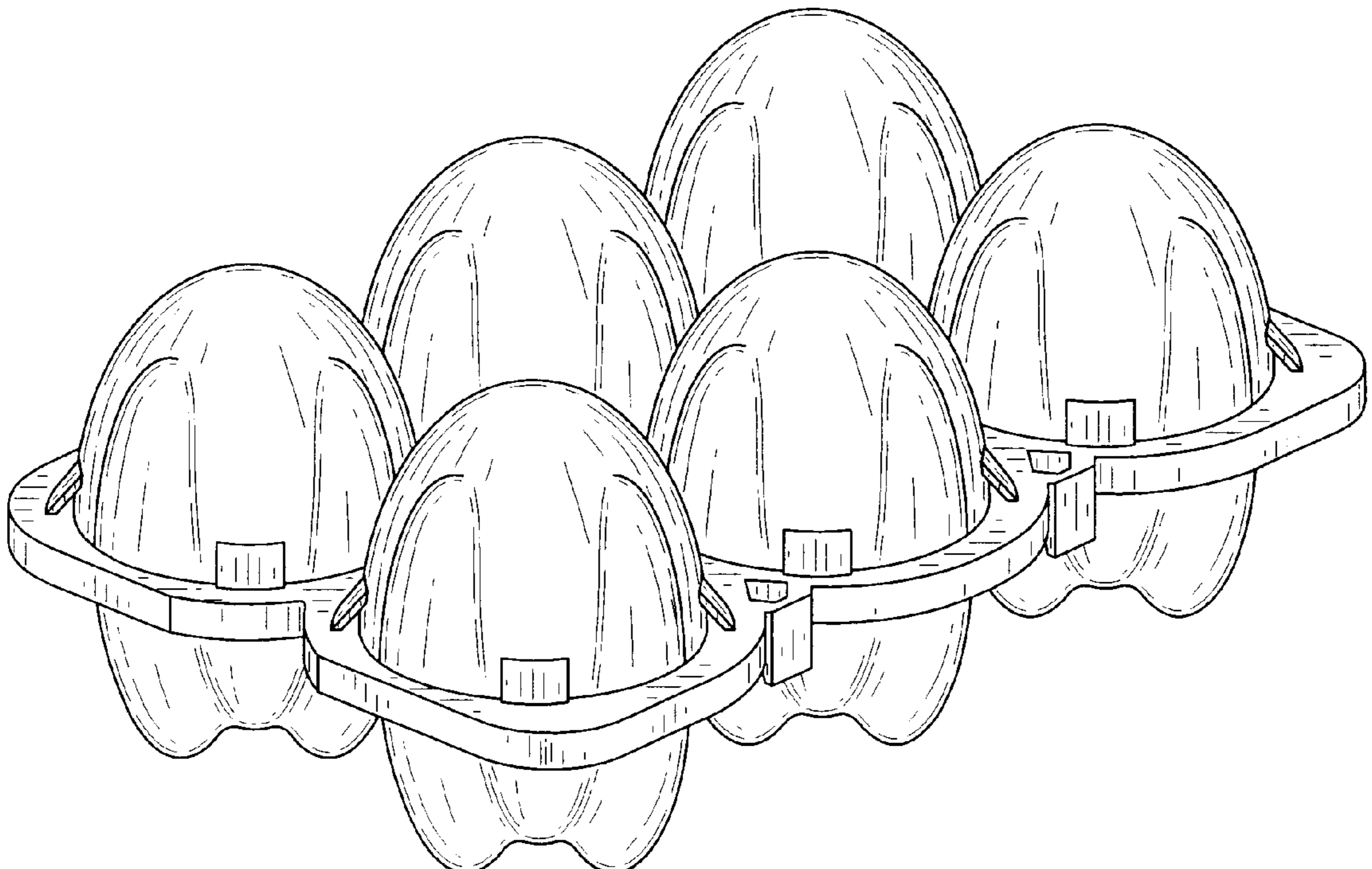

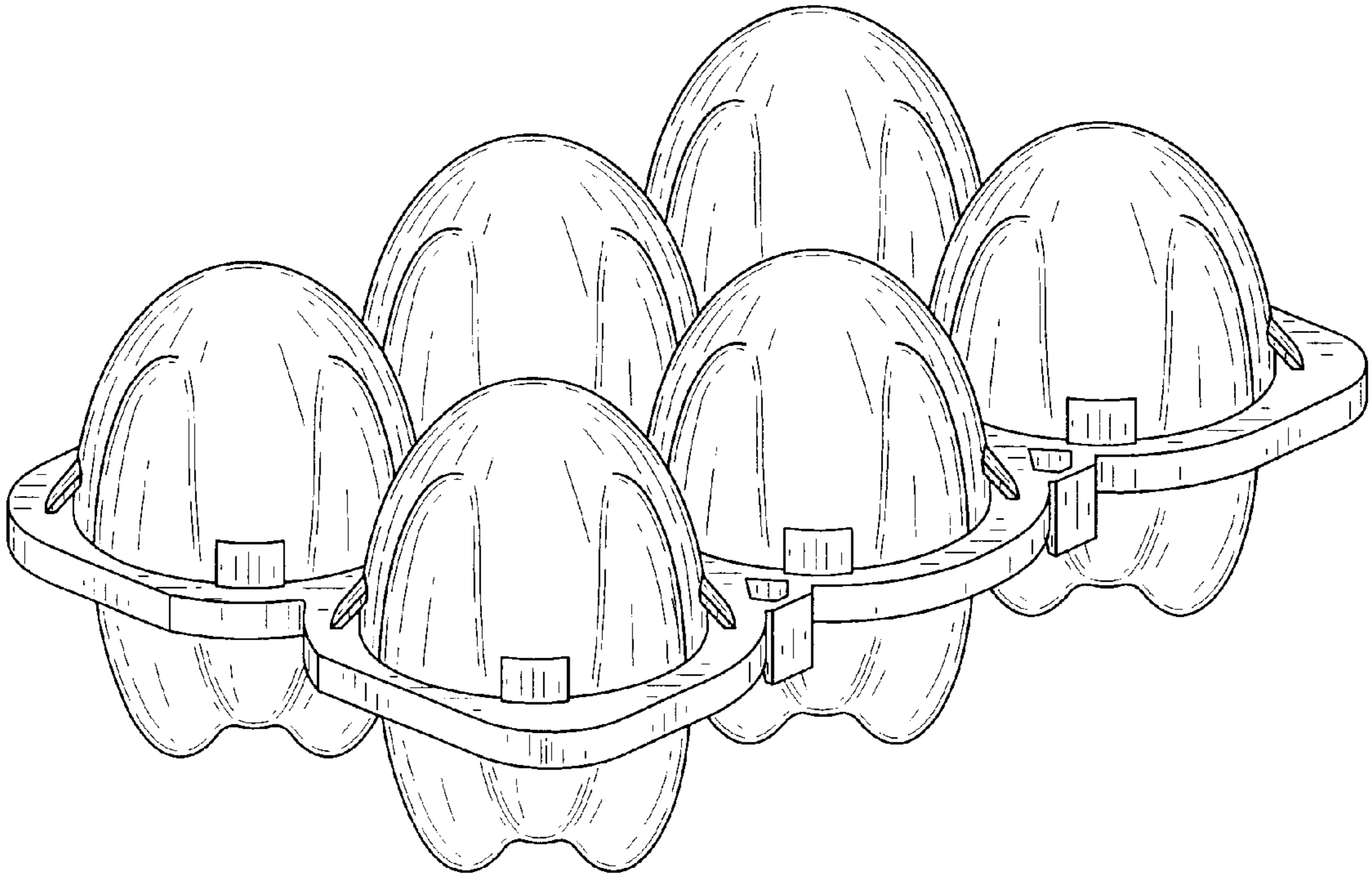

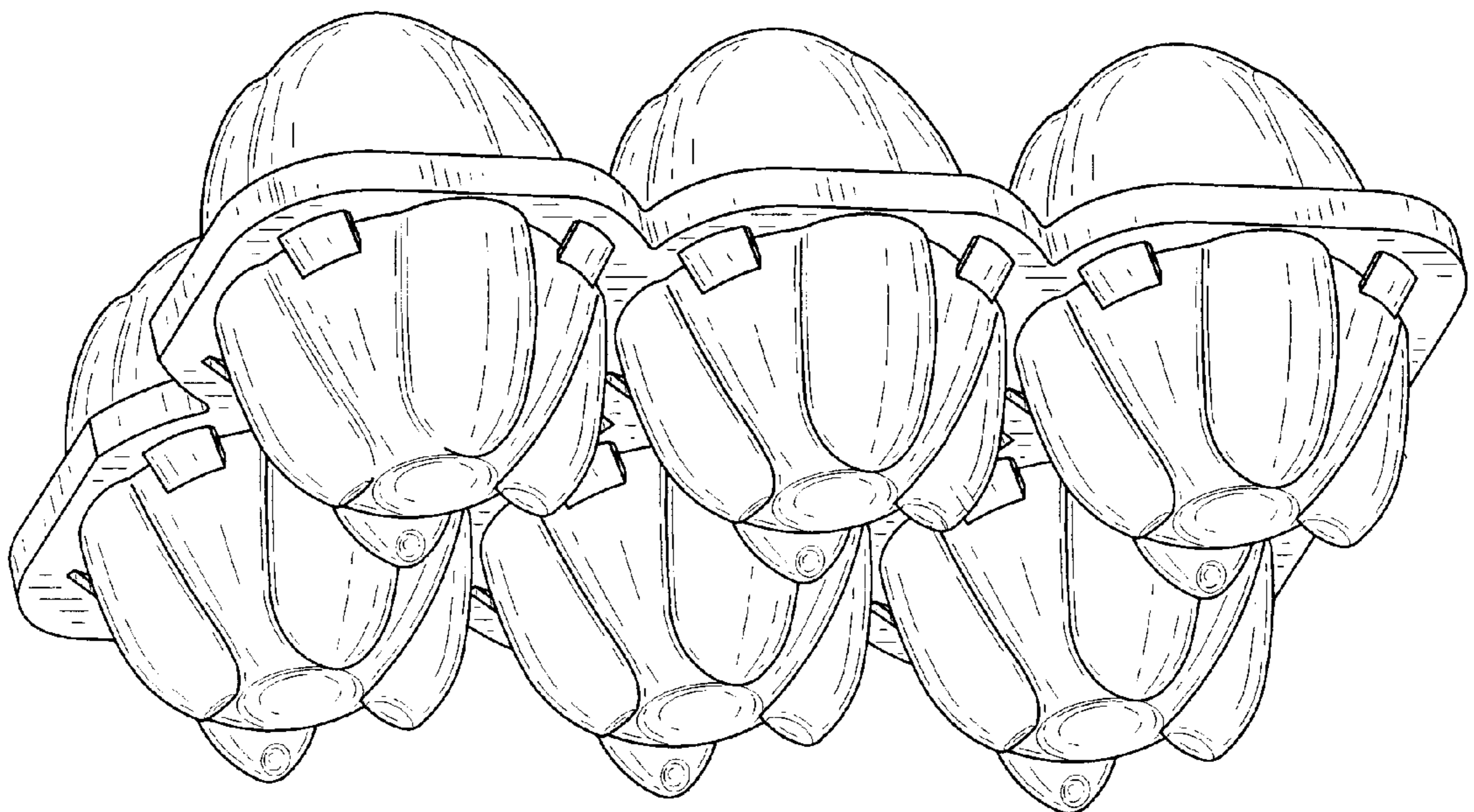

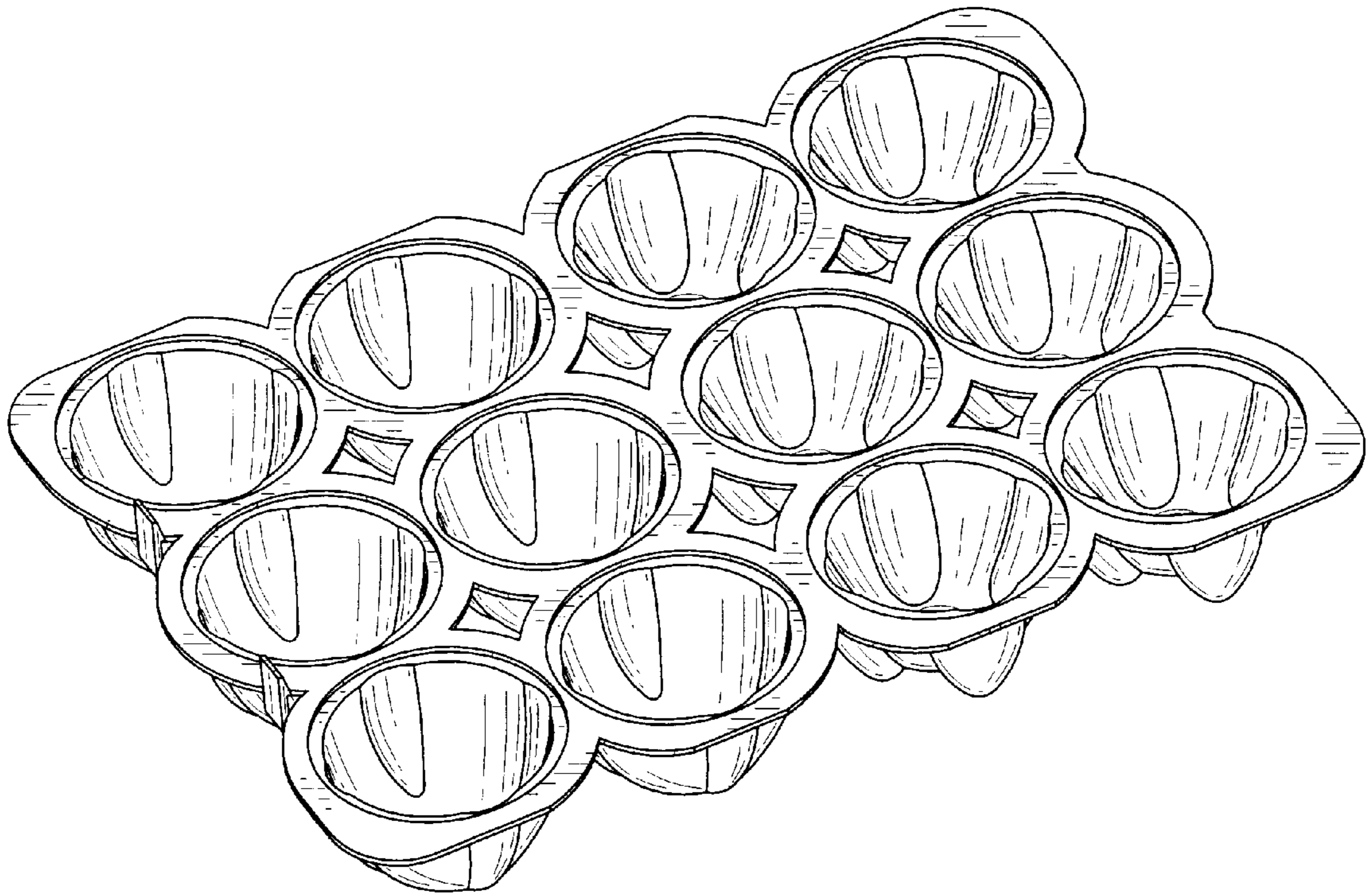

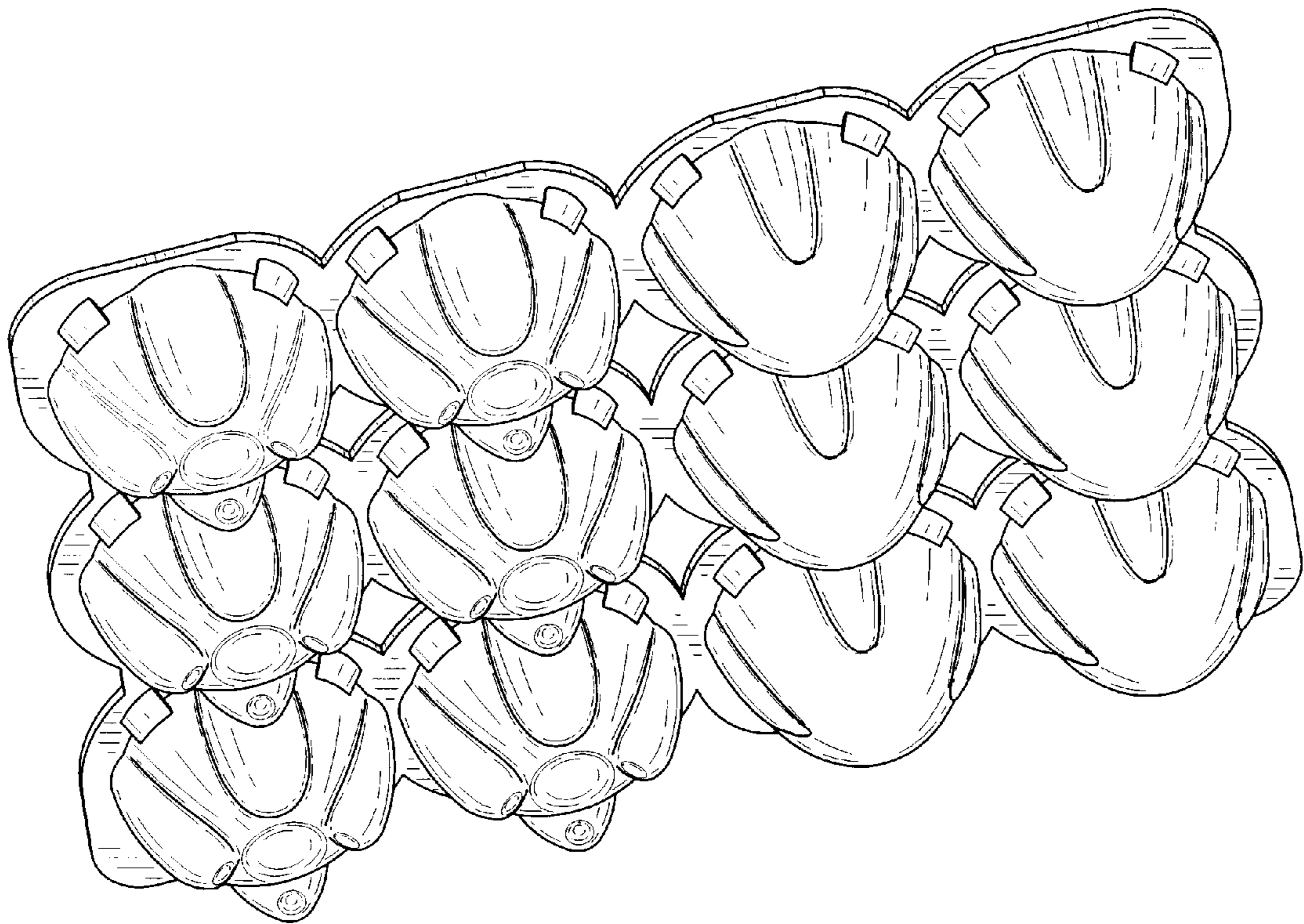

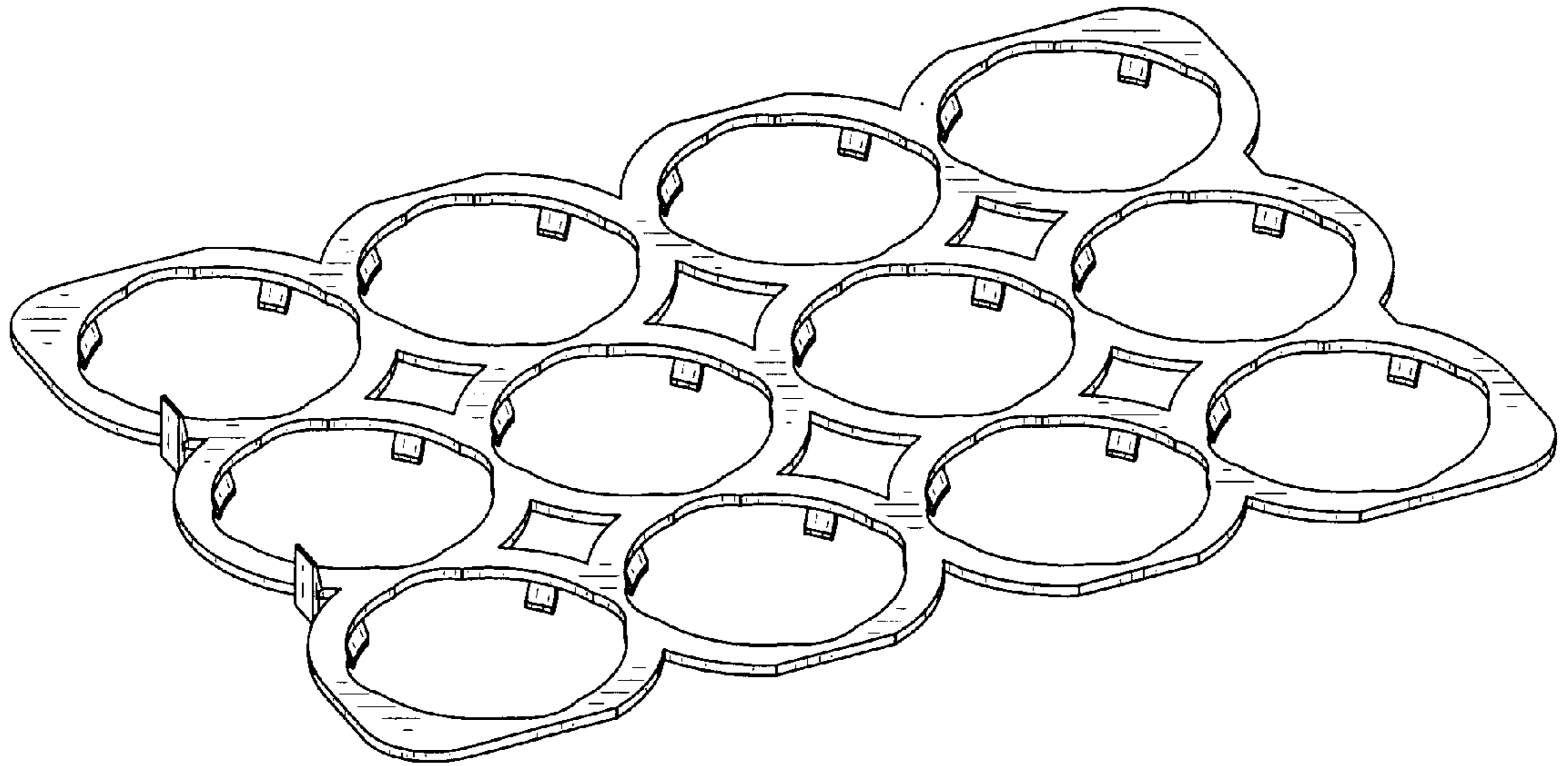

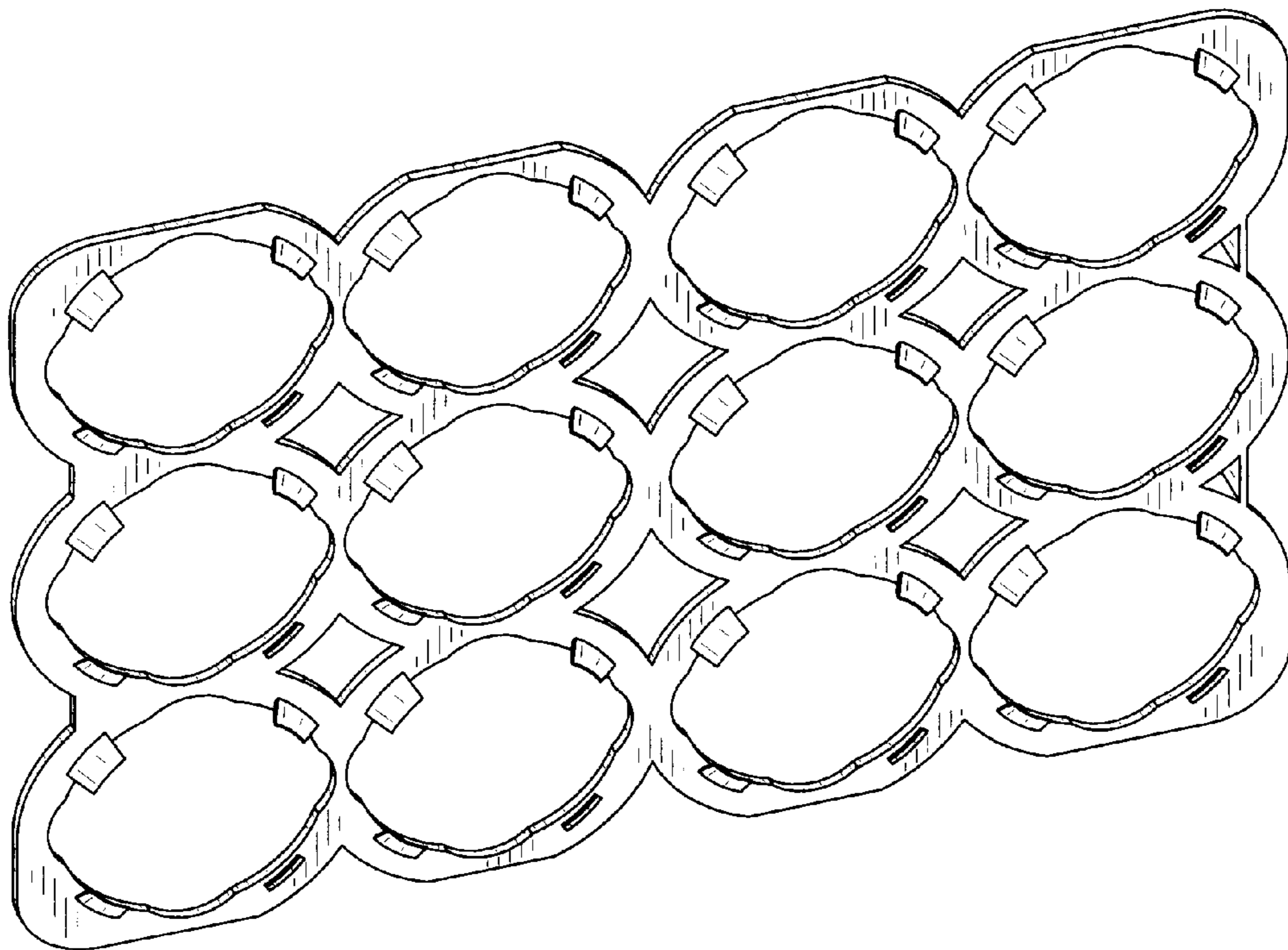

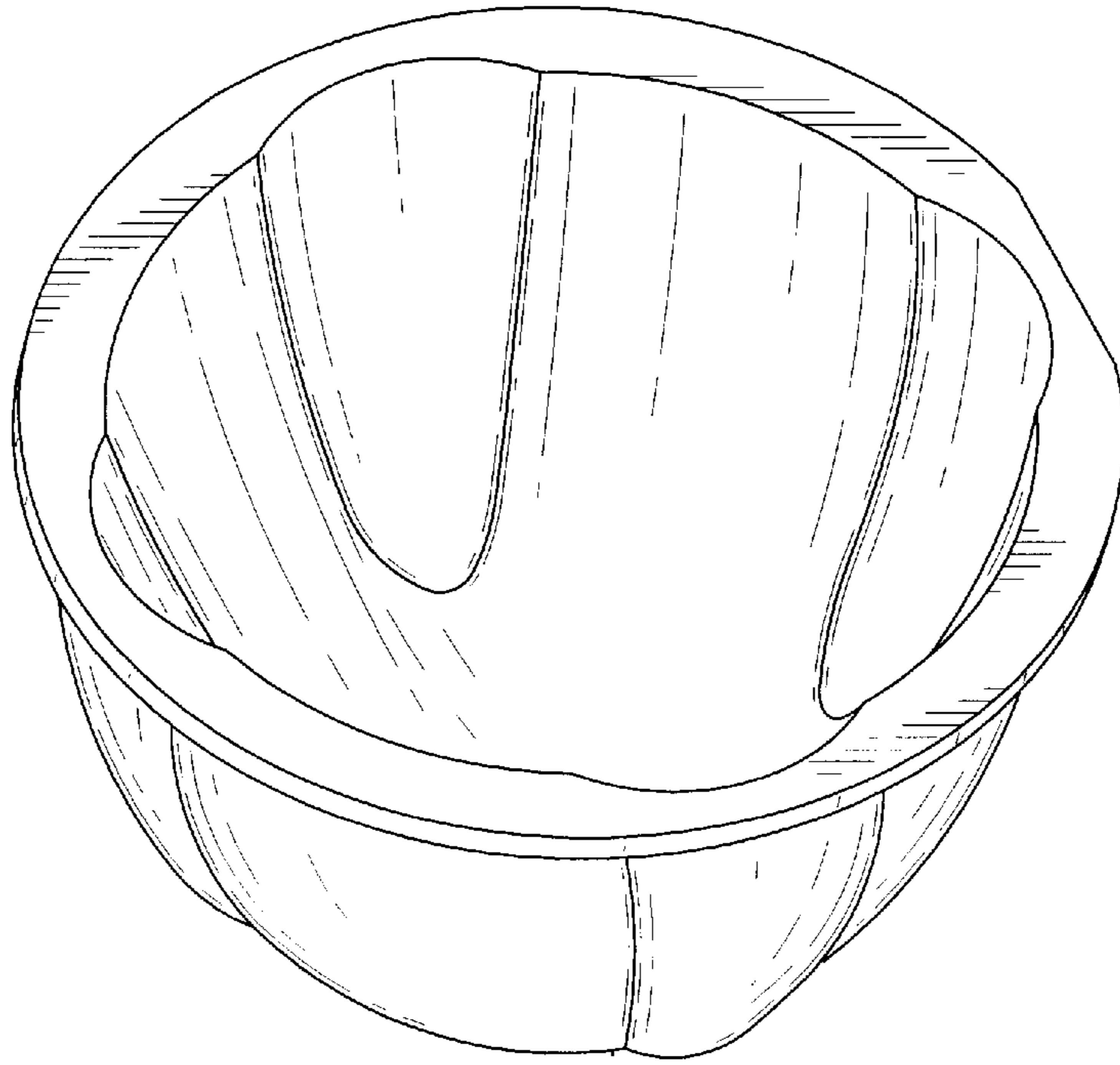

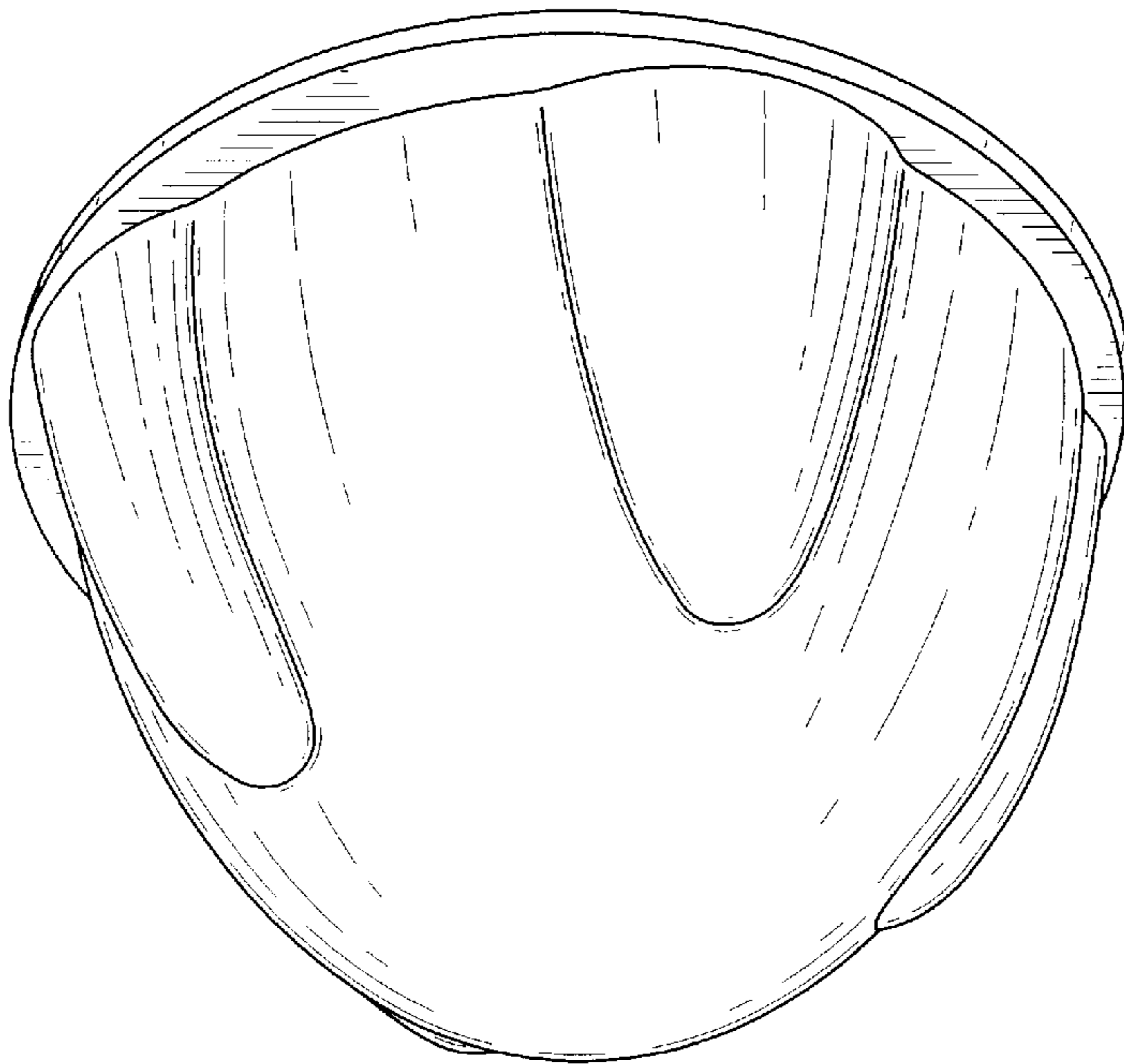

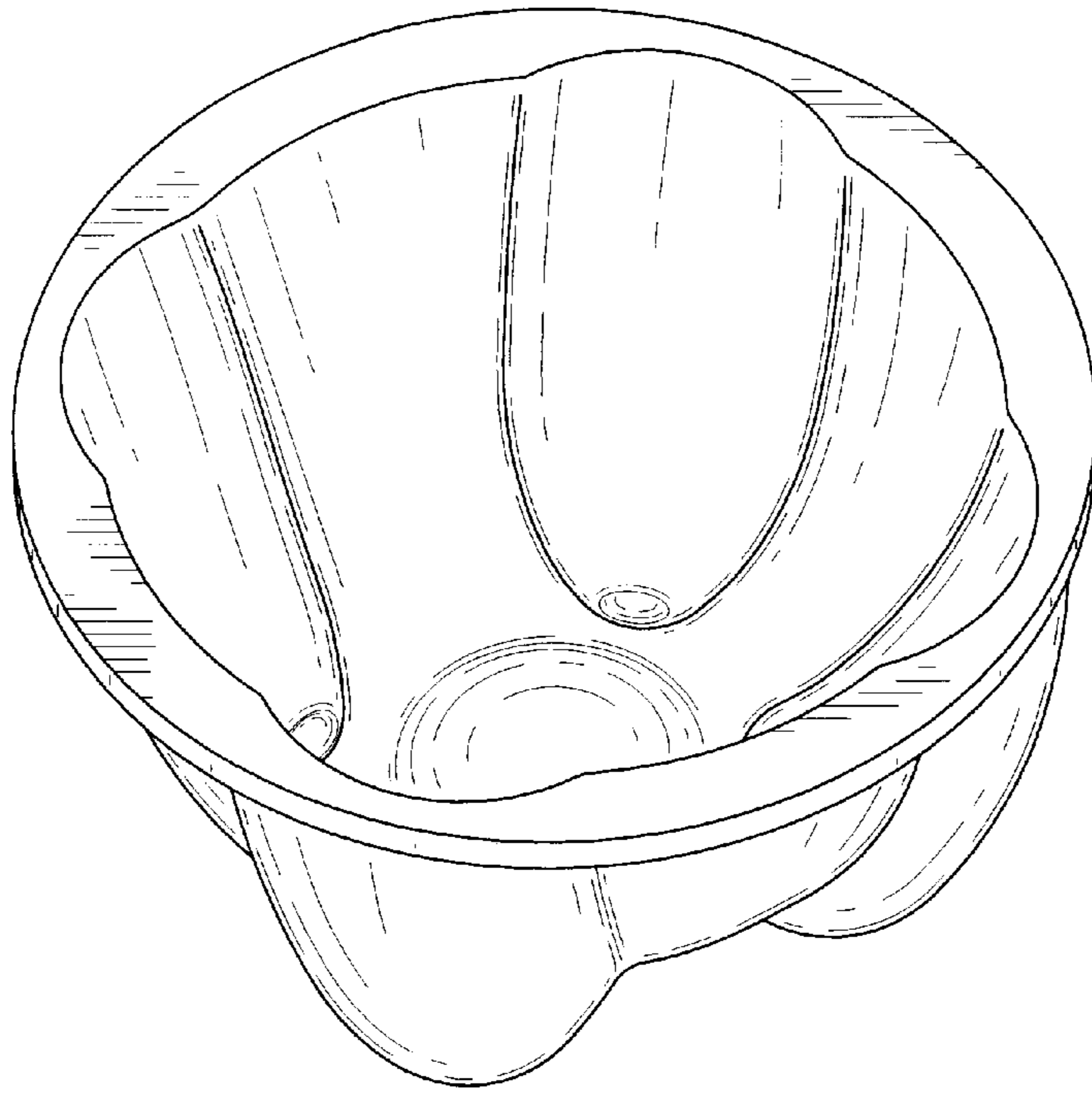
