(57) **CLAIM**

The ornamental design for an automobile bumper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an automobile bumper showing my new design;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a right side elevation view thereof, the left side elevation view is a mirror image of the right side elevation view;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a rear elevation view thereof; and,  
 FIG. 7 is a perspective view thereof, the portions of the vehicle shown in broken lines are for illustrative purposes only and form no part of the claimed design.

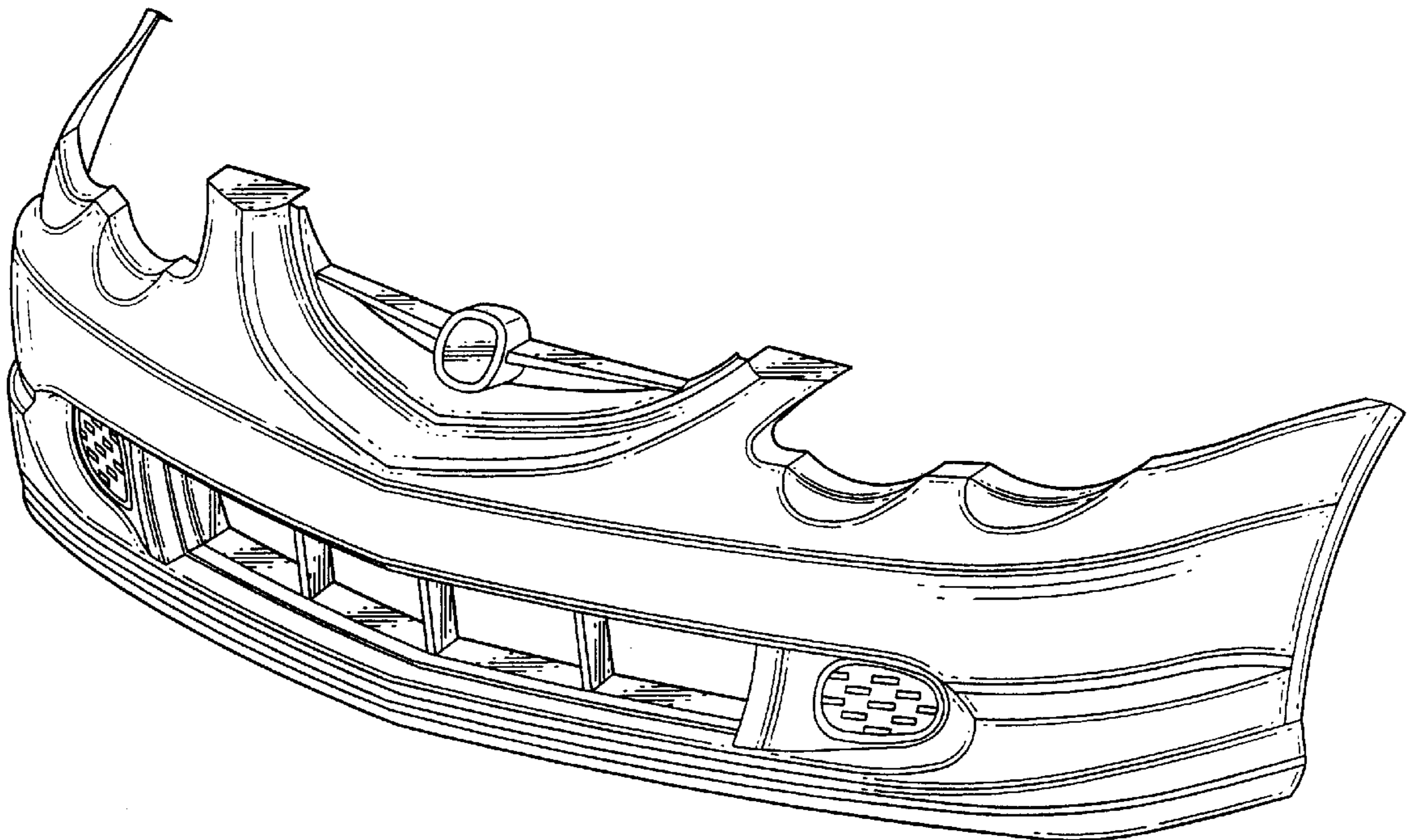

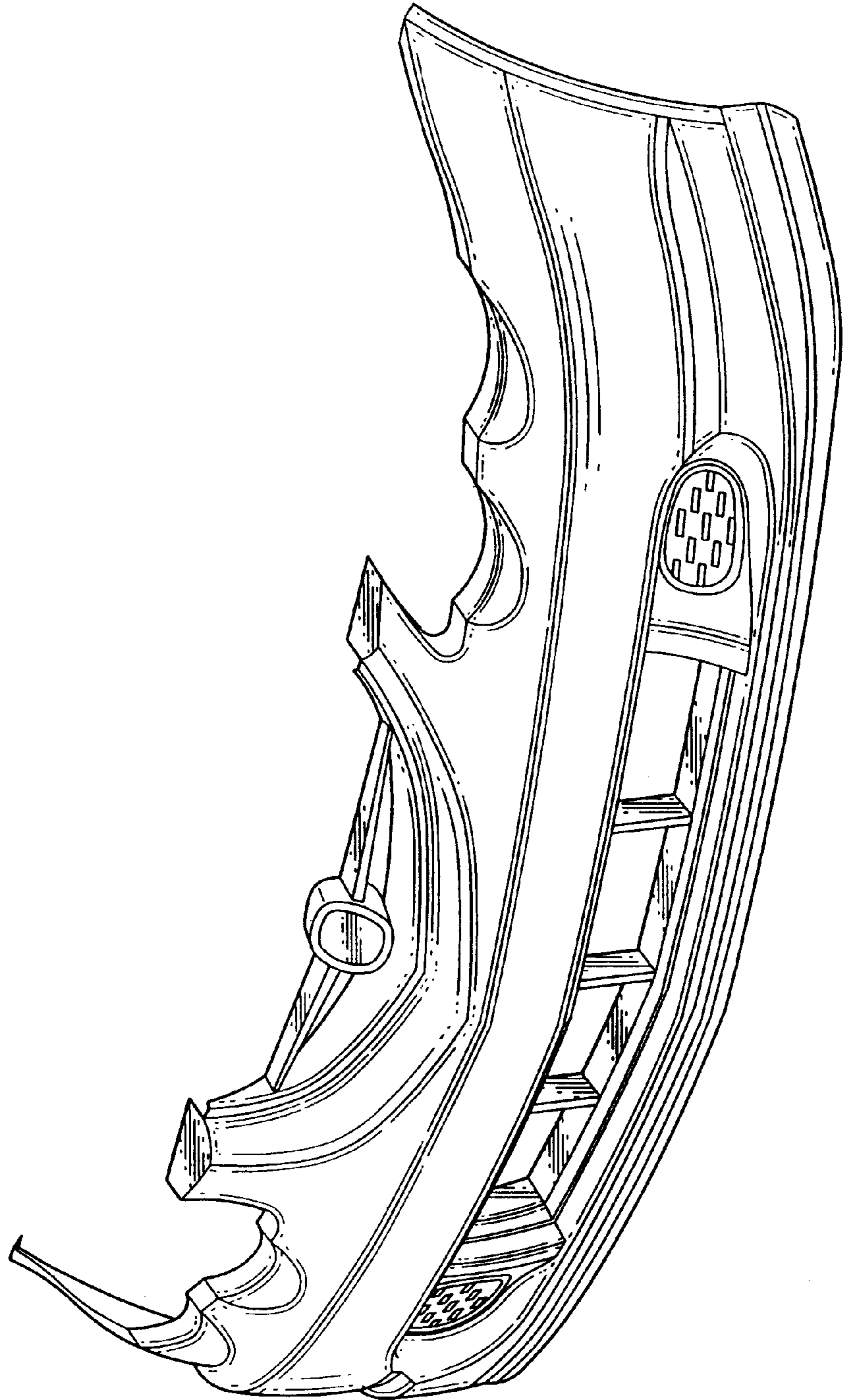

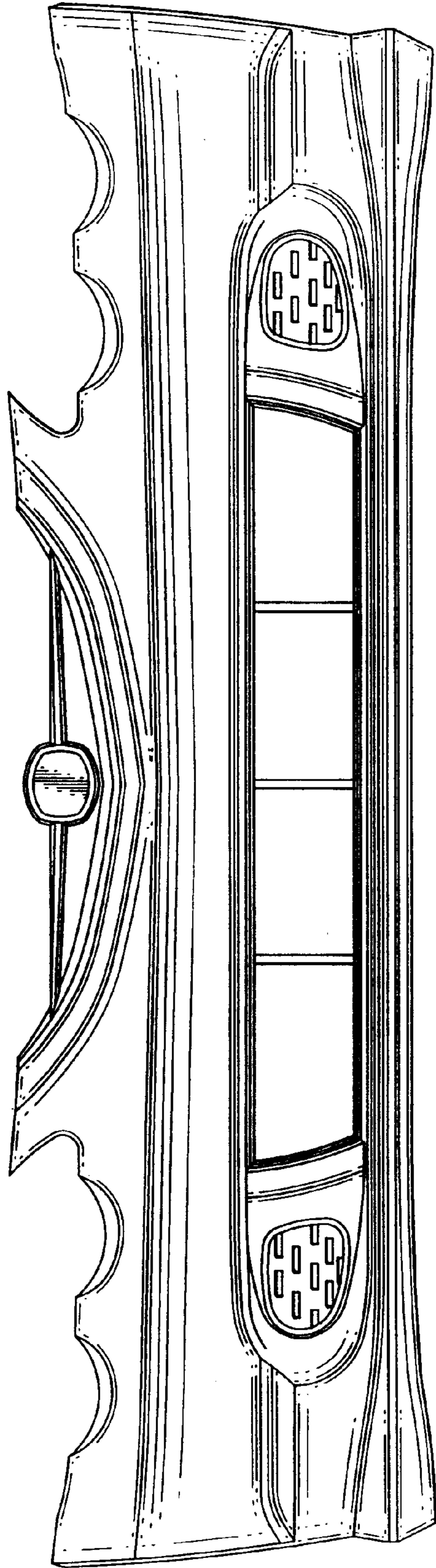

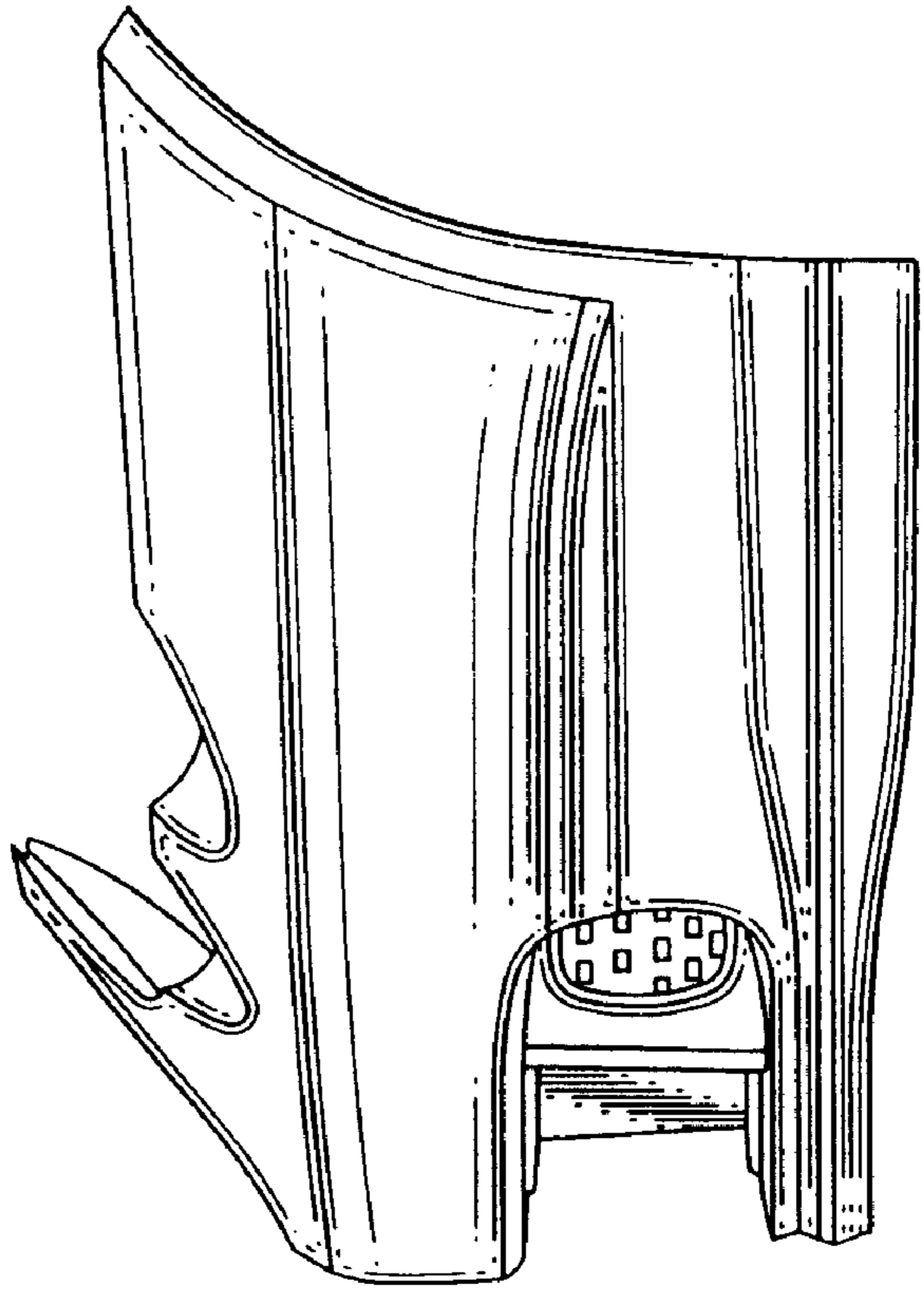

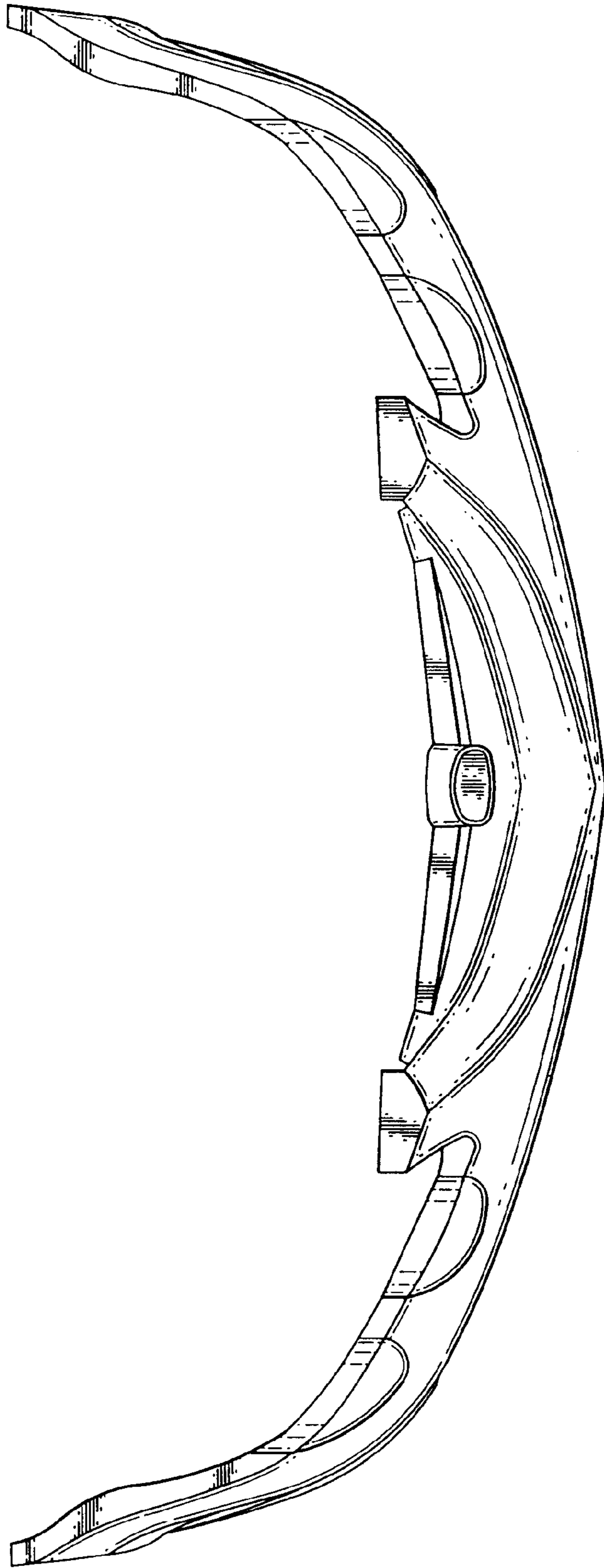

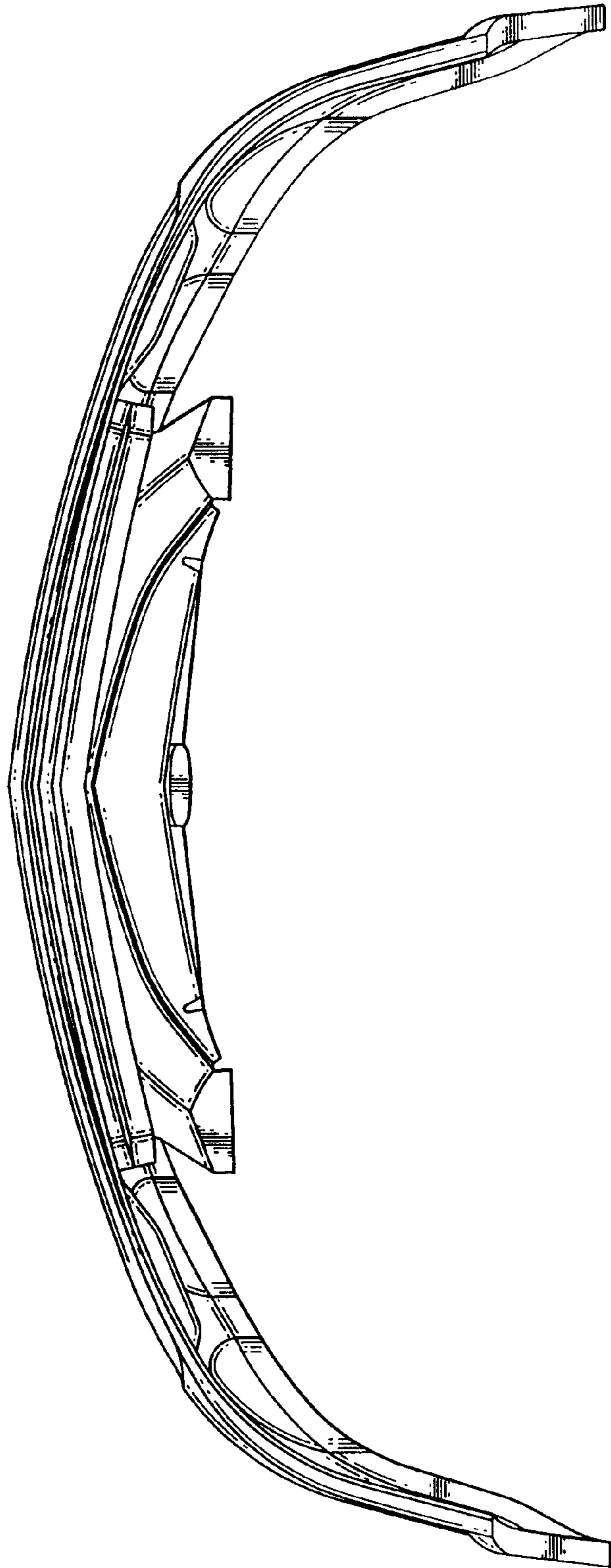
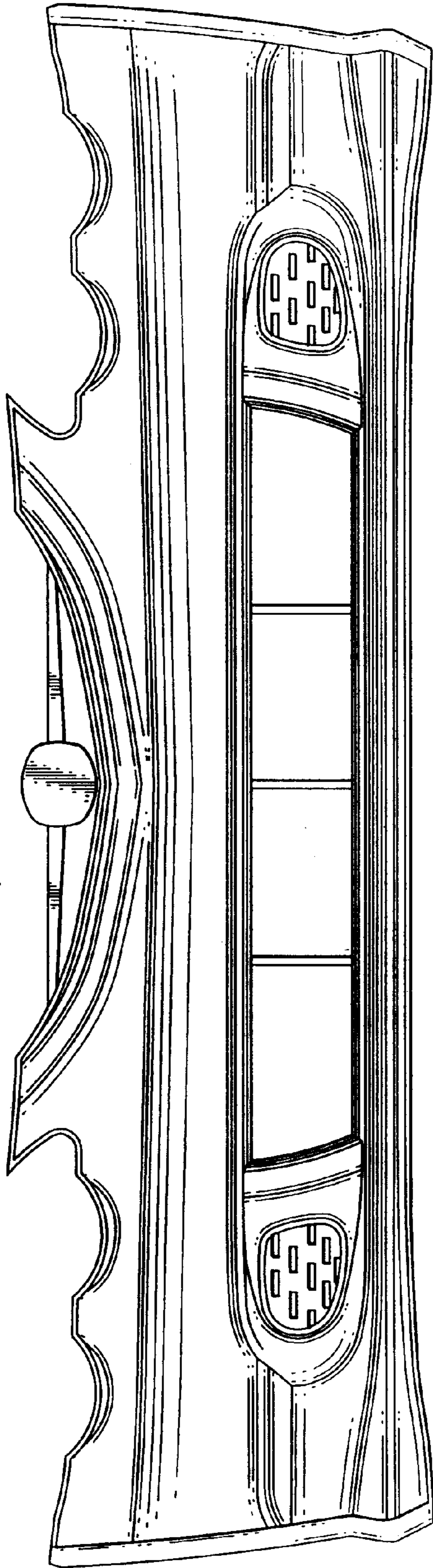

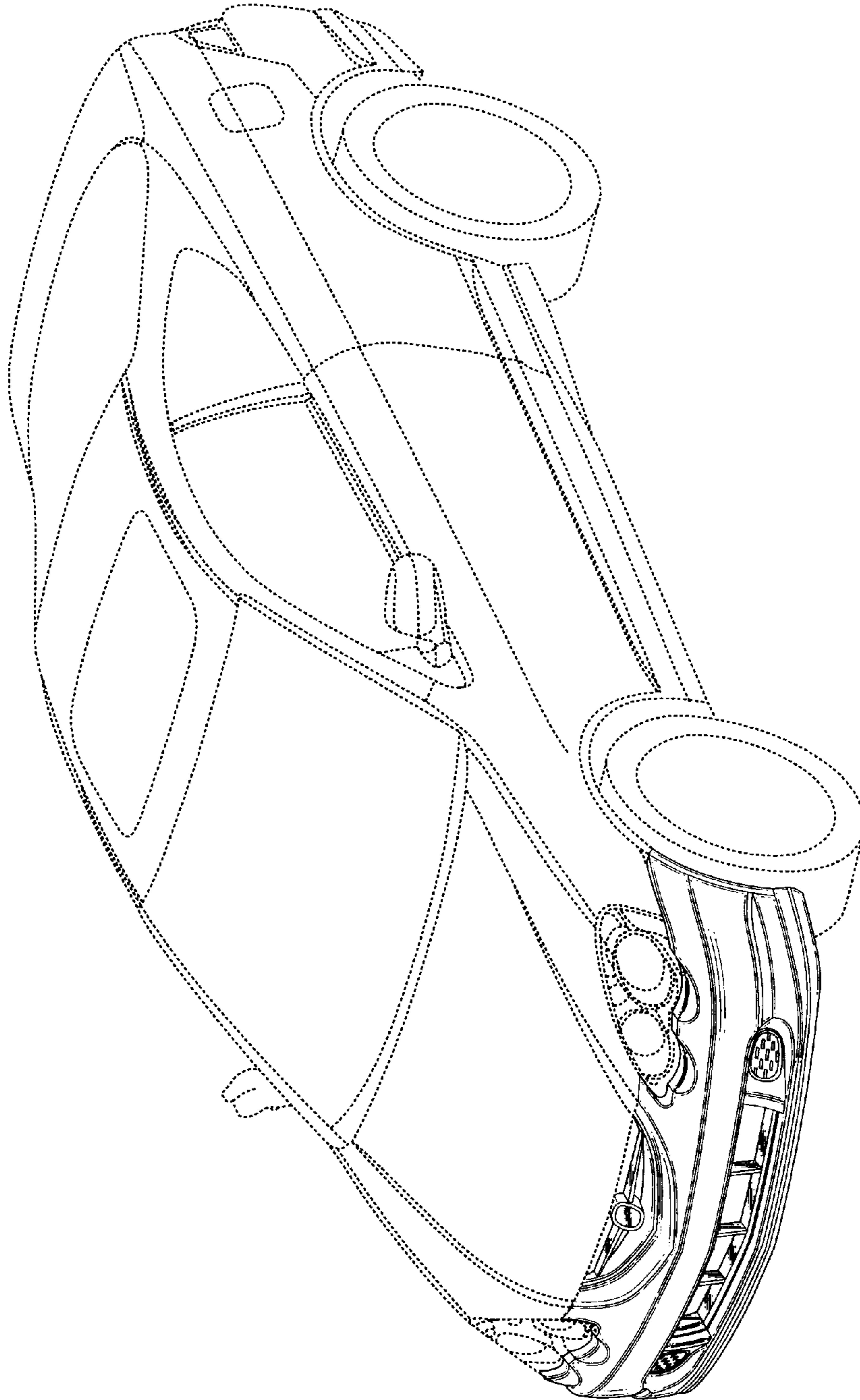
