in accordance with the present invention.

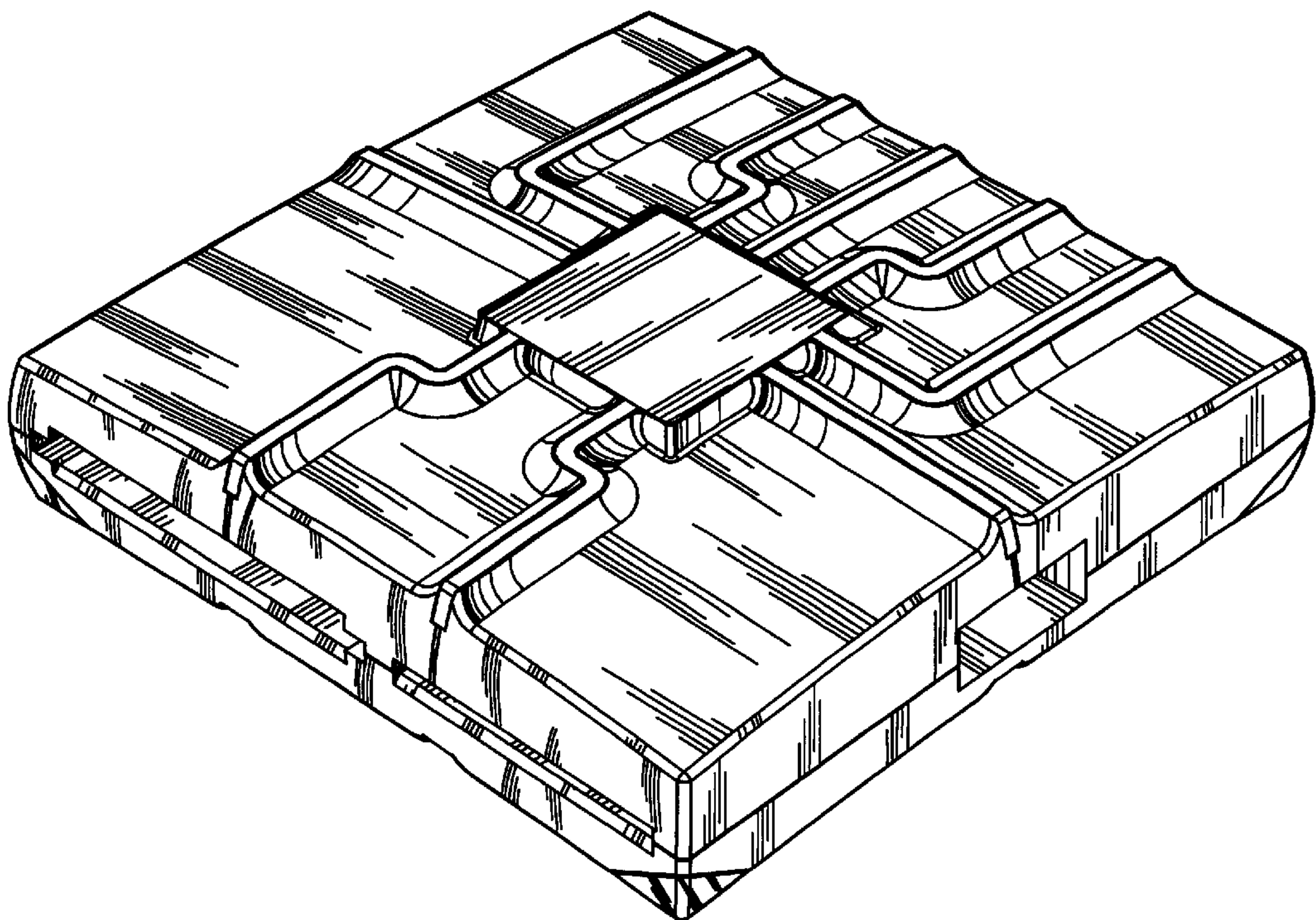
FIG. 4 is a side view of a USB hub with media reader, in

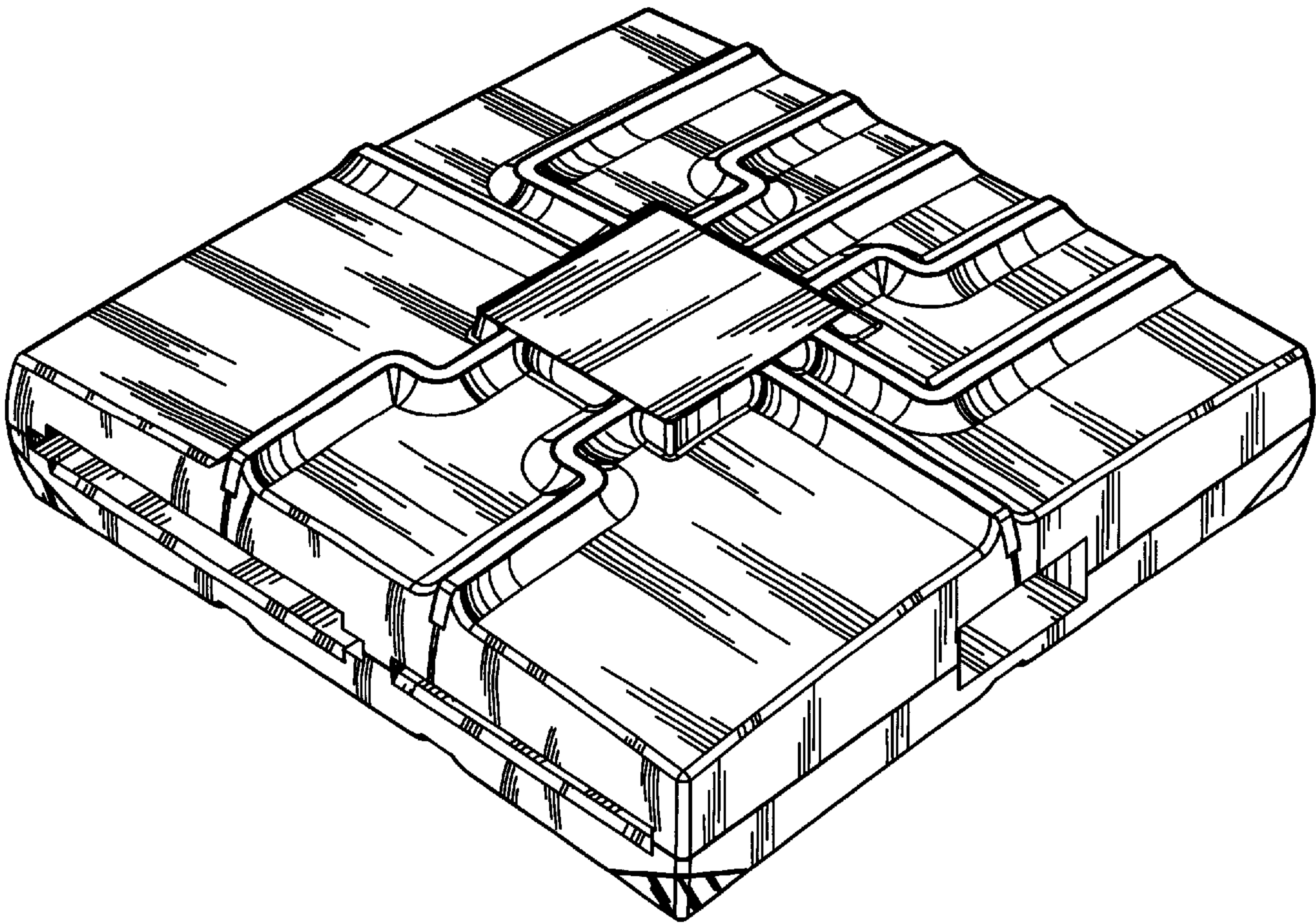

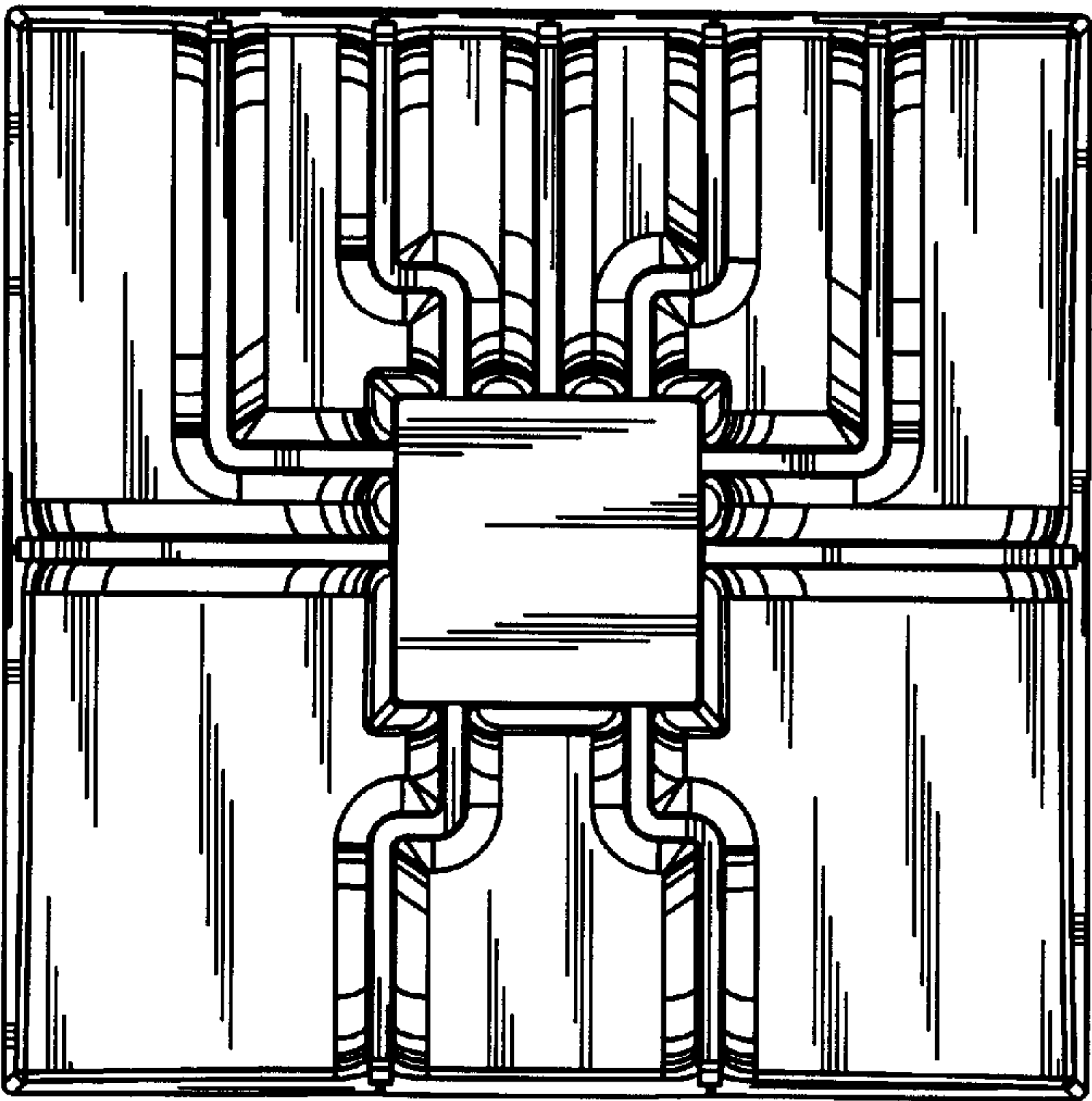

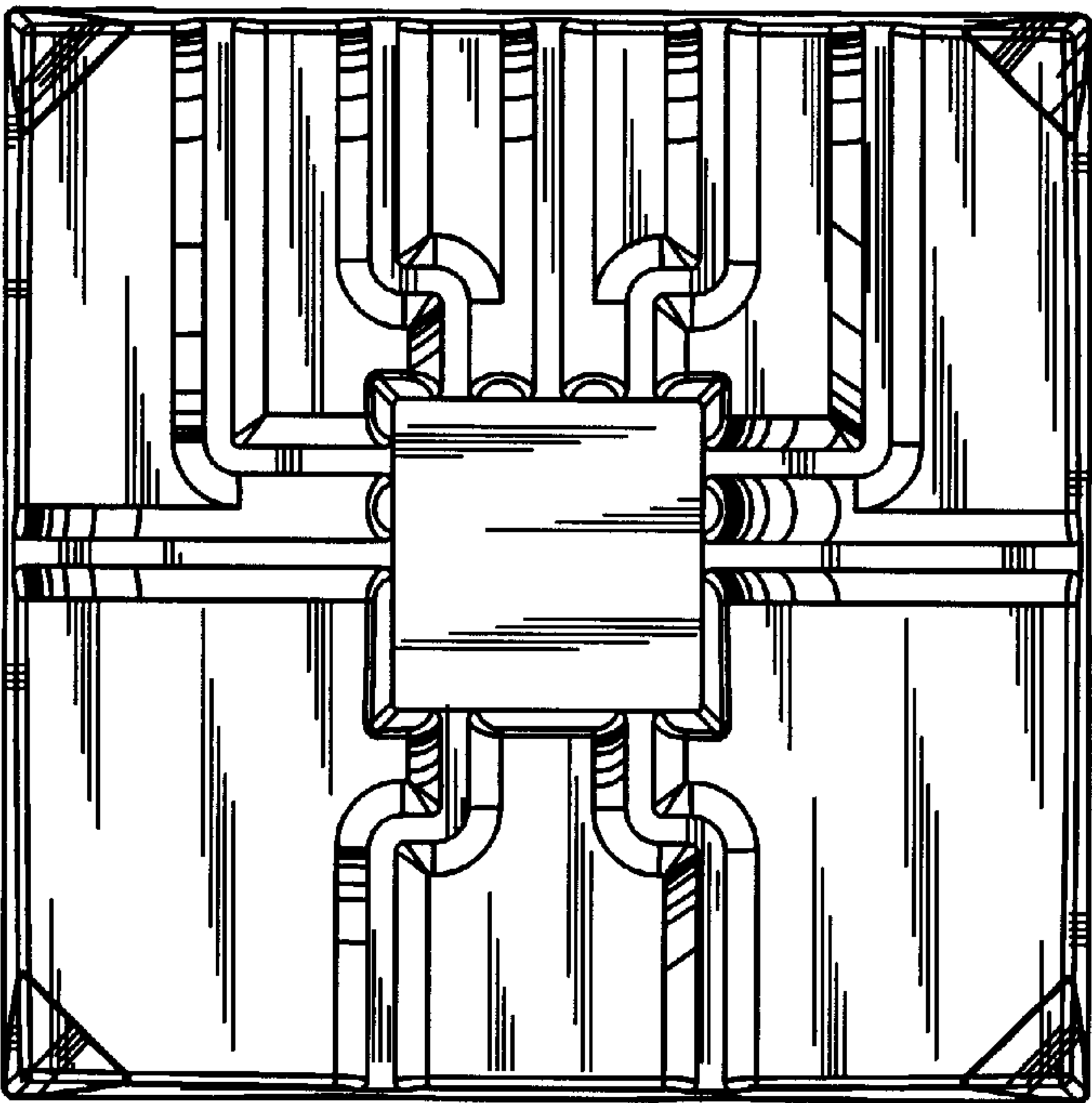

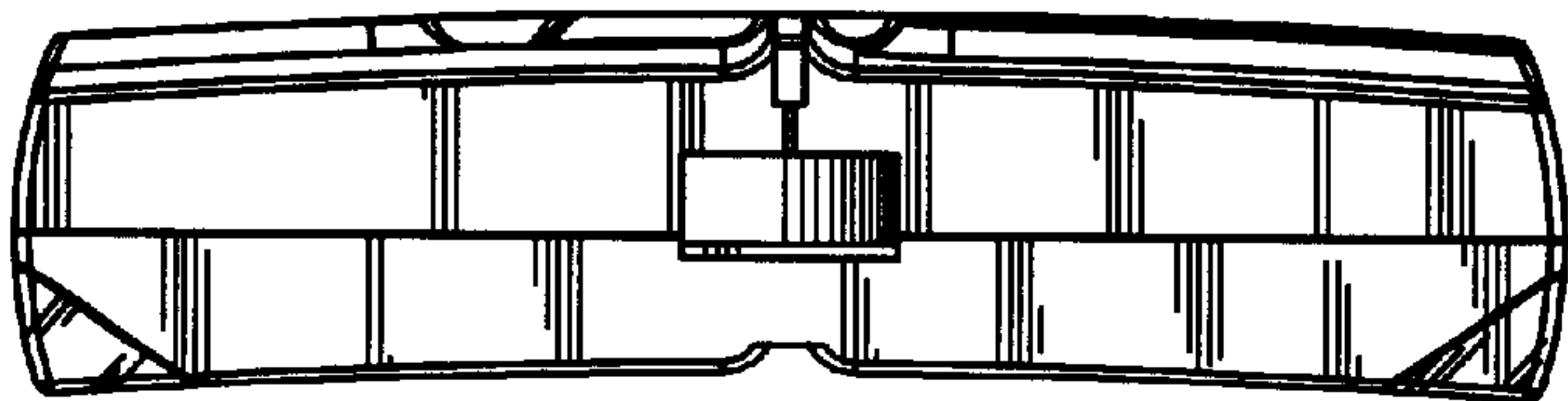

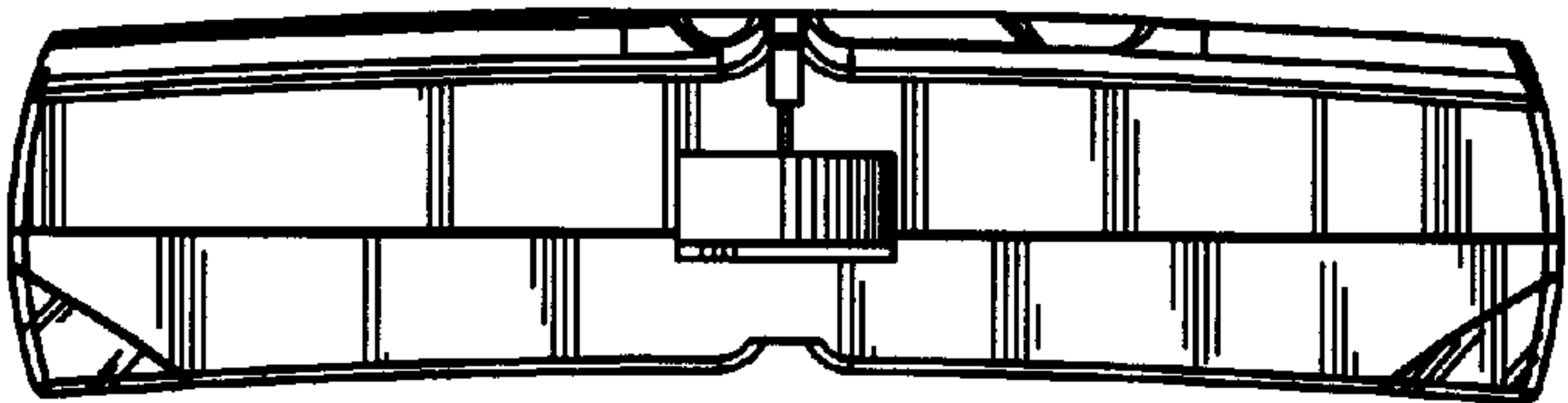

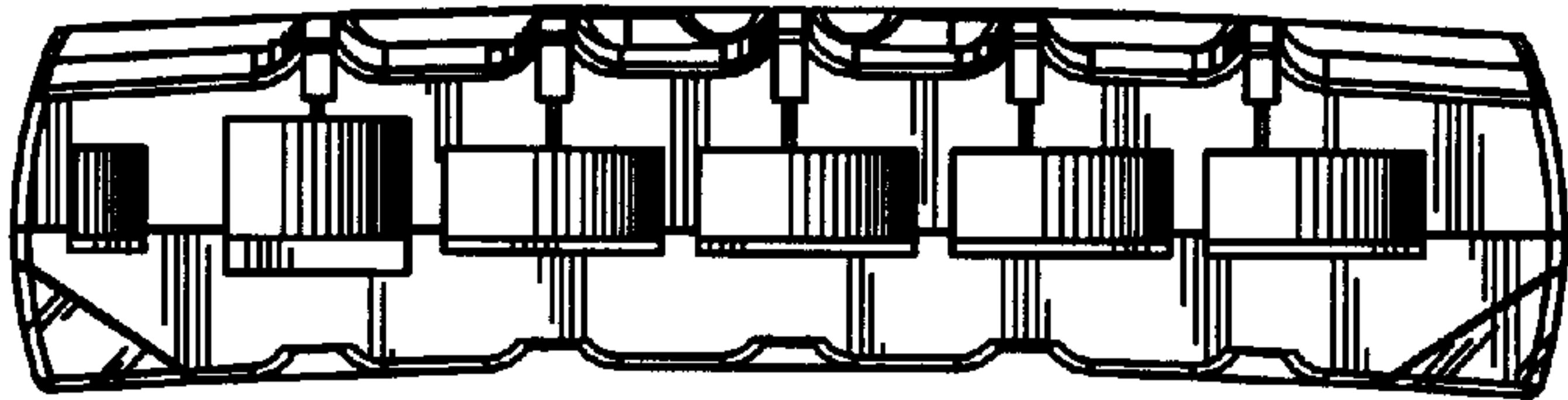

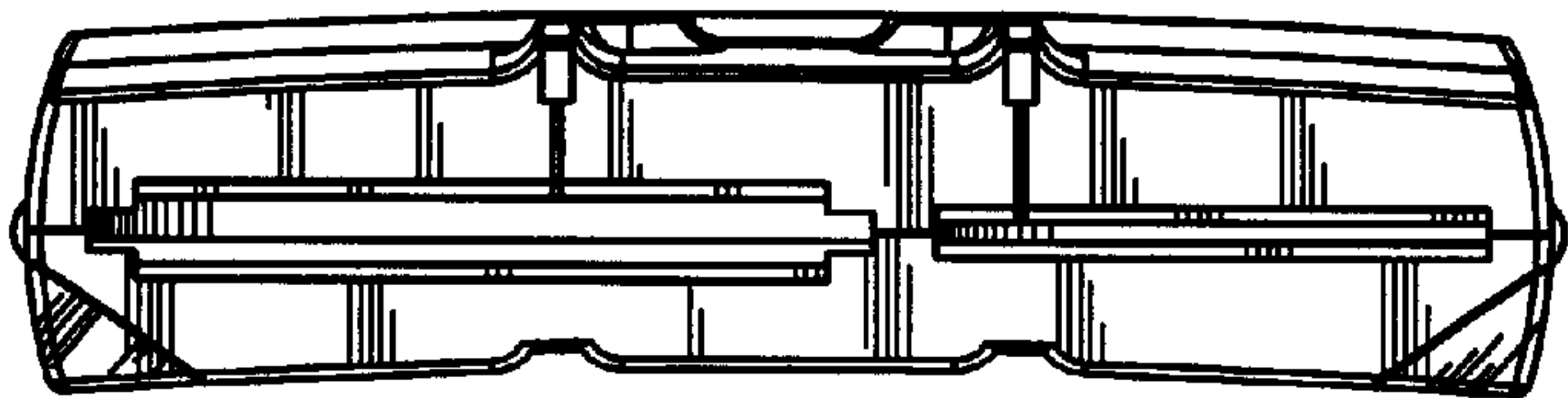

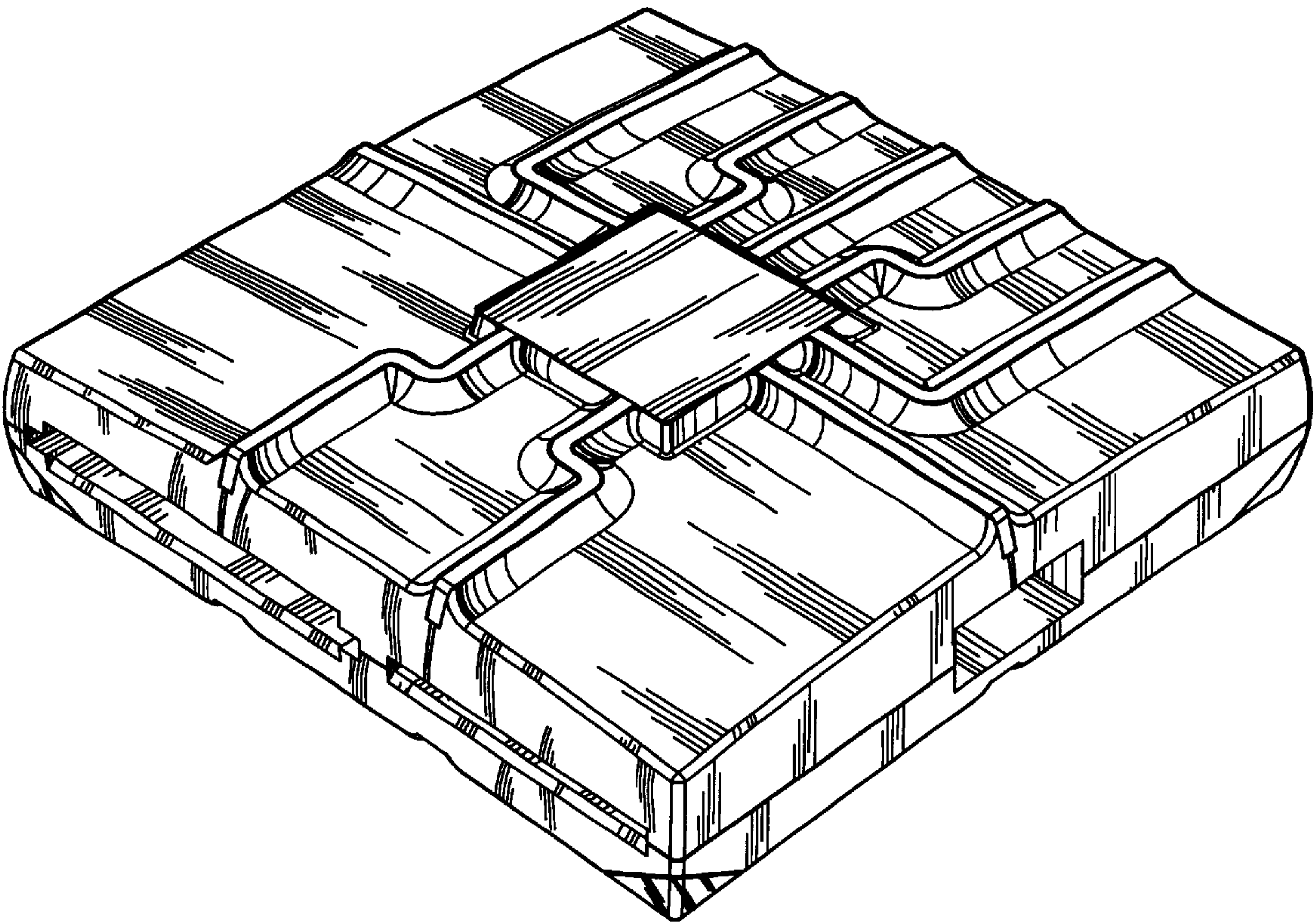

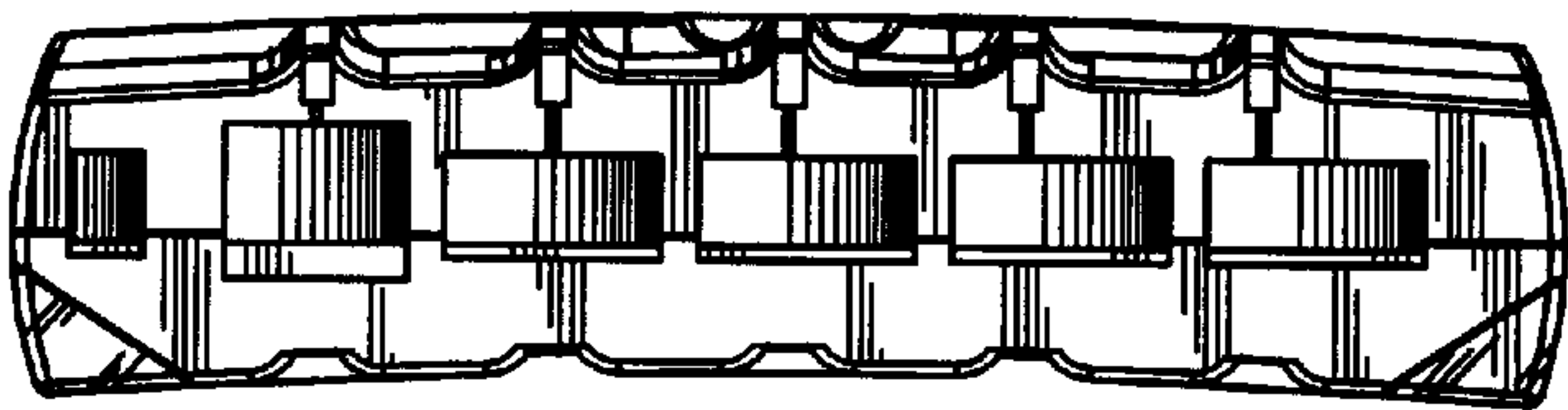

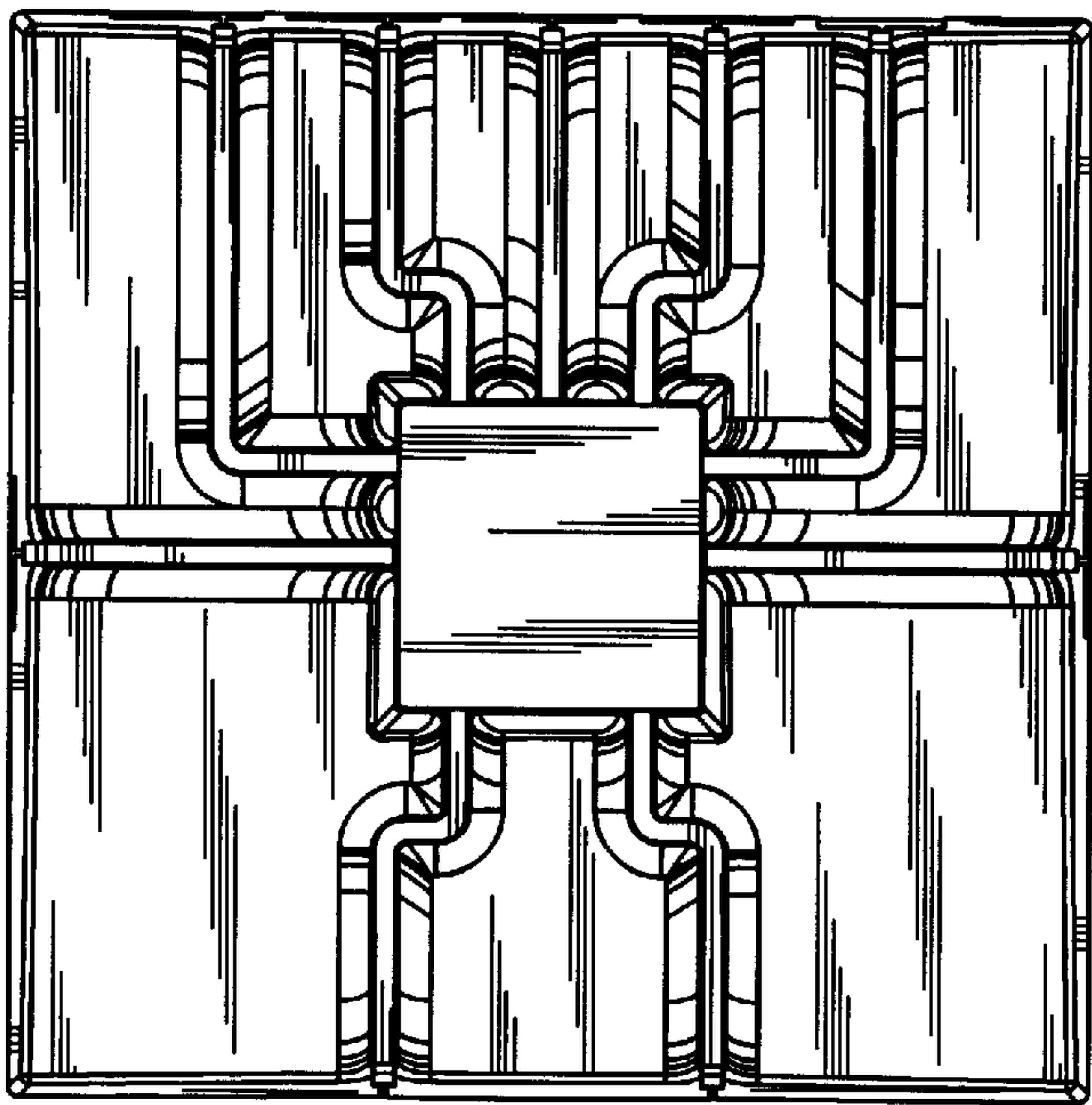

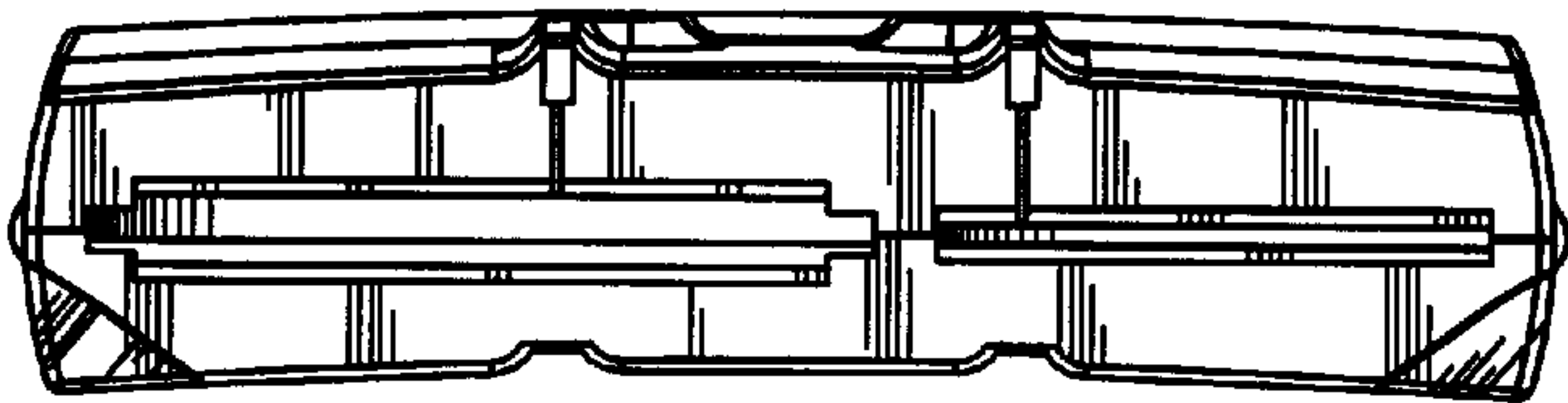

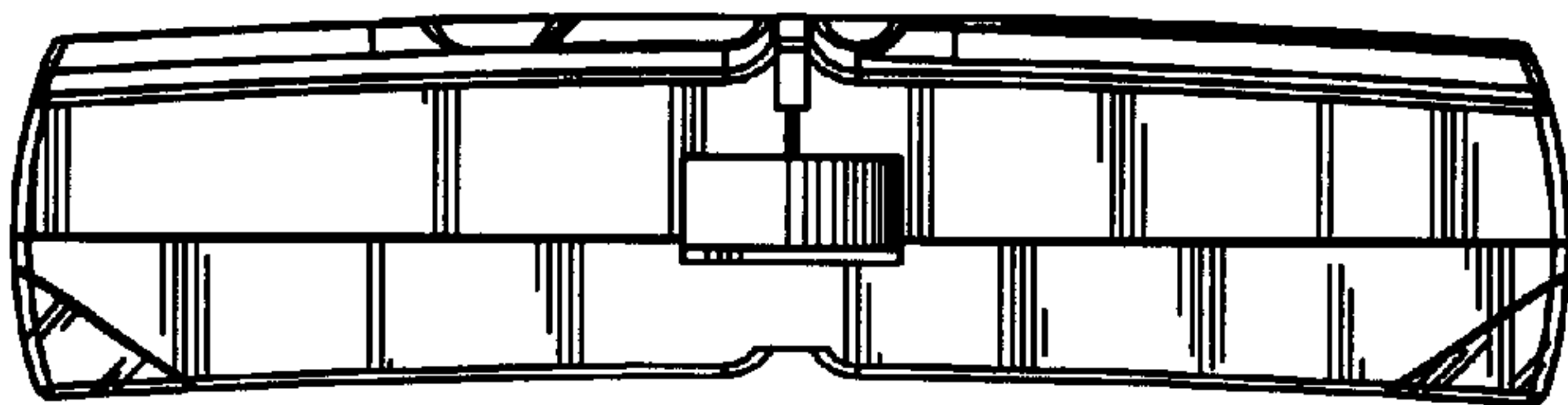

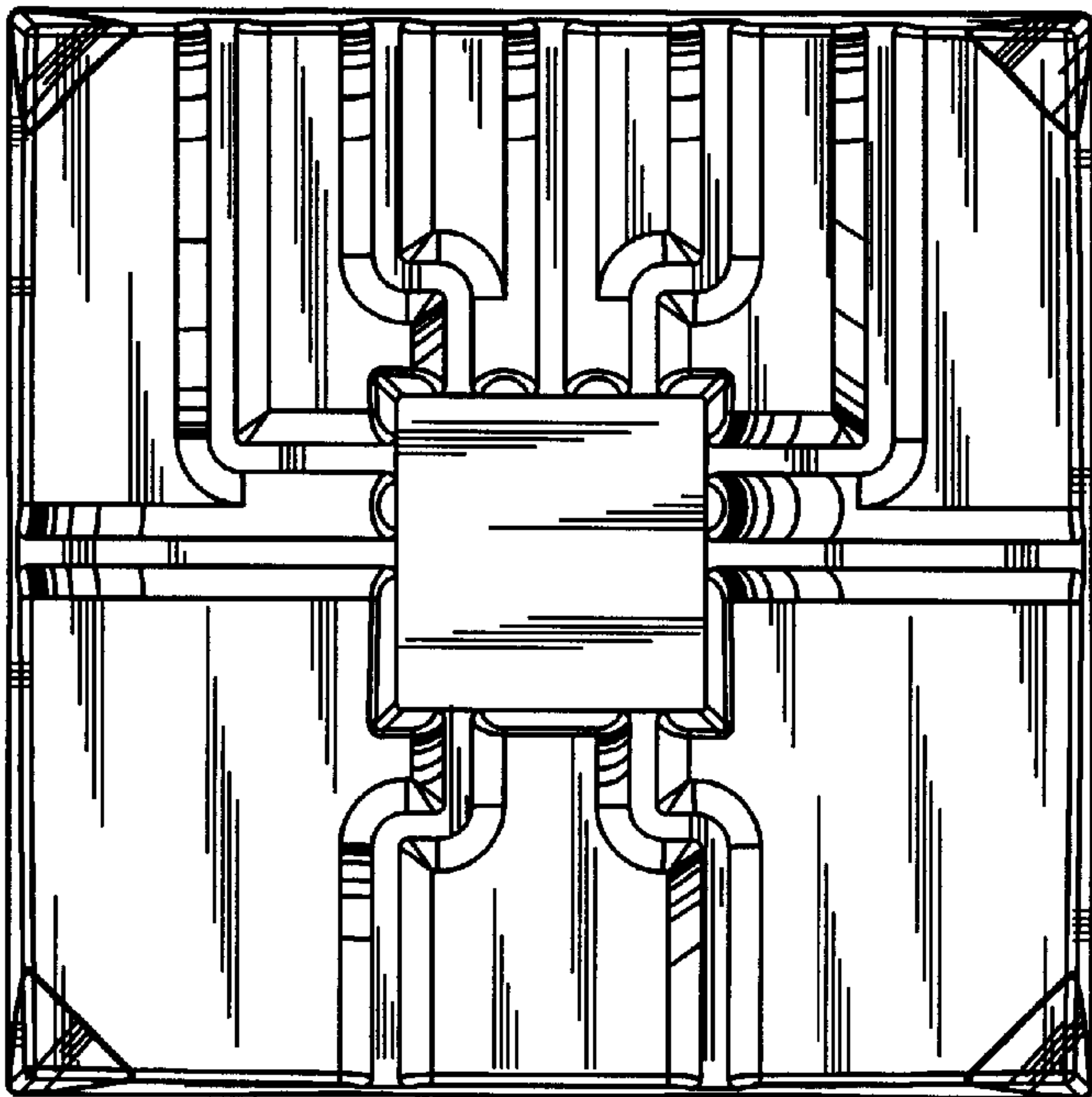

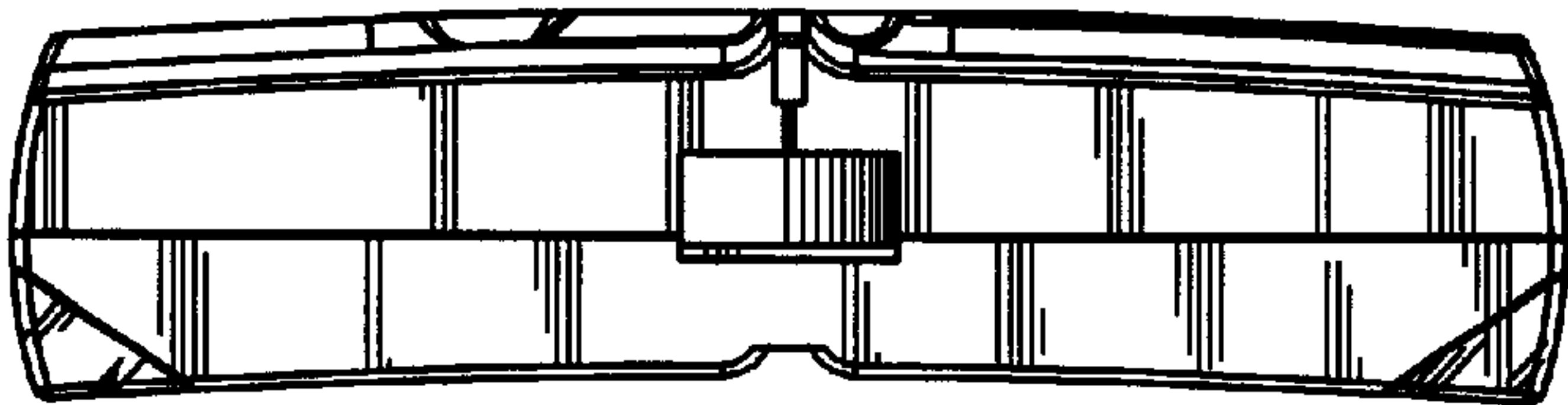
