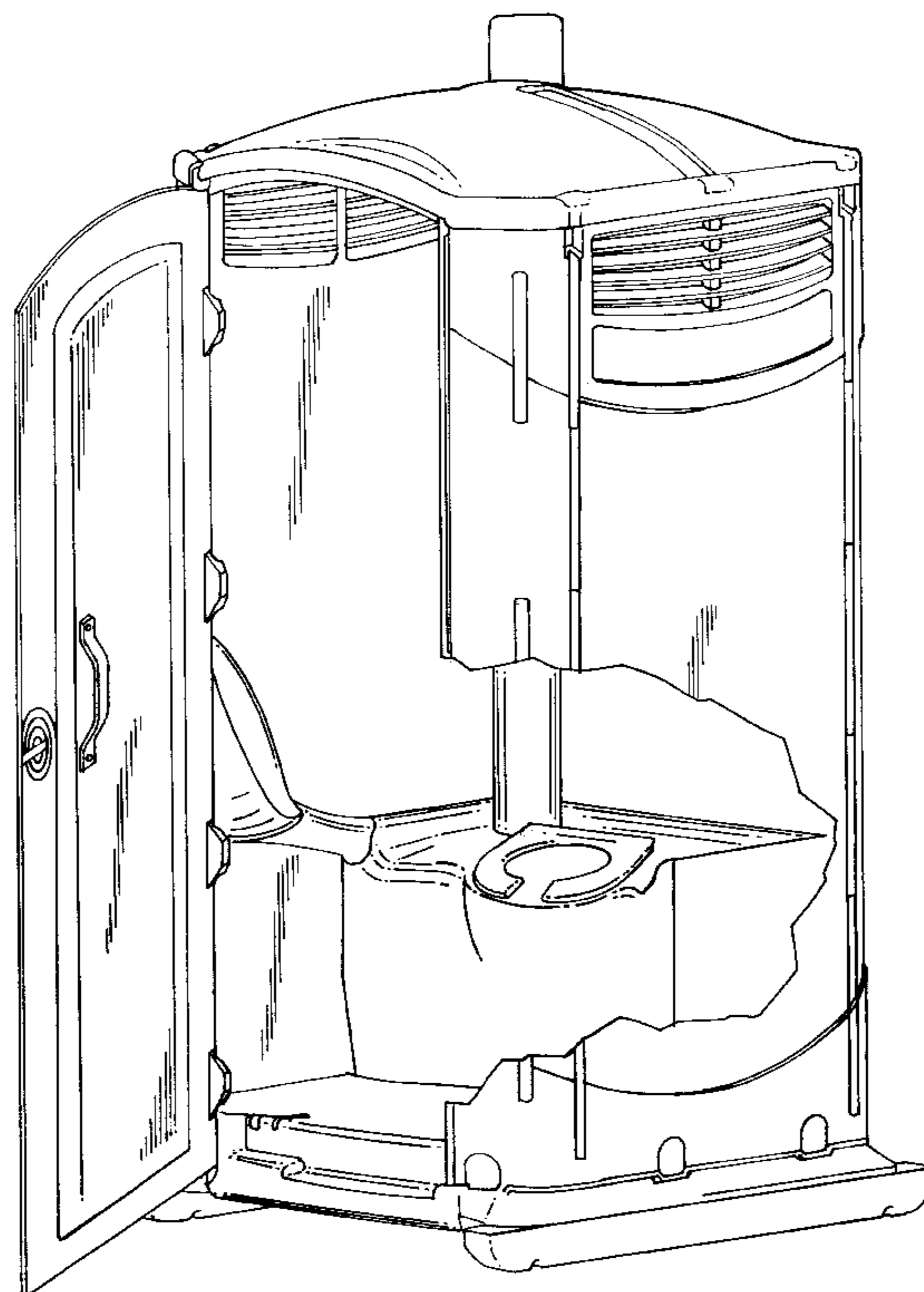
(57) **CLAIM**

The ornamental design for a portable restroom, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the top front and one side showing our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a side elevation view, side opposite that shown in FIG. 1 thereof;
 FIG. 5 is a rear elevational view, side opposite that shown in FIG. 4 thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a perspective view of the front, roof and one side showing the door open and illustrating certain interior features;
 FIG. 9 is a perspective view substantially similar to that shown in FIG. 8, however having a portion of the side wall cut away to illustrate various interior features of the portable restroom;
 FIG. 10 is a top cut away view showing the roof removed and illustrating the interior layout of the portable restroom; and,
 FIG. 11 is a second perspective view of the portable restroom having a portion of the side wall and door cut away to illustrate further interior features thereof.
 The broken lines illustrated on the portable restroom represent curved surfaces.

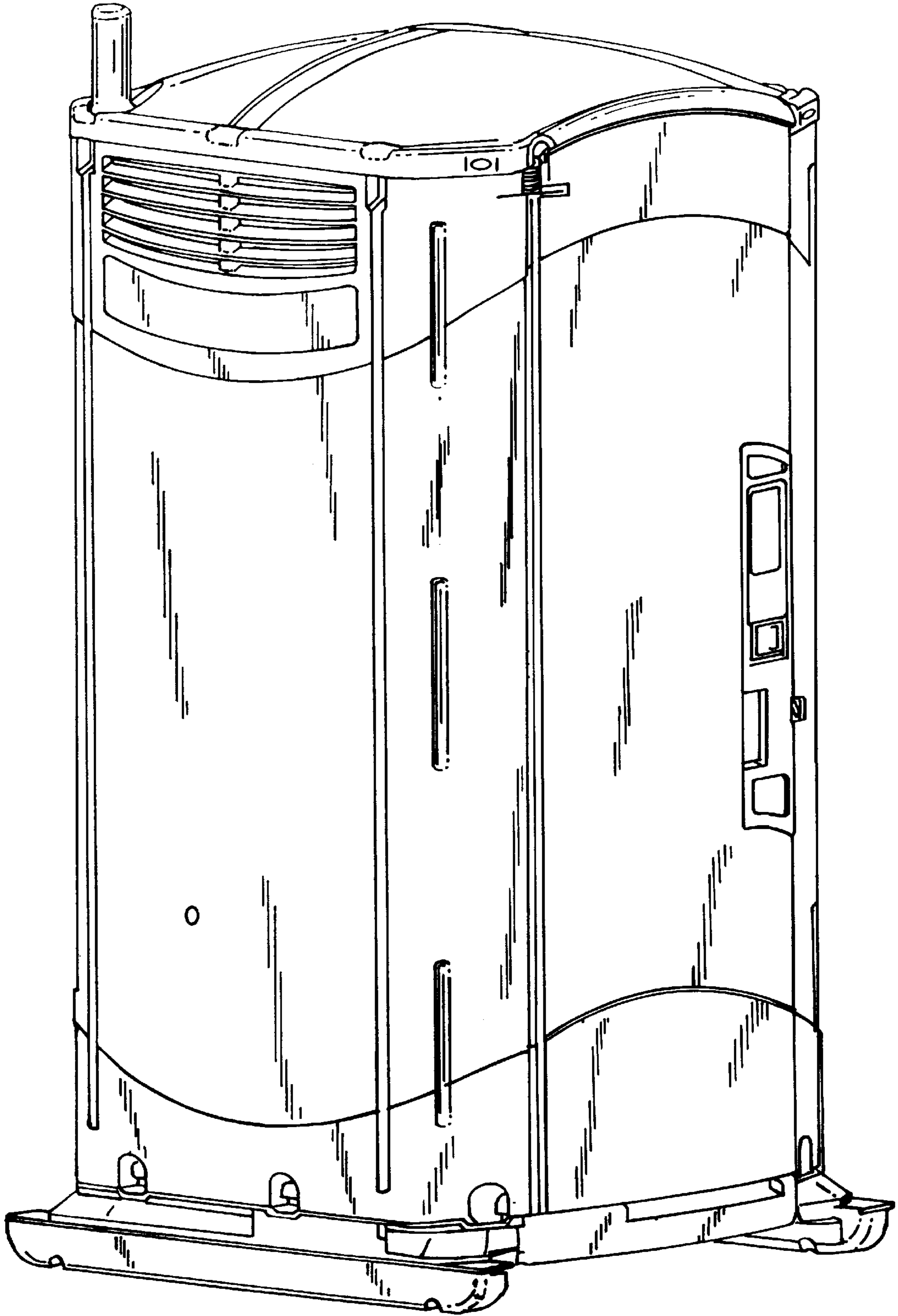

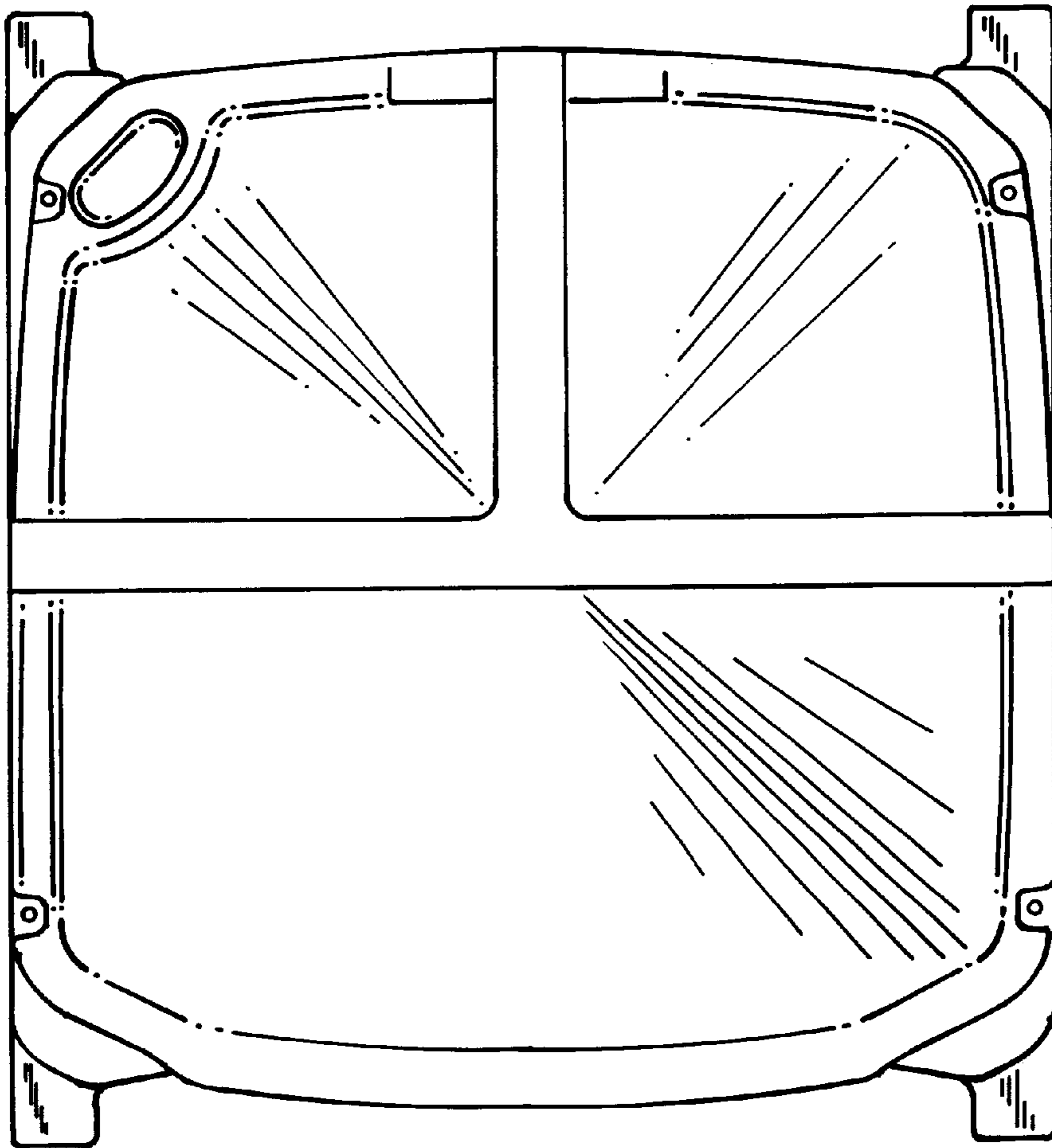

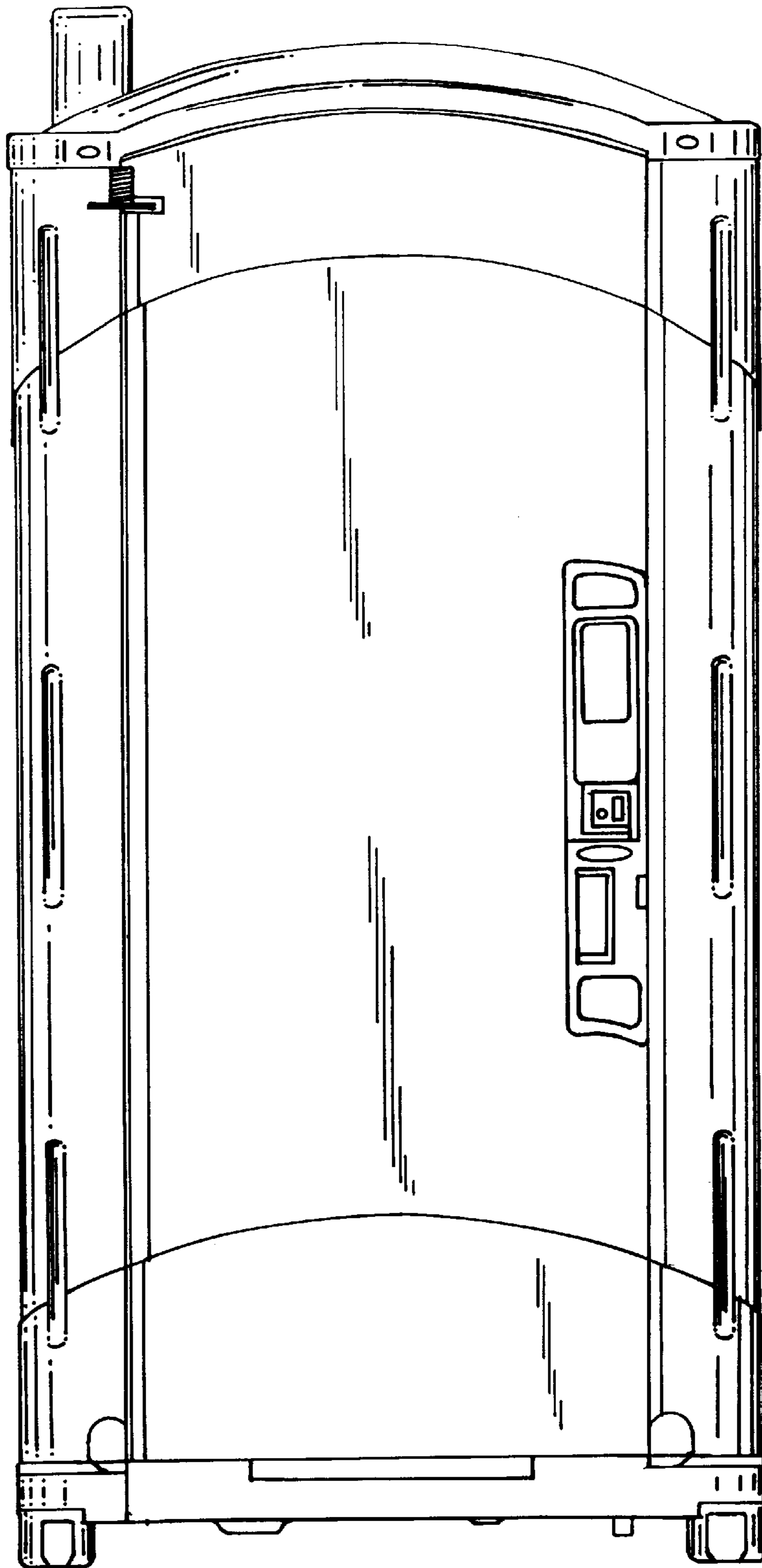

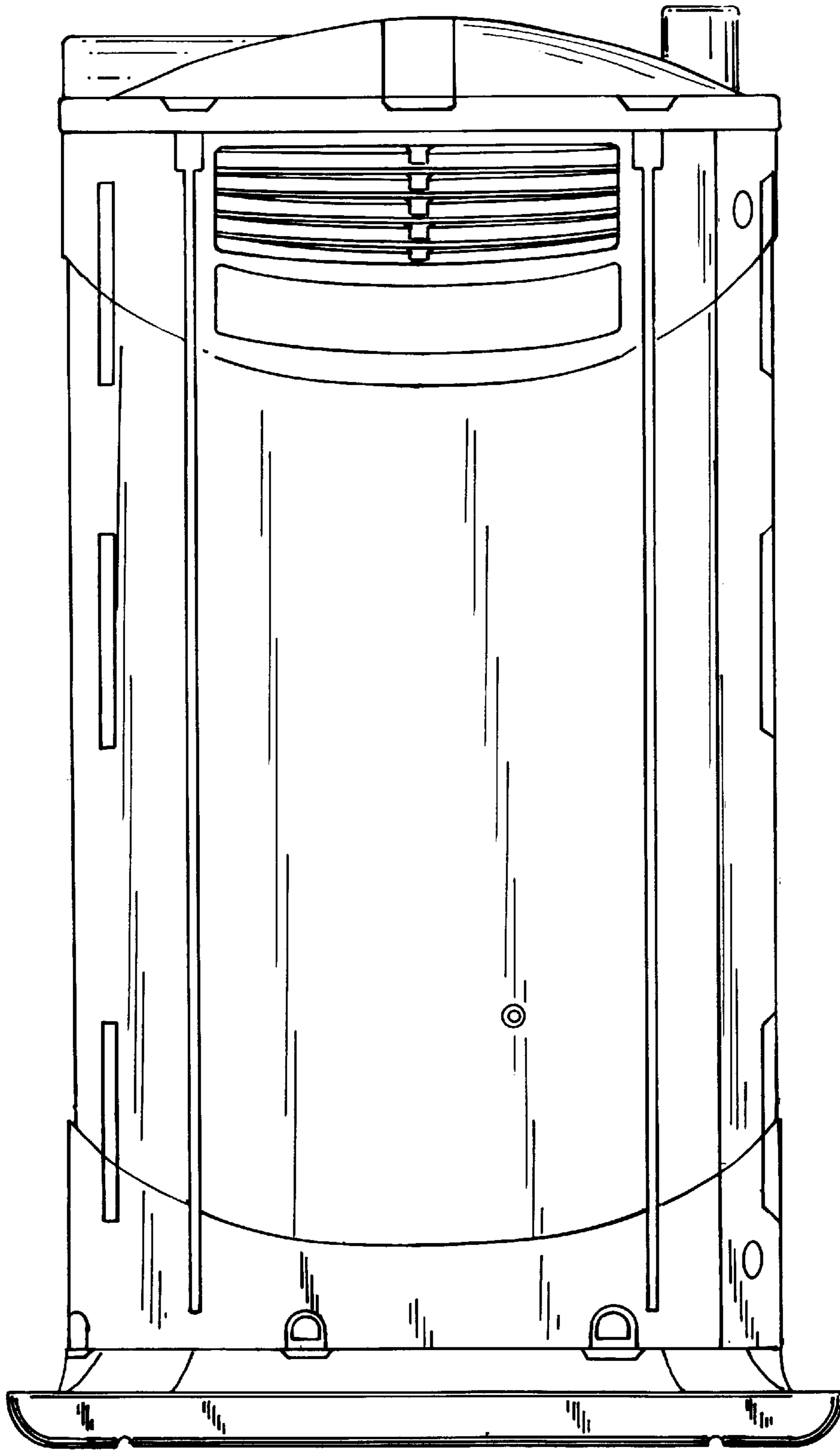

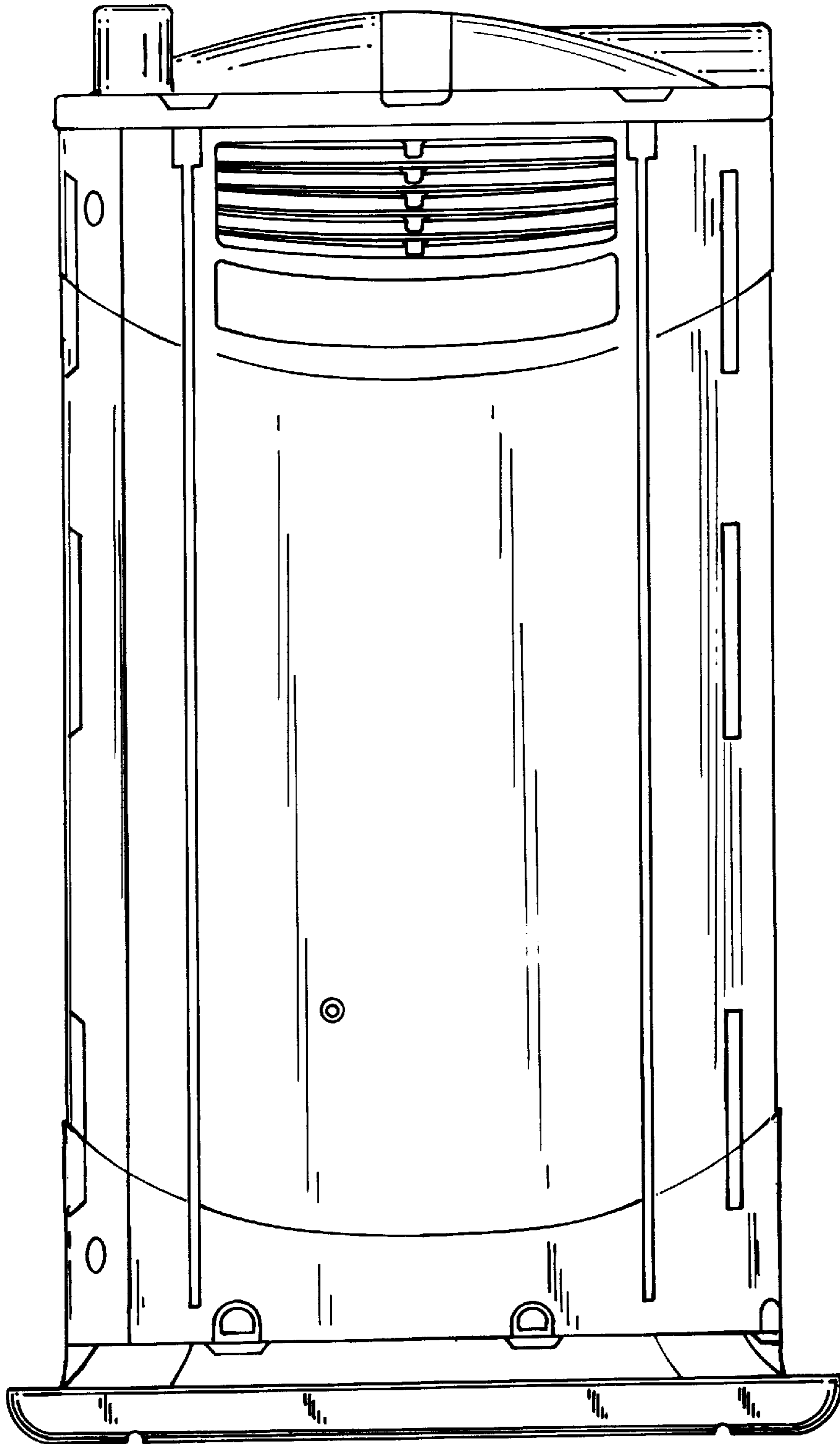

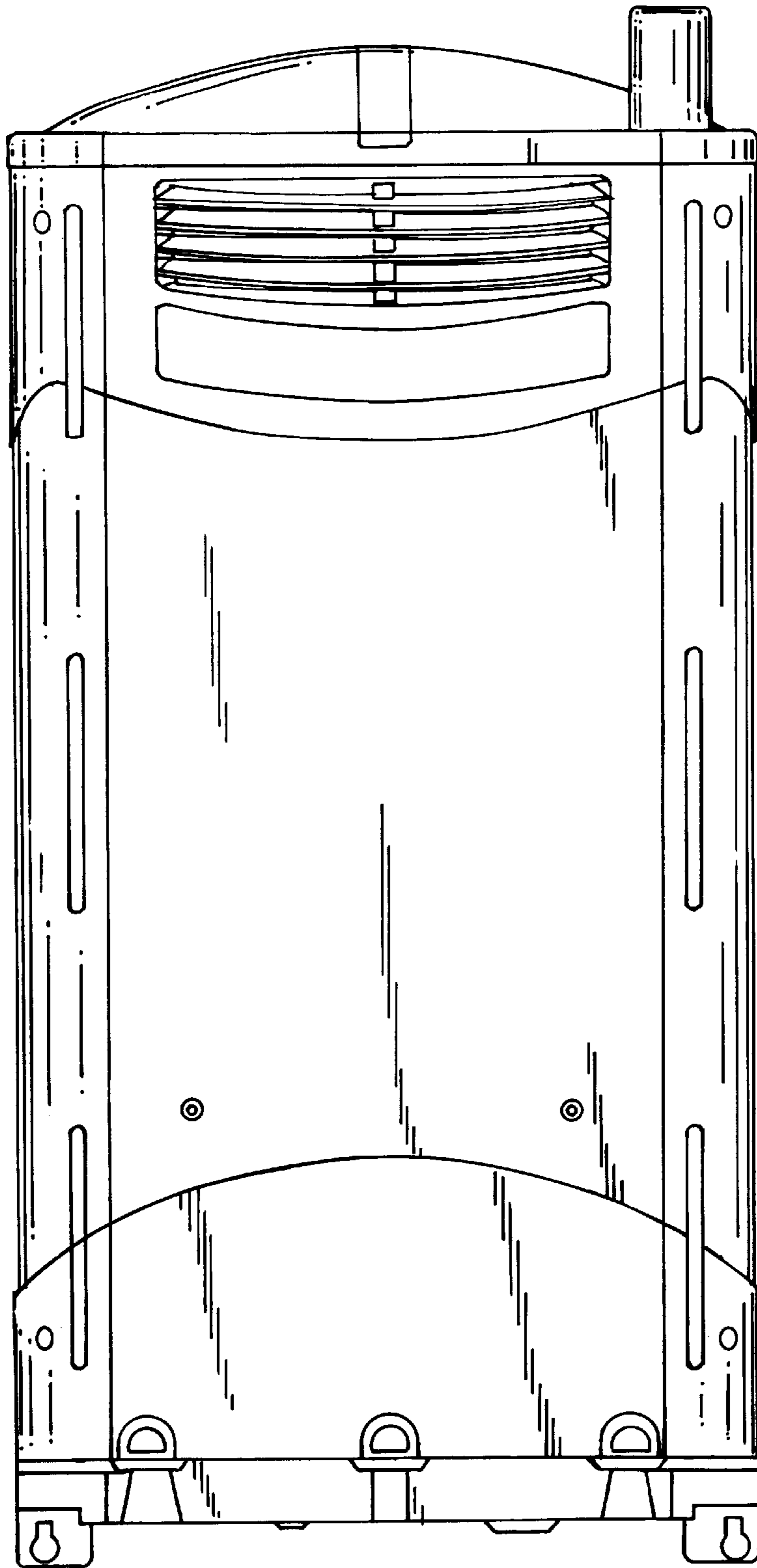

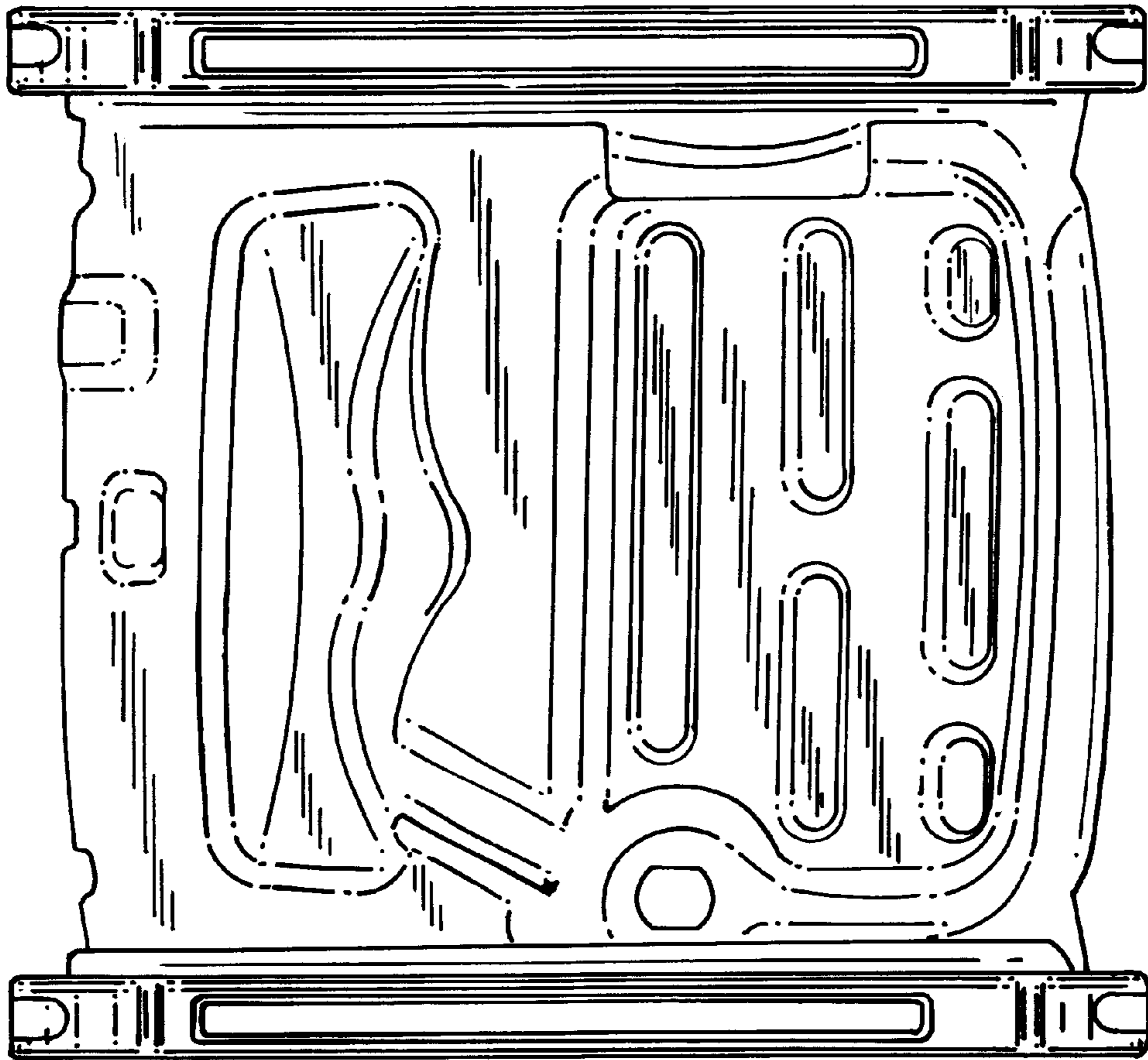

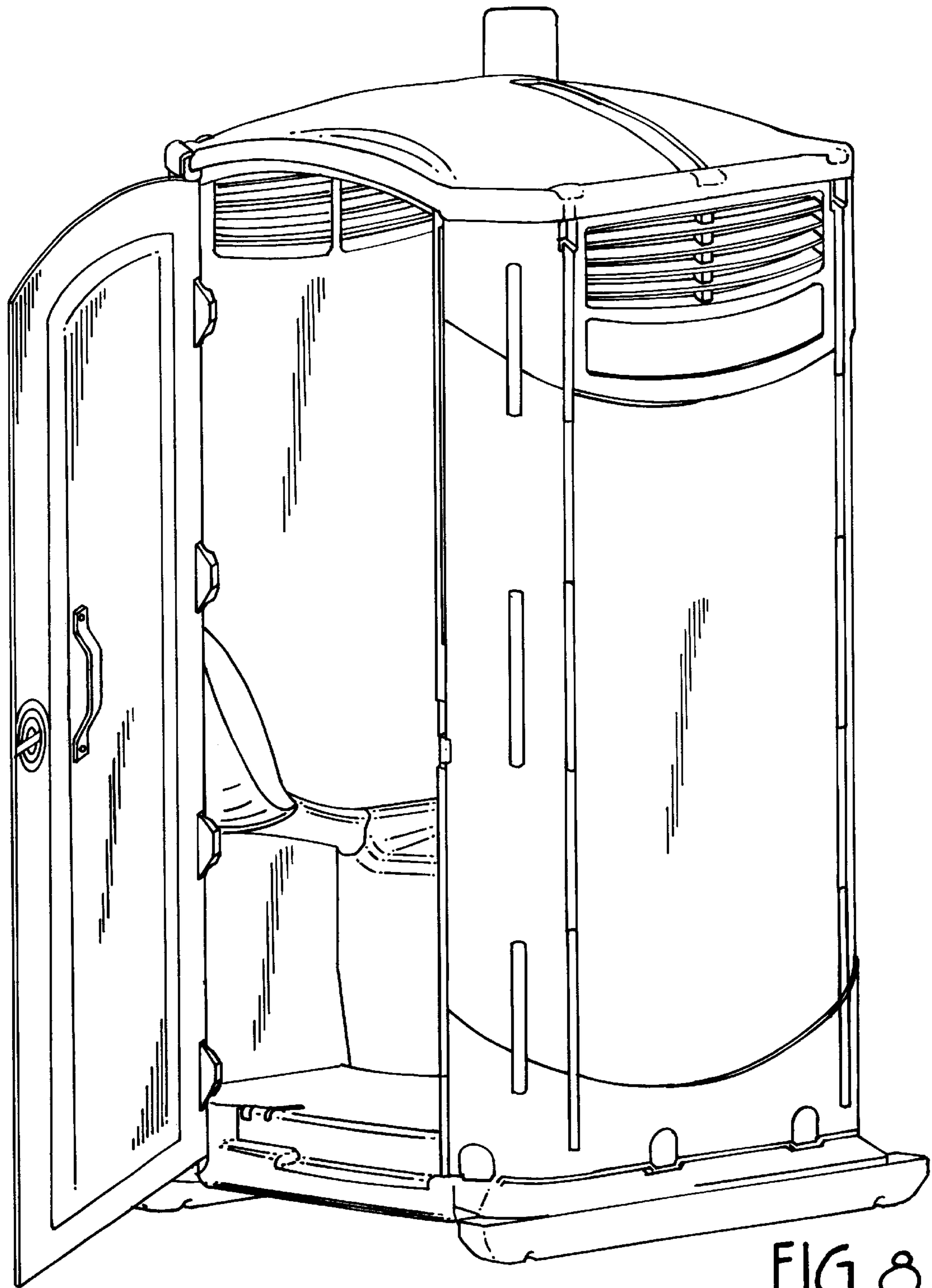

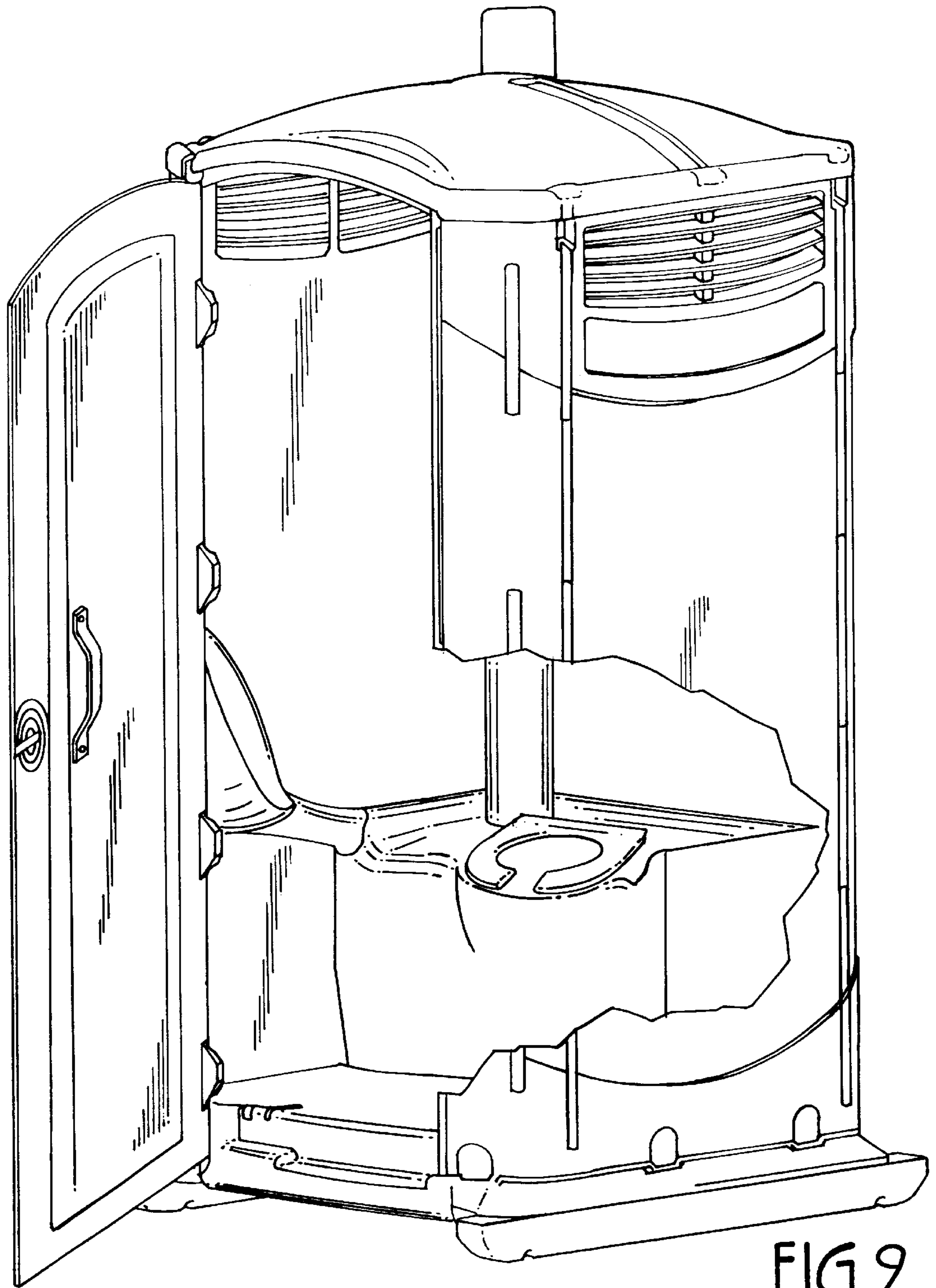

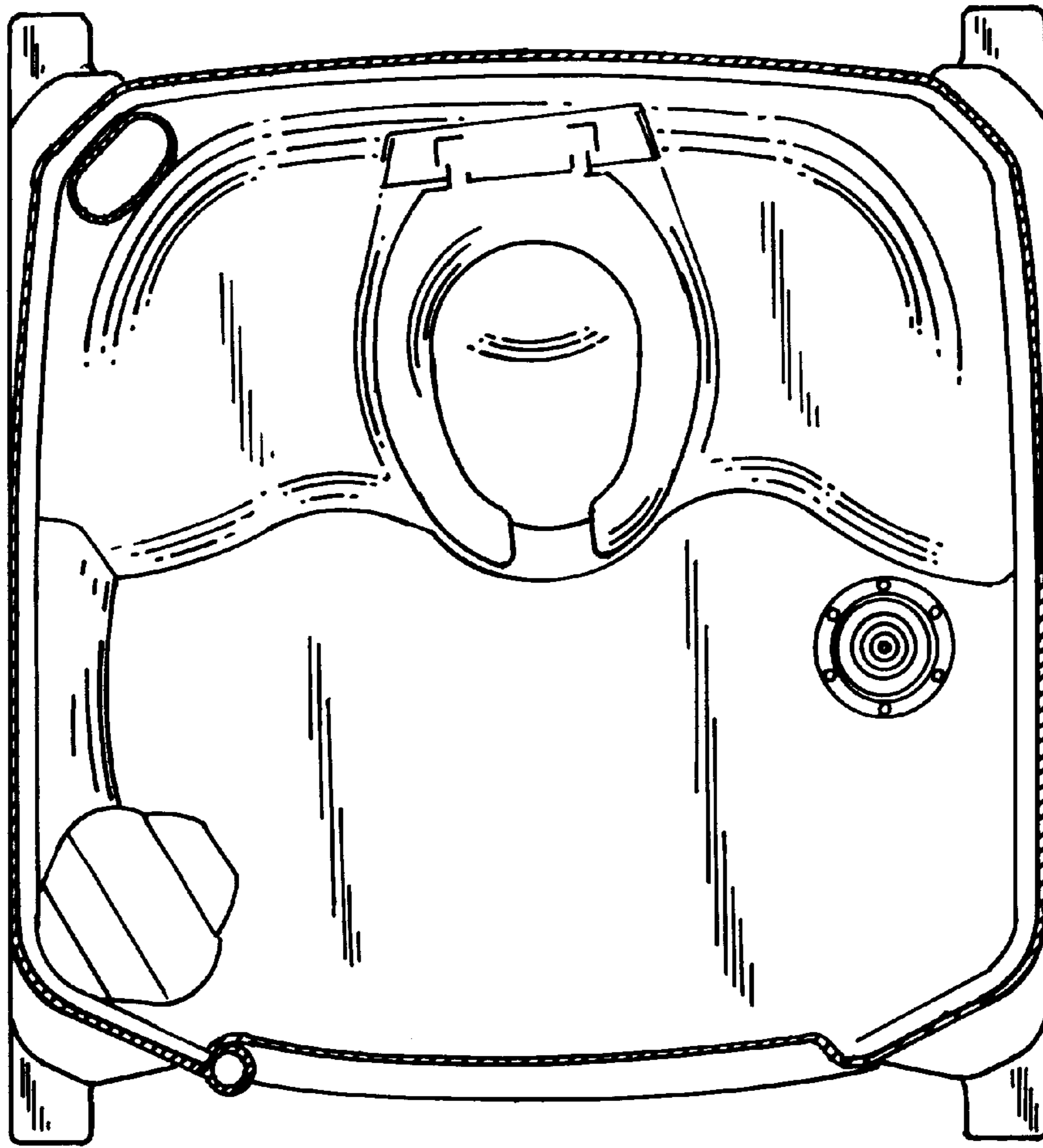

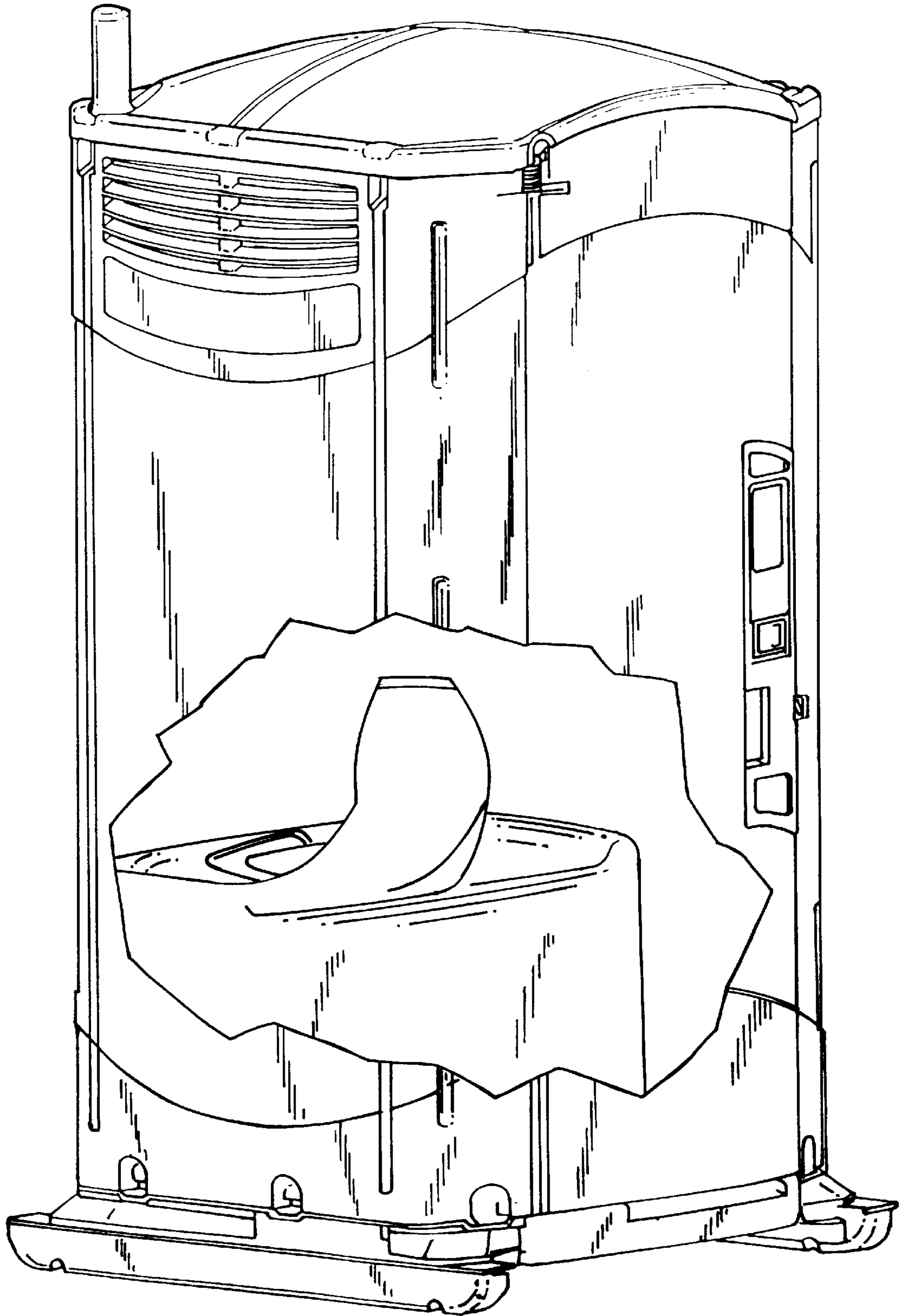
