(57) **CLAIM**

The ornamental design for a nozzle assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first nozzle assembly, embodying my new design;

FIG. 2 is a perspective view of a second nozzle assembly, embodying my new design;

FIG. 3 is a perspective view of said first nozzle assembly, wherein the cap is removed from the nozzle;

FIG. 4 is a right side elevational view of said second nozzle assembly in use; the left side being identical;

FIG. 5 is a right side elevational view of said first nozzle assembly in use; the left side being identical;

FIG. 6 is a top view of said first and second nozzle assembly in use;

FIG. 7 is a cross-sectional view taken along line X—X in FIG. 6 of said first nozzle assembly;

FIG. 8 is a cross-sectional view taken along line X—X in FIG. 6 of said second nozzle assembly;

FIG. 9 is a perspective view of a nozzle which is part of both said first and second nozzle assembly;

FIG. 10 is a top view of said nozzle;

FIG. 11 is a bottom view of said nozzle;

FIG. 12 is a perspective view of a collar which is part of said second nozzle assembly;

FIG. 13 is a top view of said collar;

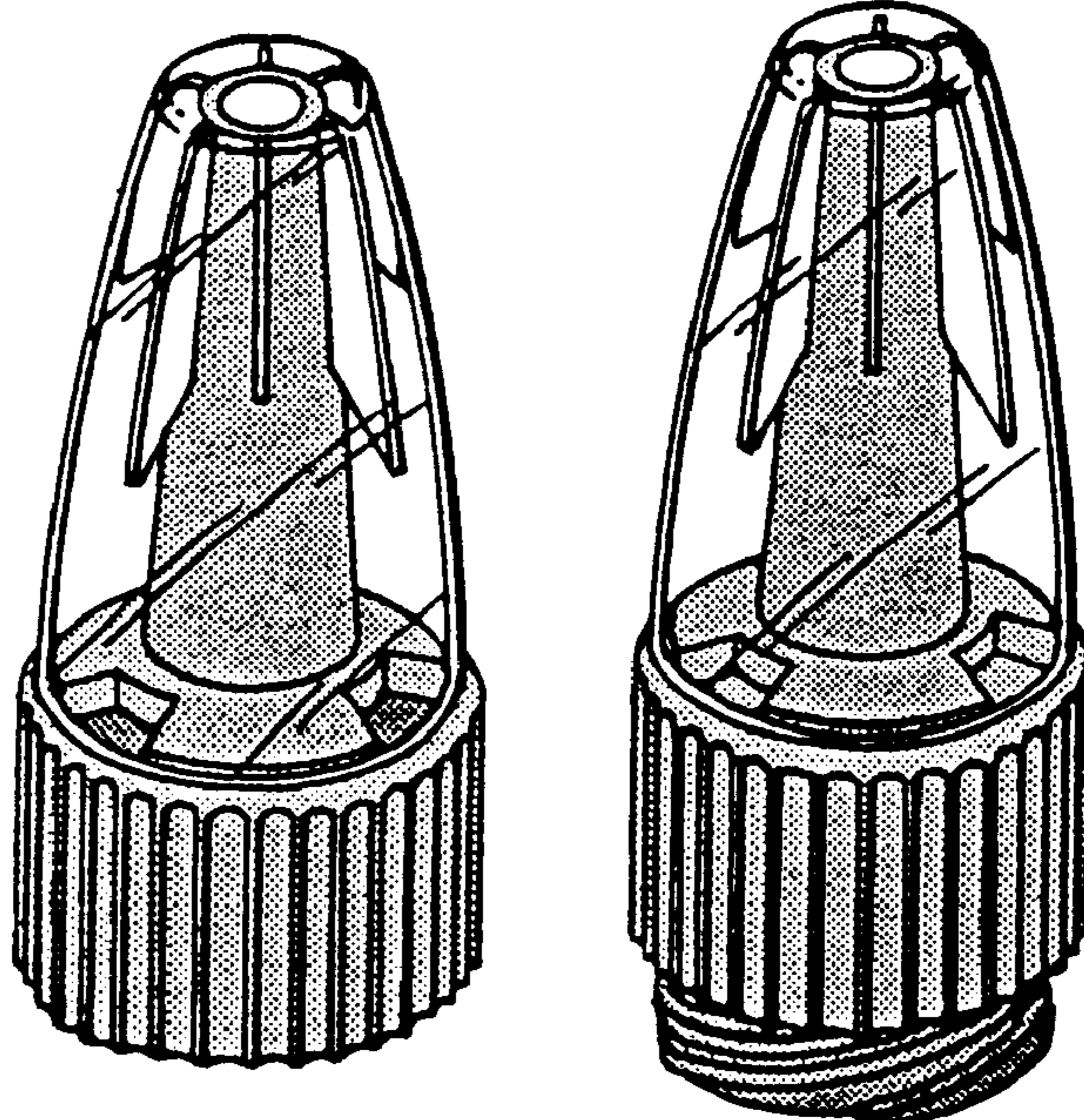
FIG. 14 is a bottom view of said collar;

FIG. 15 is a cross-sectional view of said cap which is part of both said first and second nozzle assembly;

FIG. 16 is a top view of said cap; and,

FIG. 17 is a bottom view of said cap.

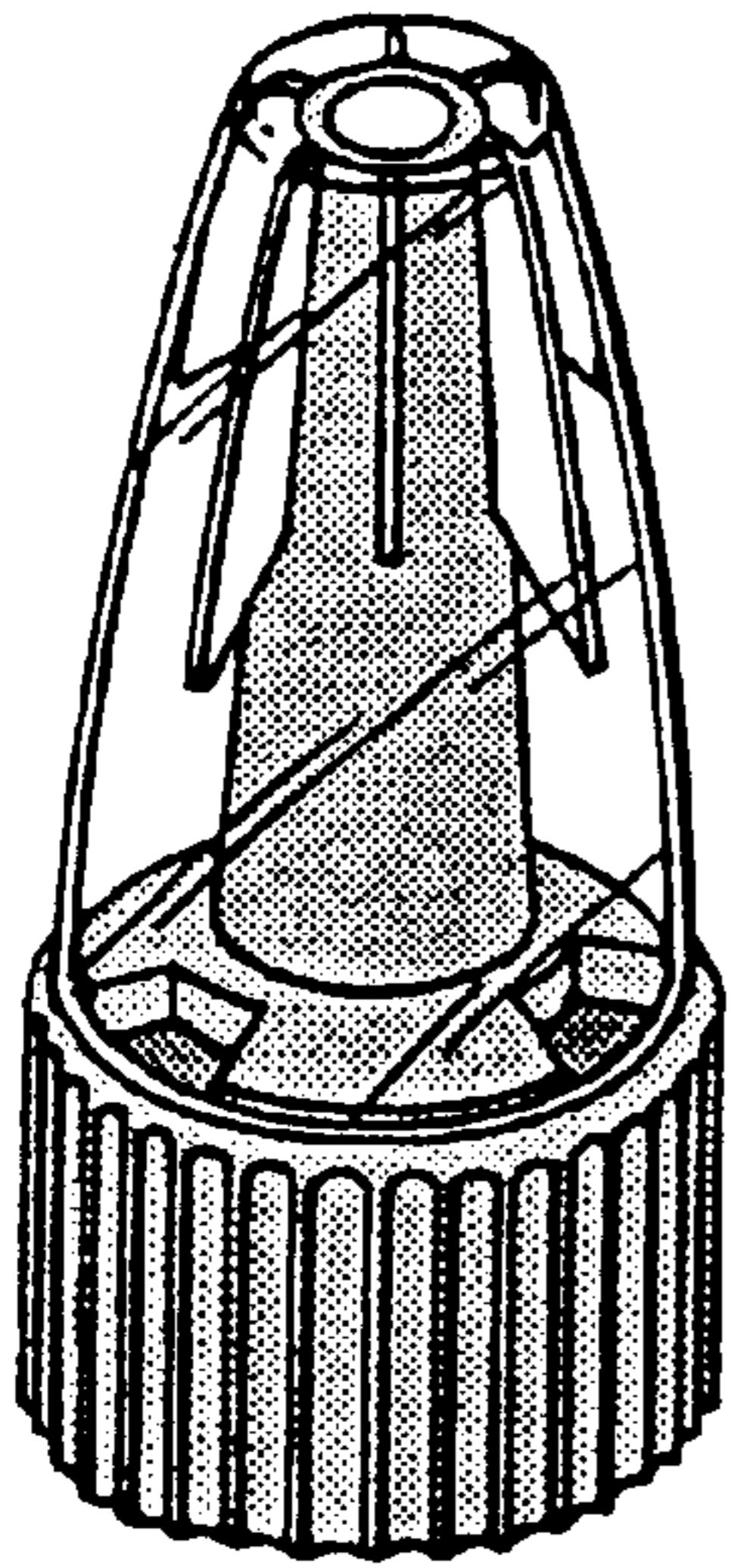

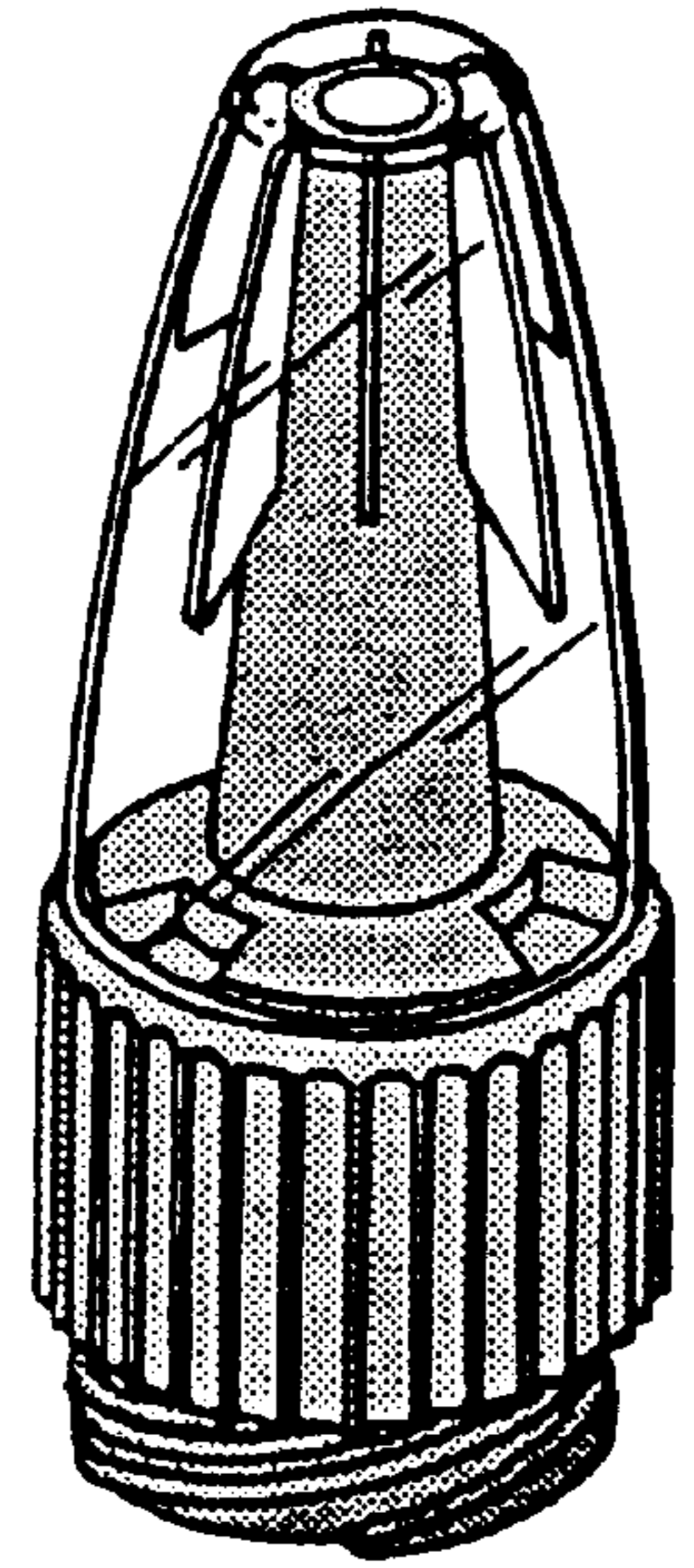

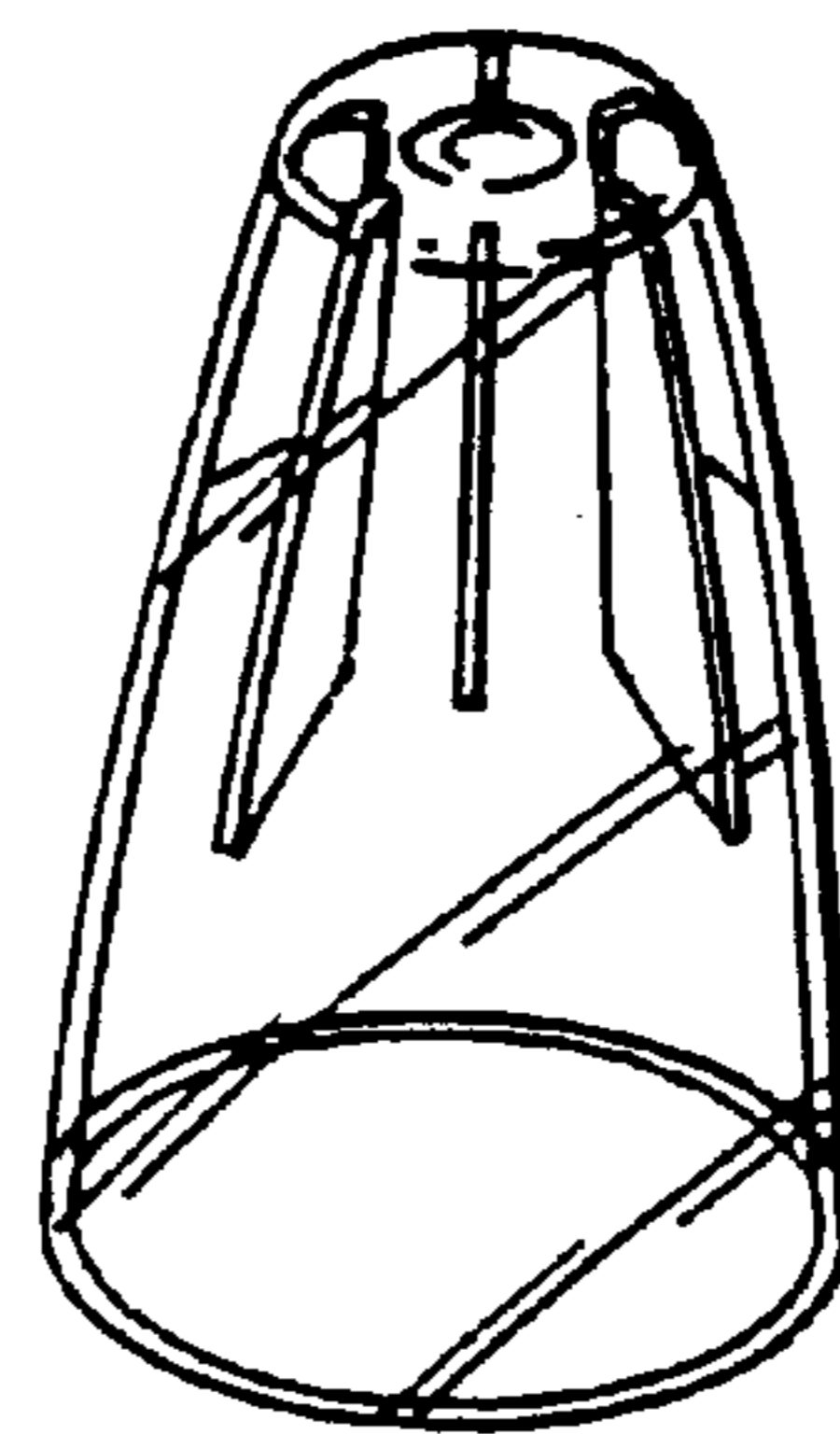
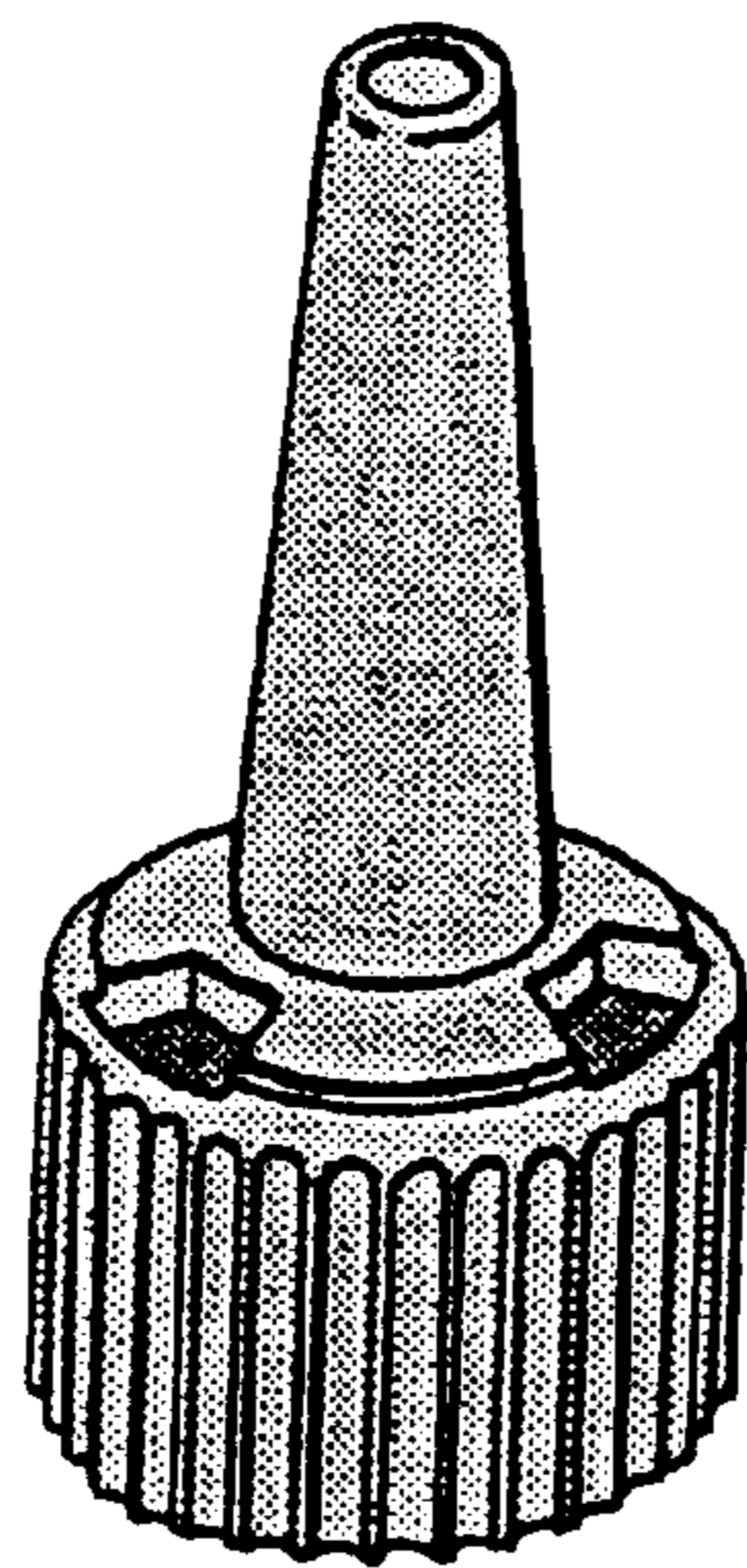

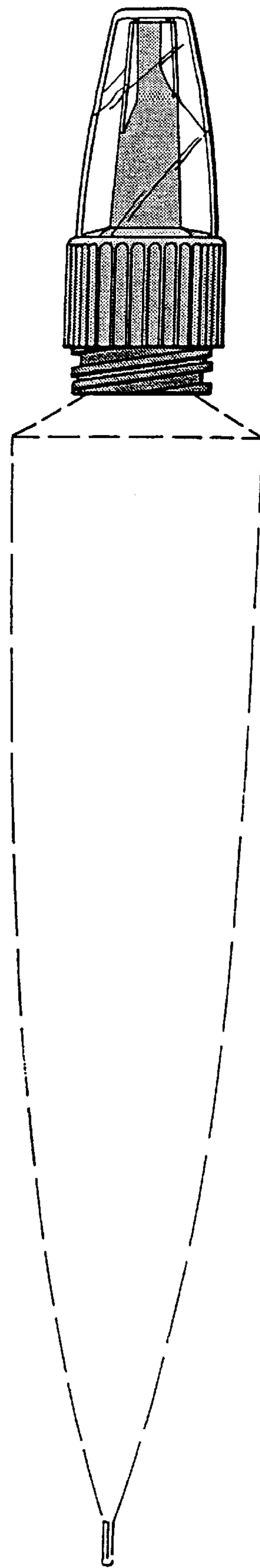

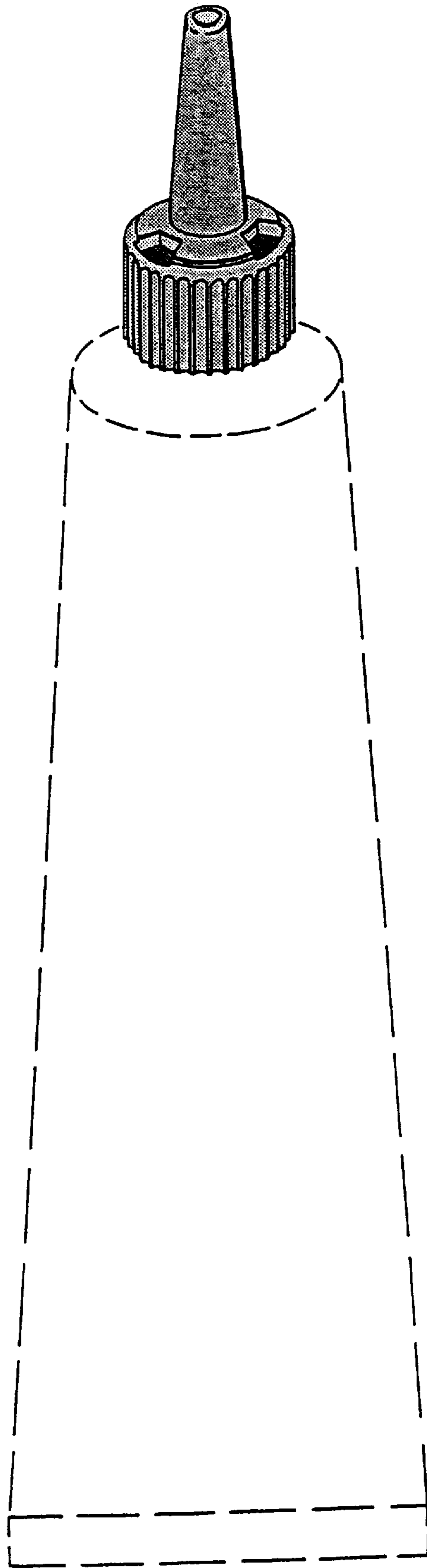

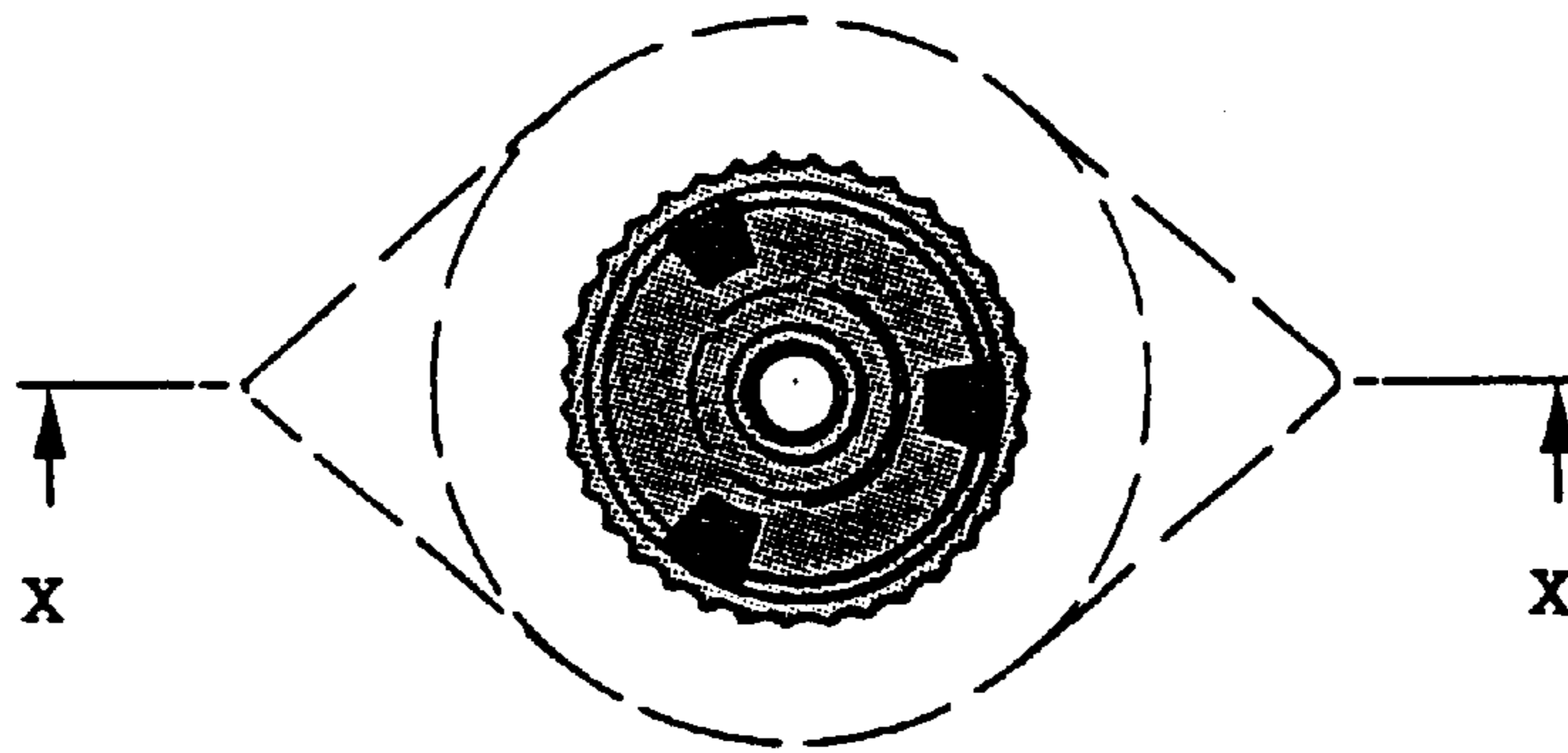

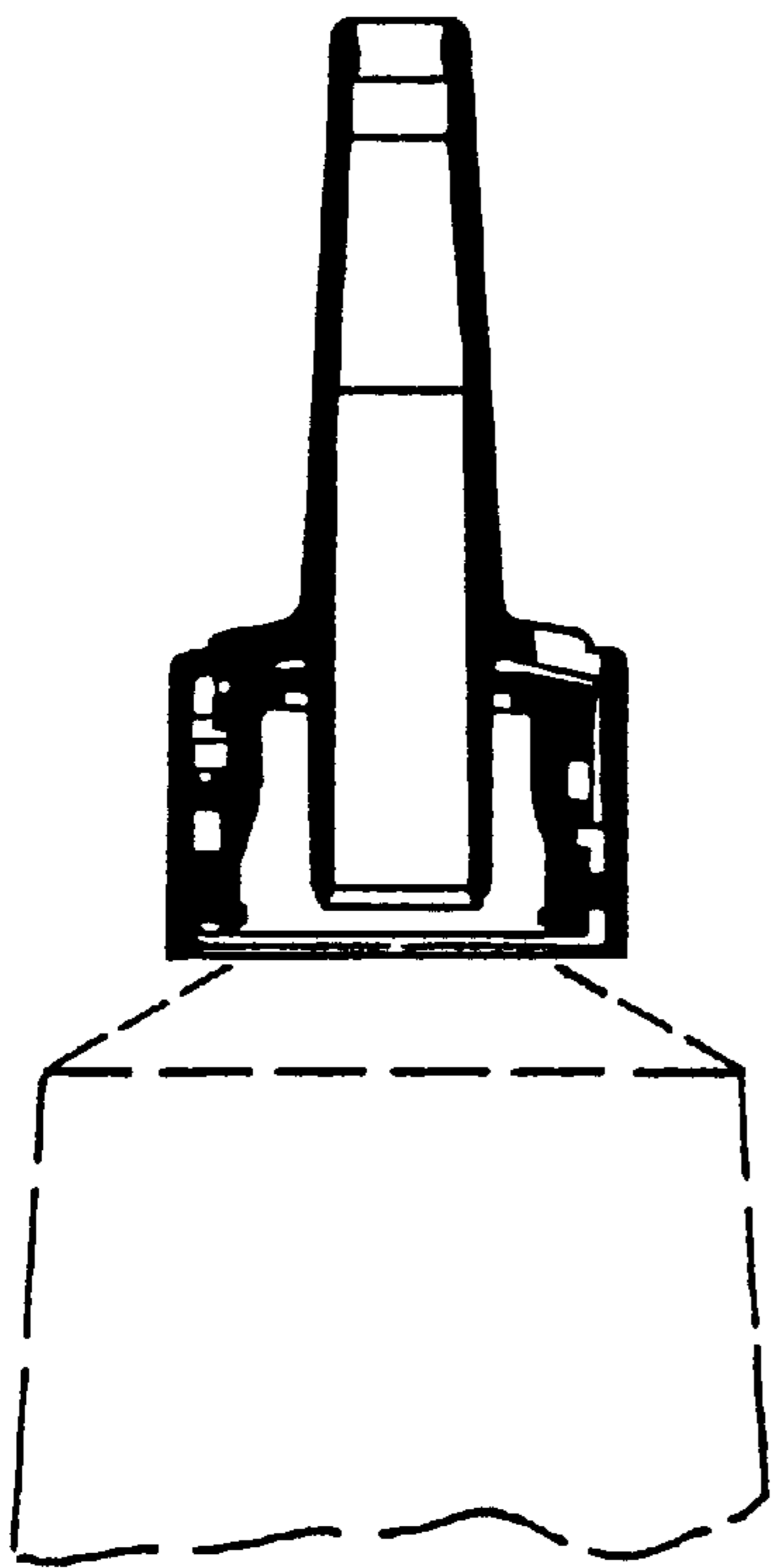

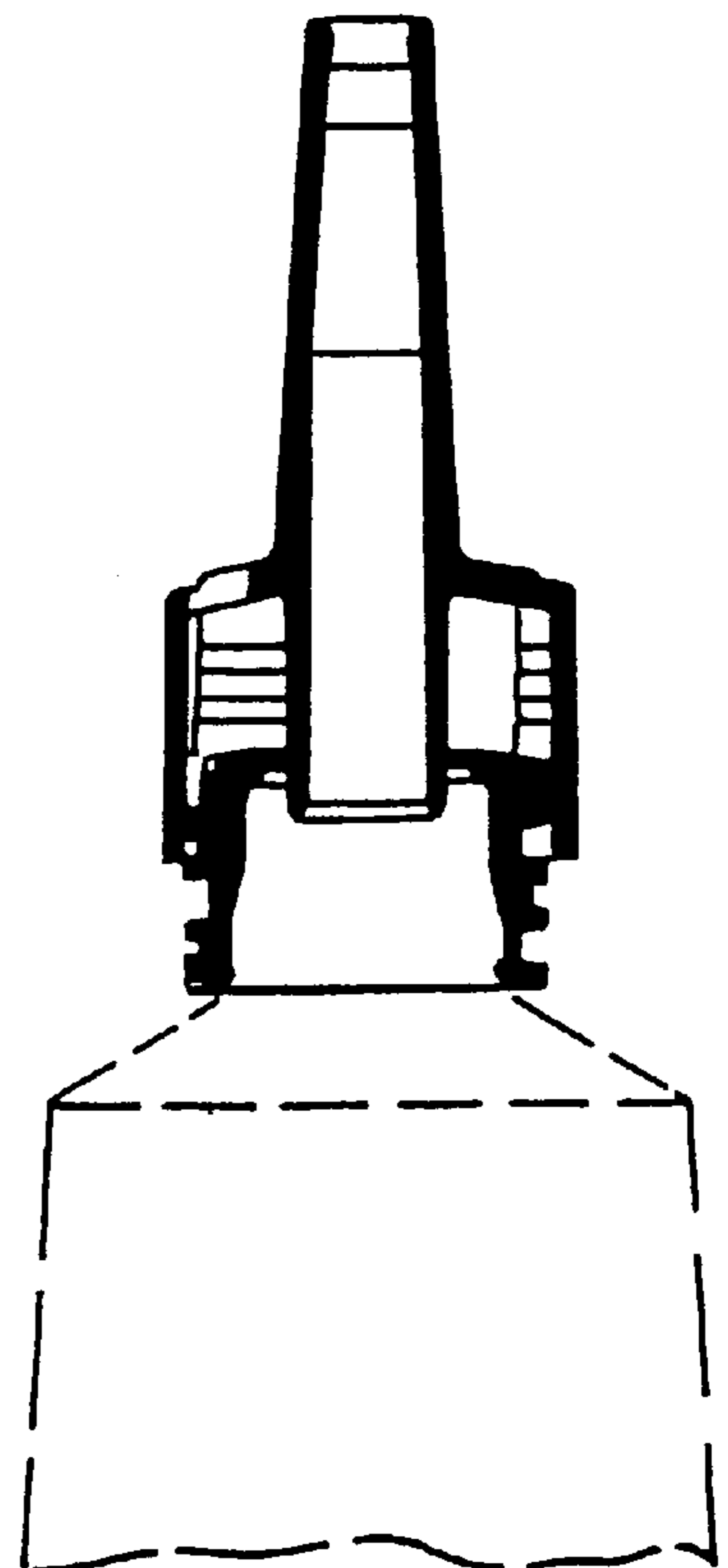

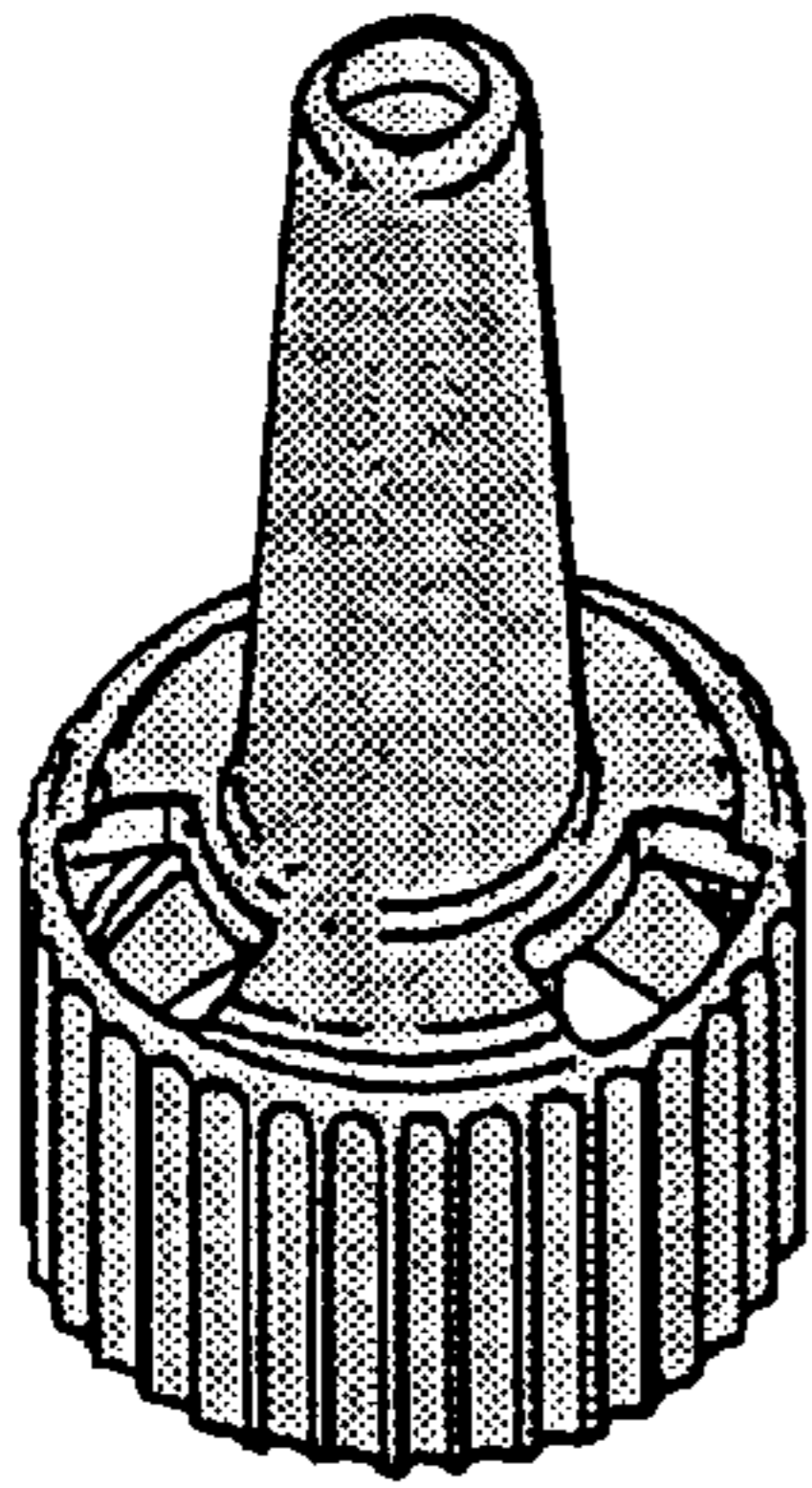

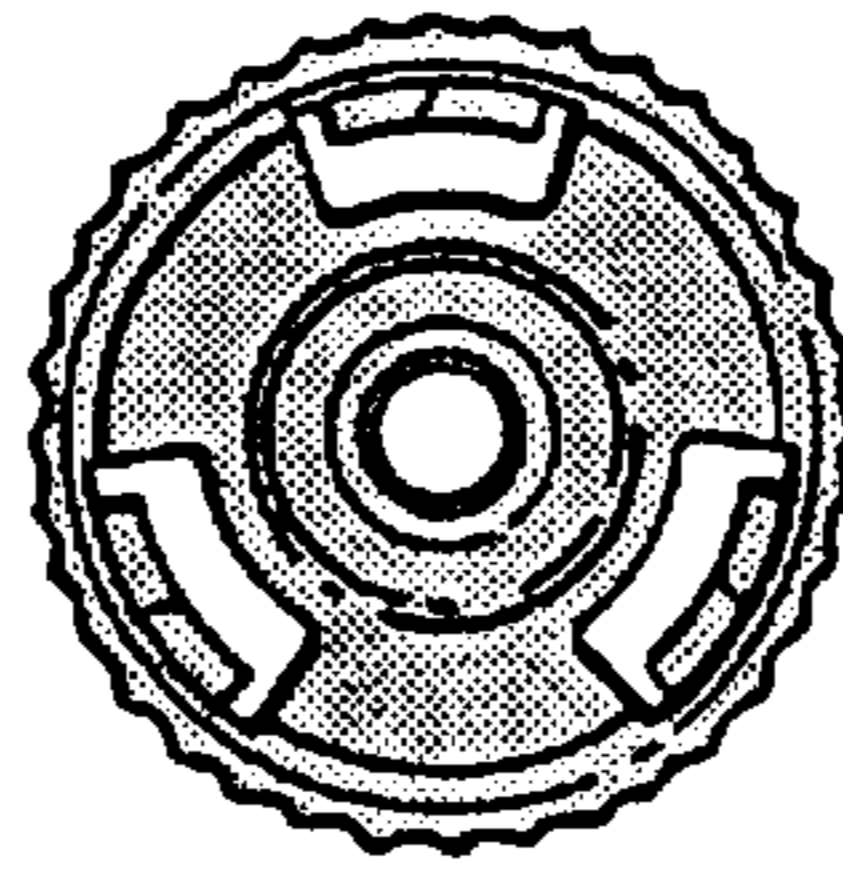

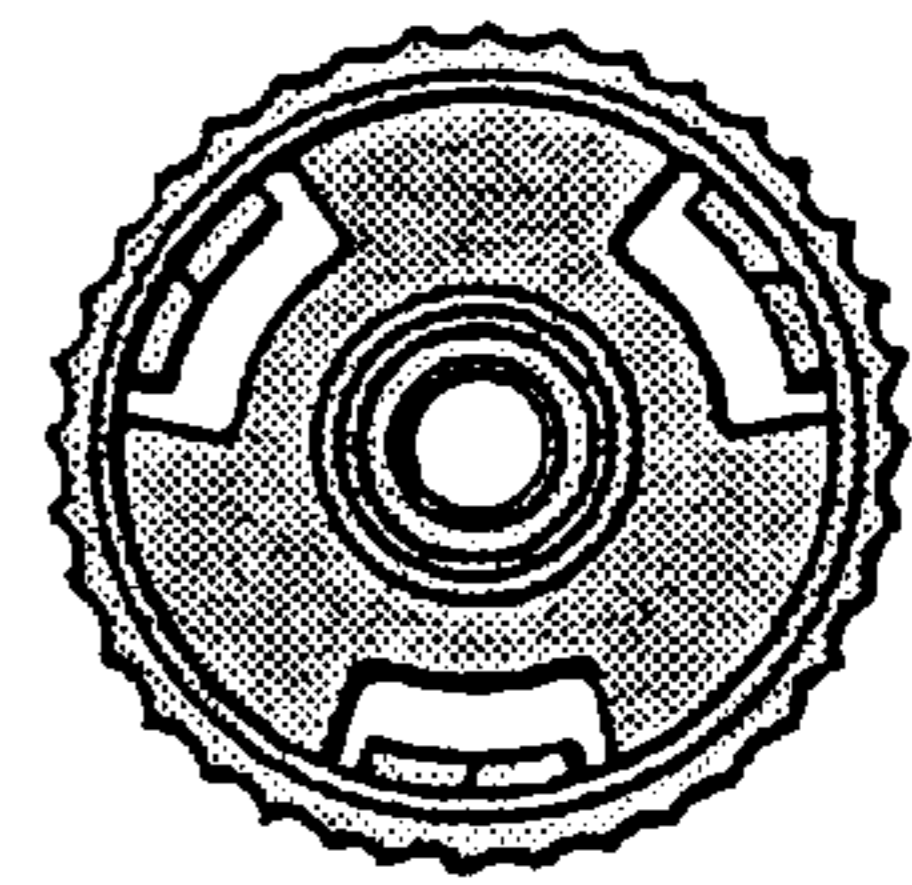

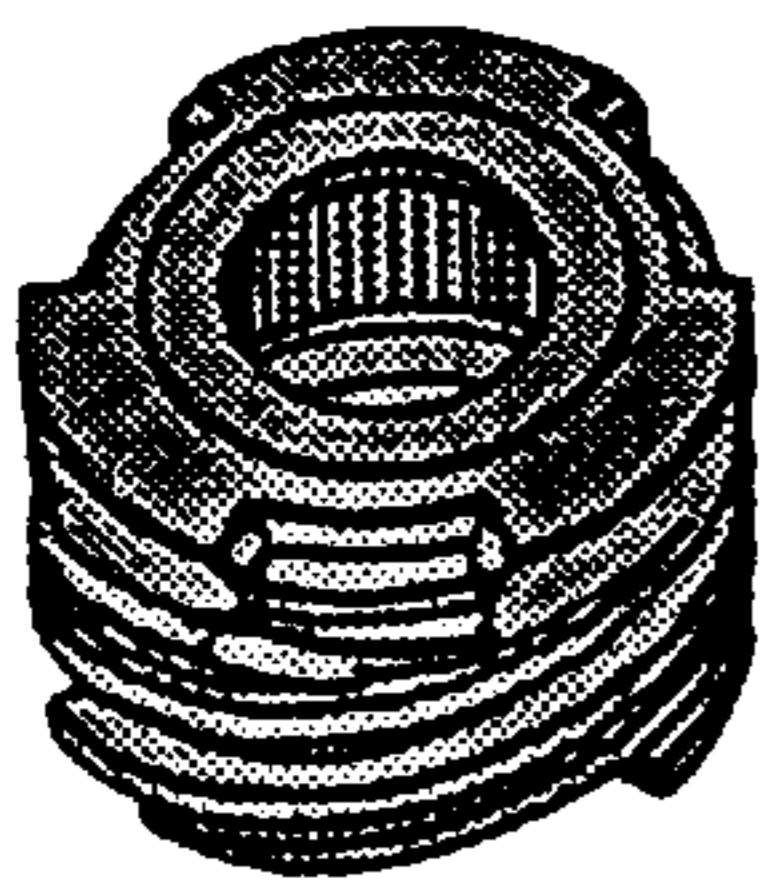

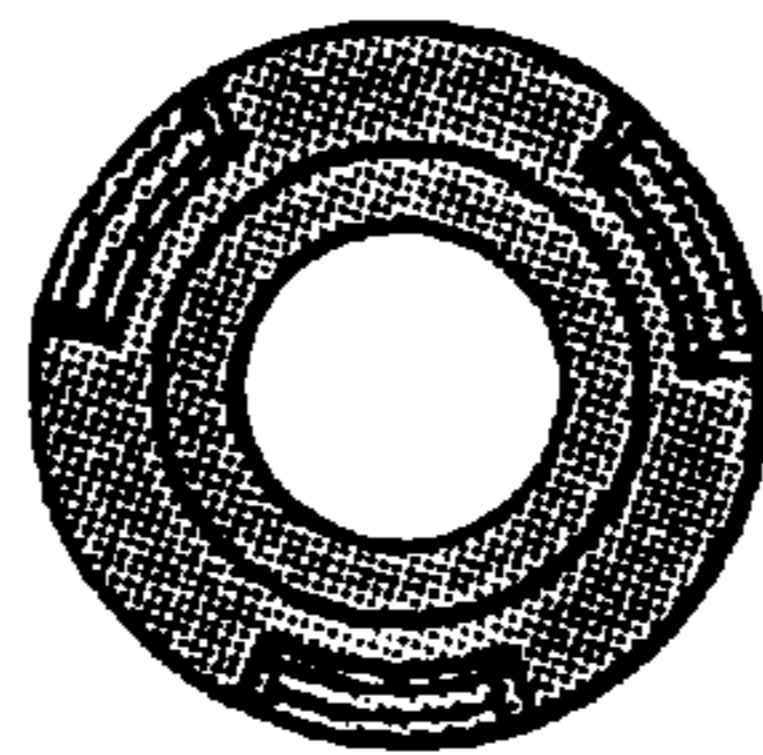

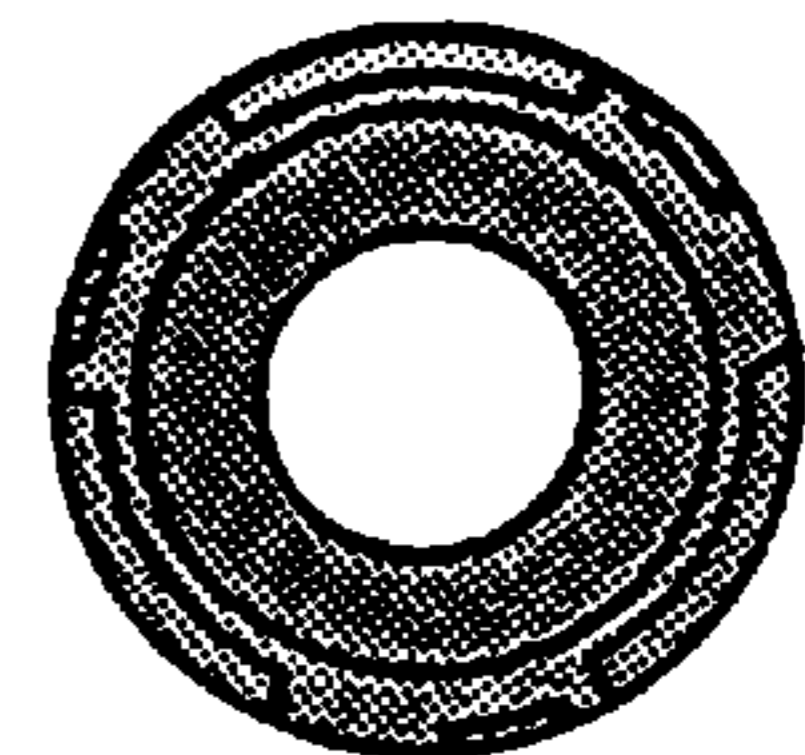

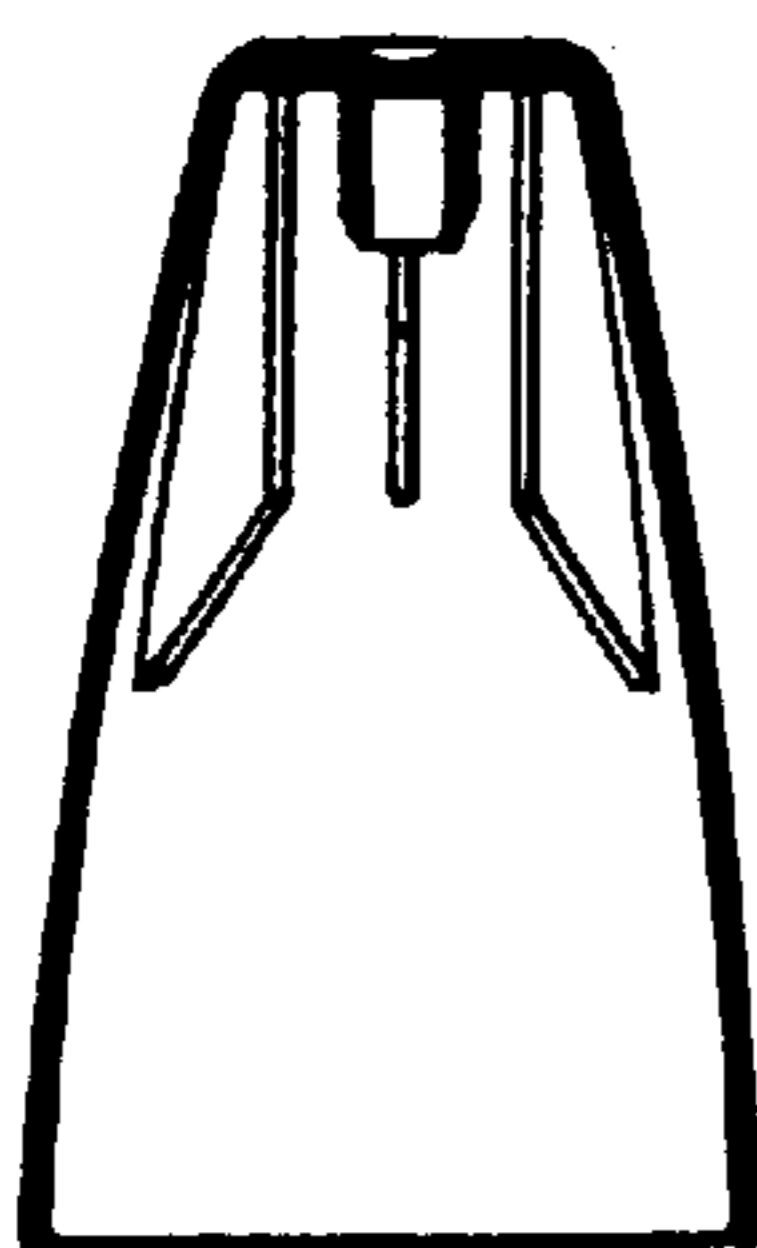

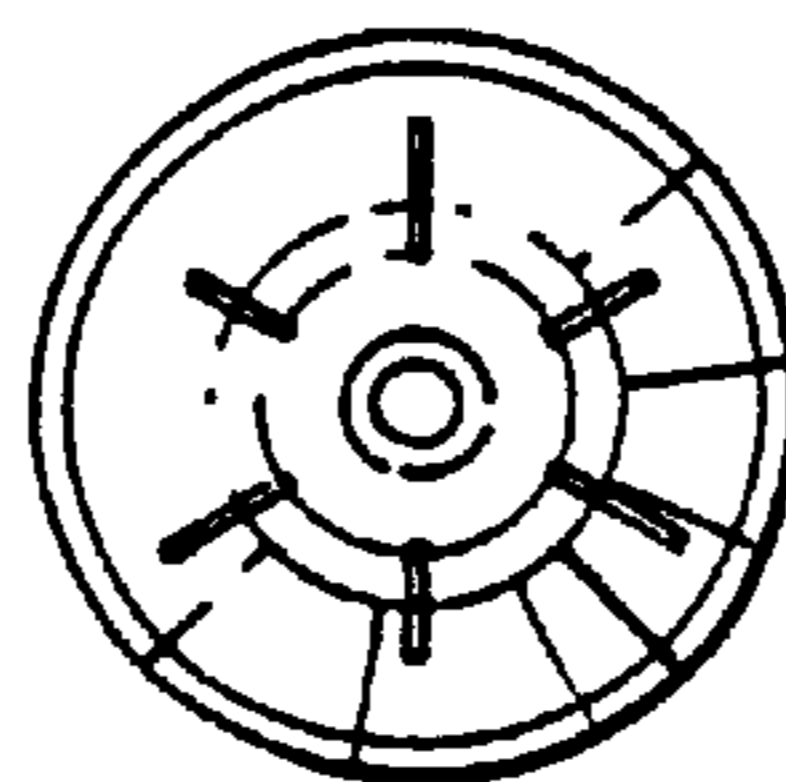

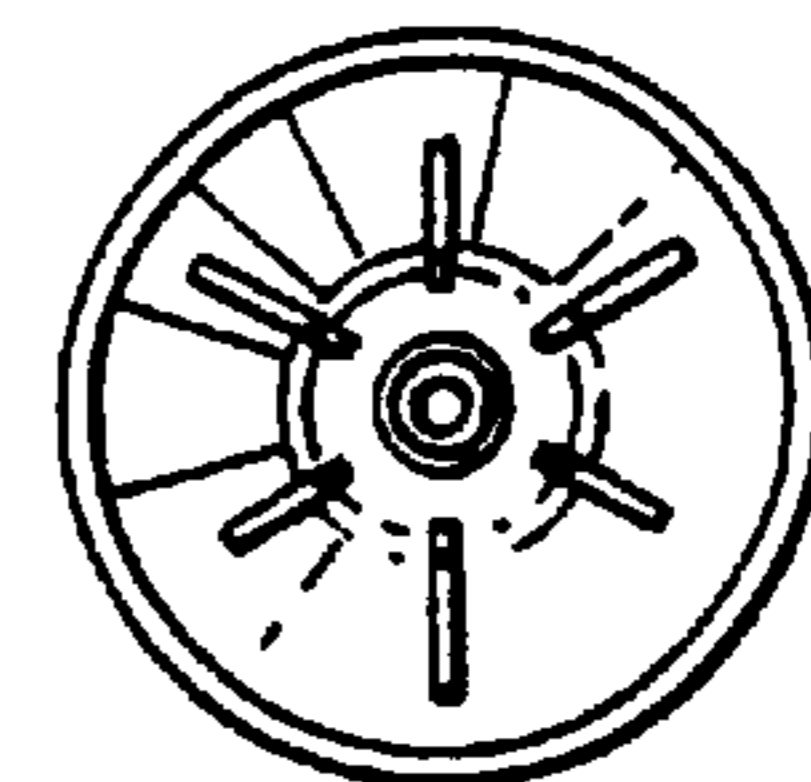
