(57) **CLAIM**

The ornamental design for a vehicle fender, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a vehicle fender of the present invention showing my new design;
 FIG. 2 is a left side elevational view of the vehicle fender of FIG. 1;
 FIG. 3 is a right side elevational view of the vehicle fender of FIG. 1;
 FIG. 4 is a top plan view of the vehicle fender of FIG. 1;
 FIG. 5 is a front elevational view of the vehicle fender of FIG. 1;
 FIG. 6 is a rear elevational view of the vehicle fender of FIG. 1;
 FIG. 7 is a right front perspective view of a second embodiment of a vehicle fender of the present invention;
 FIG. 8 is a right side elevational view of the vehicle fender of FIG. 7;
 FIG. 9 is a left side elevational view of the vehicle fender of FIG. 7;
 The broken lines shown in the FIG. 1 drawing view are for illustrative purposes only and form no part of the claimed design.
 FIG. 10 is a top plan view of the vehicle fender of FIG. 7;
 FIG. 11 is a front elevational view of the vehicle fender of FIG. 7; and,
 FIG. 12 is a rear elevational view of the vehicle fender of FIG. 7.
 The broken line representation of an aperture in Figures 2, 3, 8 and 9 is for illustrative purposes only and forms no part of the claimed design. The bottom view of each embodiment is unornamental and forms no part of the claimed design.

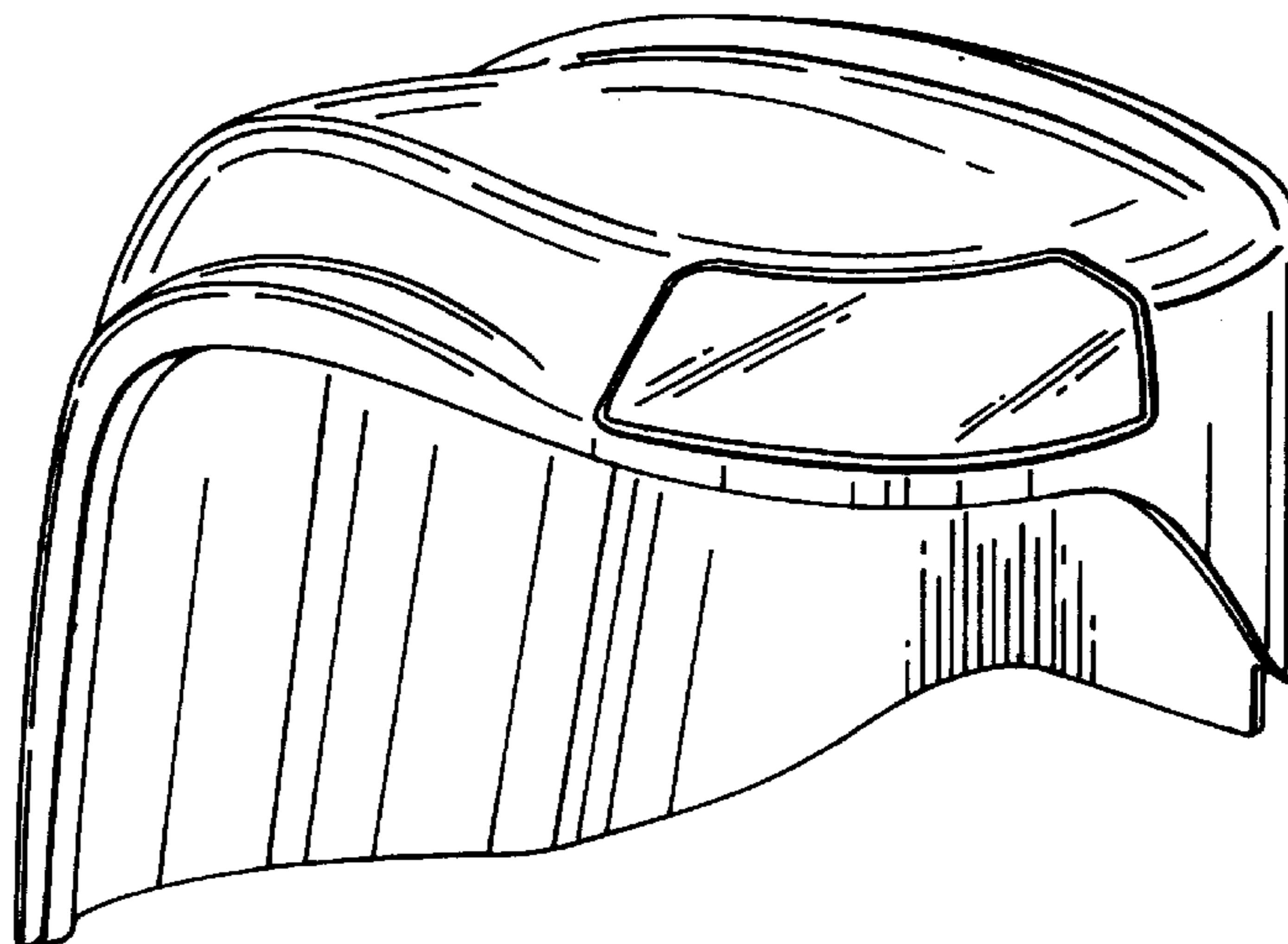

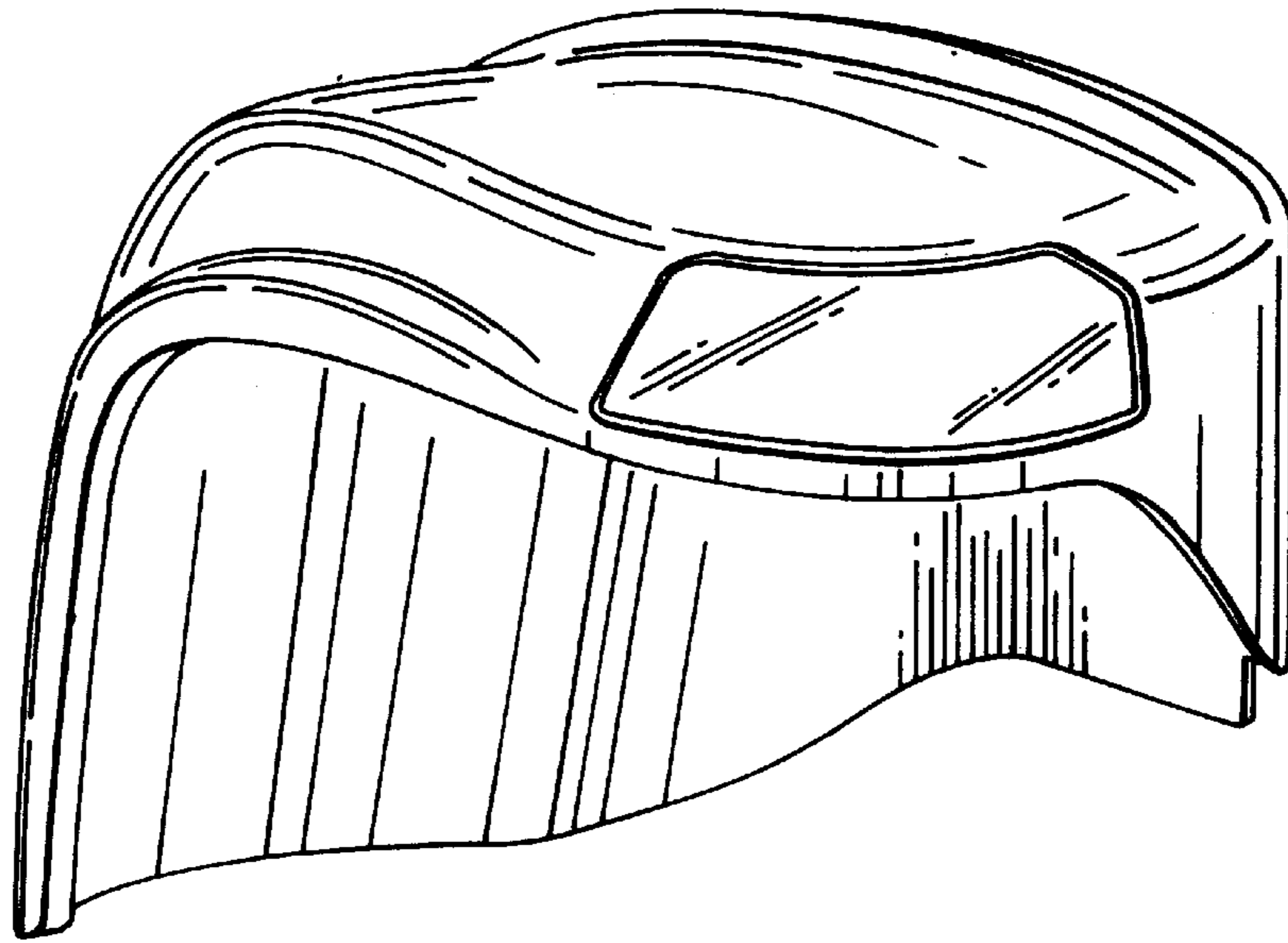

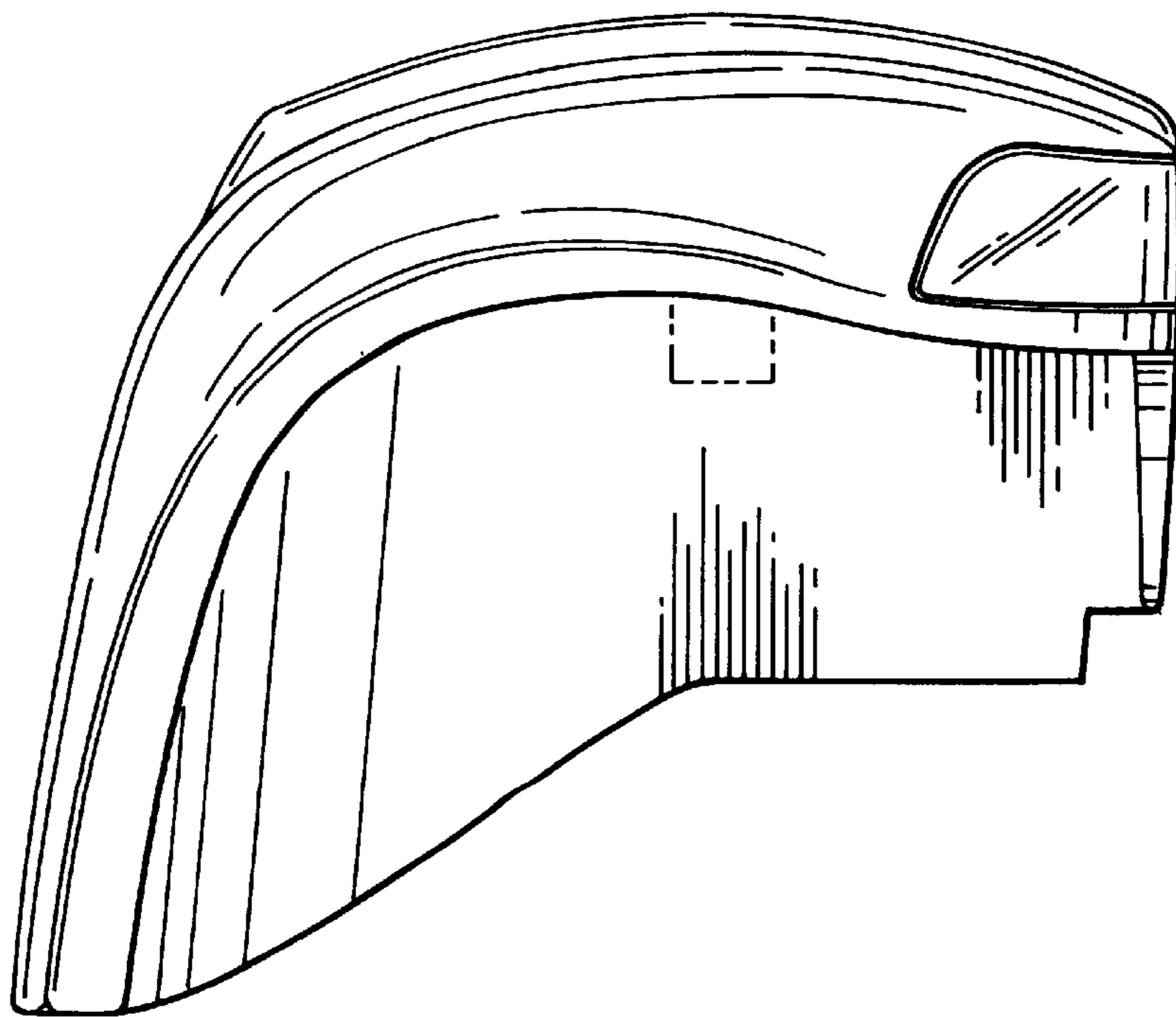

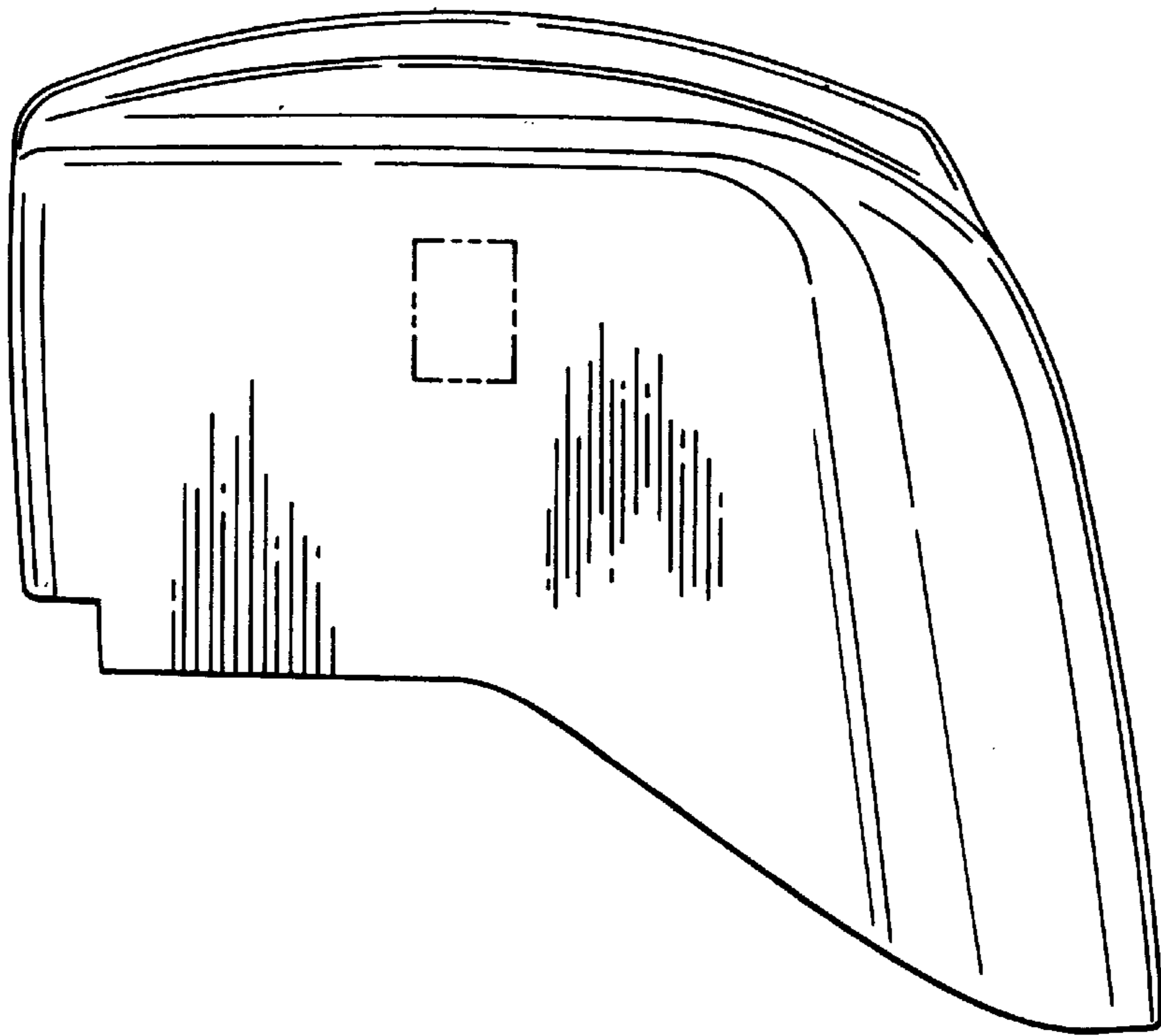

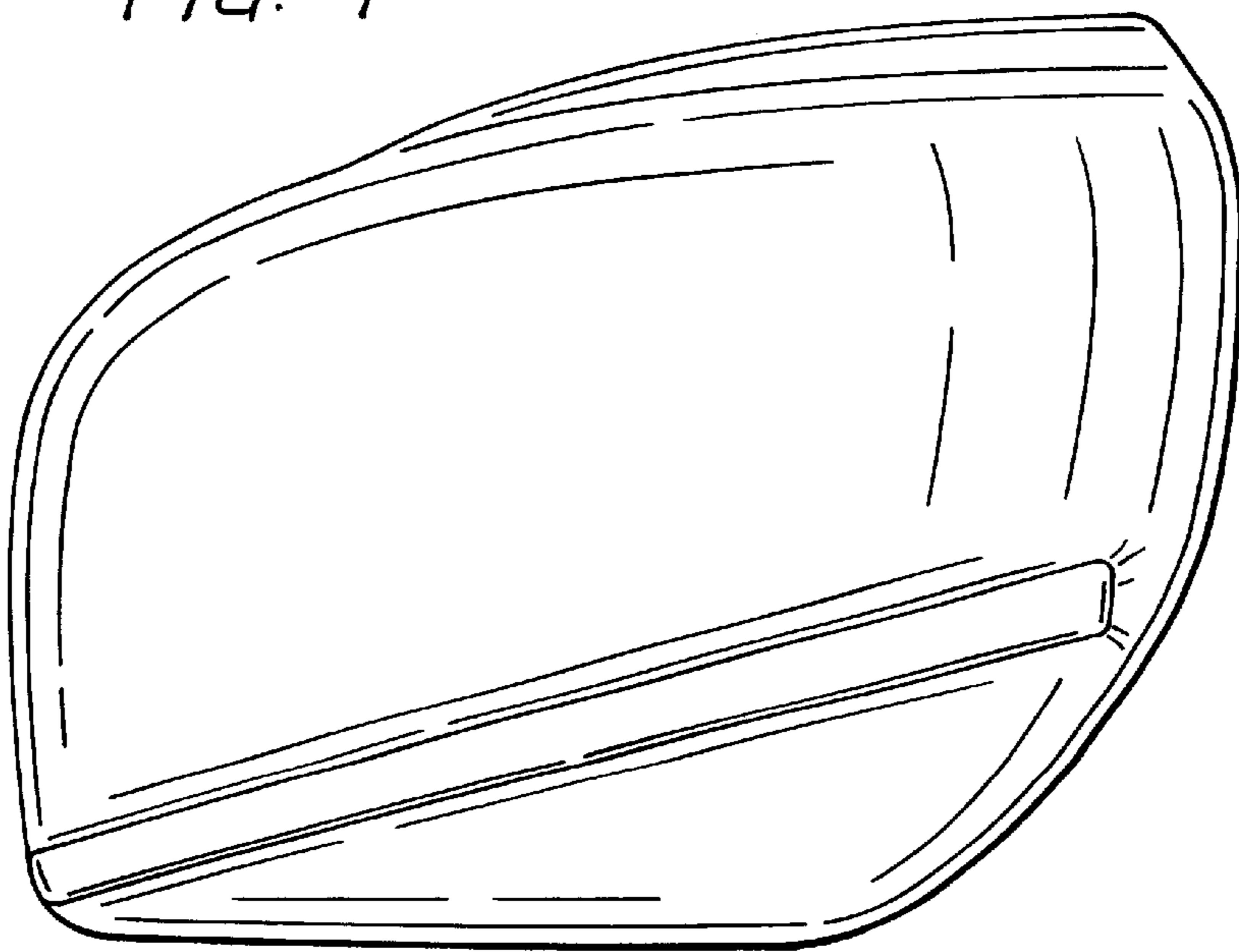

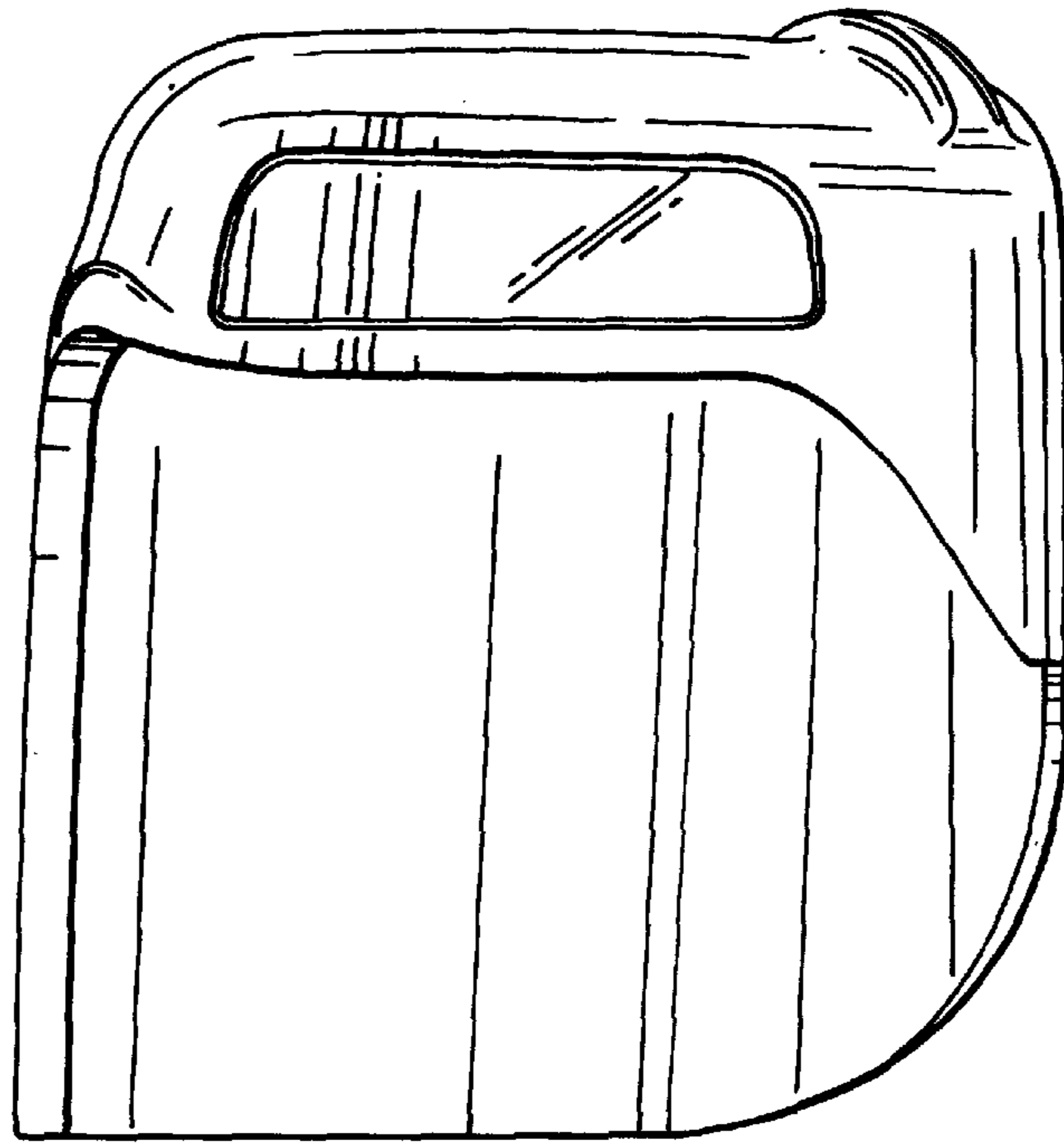

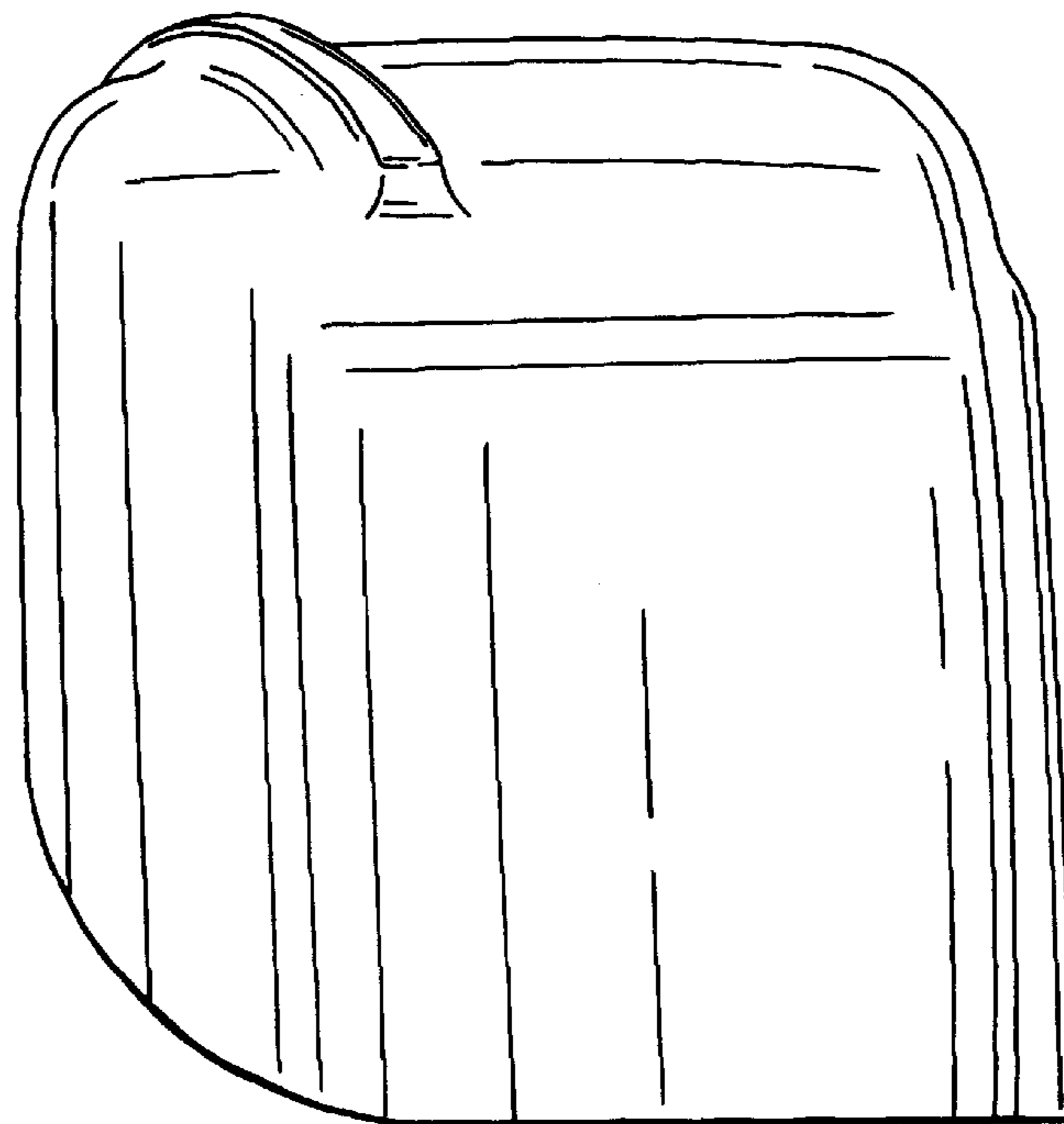

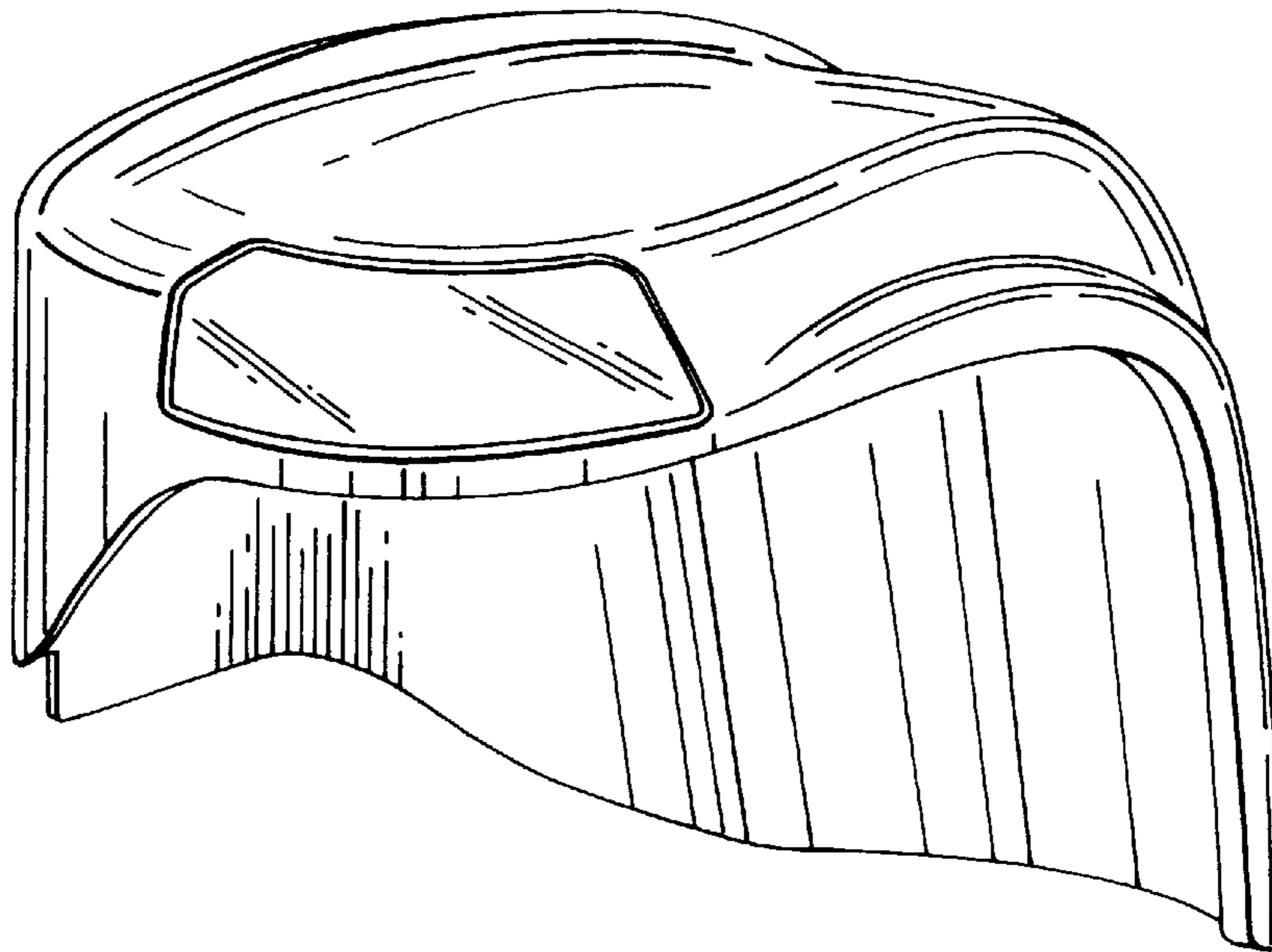

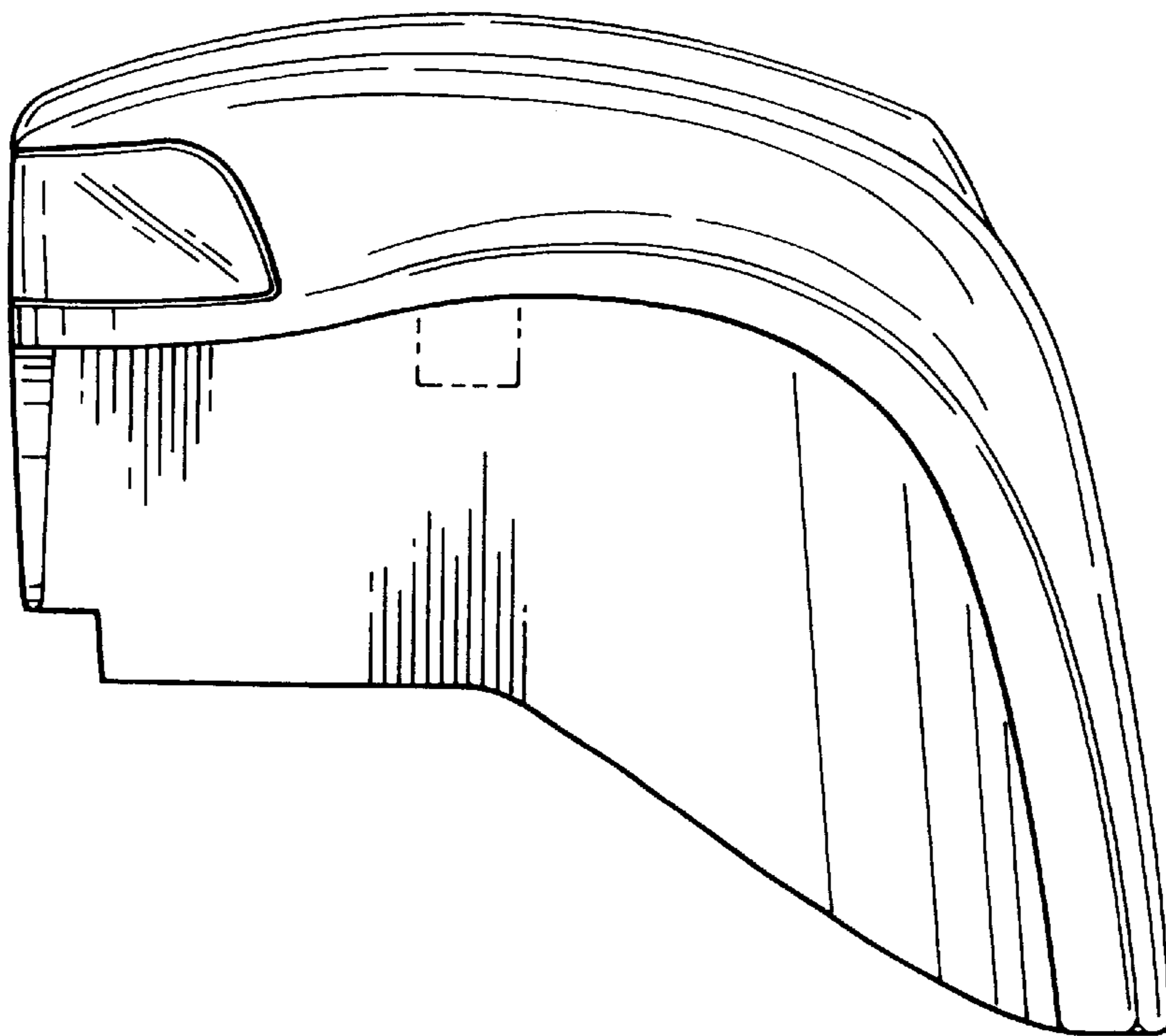

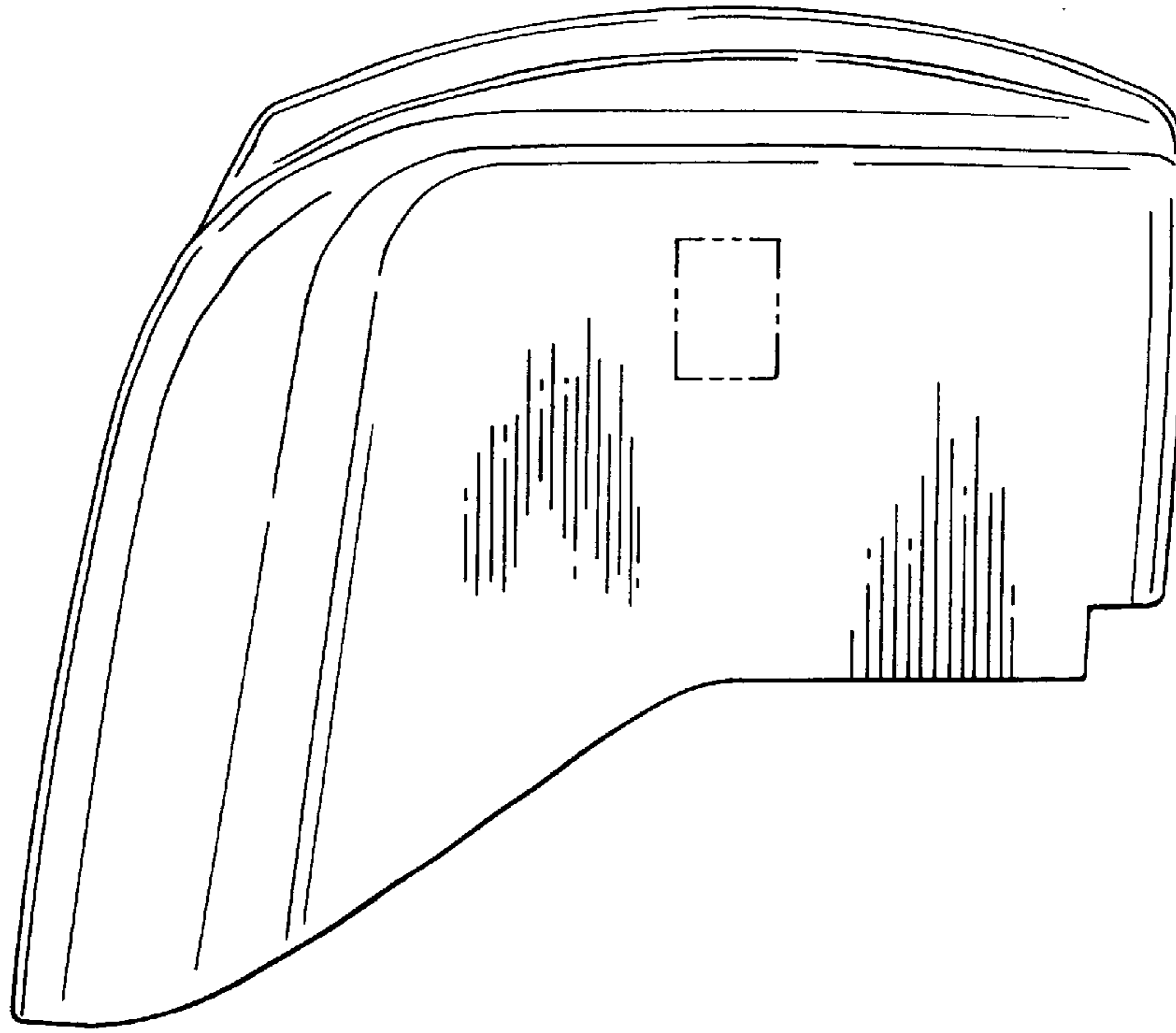

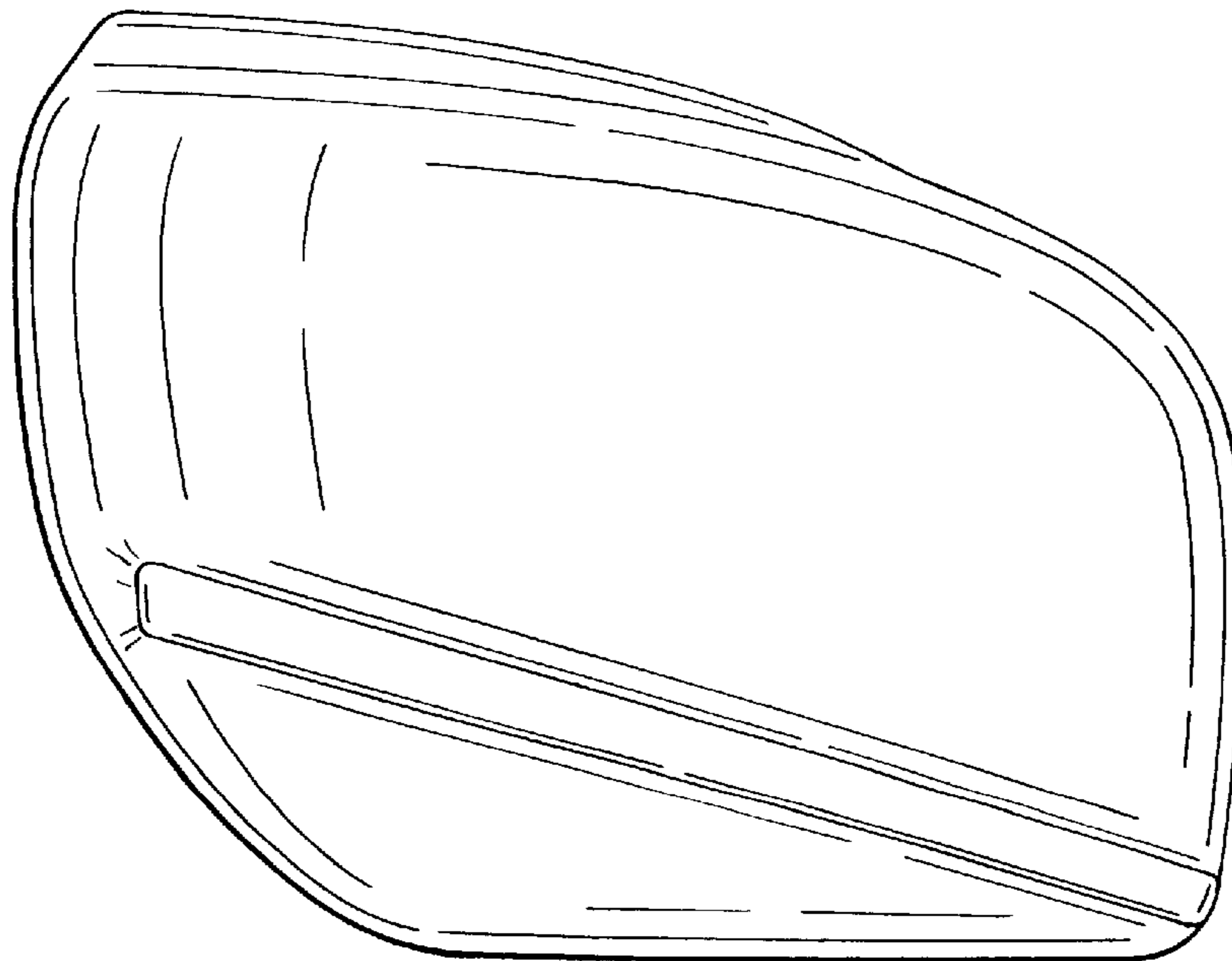

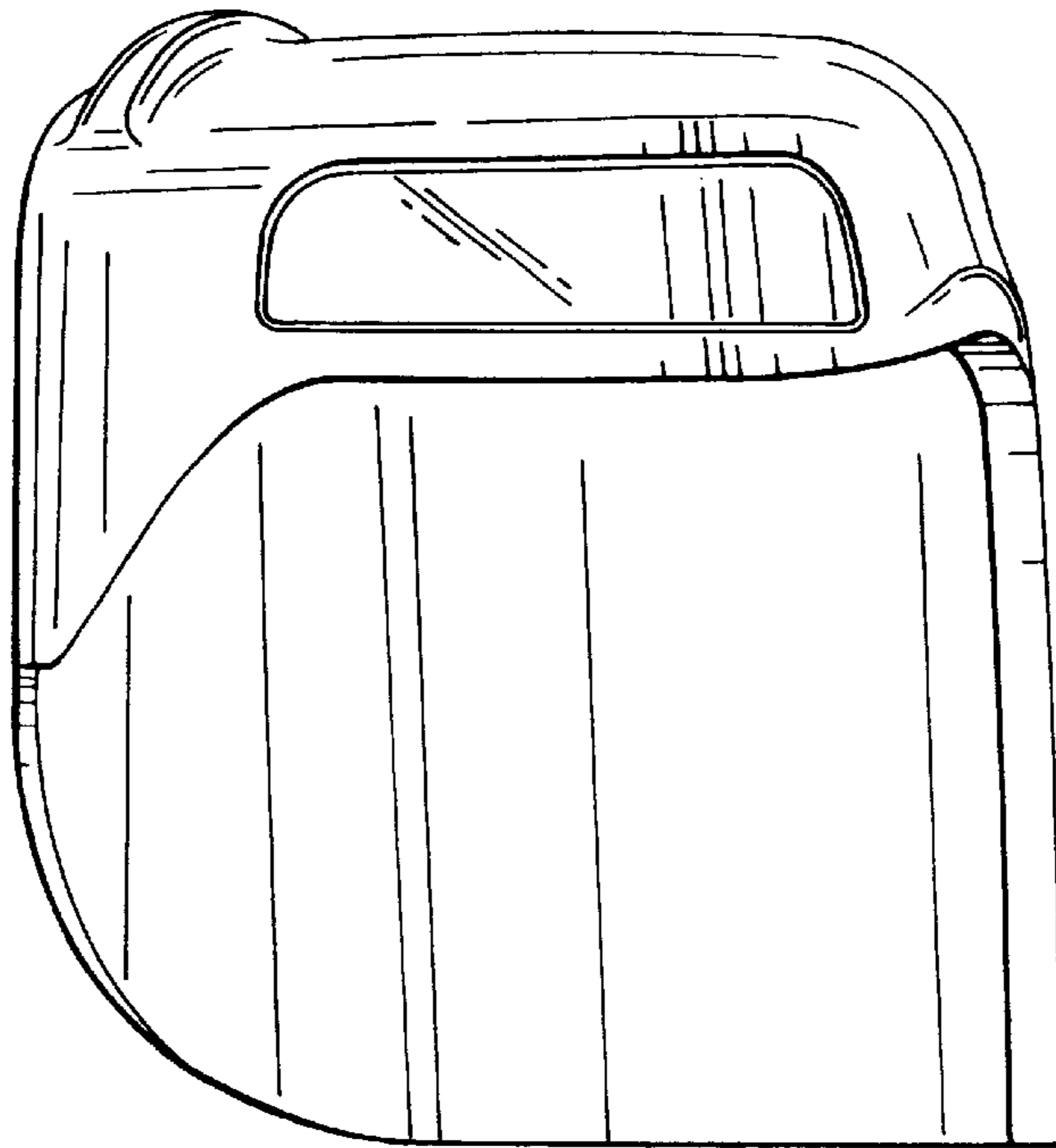
