(57) **CLAIM**

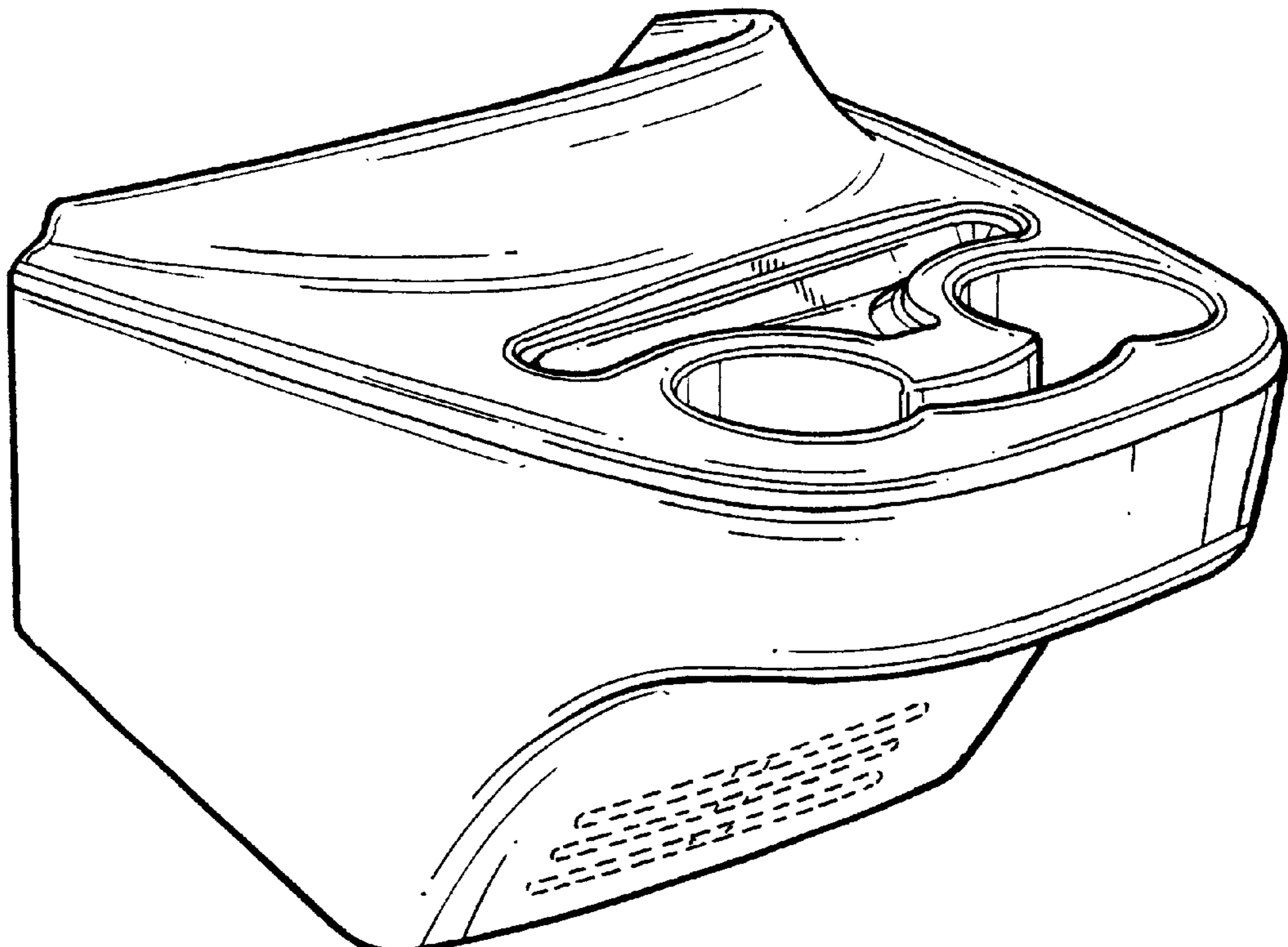
The ornamental design for a console for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left, front perspective view of a console for a vehicle according to our novel design, the right, front perspective view being mirror symmetrical;
FIG. 2 is a front view of the console for a vehicle according to our novel design;
FIG. 3 is a top view of the console for a vehicle according to our novel design; and,
FIG. 4 is a left side view of the console for a vehicle according to our novel design, the right side view being mirror symmetrical.

The dash lines included depict environment and are not part of the claimed design.

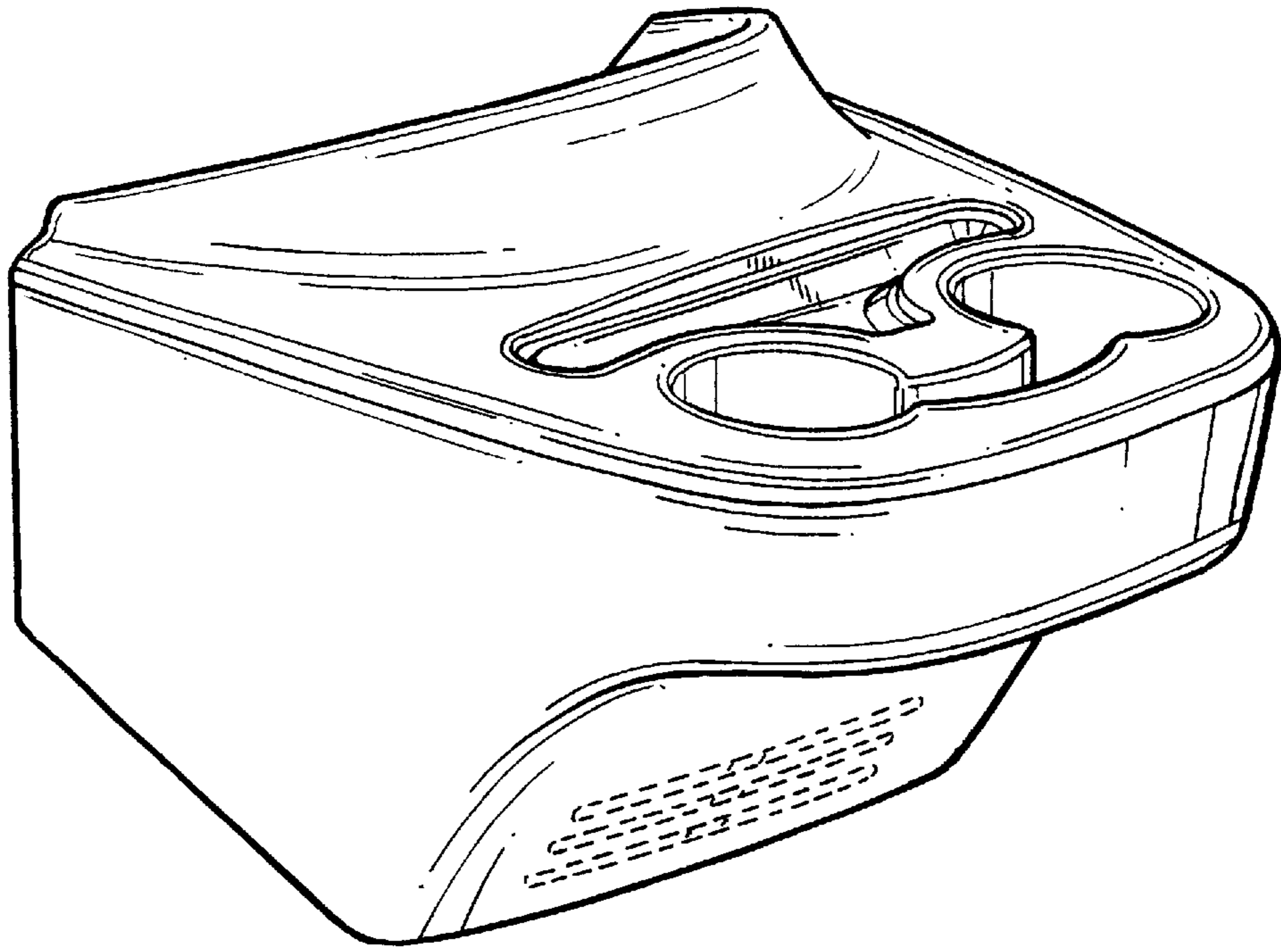

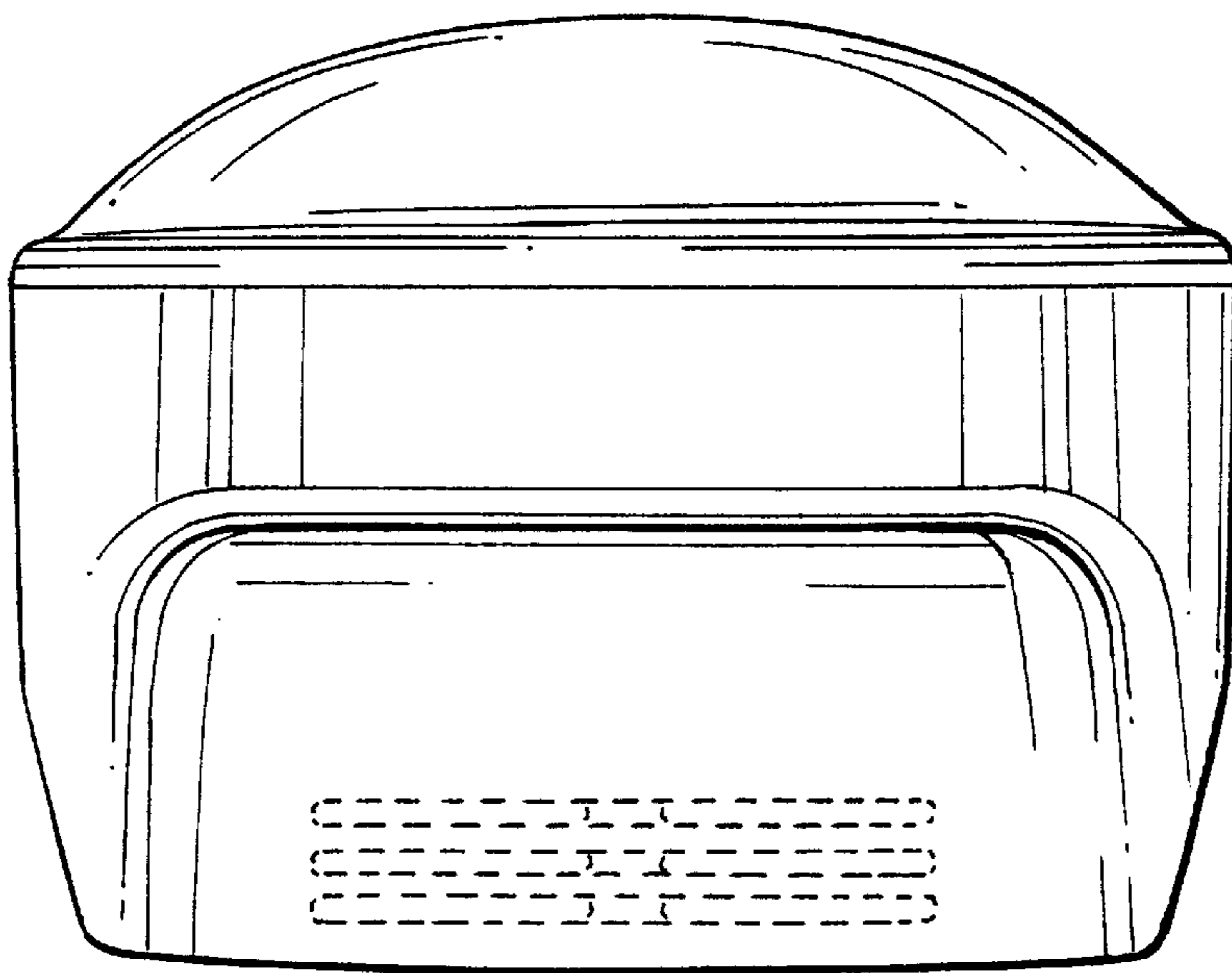

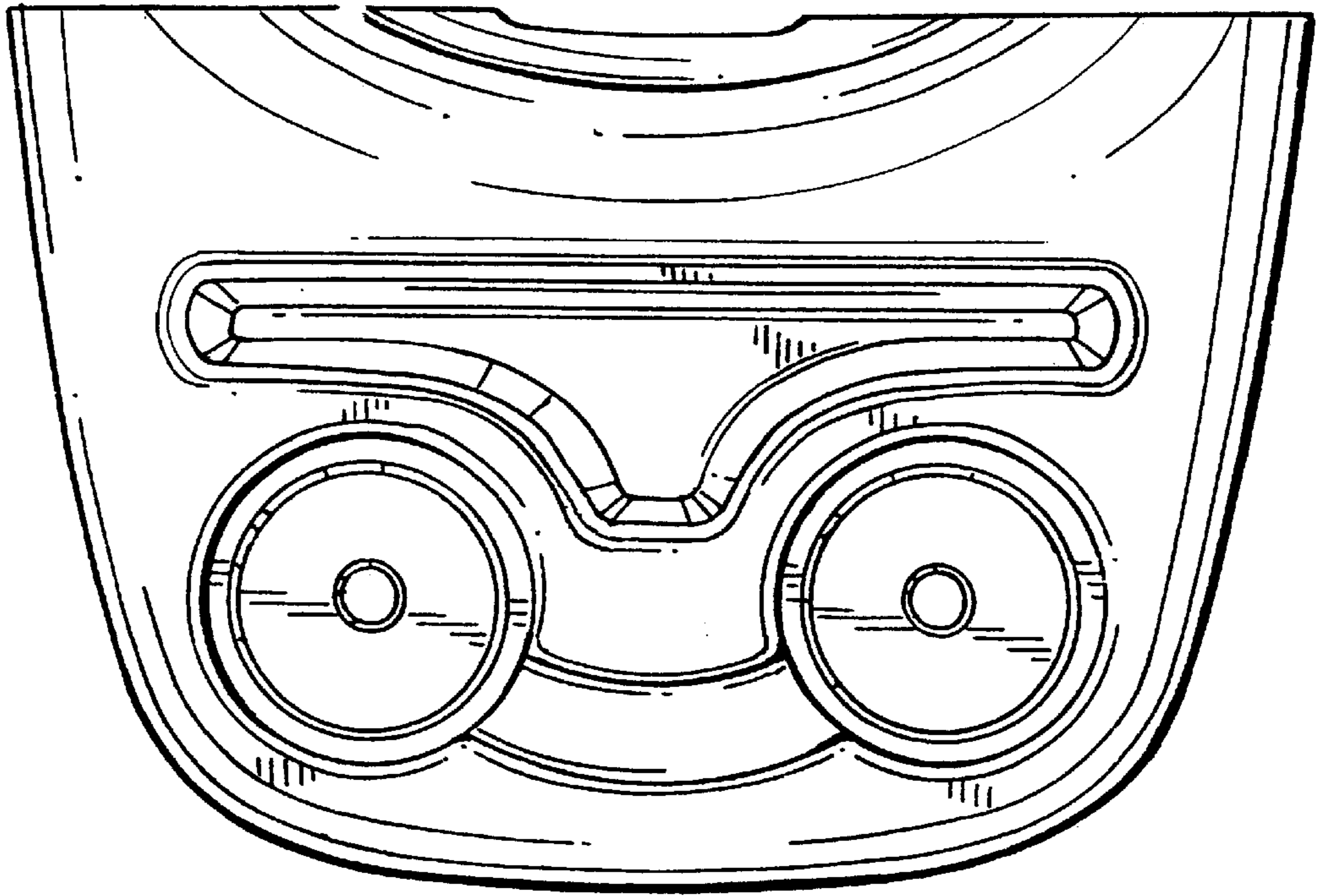

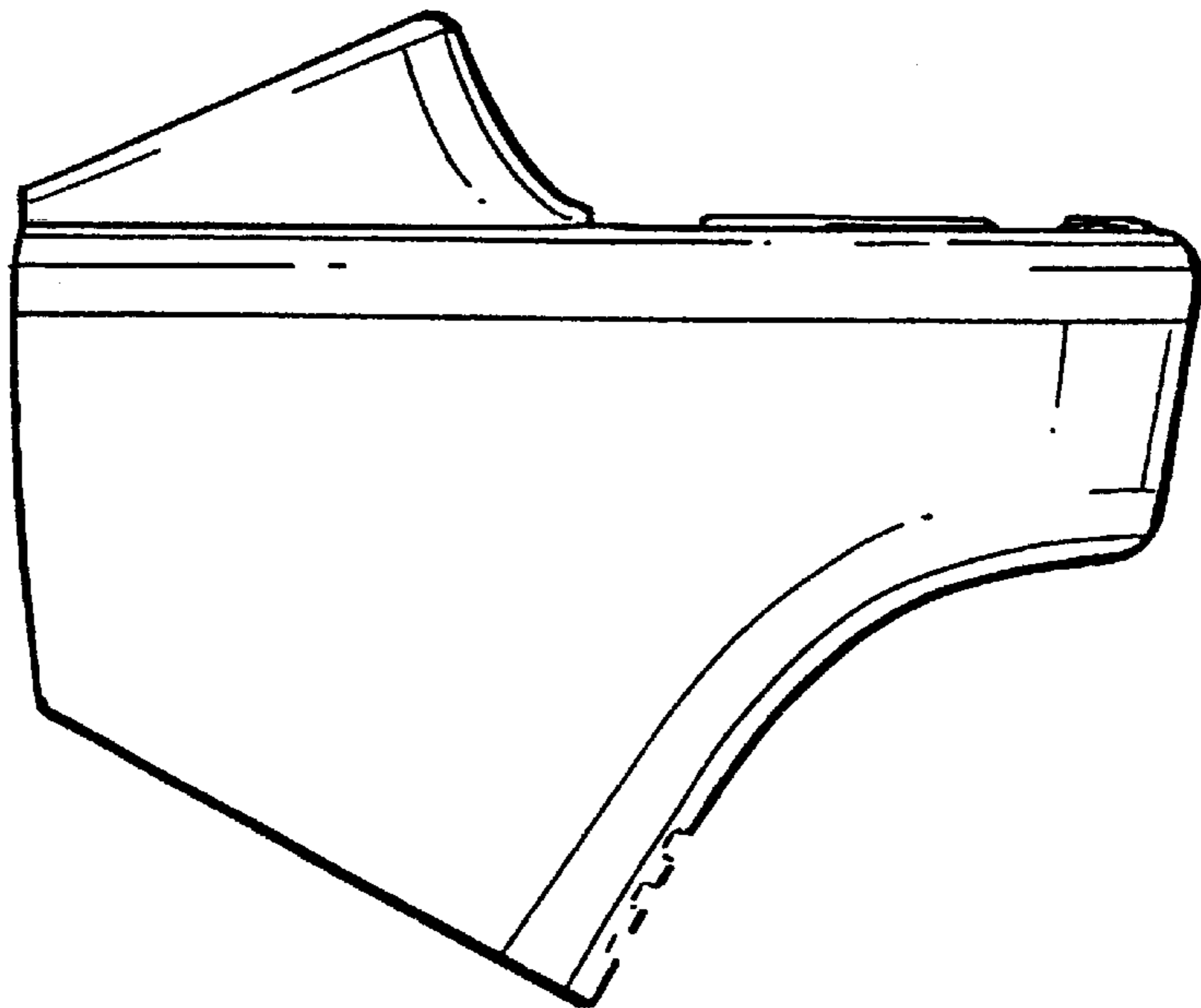
