(57) **CLAIM**

The ornamental design for a right fender surface, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated front right perspective view of a right fender surface showing our new design, the broken line showing being for illustrative purposes only, and forms no part of the claimed design.

FIG. 2 is an elevated front right perspective view of the right fender surface design of FIG. 1.

FIG. 3 is a plan view of the right fender surface design of FIG. 1.

FIG. 4 is a right side view of the right fender surface design of FIG. 1.

FIG. 5 is a front view of the right fender surface design of FIG. 1.

FIG. 6 is a rear view of the right fender surface design of FIG. 1; and,

FIG. 7 is a left side view of the right fender surface design of FIG. 1.

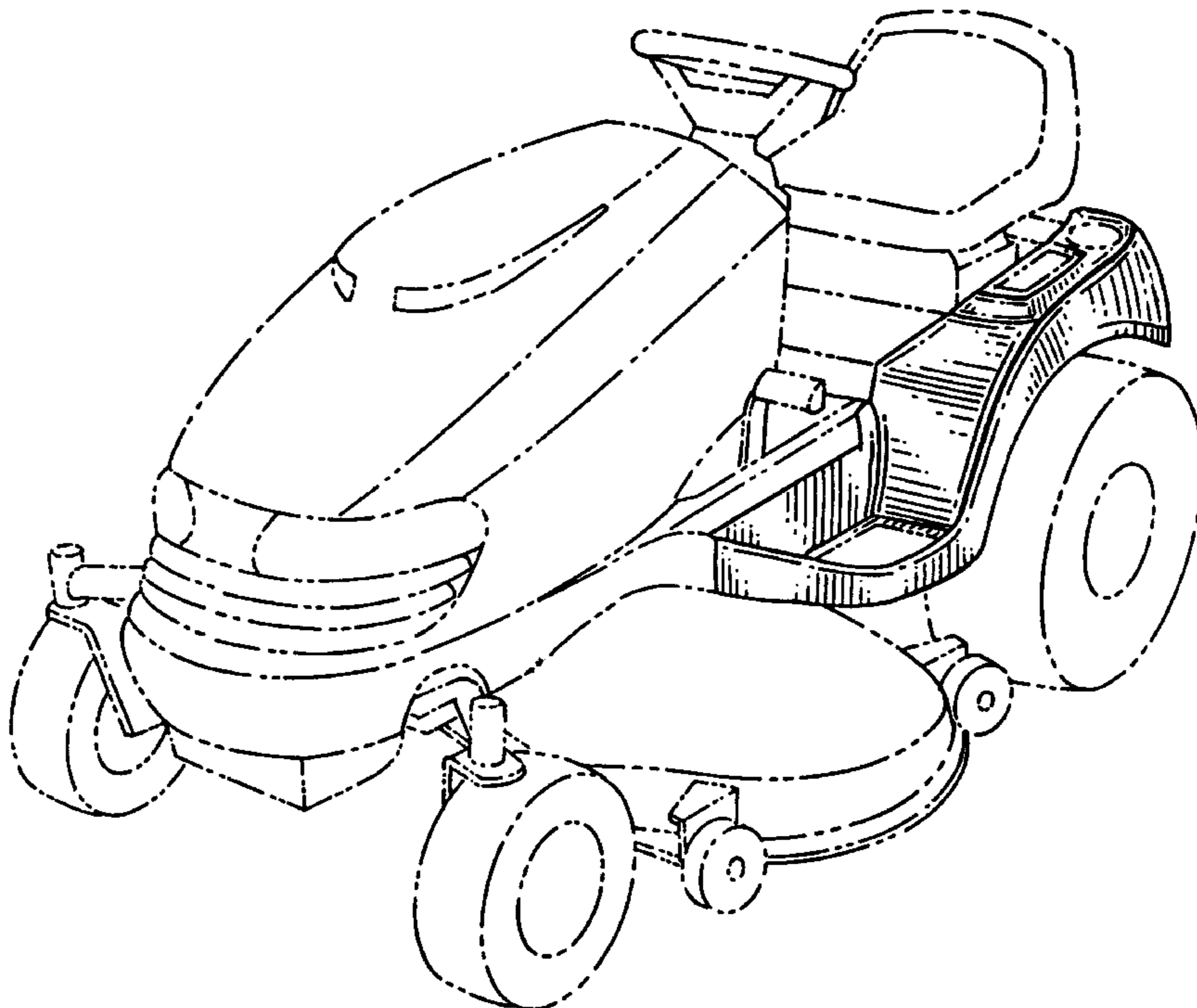

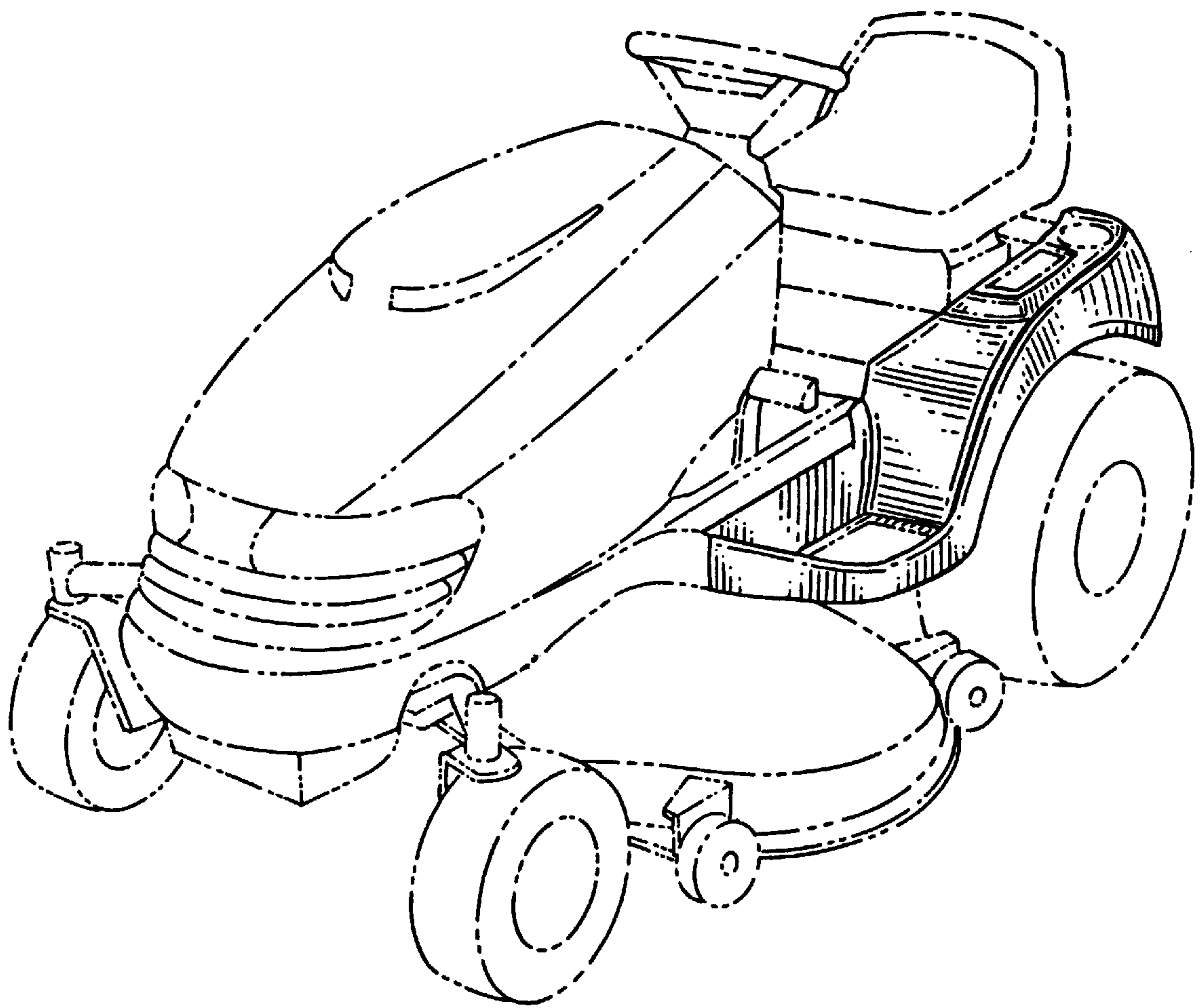
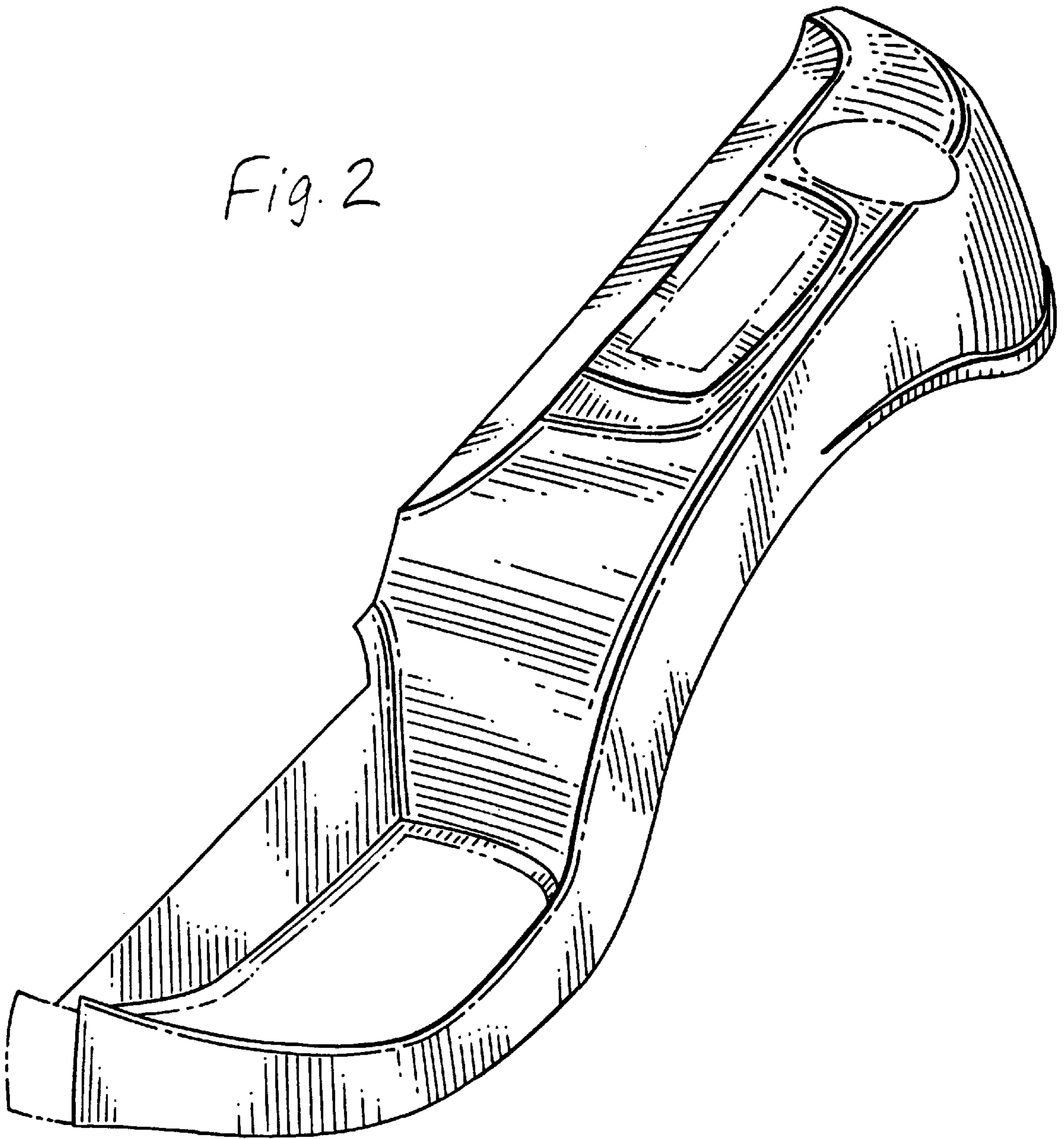

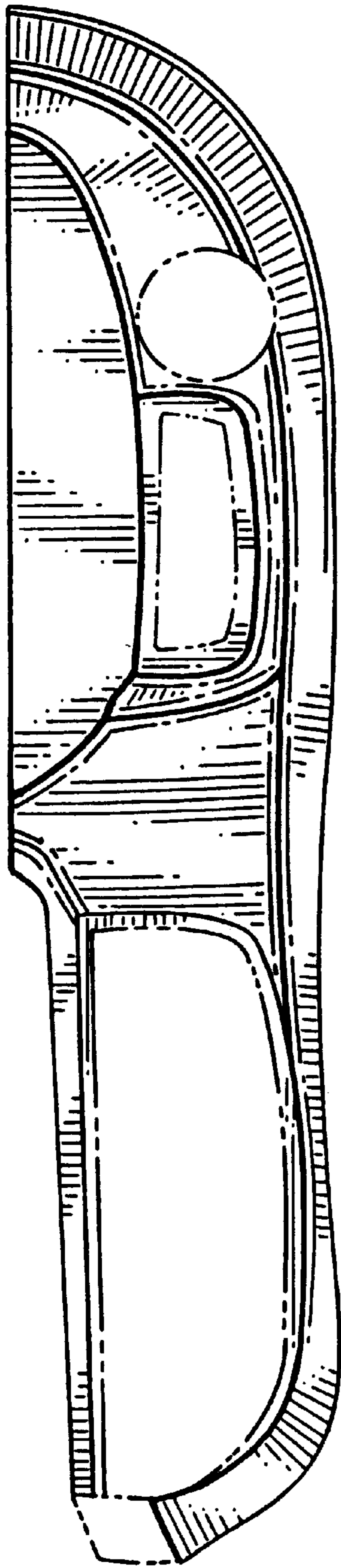

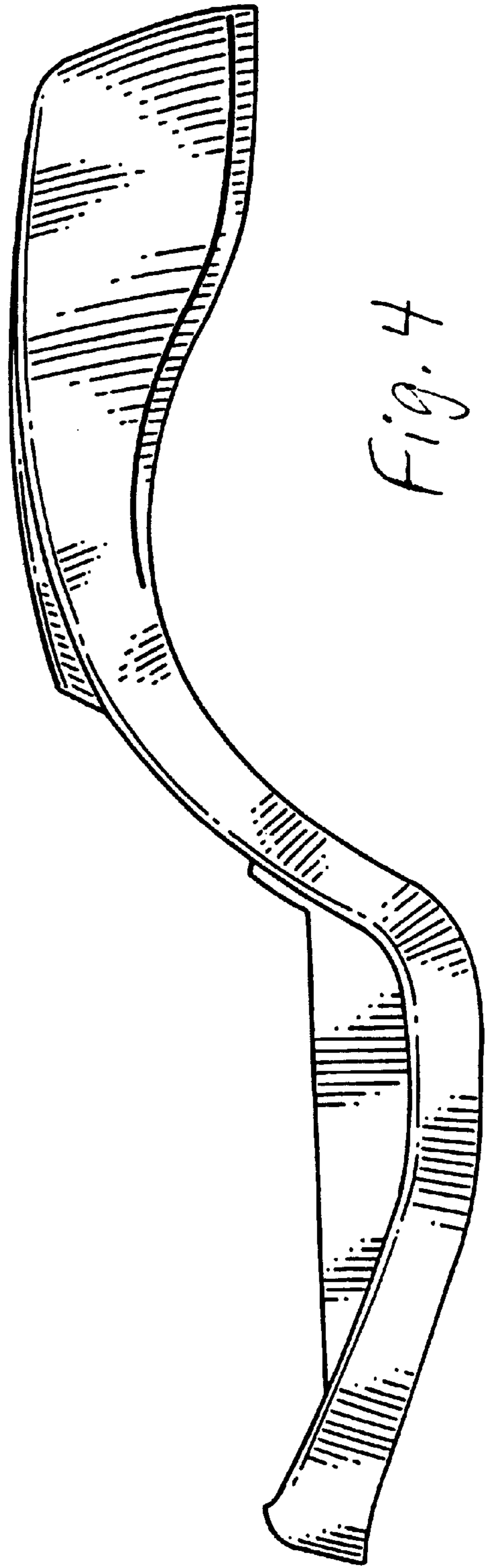

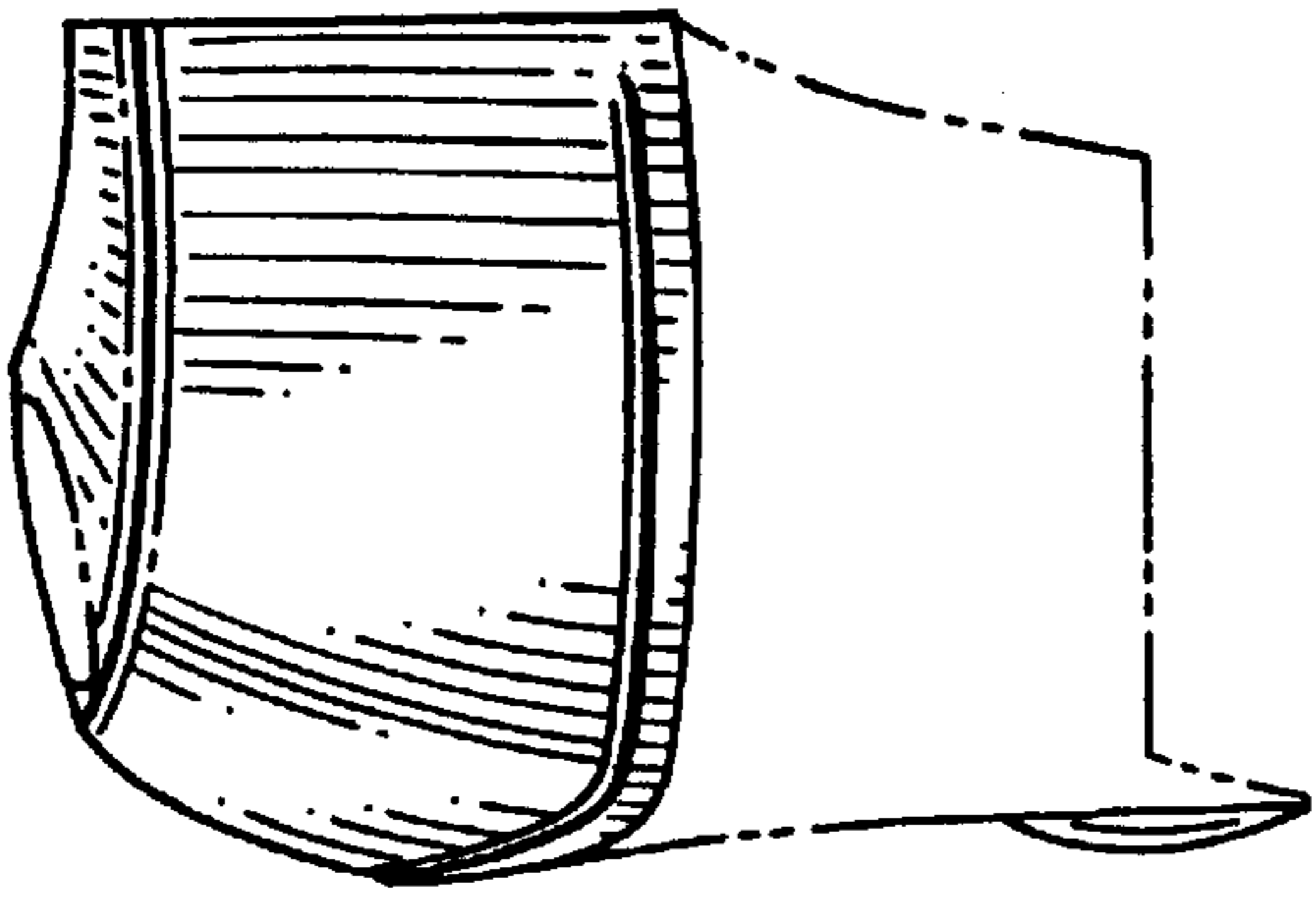

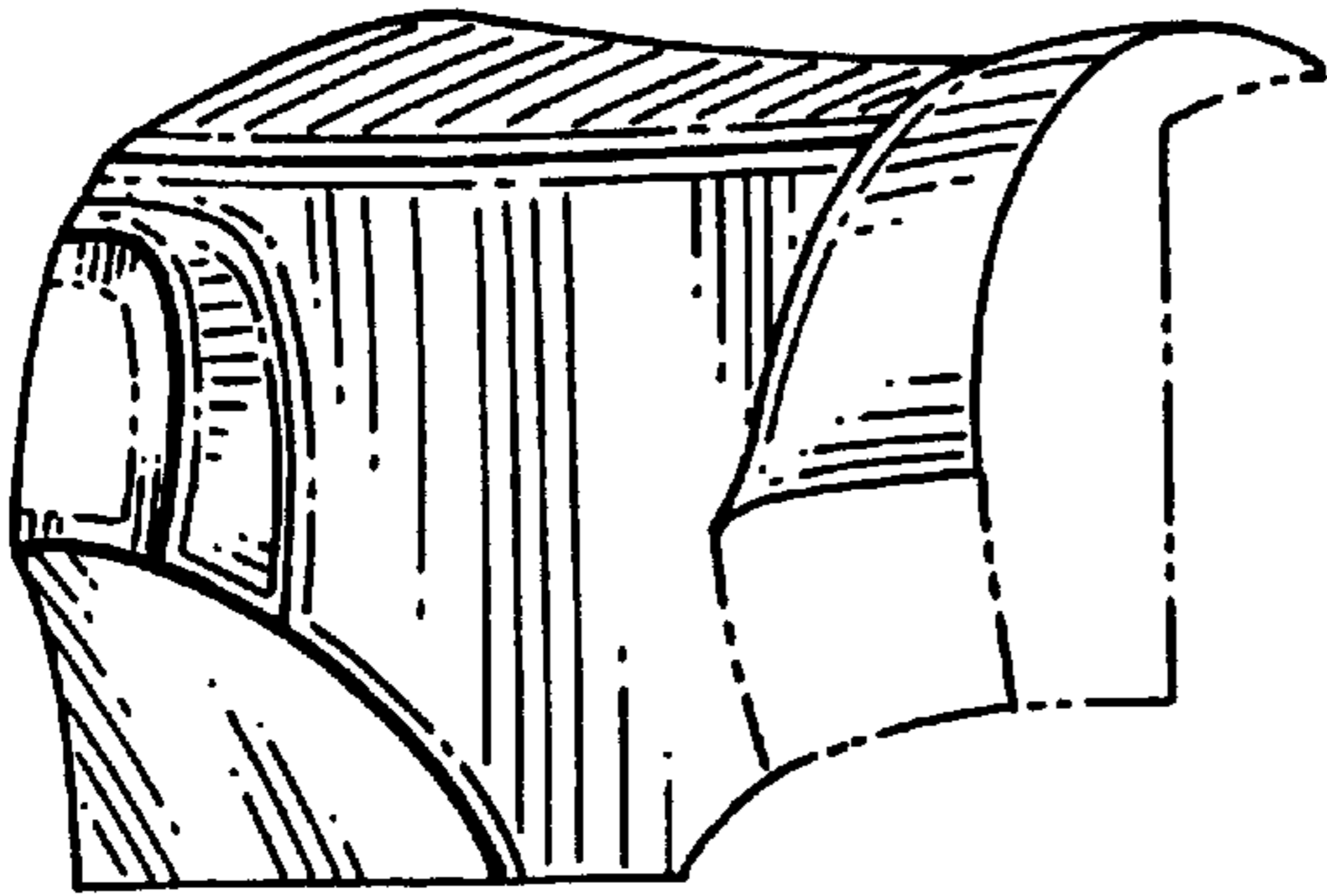

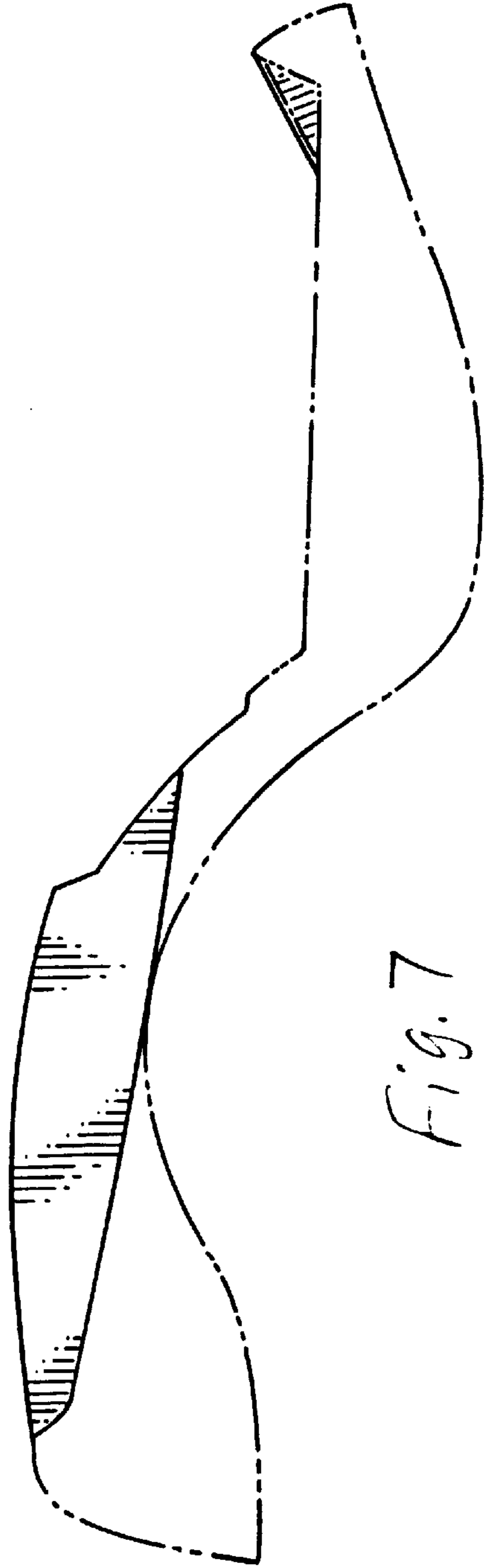
