(57) **CLAIM**

The ornamental design for a fork lift truck, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a fork lift truck showing our new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a sectional plan view thereof taken along line 7—7 in FIG. 5;

FIG. 8 is a perspective view thereof from the right front;

FIG. 9 is a perspective view thereof from the left rear;

FIG. 10 is a right side elevational view showing the wheels in an alternate position;

FIG. 11 is a perspective view thereof; and,

FIG. 12 is a right side elevational view showing the wheels in yet another alternate position.

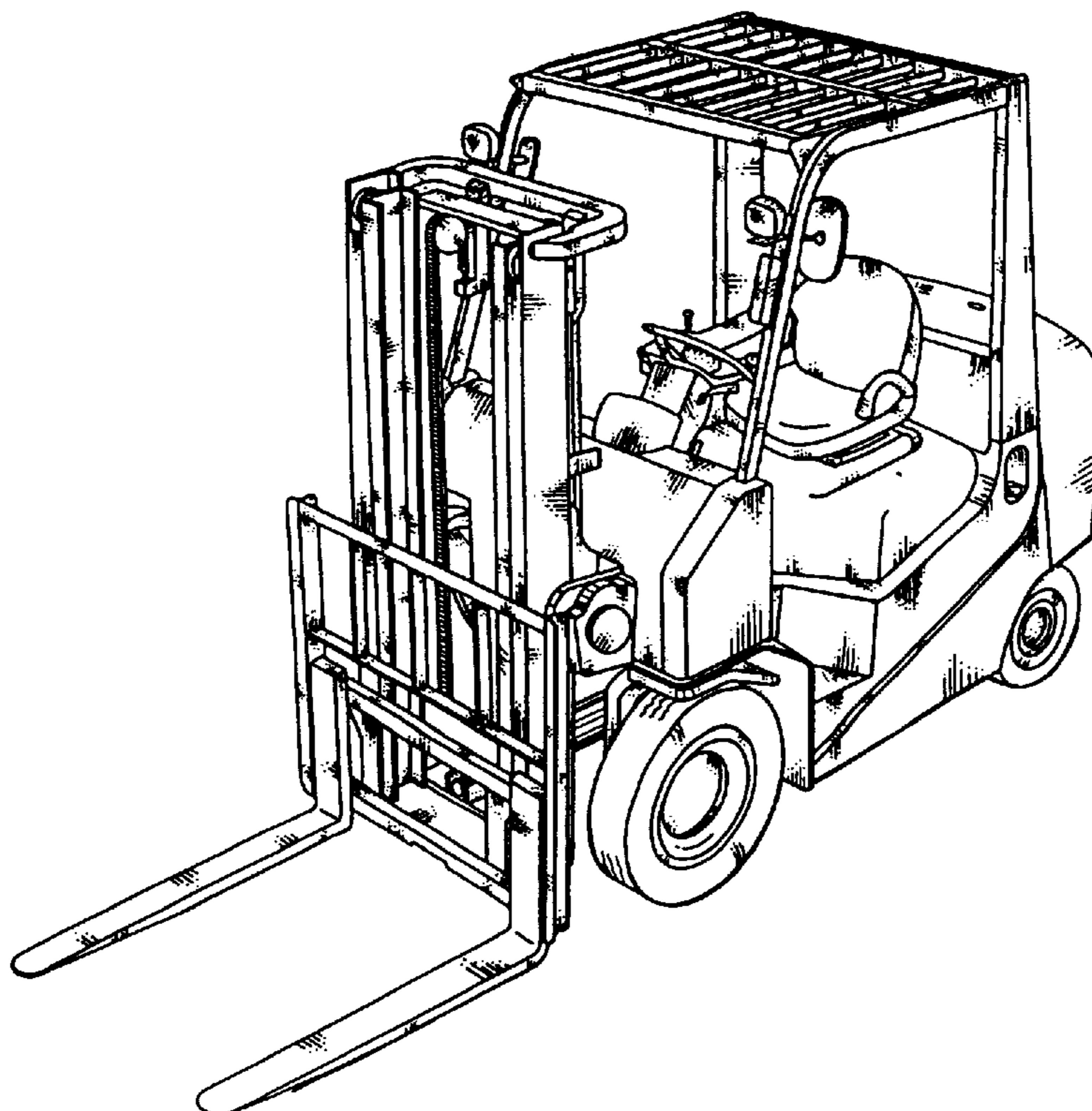

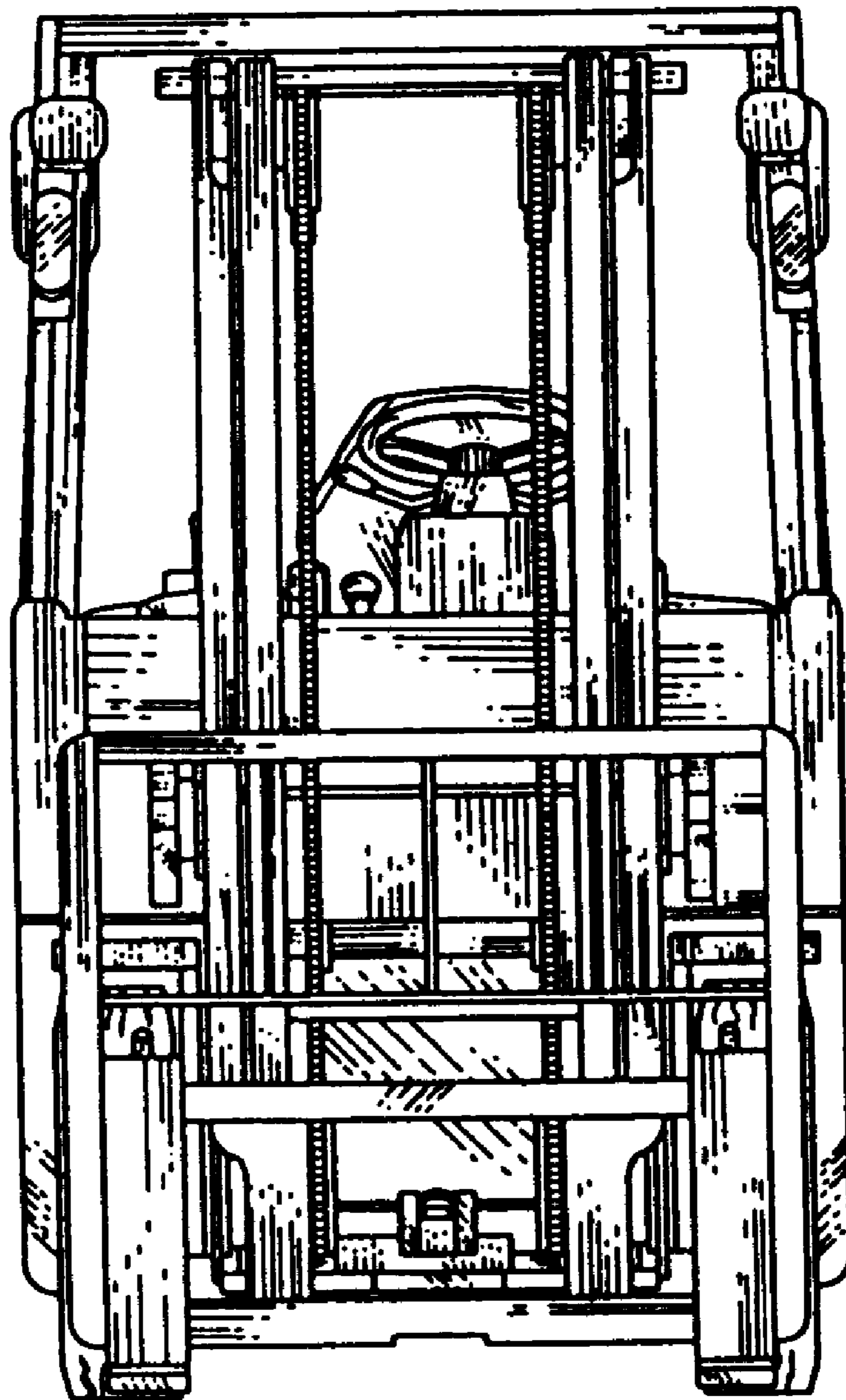

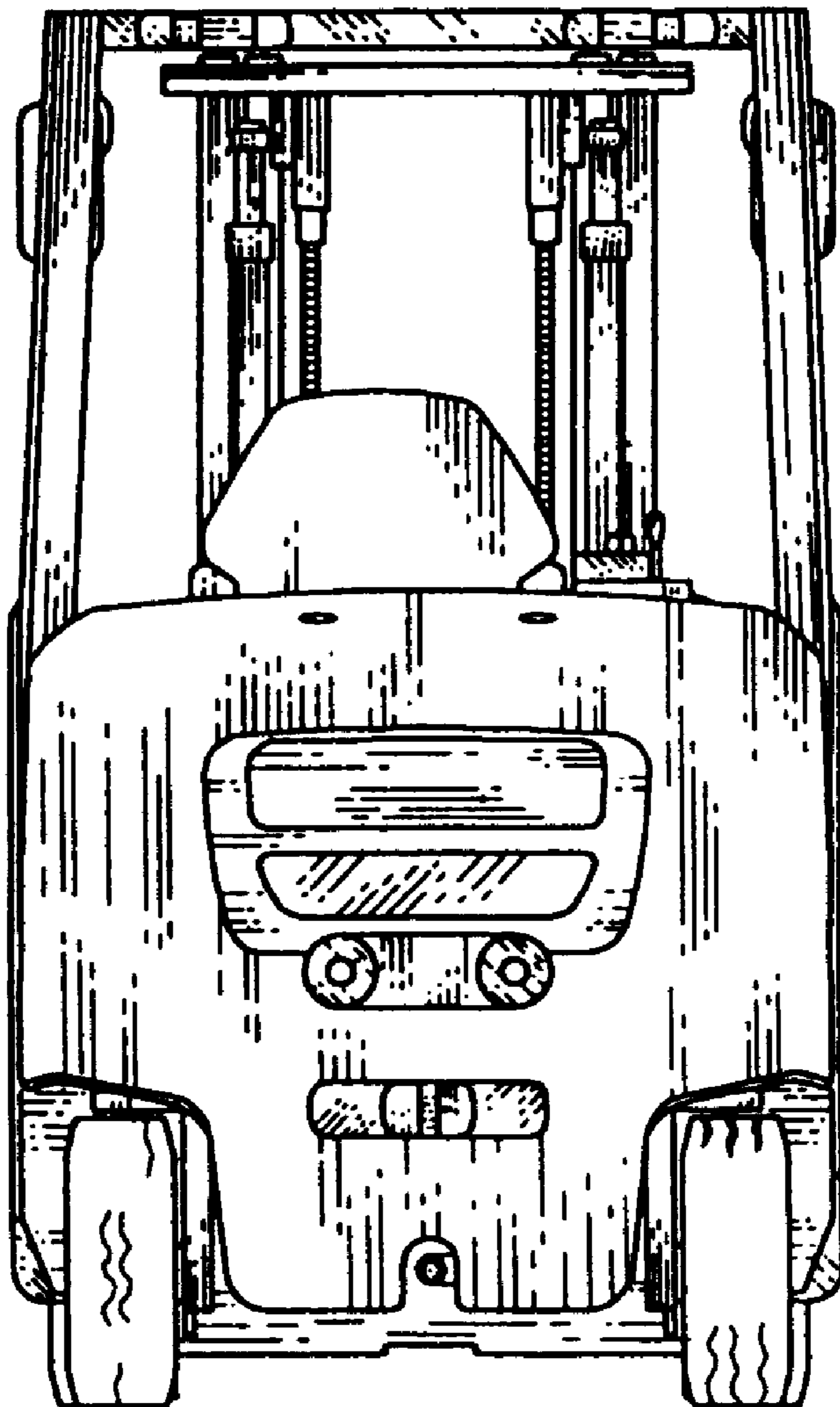

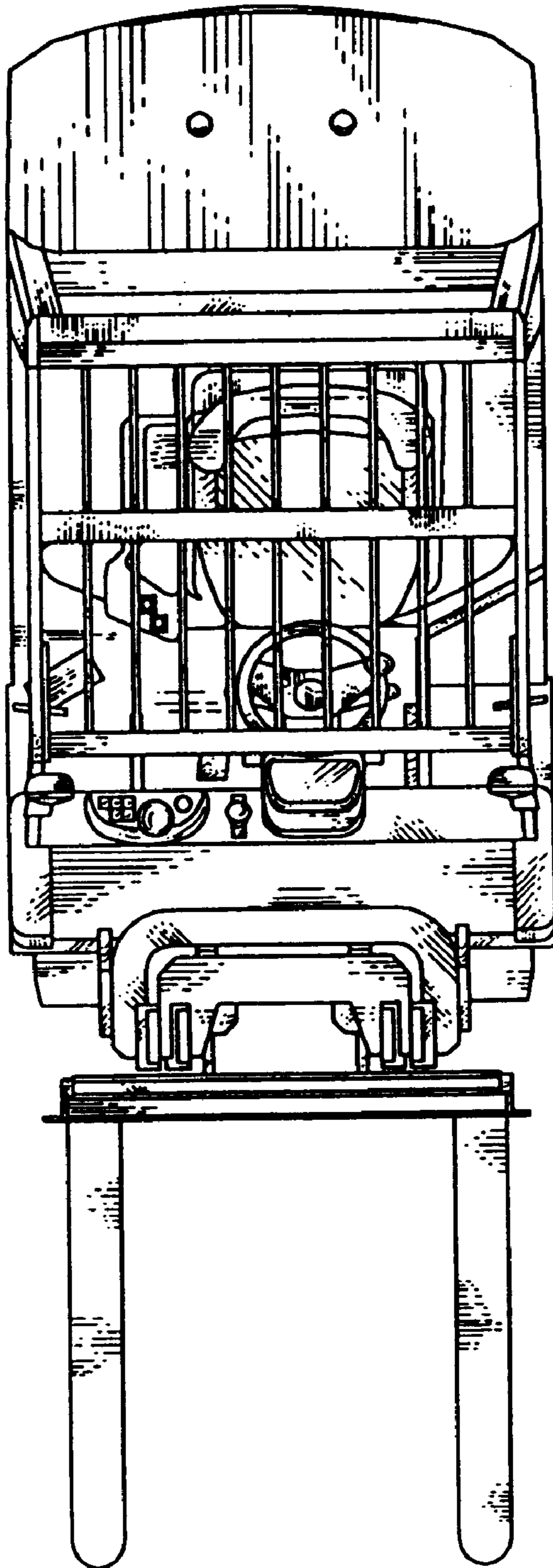

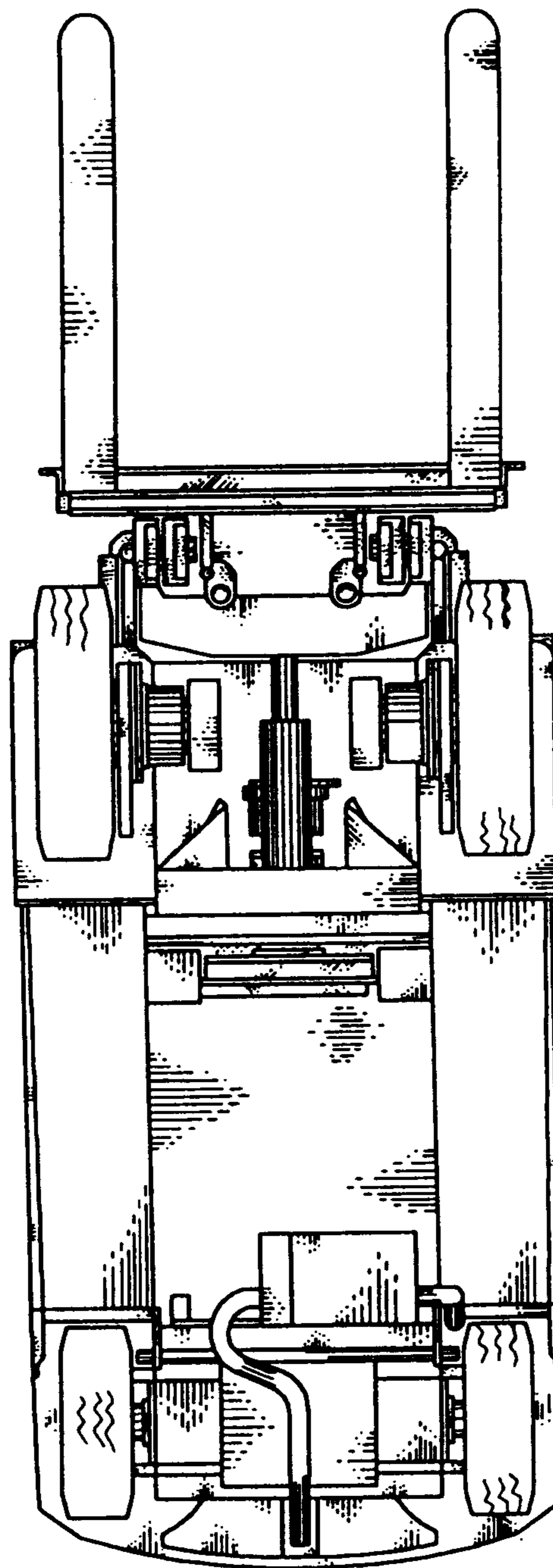

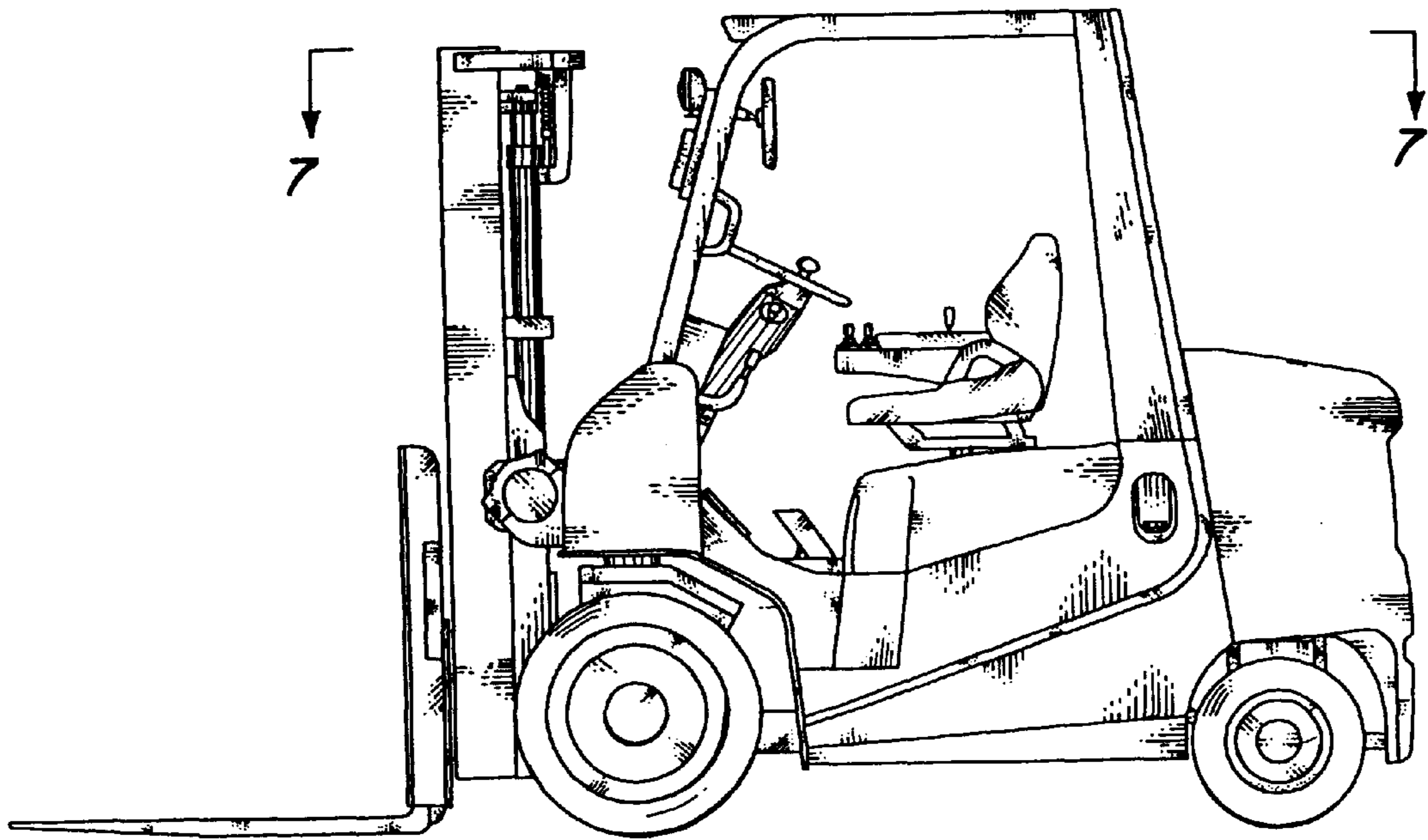

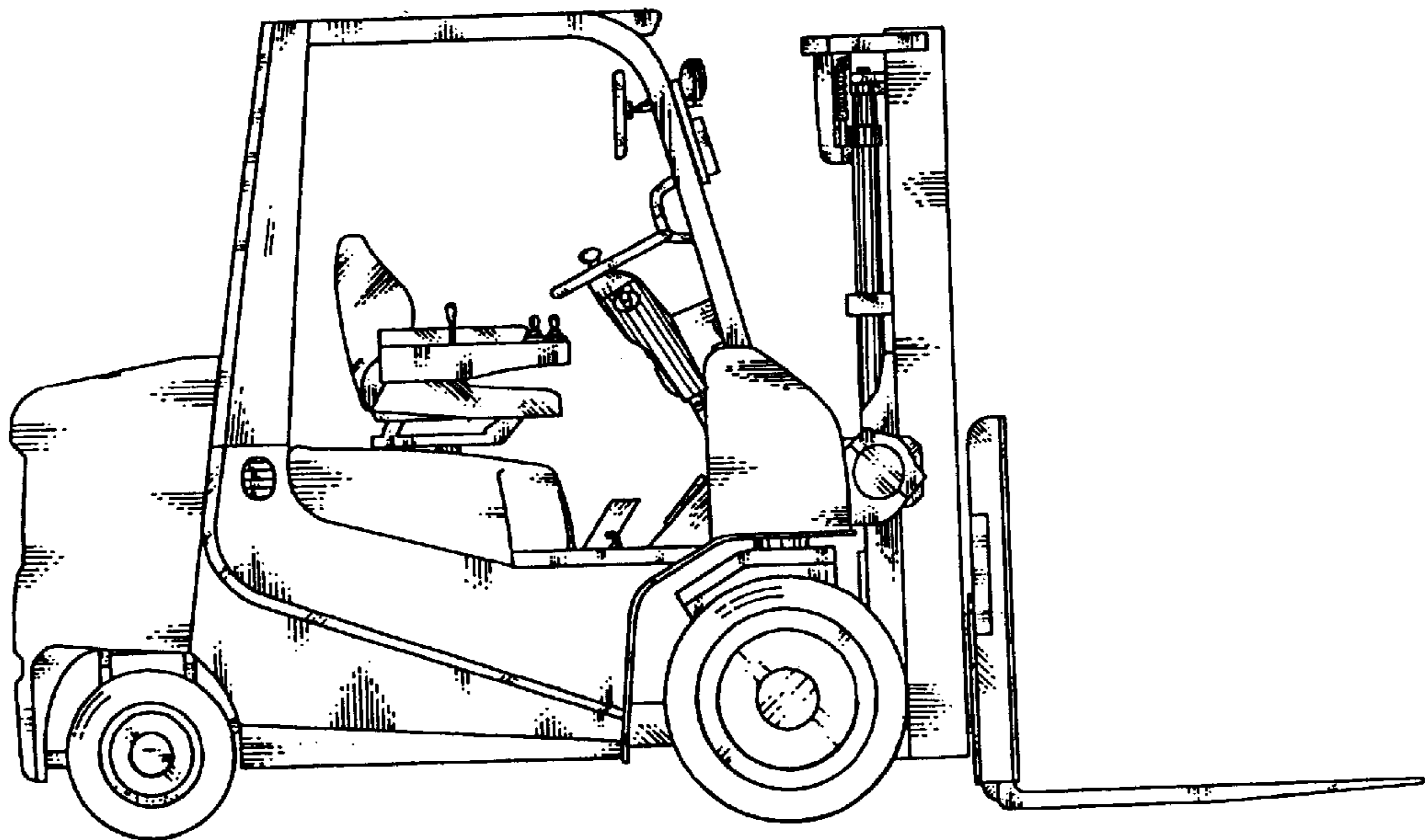

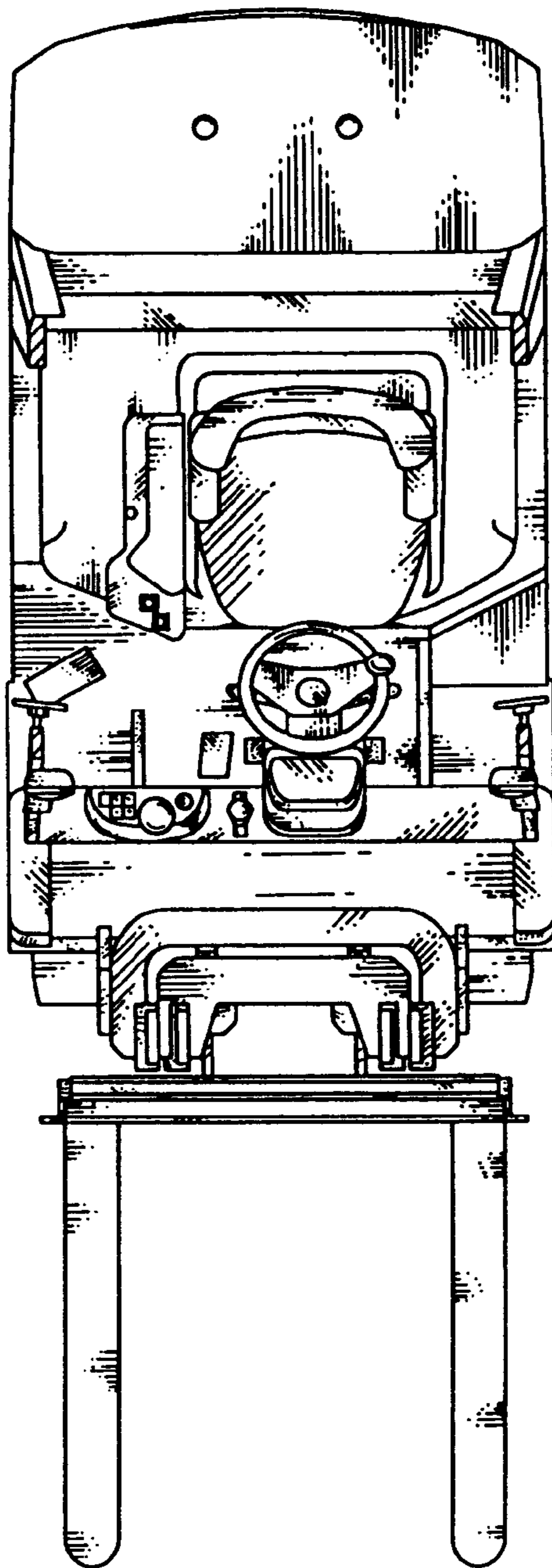

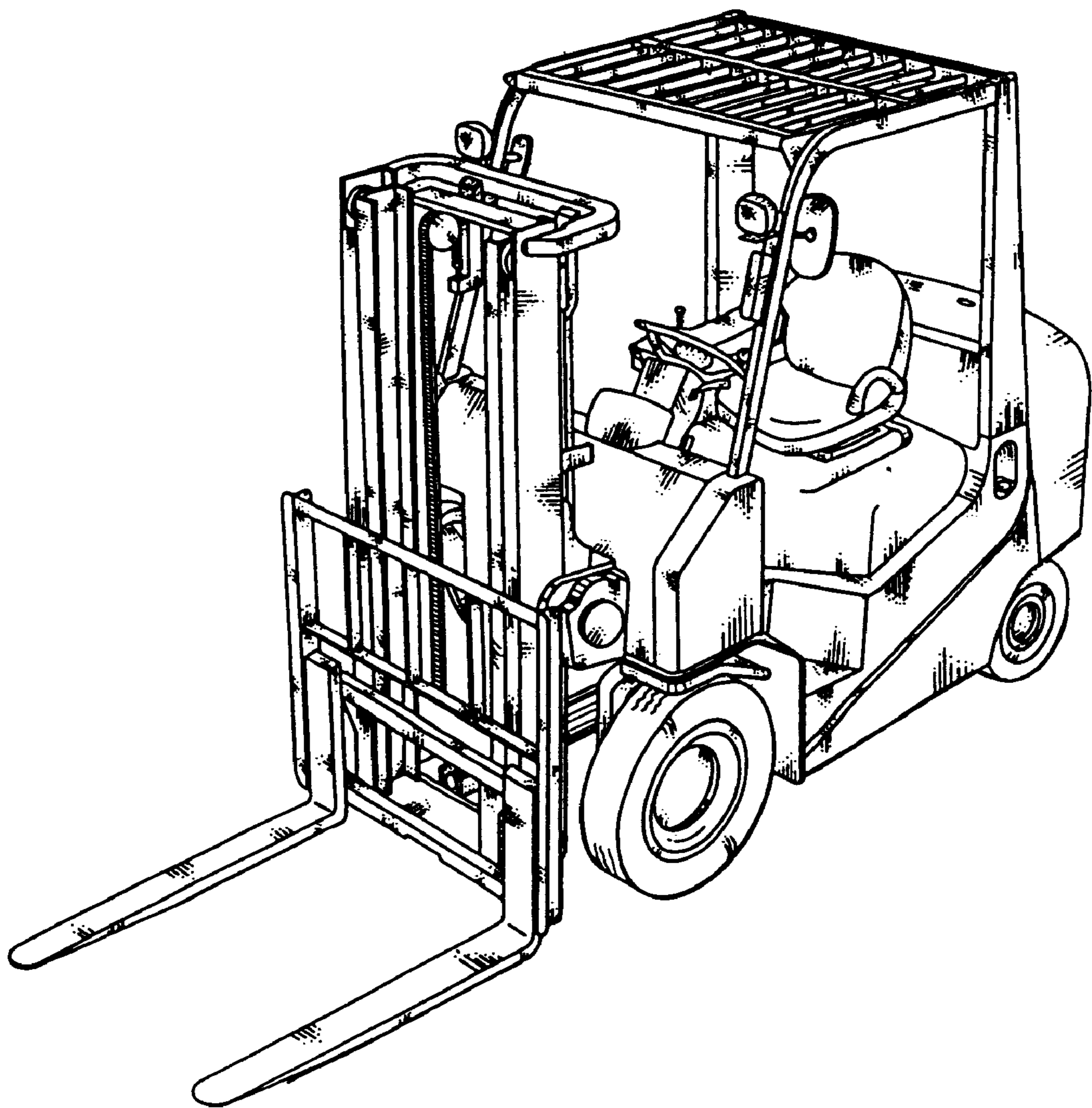

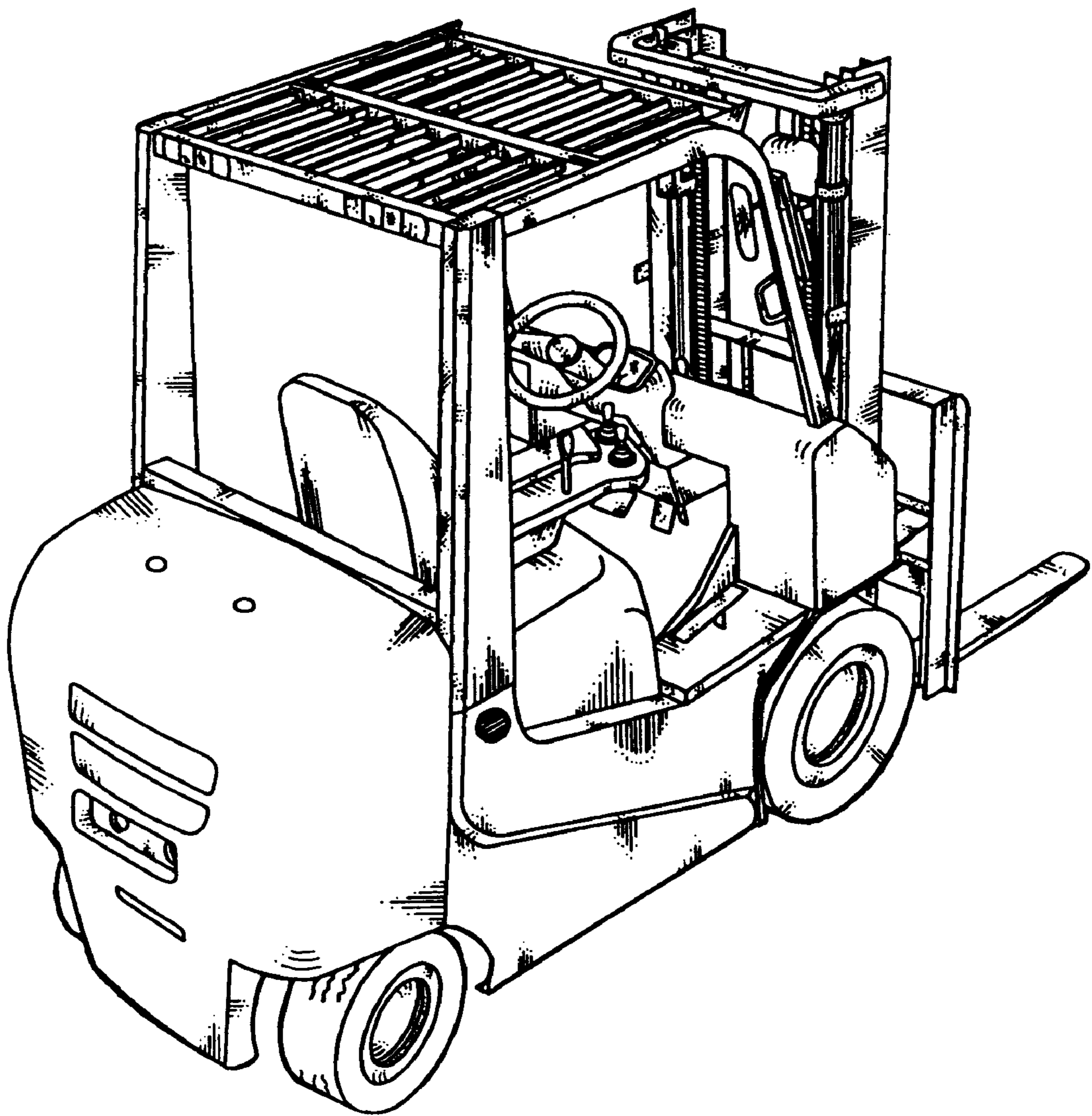

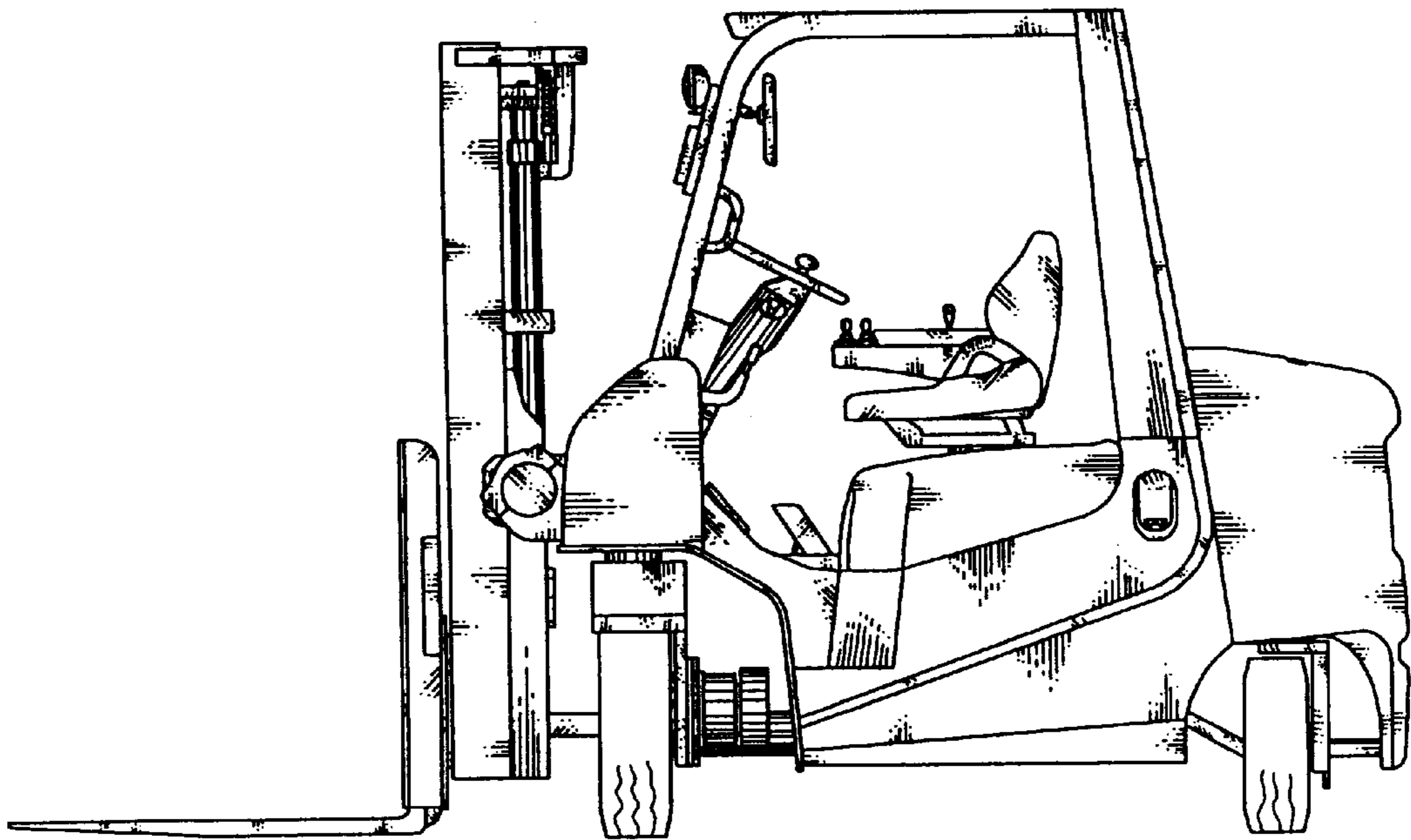

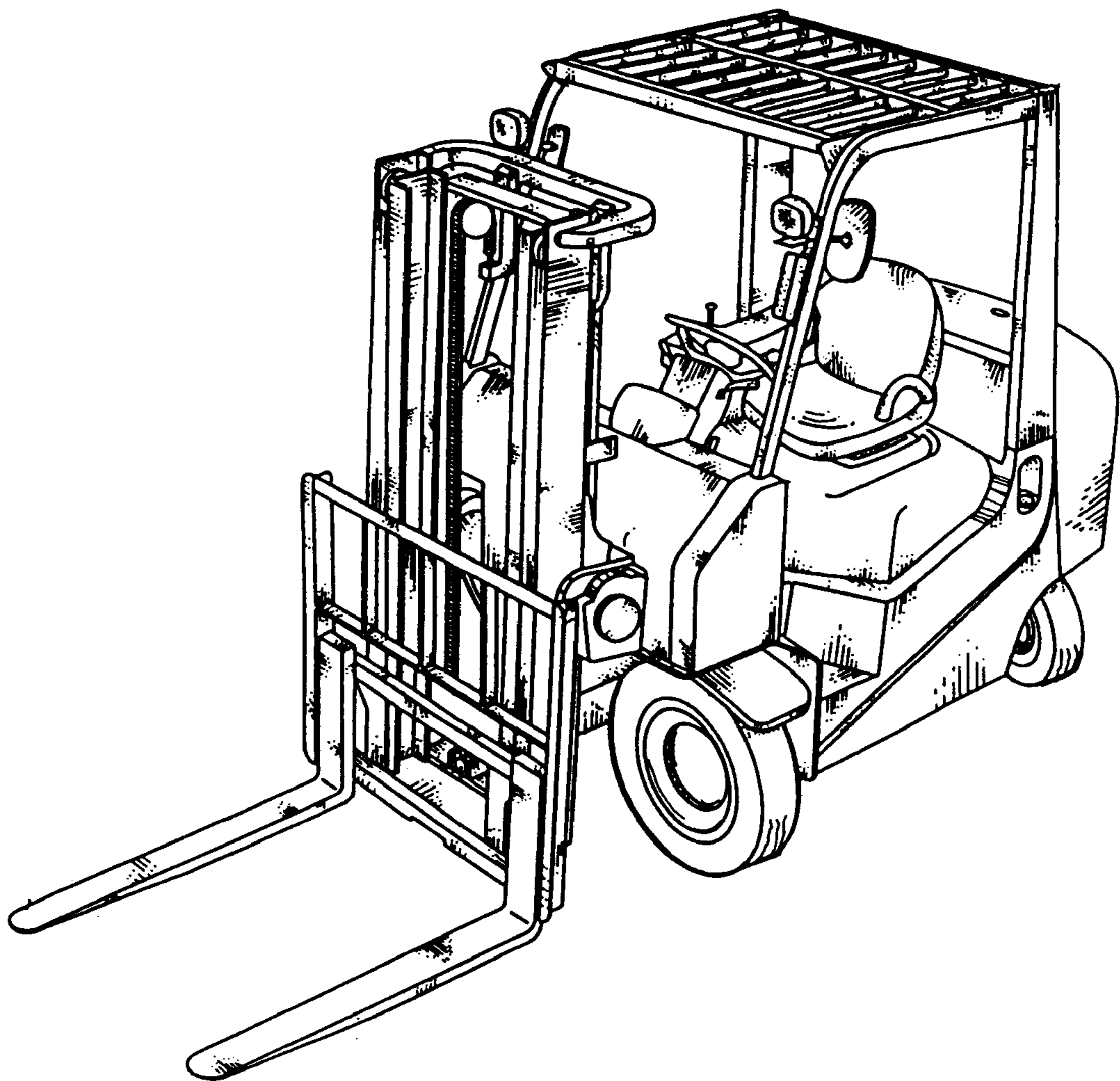
