(57) **CLAIM**

The ornamental design for an infant wrap and receiving blanket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an infant wrap and receiving blanket according to the present invention in an unfolded state;

FIG. 2 is a front plan view of an infant wrap and receiving blanket according to the present invention;

FIG. 3 is a rear plan view of an infant wrap and receiving blanket according to the present invention;

FIG. 4 is a right elevation view of an infant wrap and receiving blanket according to the present invention;

FIG. 5 is a top elevation view of an infant wrap and receiving blanket according to the present invention;

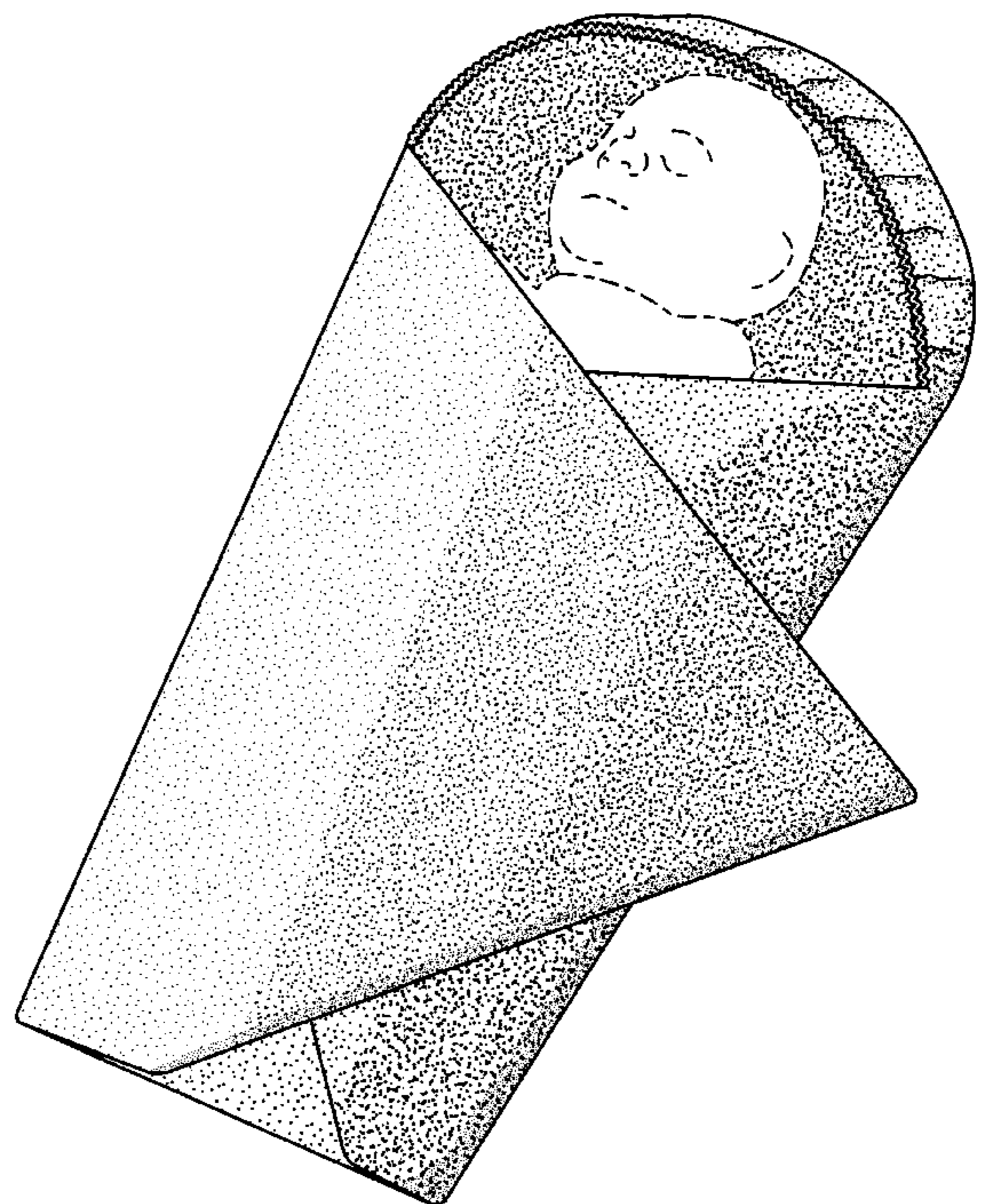
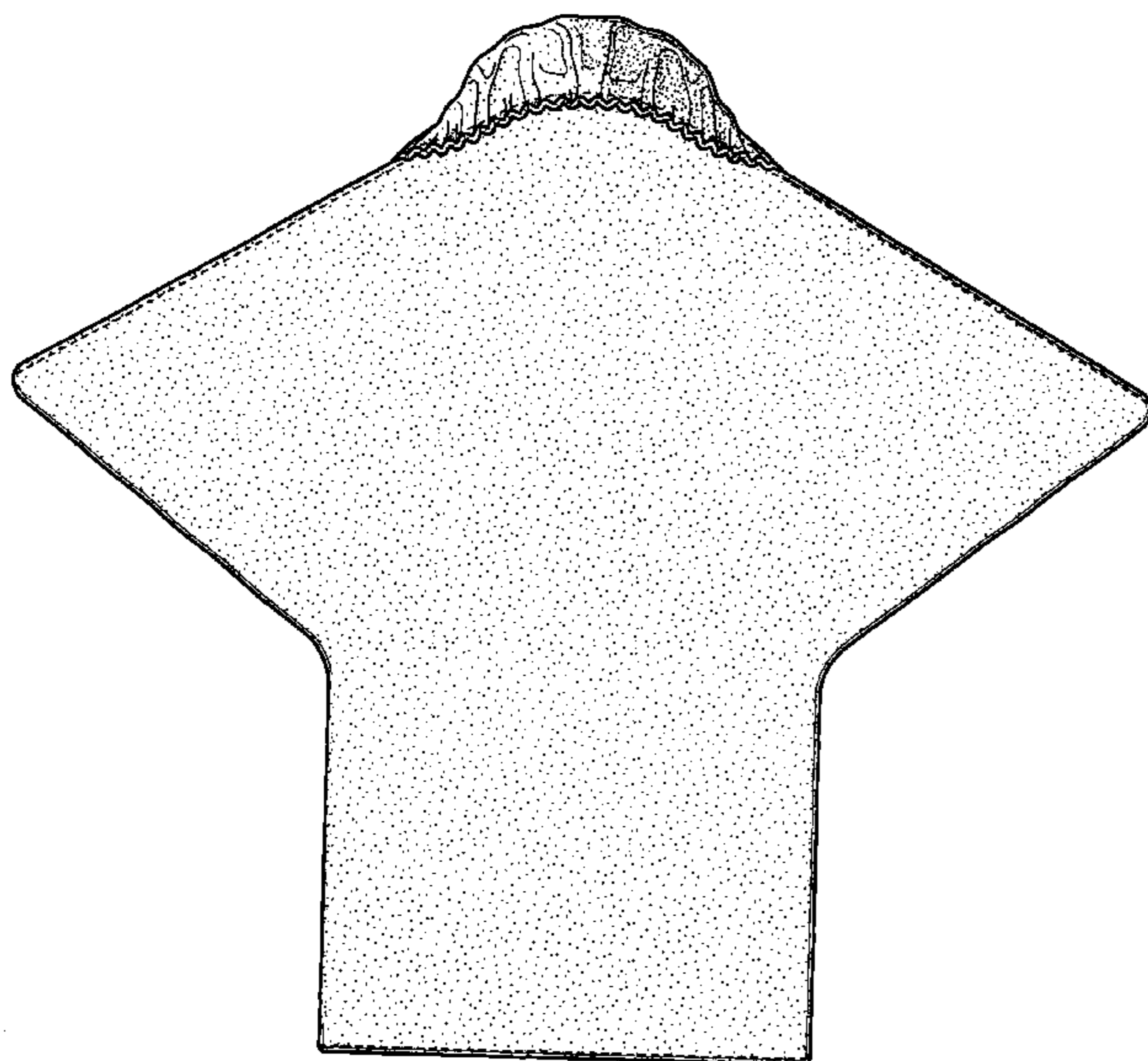
FIG. 6 is a bottom elevation view of an infant wrap and receiving blanket according to the present invention;

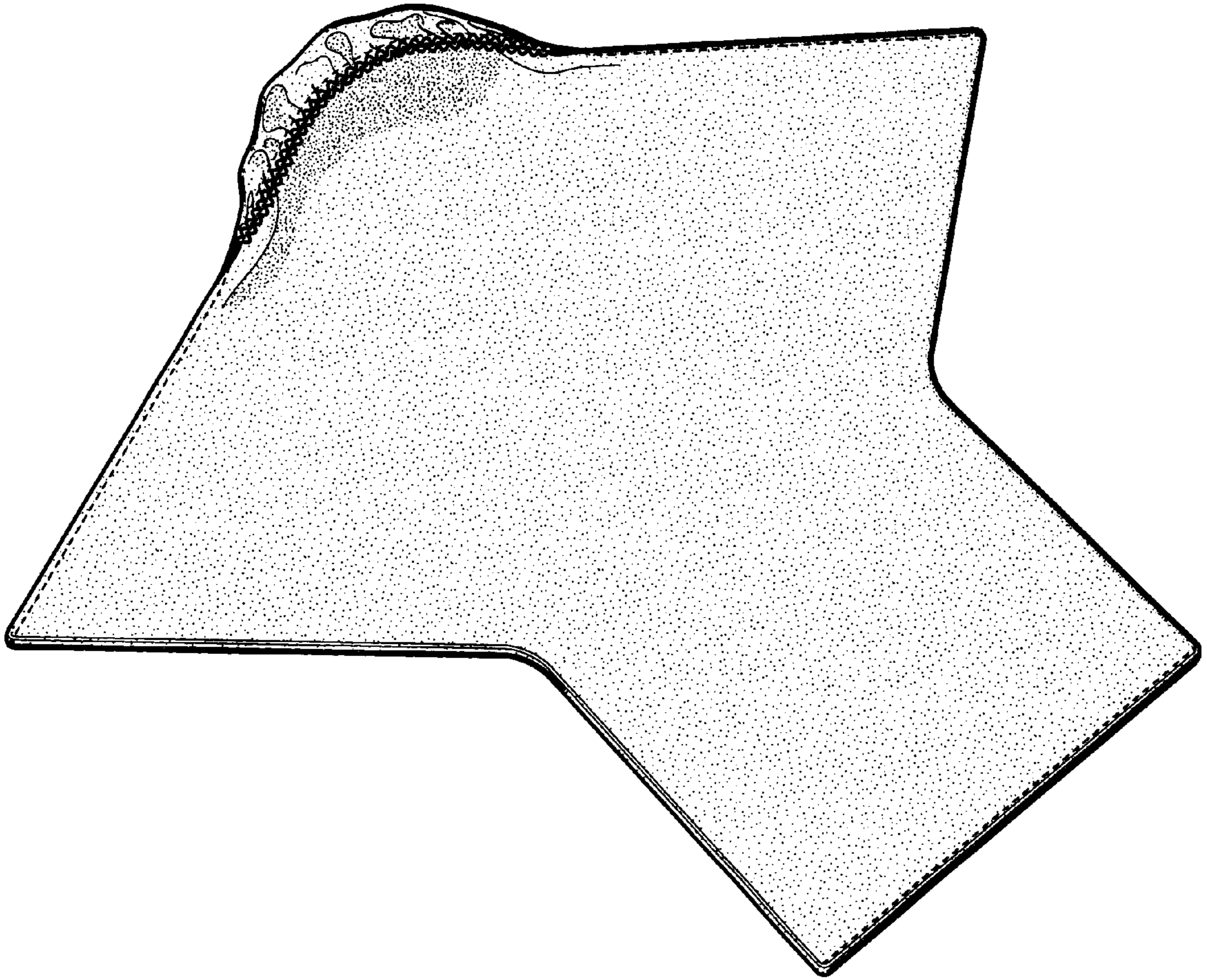

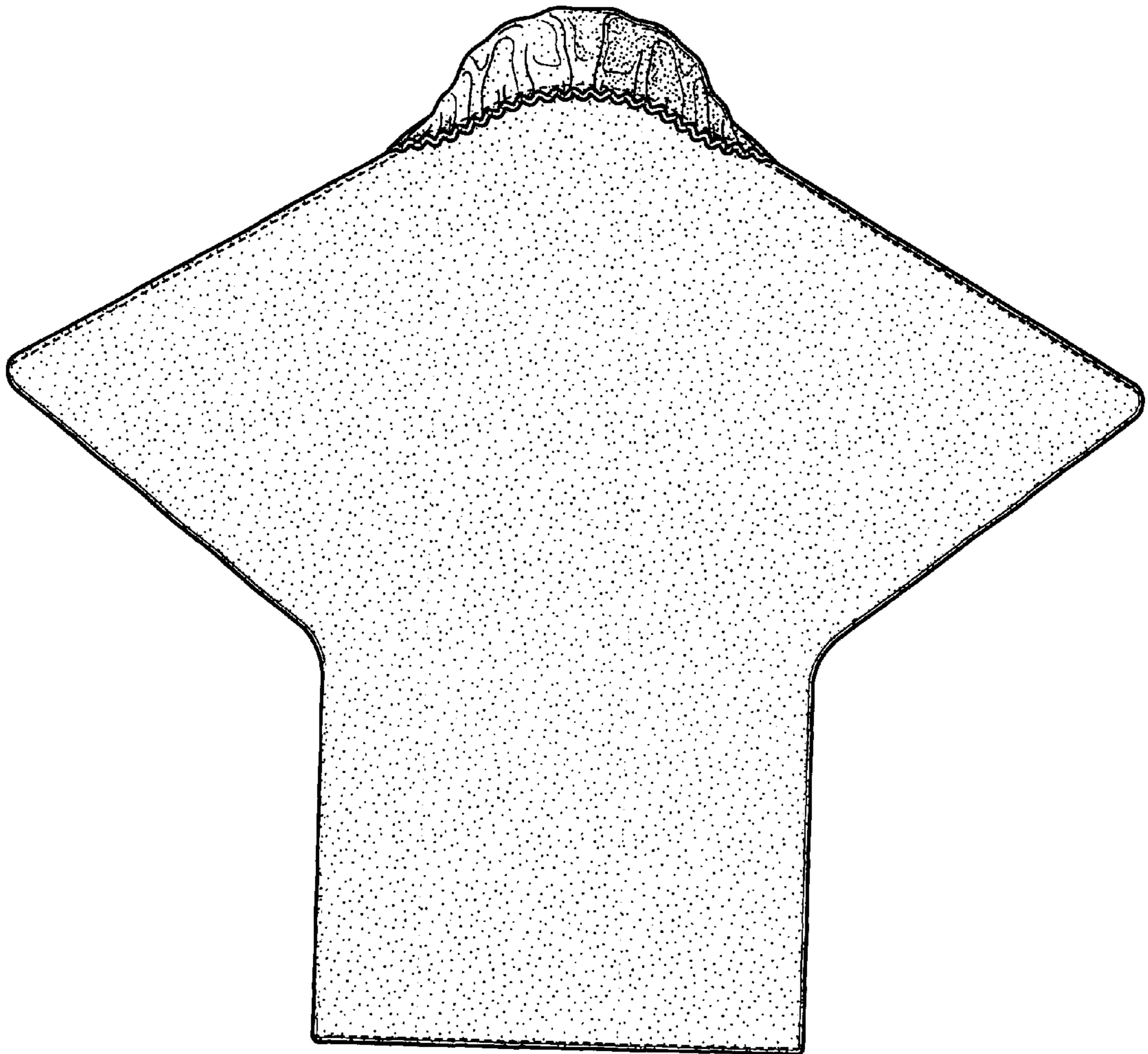

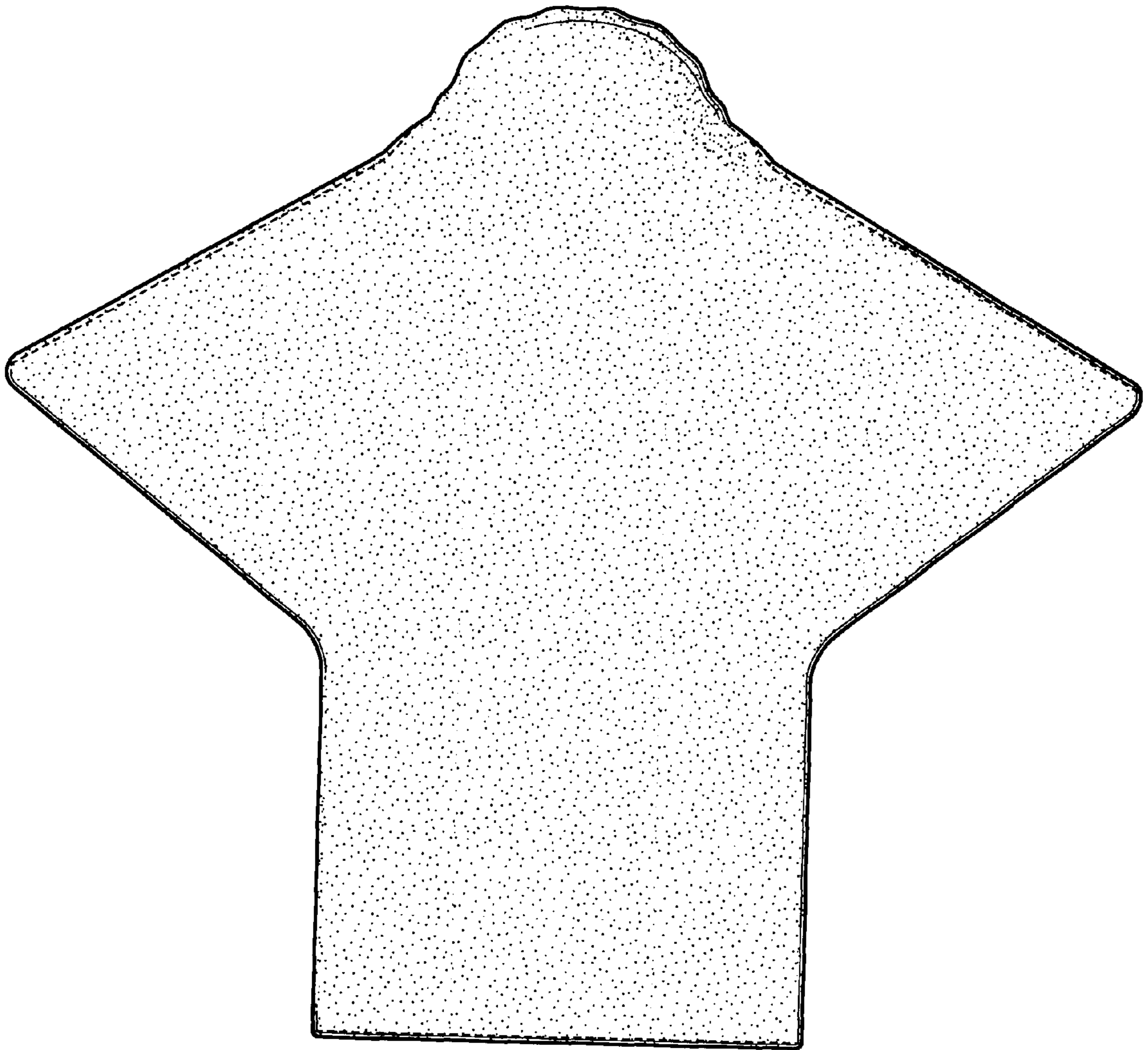

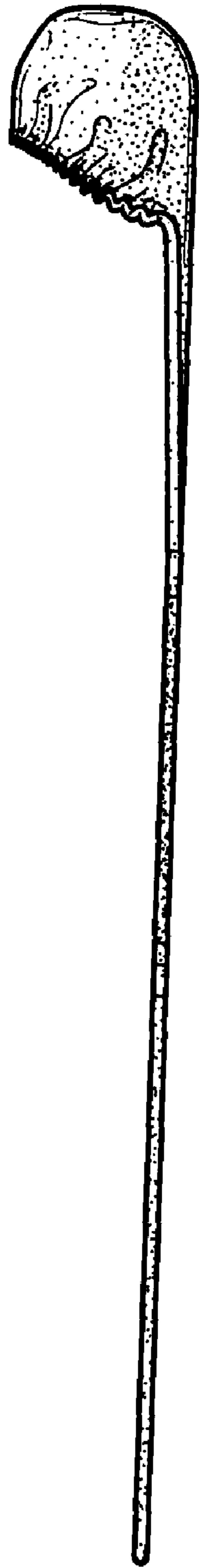

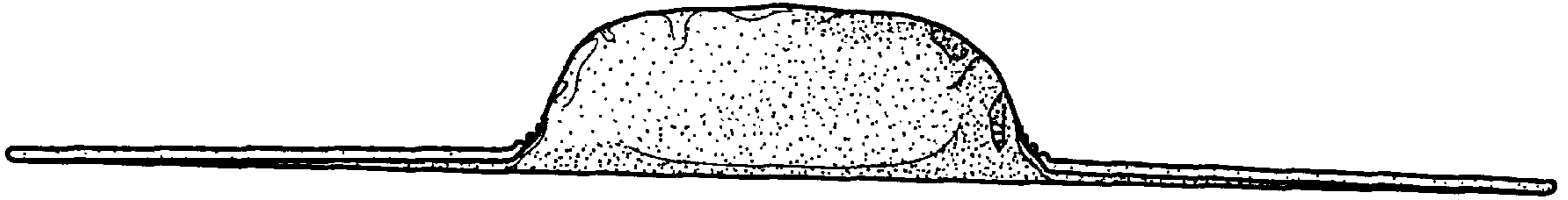

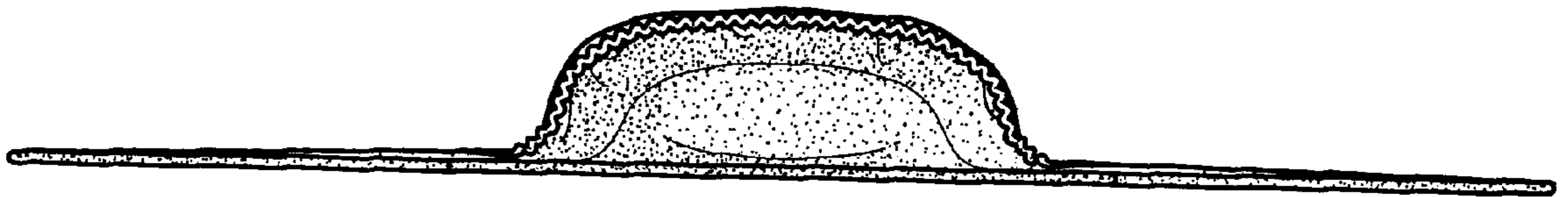

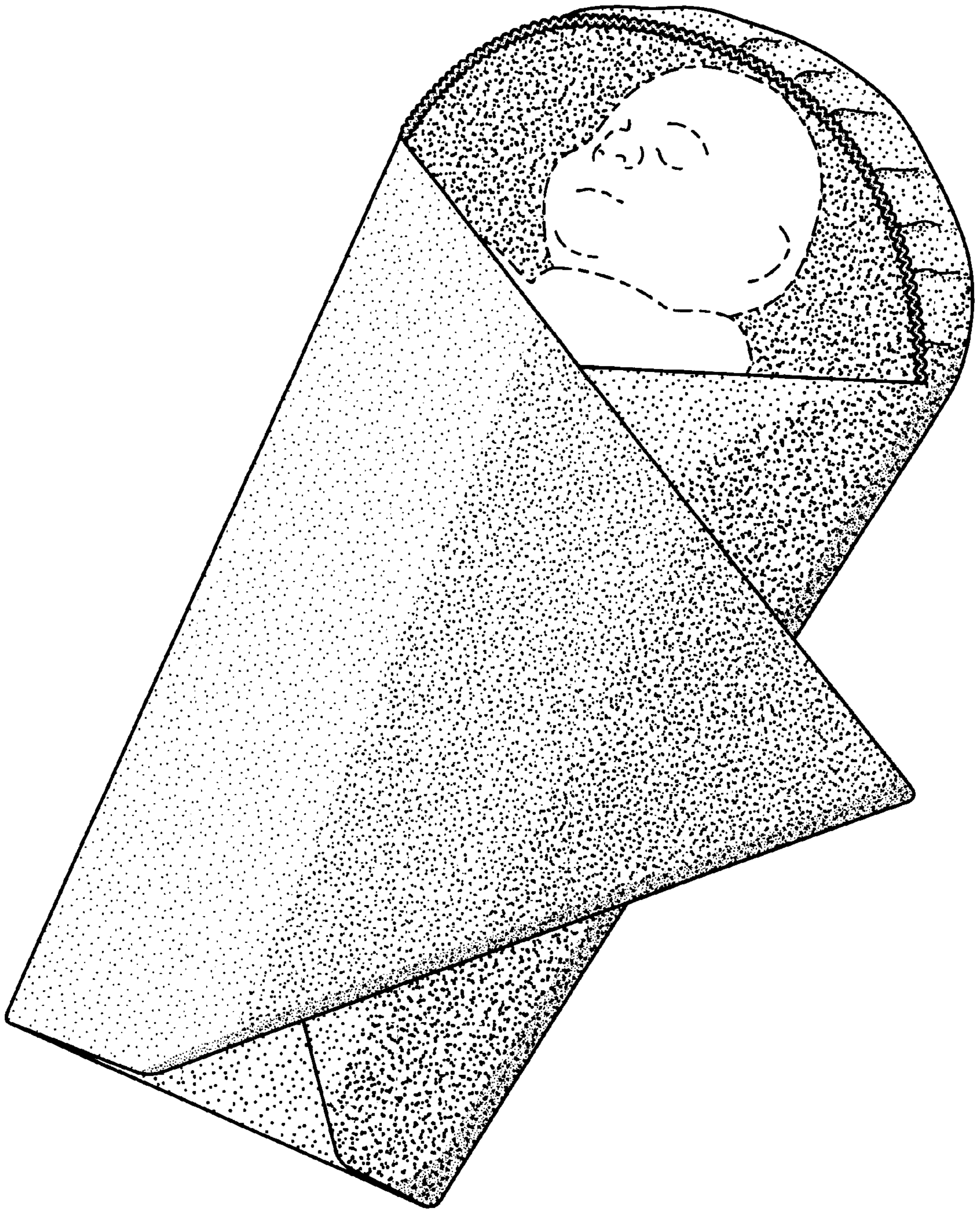

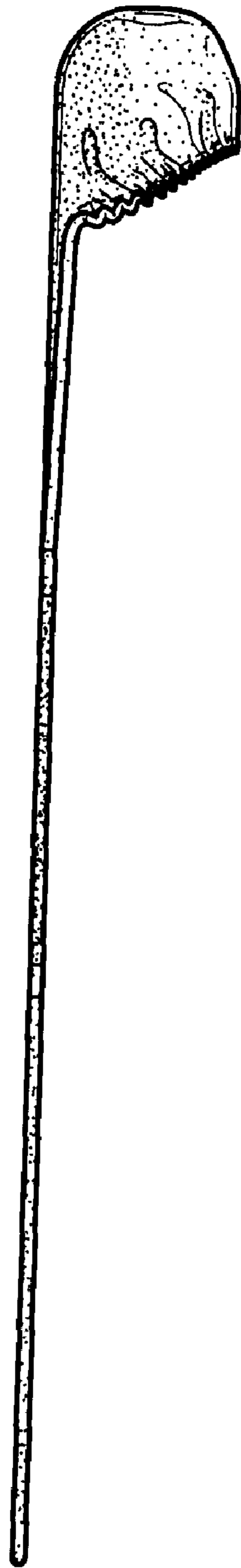
