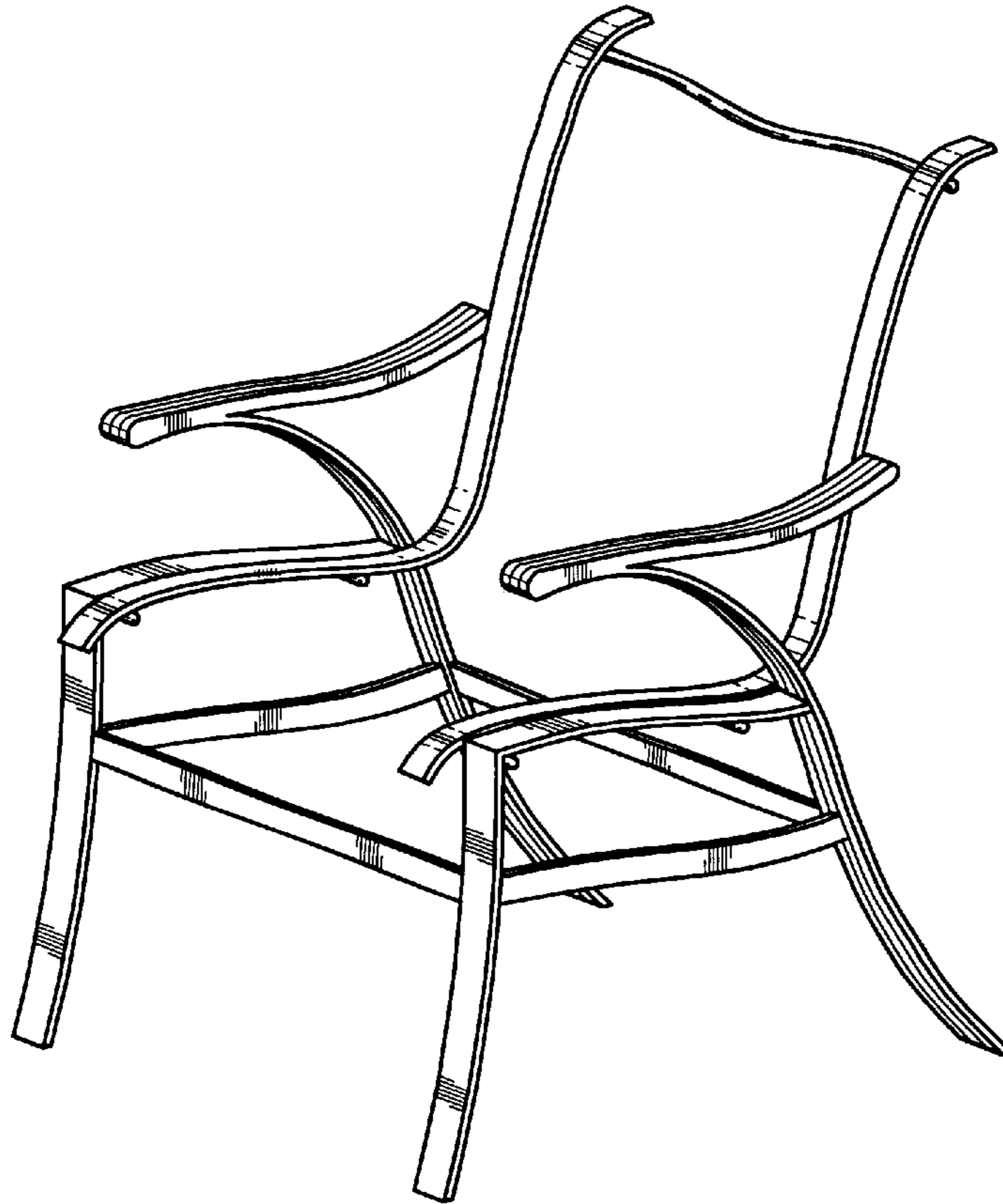
The ornamental design for a chair, as shown and described.

**DESCRIPTION**

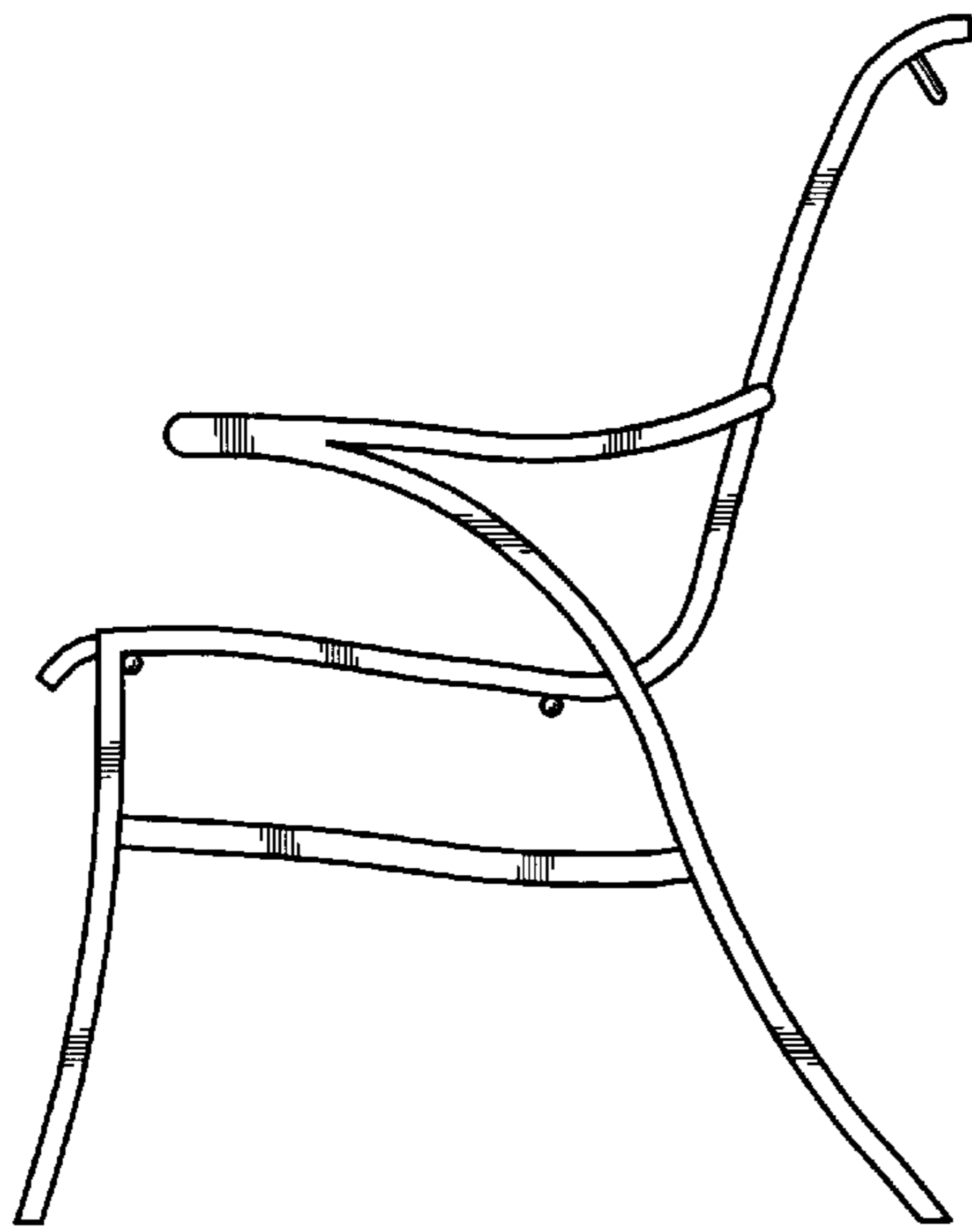
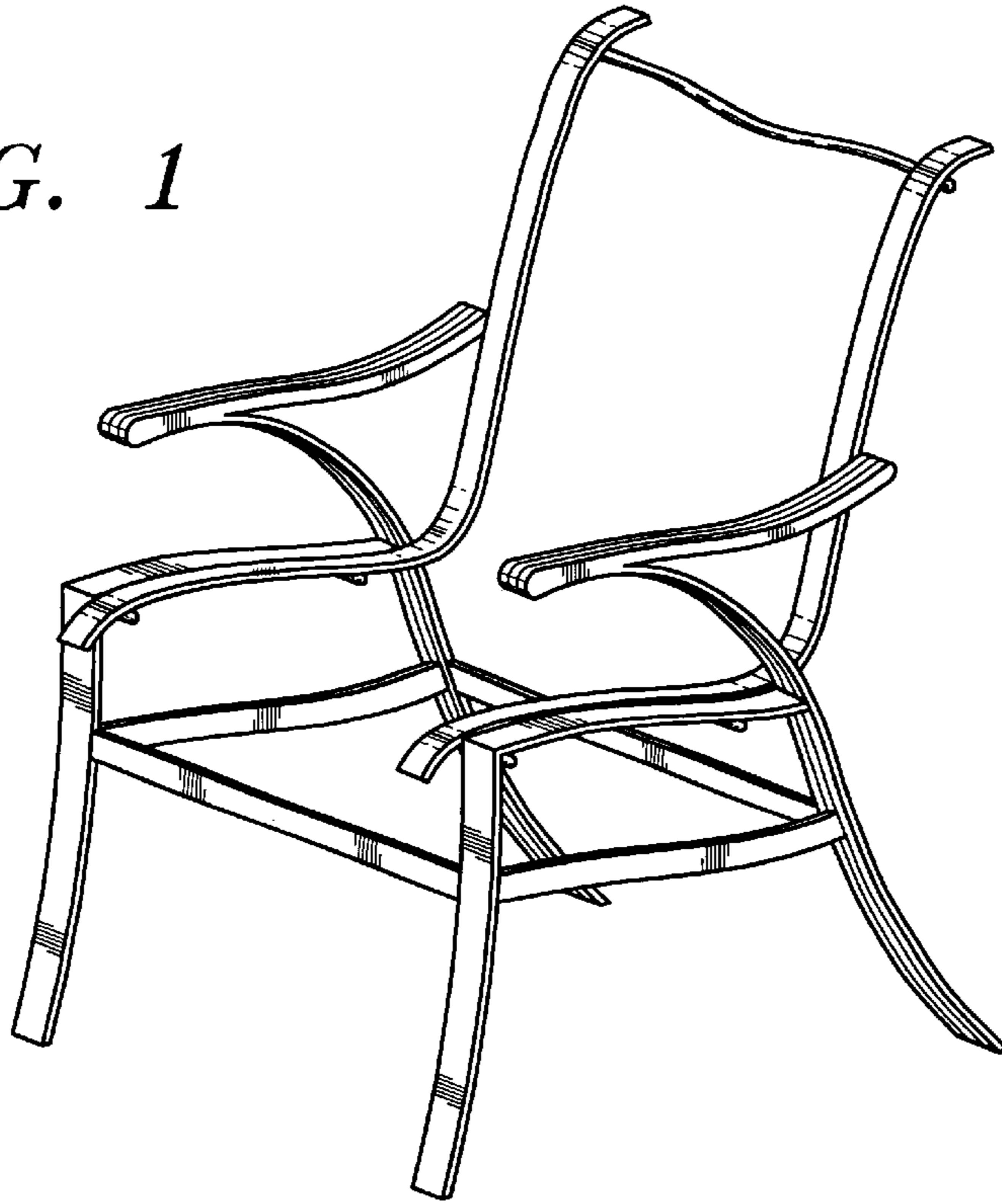
FIG. 1 is a left top front perspective view of the new design;

The broken lines in the embodiment shown in FIGS. 7–12 illustrate the environmental structure of the embodiment disclosed therein and form no part of the claimed design.

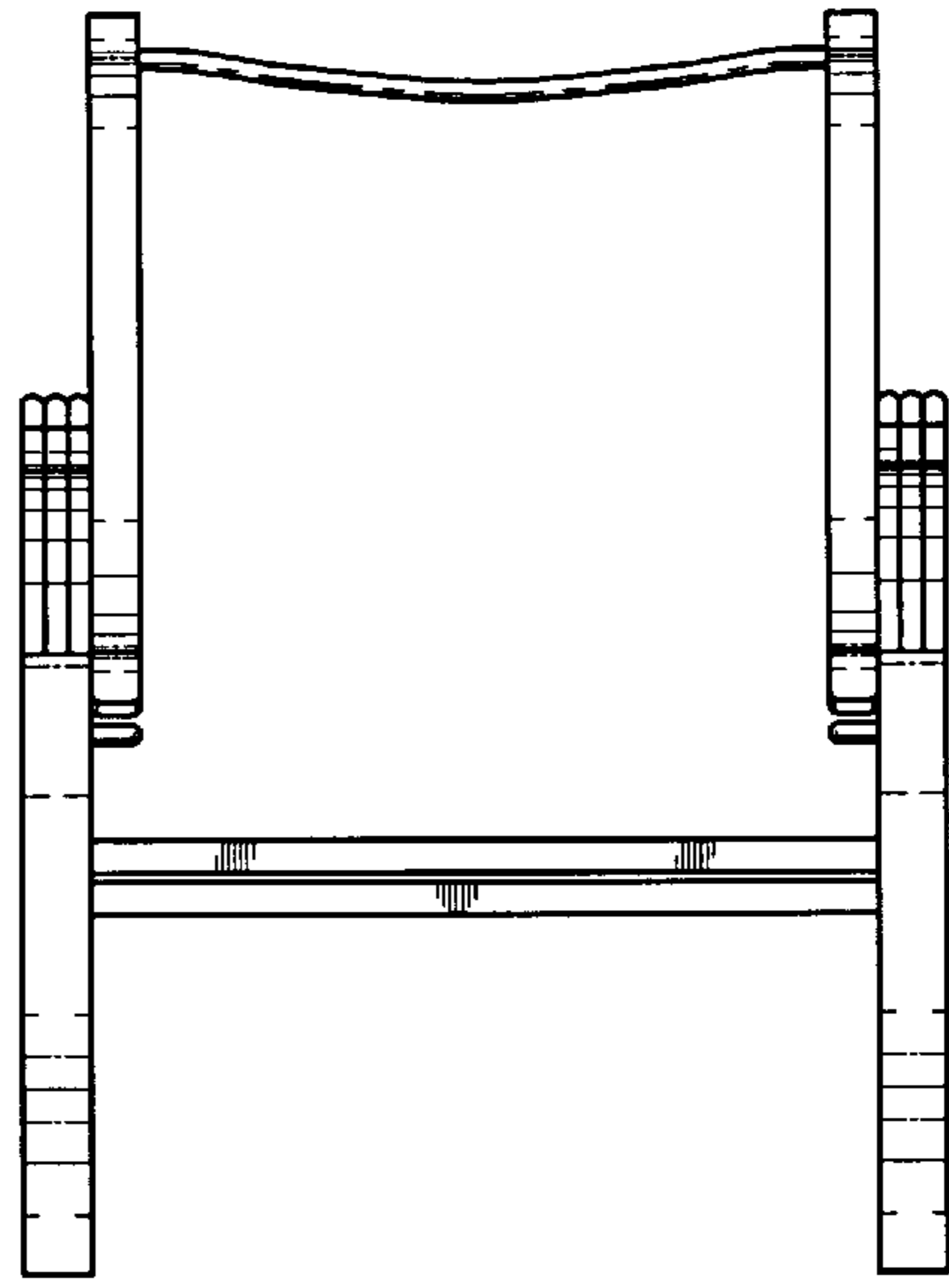

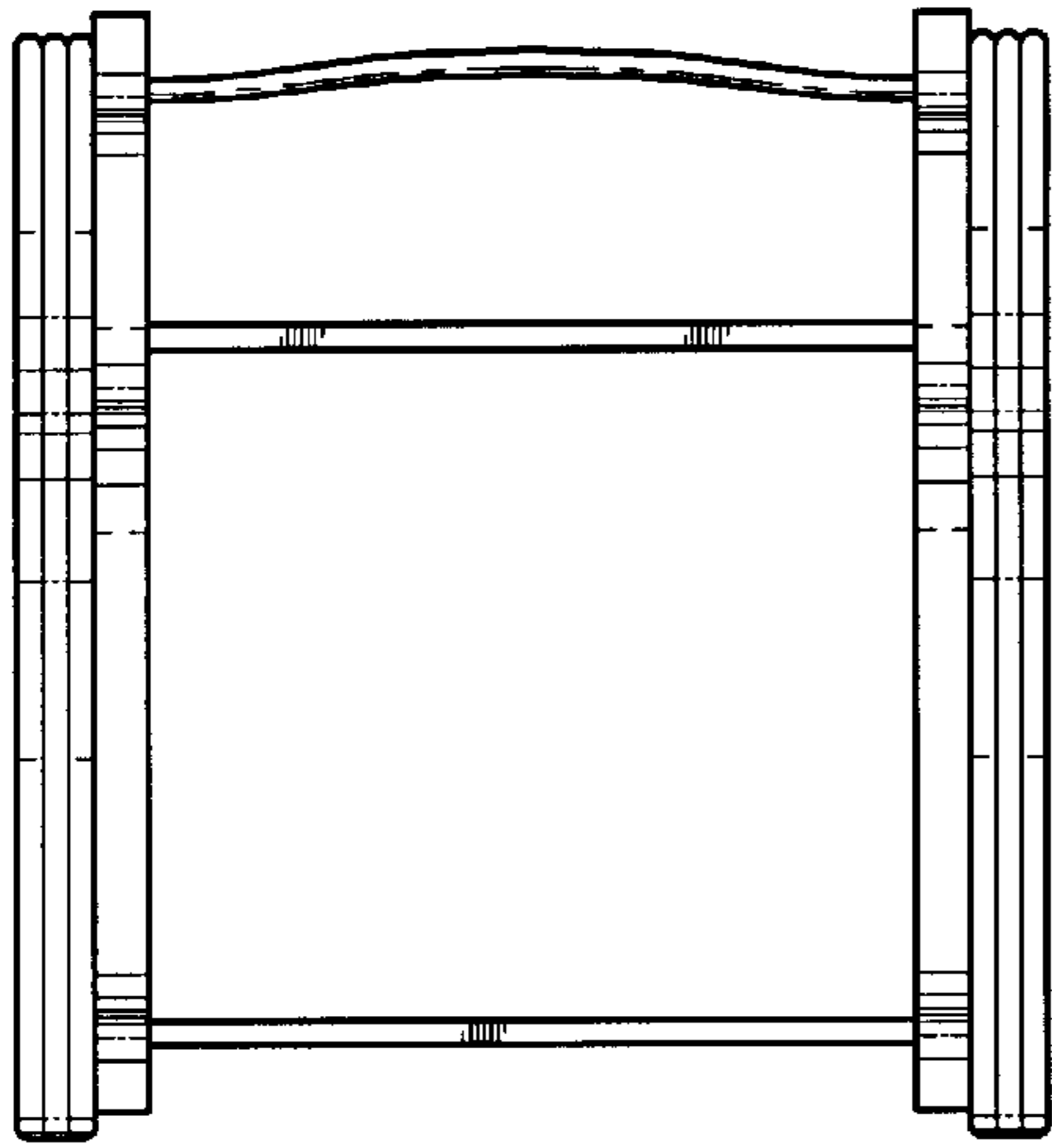

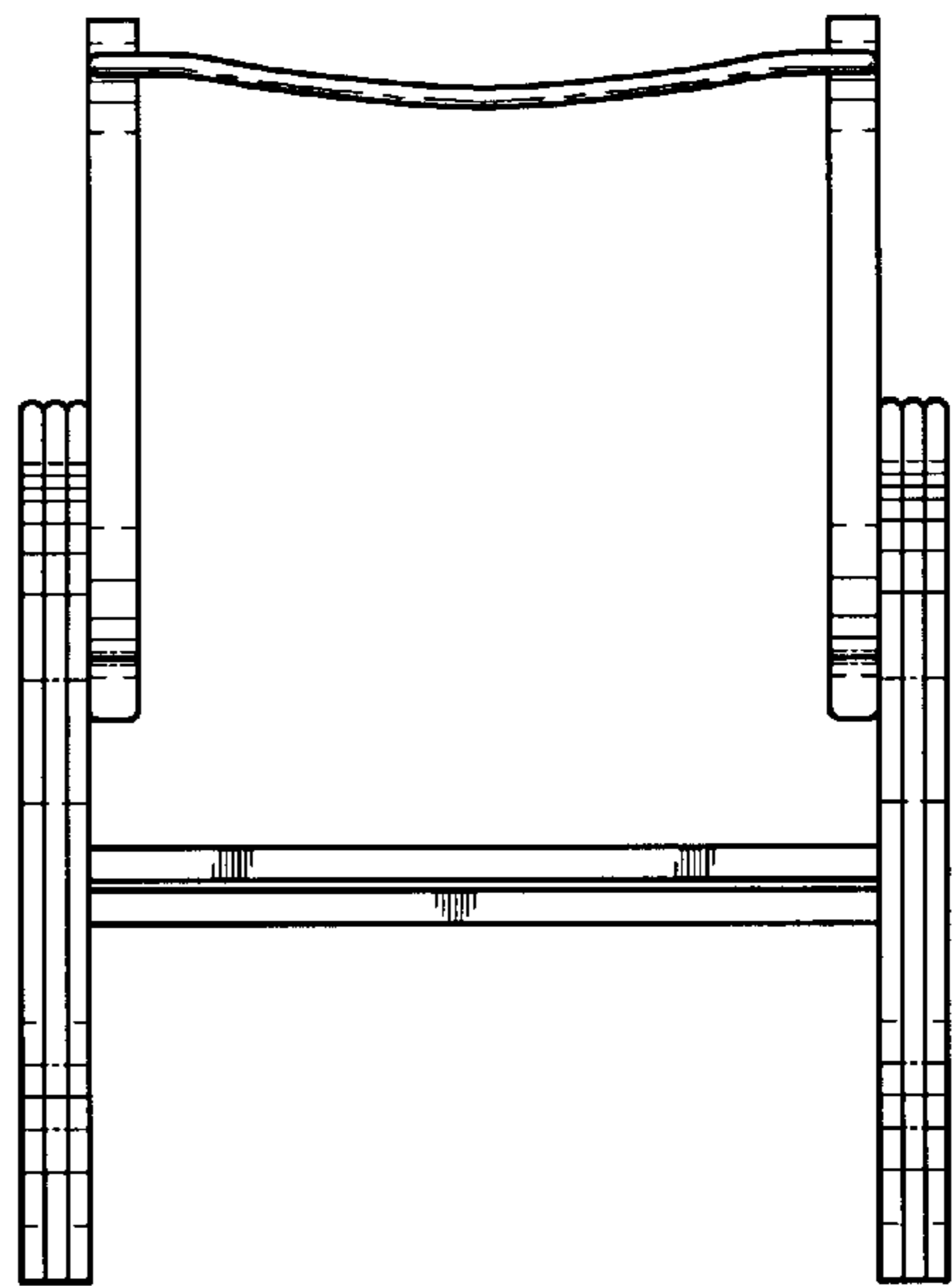

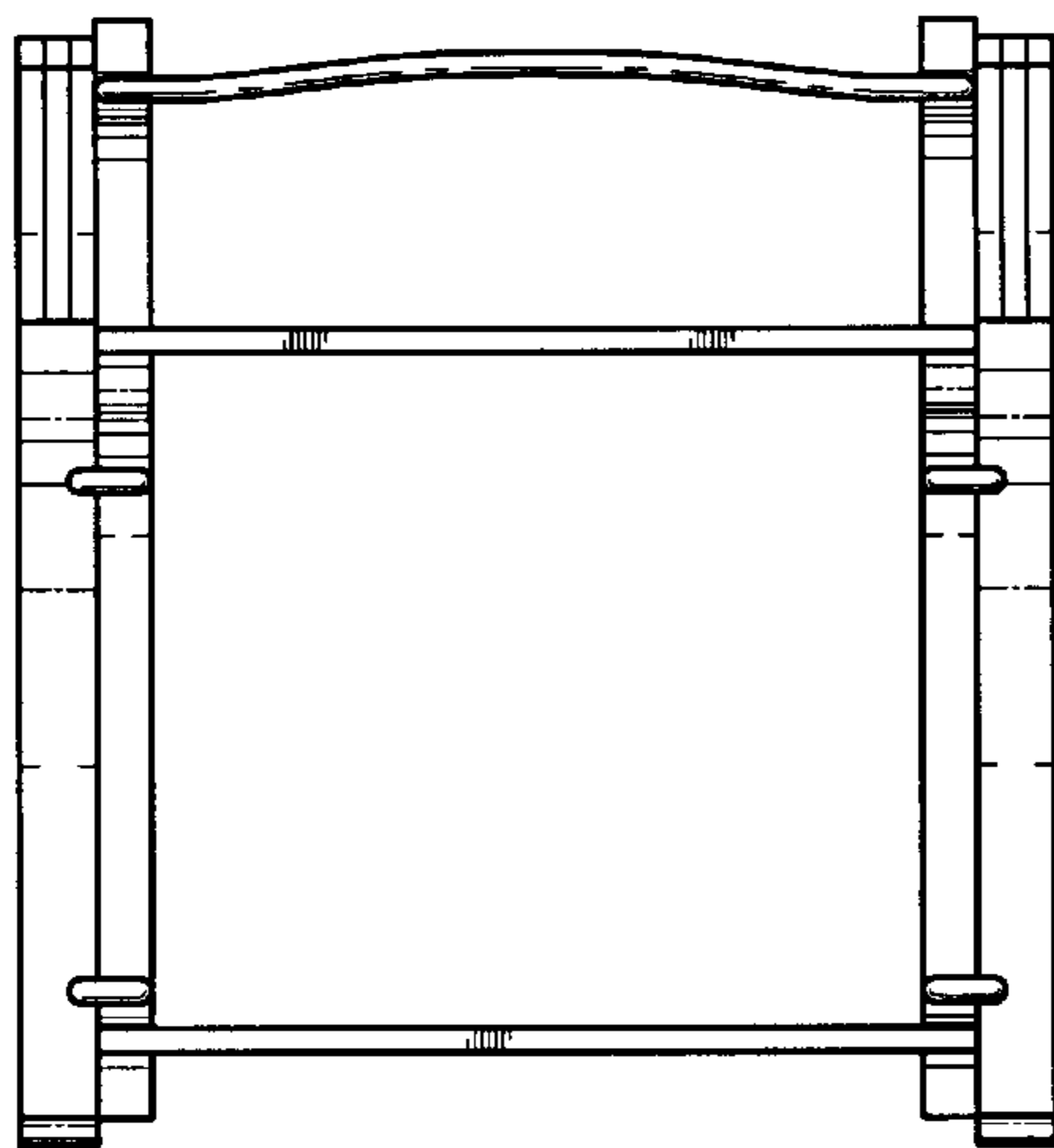

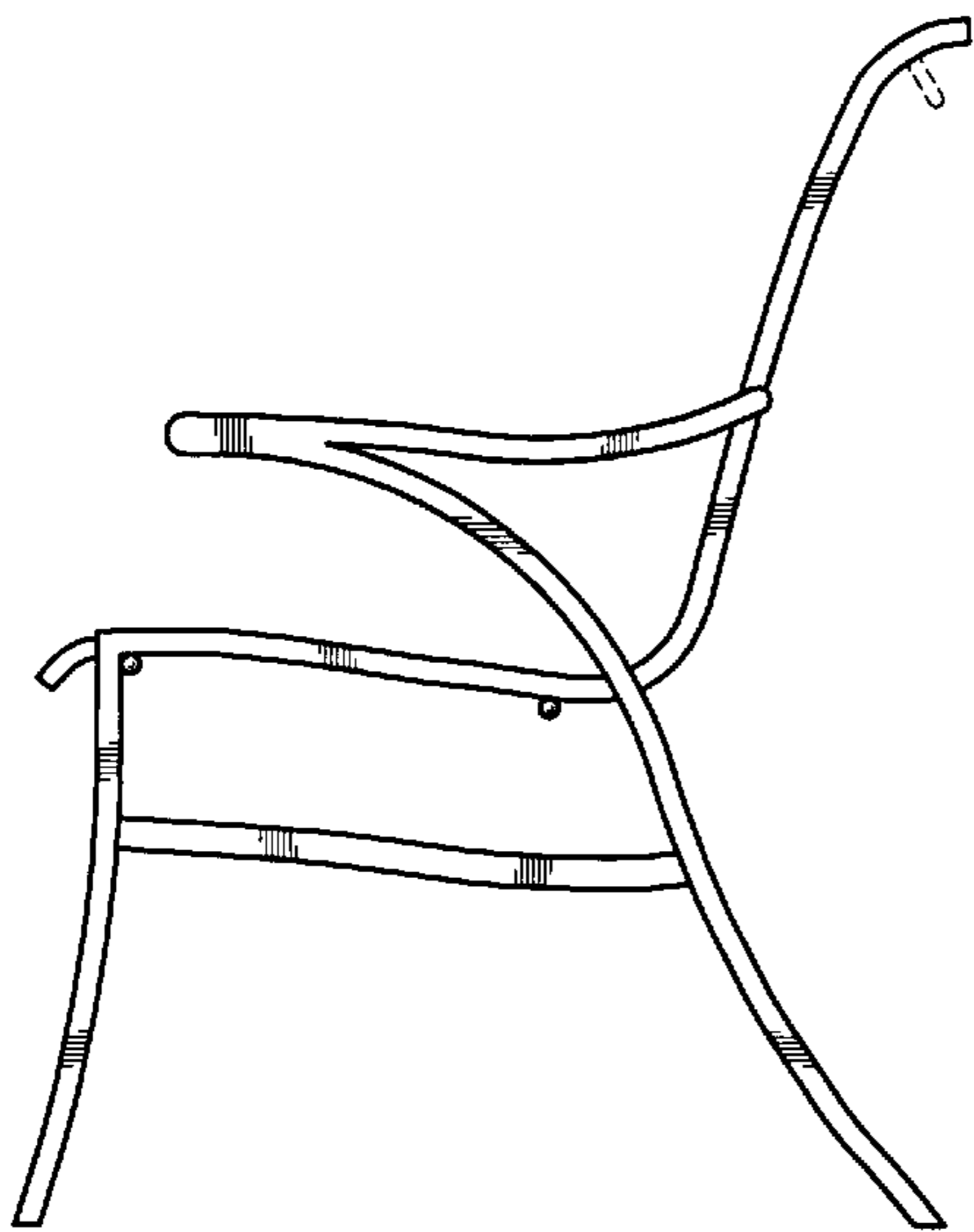
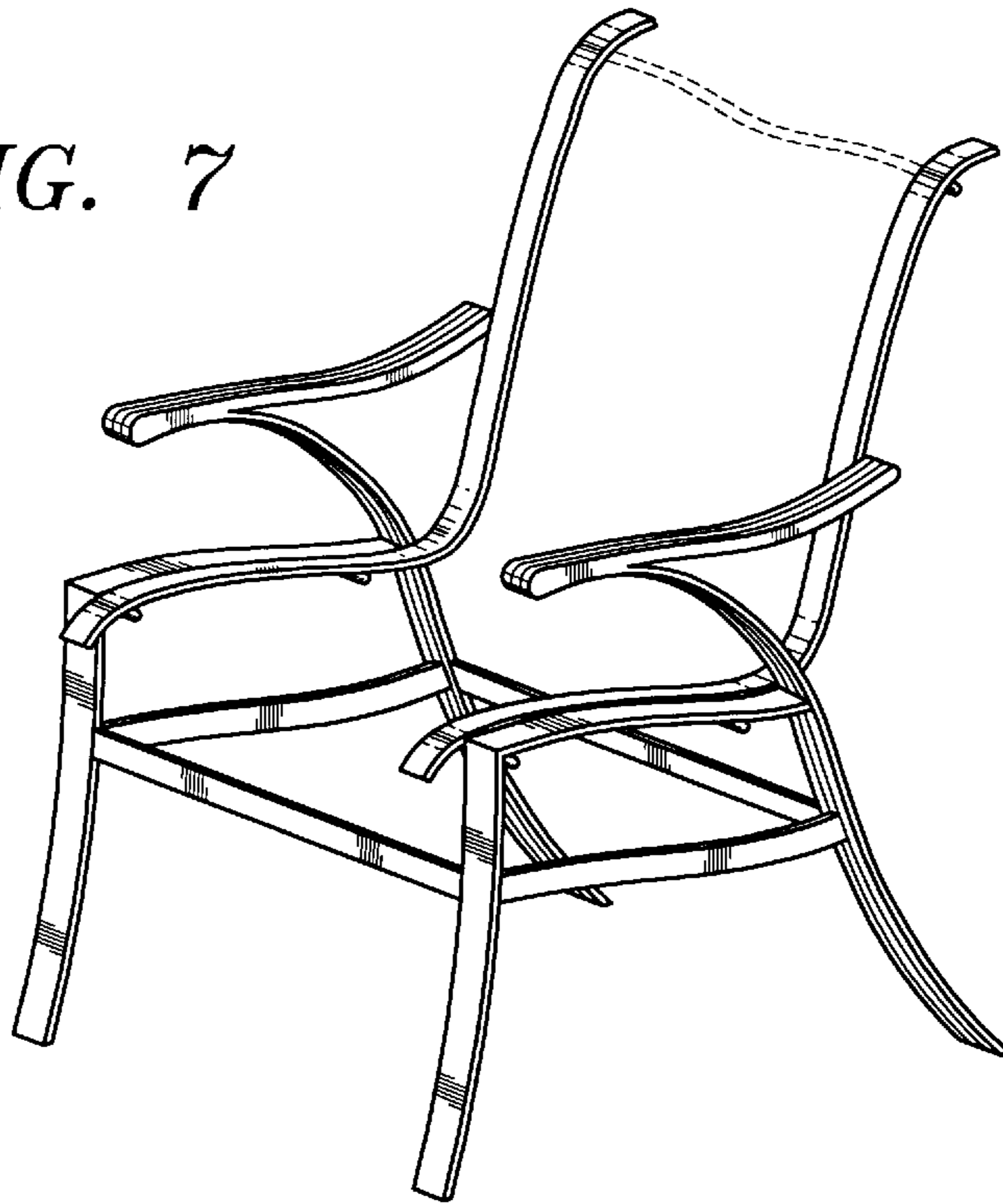

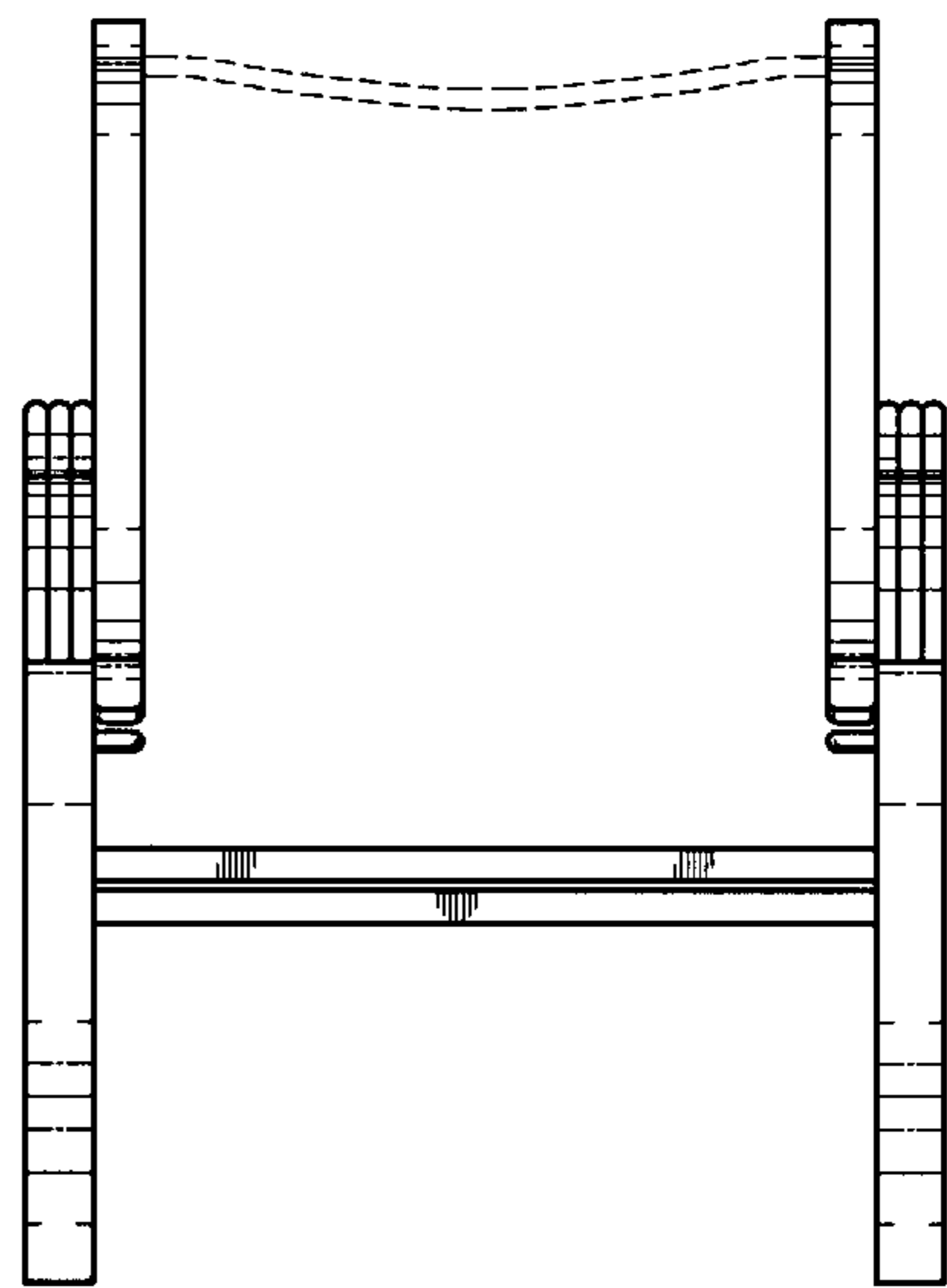

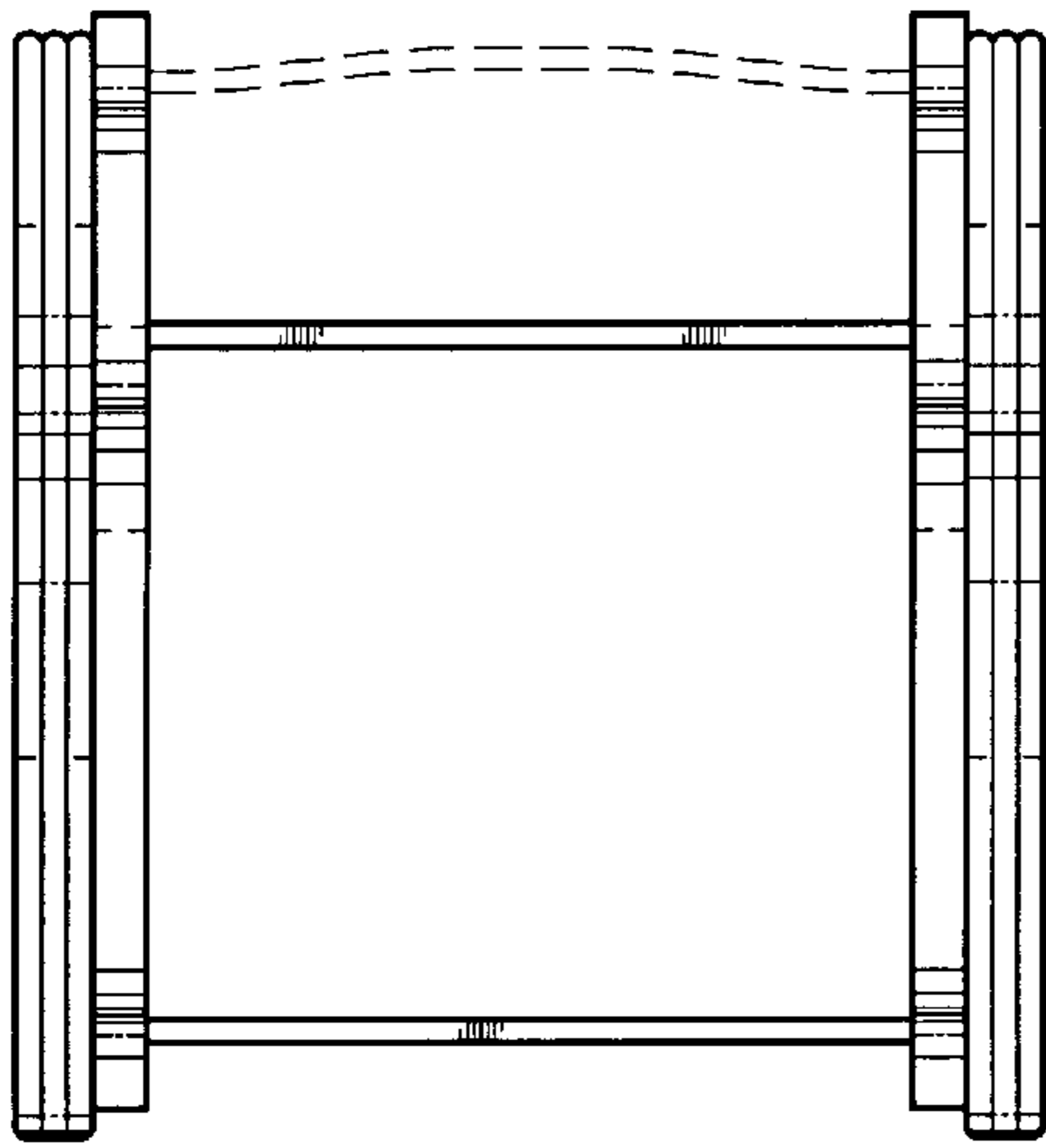

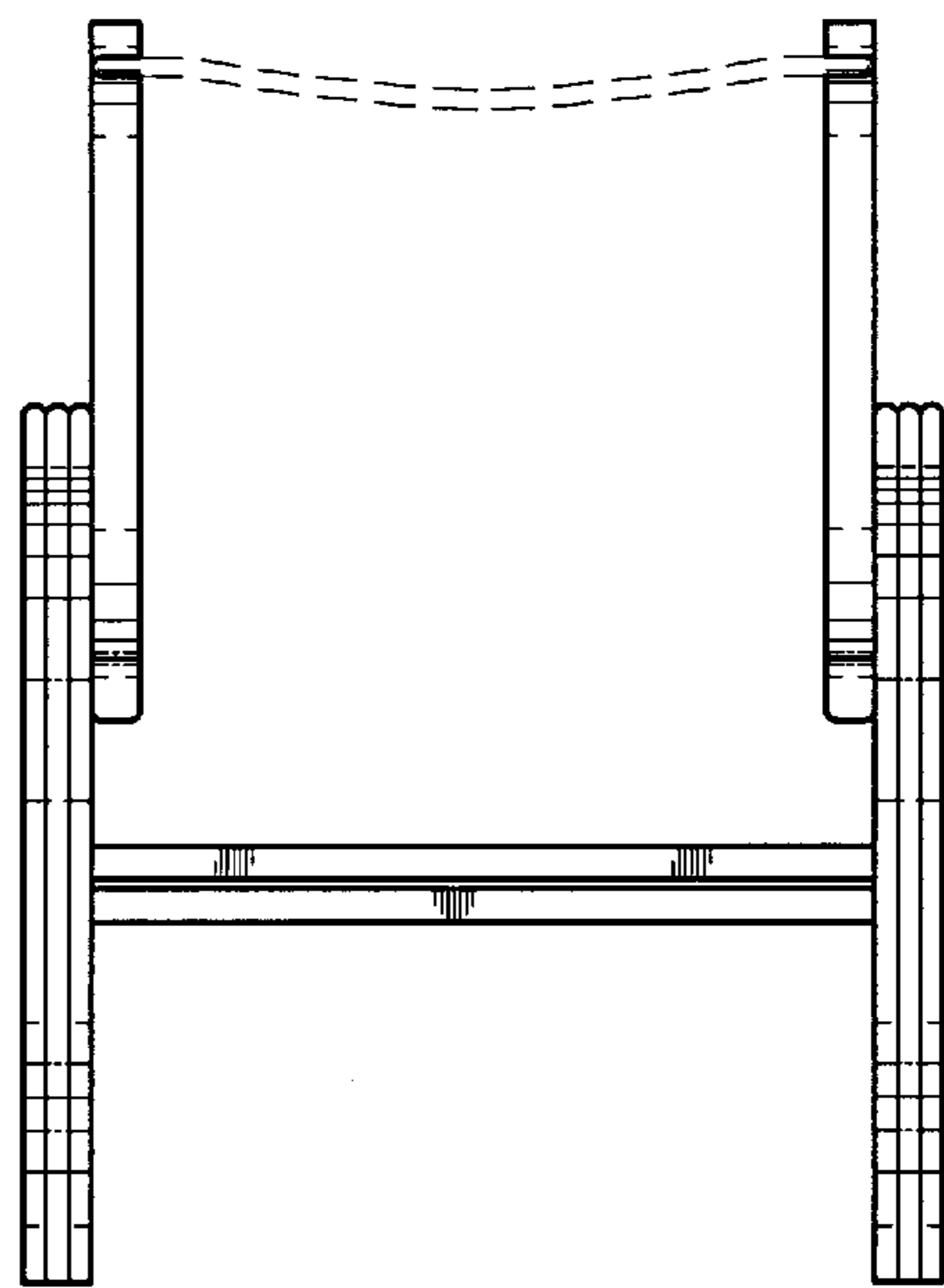

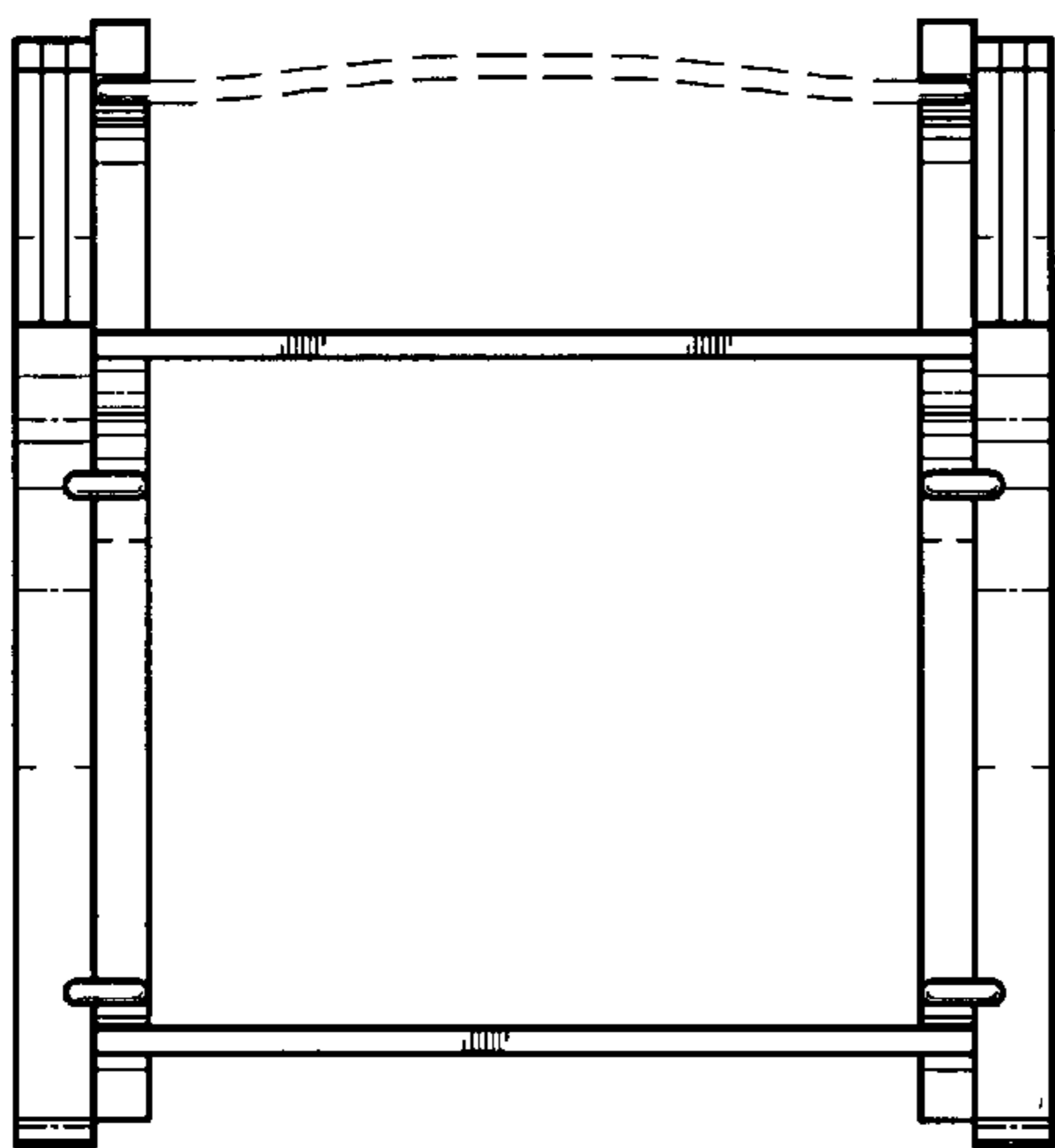
