The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the rear and to one side of the chair.

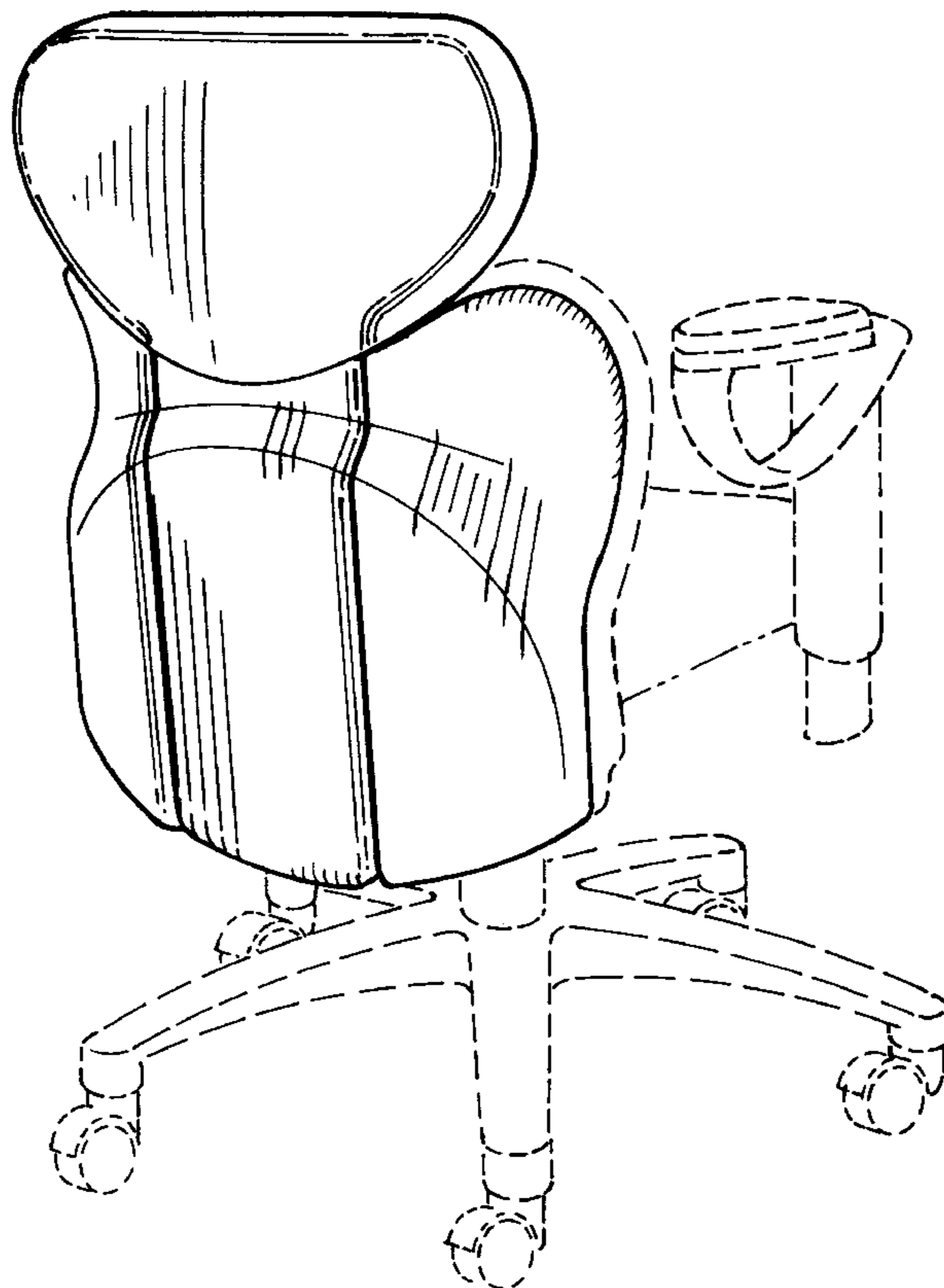
FIG. 2 is a side elevational view of the chair of FIG. 1. The other side is a mirror image of this view.

FIG. 3 is a top plan view of the chair of FIG. 1; and,

FIG. 4 is a rear elevational view of the chair of FIG. 1.

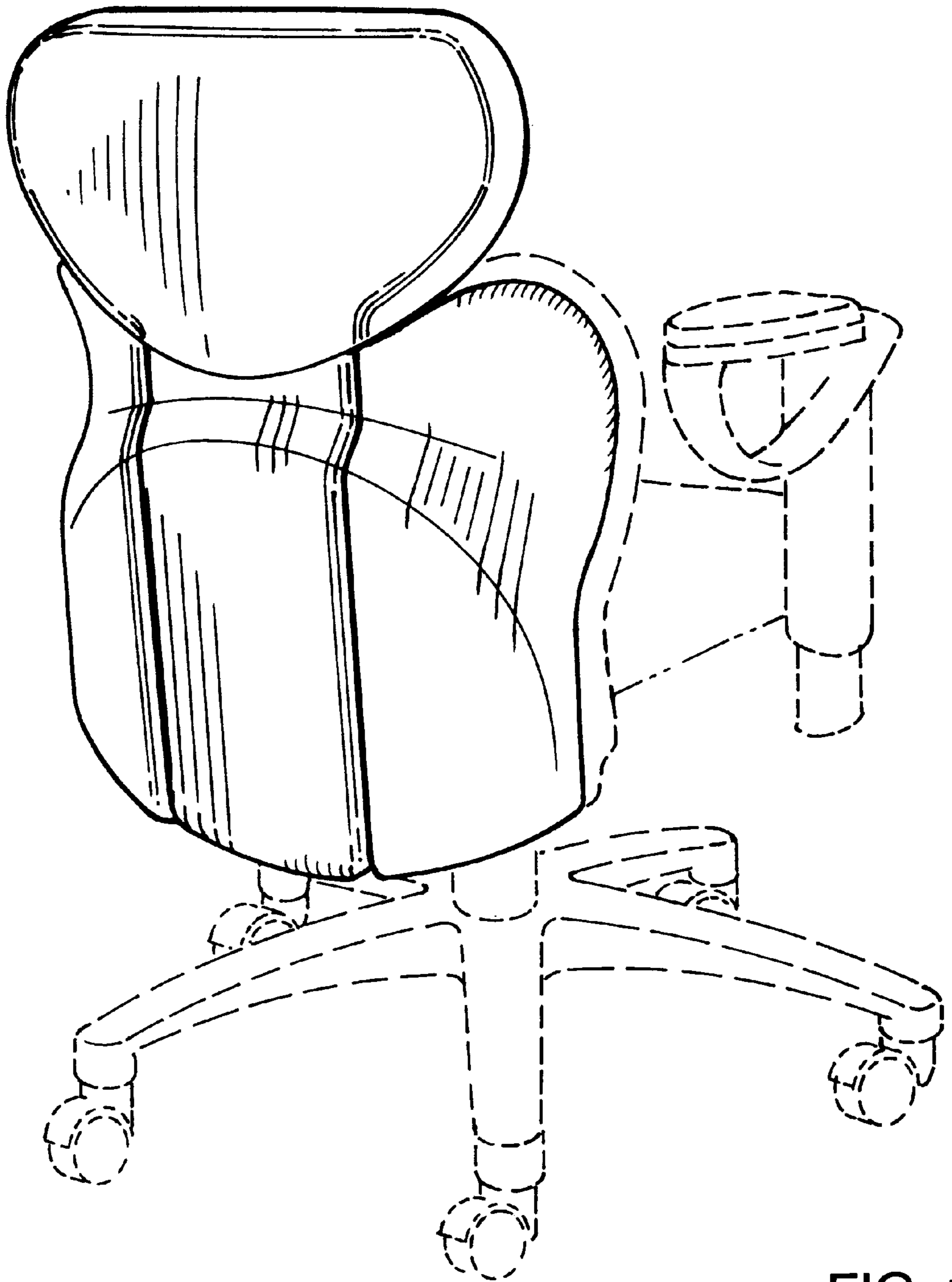

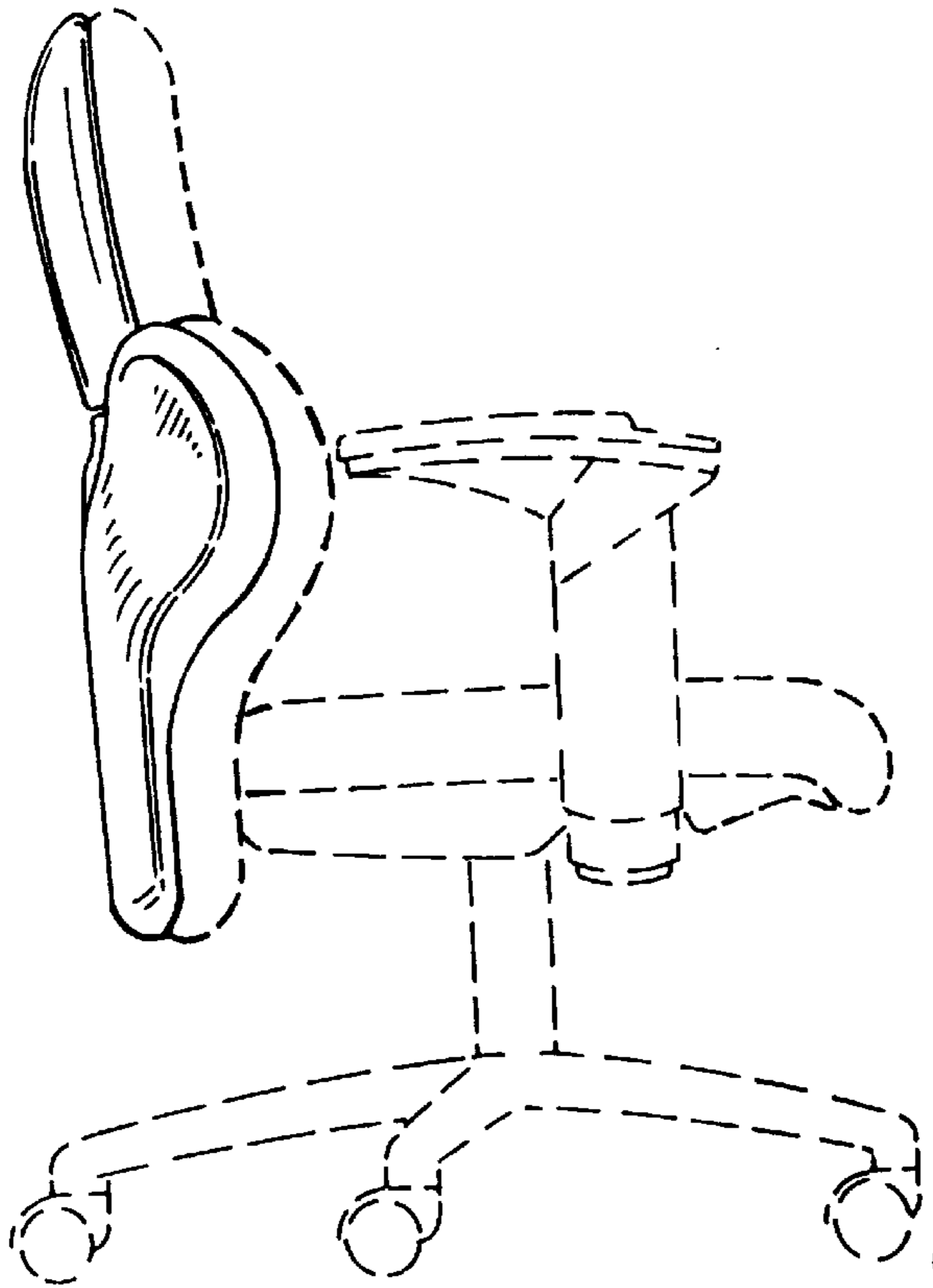

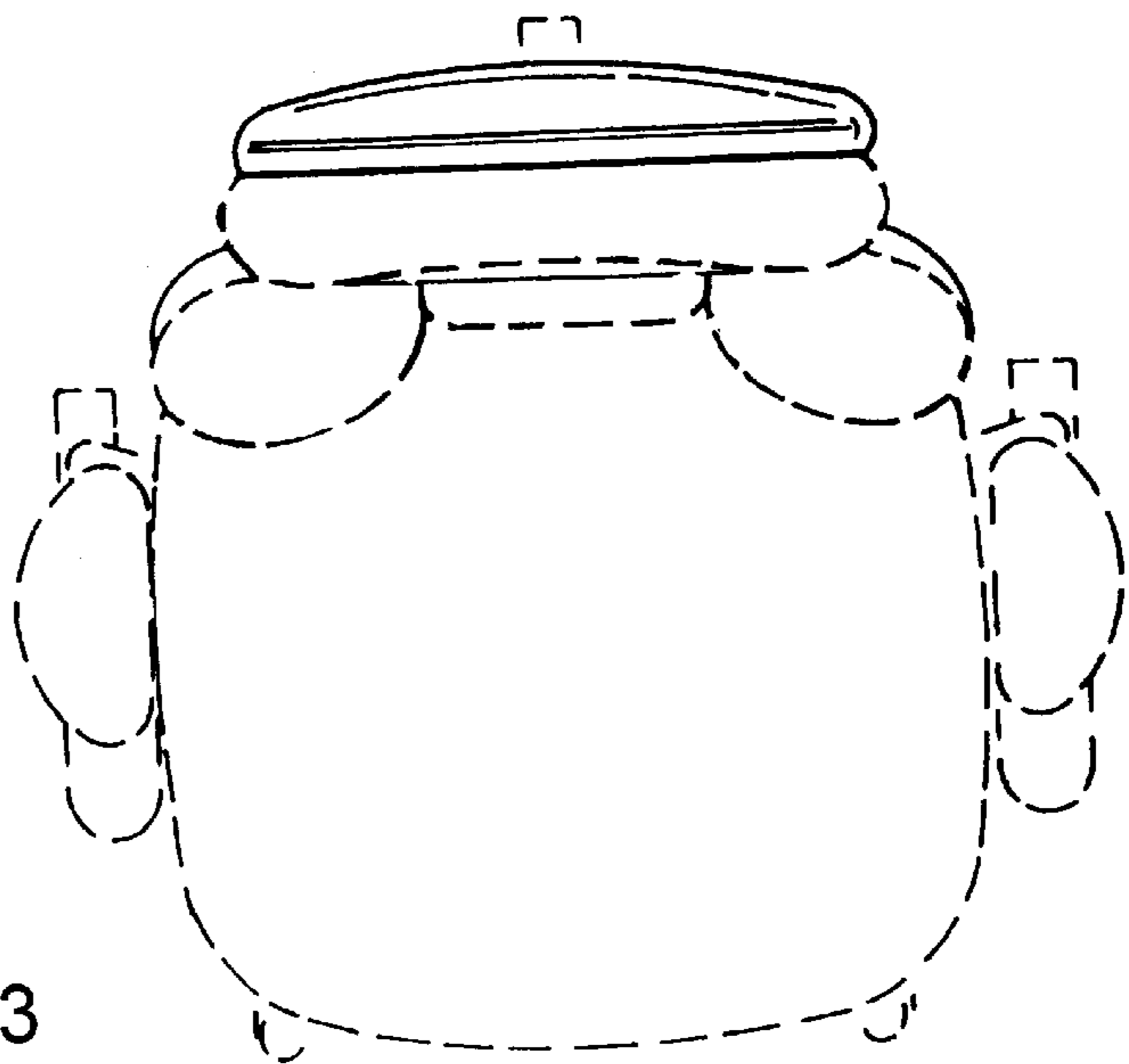

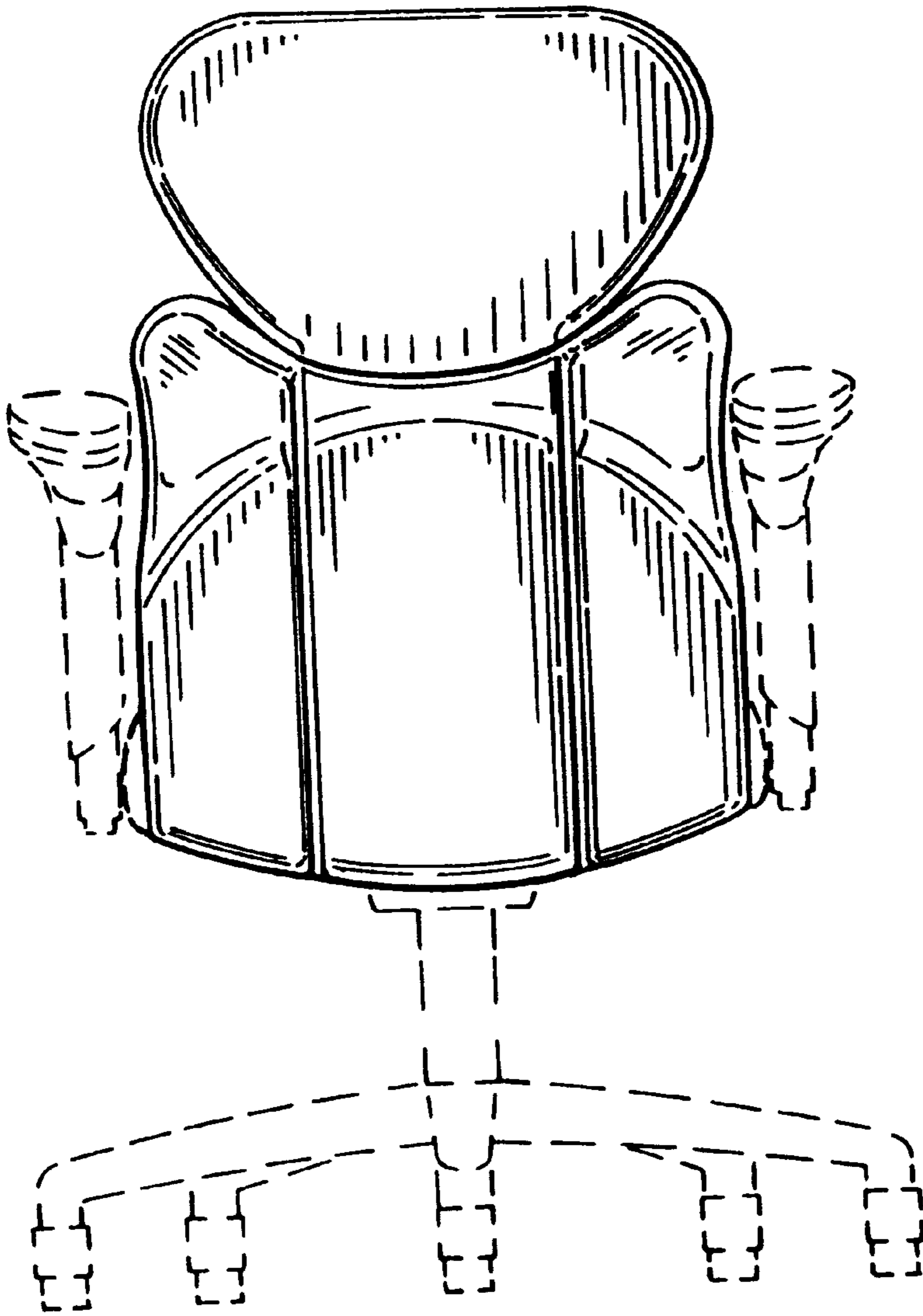
