(57) **CLAIM**

The ornamental design for an angle-handled chef's knife with contour handle, as shown and described.

DESCRIPTION

FIG. 2 is a left-end view thereof;

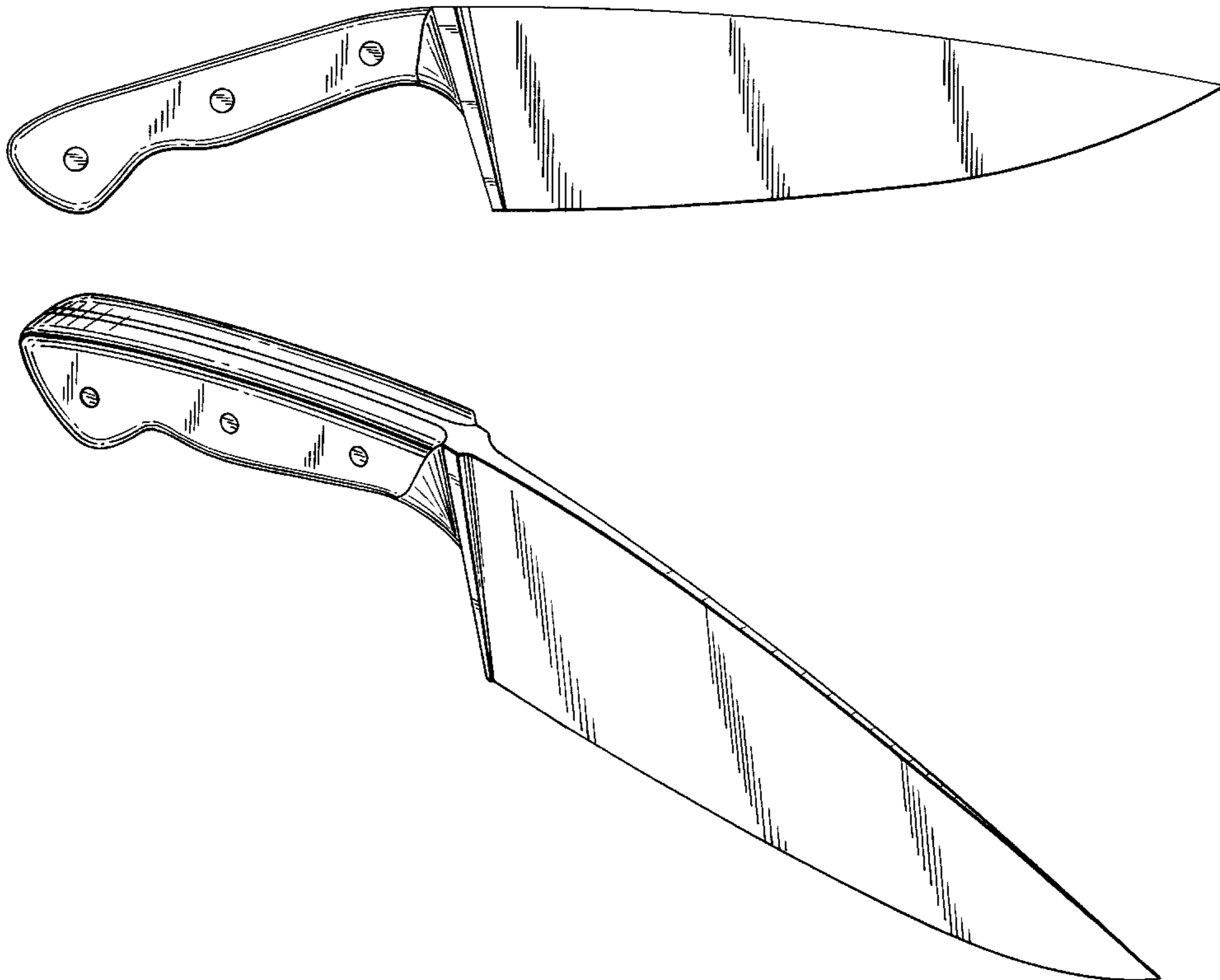
FIG. 3 is a right-end view thereof;

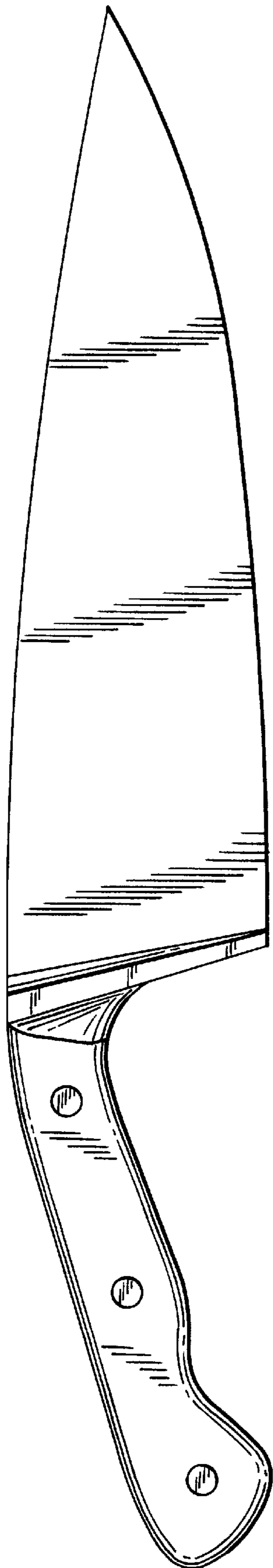

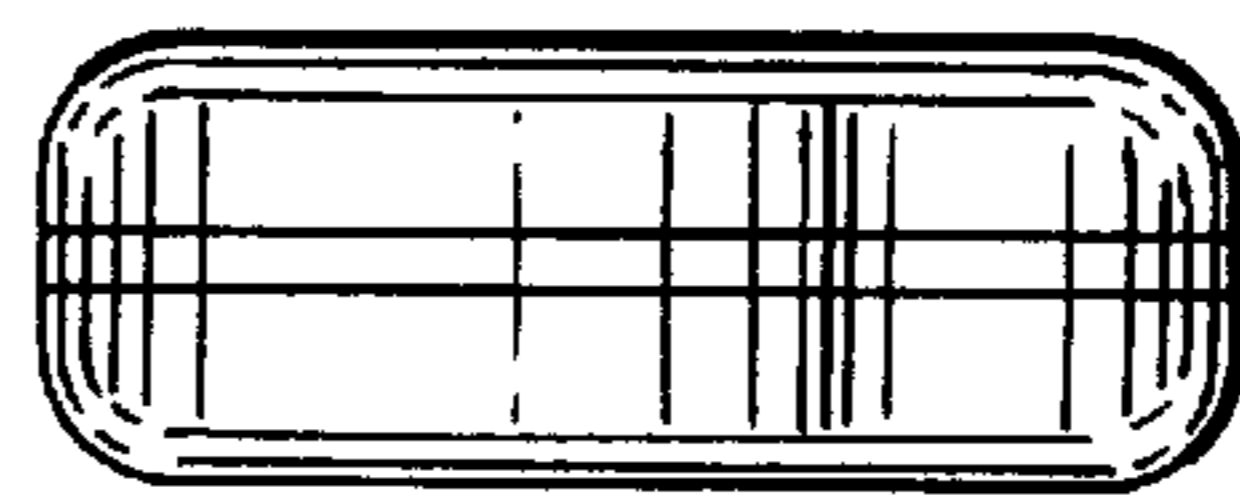

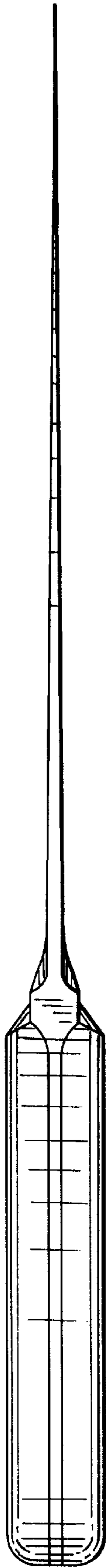

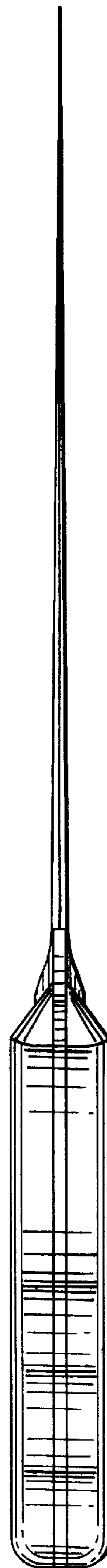

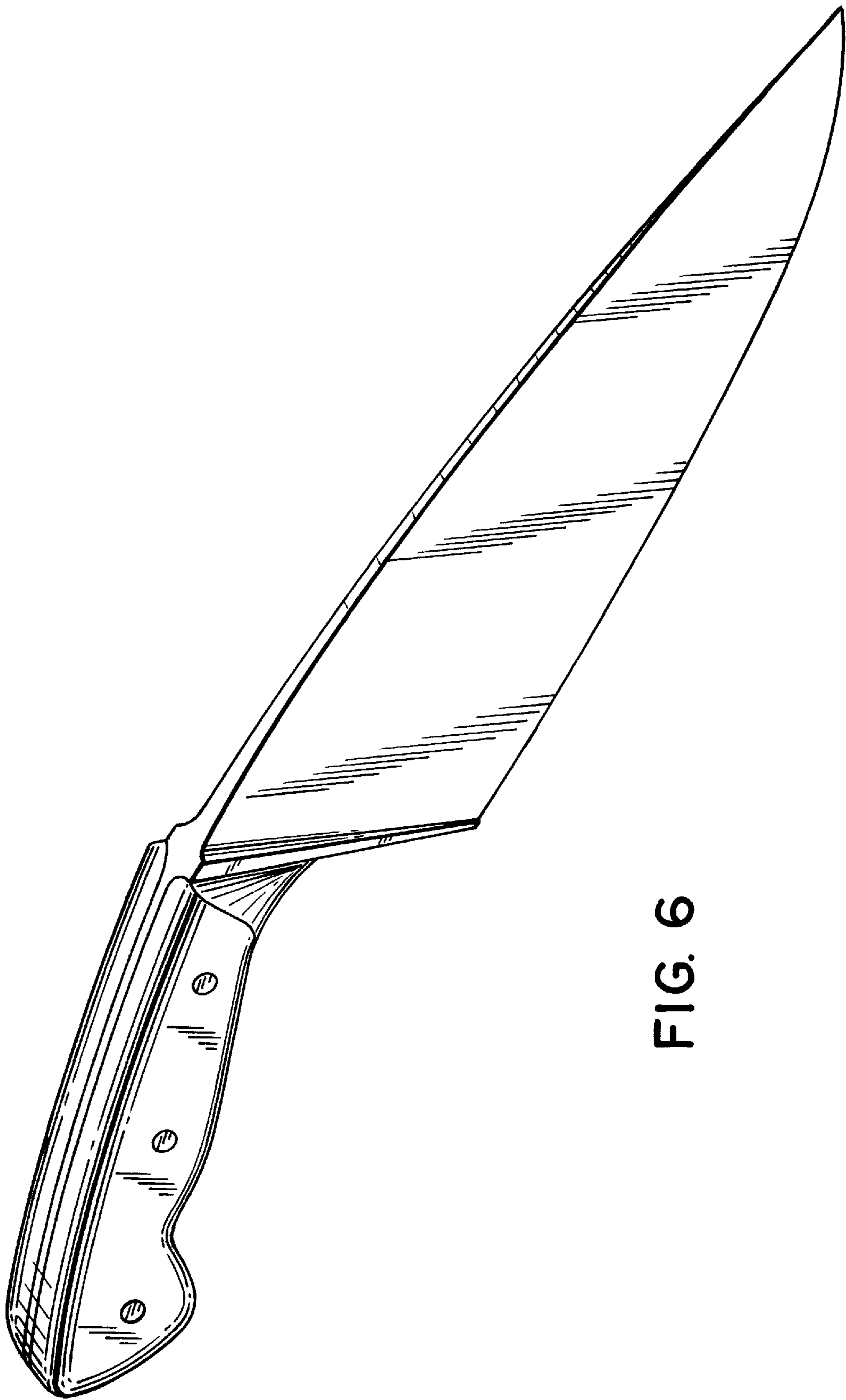
