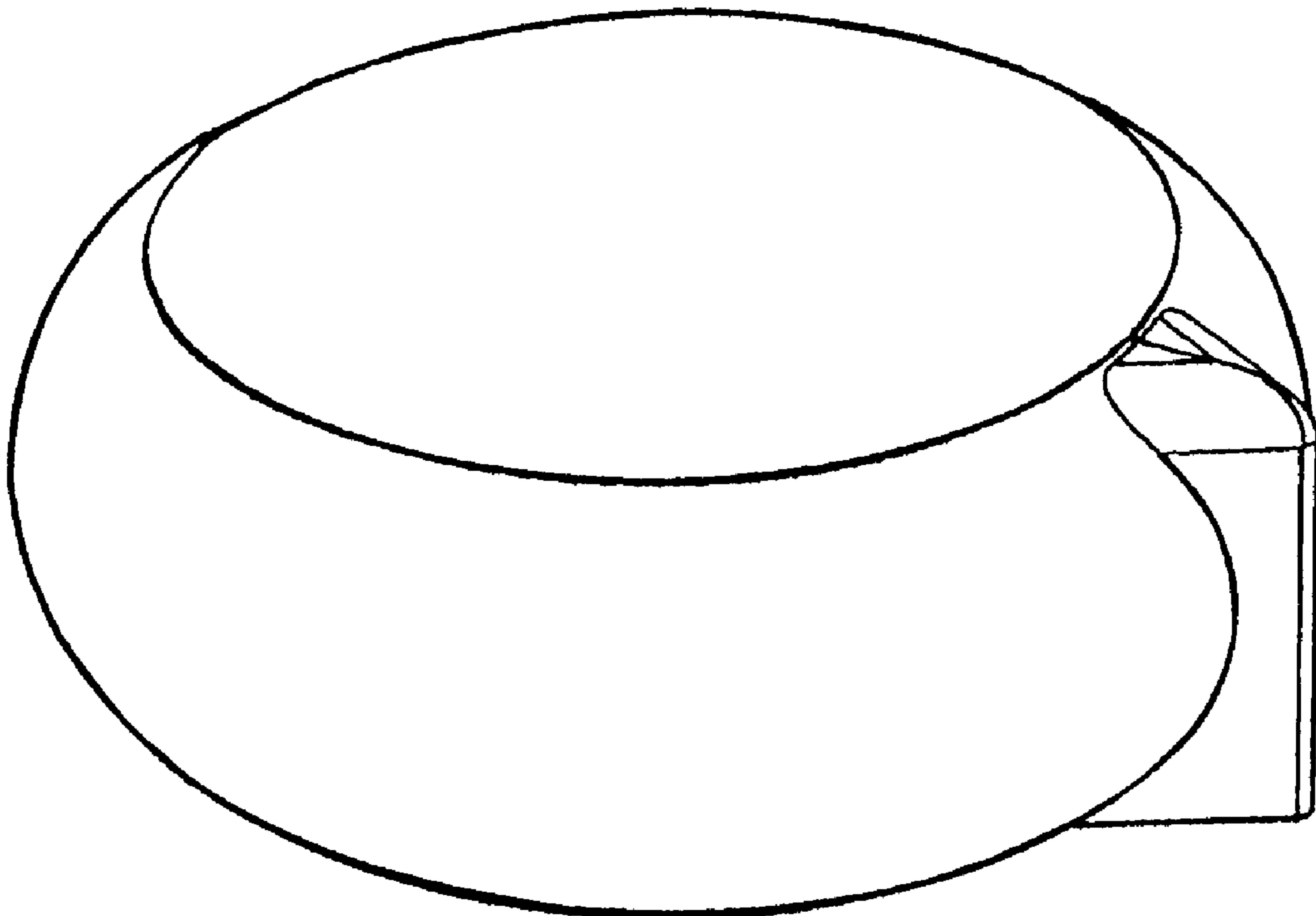
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a knob according to the present invention.
FIG. 2 is a top view of the knob of FIG. 1.
FIG. 3 is a first side view of the knob of FIG. 1.
FIG. 4 is a front view of the knob of FIG. 1.
FIG. 5 is a second side view of the knob of FIG. 1, opposite the first side shown in FIG. 3.
FIG. 6 is a rear perspective view of the knob of FIG. 1; and, FIG. 7 is a bottom perspective view of the knob of FIG. 1.

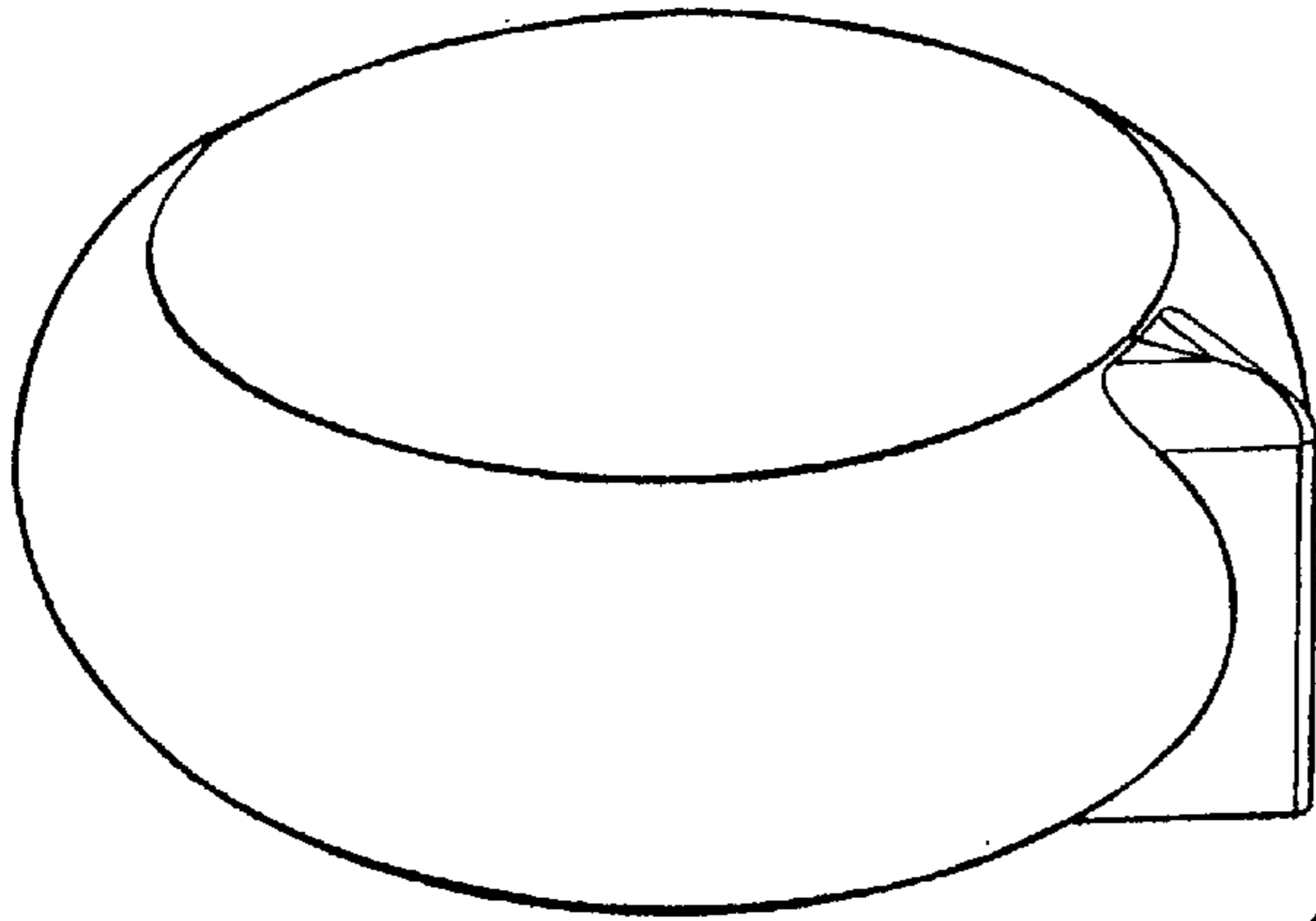

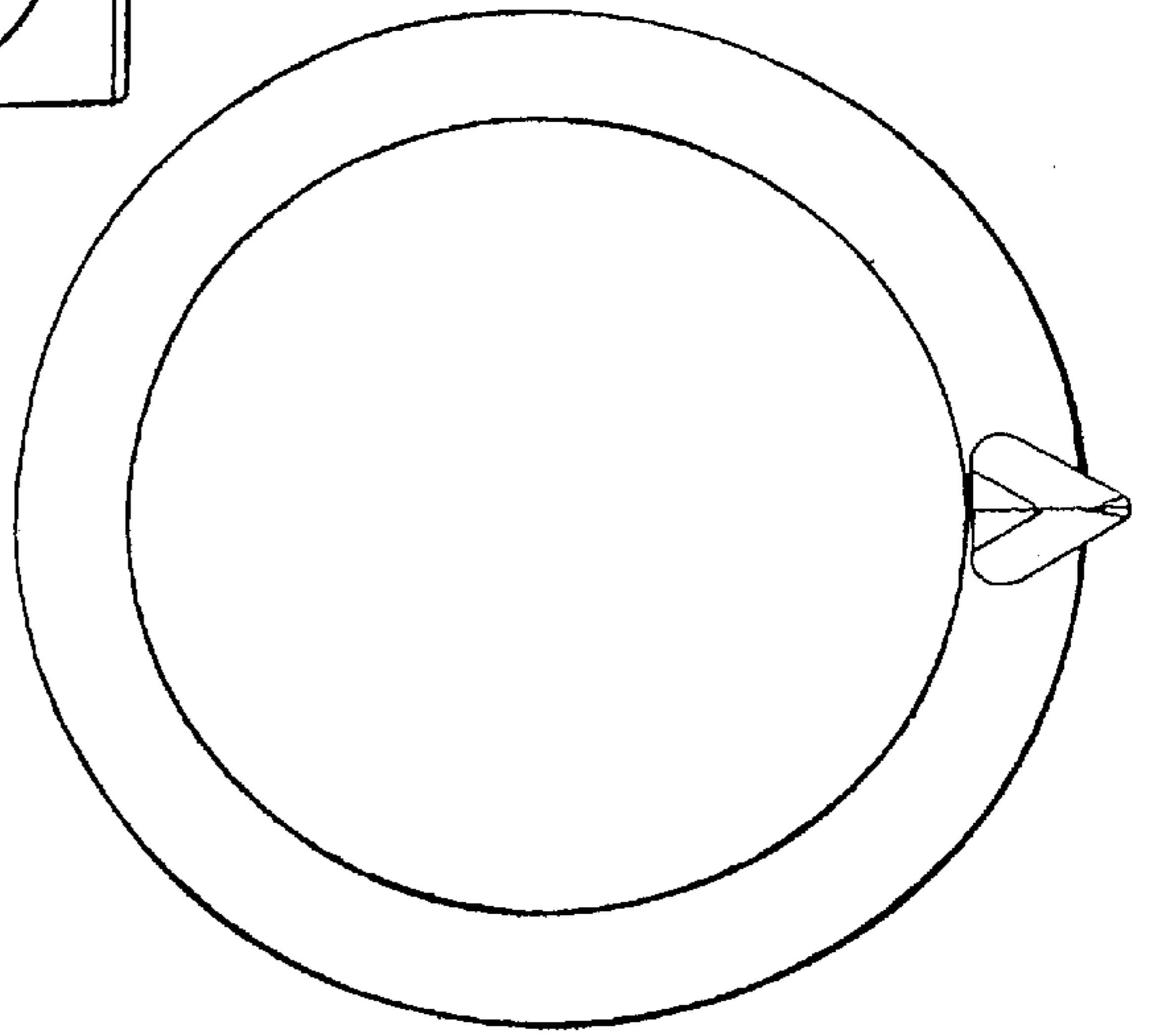

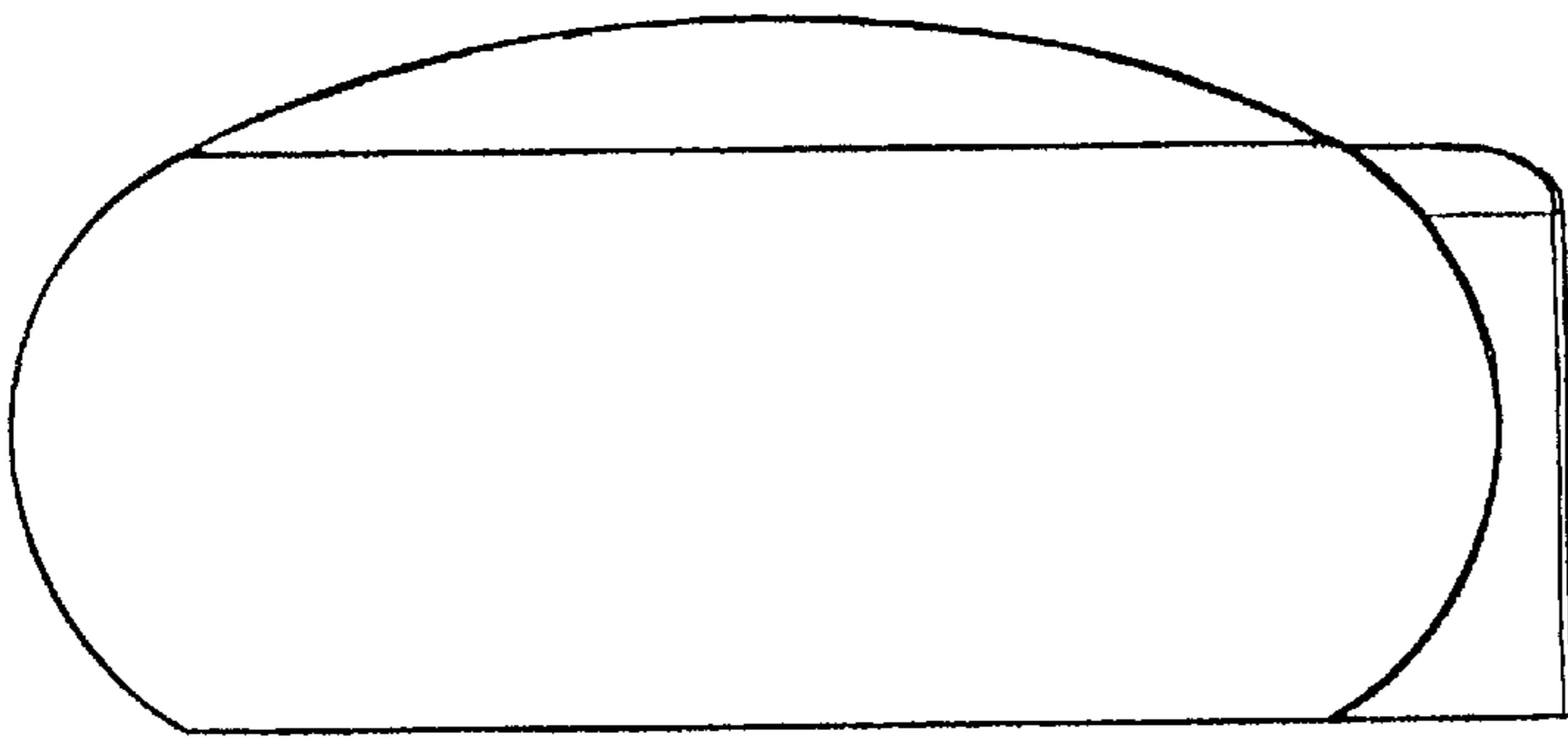

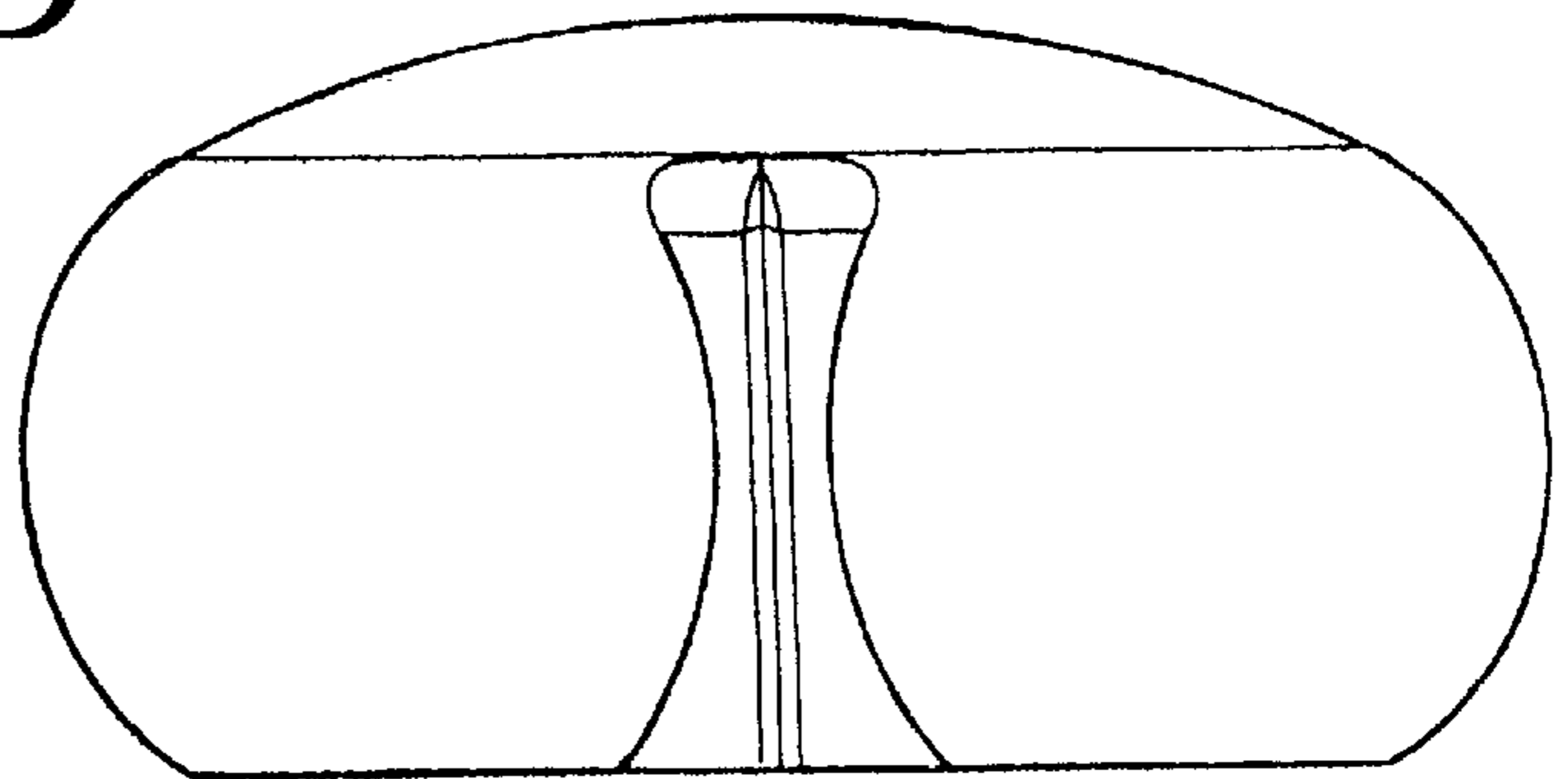

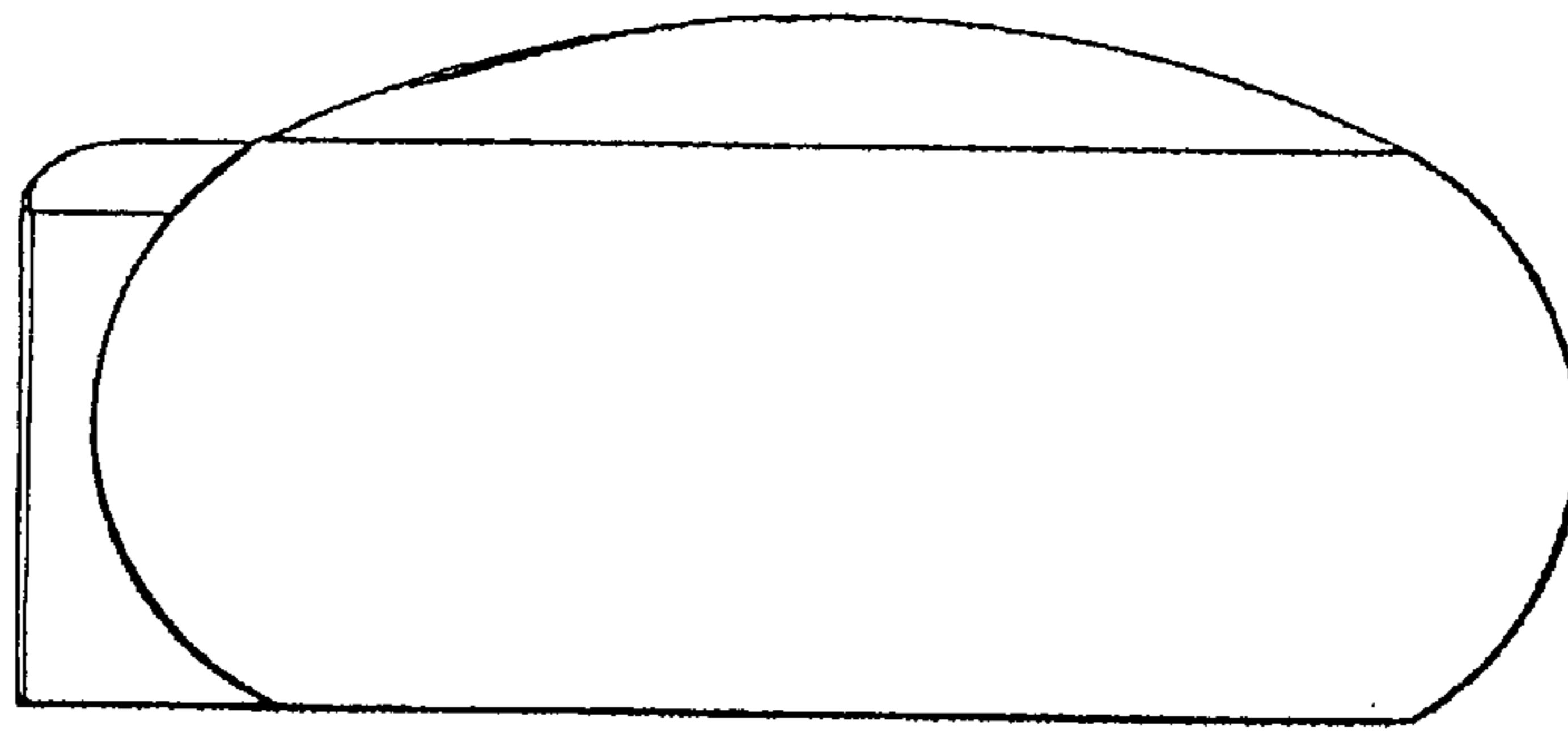

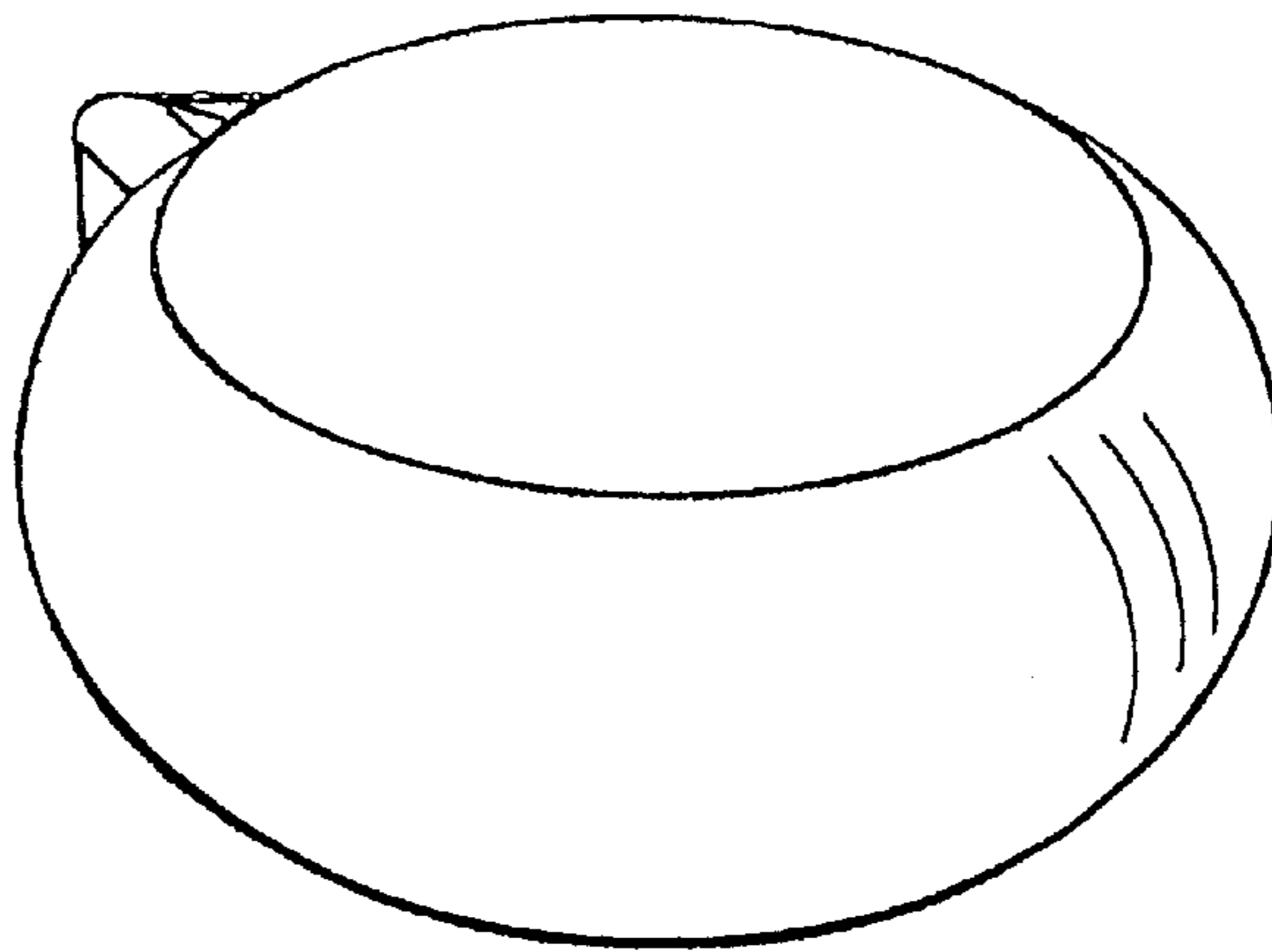

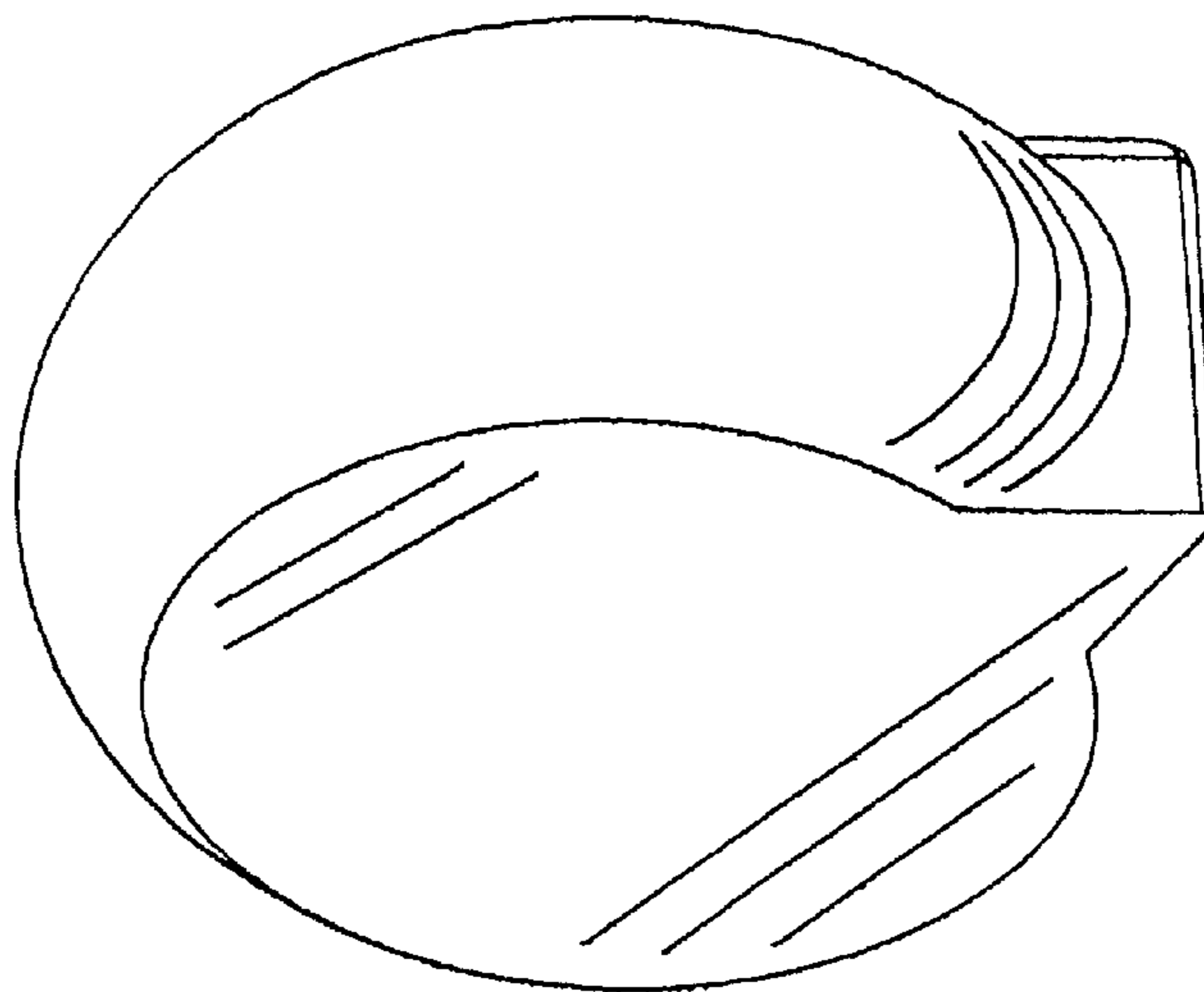
