(57) **CLAIM**

The ornamental design for a combined body lotion tube and cap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a combined body lotion tube and cap showing my new design, the rear view being identical to the front view;

FIG. 2 is a right side view thereof, the left side view being identical to the right side view;

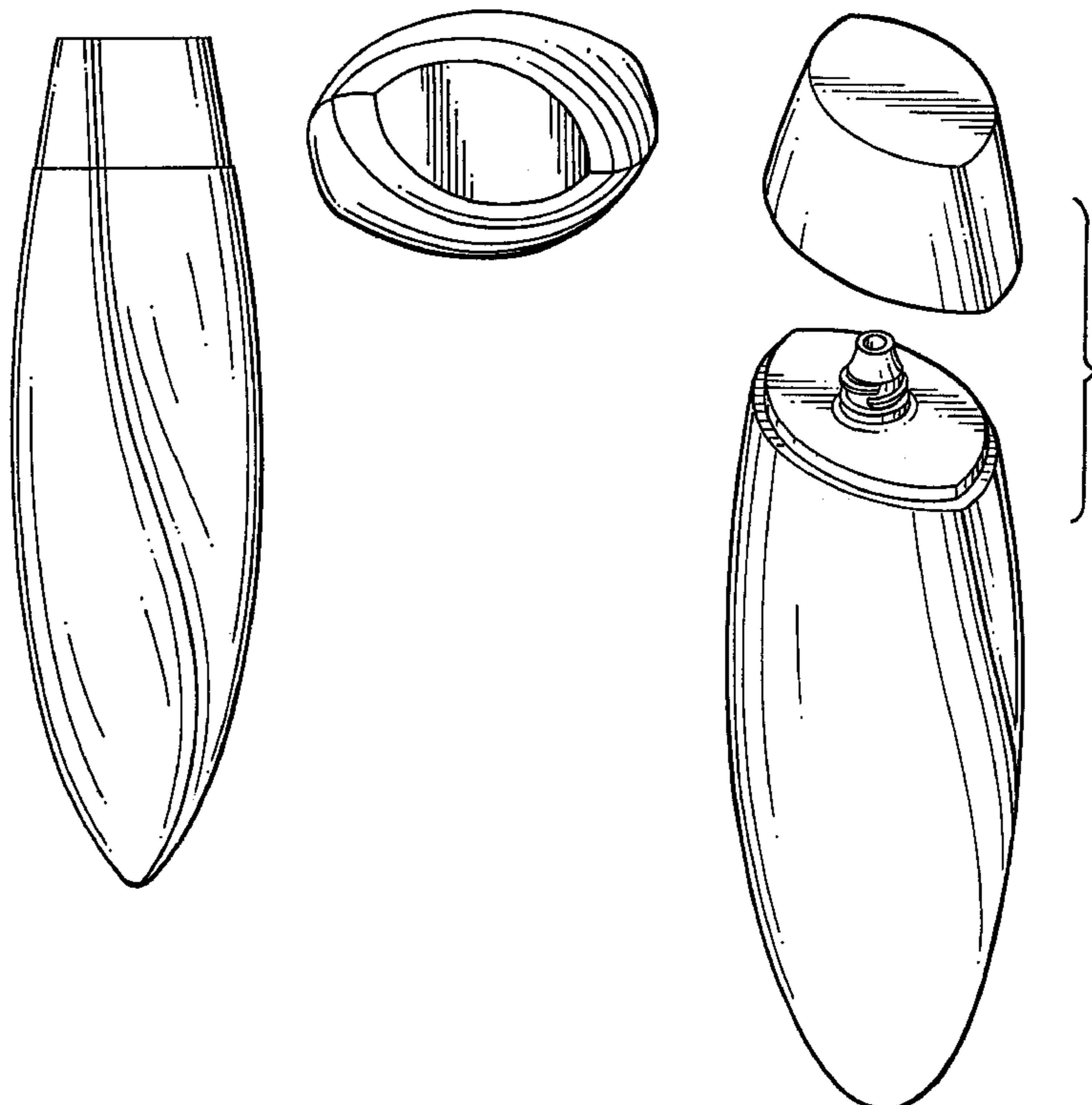
FIG. 3 is a top plan view thereof;

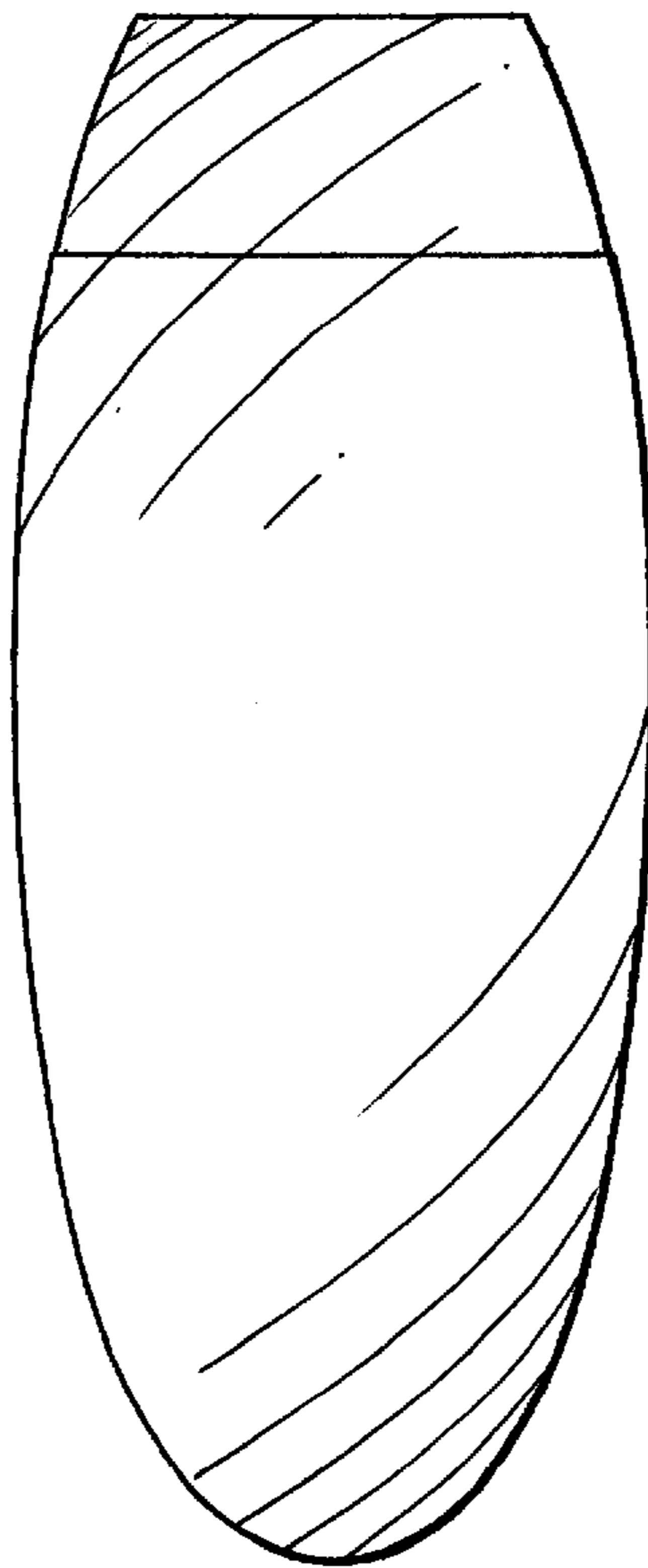

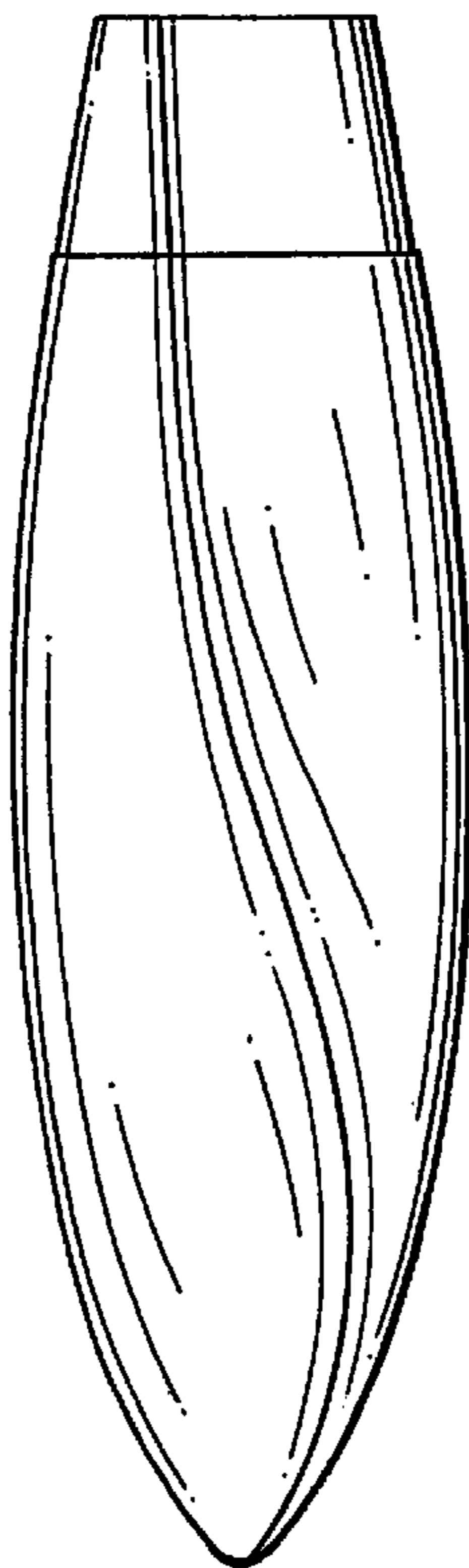

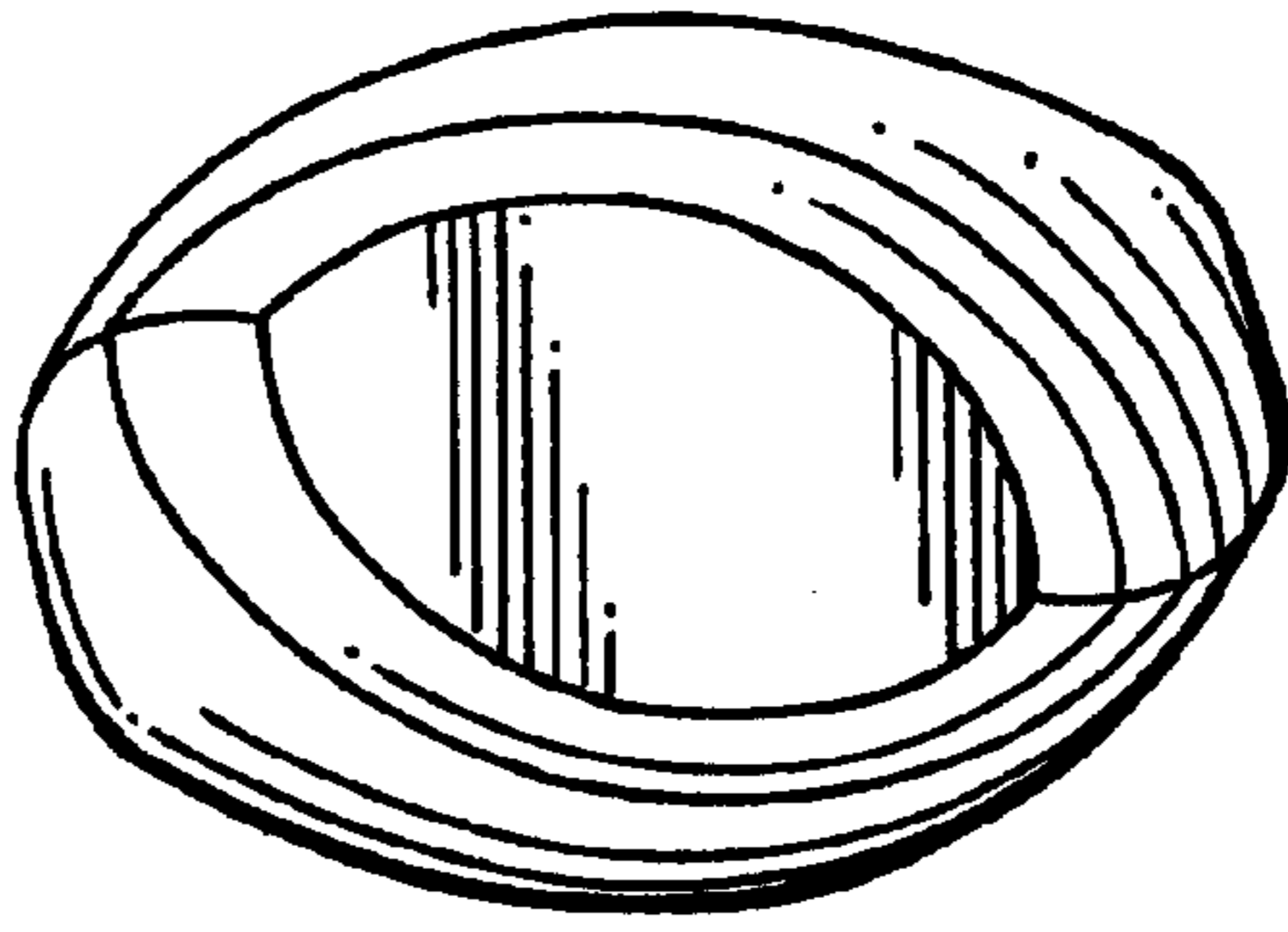

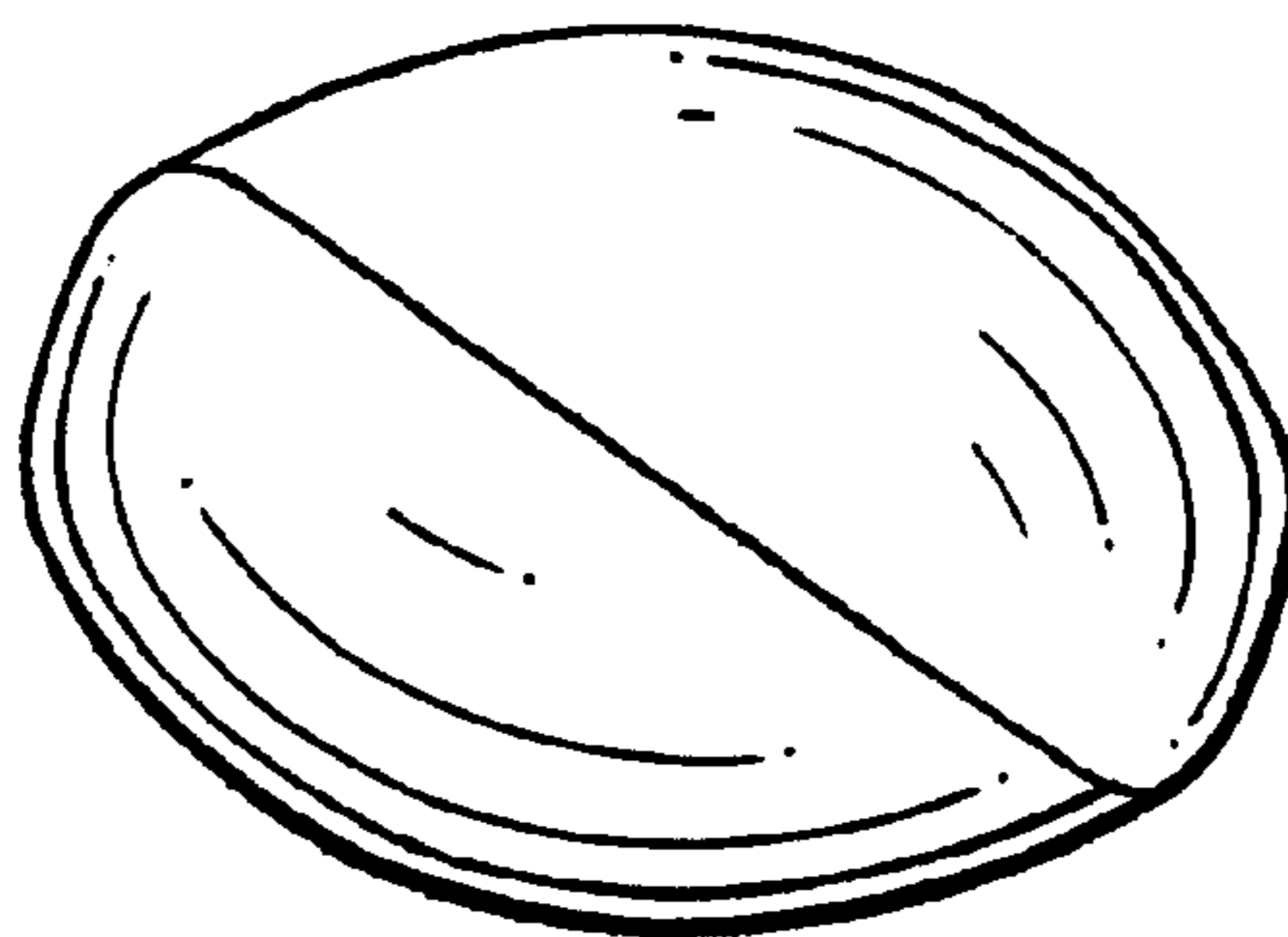

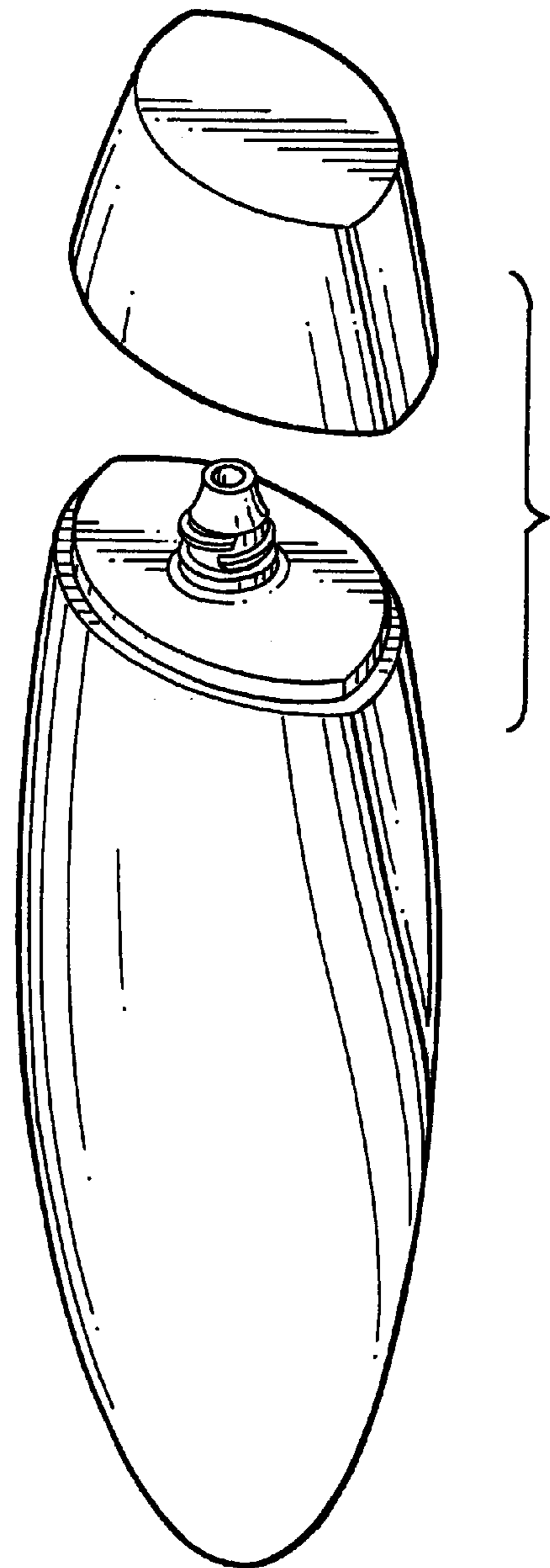
