(57) **CLAIM**

I claim the ornamental design for a paper clip, as shown.

DESCRIPTION

FIG. 1 is a front view of a new design for a paper clip, the
rear view being a mirror image thereof;
FIG. 2 is a top edge view;
FIG. 3 is a bottom edge view;
FIG. 4 is a left edge view; and,
FIG. 5 is a right edge view.

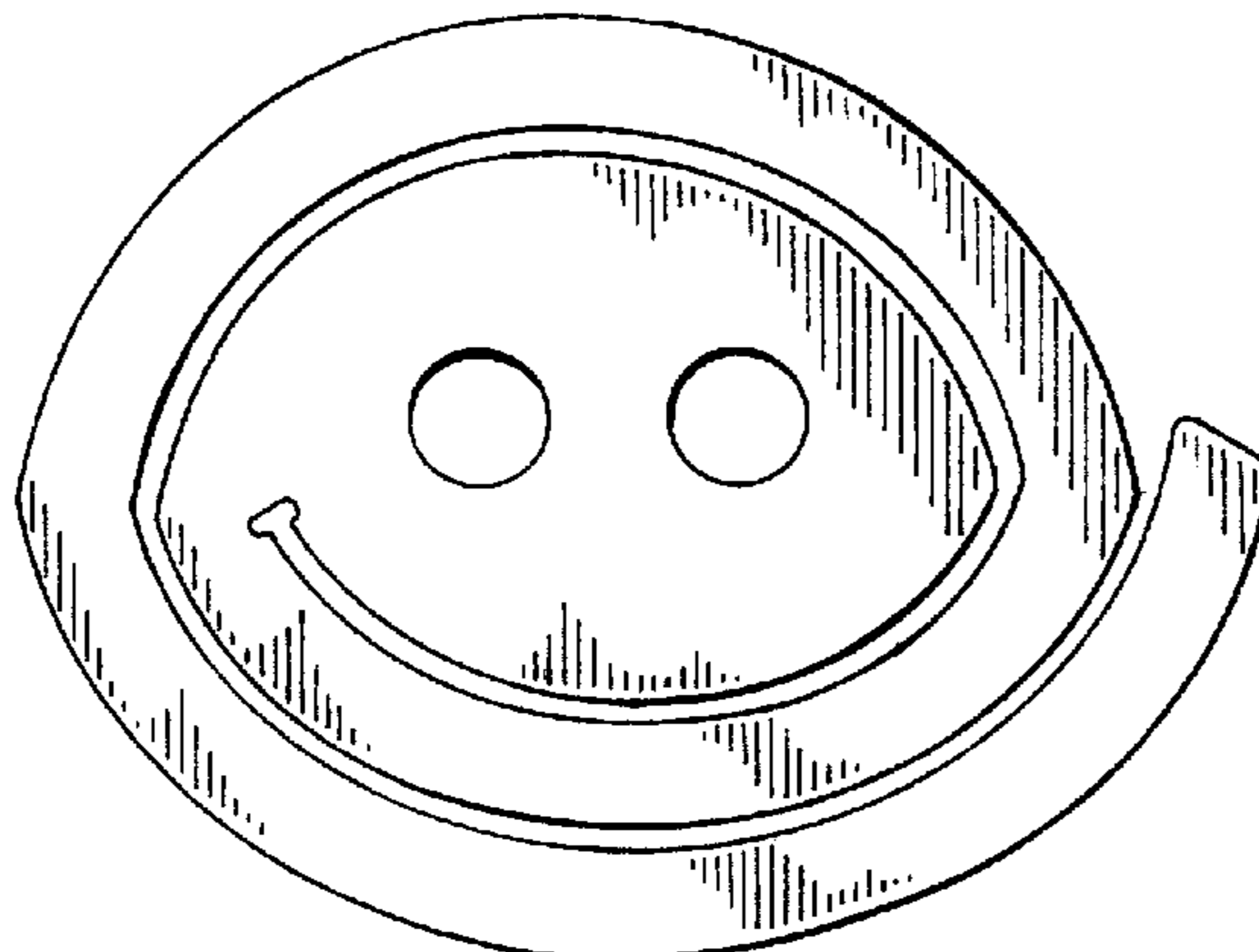

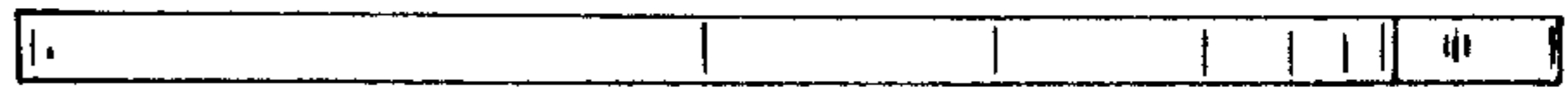

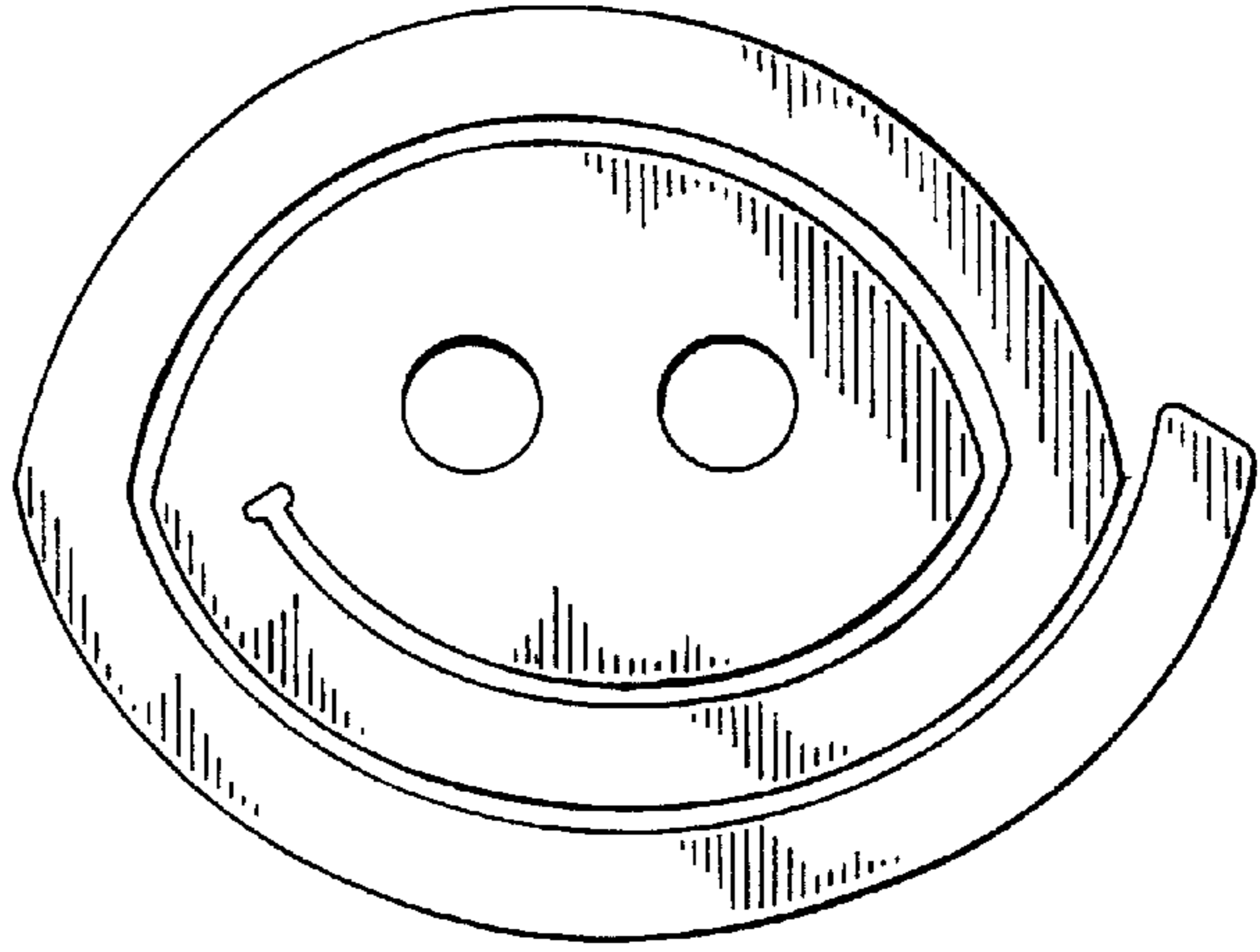

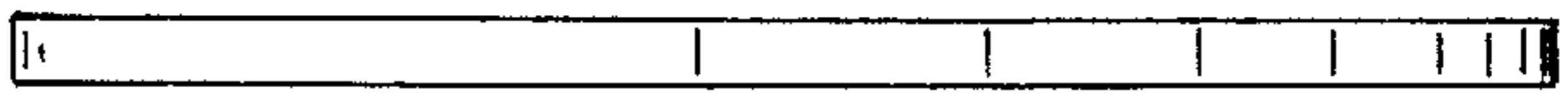
