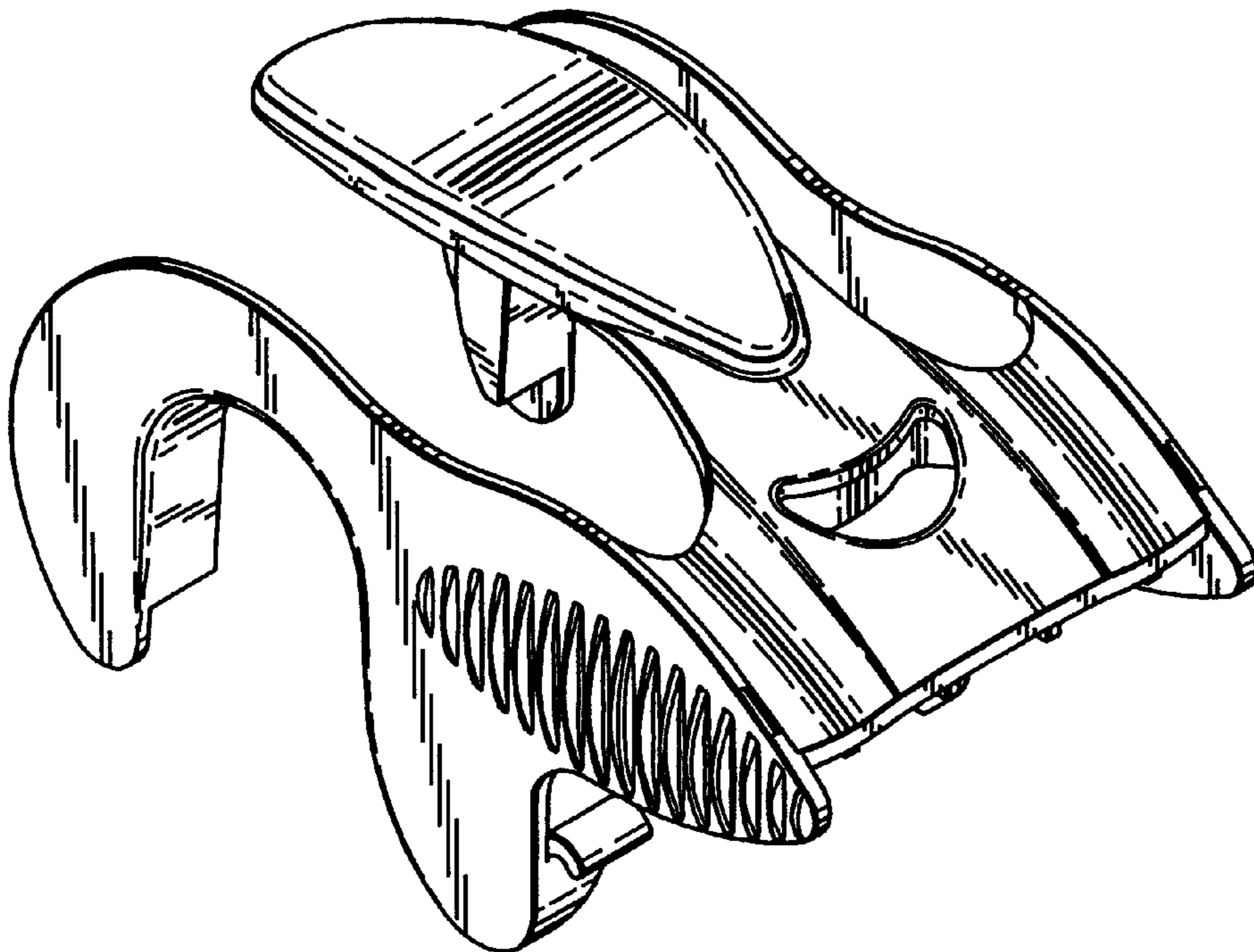

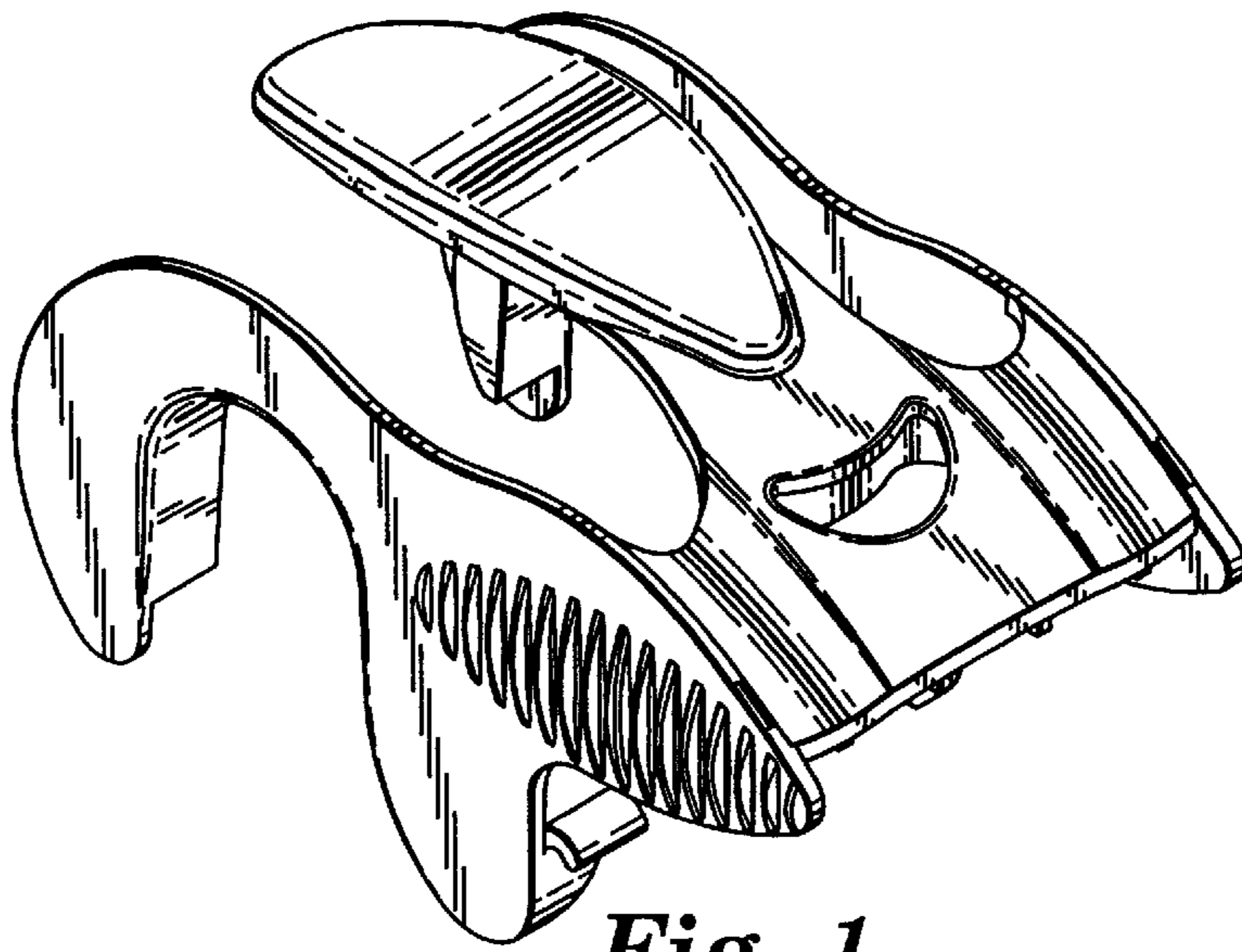
The ornamental design for the tape dispenser, as shown and described.

**DESCRIPTION**

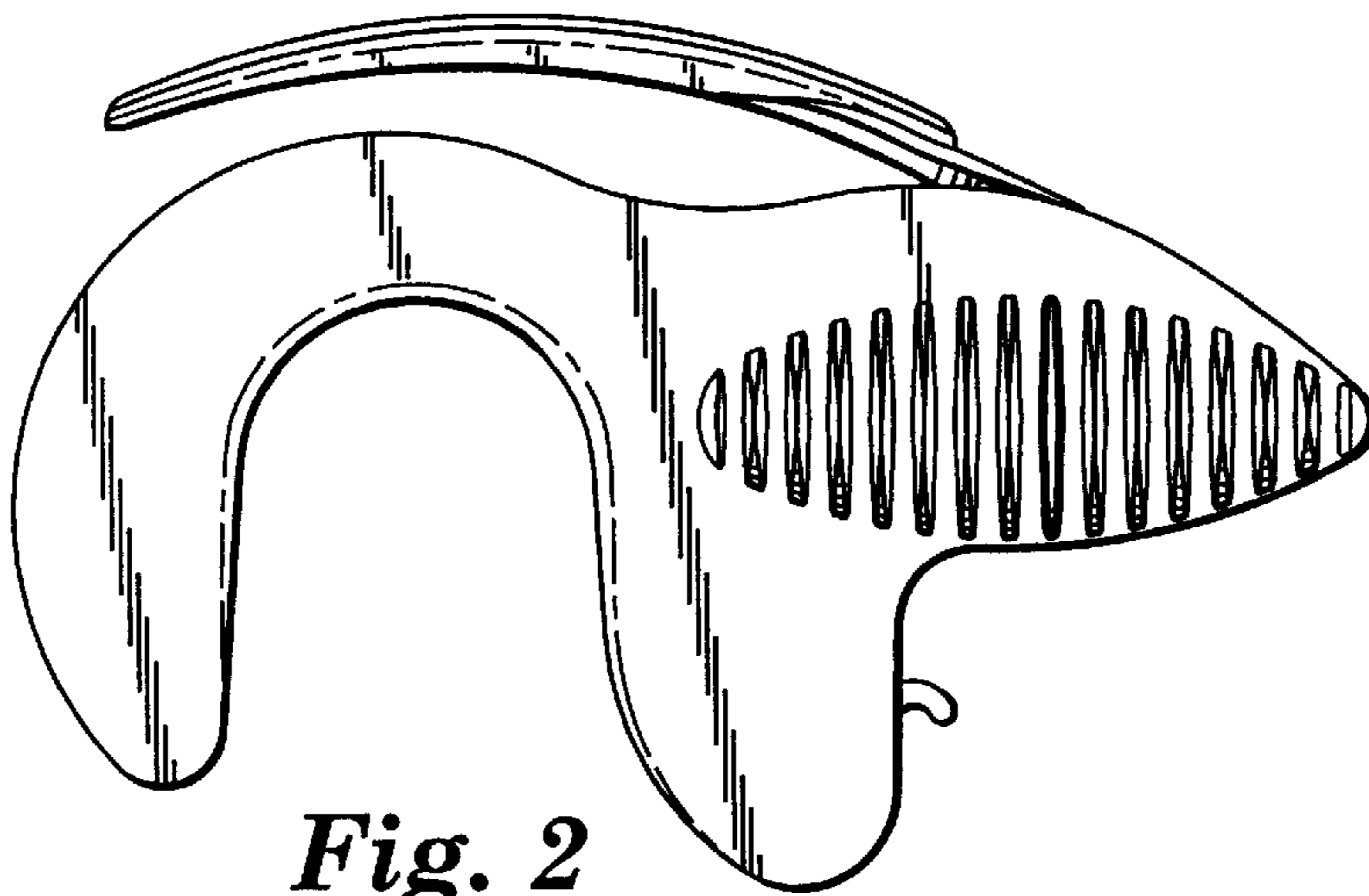
FIG. 1 is a perspective view of the tape dispenser according to the present invention;

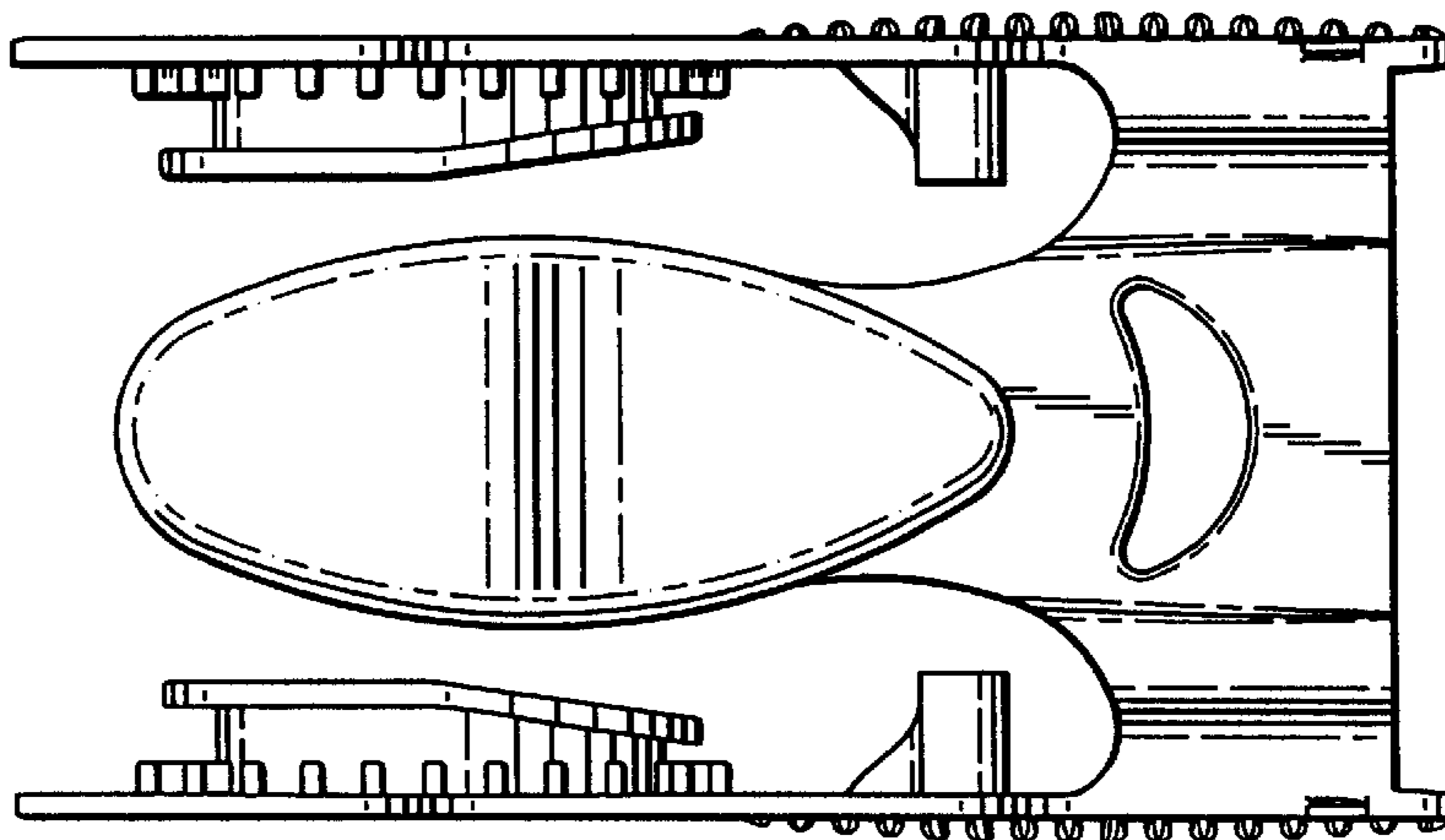




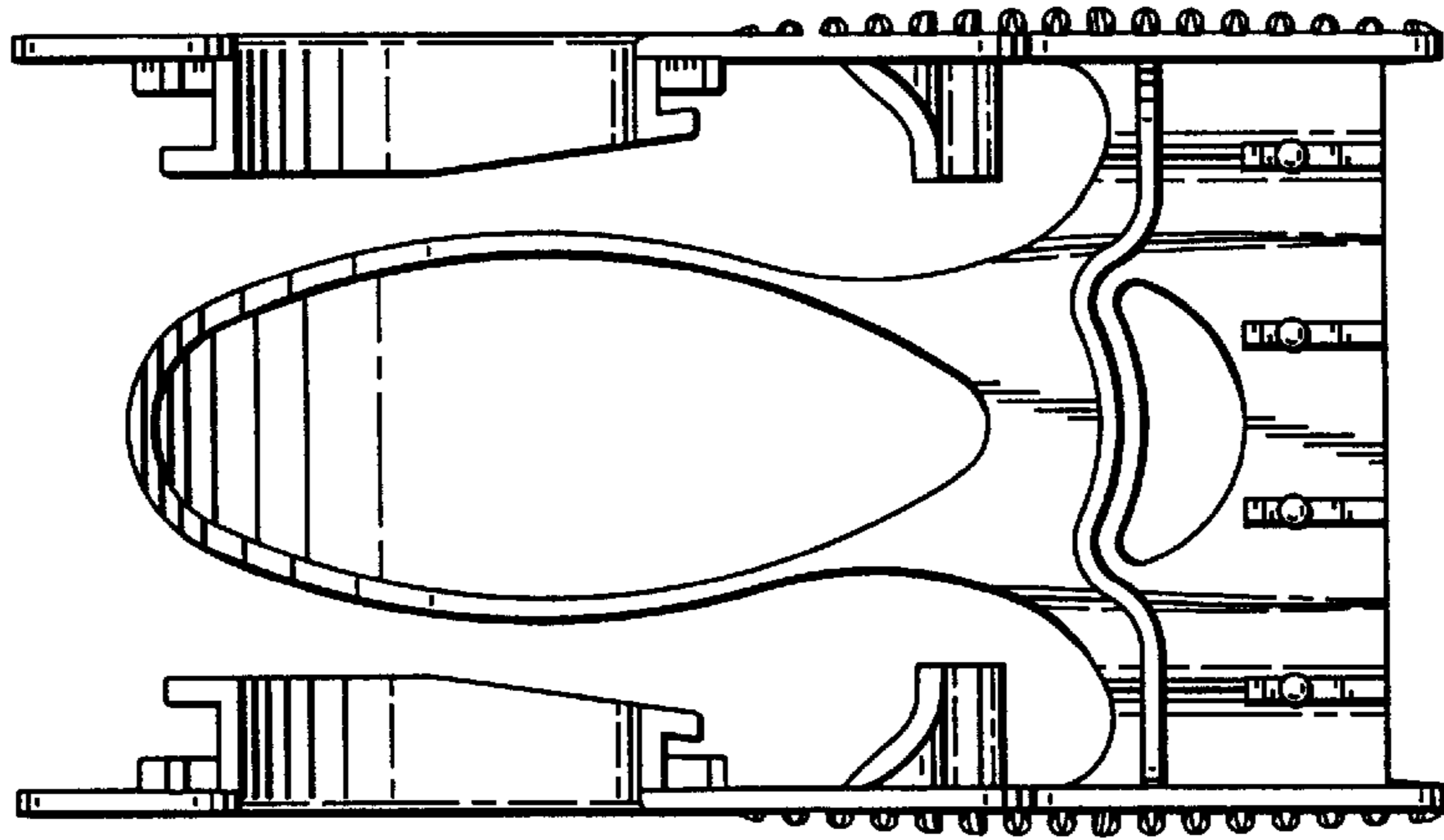

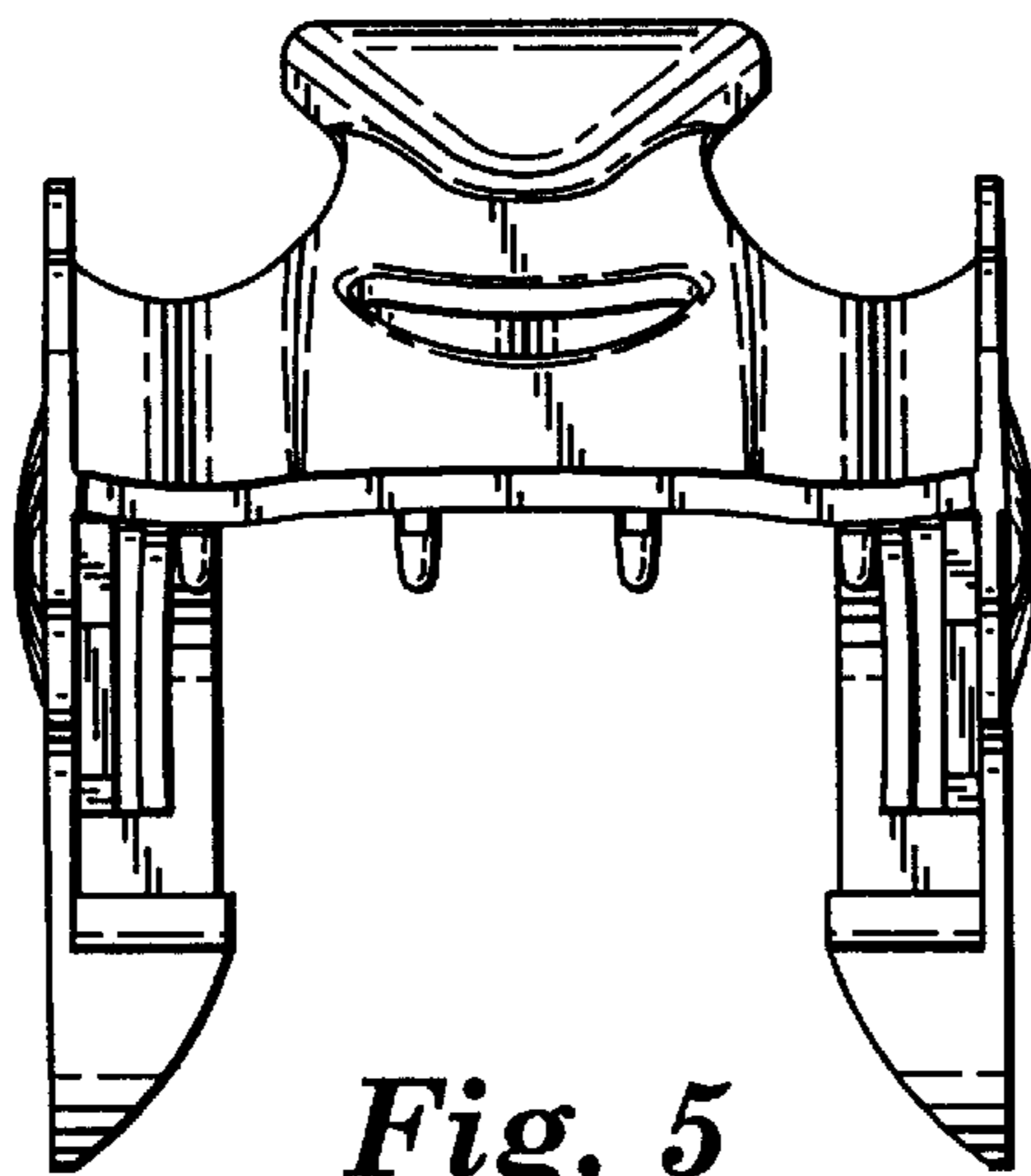

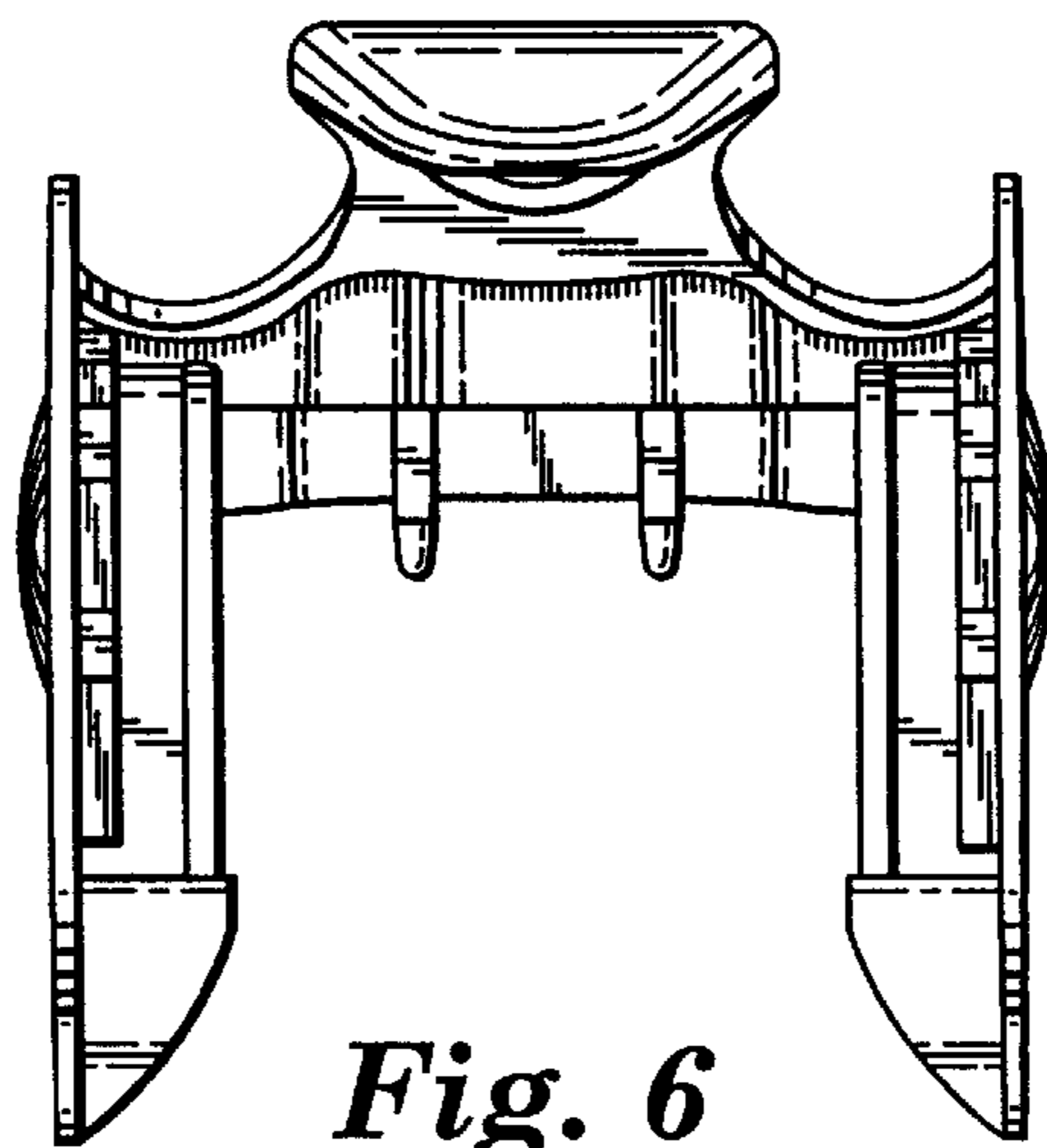
