(57) **CLAIM**

The ornamental design for a toy figure, as shown.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the toy figure of the present invention.

FIG. 2 is an elevational view of the front of the toy figure depicted in FIG. 1.

FIG. 3 is a side elevation as seen from the right side of FIG. 2.

FIG. 4 is a plan view of the top of the toy figure depicted in FIG. 1.

FIG. 5 is an elevational view of the rear of the toy figure depicted in FIG. 1.

FIG. 6 is a plan view of the bottom of the toy figure depicted in FIG. 1.

FIG. 7 is a perspective view of another embodiment of the toy figure of the present invention.

FIG. 8 is an elevational view of the front of the toy figure depicted in FIG. 7.

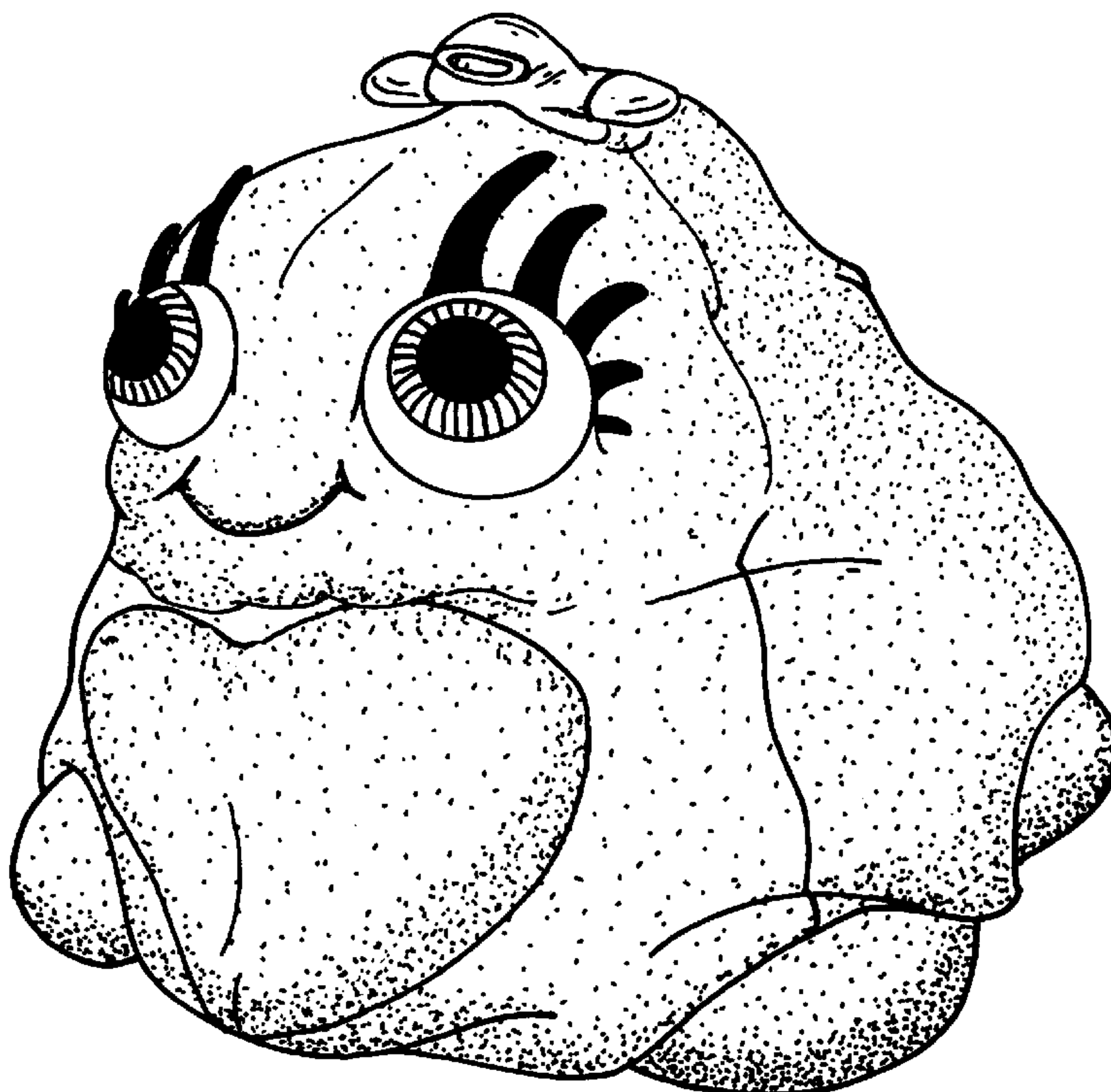
FIG. 9 is a side elevation as seen from the right side of FIG. 8.

FIG. 10 is a plan view of the top of the toy figure depicted in FIG. 7.

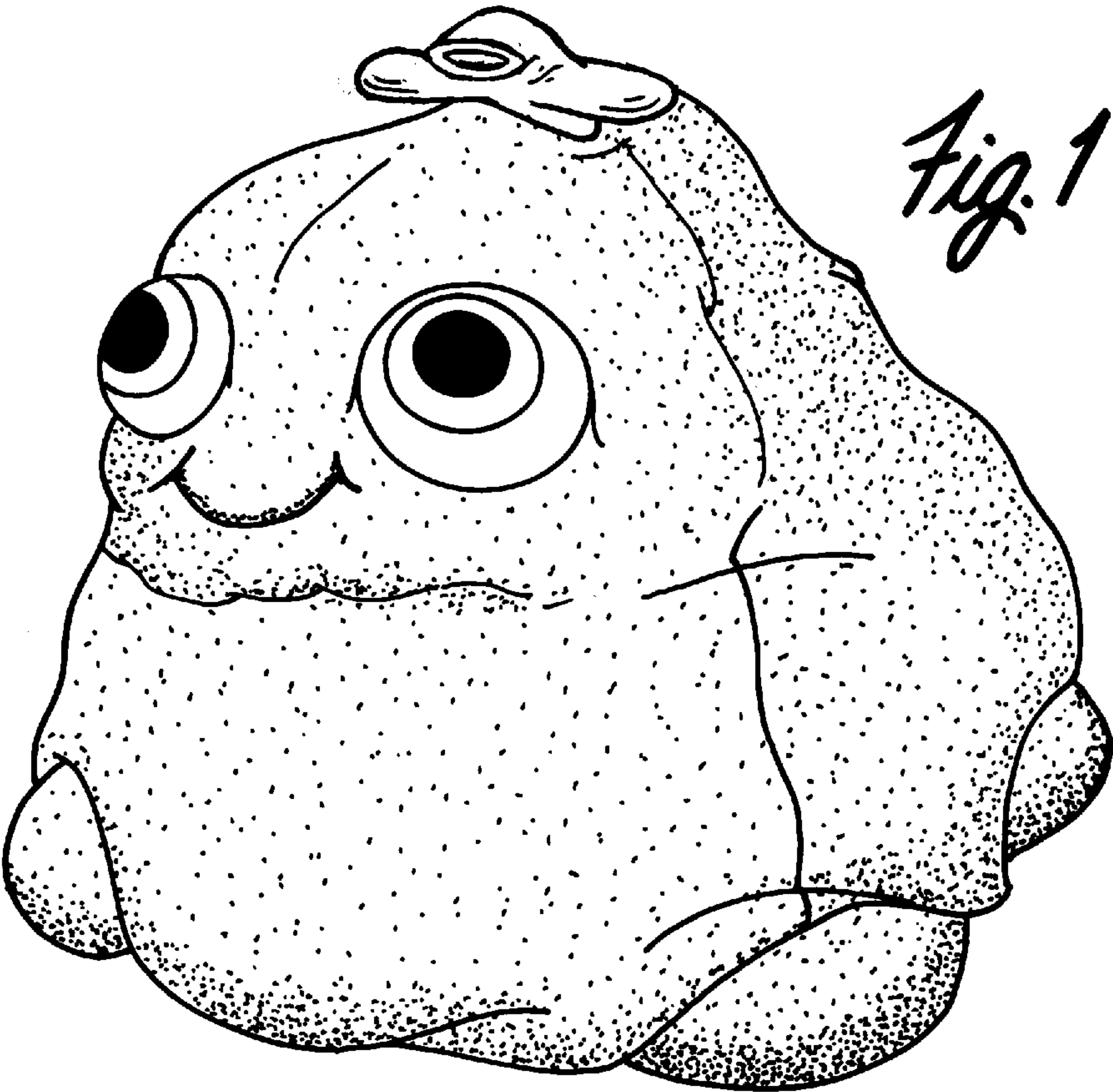

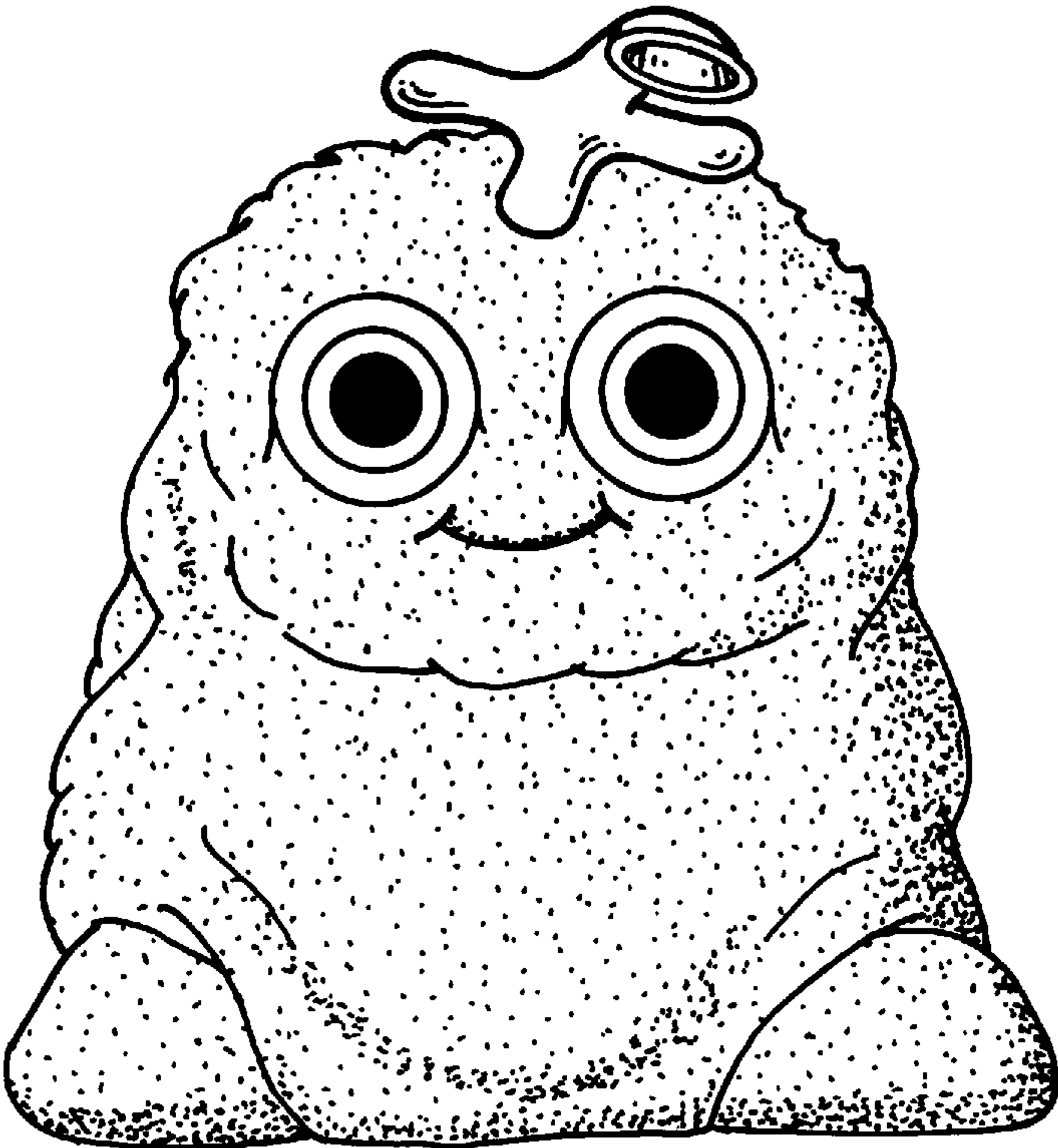

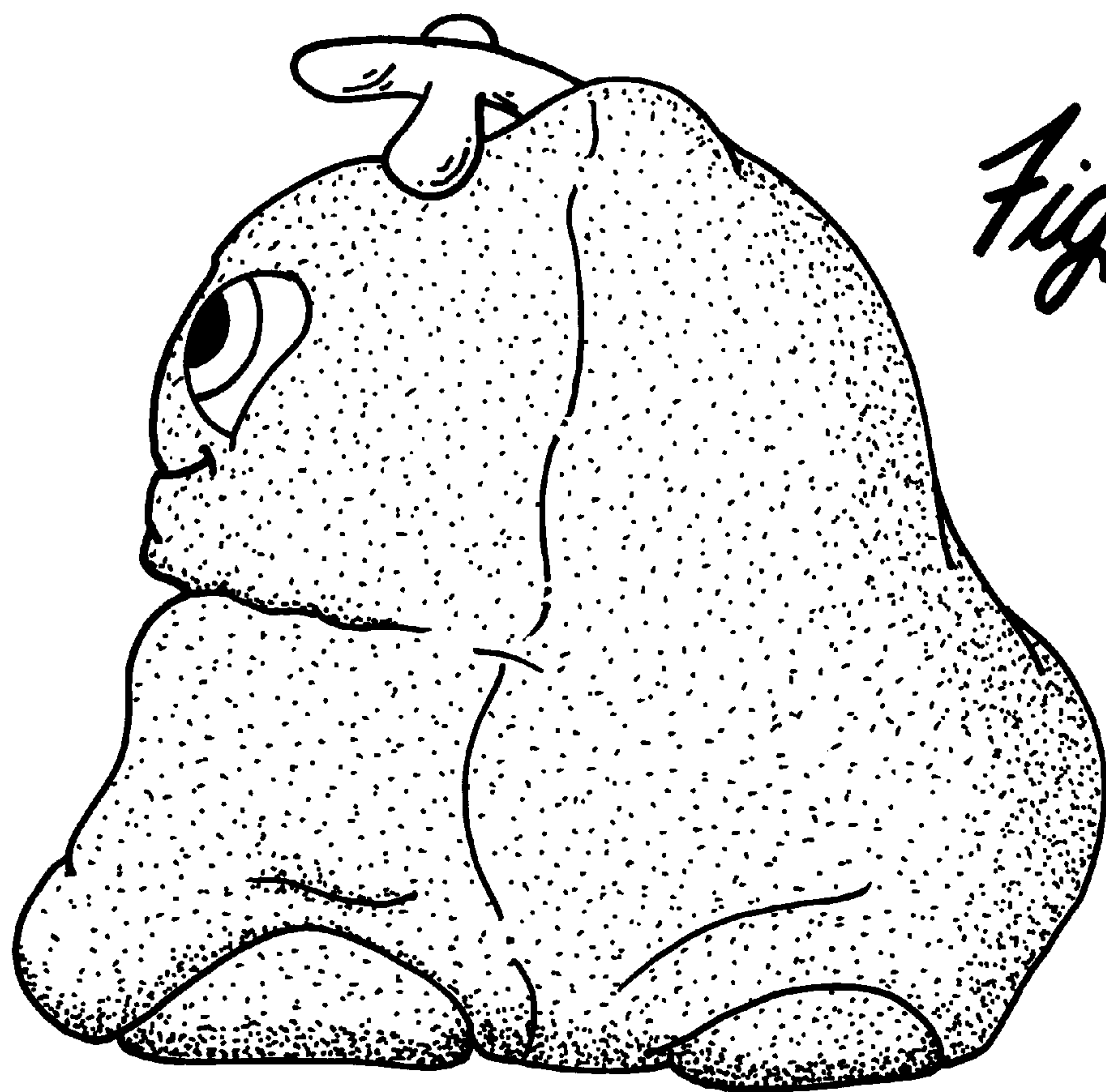

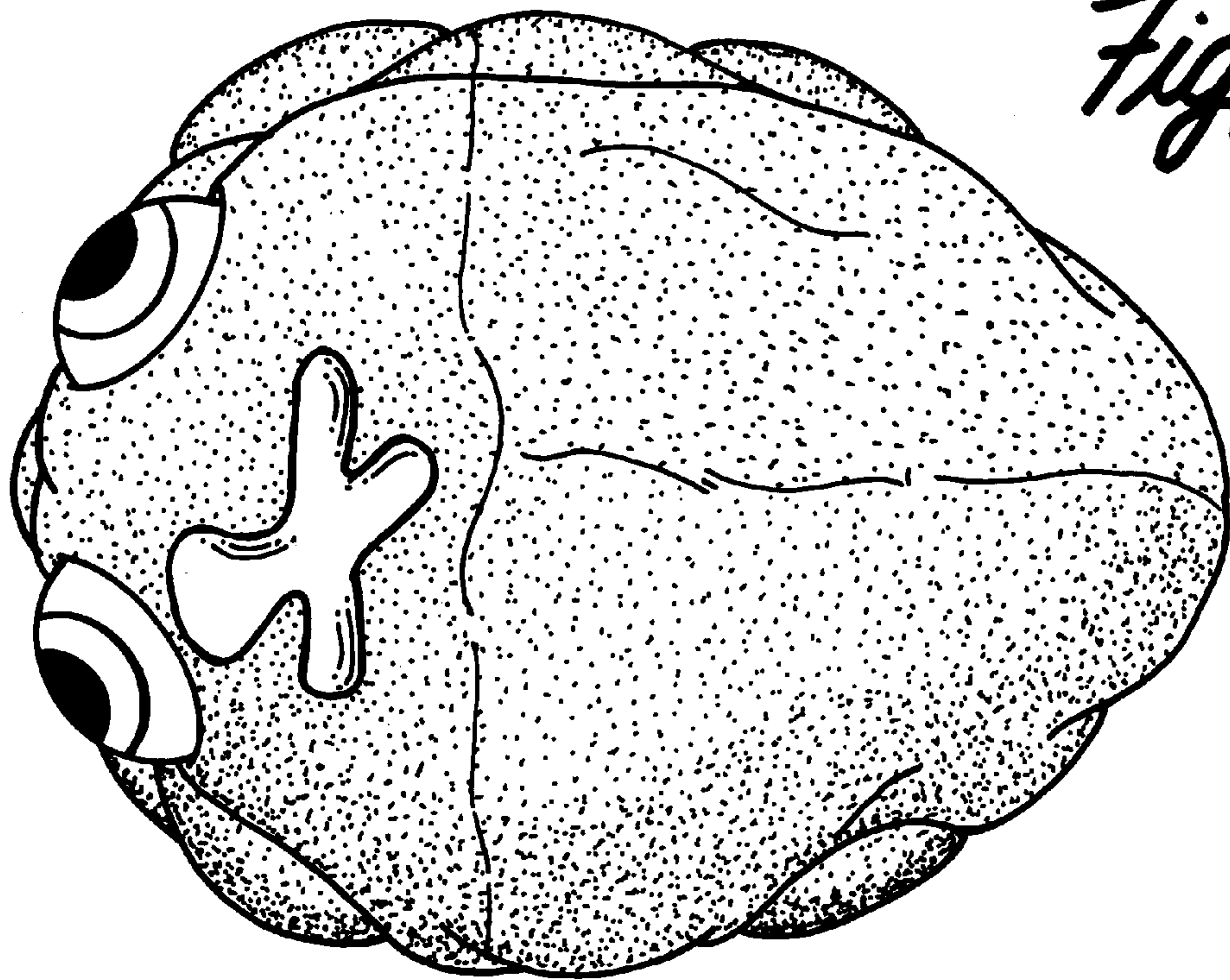

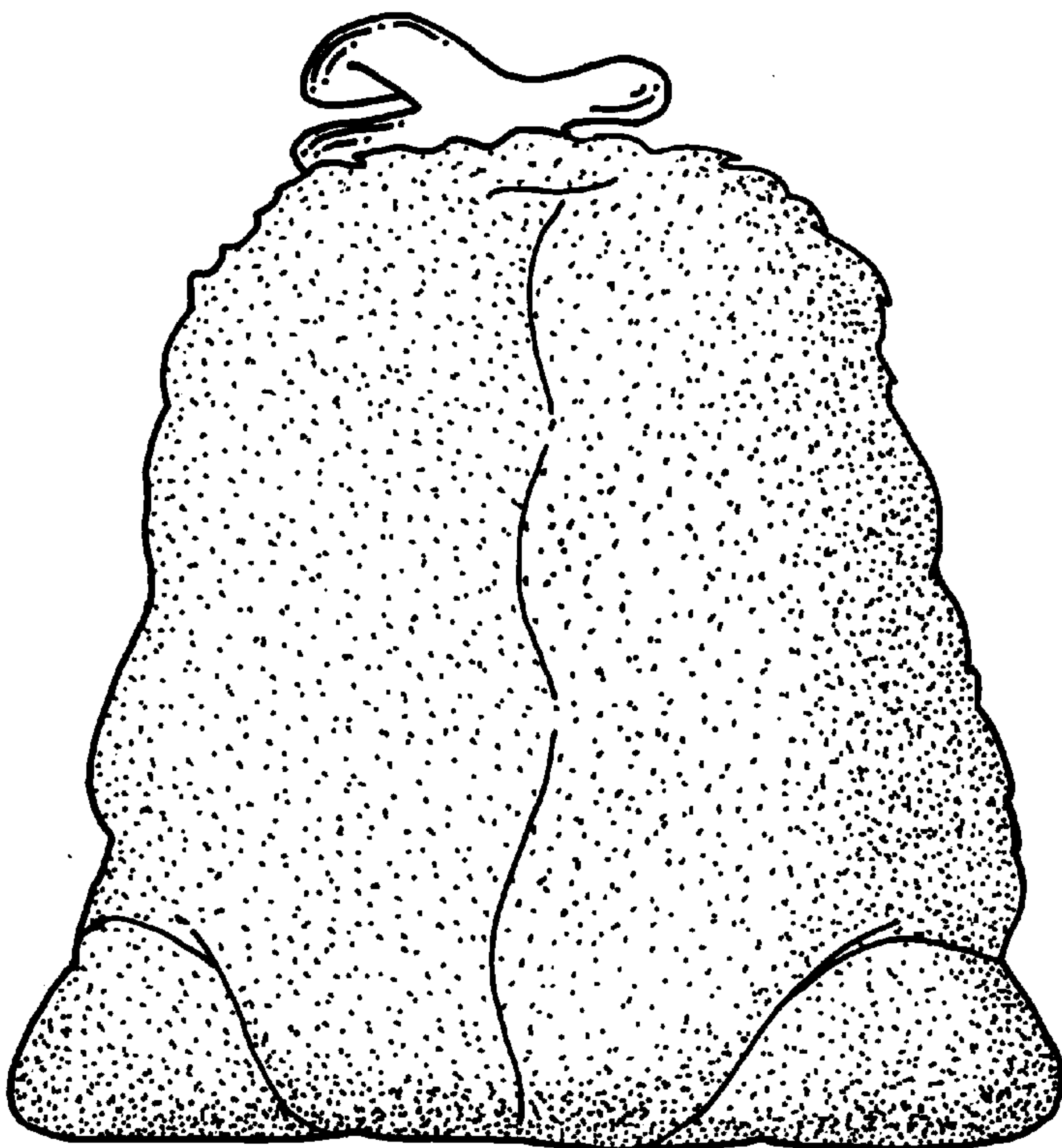

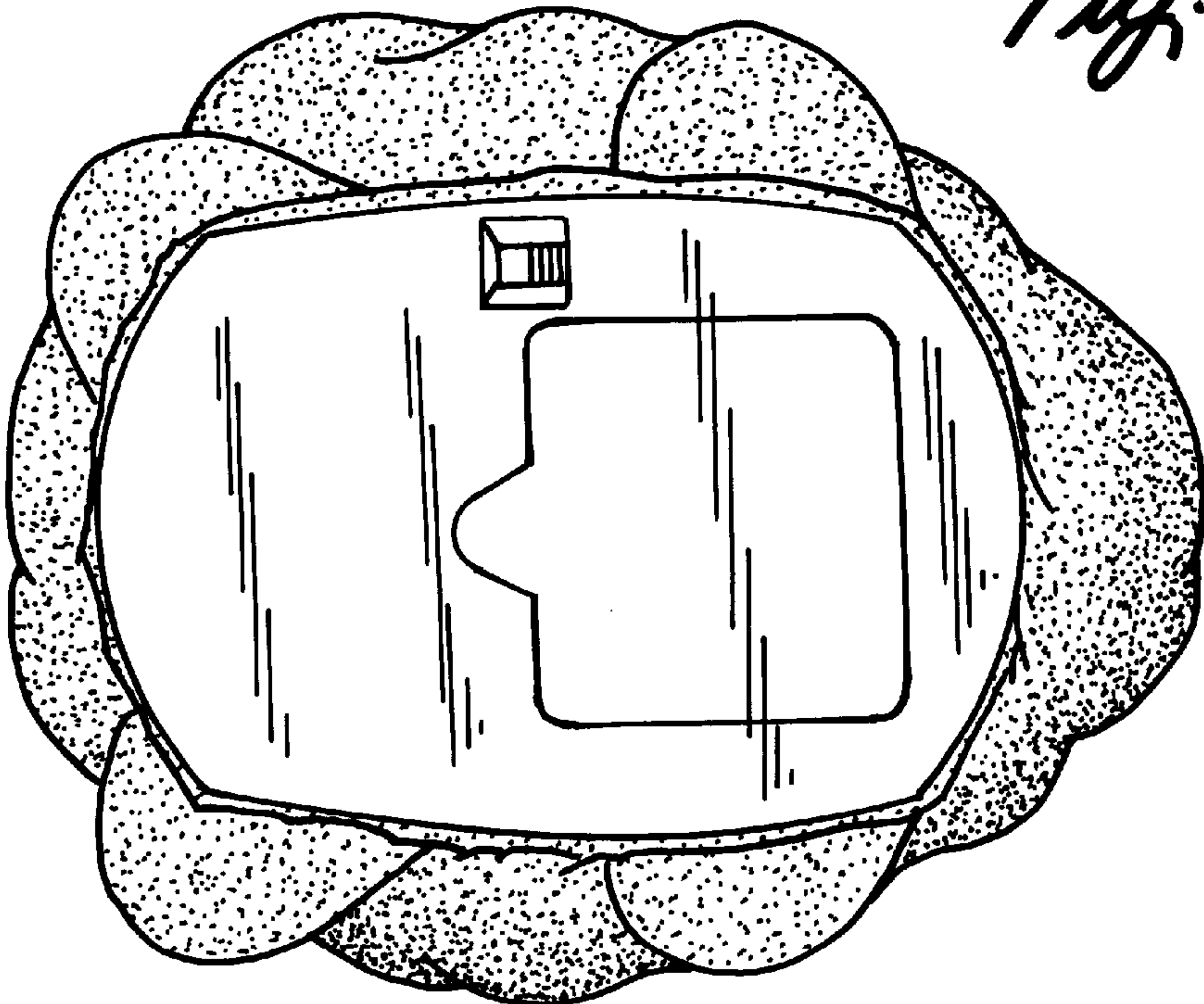

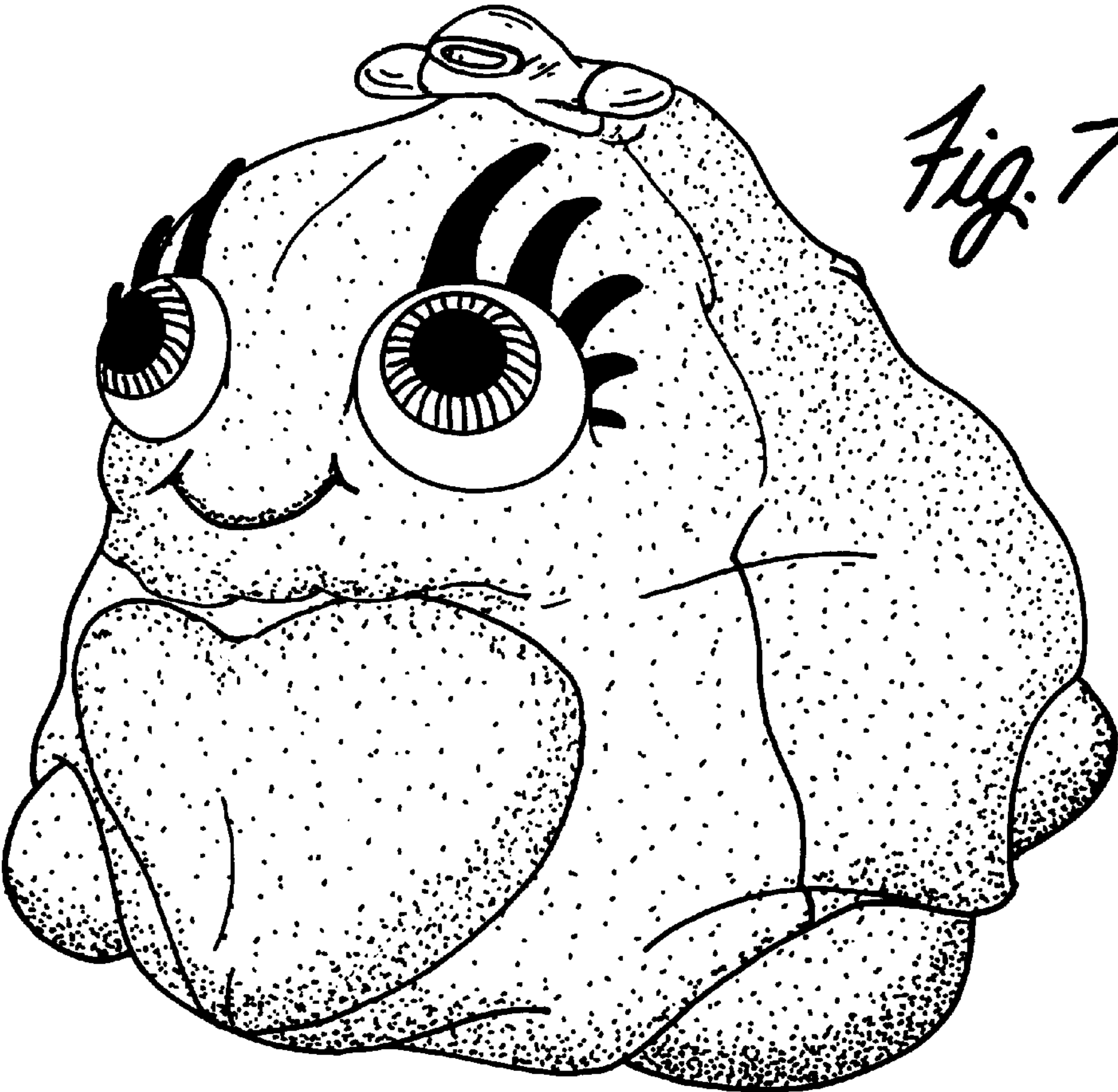

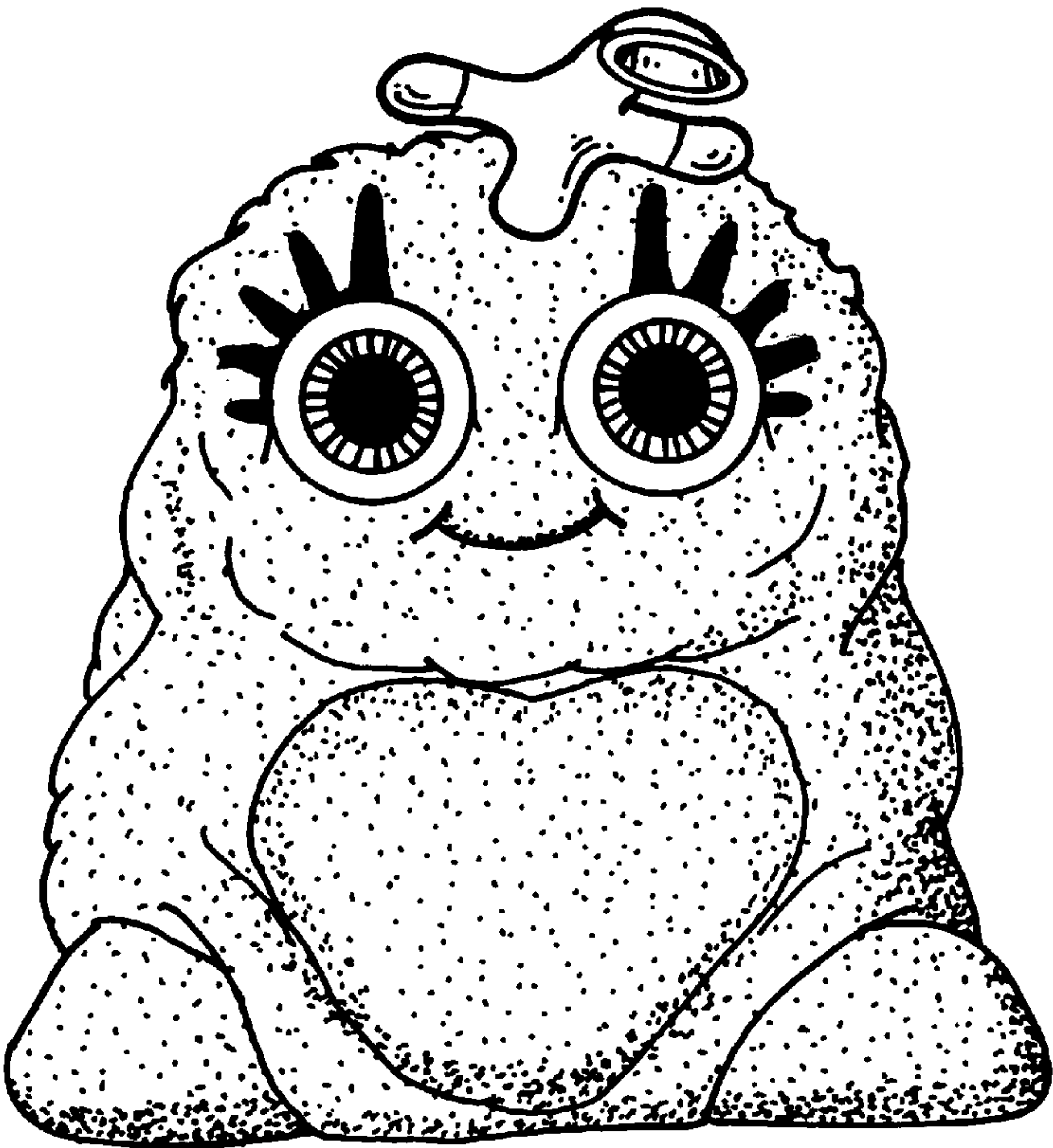

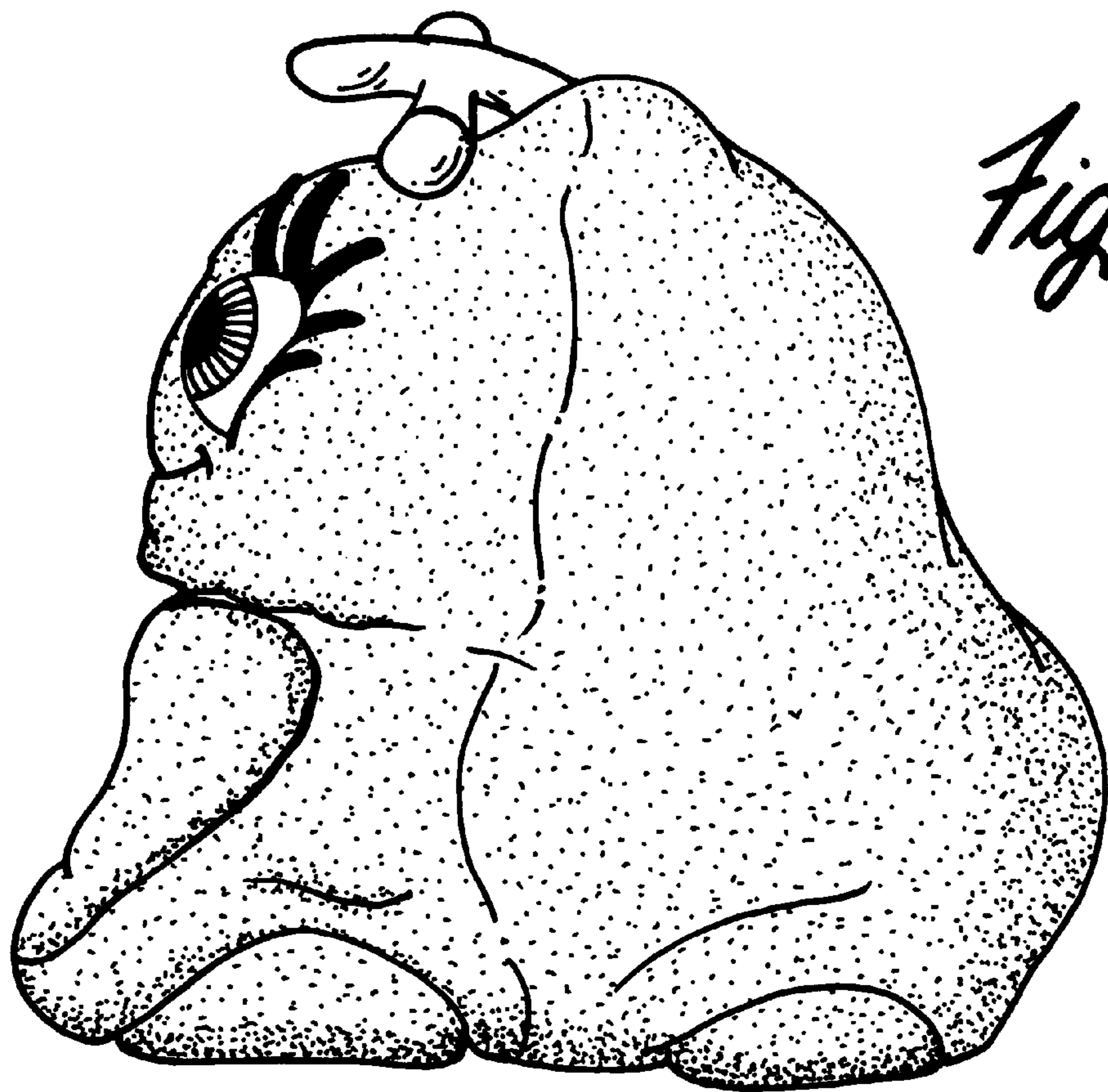

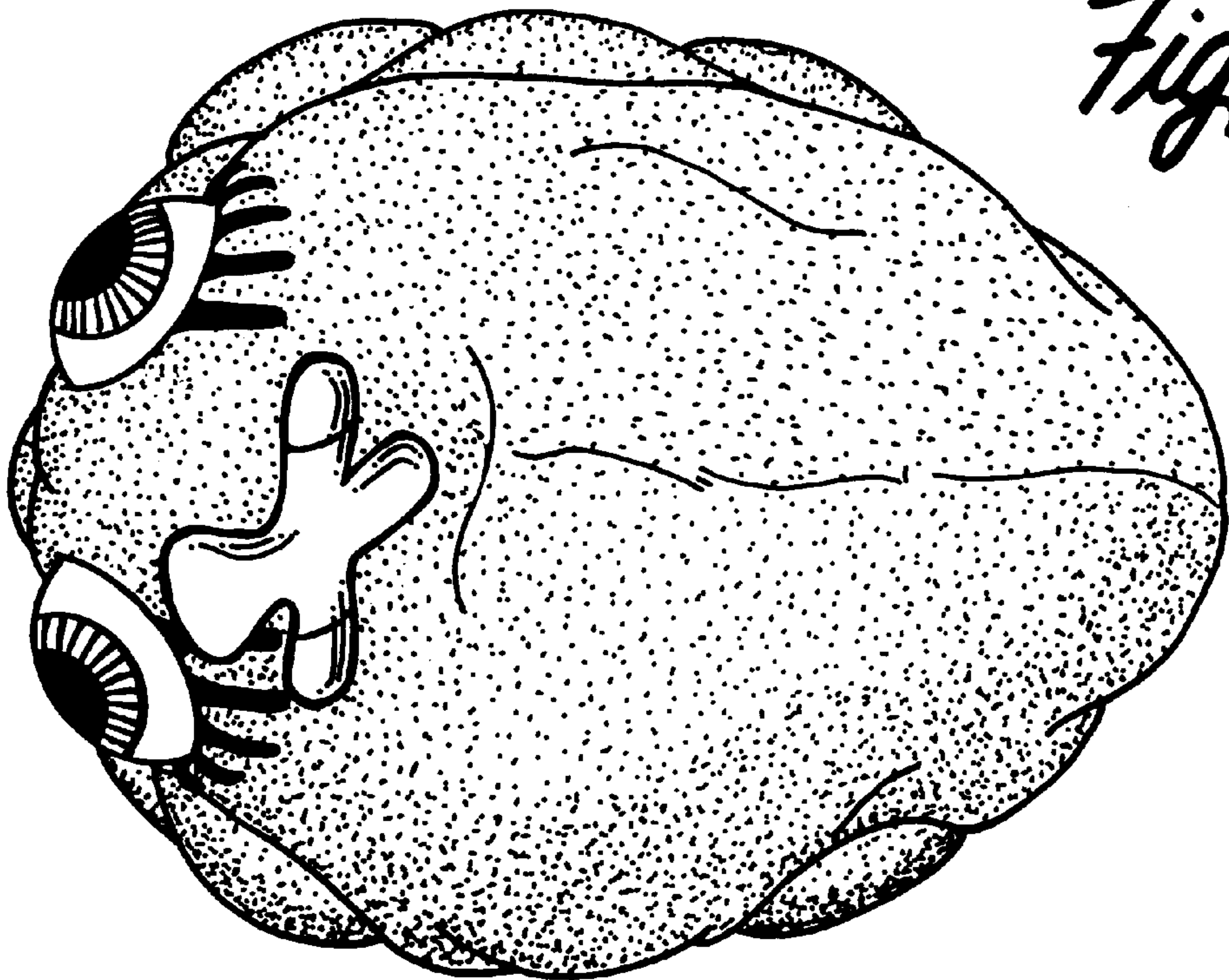

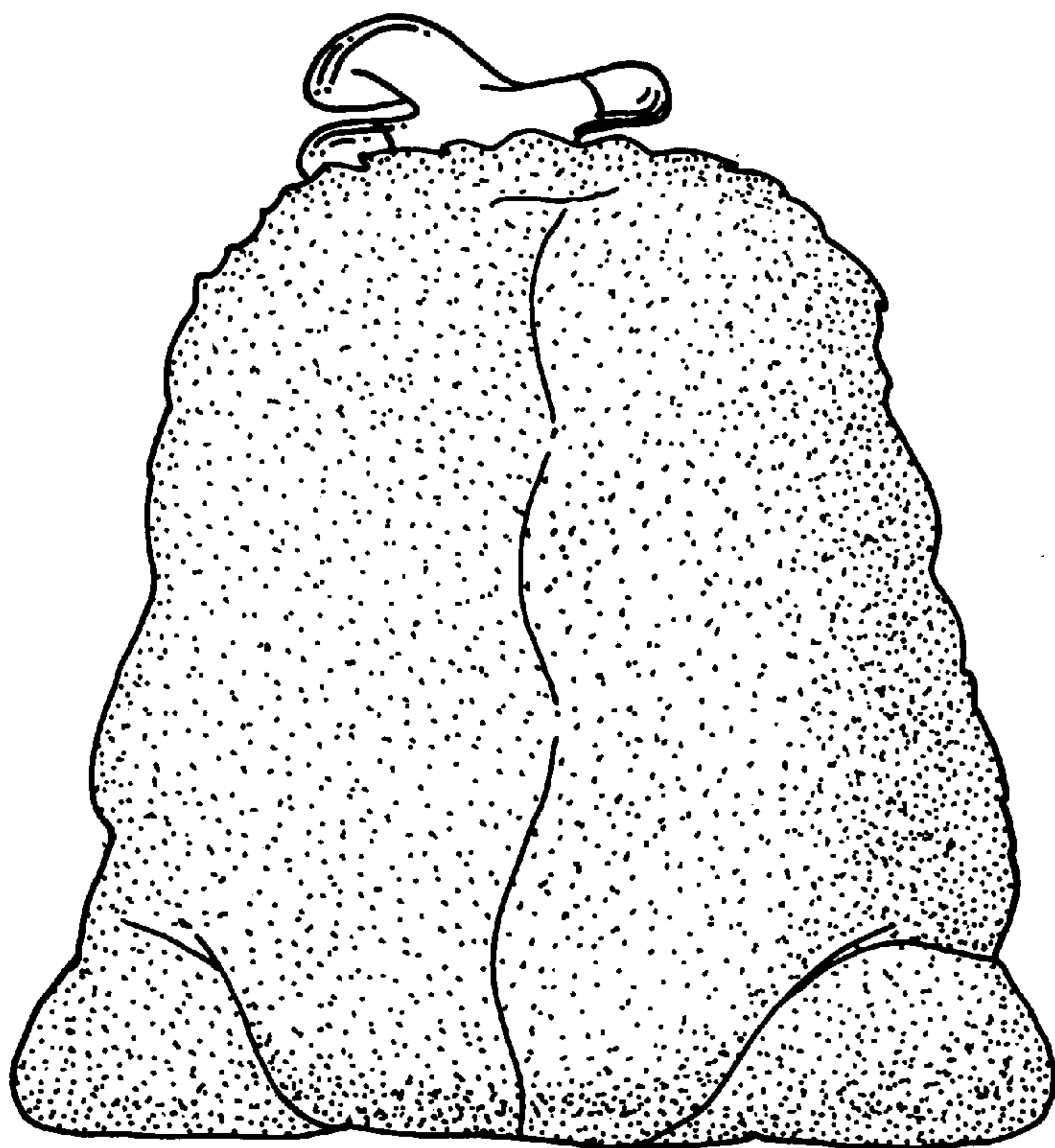

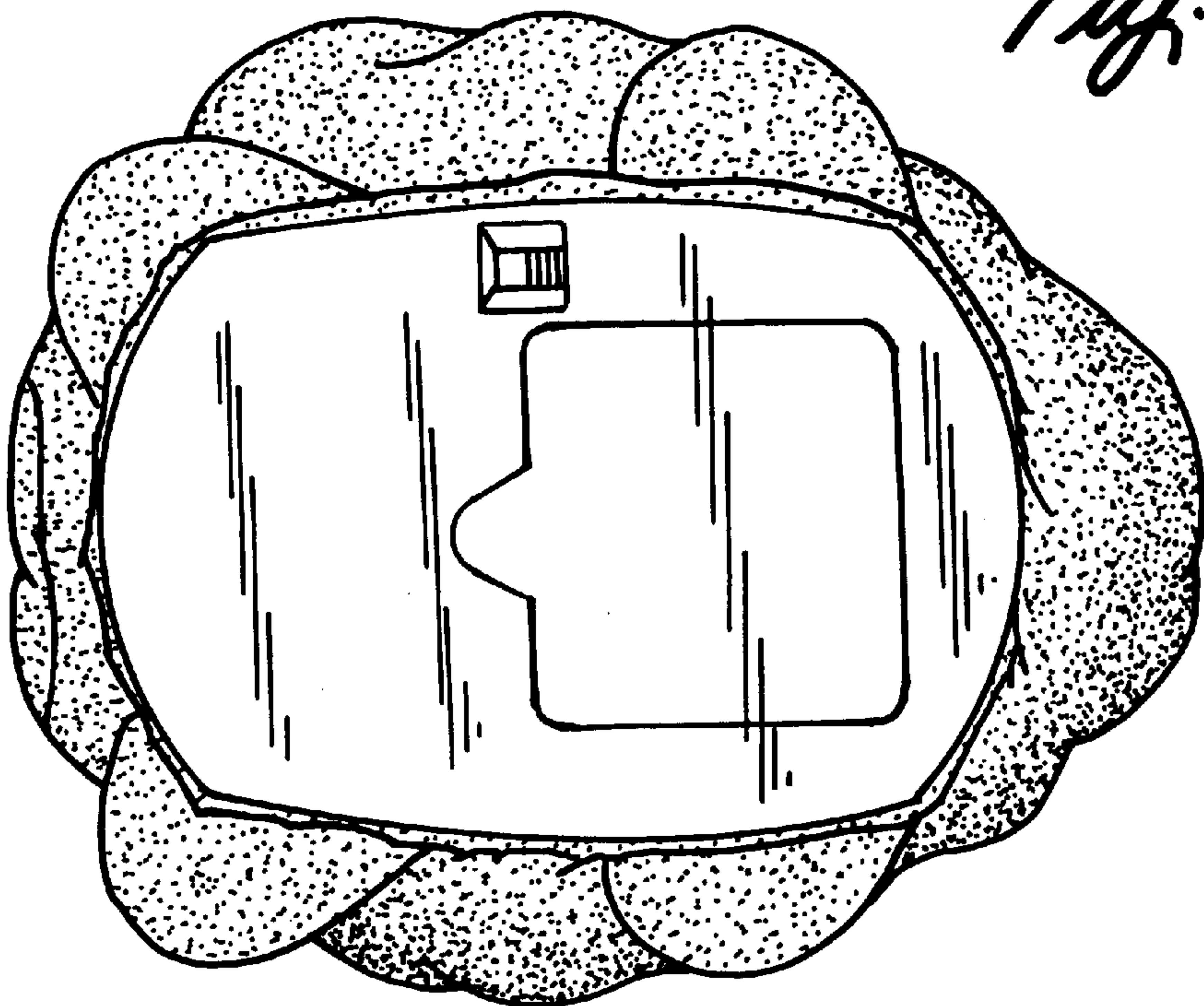
