(57) **CLAIM**

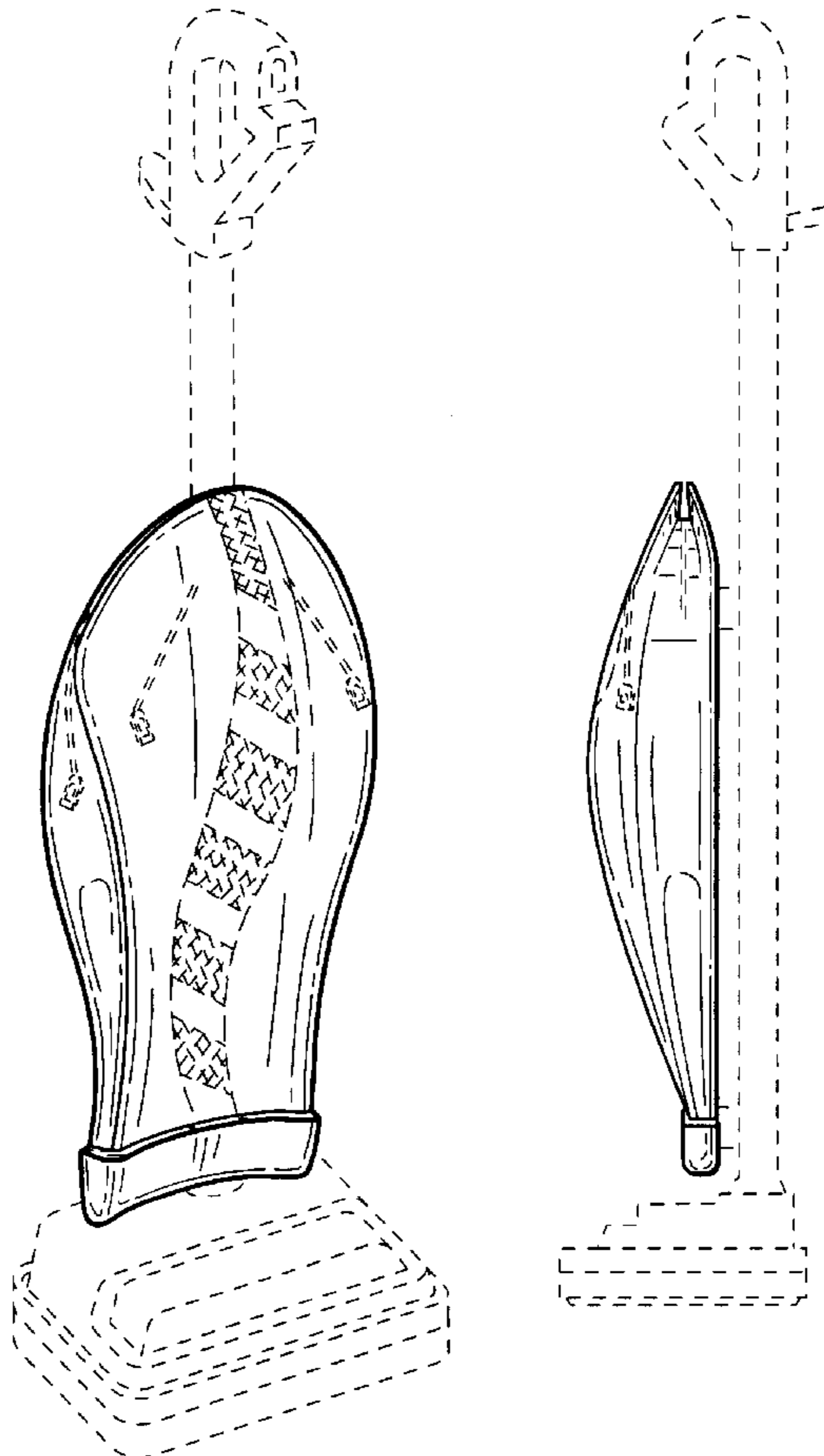
The ornamental design for a containment member for floor care apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a containment member for floor care apparatus showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a top plan view thereof.

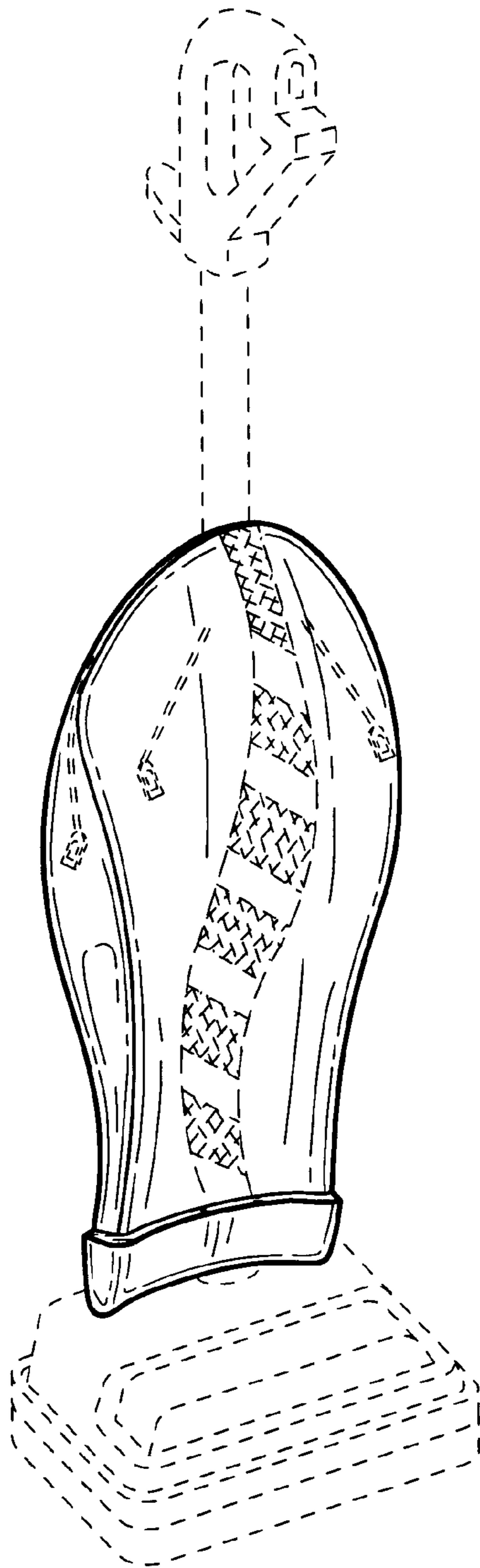

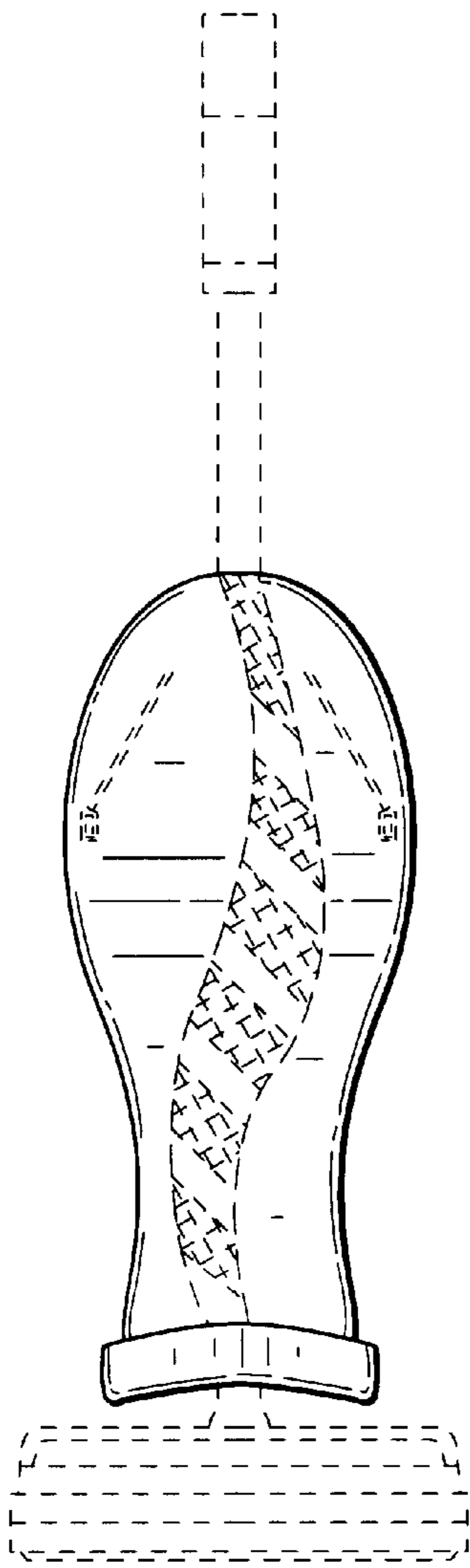

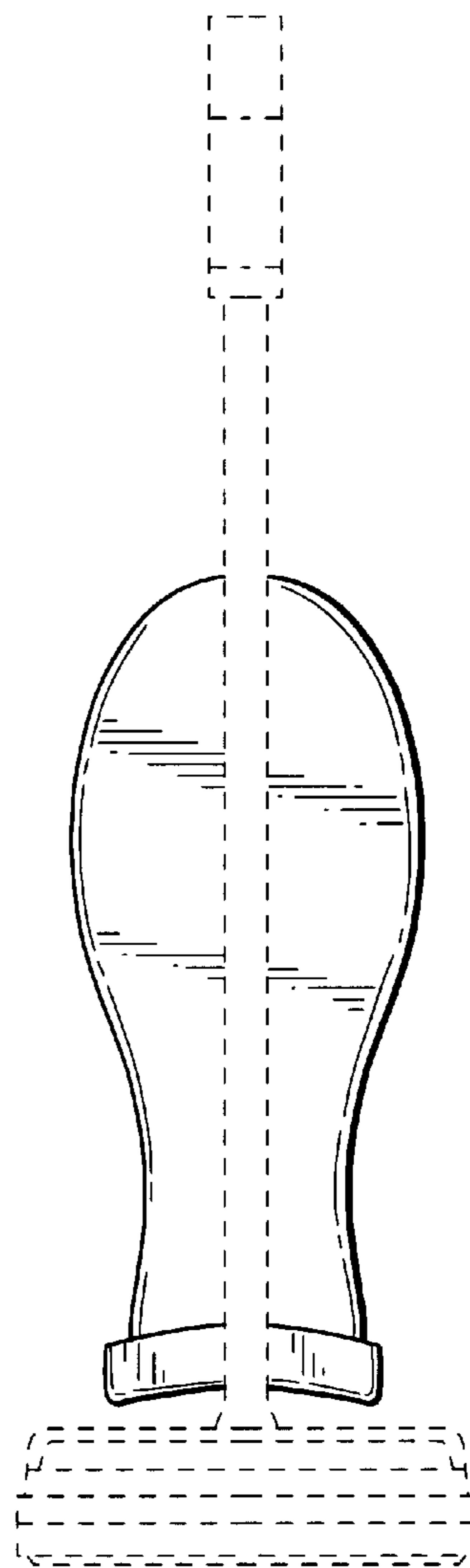

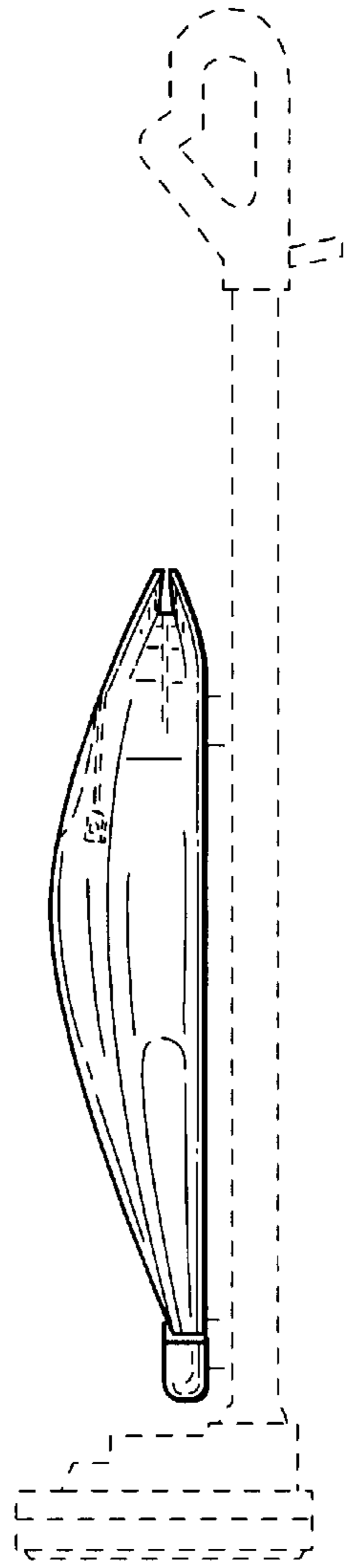

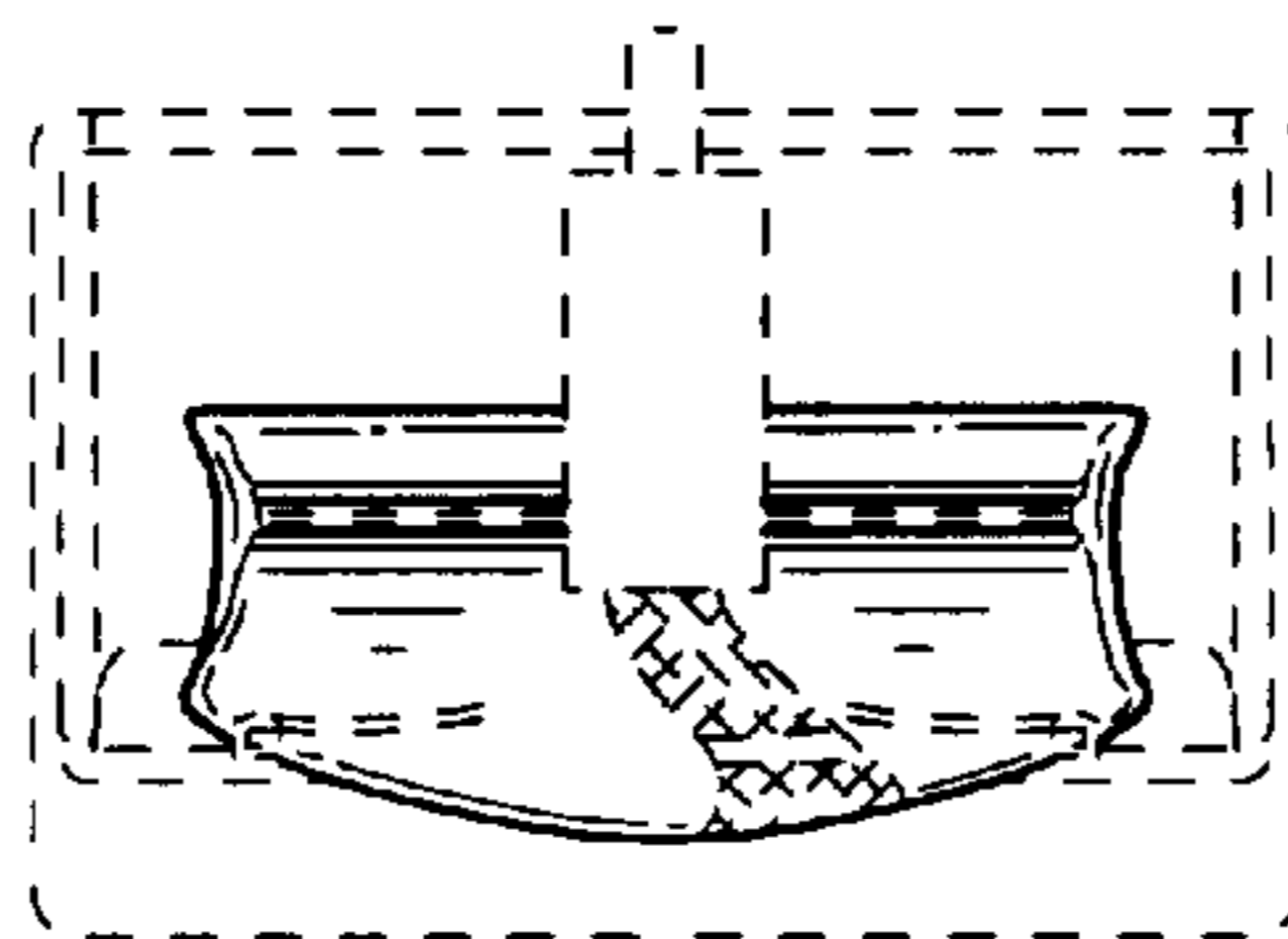
