**DESCRIPTION**

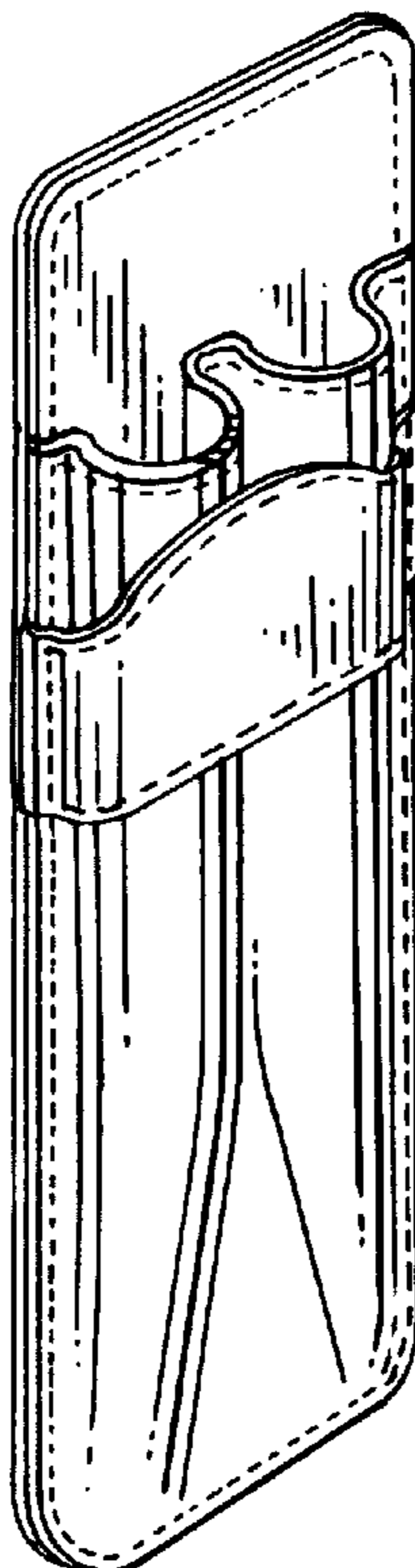

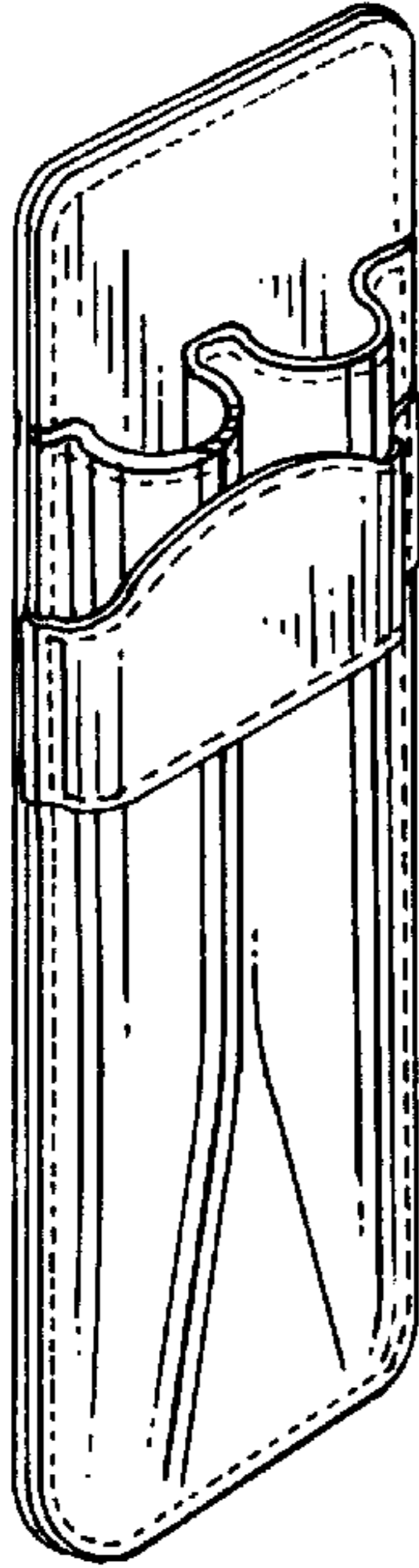

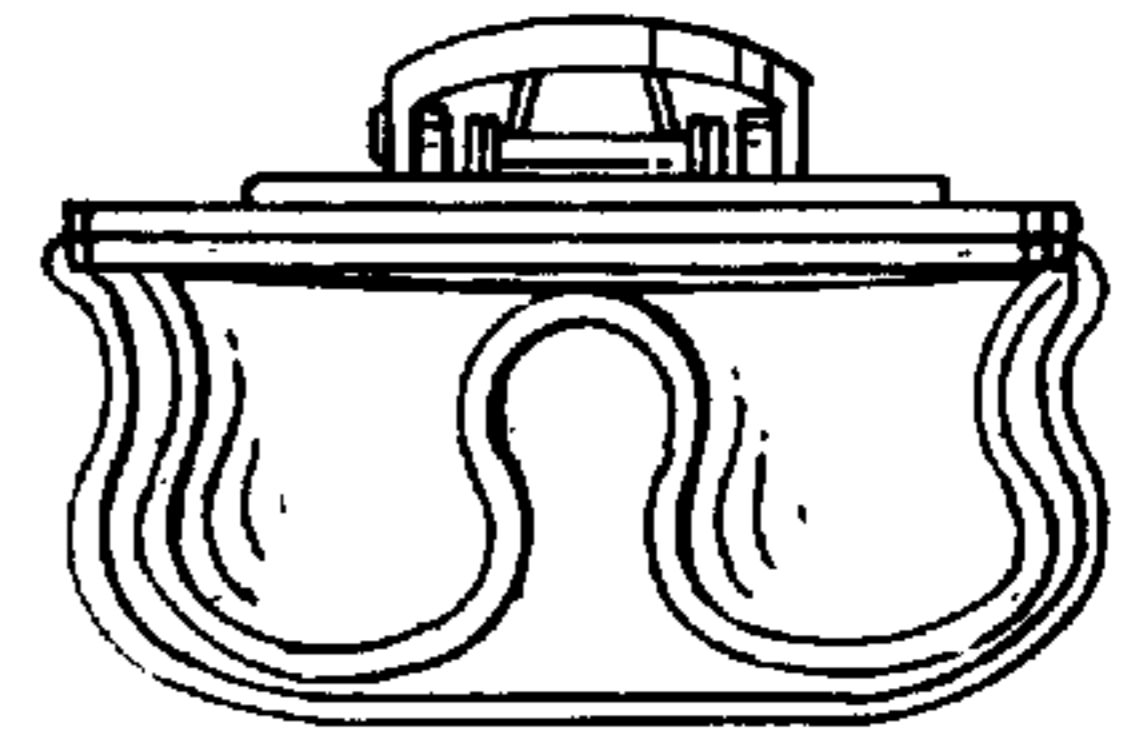

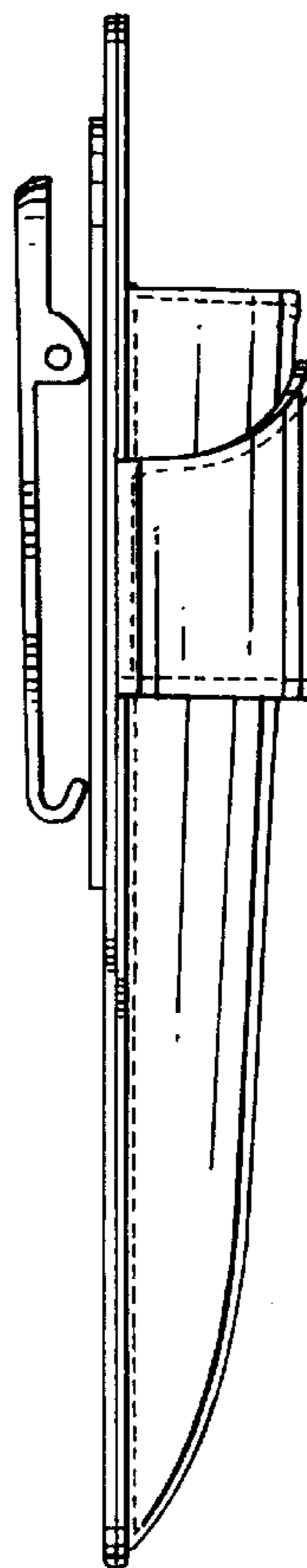

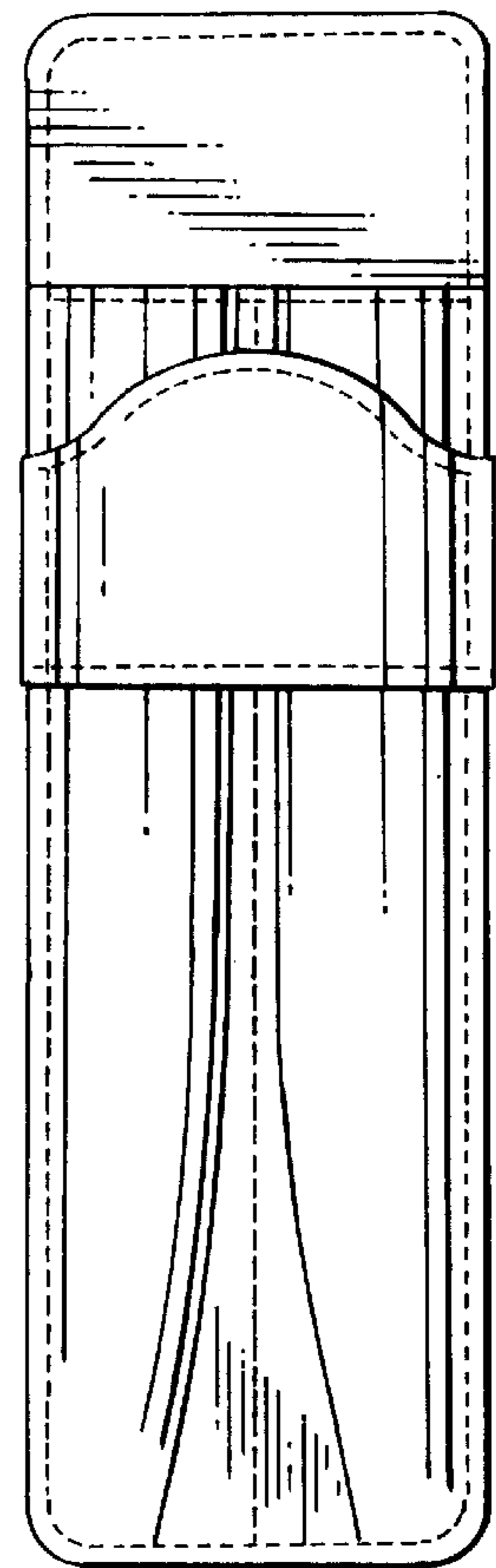

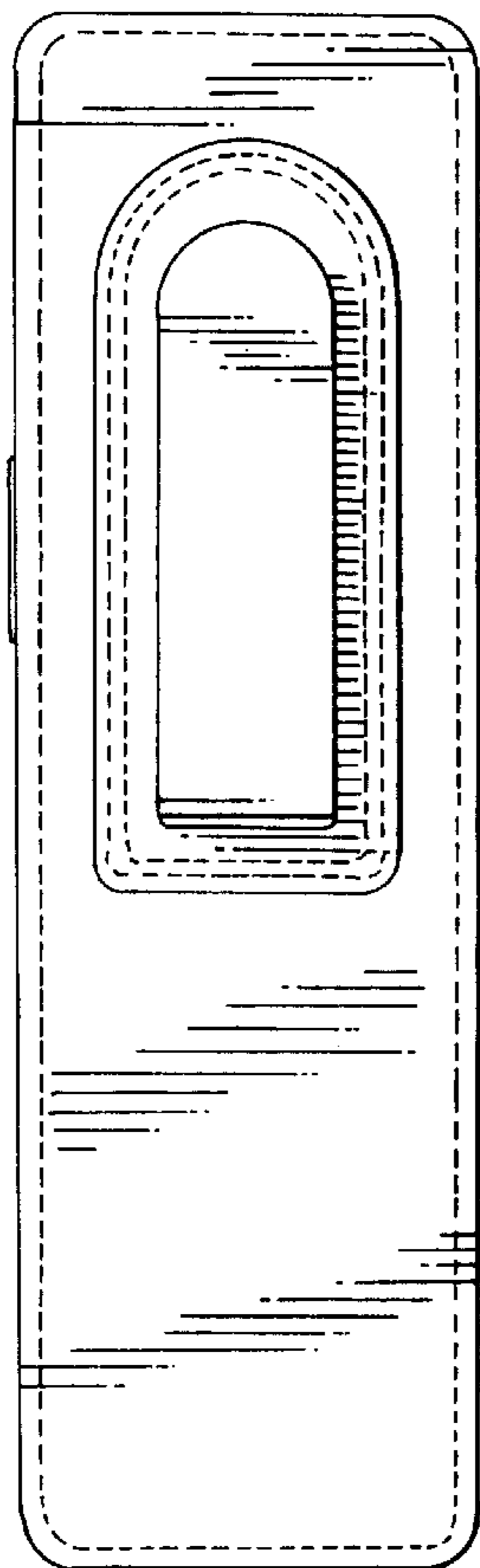

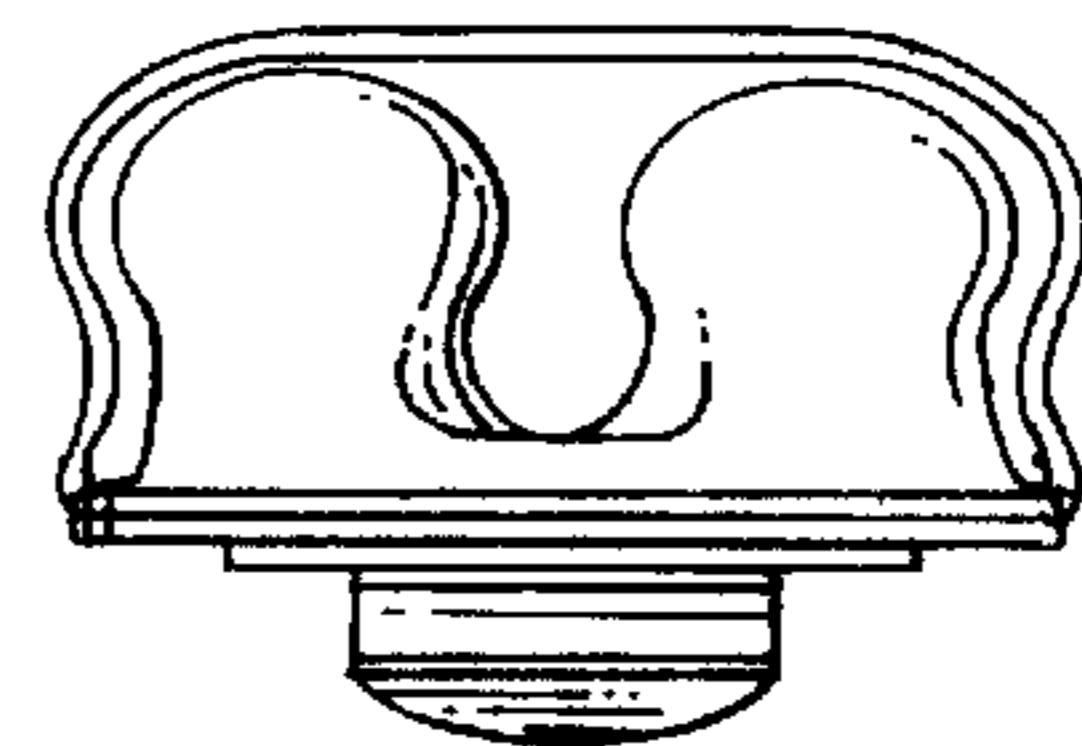

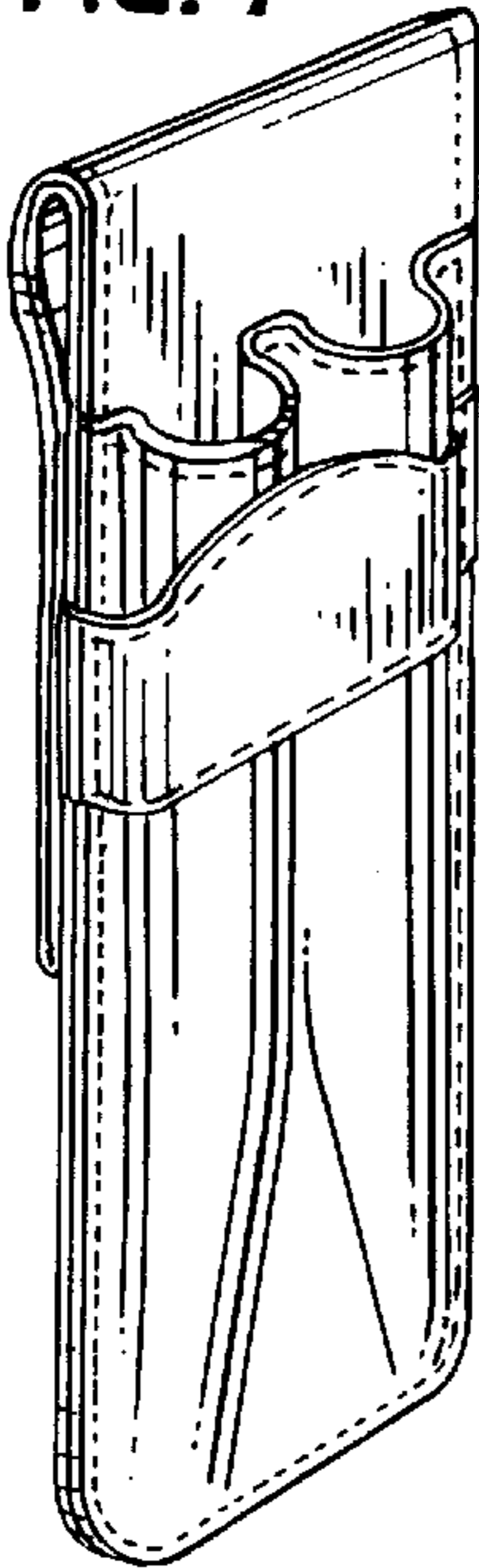

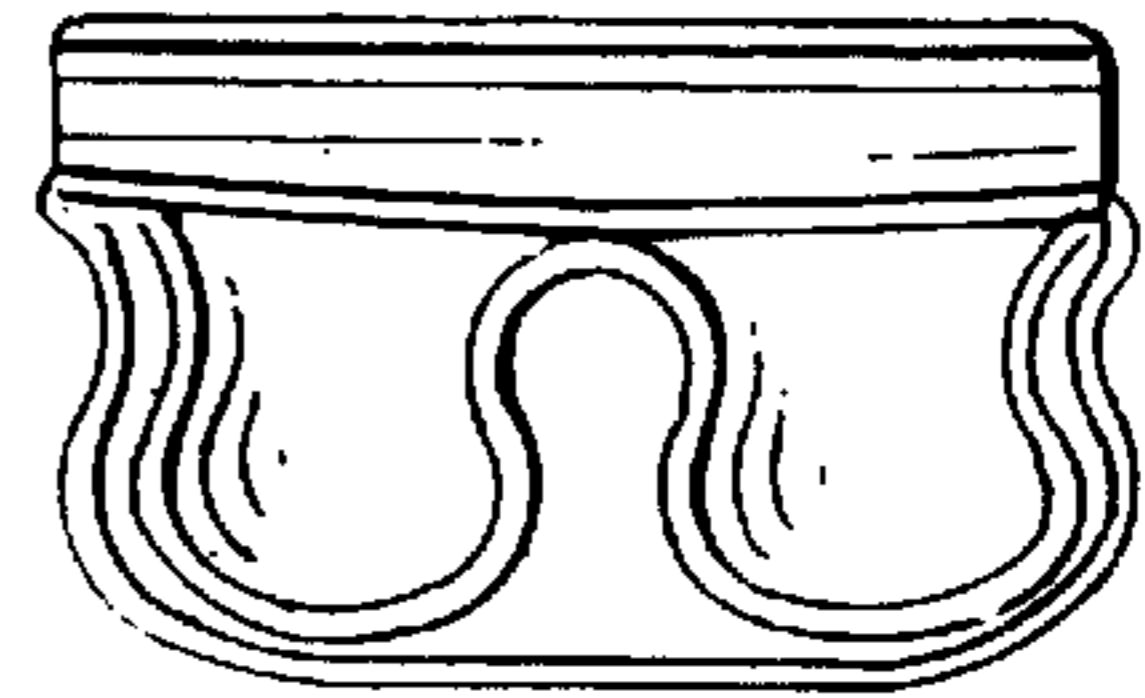

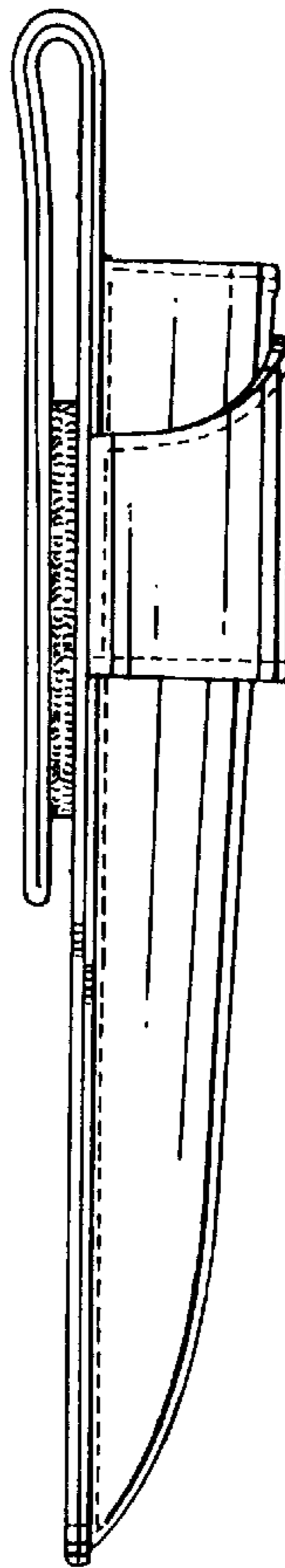

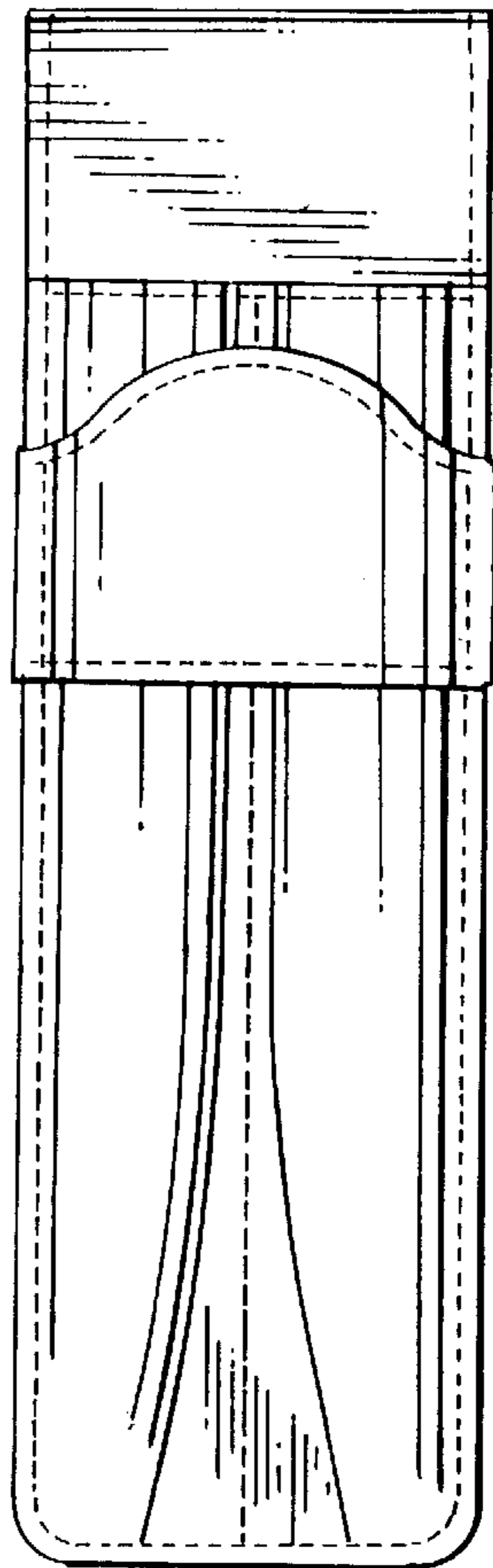

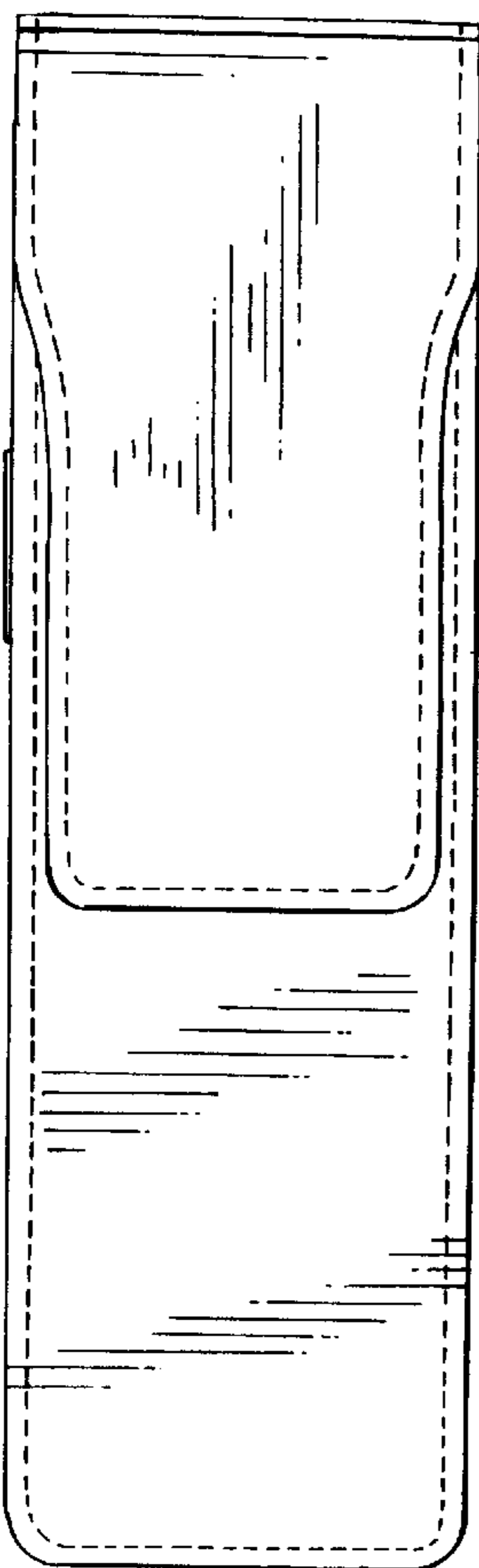
