I claim the ornamental design for a gravity feed shelf for a merchandiser, as shown and described.

DESCRIPTION

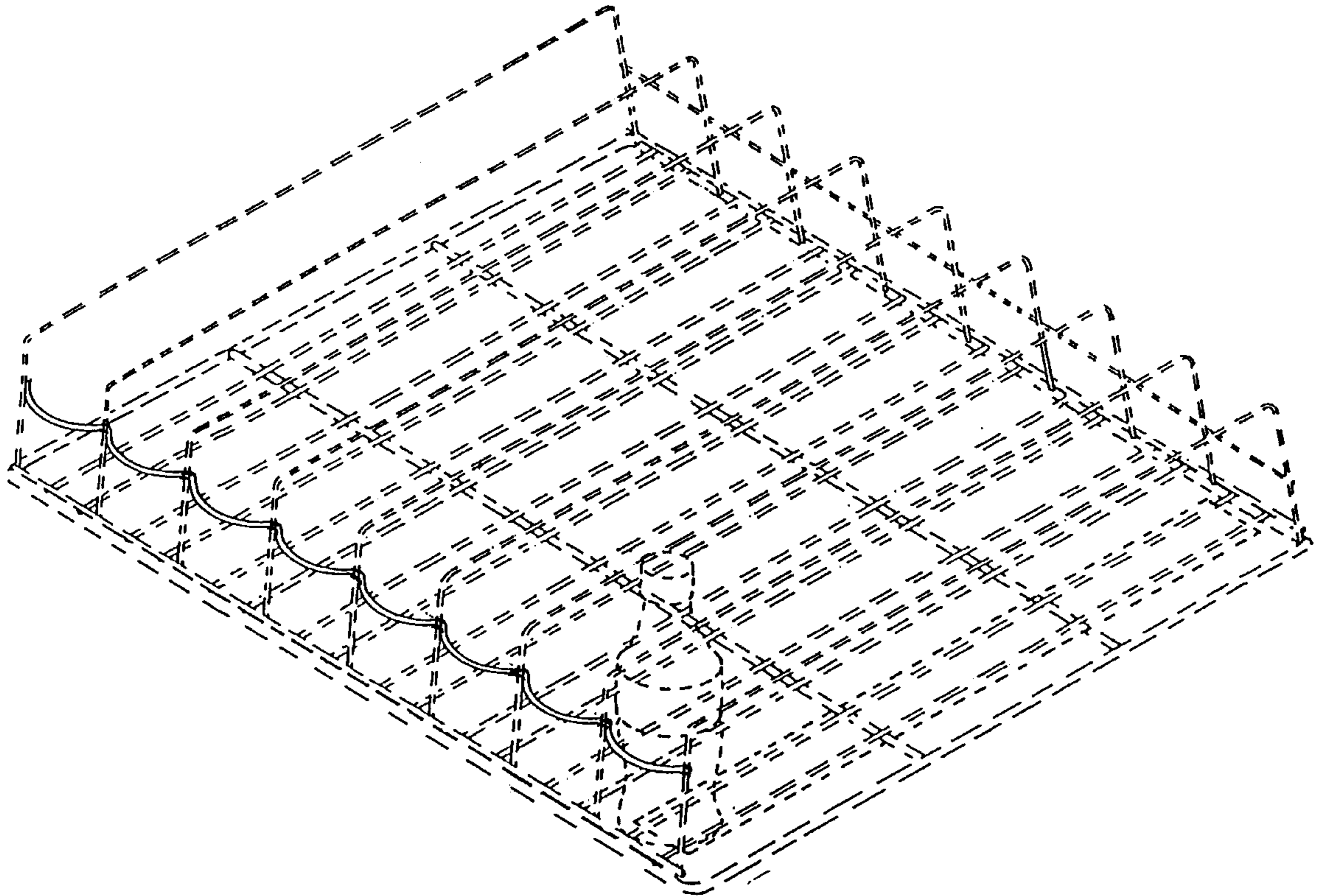
FIG. 1 is a perspective view of an element of a gravity feed shelf, the broken line showing is for illustrative purposes only and forms no part of the design;

 FIG. 4 is a right side elevational view of FIG. 1, the left side elevational view of FIG. 1 being in mirror image thereof;

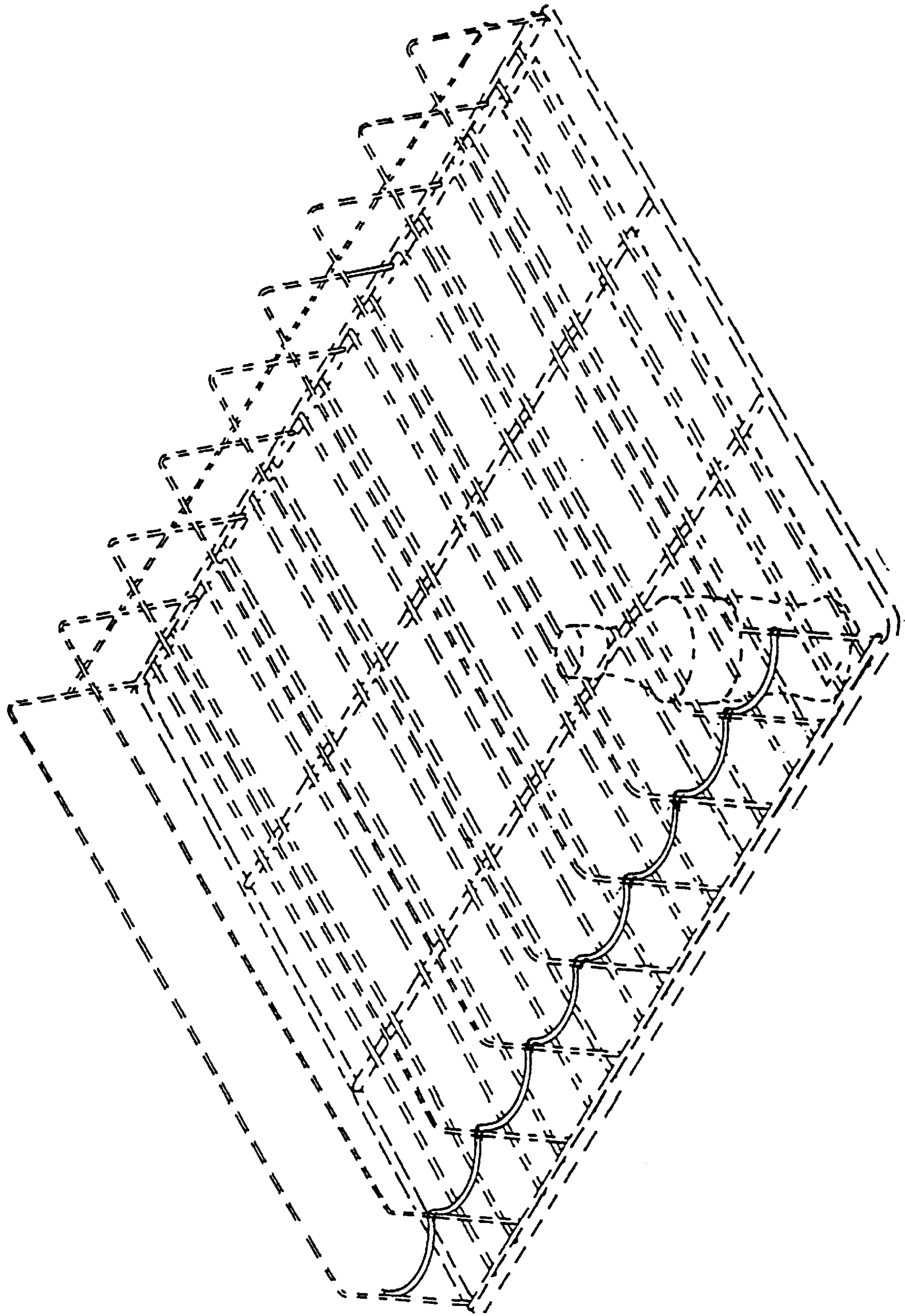

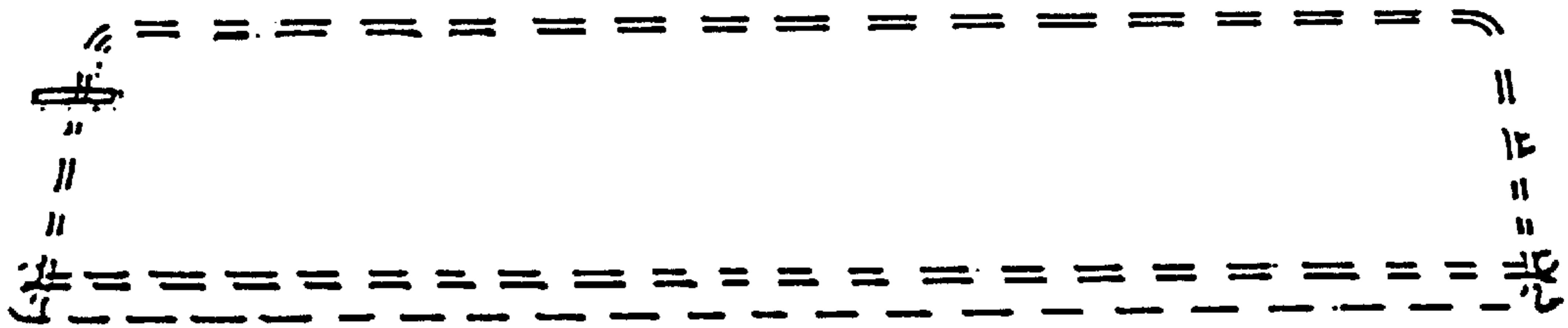

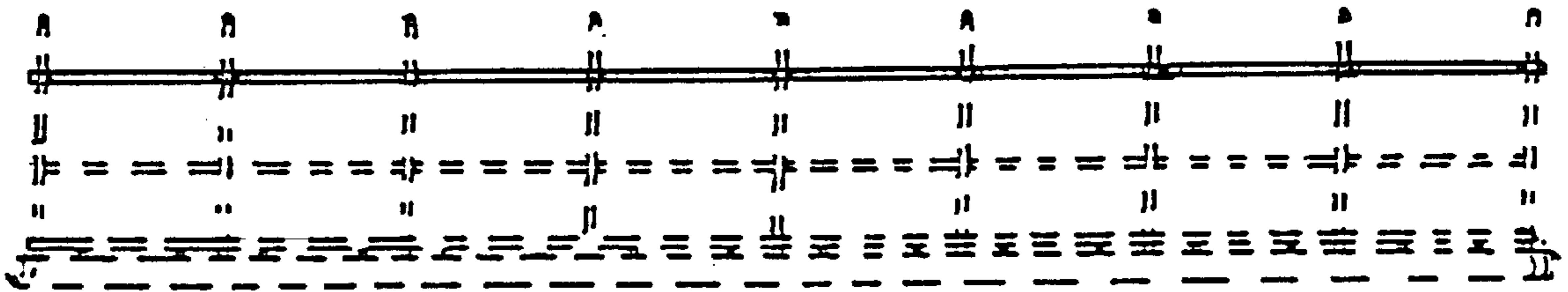

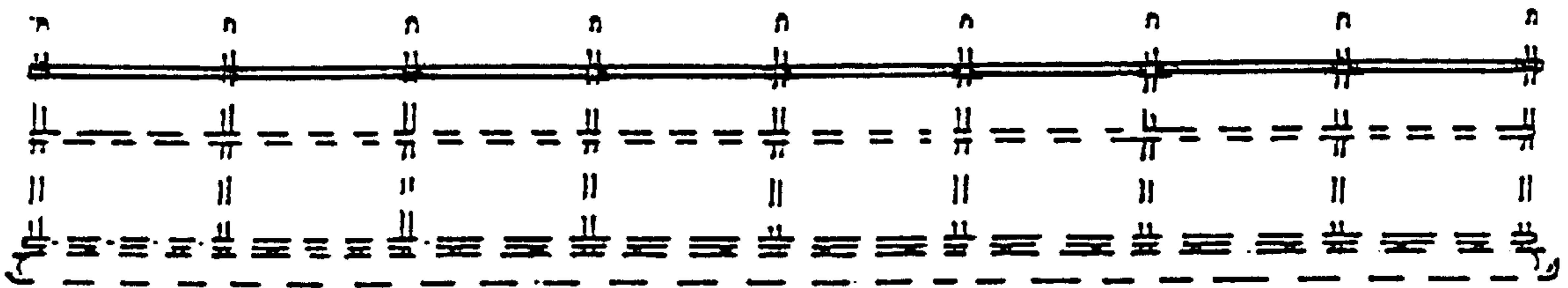

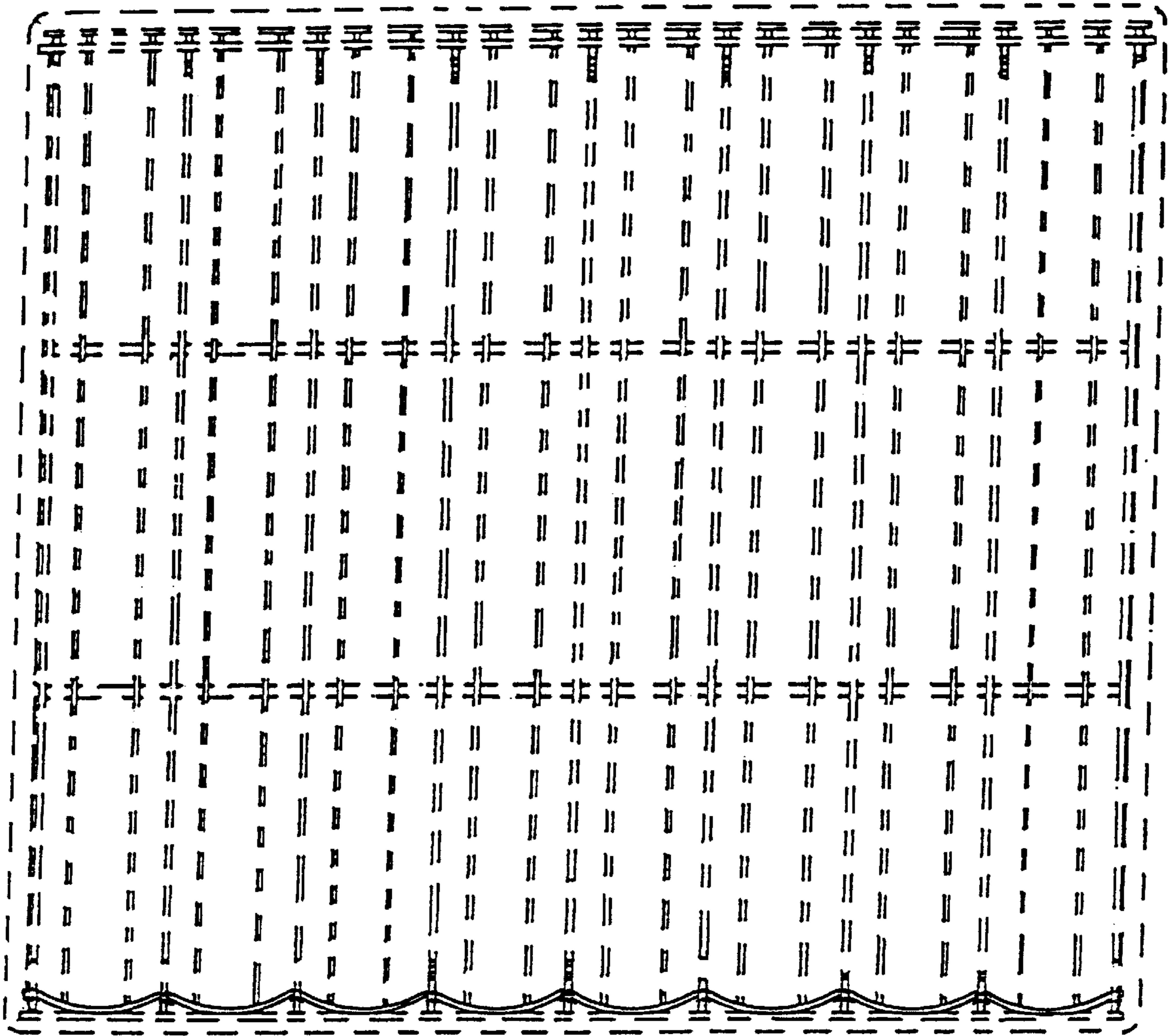

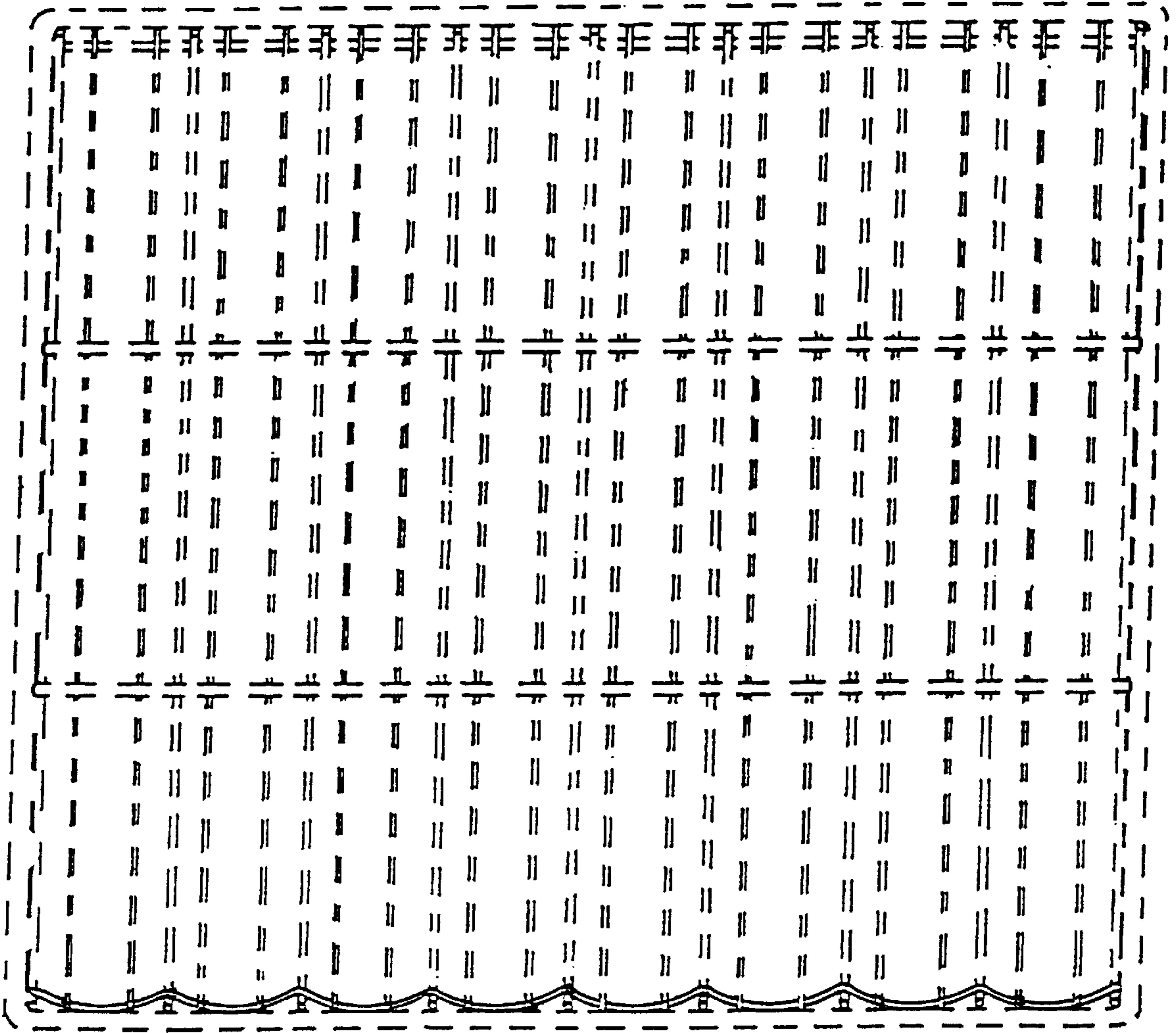
