FIG. 1 is a front perspective view of the plastic bag carrying handle with a bag shown in dotted lines for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear side elevational view thereof; FIG. 4 is a left side elevational view thereof with the right side elevational view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a front elevational view of the plastic bag carrying handle in a folded orientation; FIG. 8 is a rear side elevational view of the plastic bag carrying handle in a folded orientation; FIG. 9 is a left side elevational view of the plastic bag carrying handle in a folded orientation with the right side elevational view being a mirror image thereof; FIG. 10 is a top plan view of the plastic bag carrying handle in a folded orientation; and, FIG. 11 is a bottom plan view of the plastic bag carrying handle in a folded orientation.

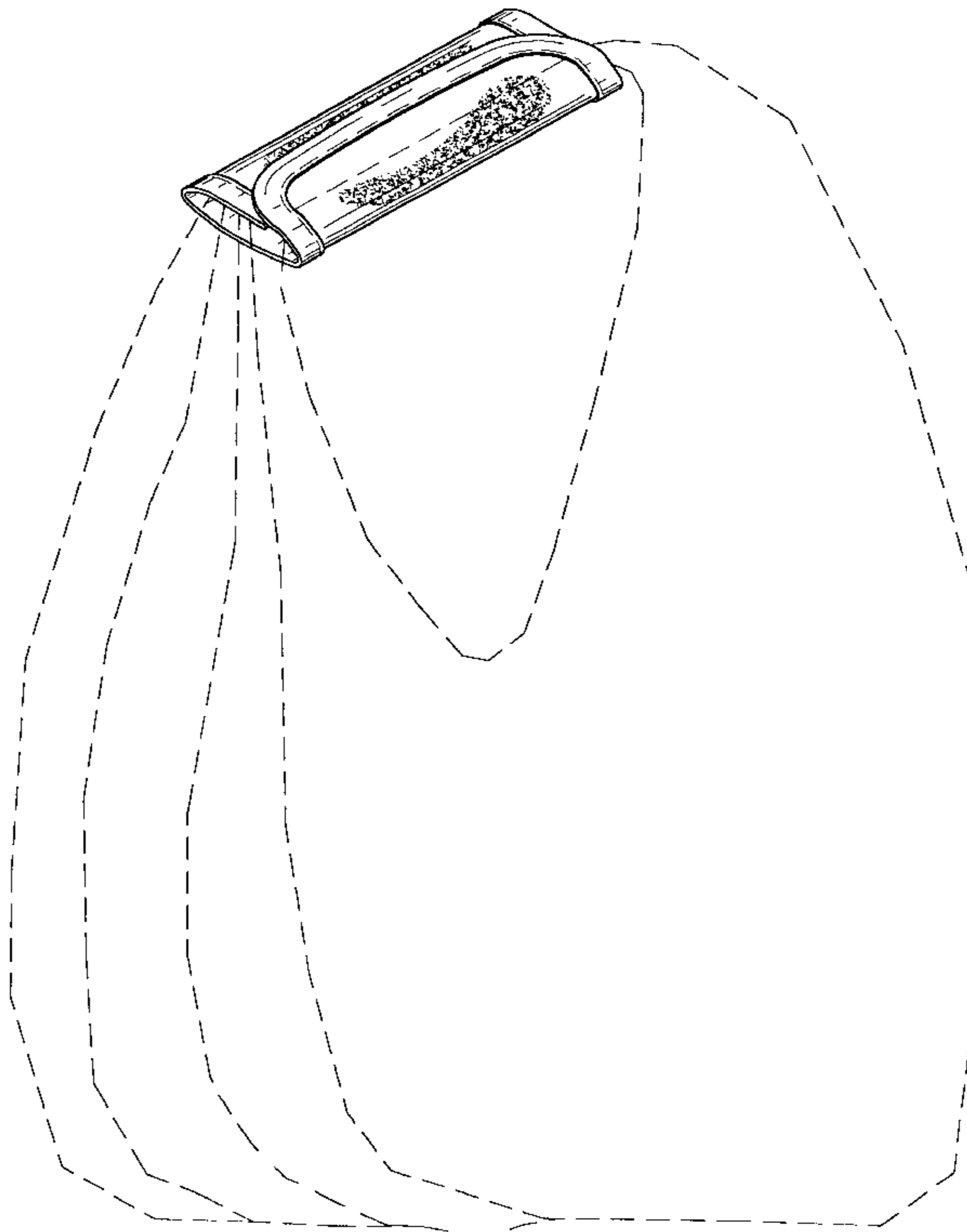

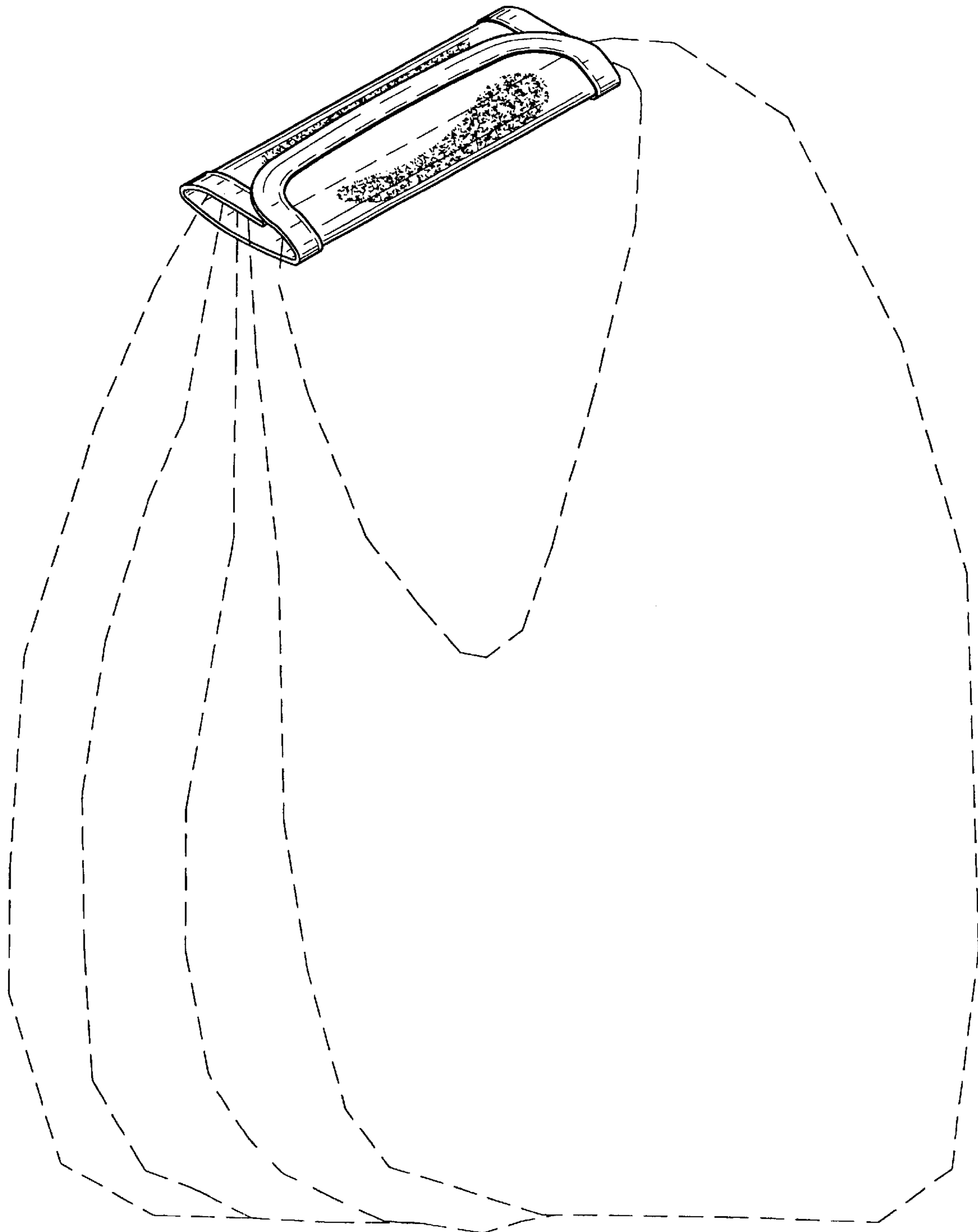

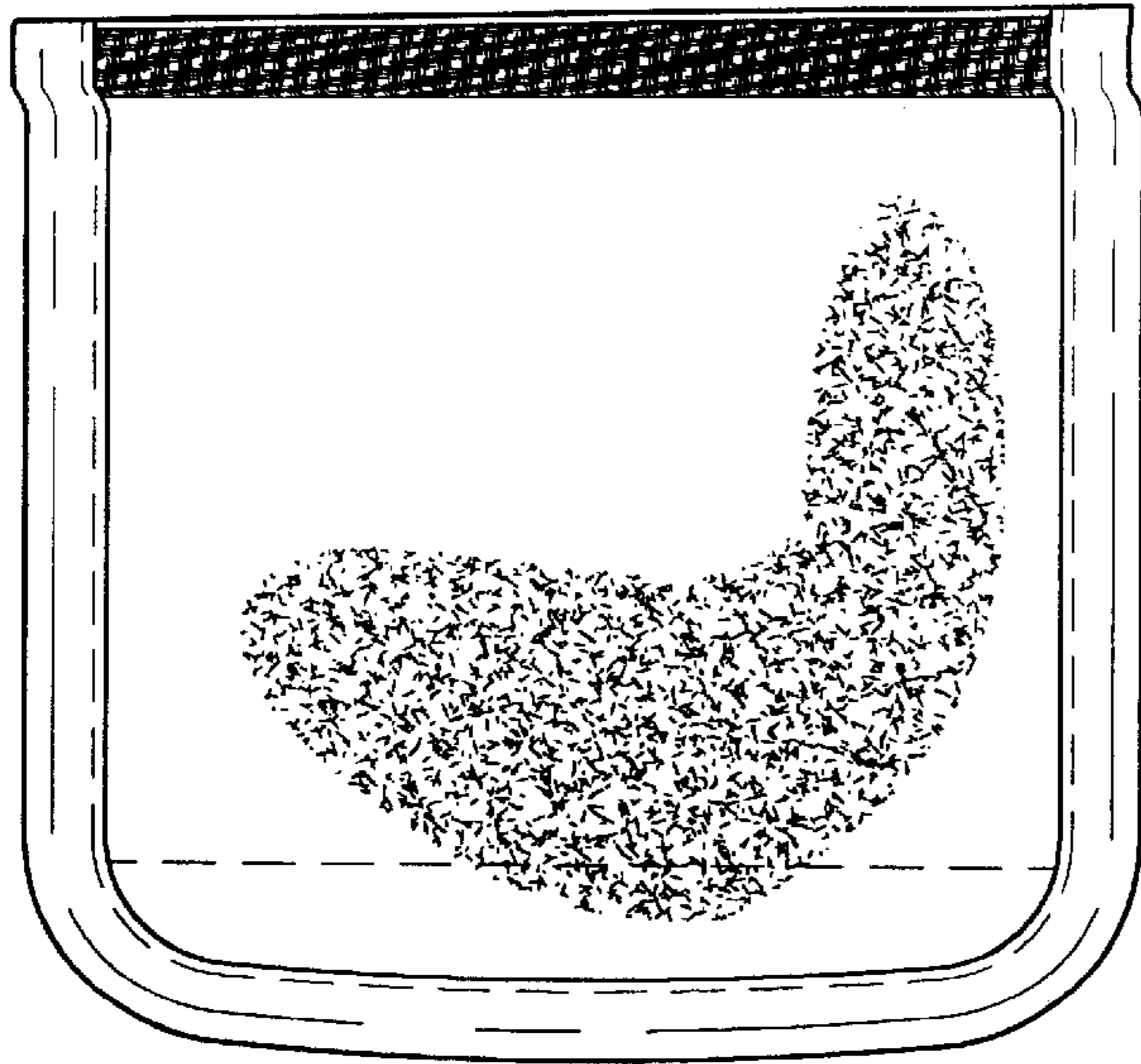

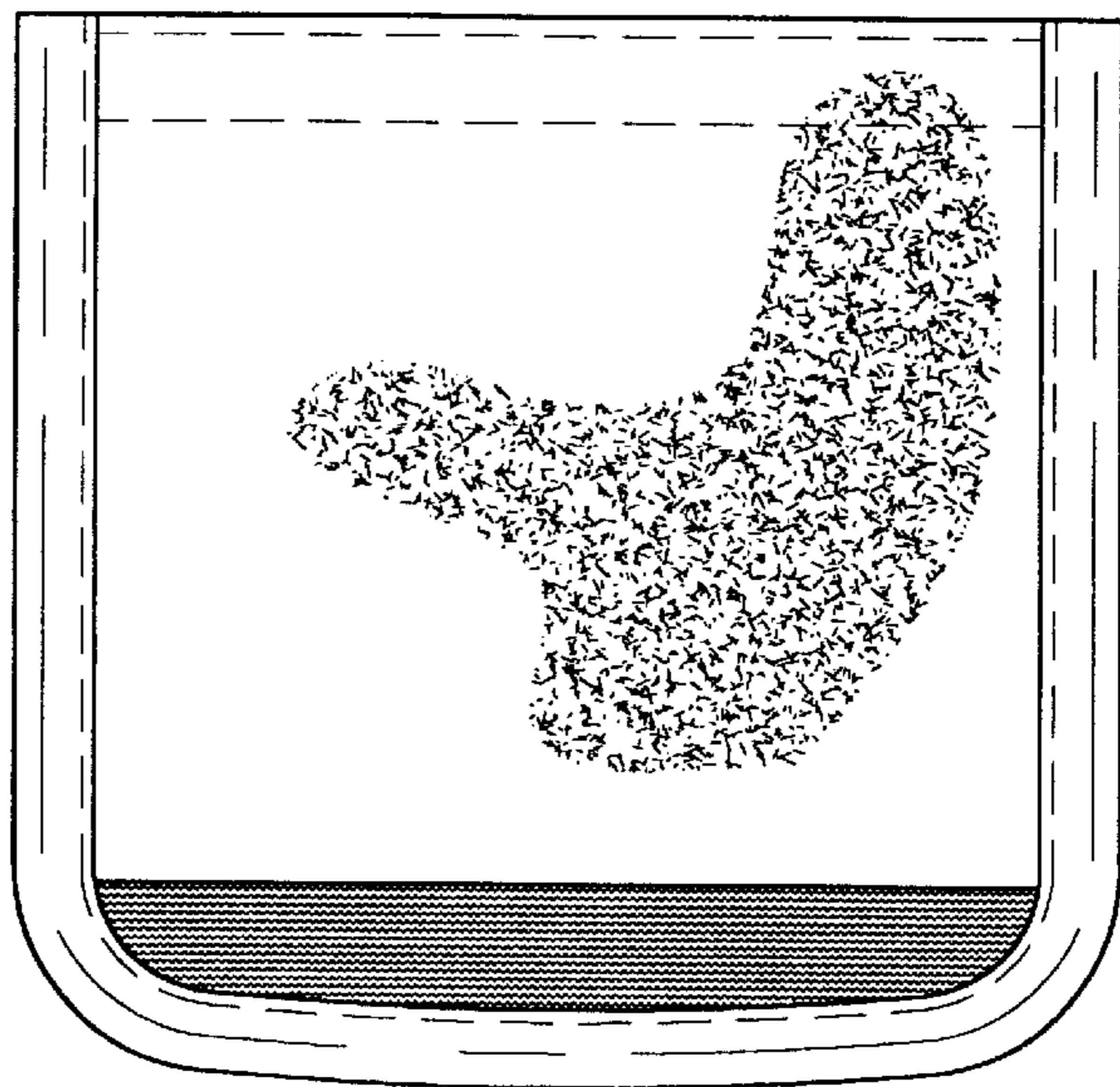

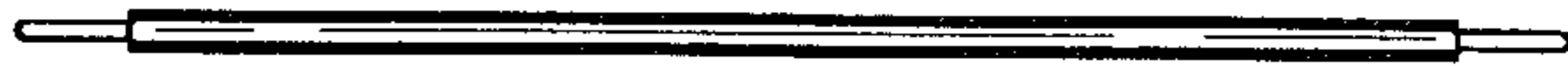

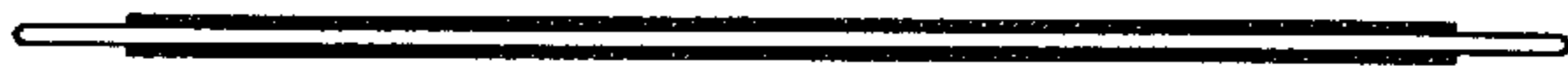

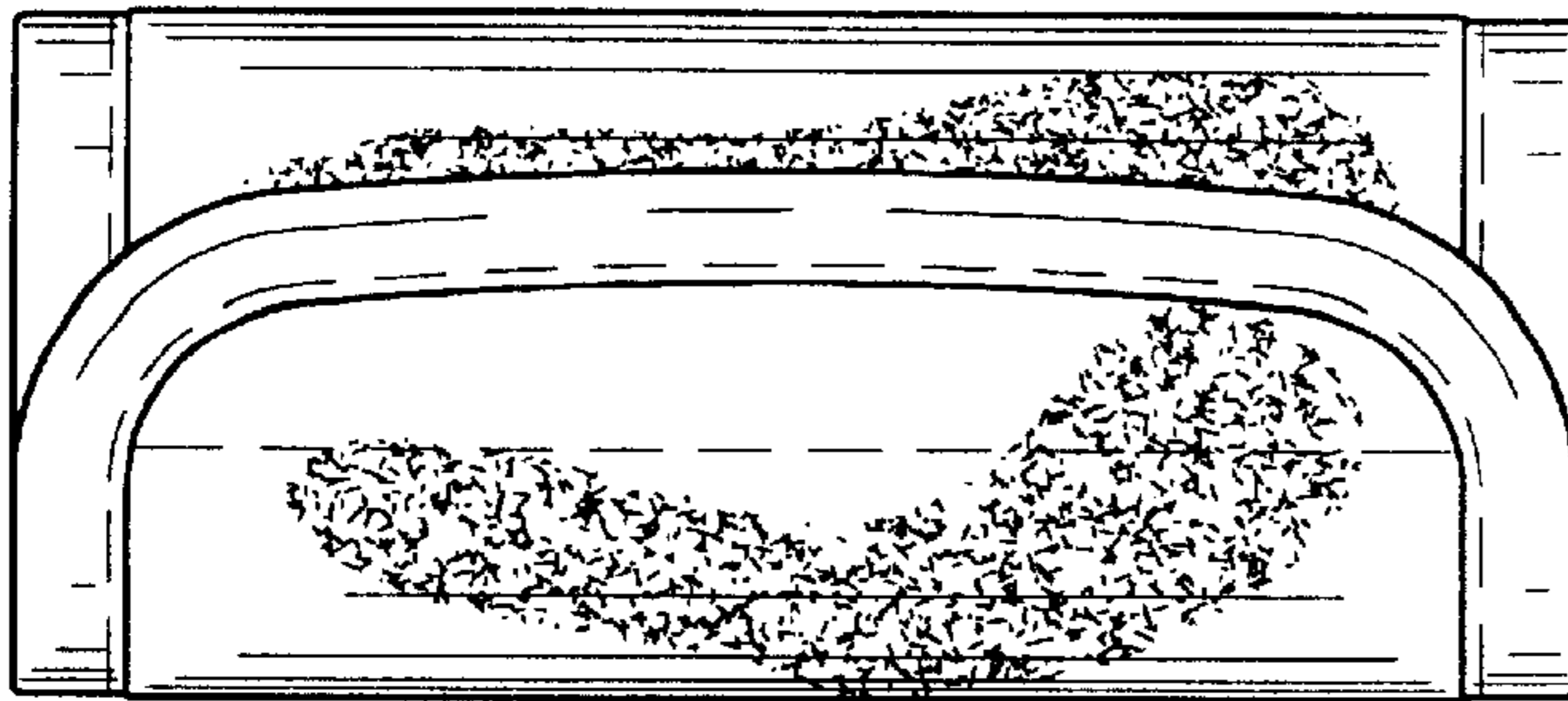

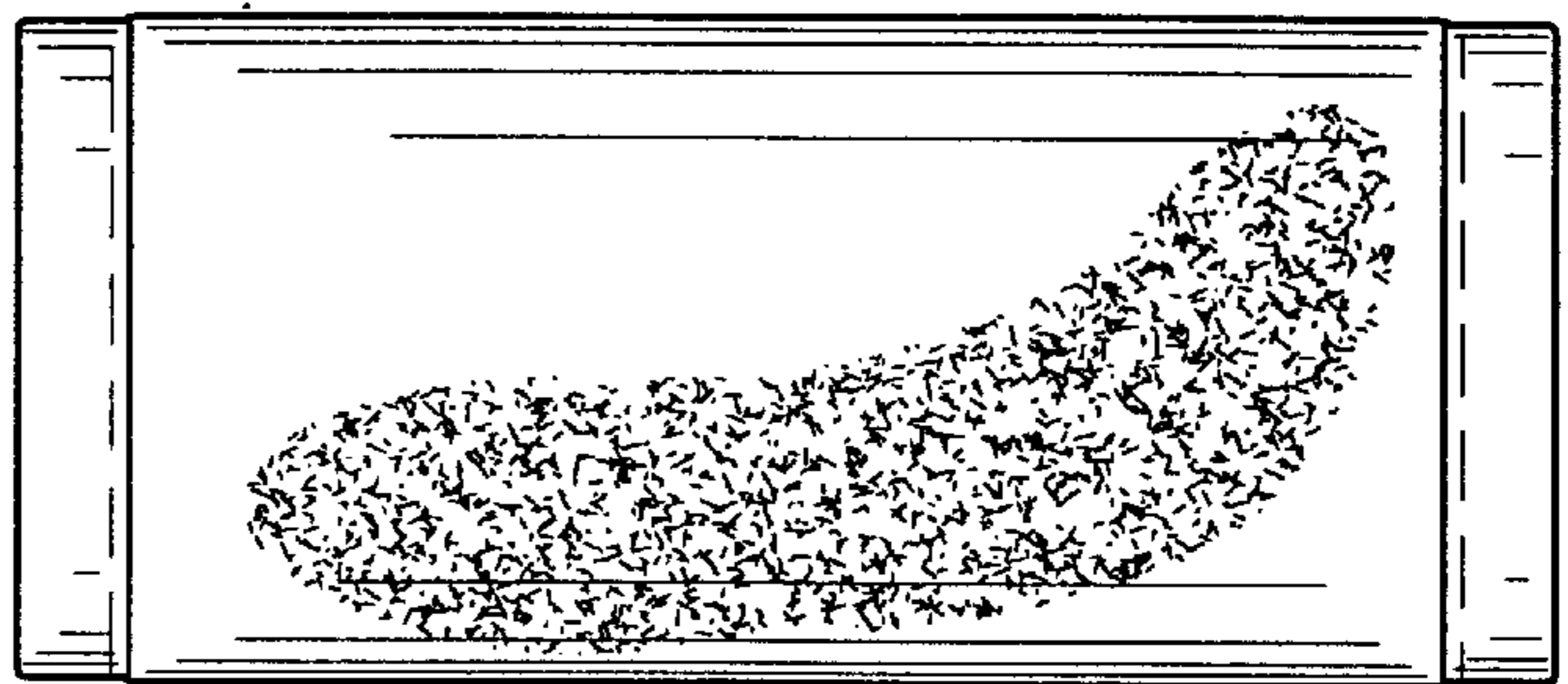

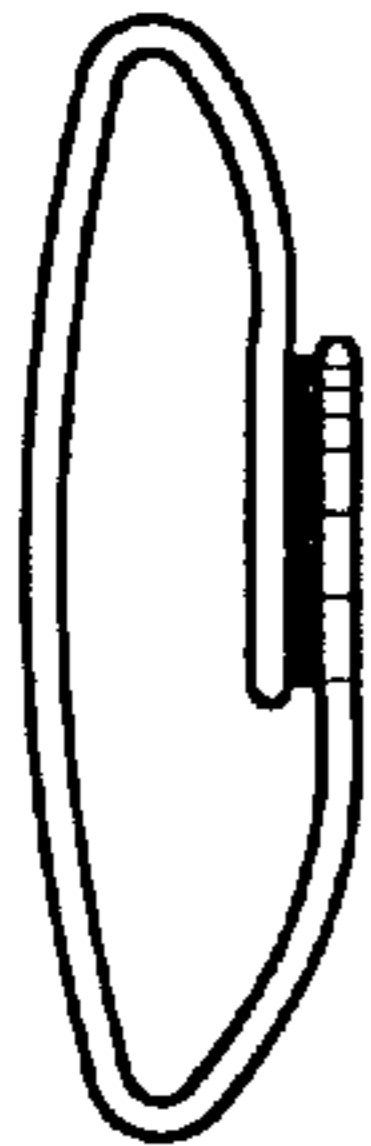

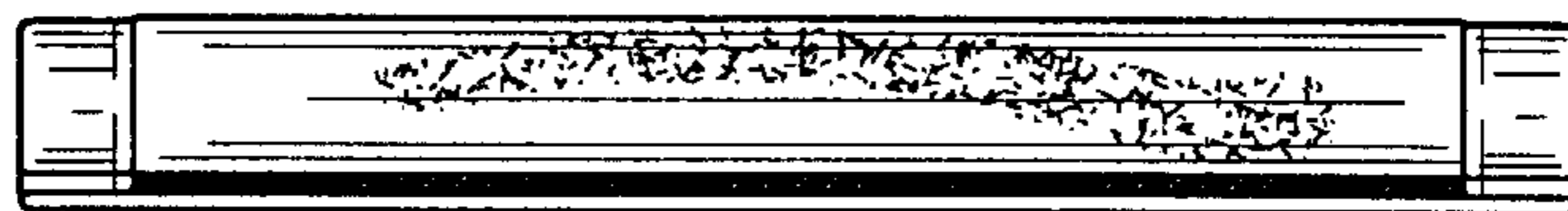

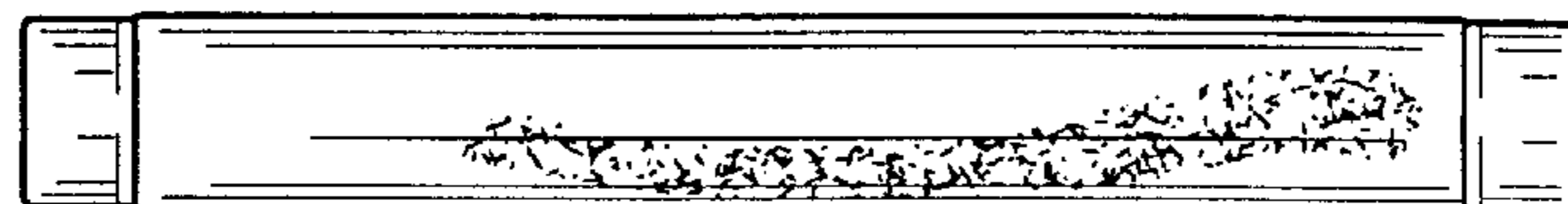
