DESCRIPTION

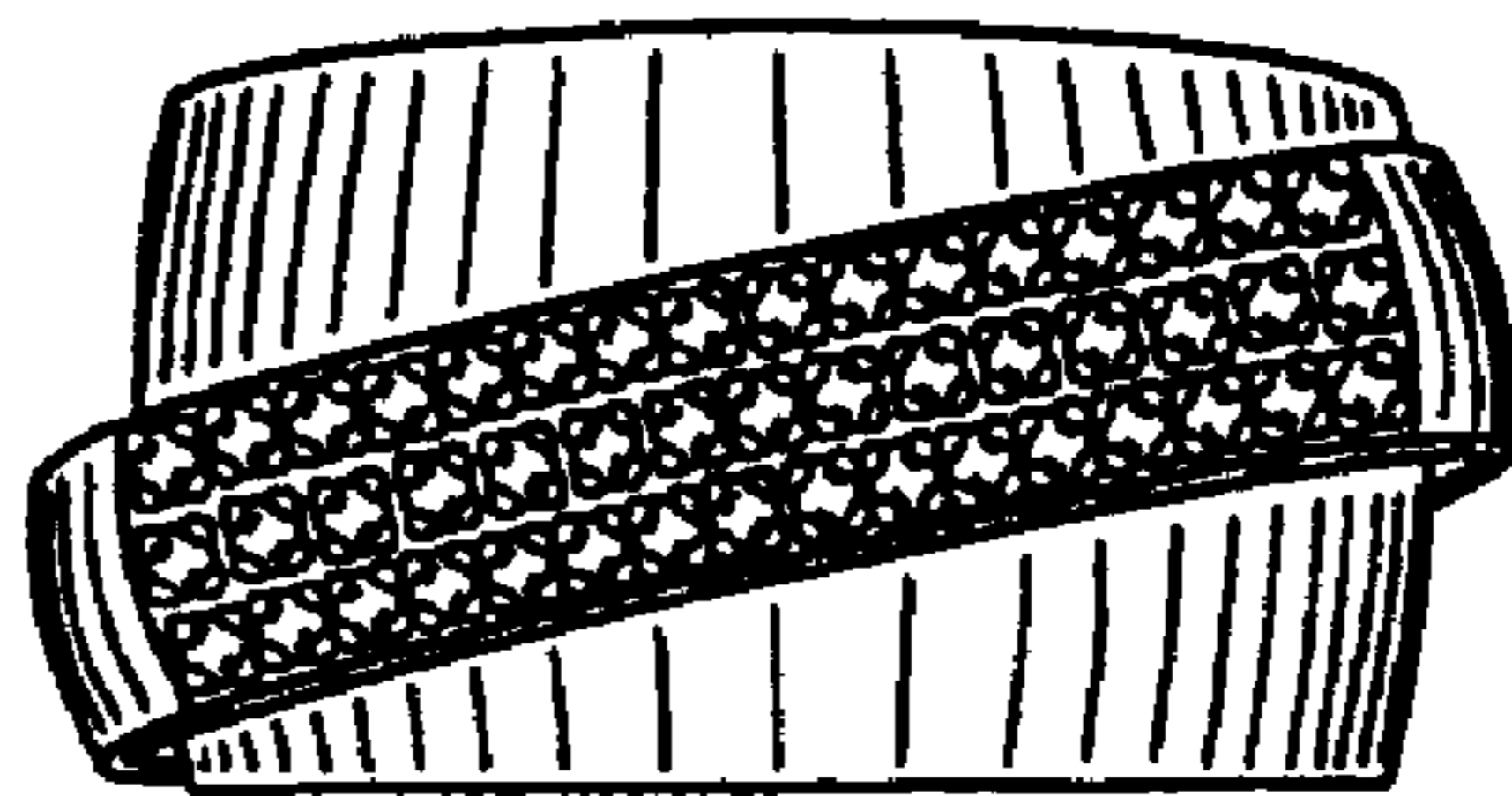
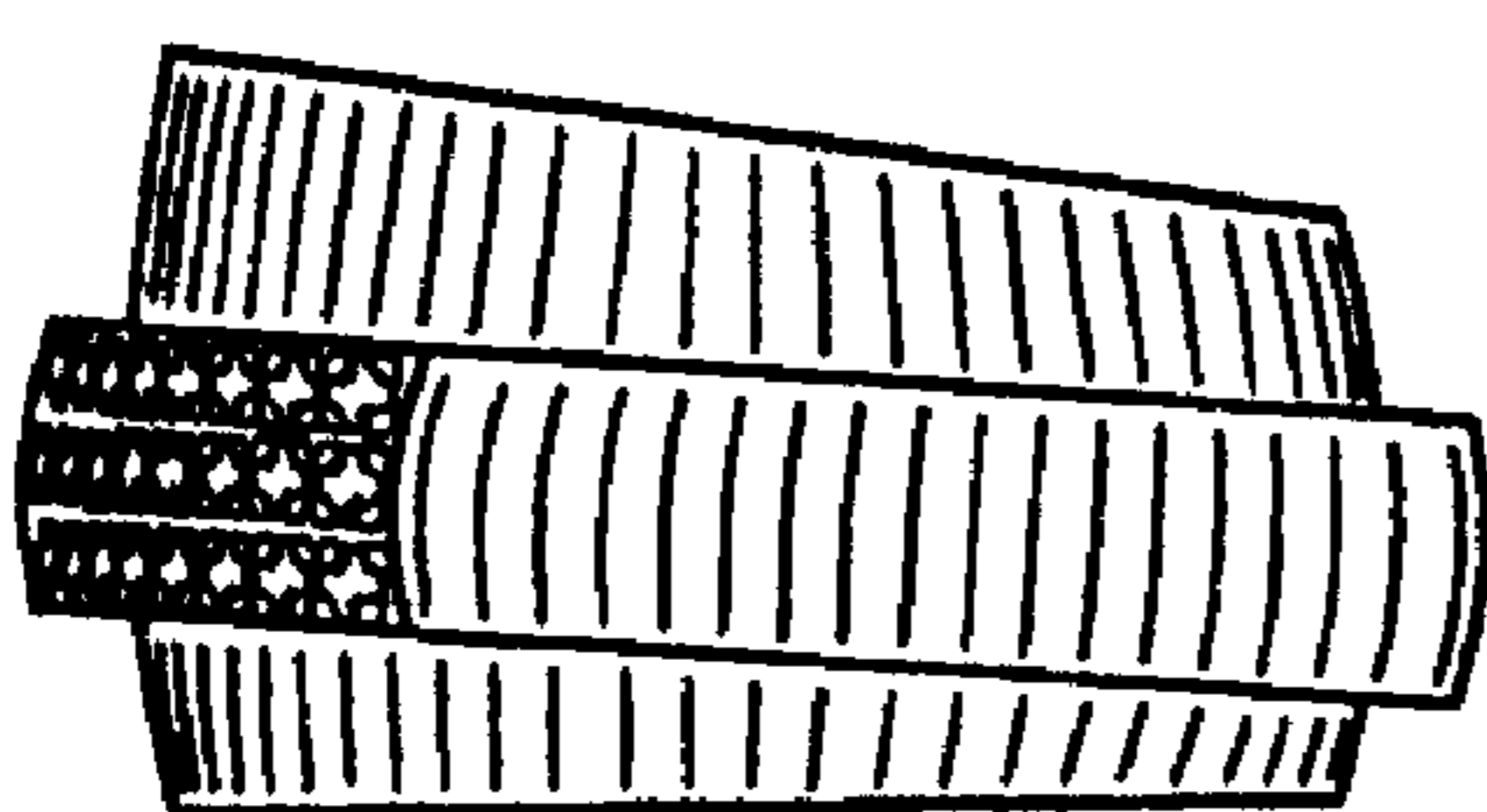
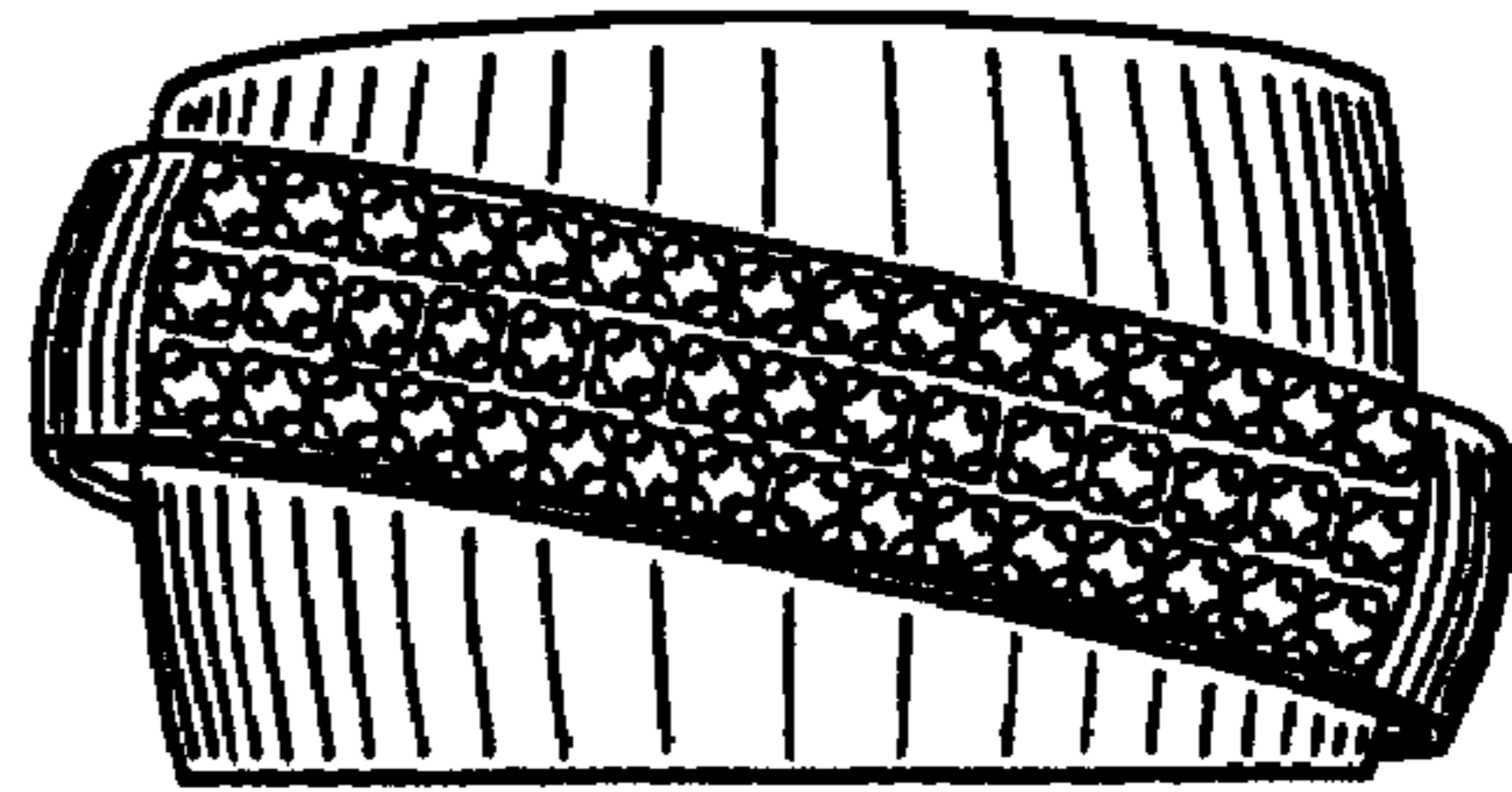
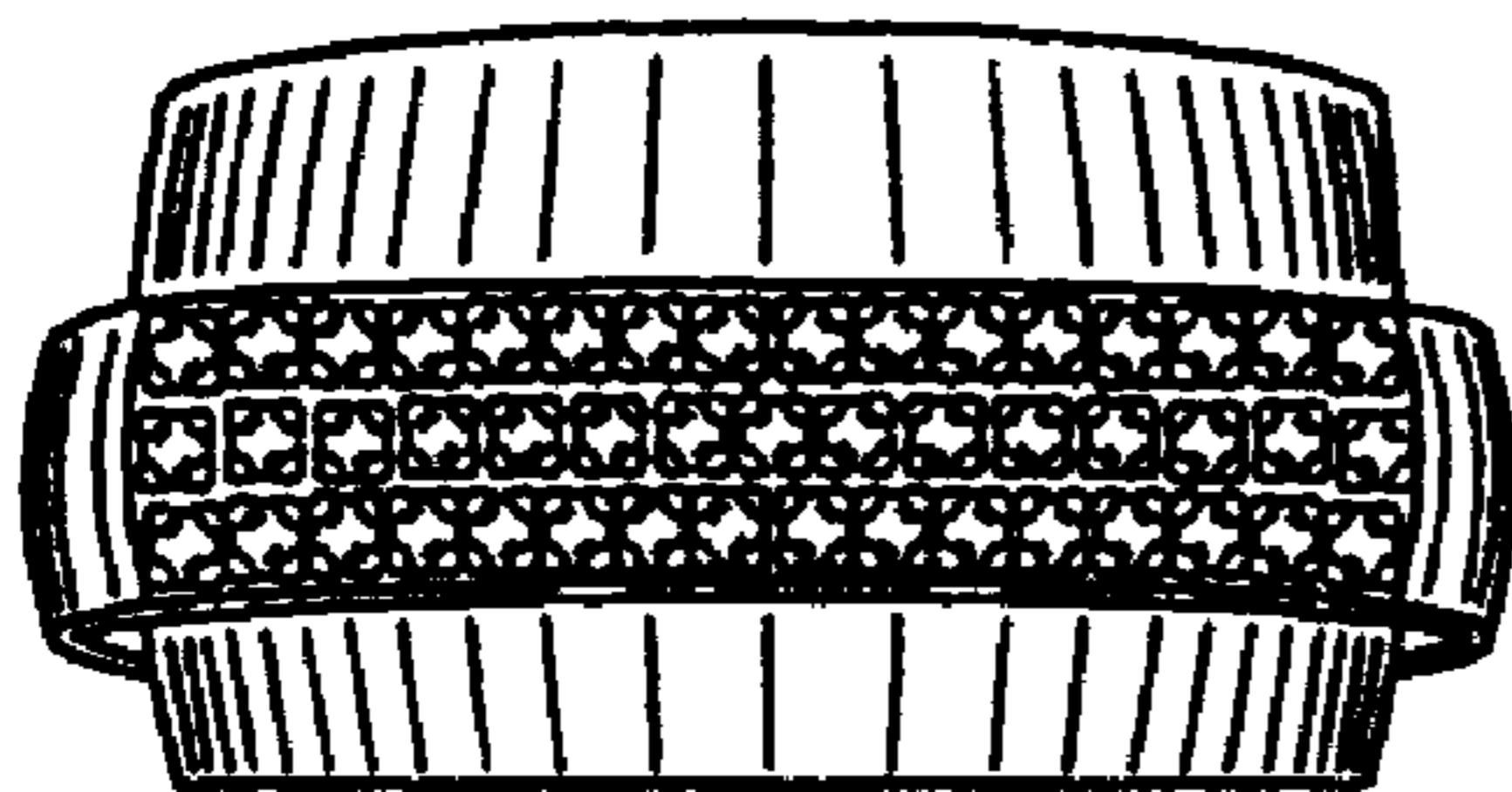

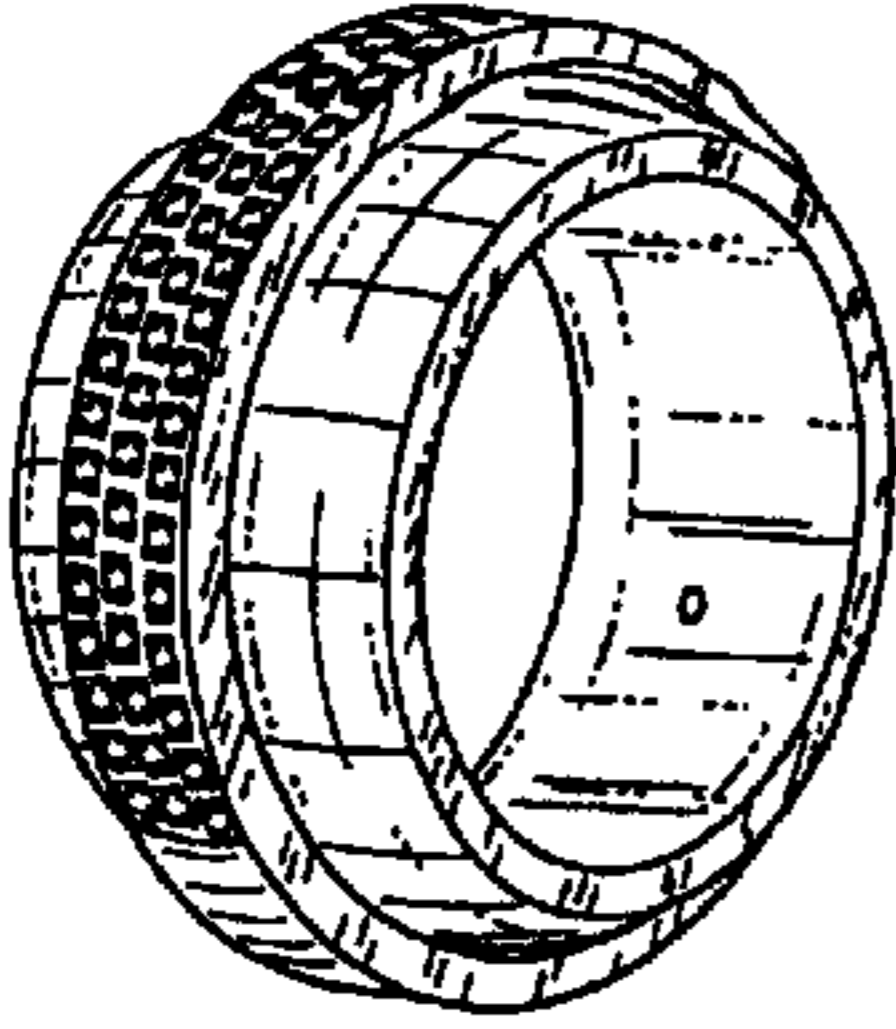

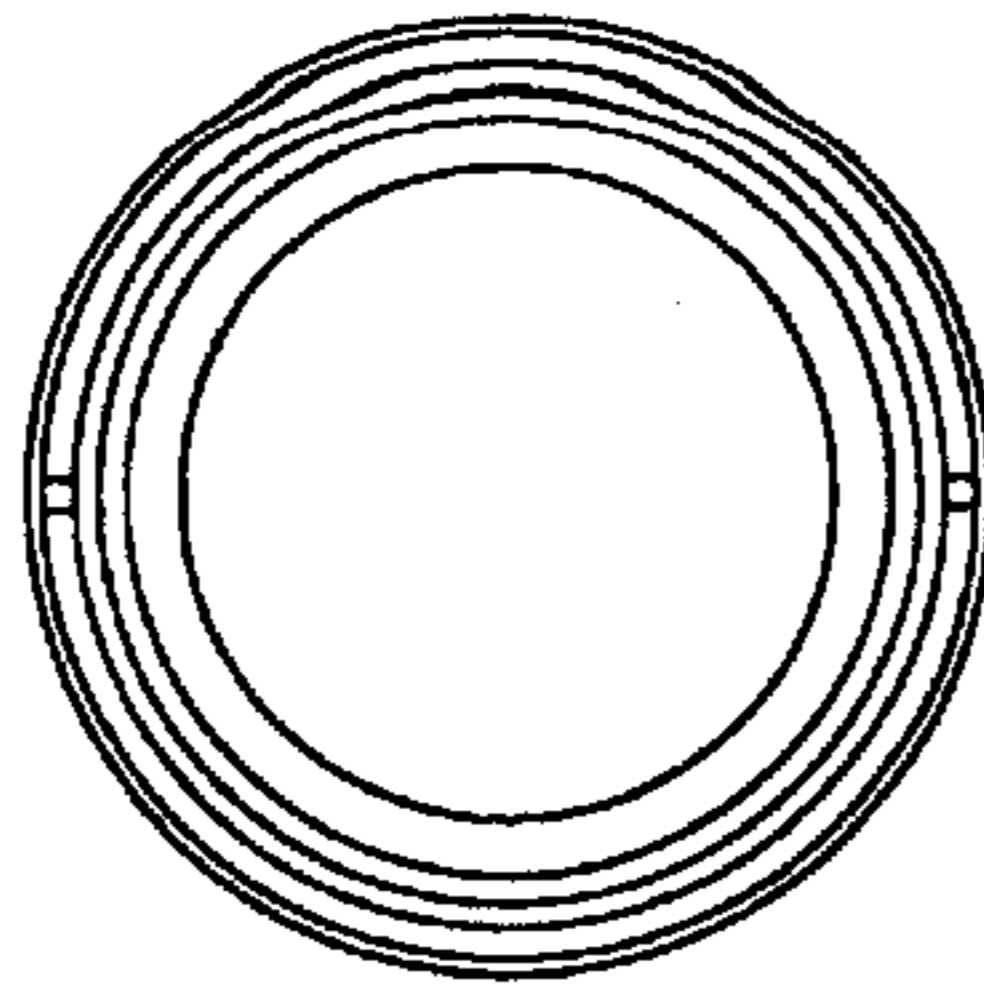

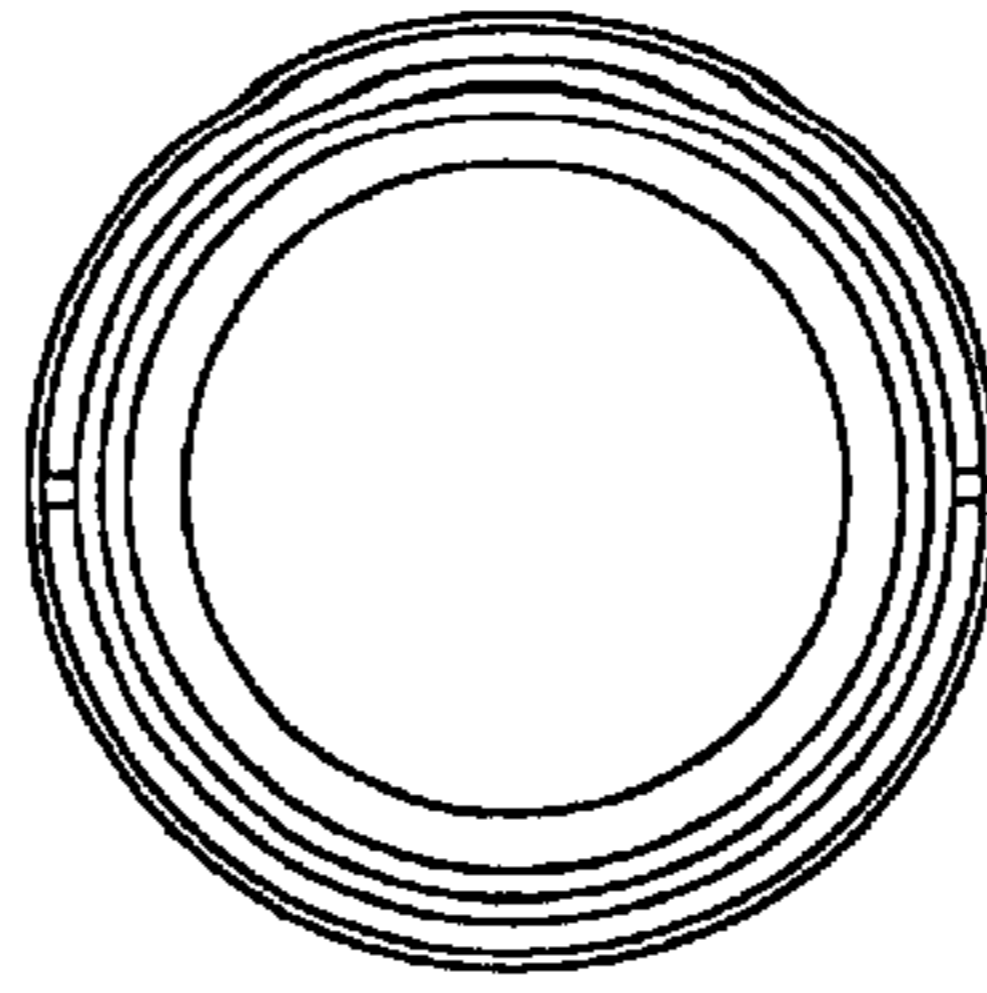

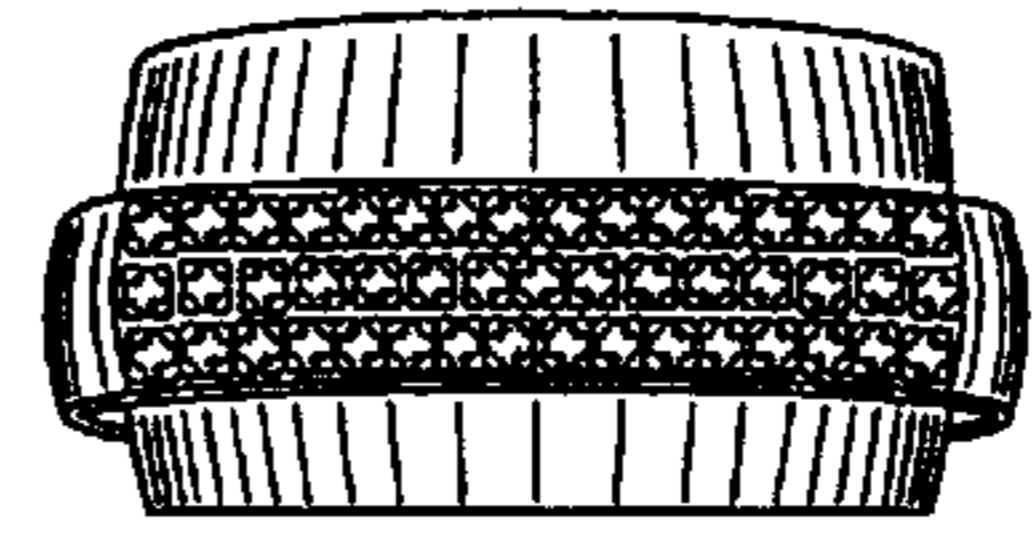

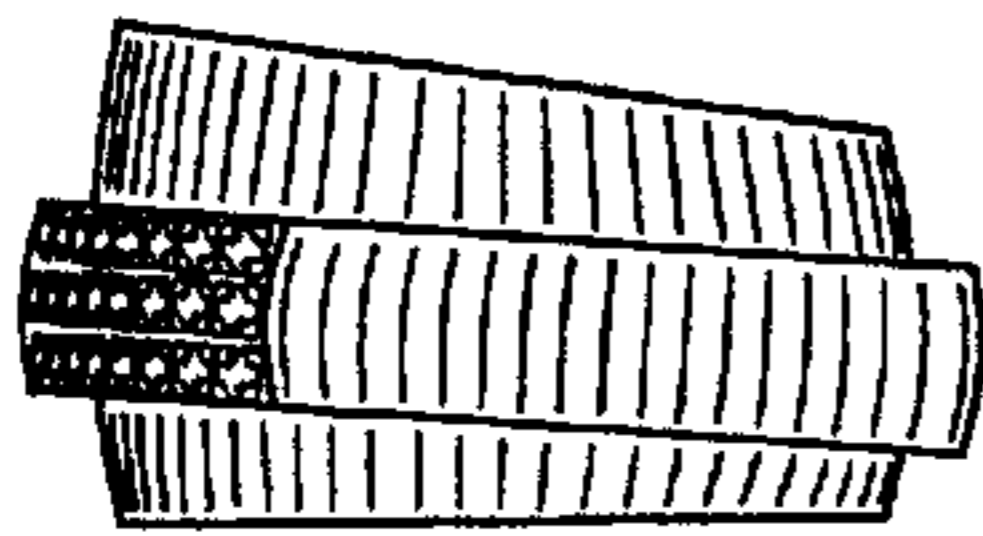

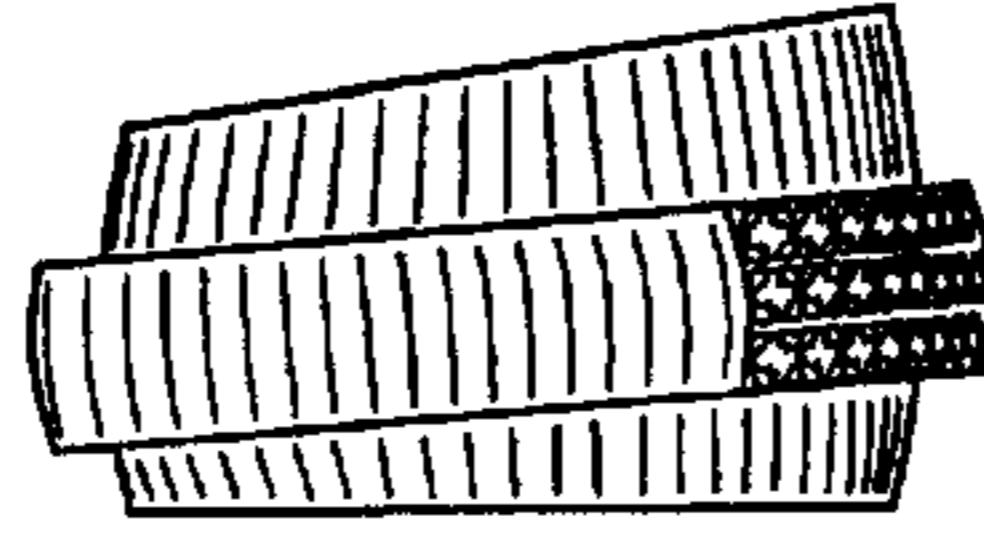

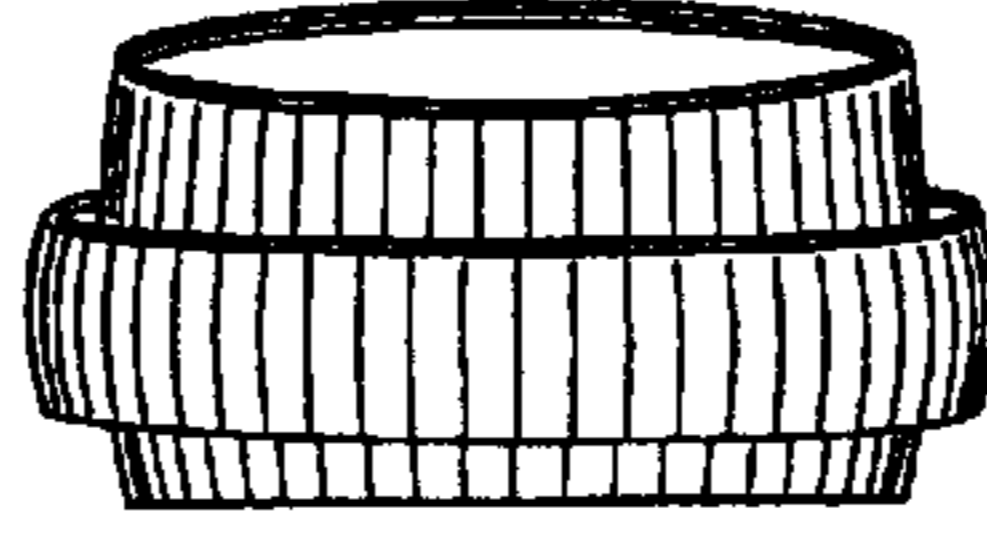

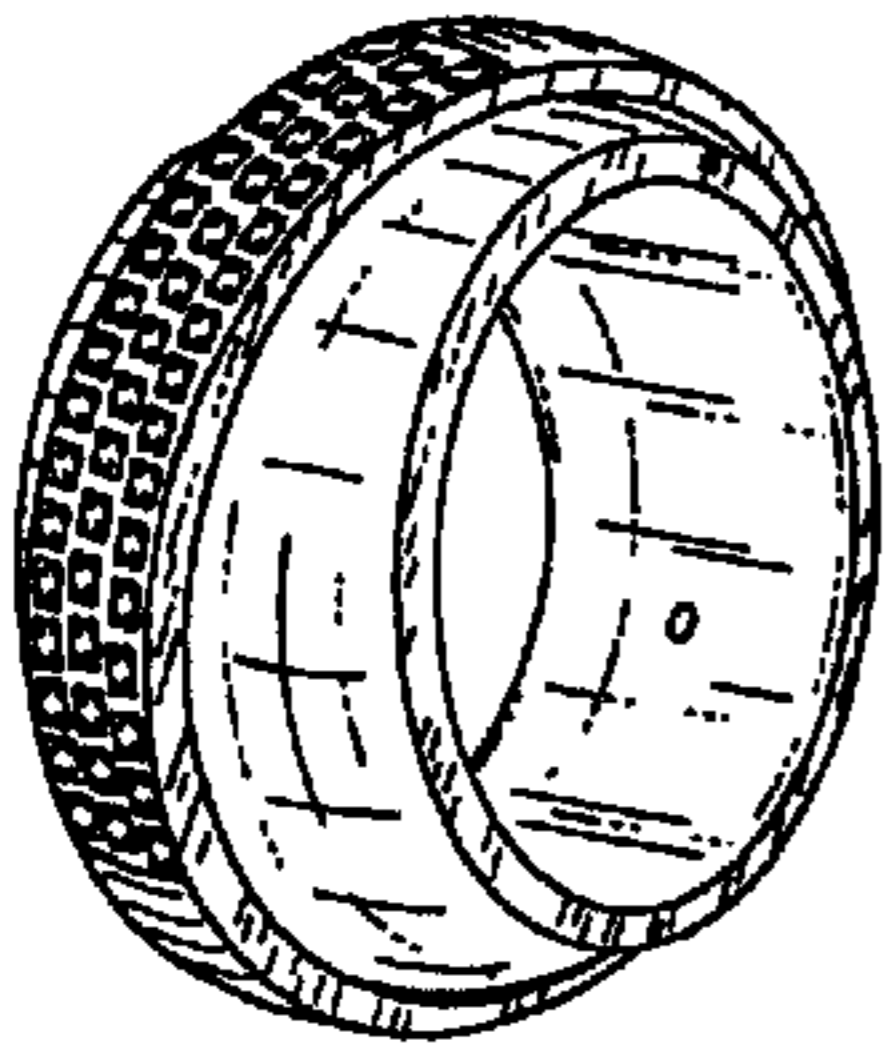

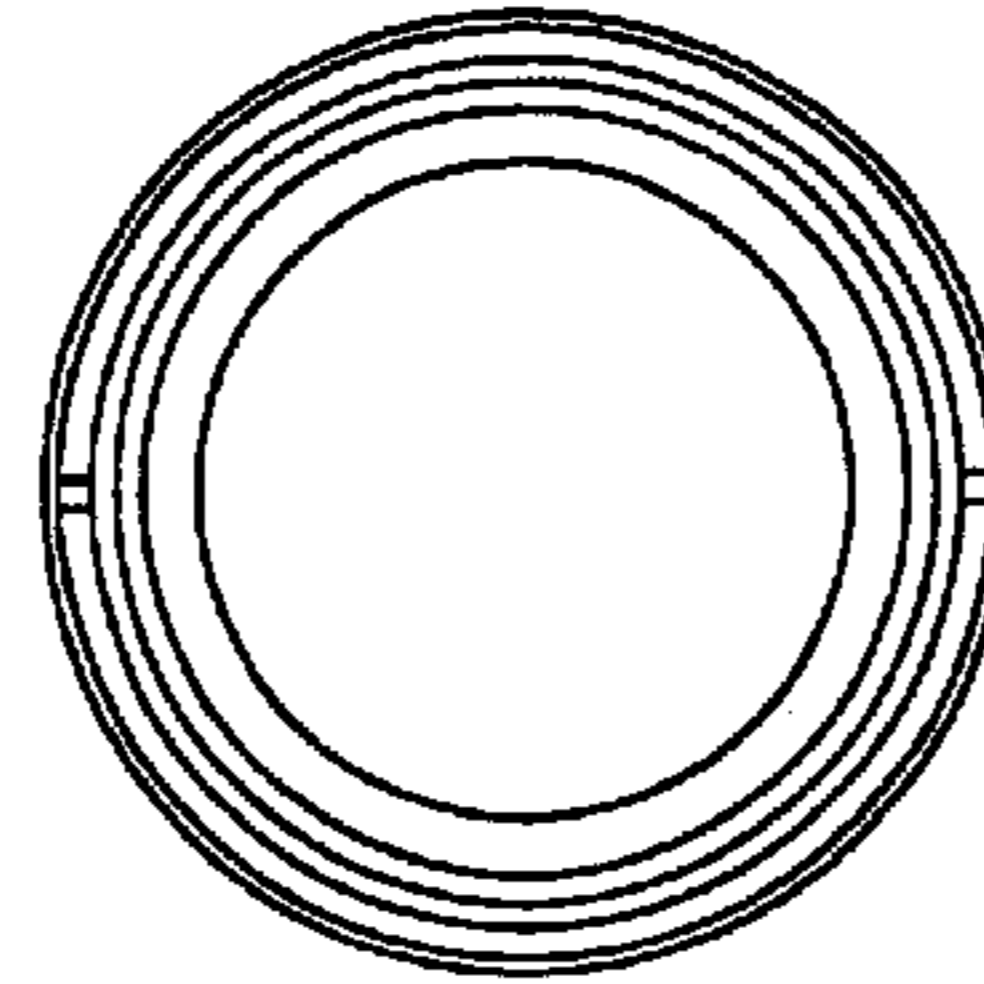

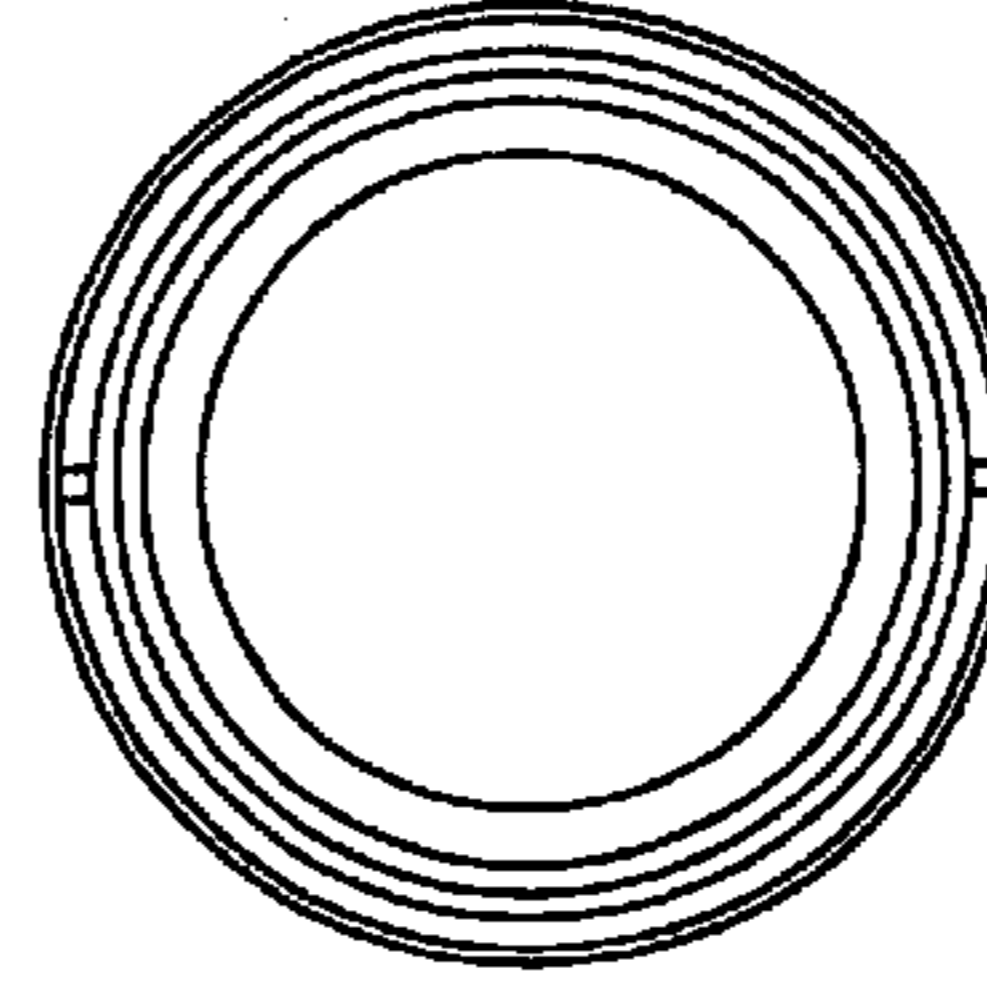

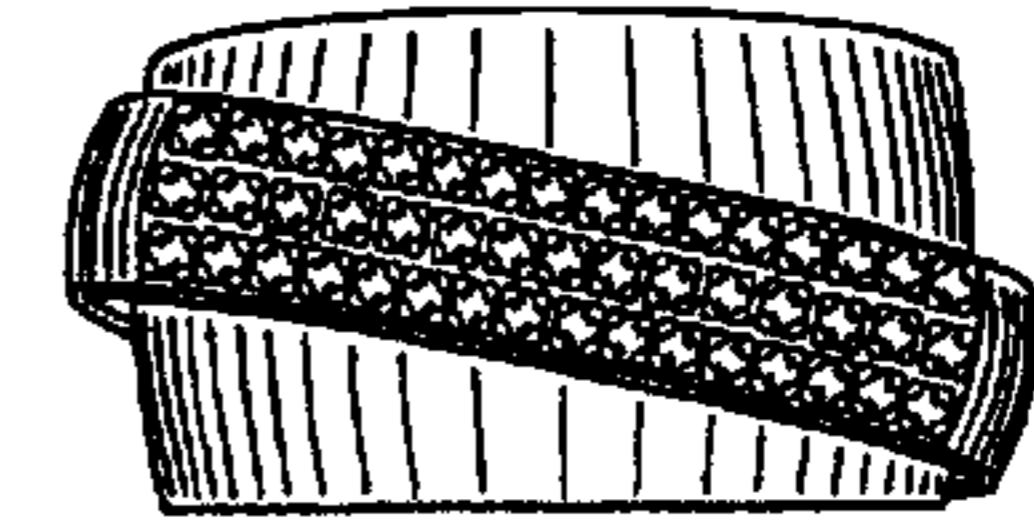

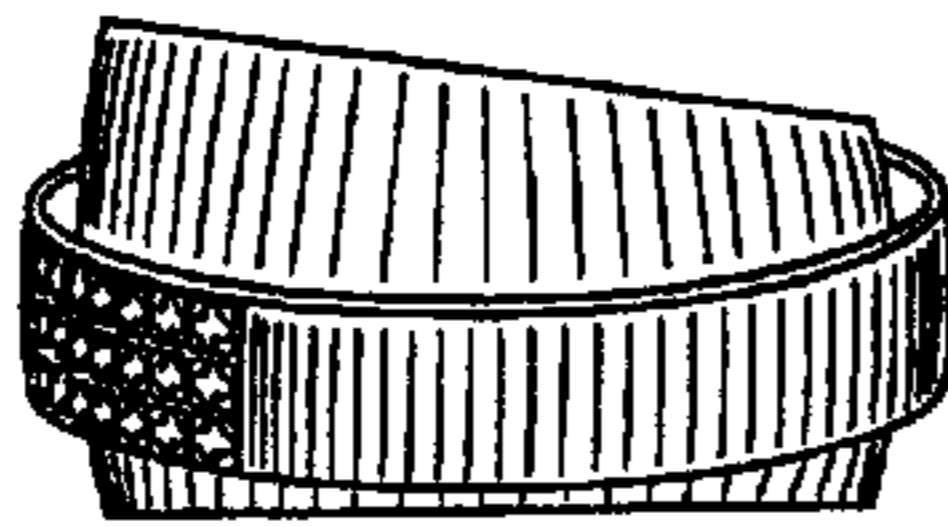

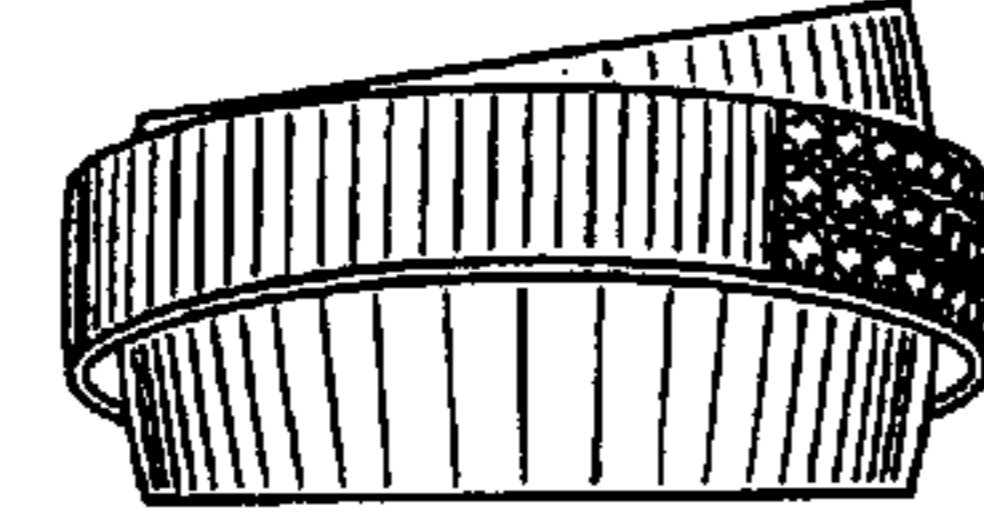

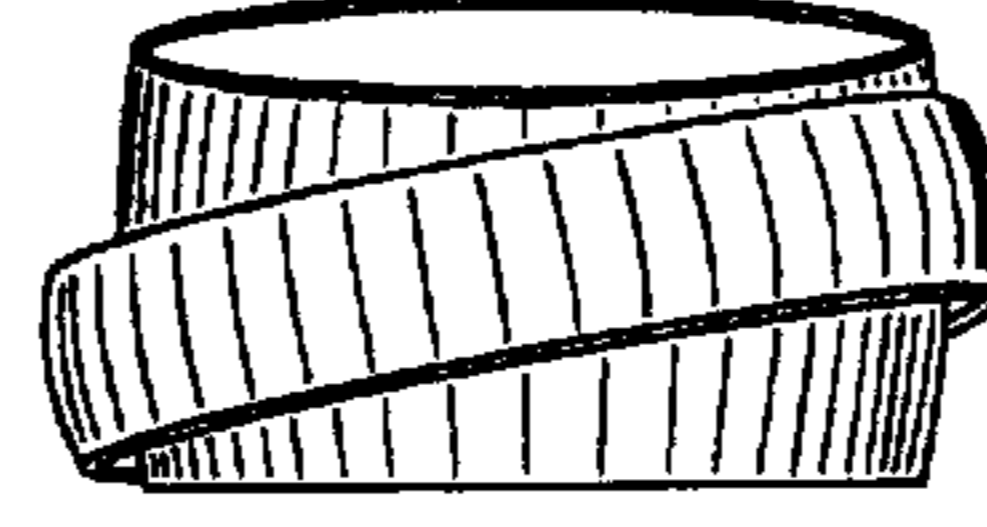

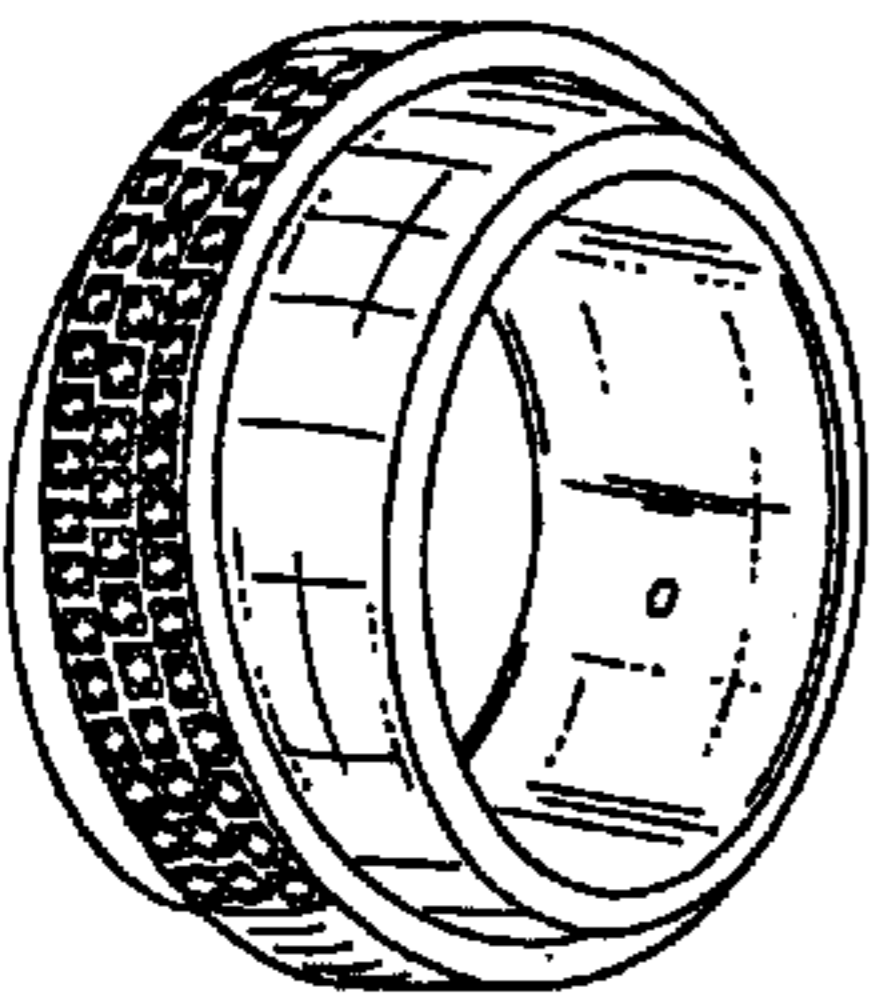

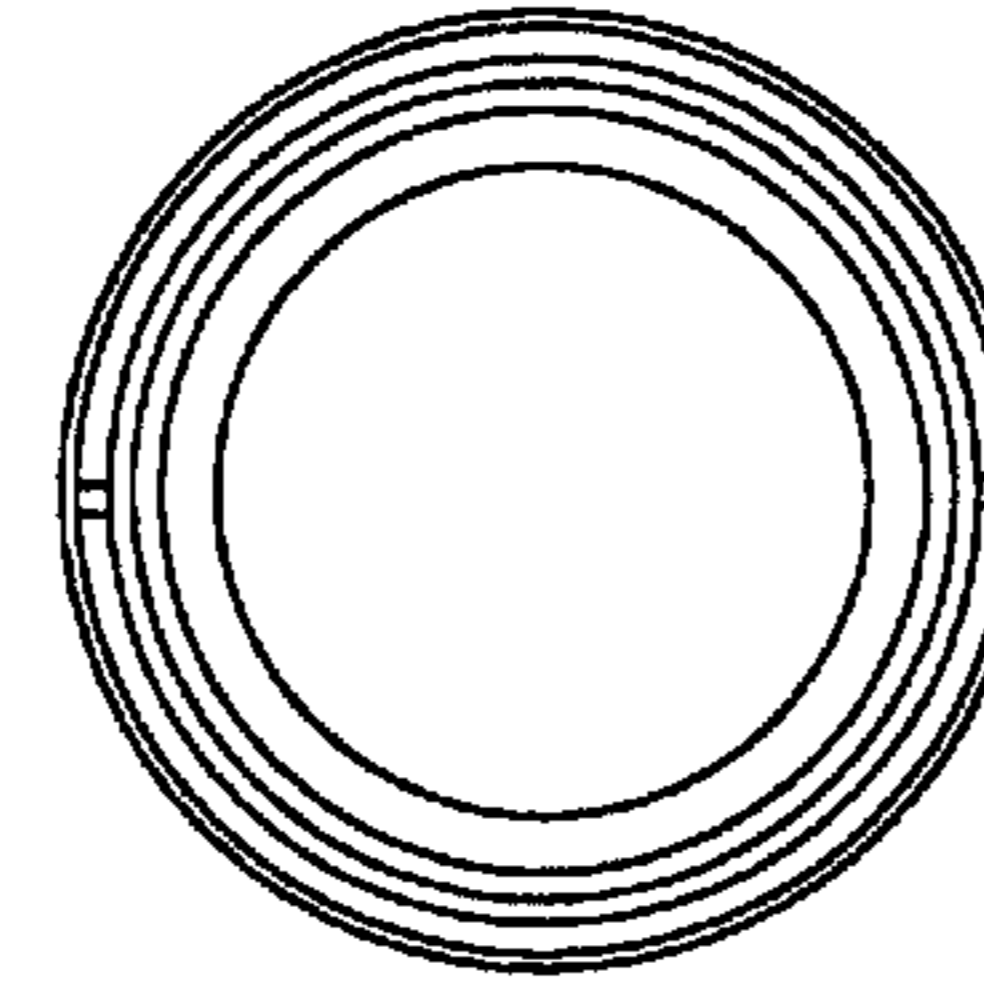

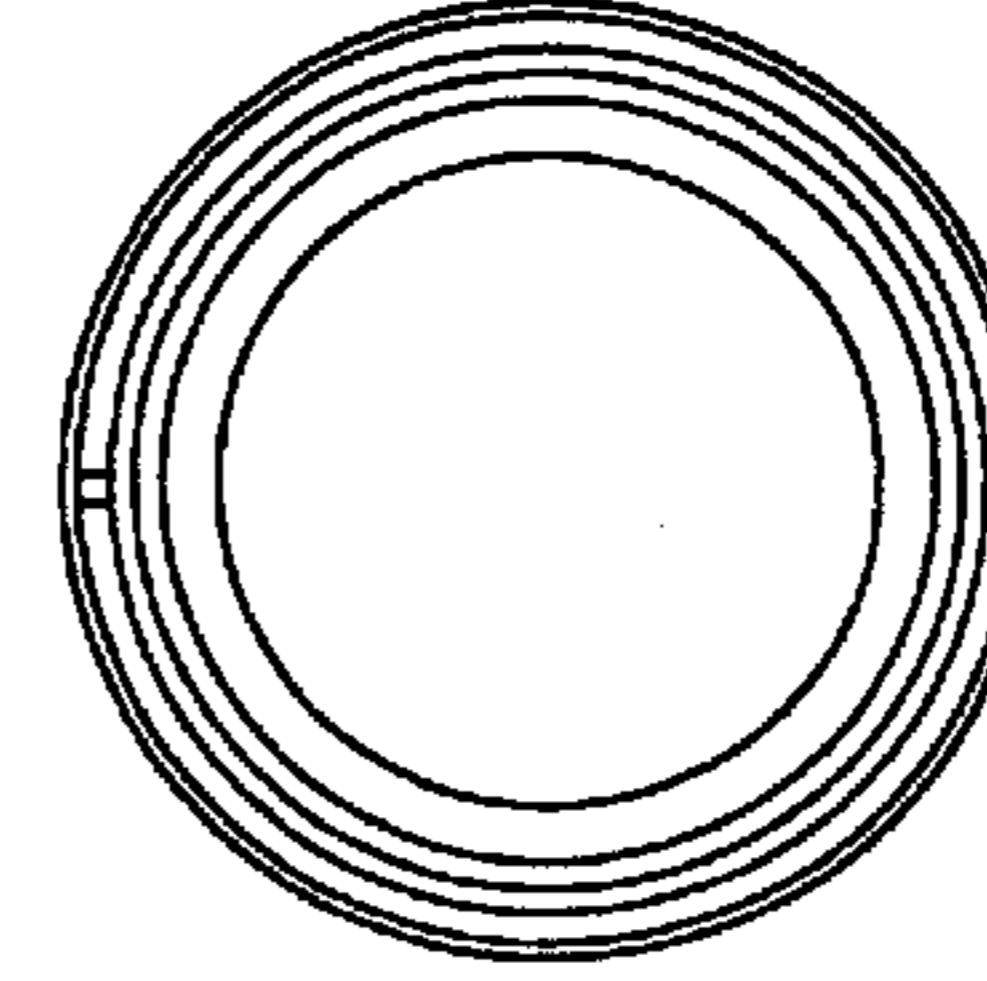

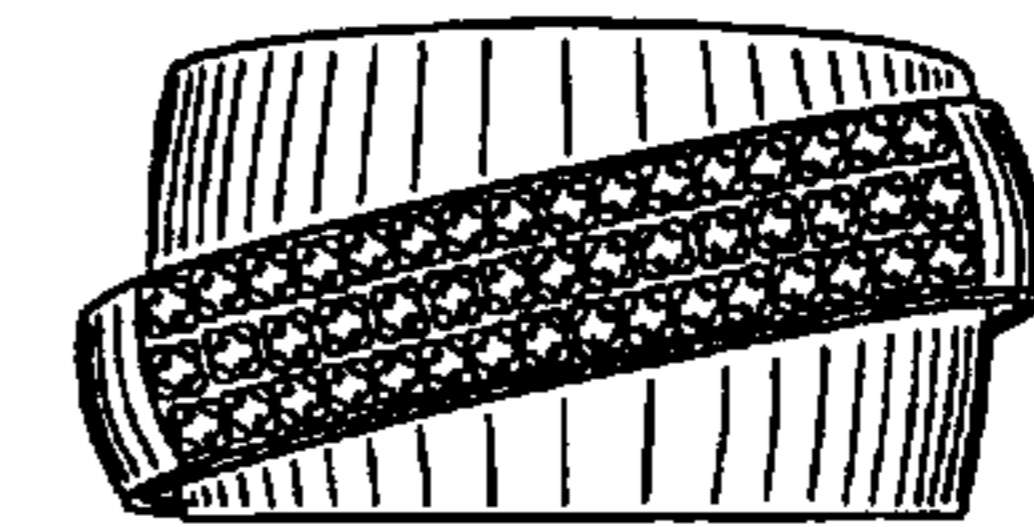

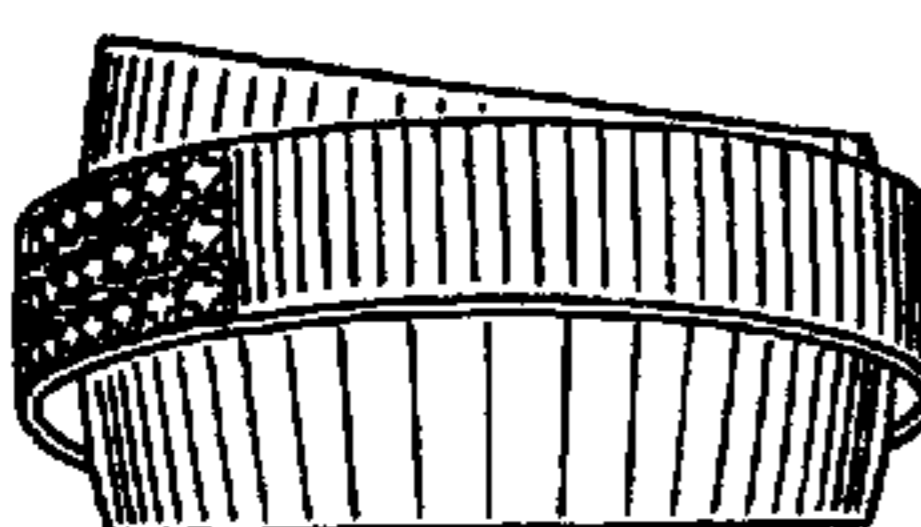

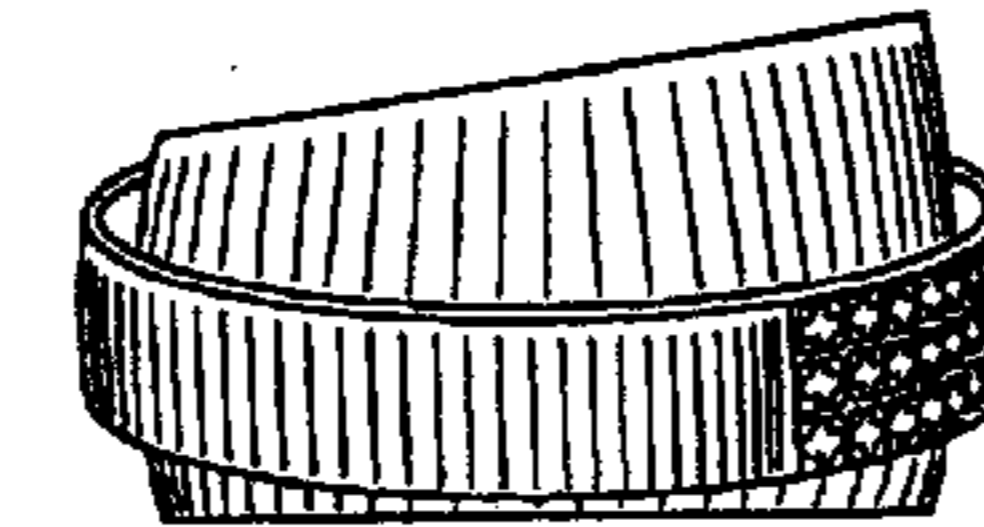
