FIG. 4 is a top view of the portable automotive booster depicted in FIG. 1.

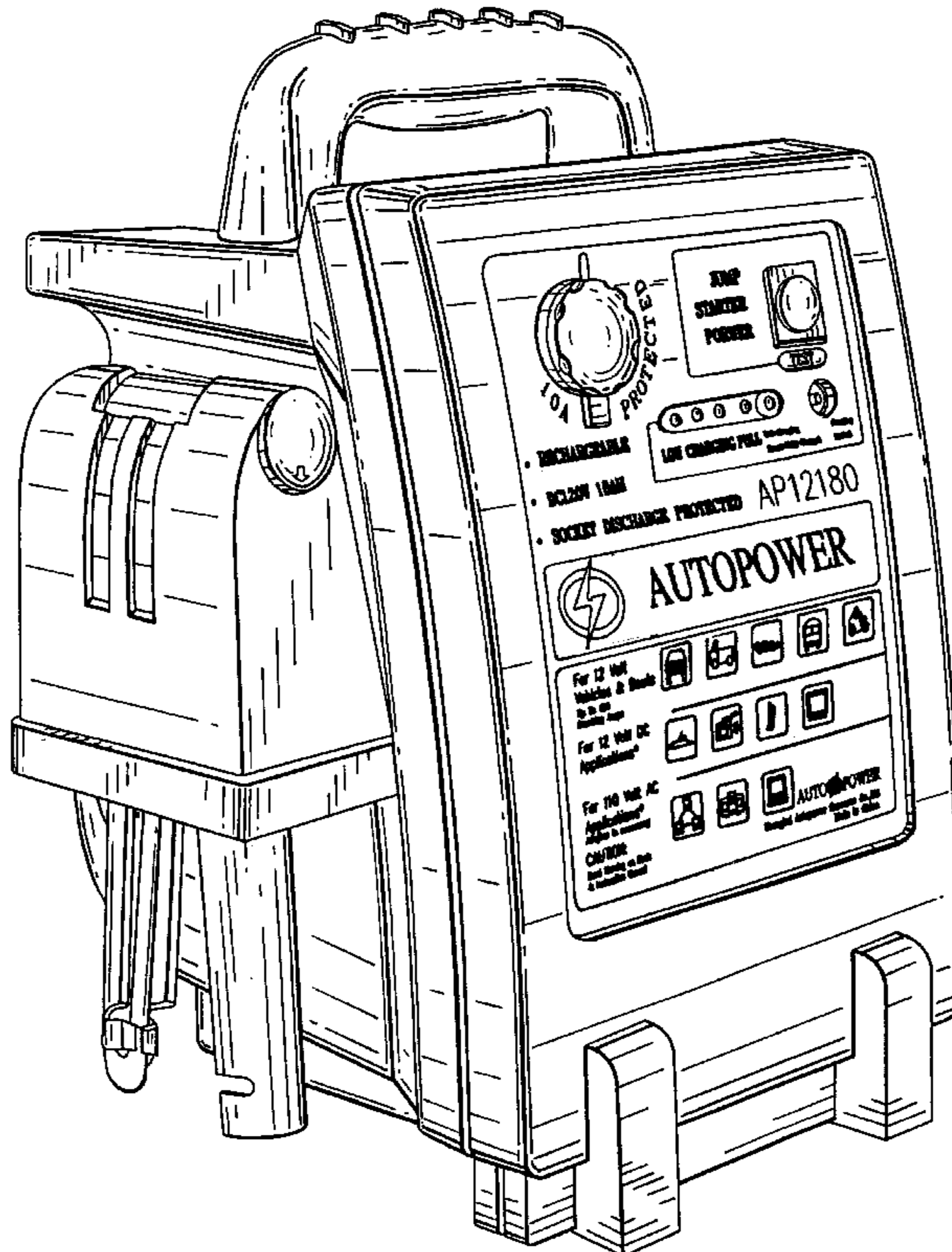
FIG. 5 is a bottom view of view of the portable automotive booster depicted in FIG. 1.

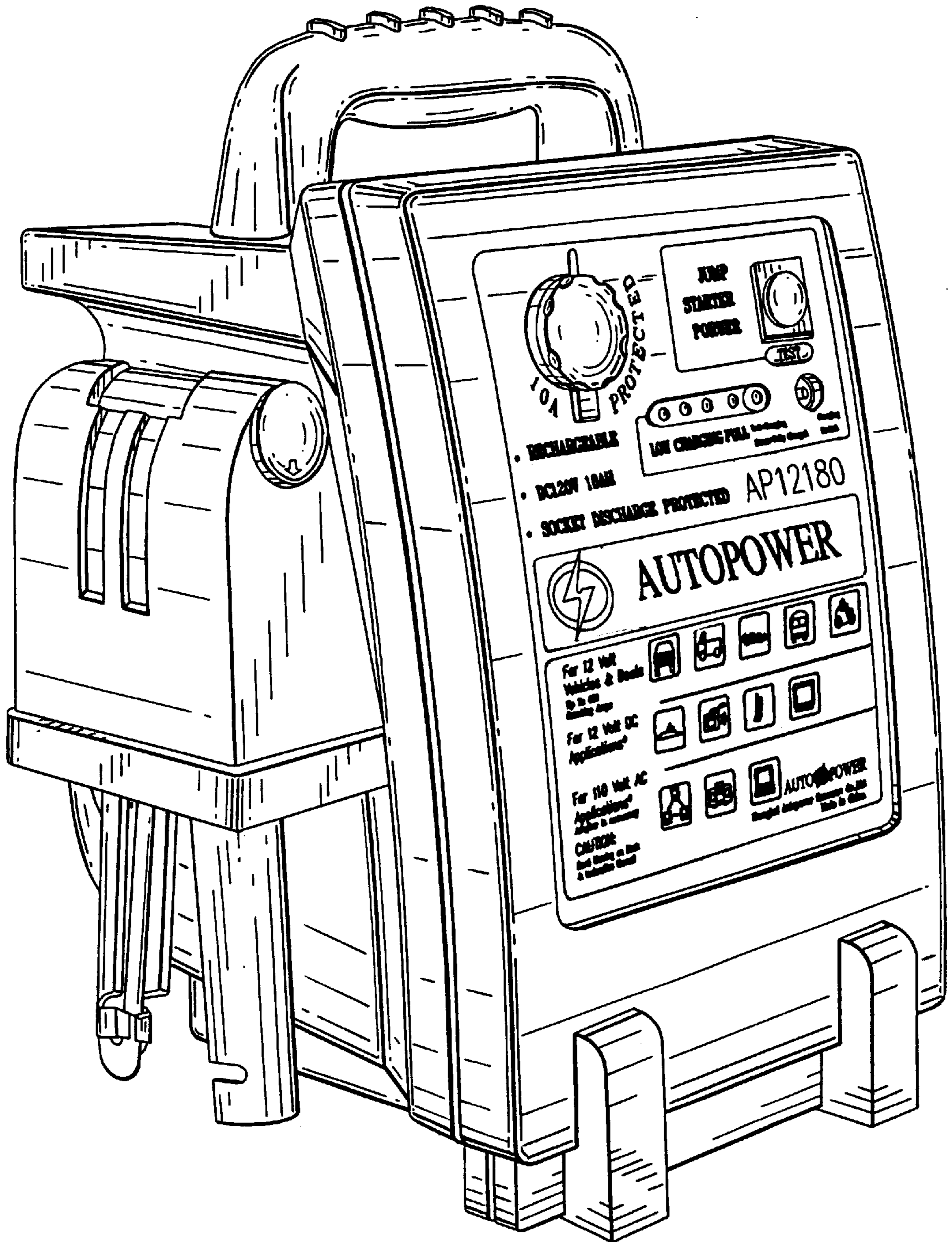

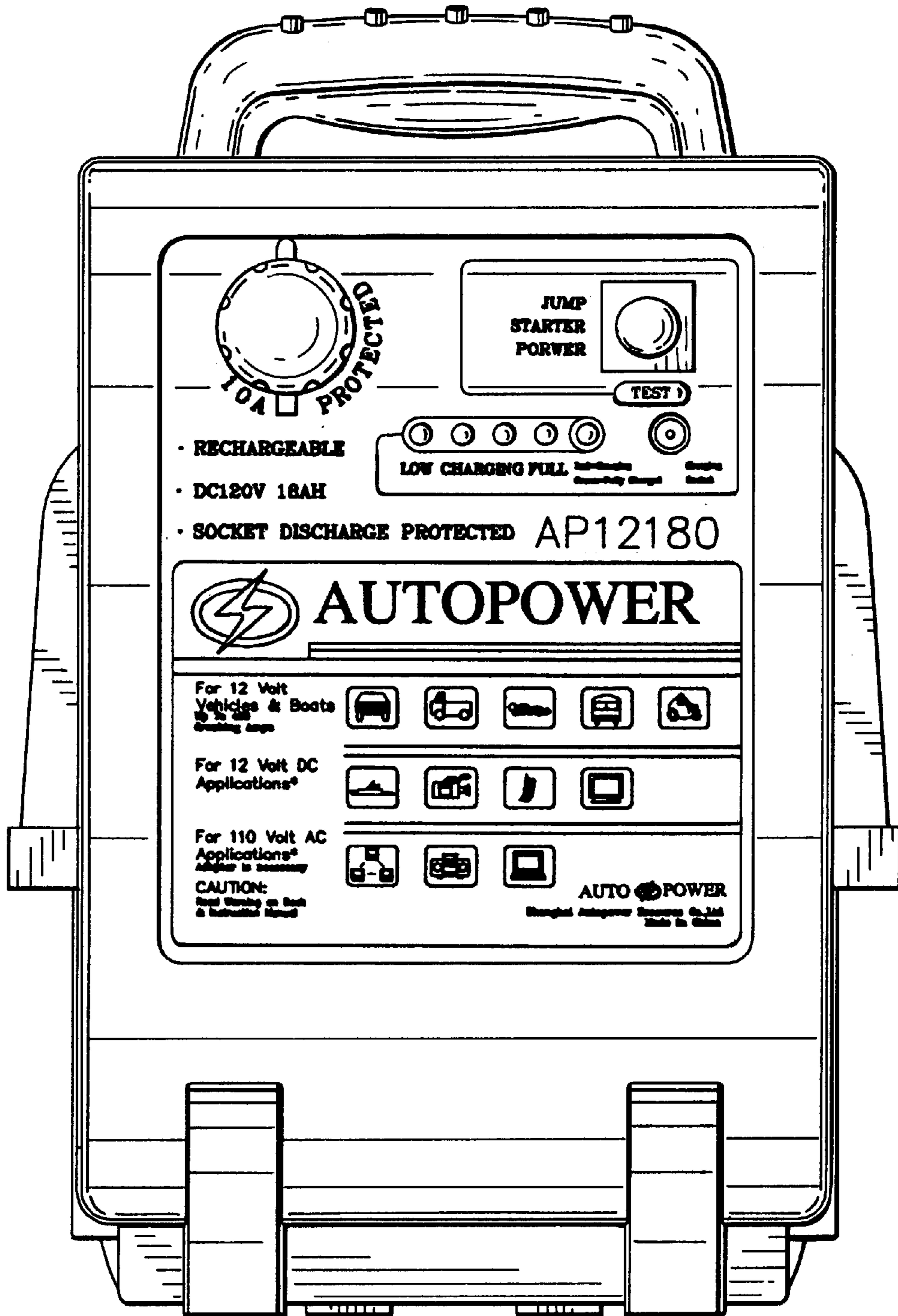

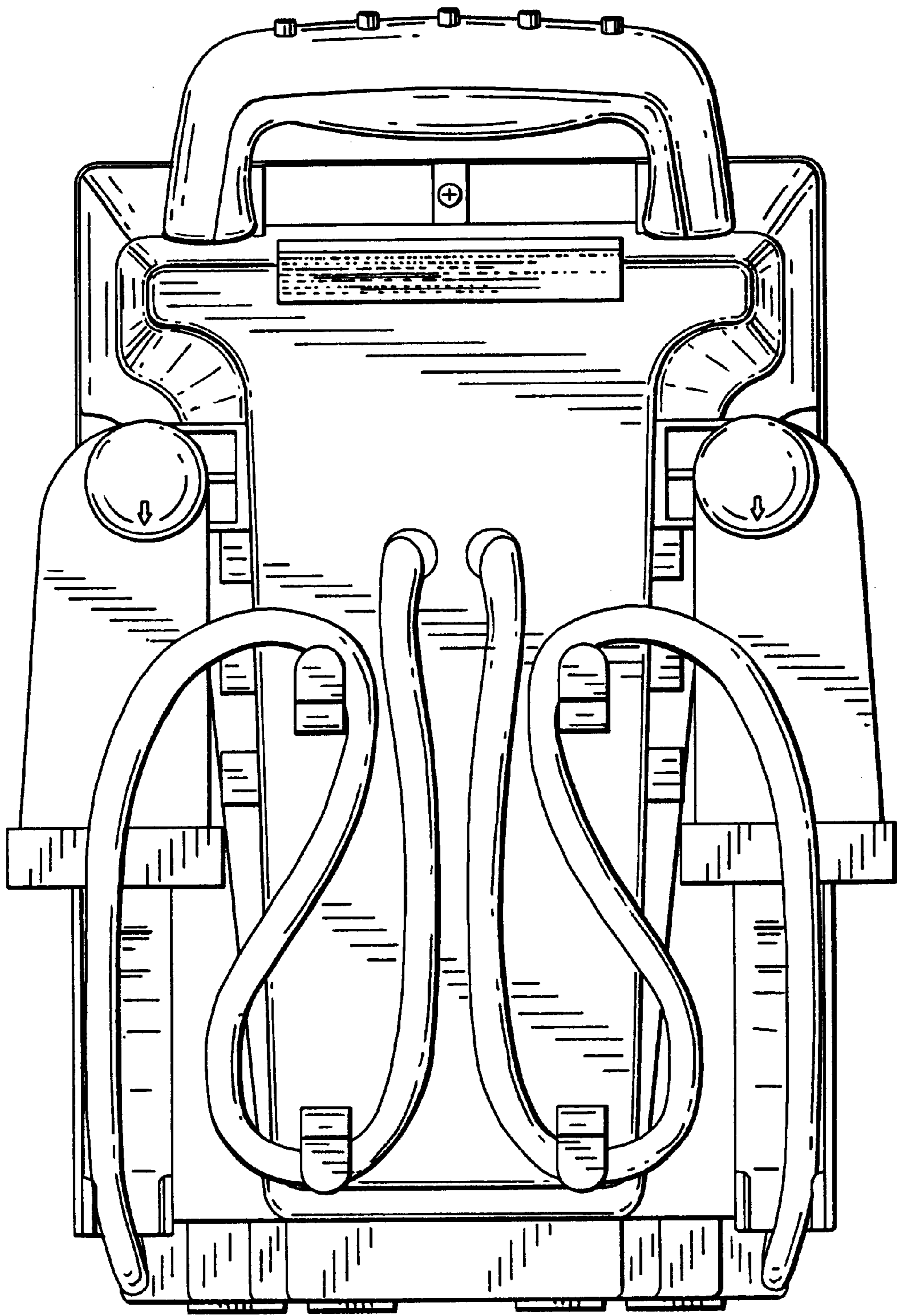

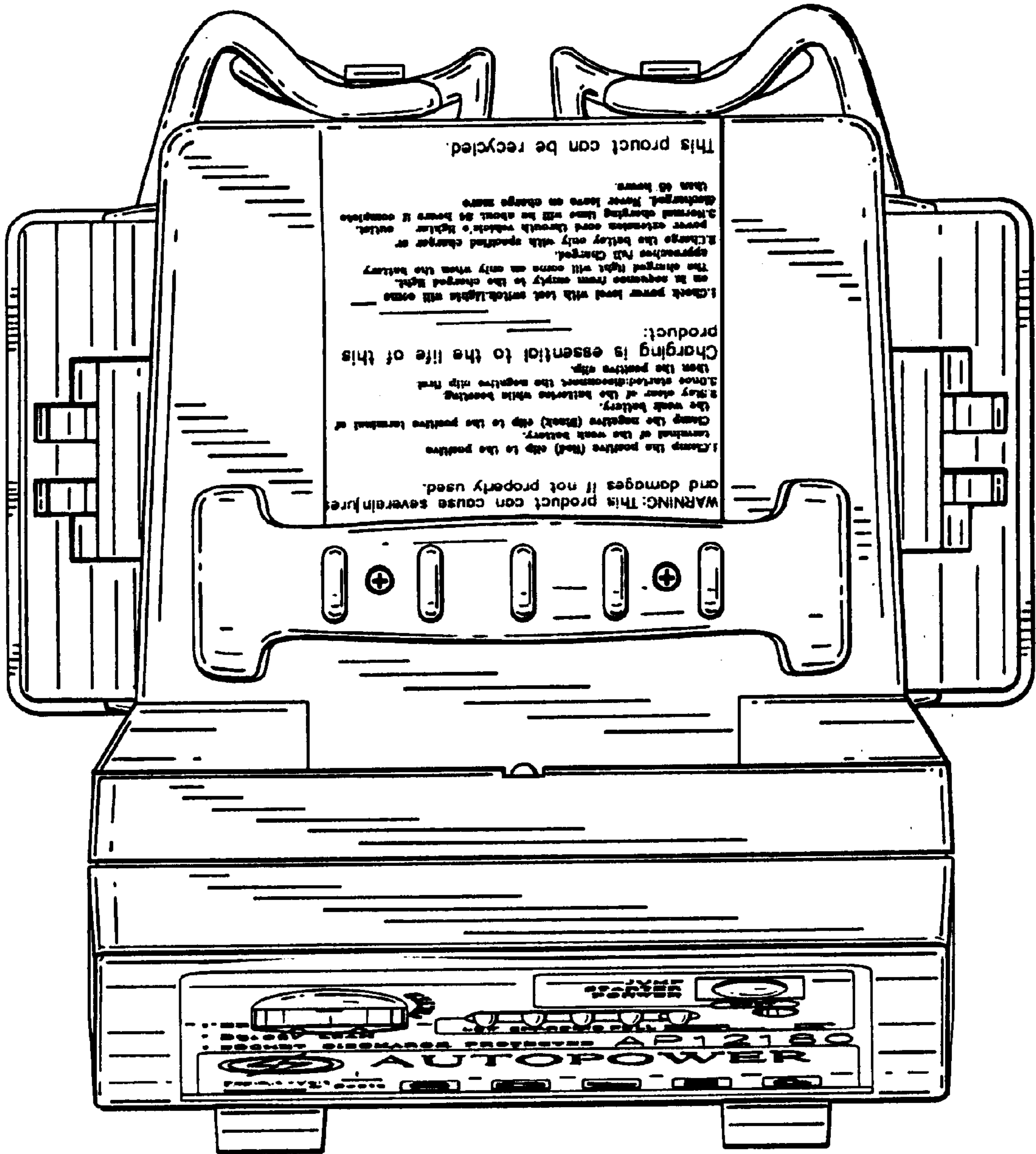

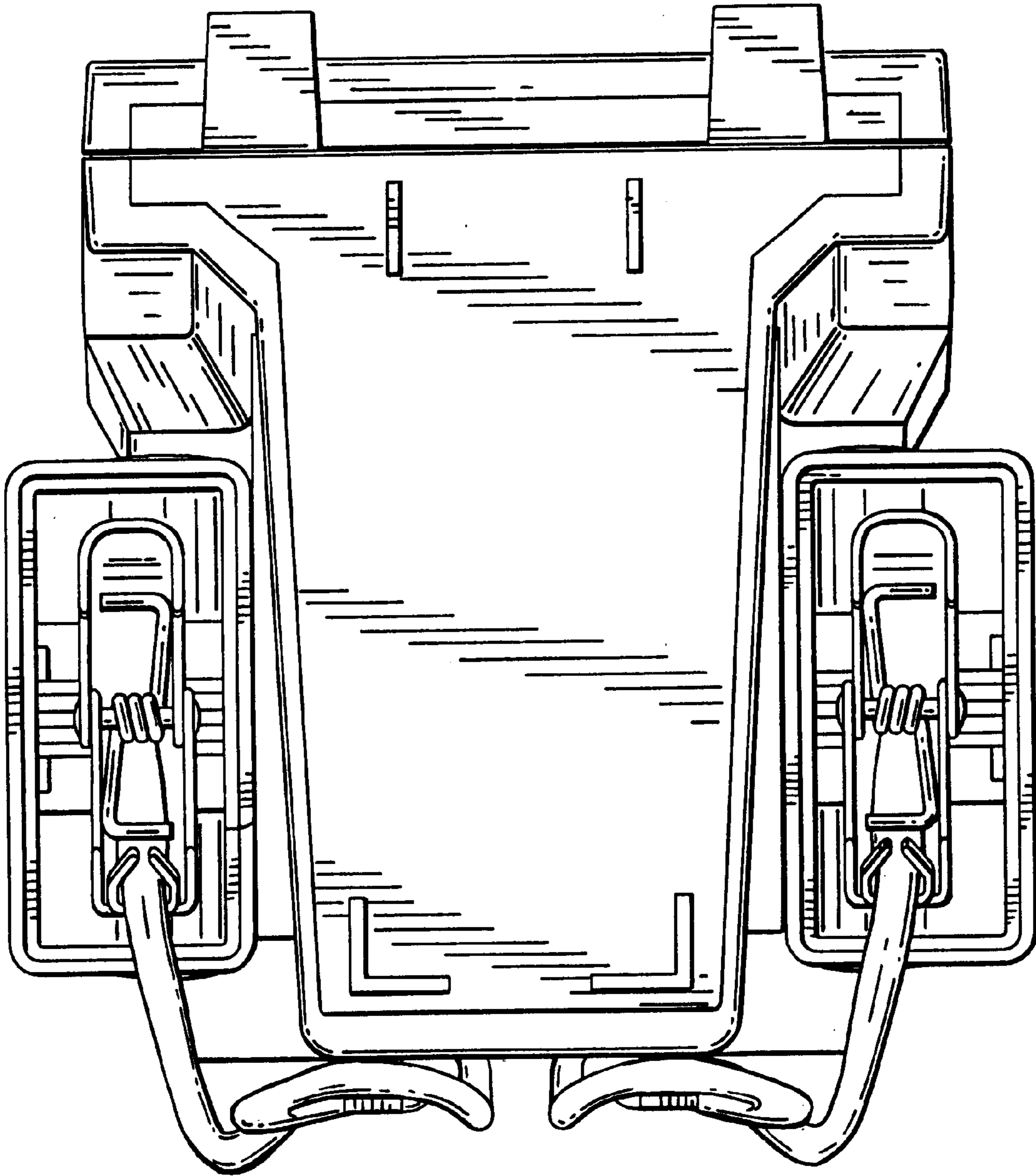

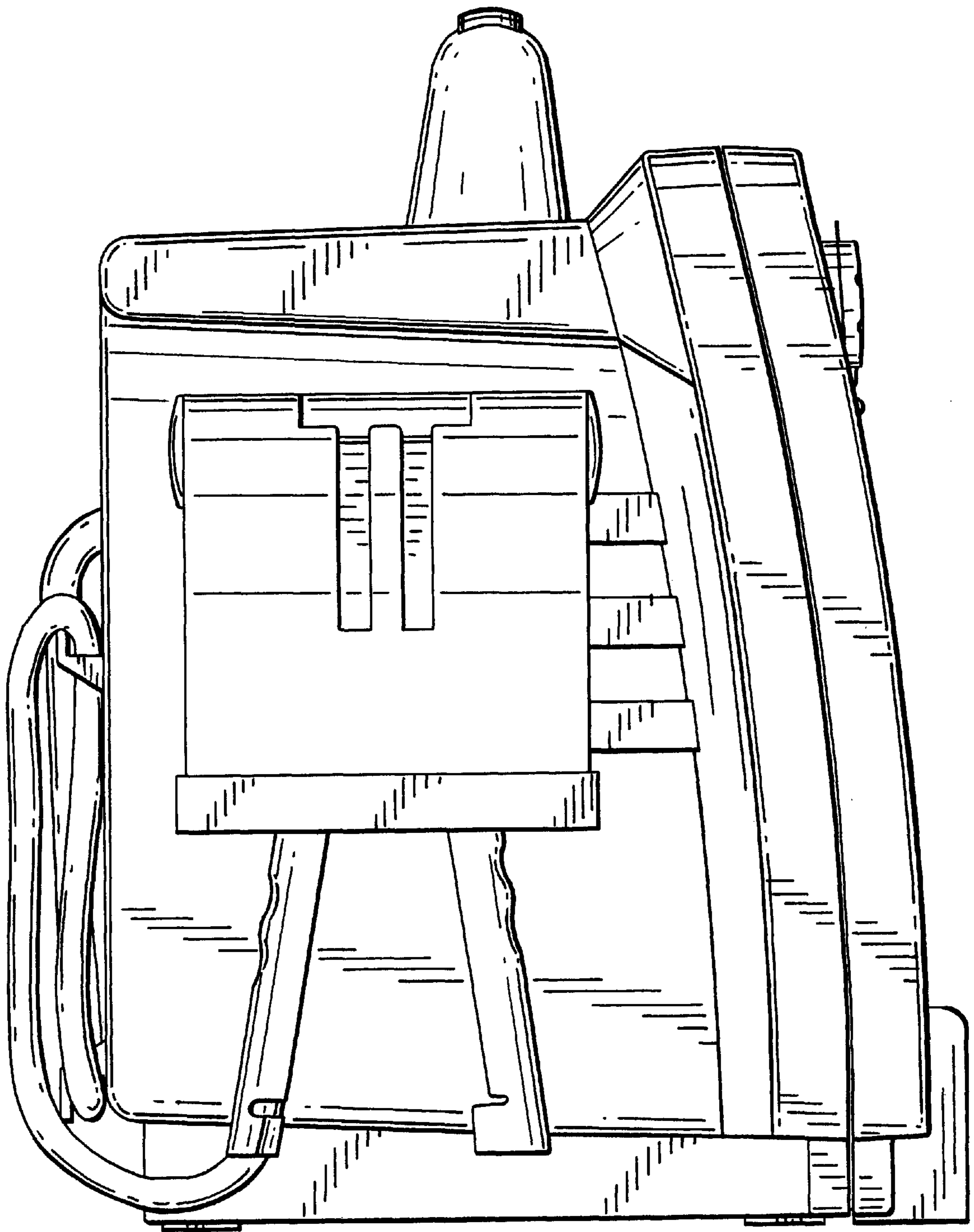

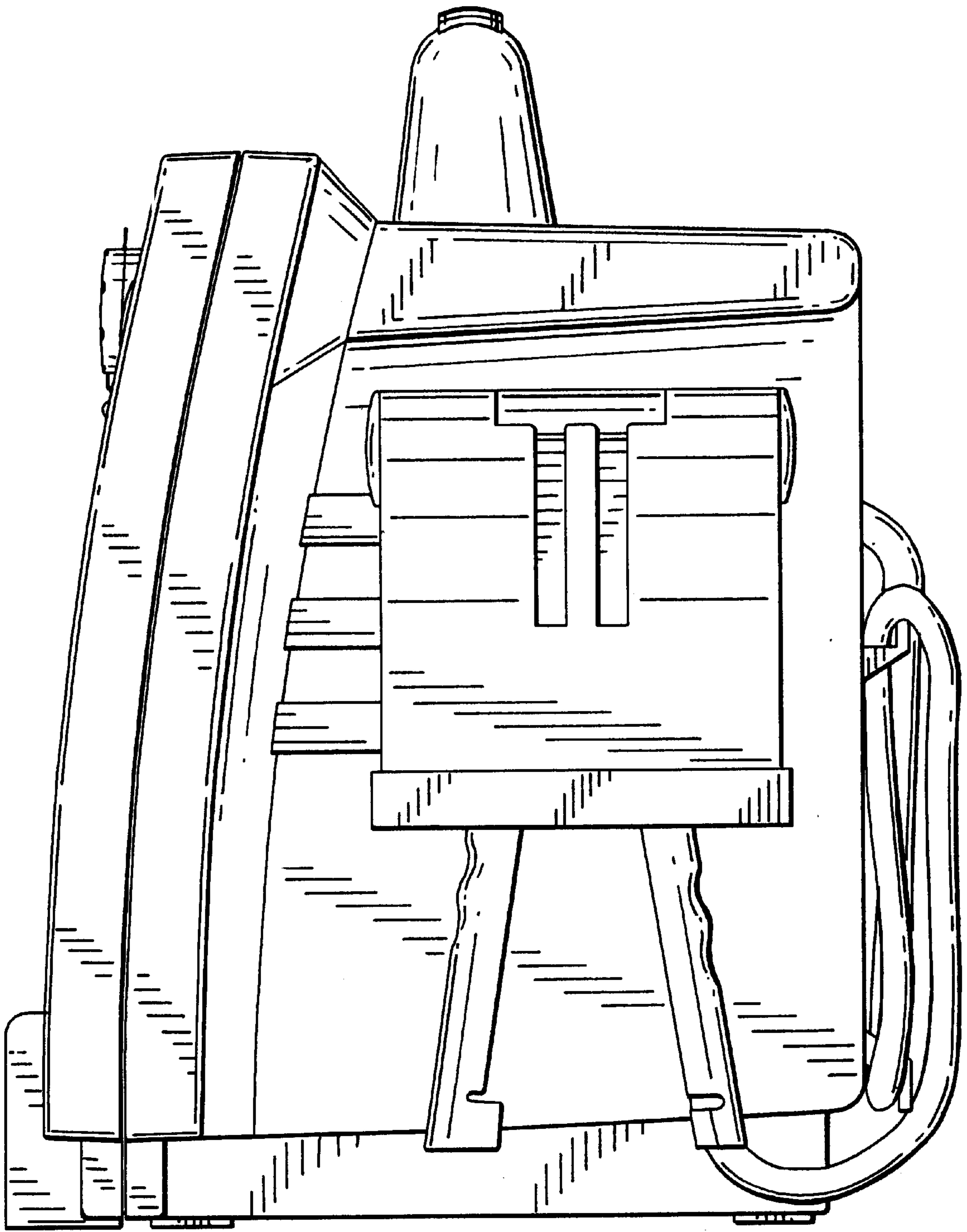

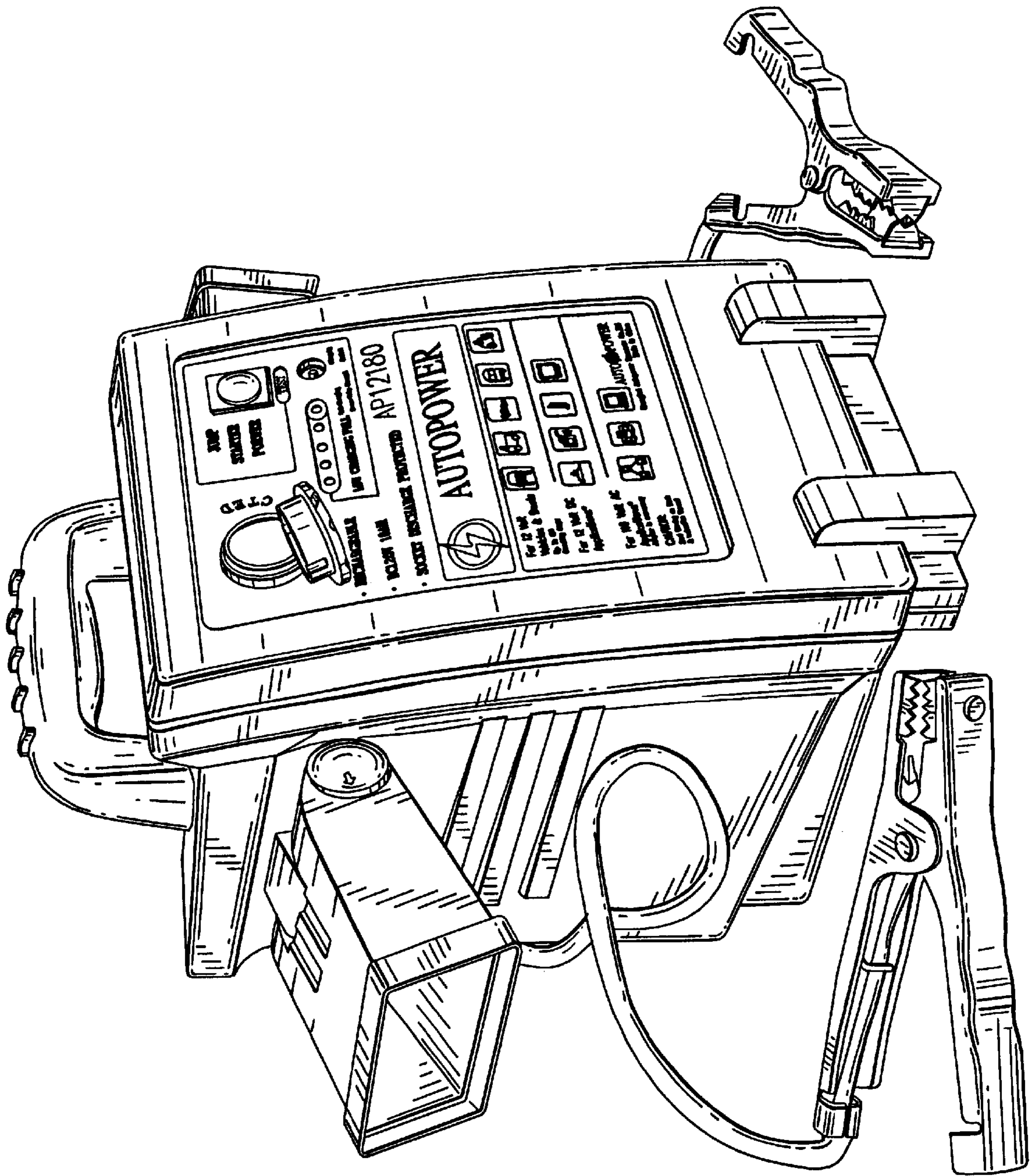
