(57) **CLAIM**

The ornamental design for a personal organizer case, as shown in the above figures and described.

**DESCRIPTION**

FIG. 1 is a front view of a personal organizer case showing my new design;

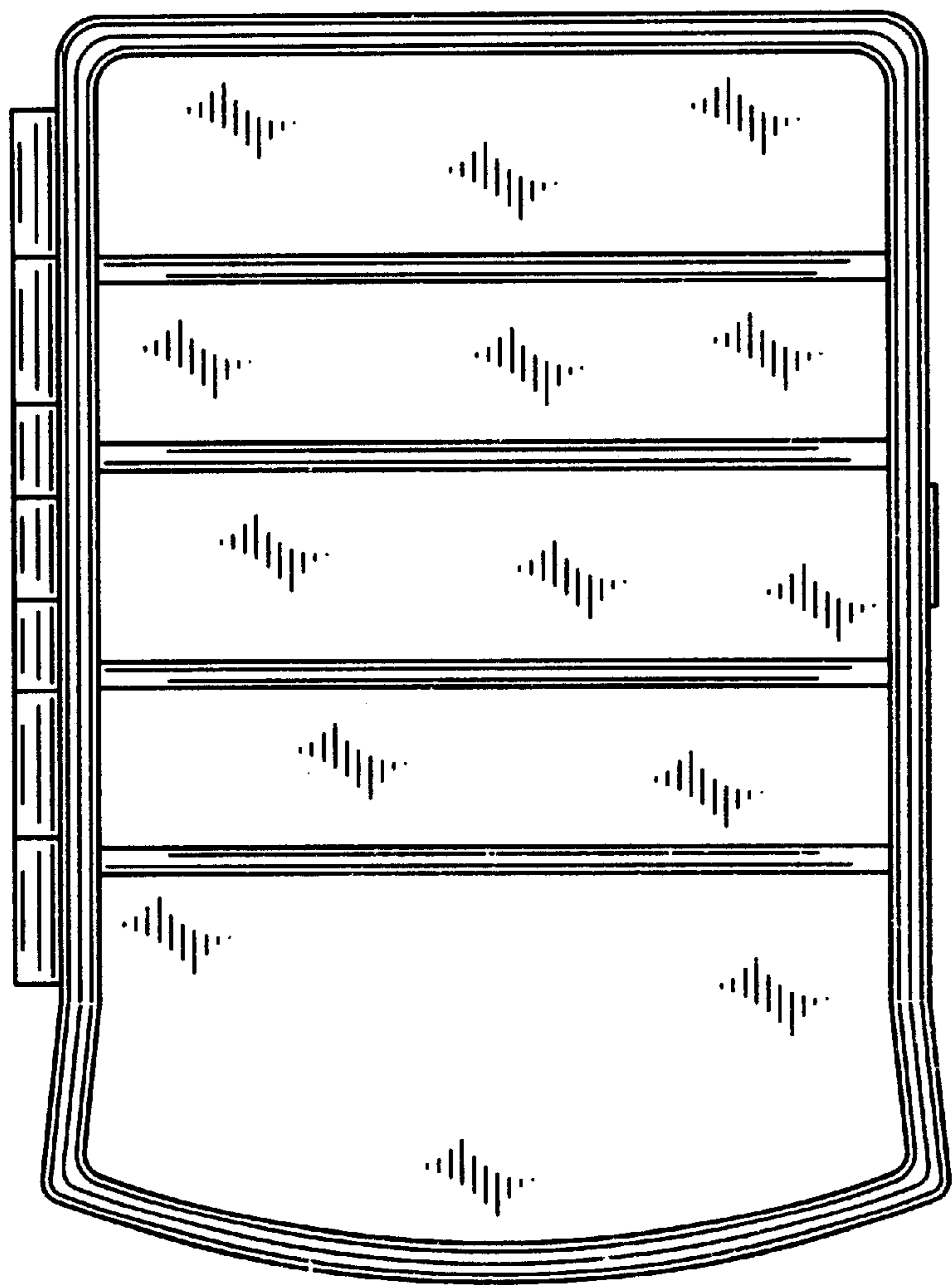

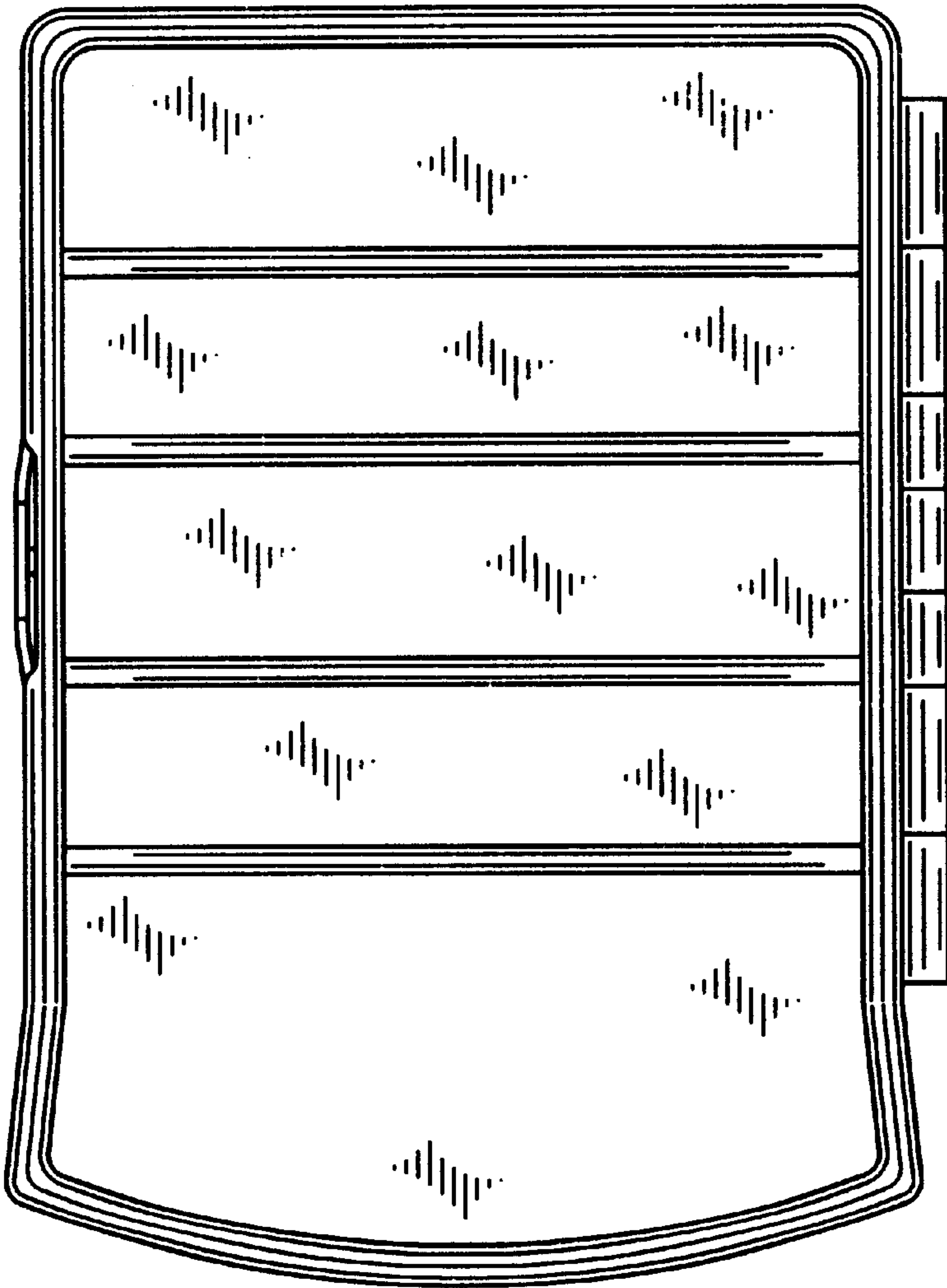

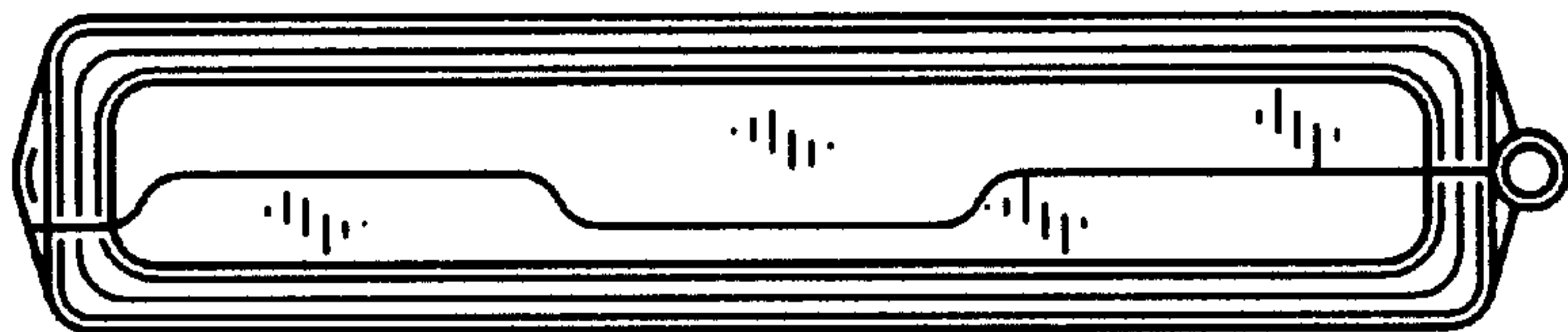

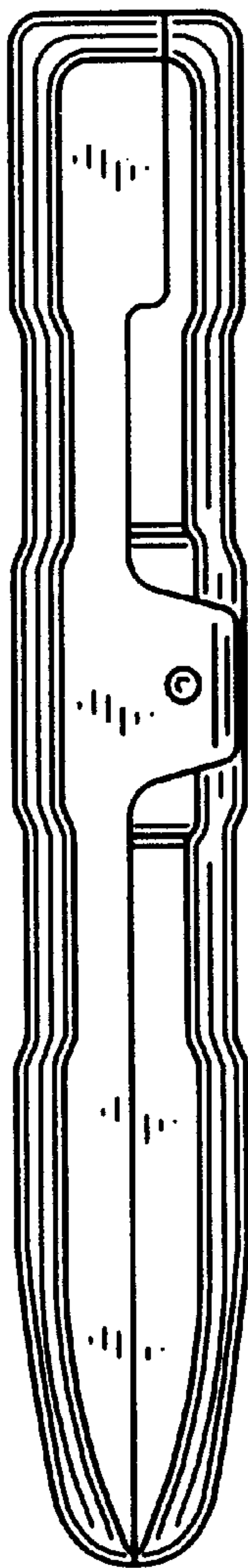

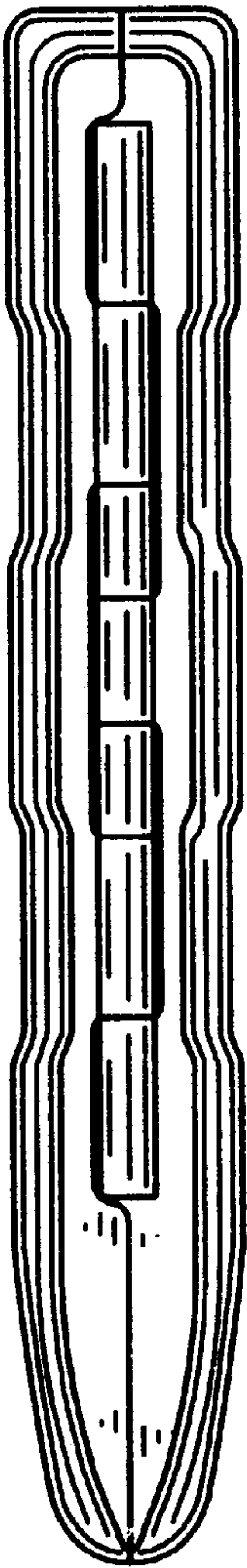

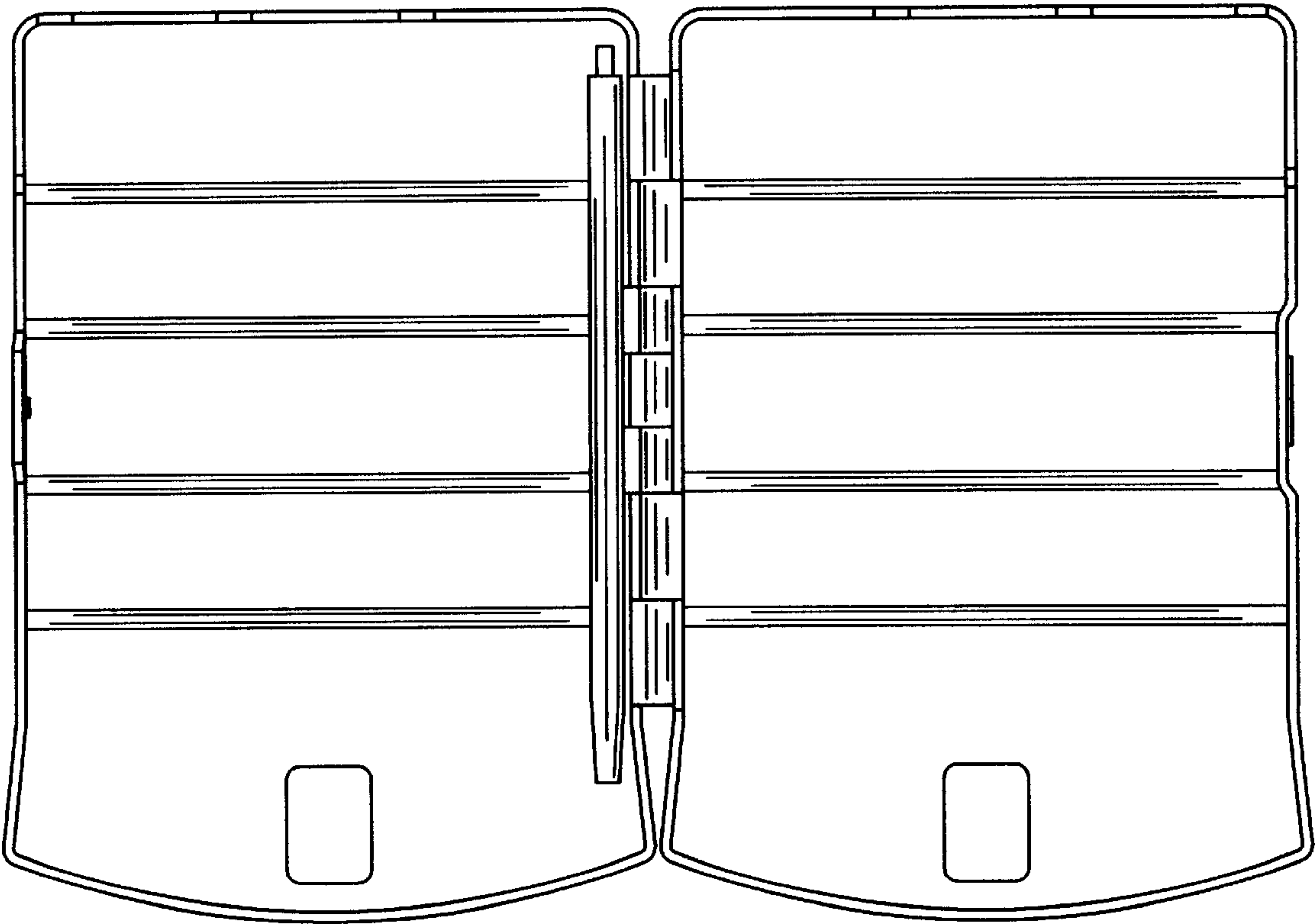

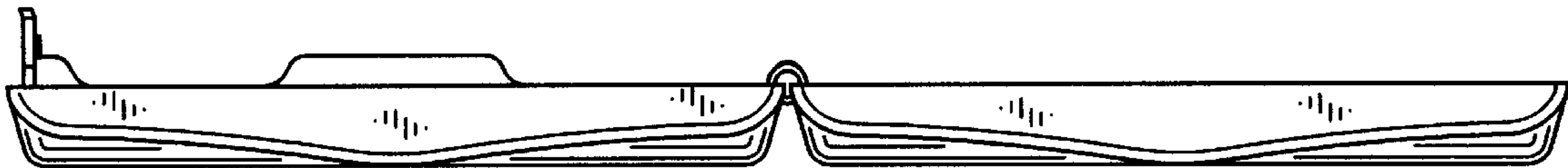

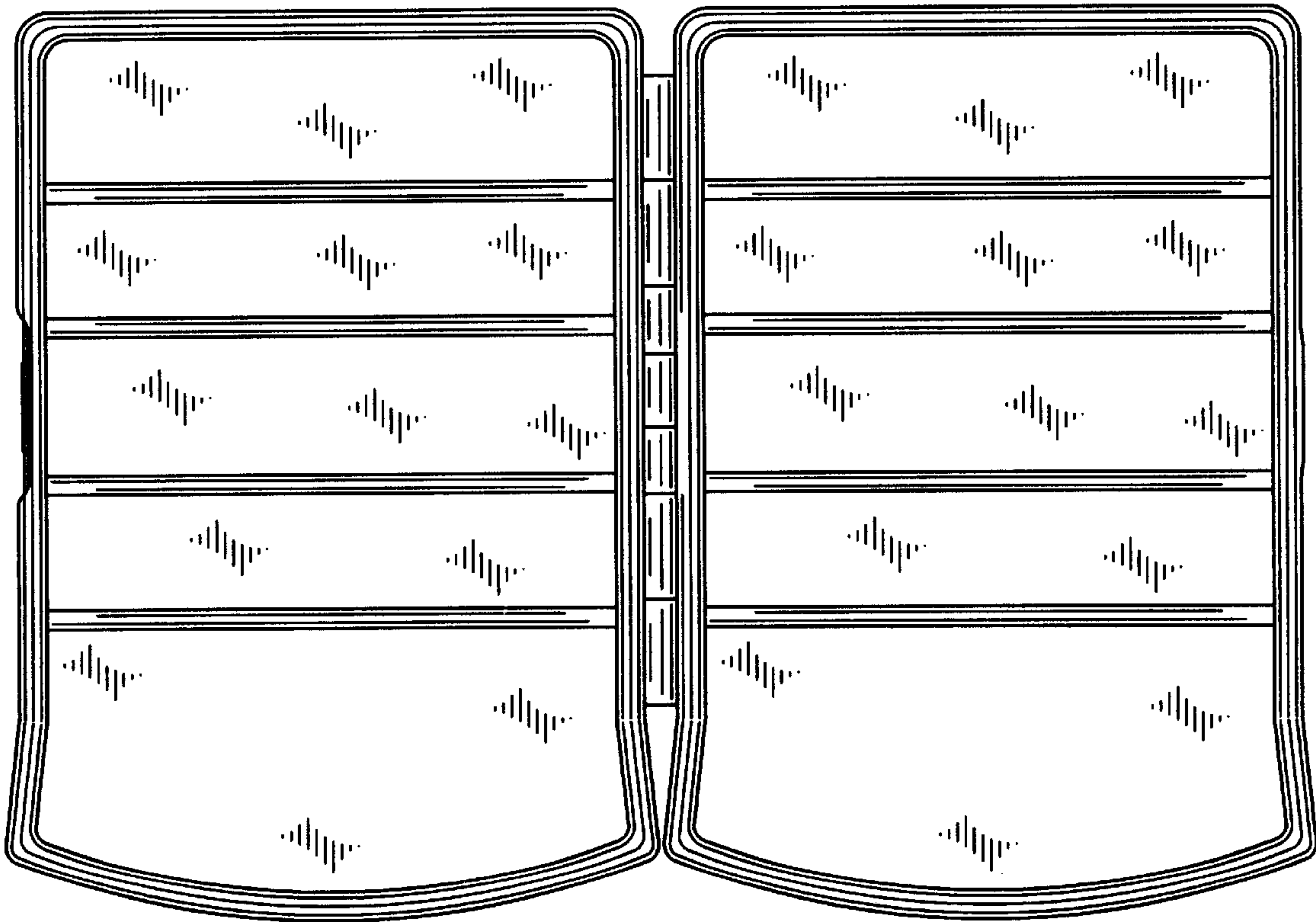

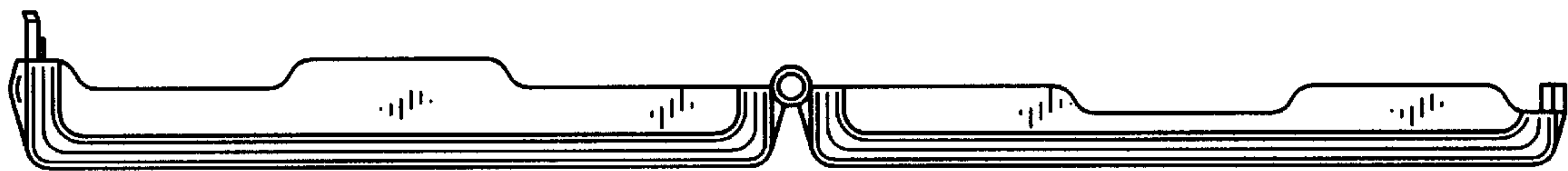

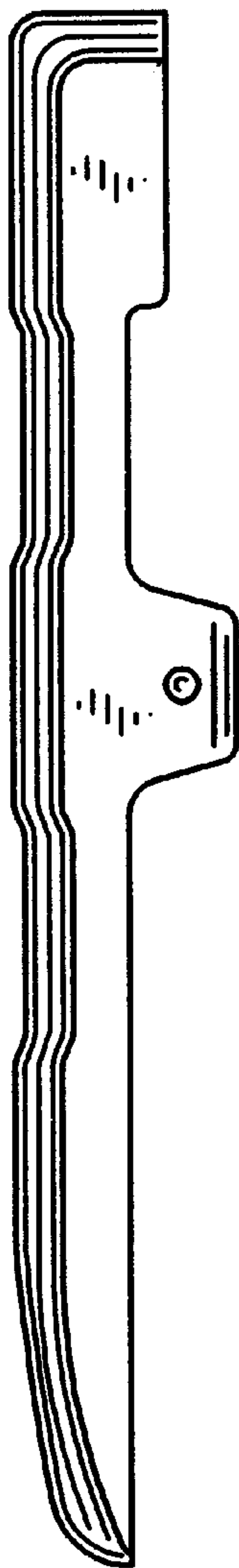

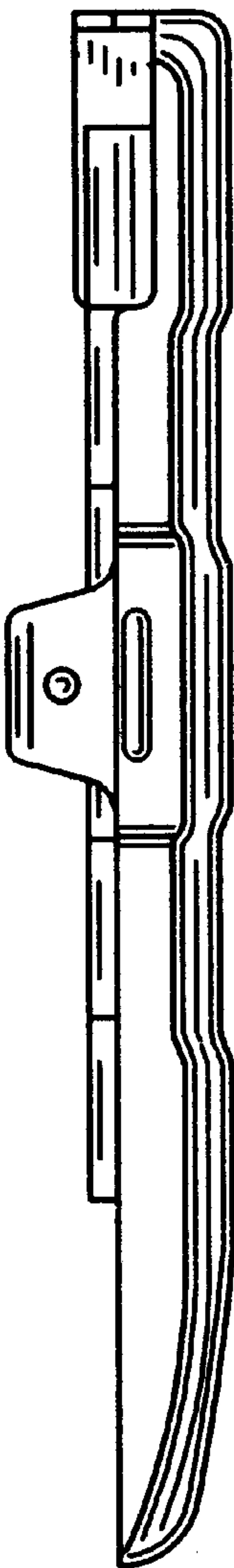

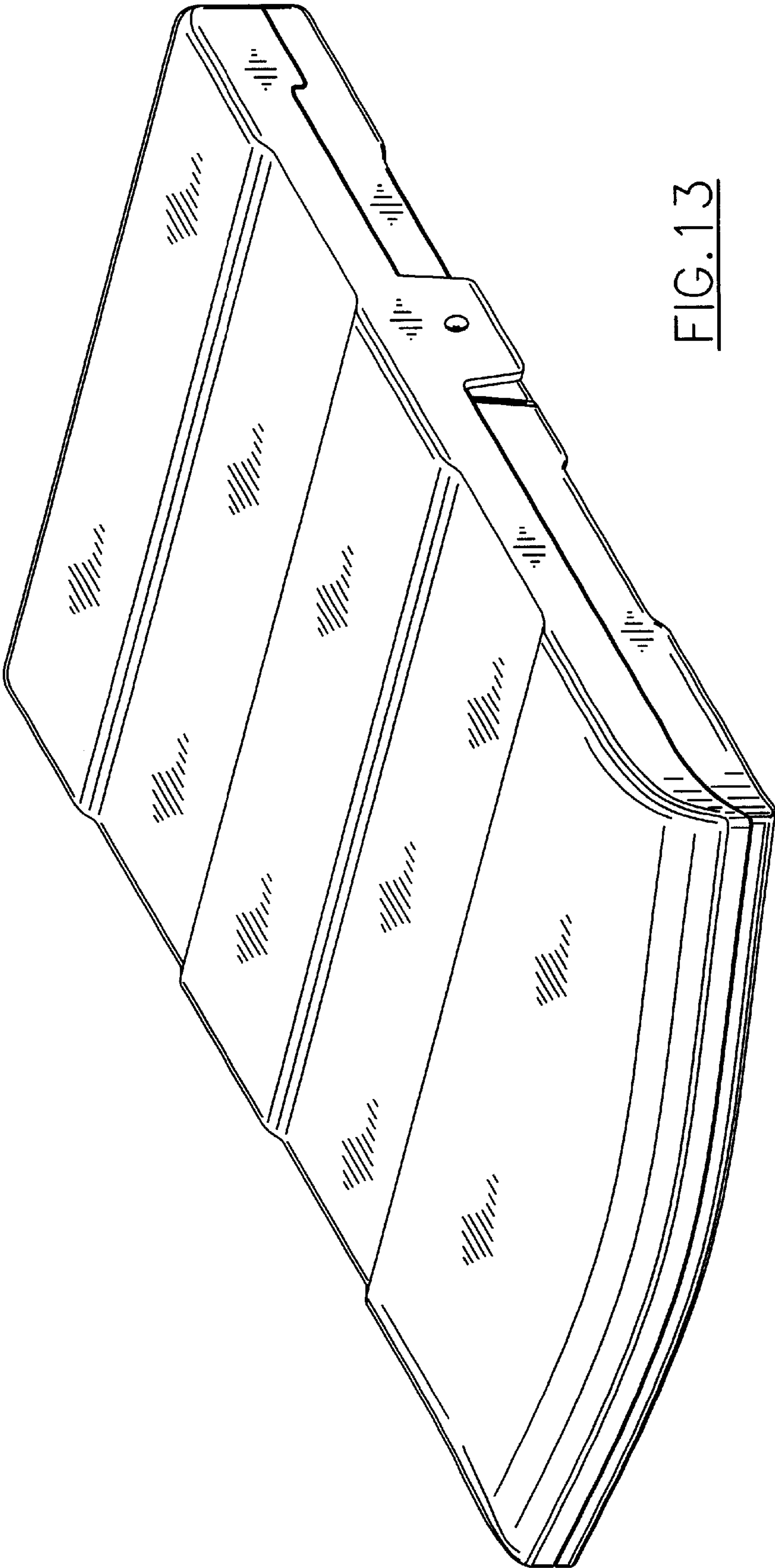
