FIG. 12 is a right side plan view thereof which is symmetric with a left side plan view;

FIG. 13 is a front side plan view of a picture holder for a corner mounted picture frame;

FIG. 14 is a top side plan view thereof;

FIG. 15 is a bottom side plan view thereof;

FIG. 16 is a rear side plan view thereof;

FIG. 17 is a right side plan view thereof; and,

FIG. 18 is a left side plan view thereof.

FIGS. 8-18 show the mounting bracket and picture holder separately for convenience of illustration.

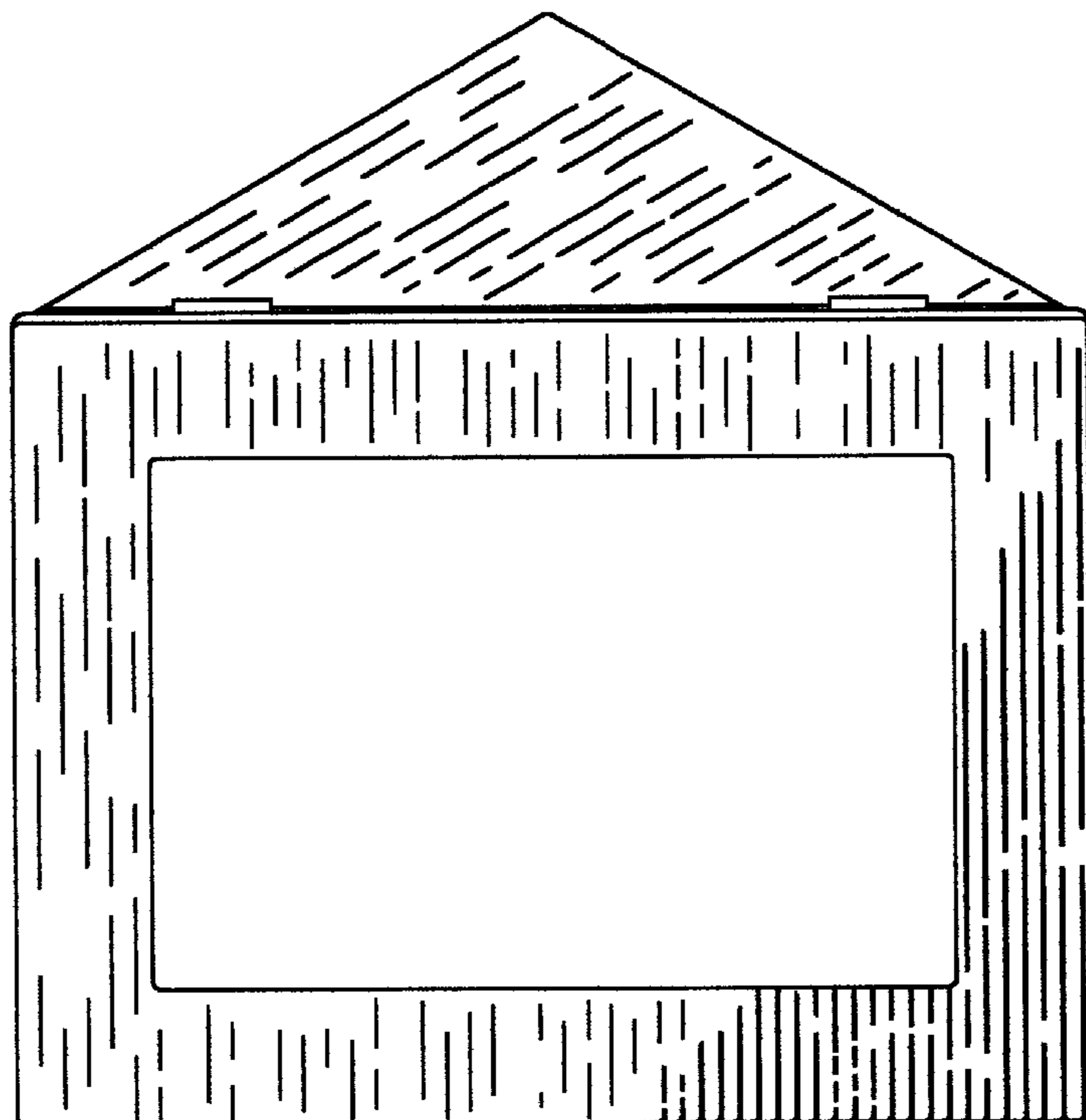

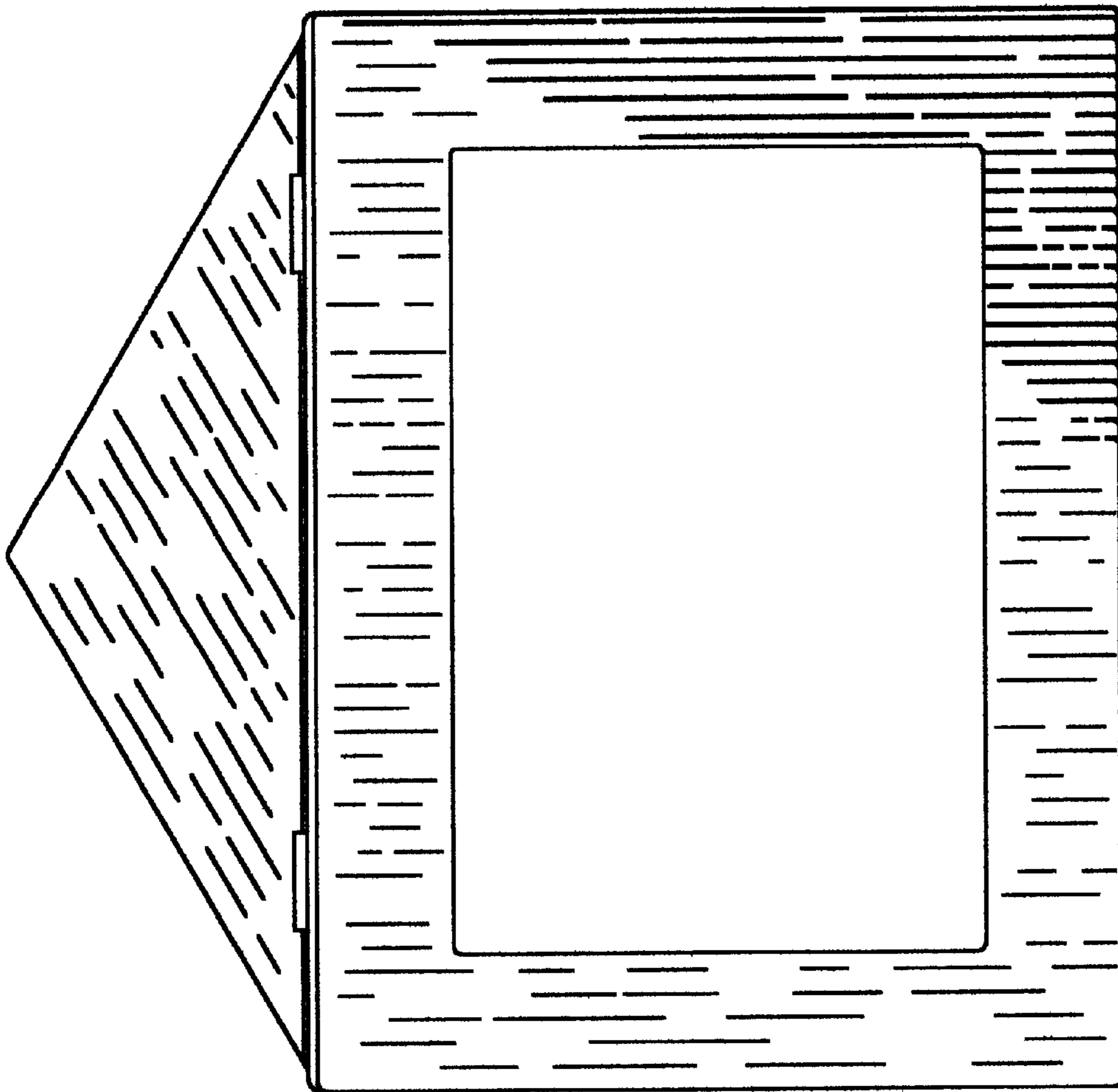

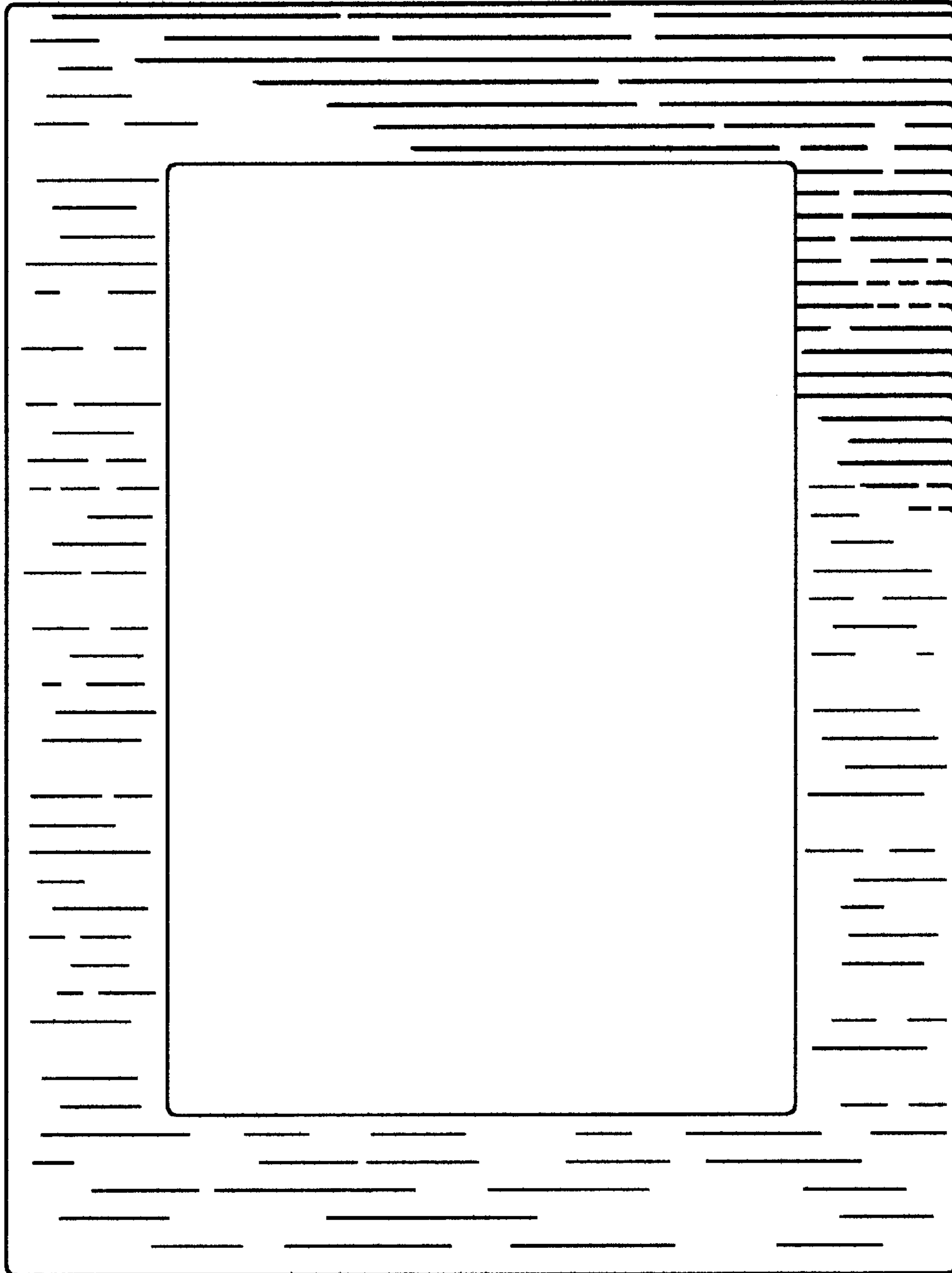

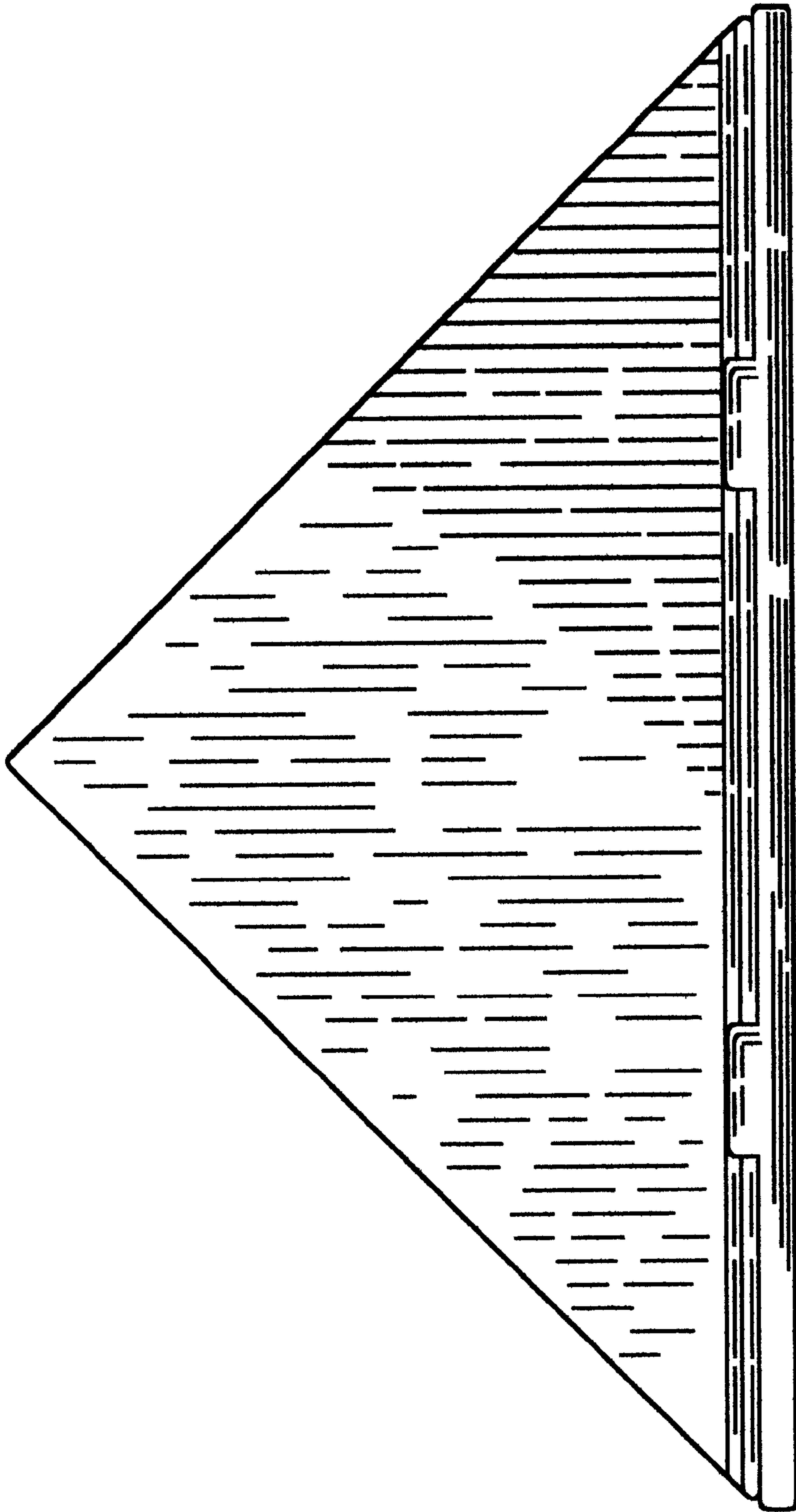

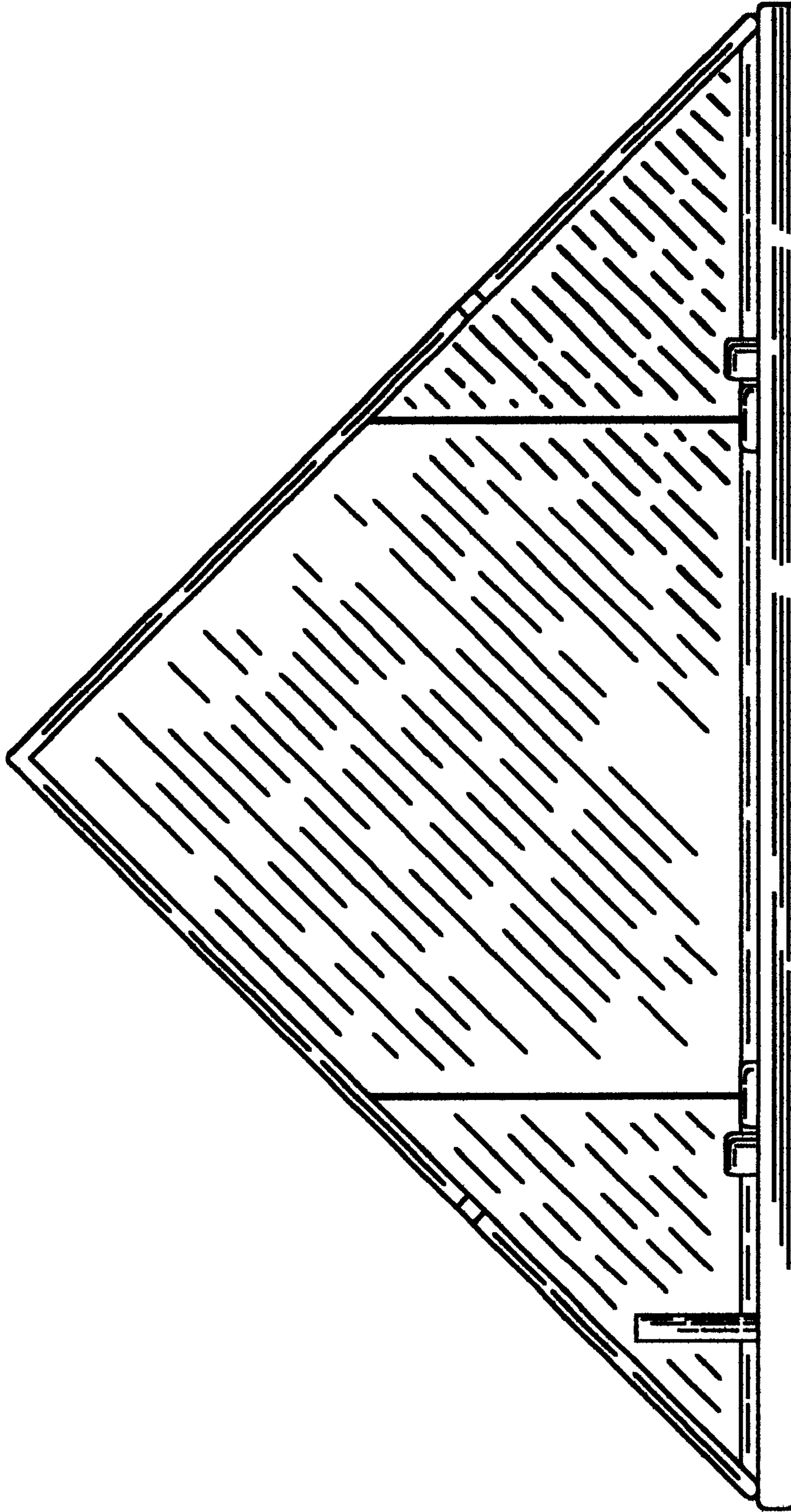

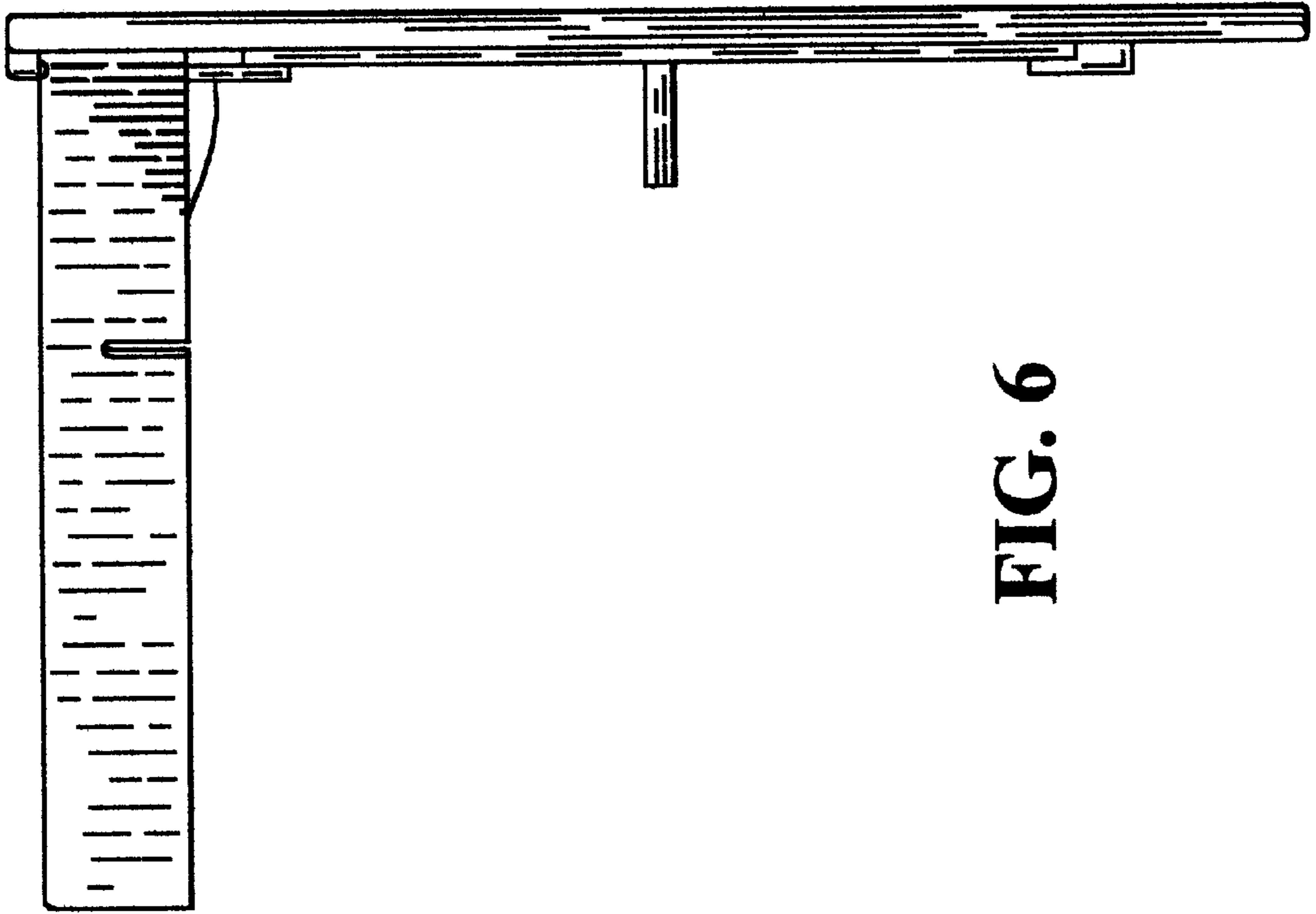

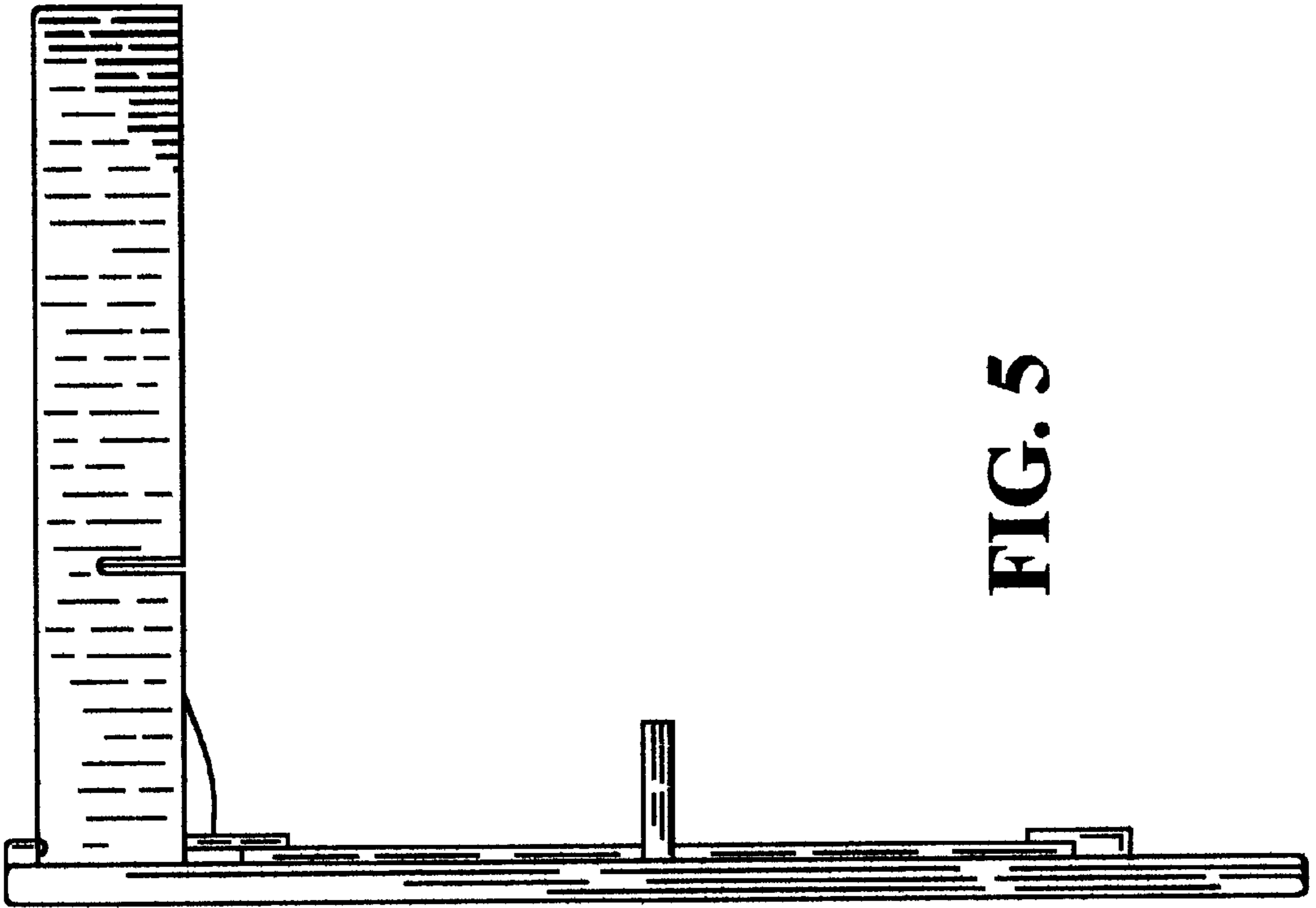

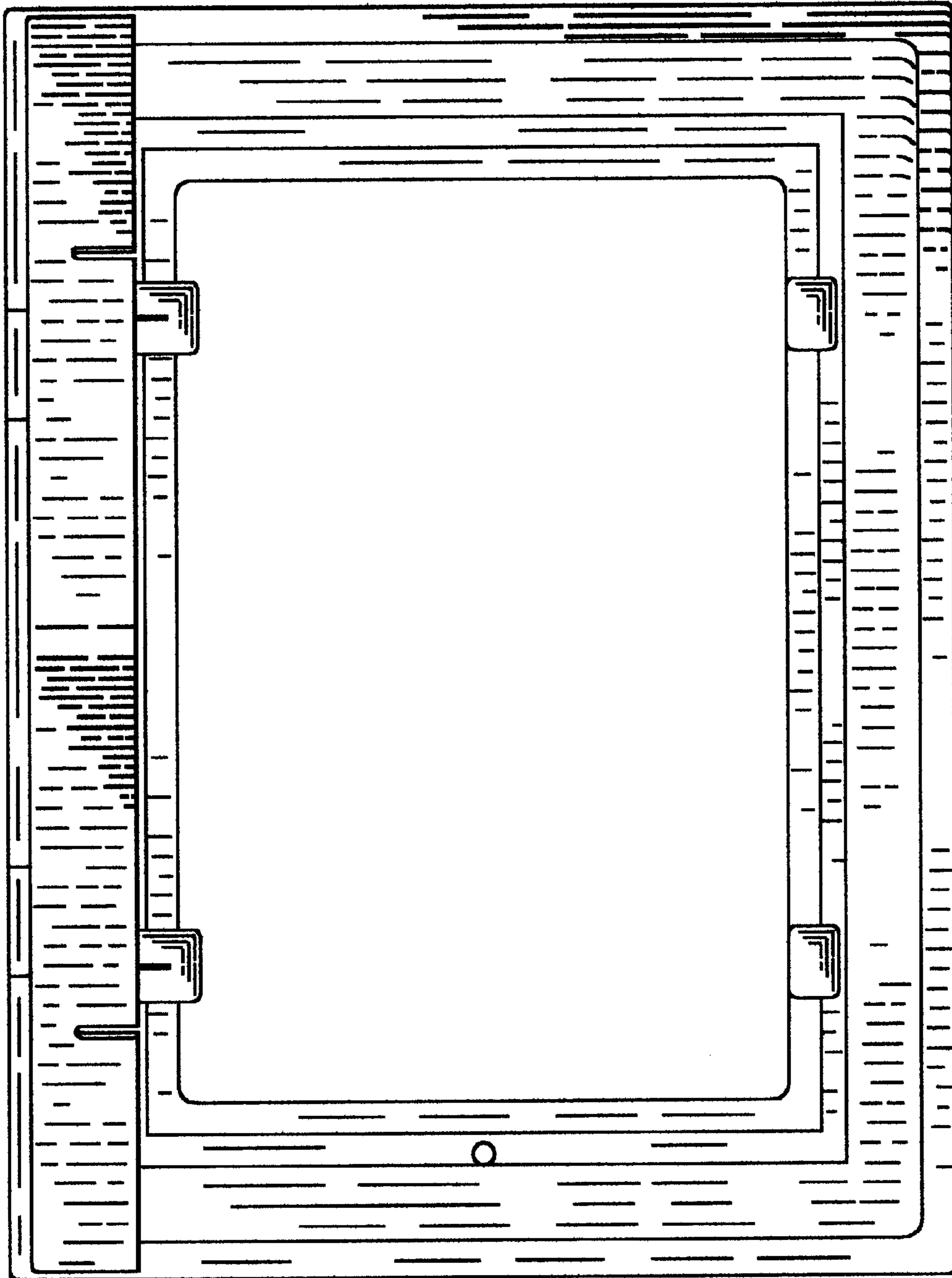

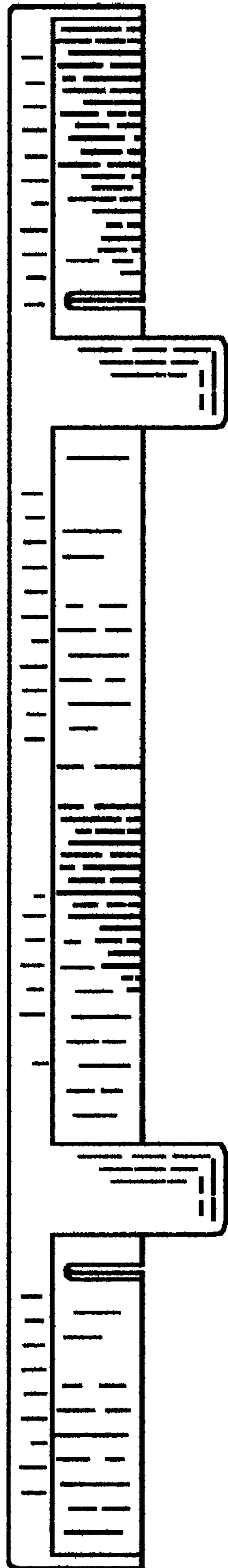

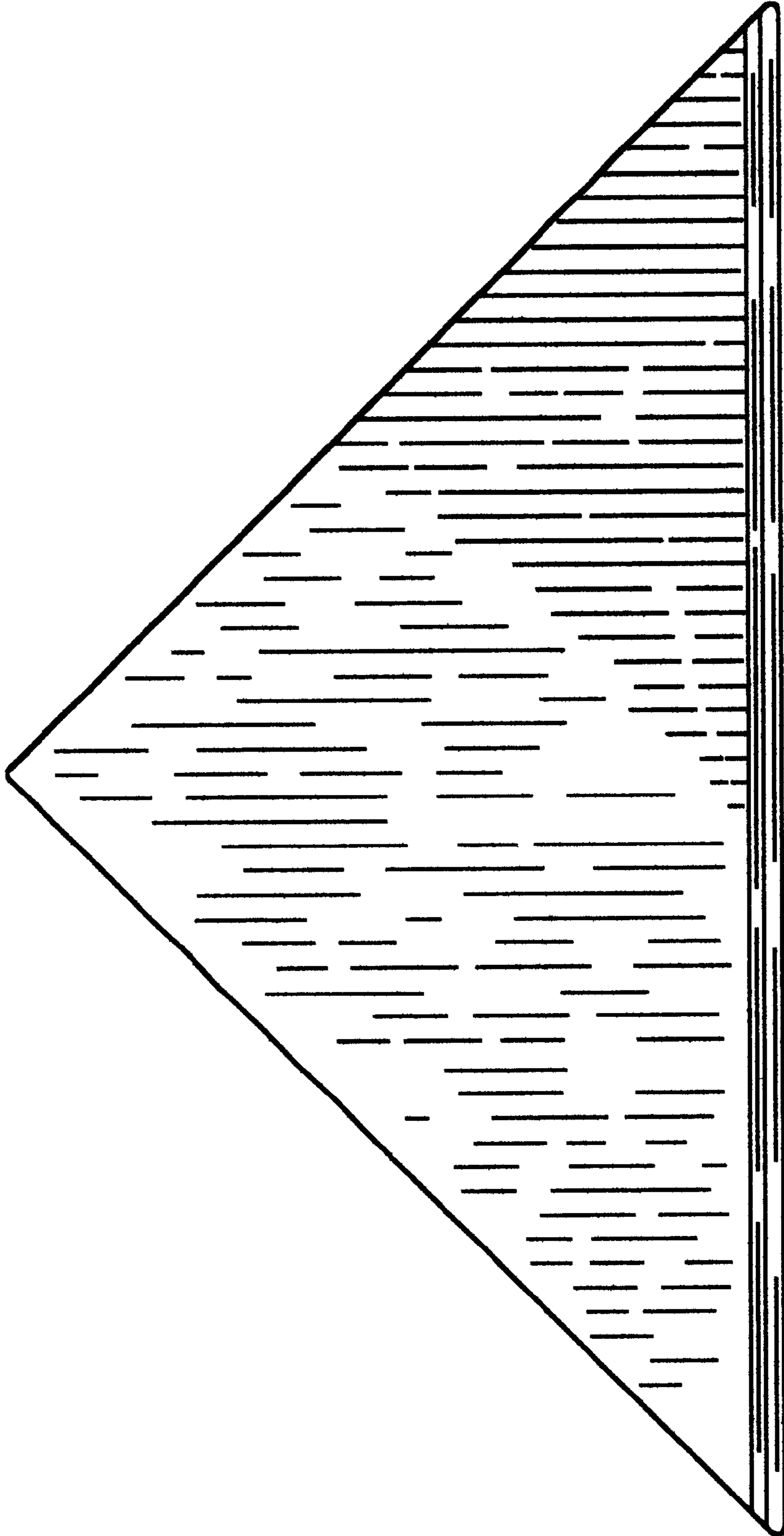

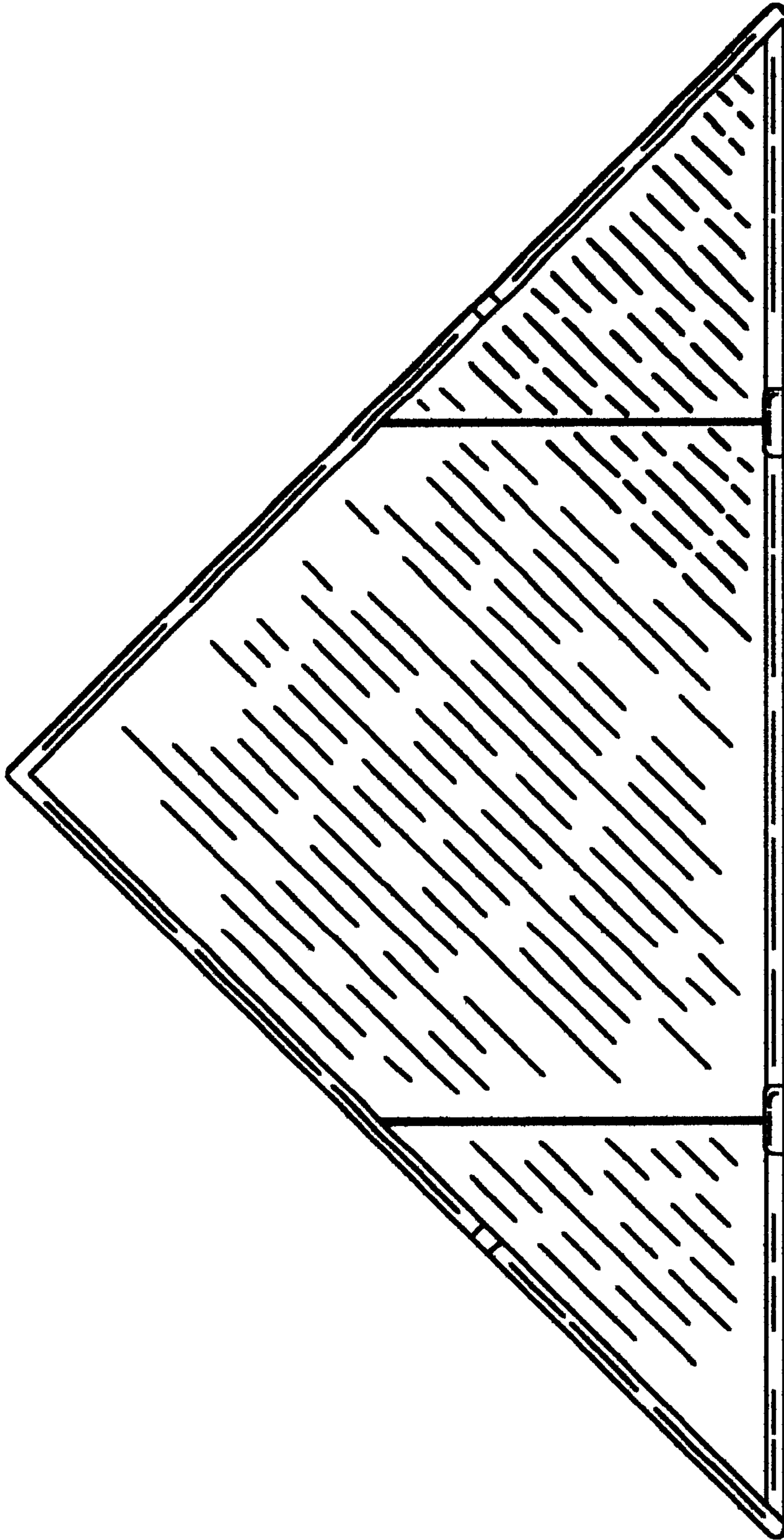

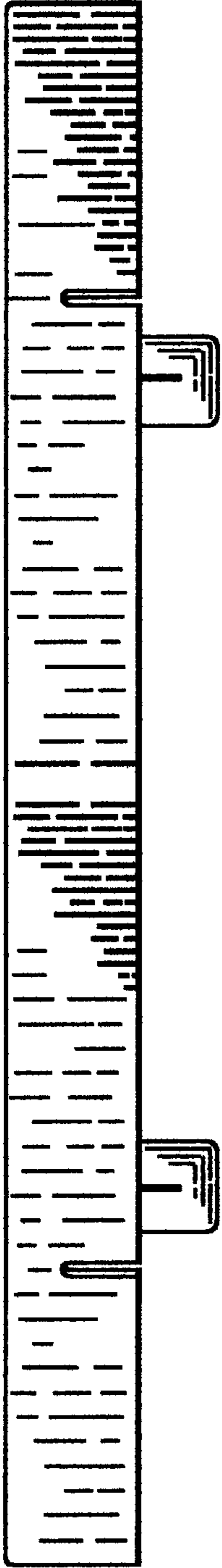

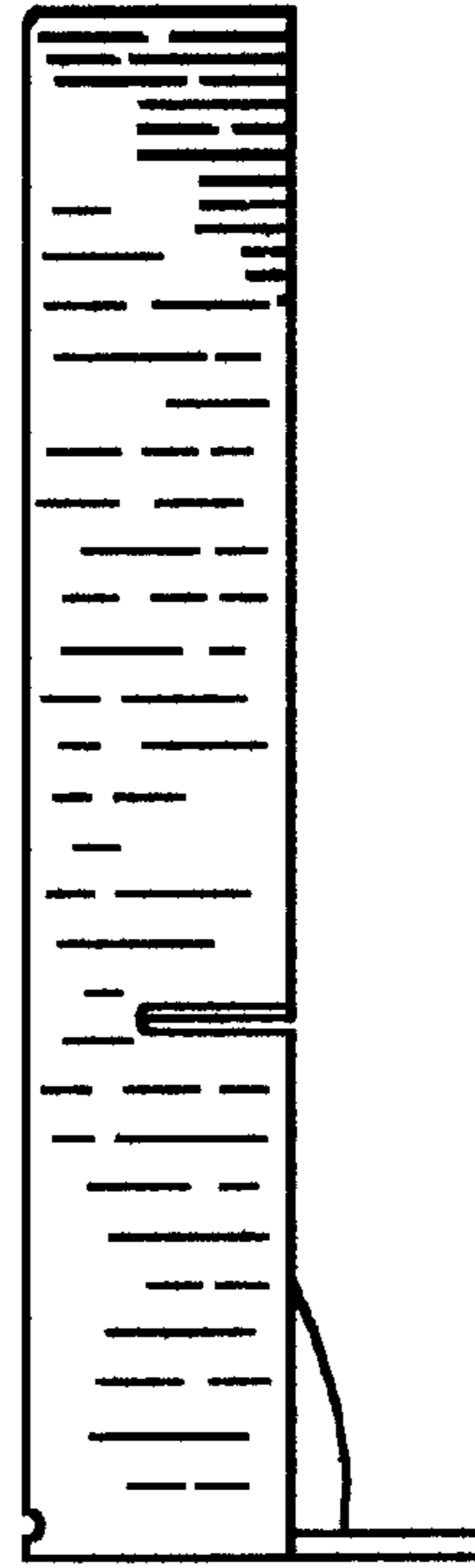

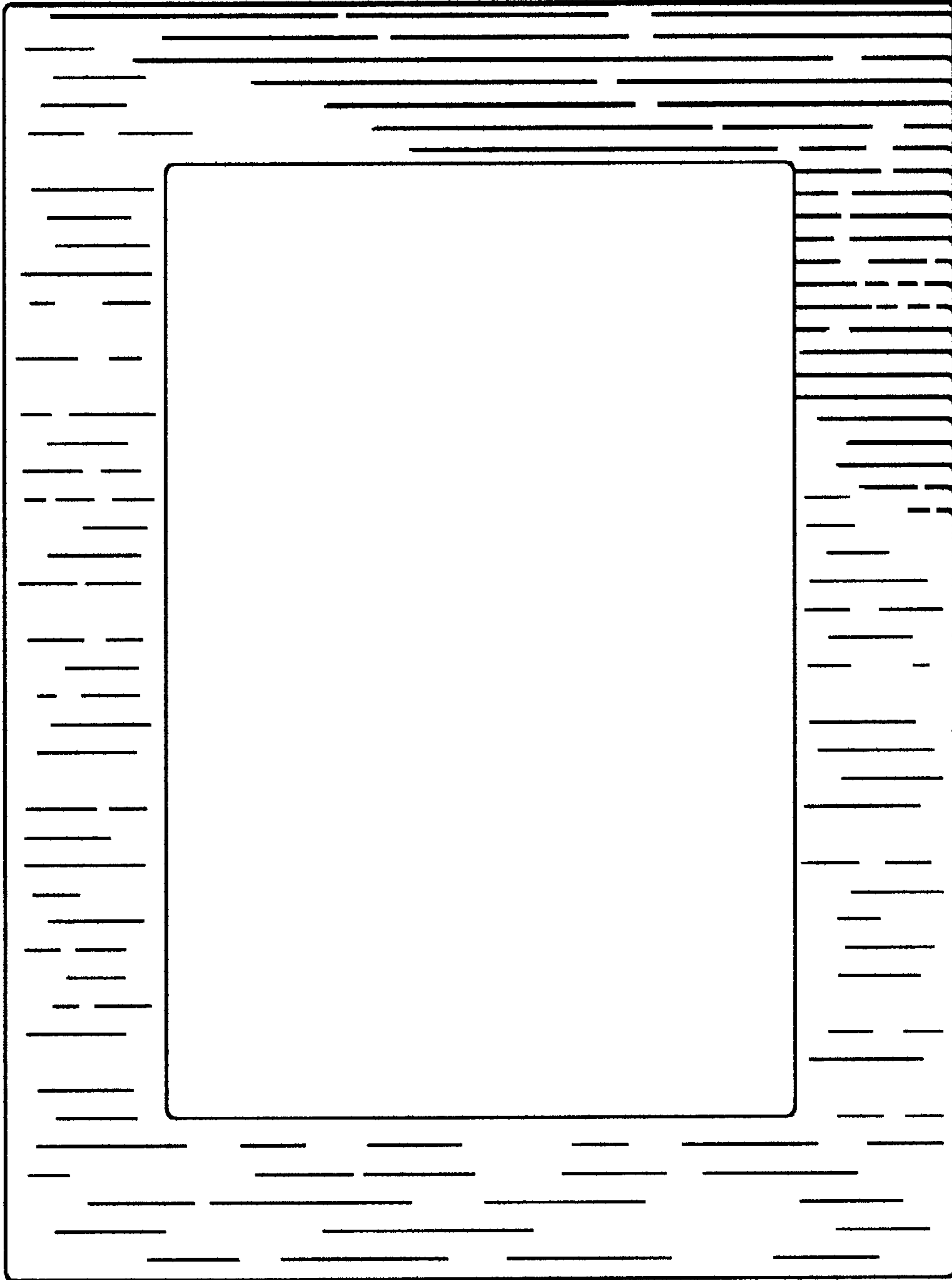

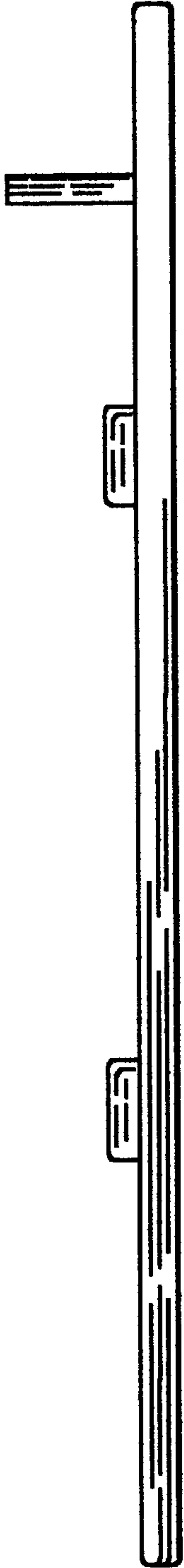

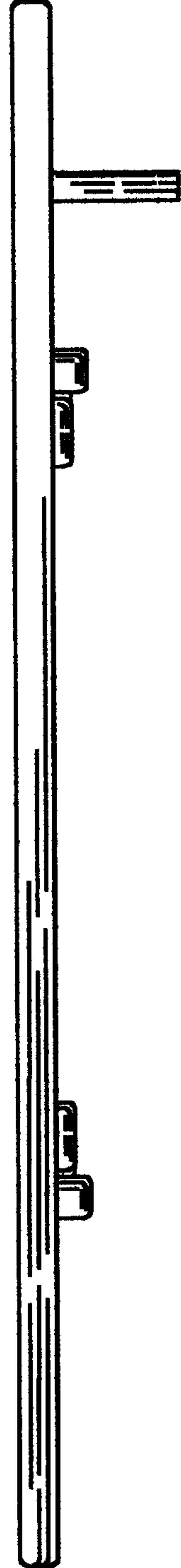

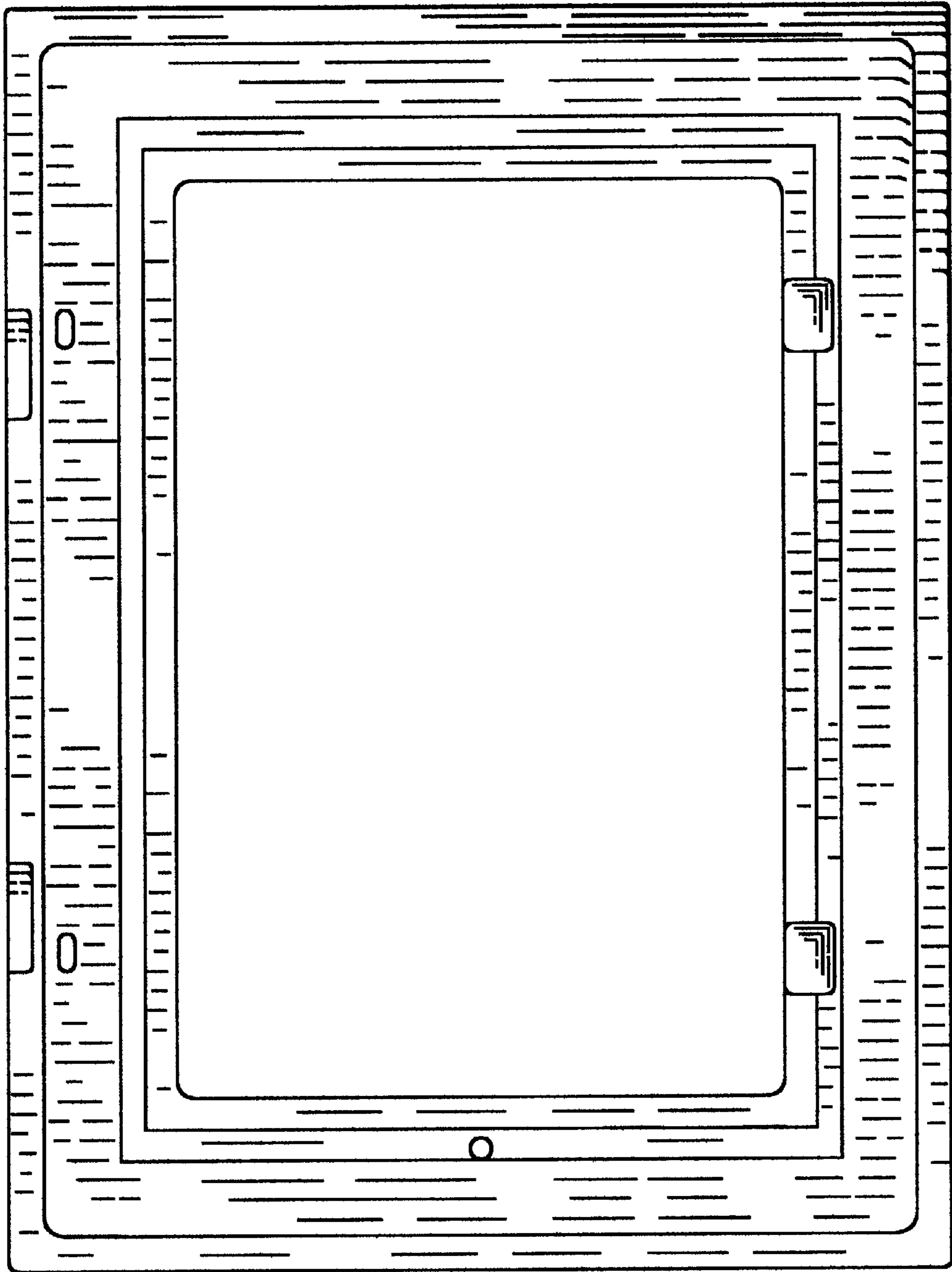

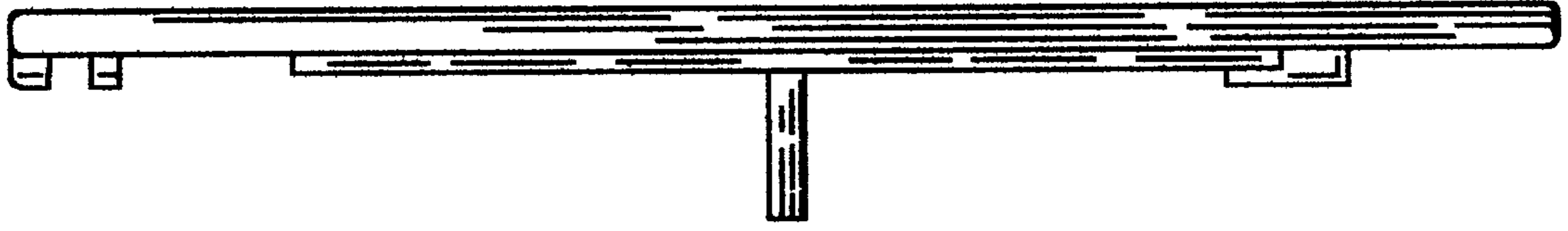

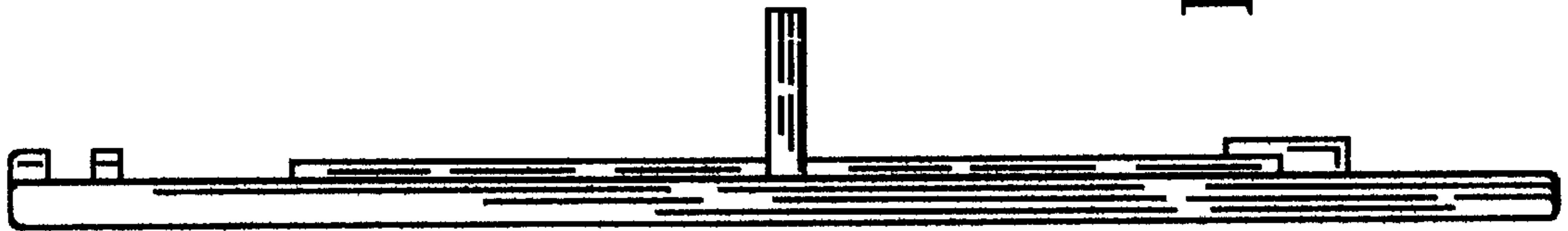
