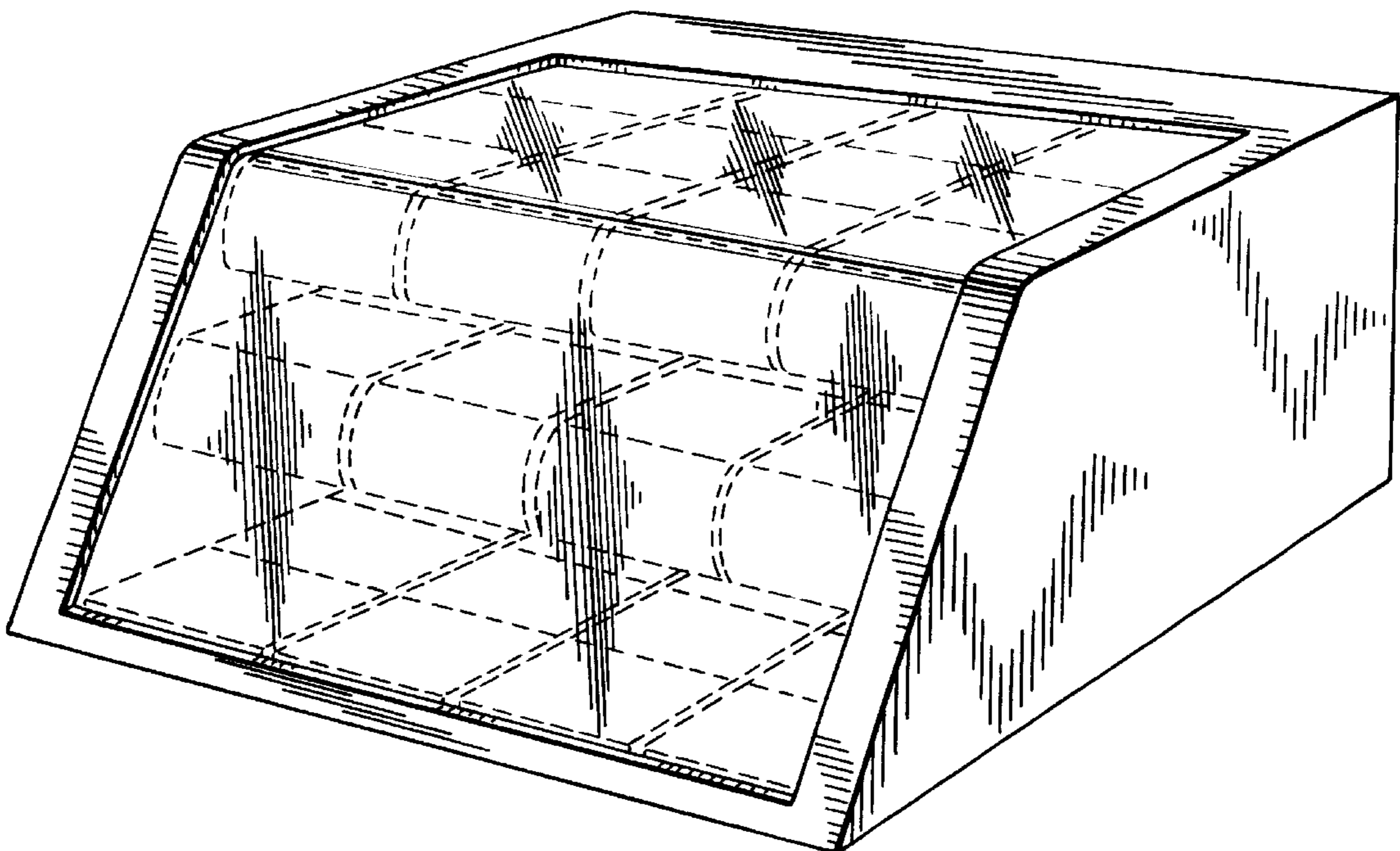
(57) **CLAIM**

The ornamental design for a counter top lottery ticket dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a counter top lottery ticket dispenser showing our new design; FIG. 2 is a top, rear, and left side perspective view thereof; and, FIG. 3 is a front elevational view thereof. The broken-line disclosure in the views is for illustrative purposes only and forms no part of the claimed design.

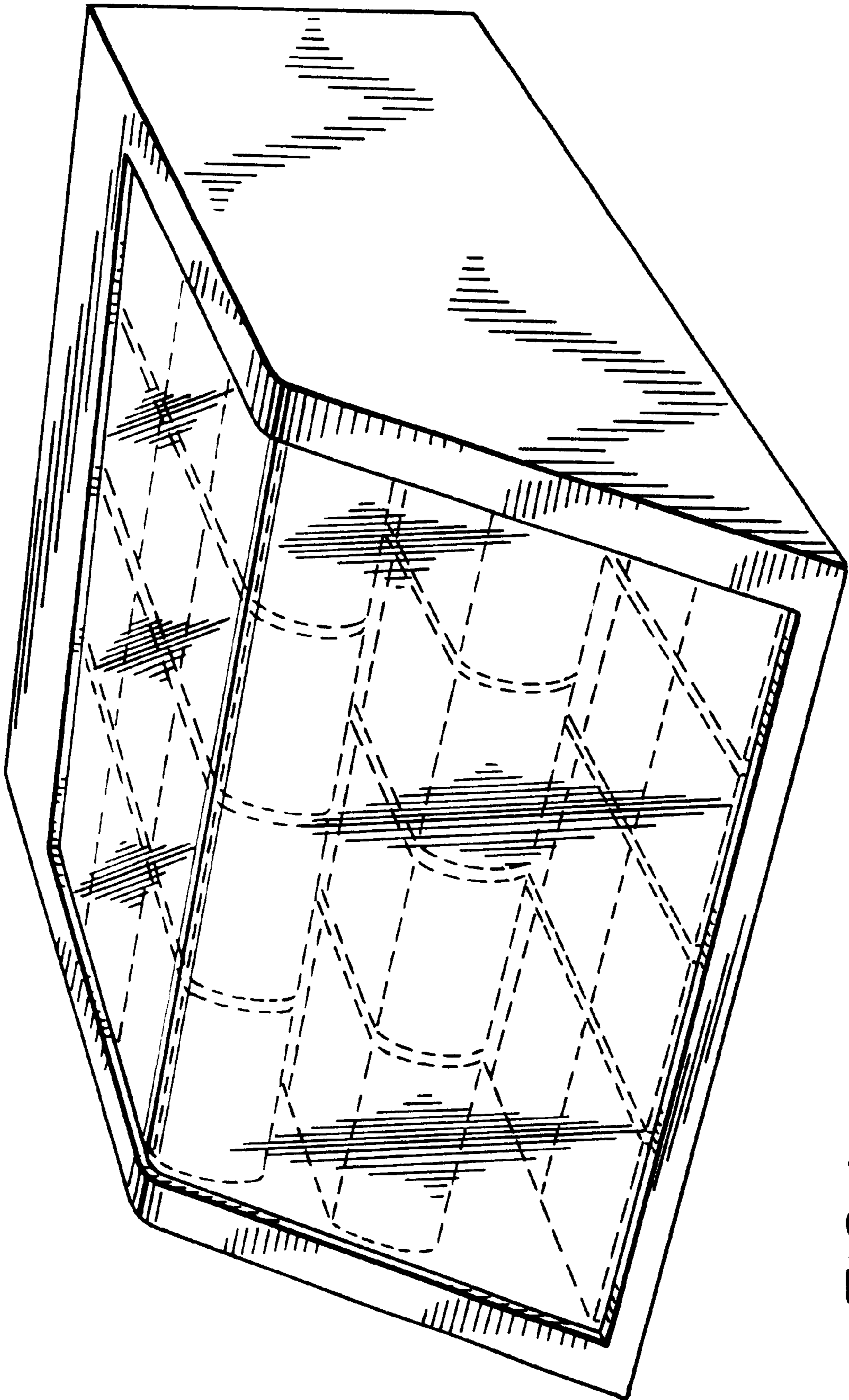

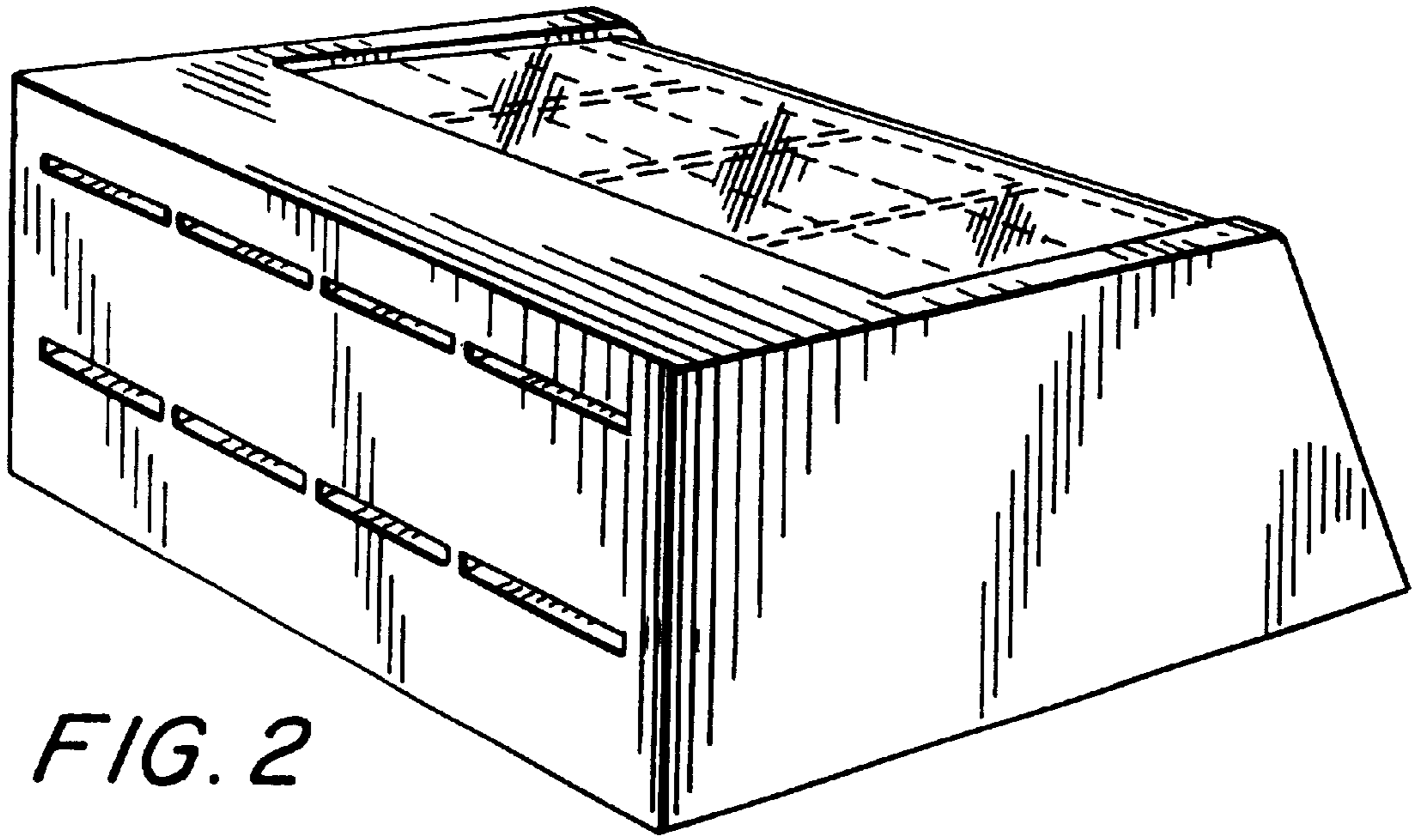

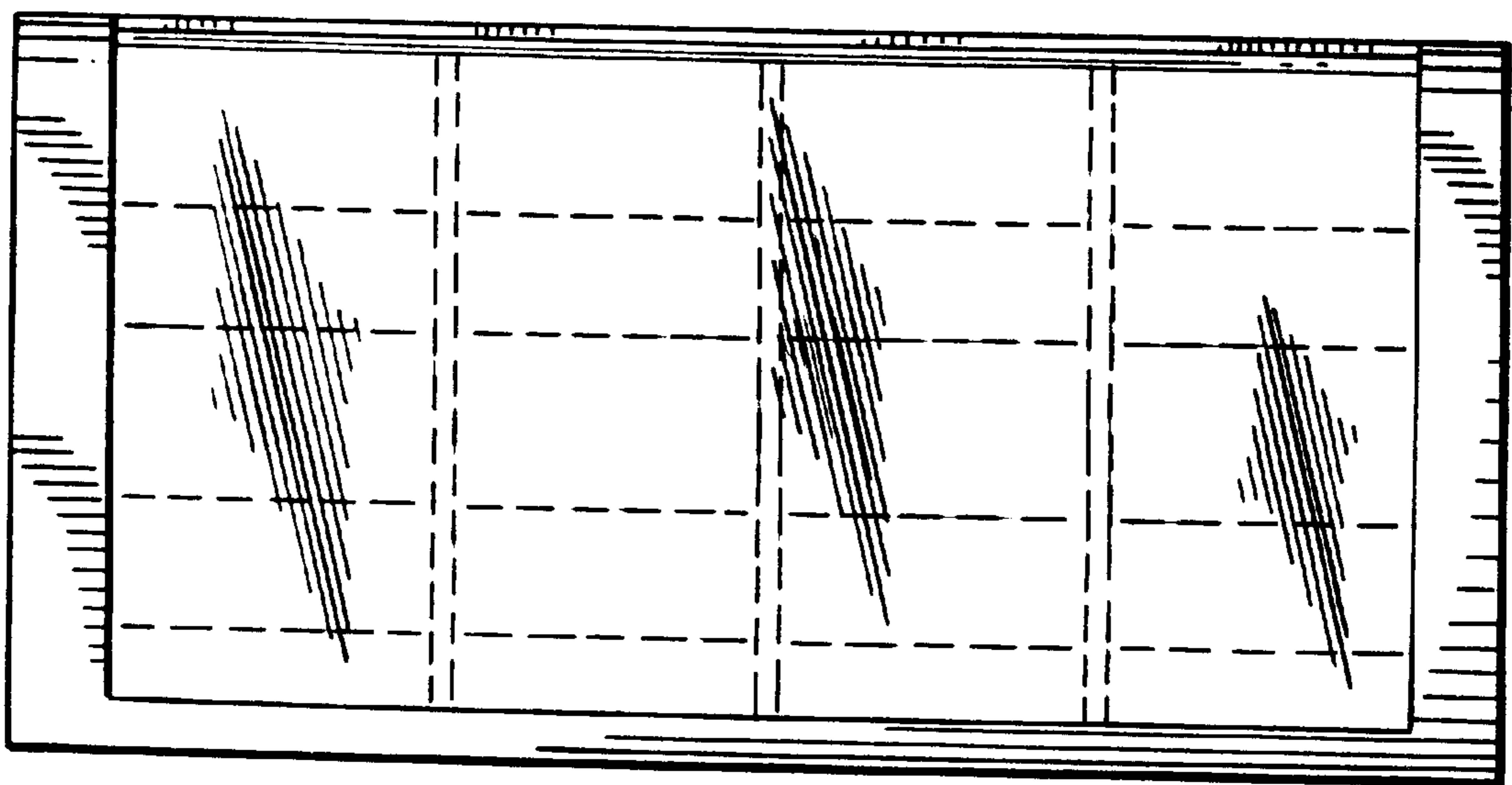
