FIG. 10 is a perspective view showing a fifth embodiment of my design.

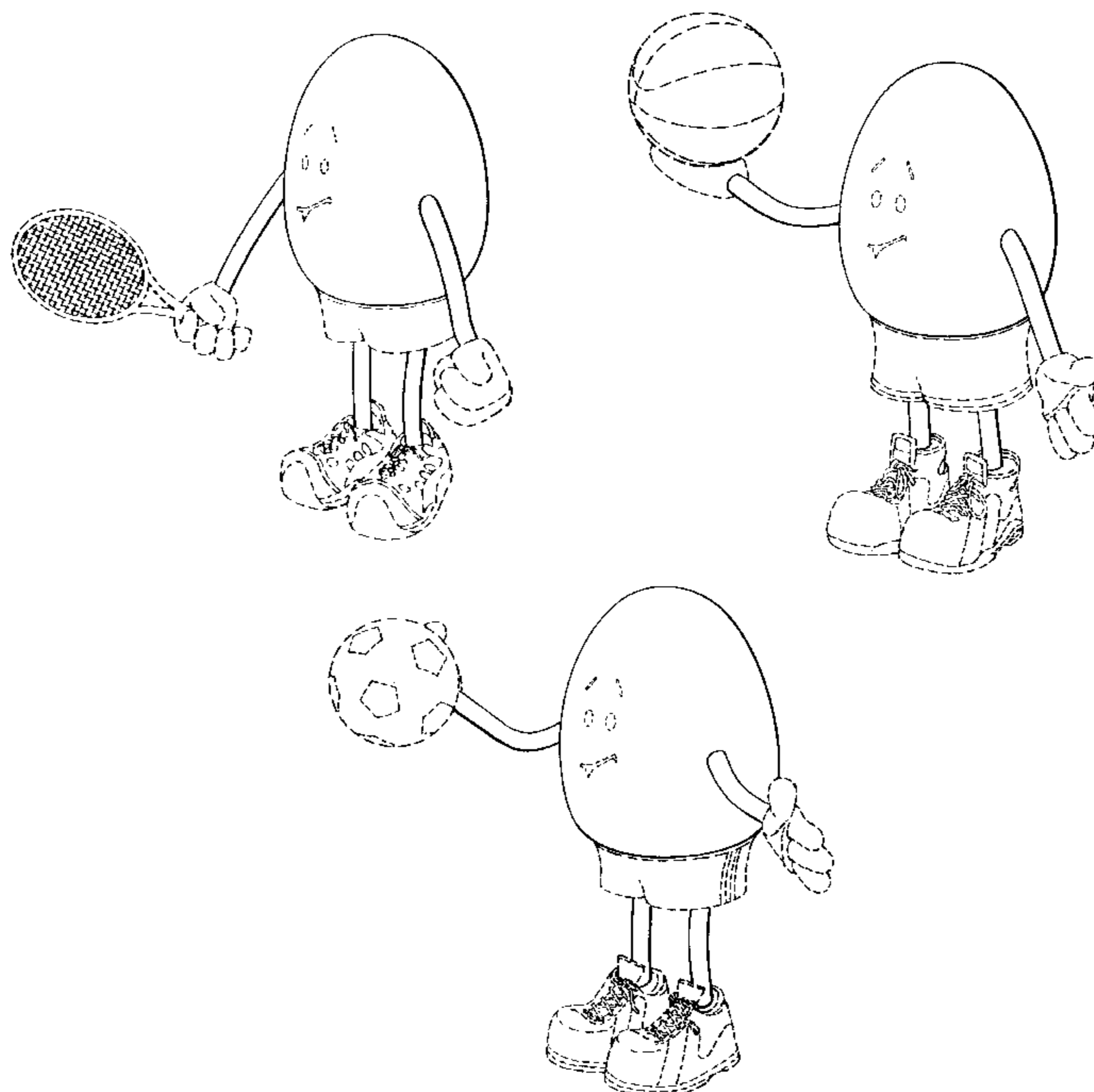

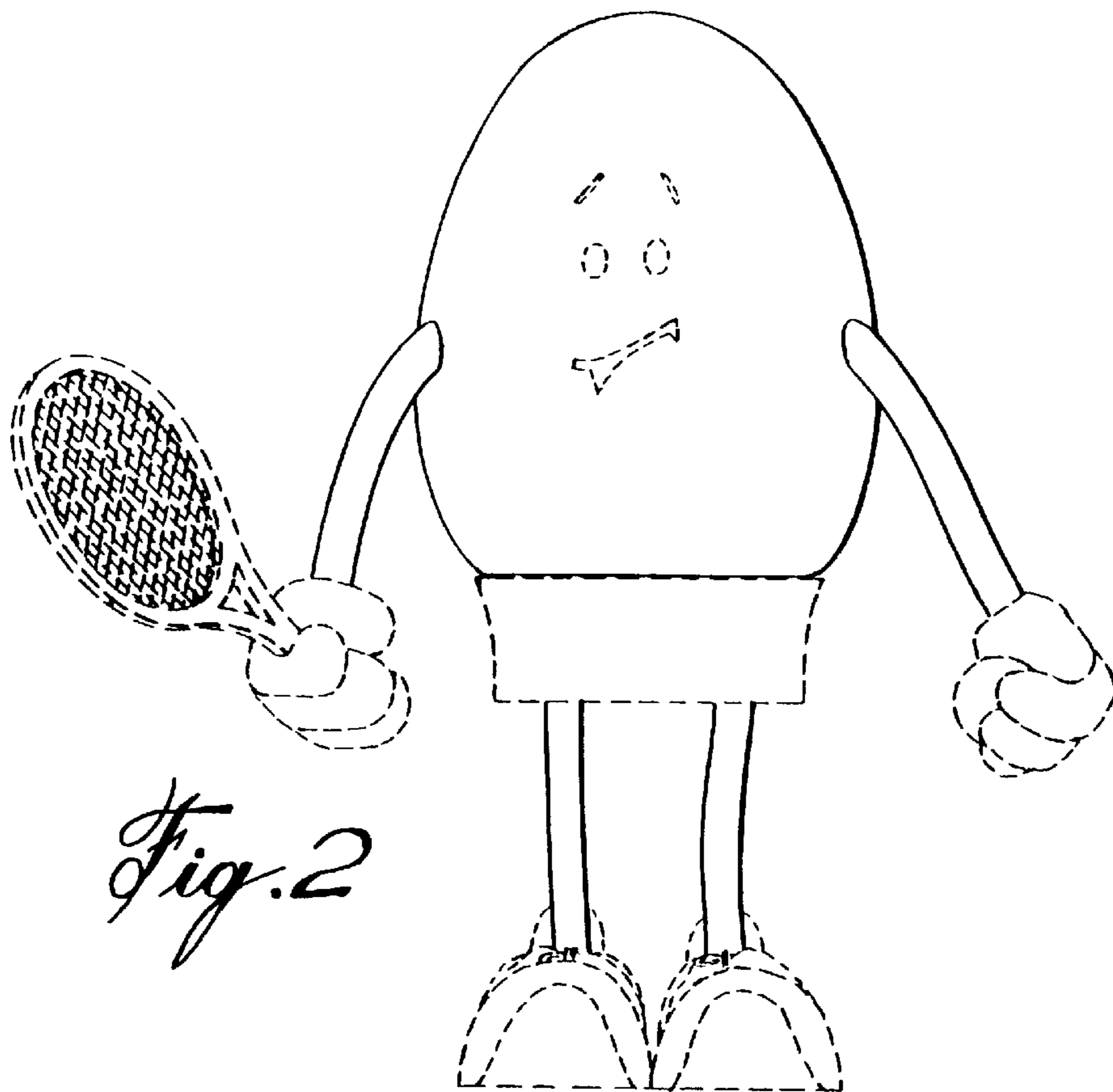
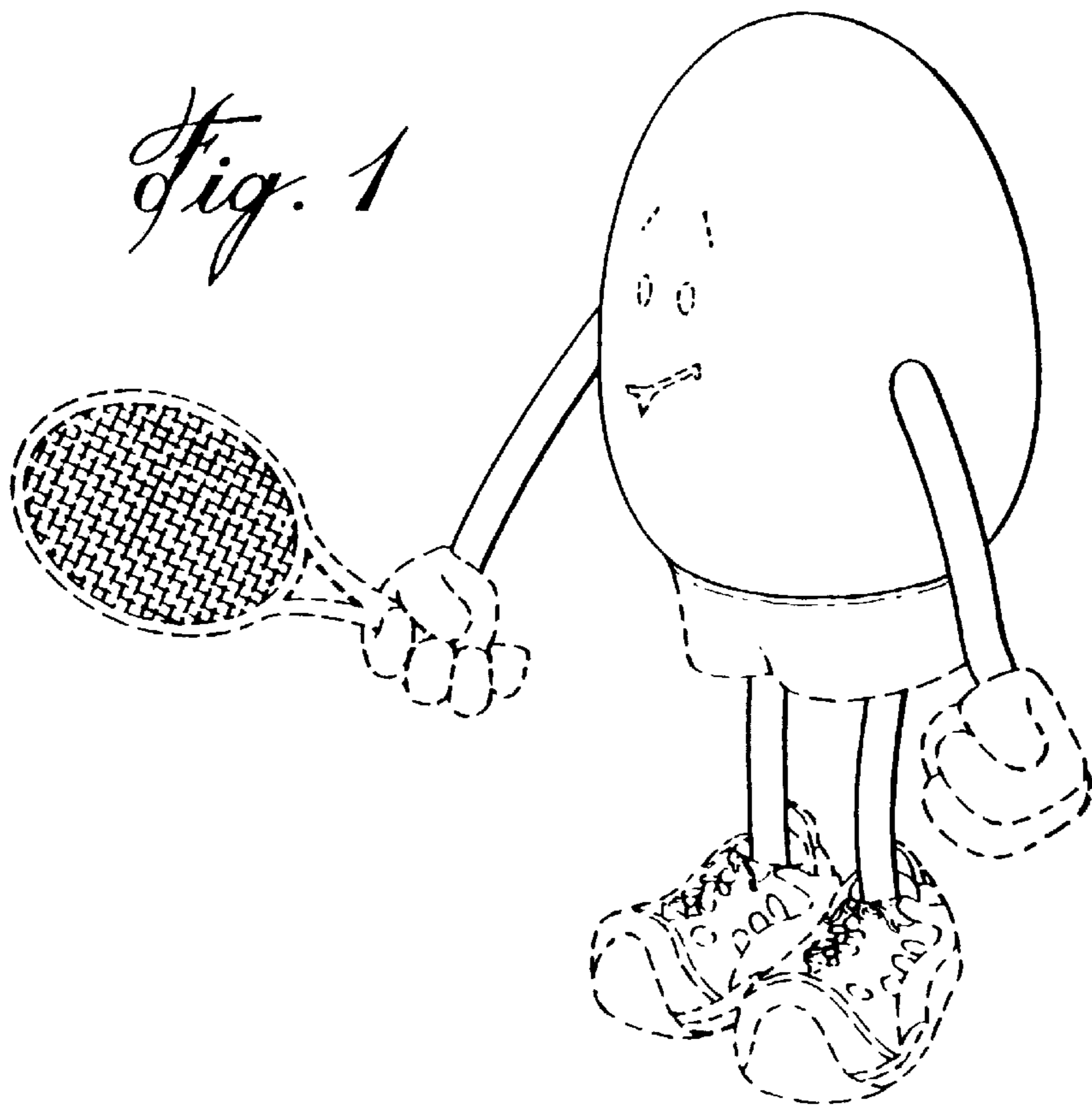

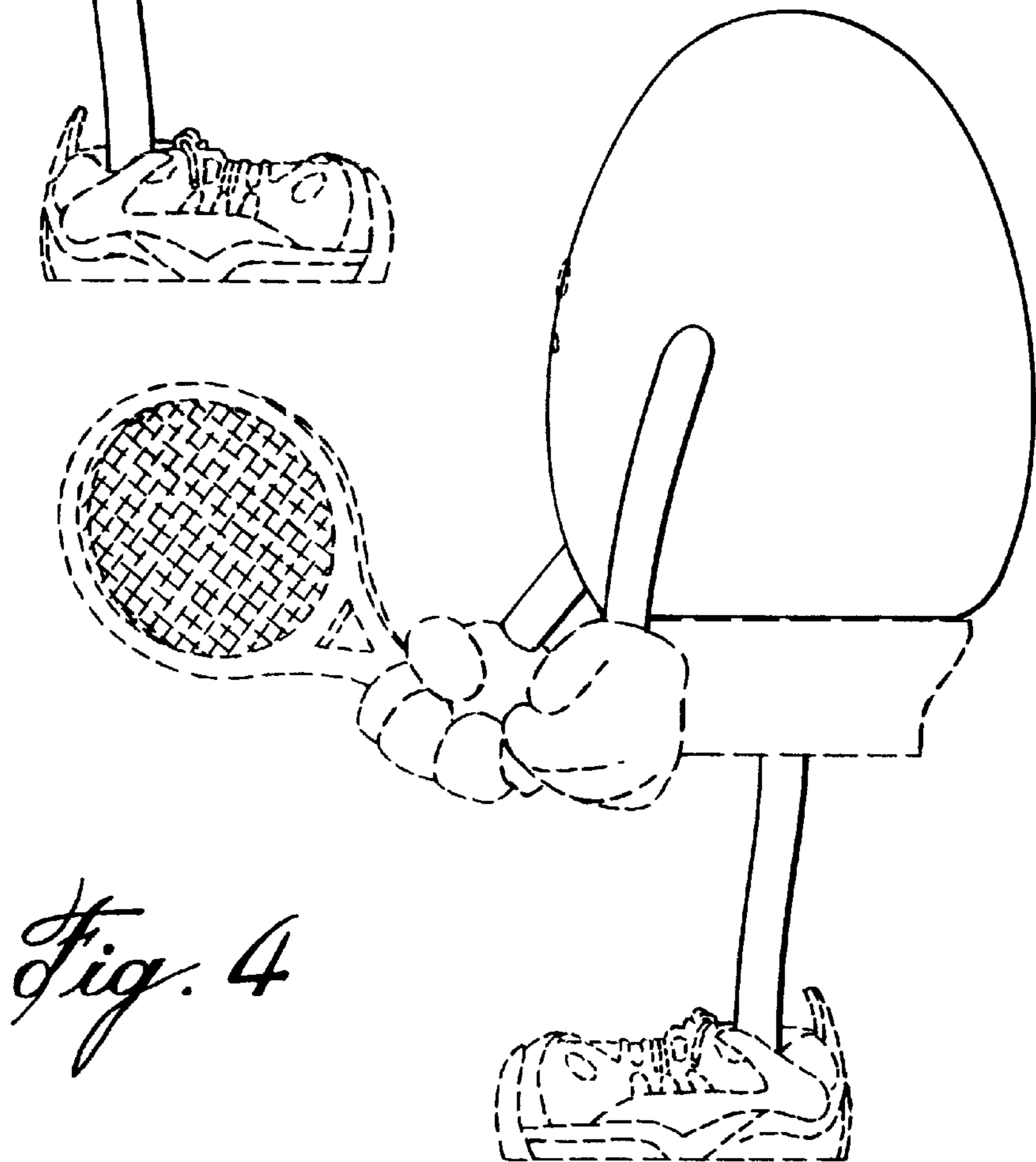
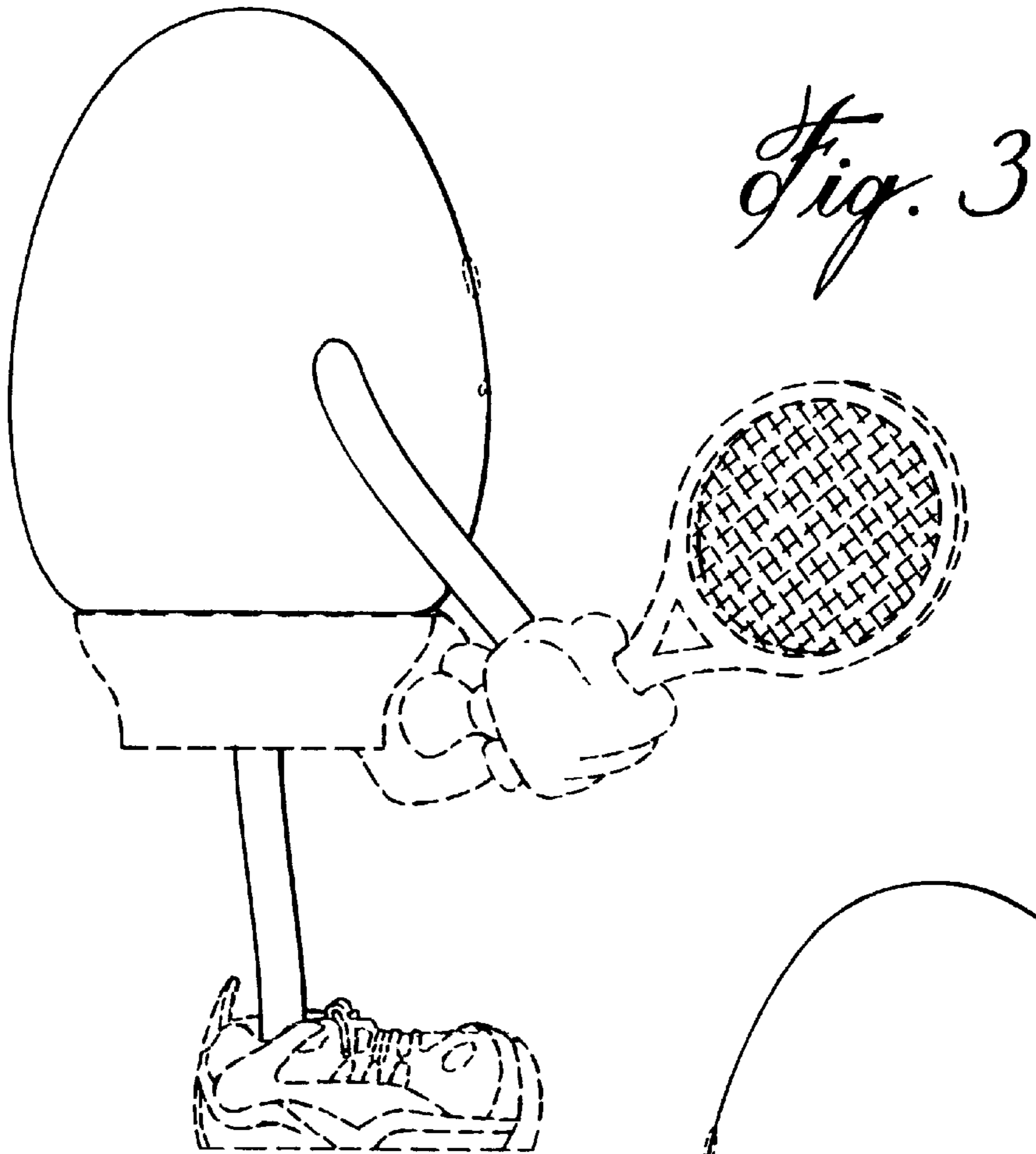

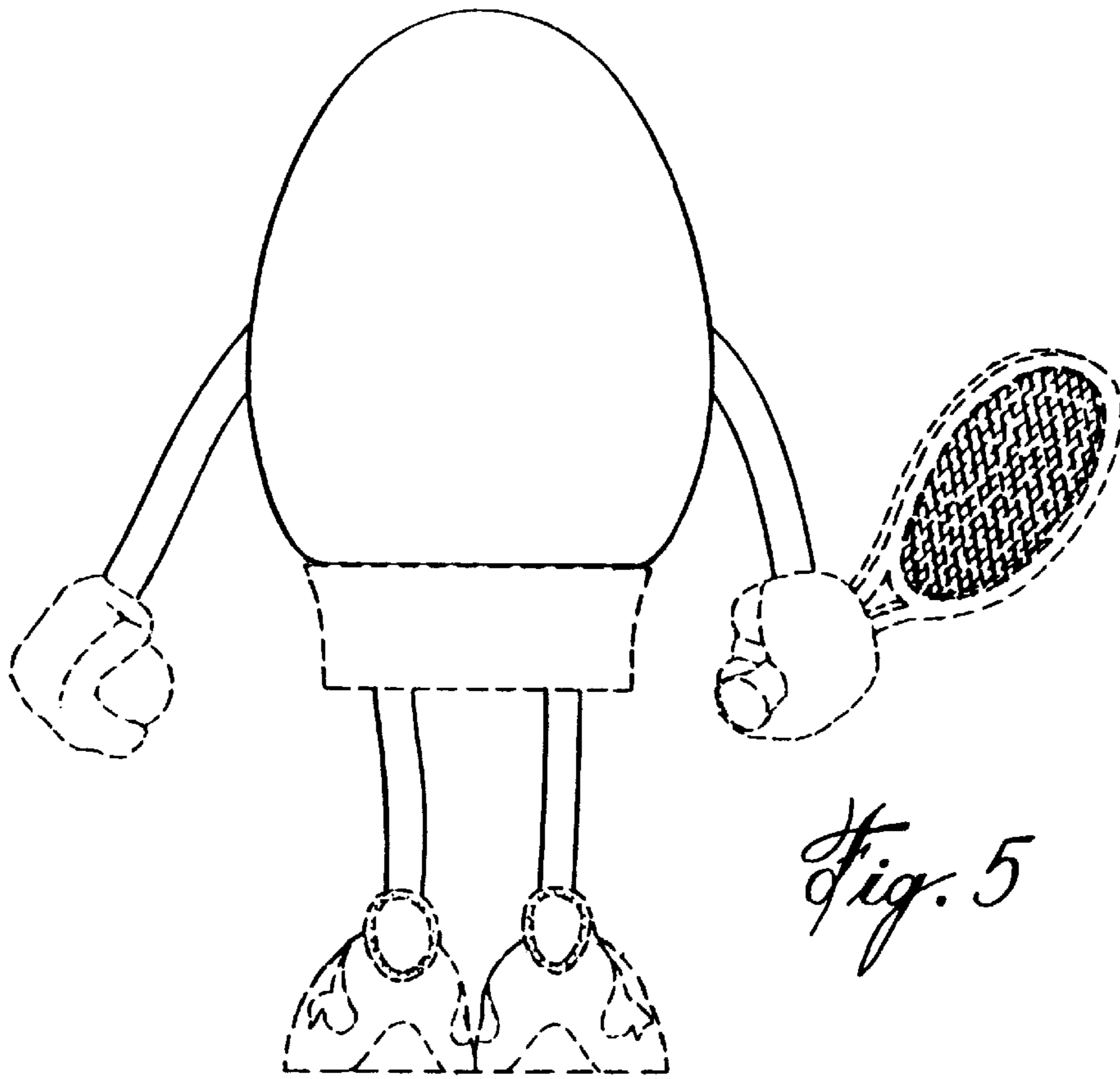

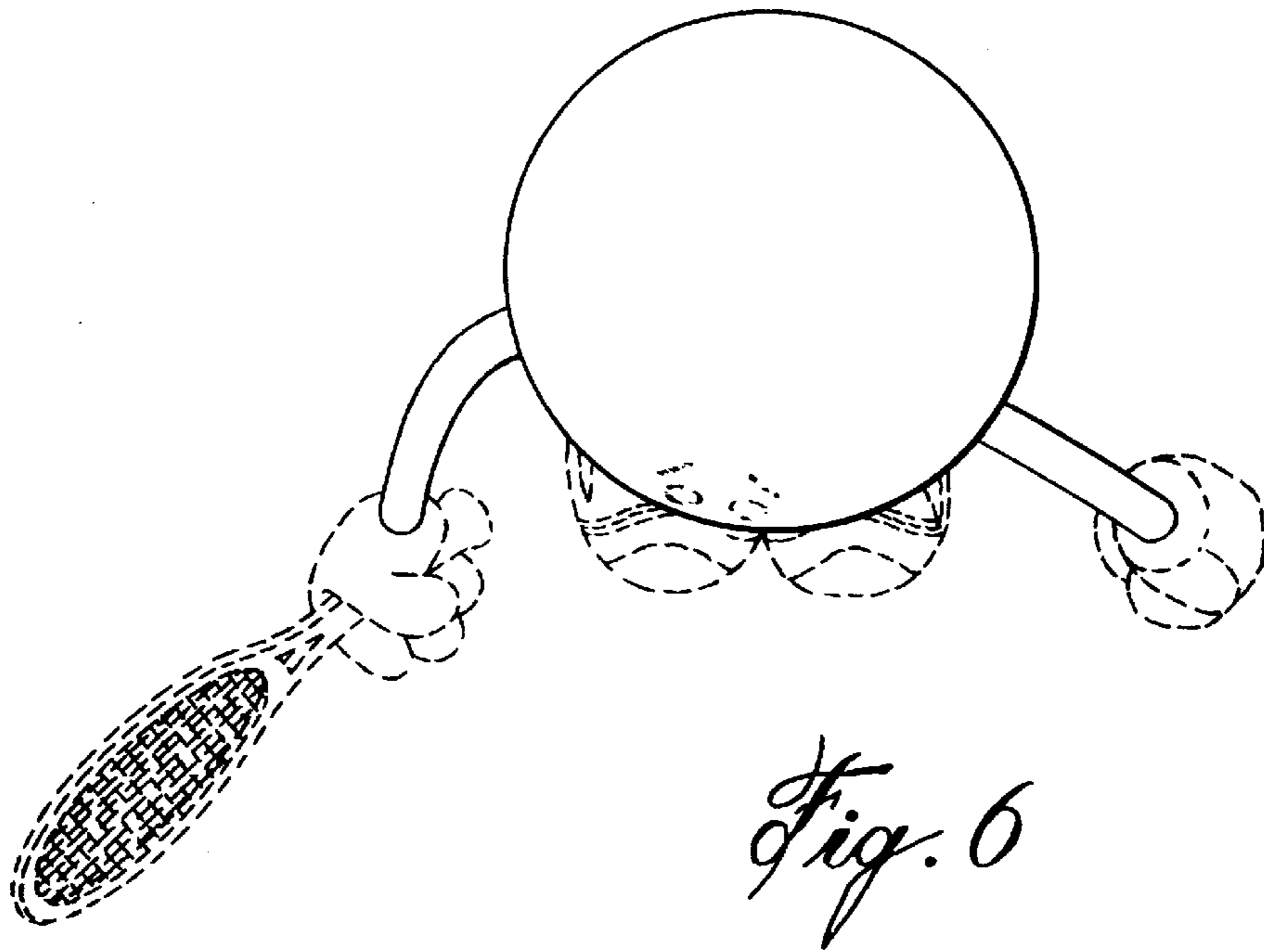




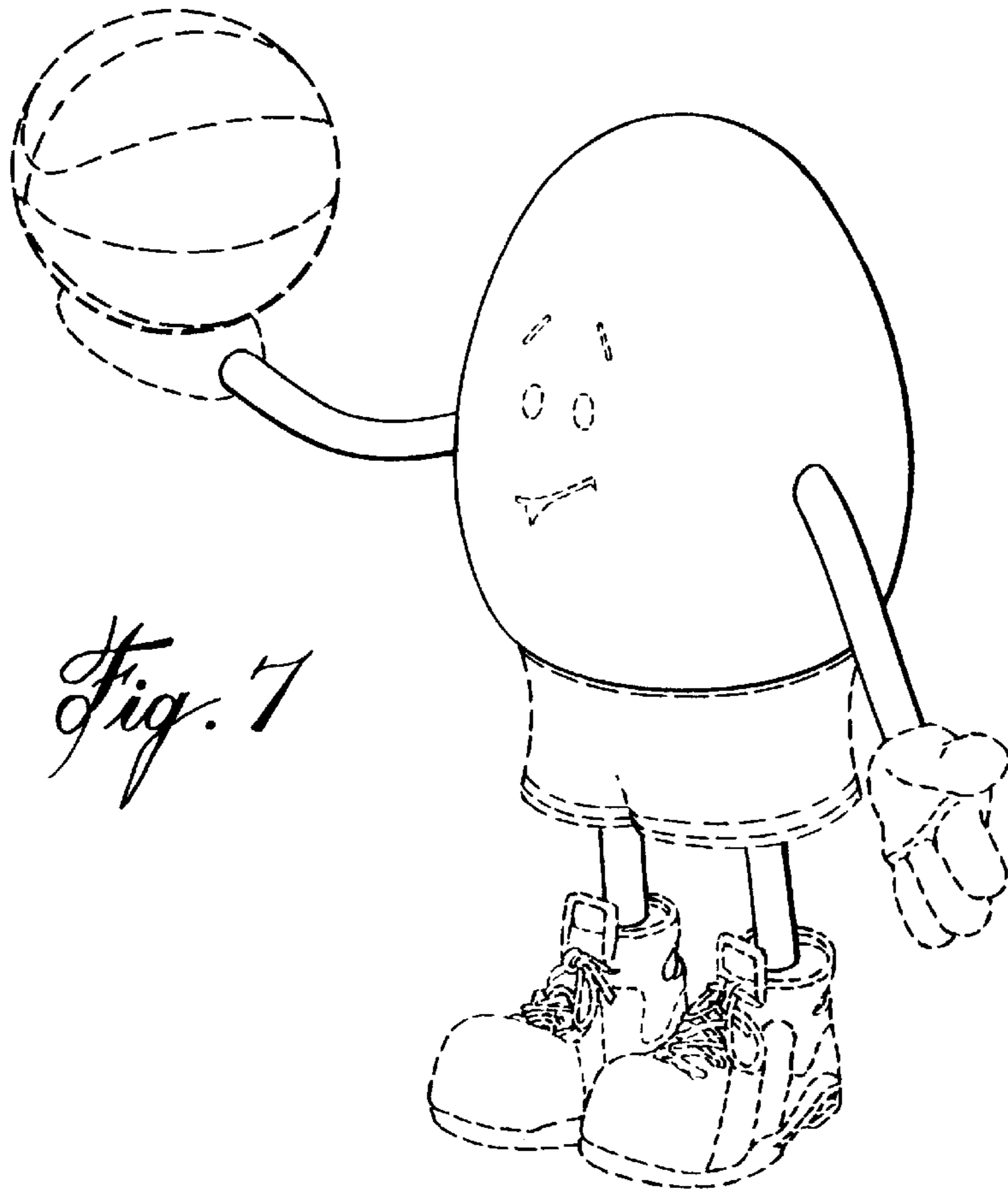




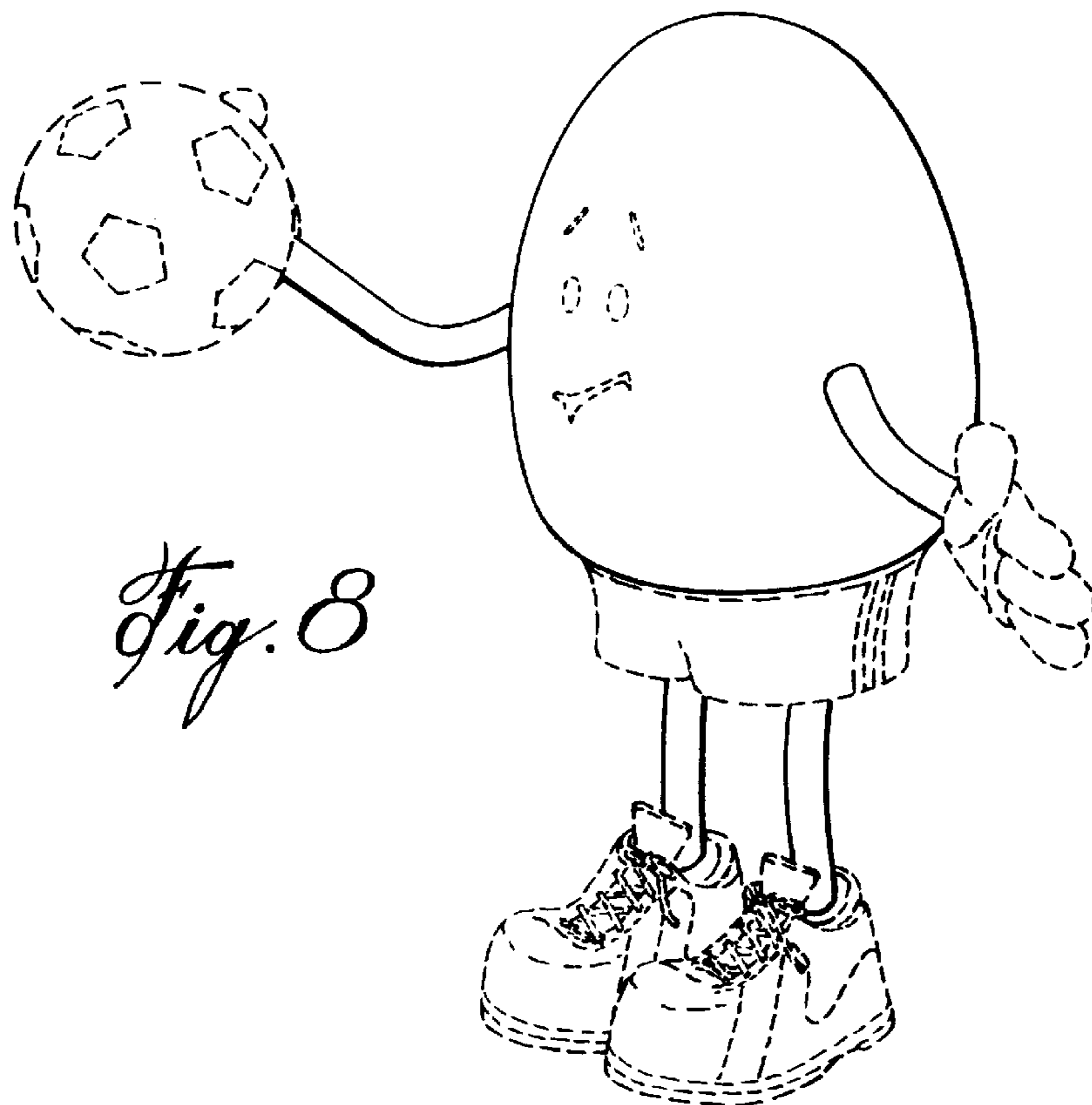

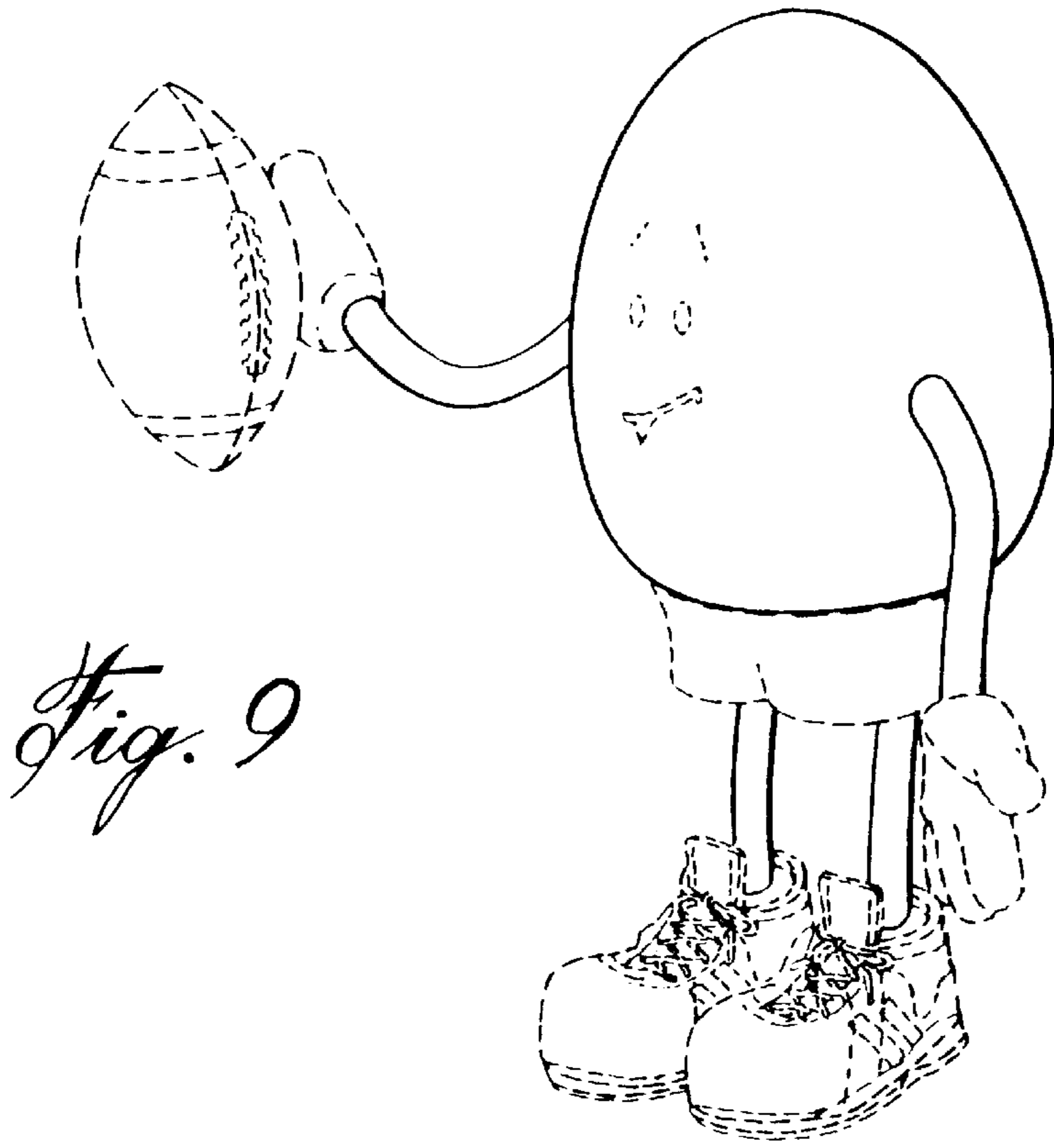

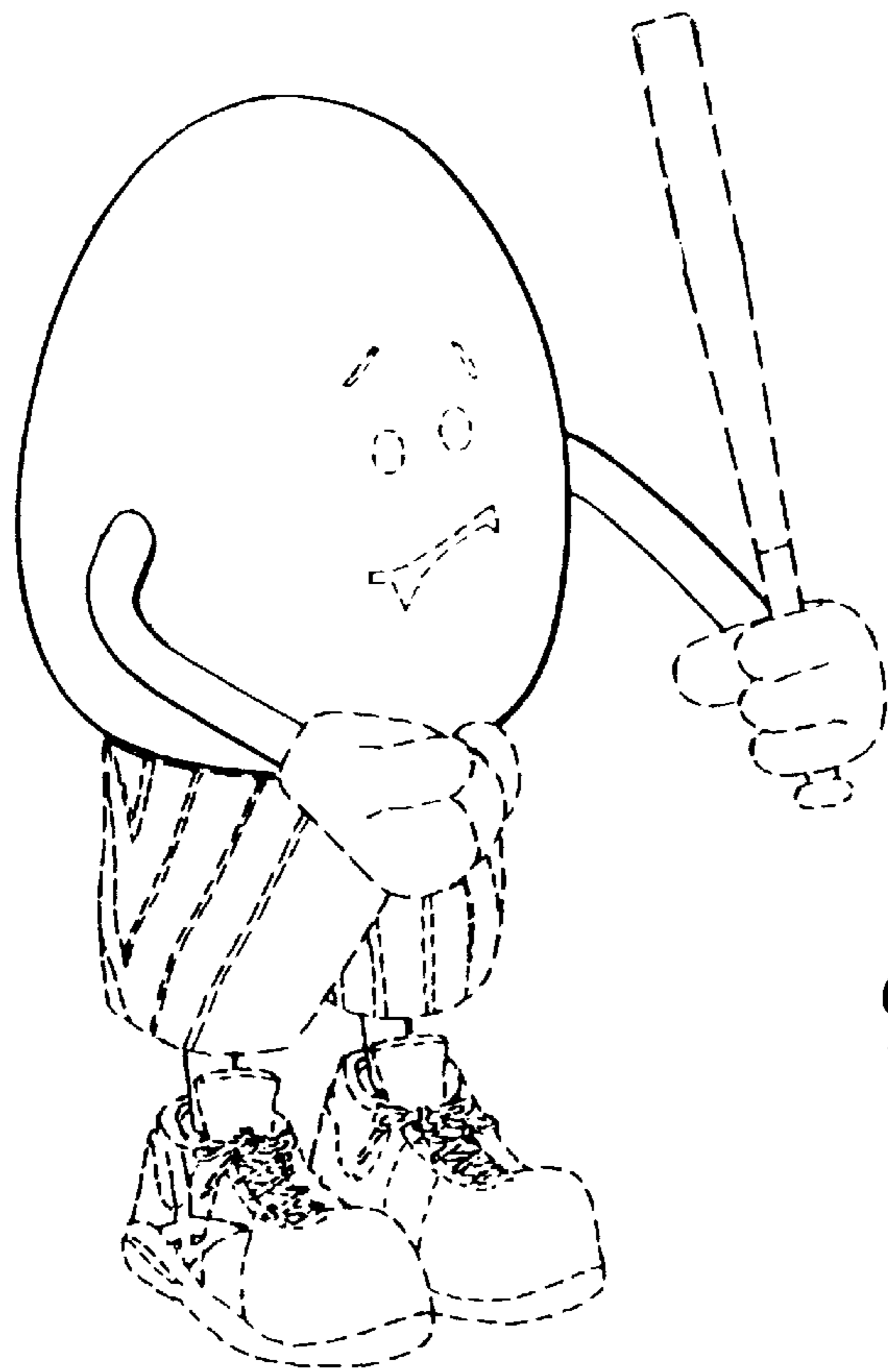
