FIG. 6 is a bottom view of the laptop desk and carrying case;

FIG. 7 is a perspective view of the laptop desk and carrying case, showing it in an opened position; and,

FIG. 8 is a perspective view of the laptop desk and carrying case showing it in an alternate opened position wherein the center section is raised to meet to top section.

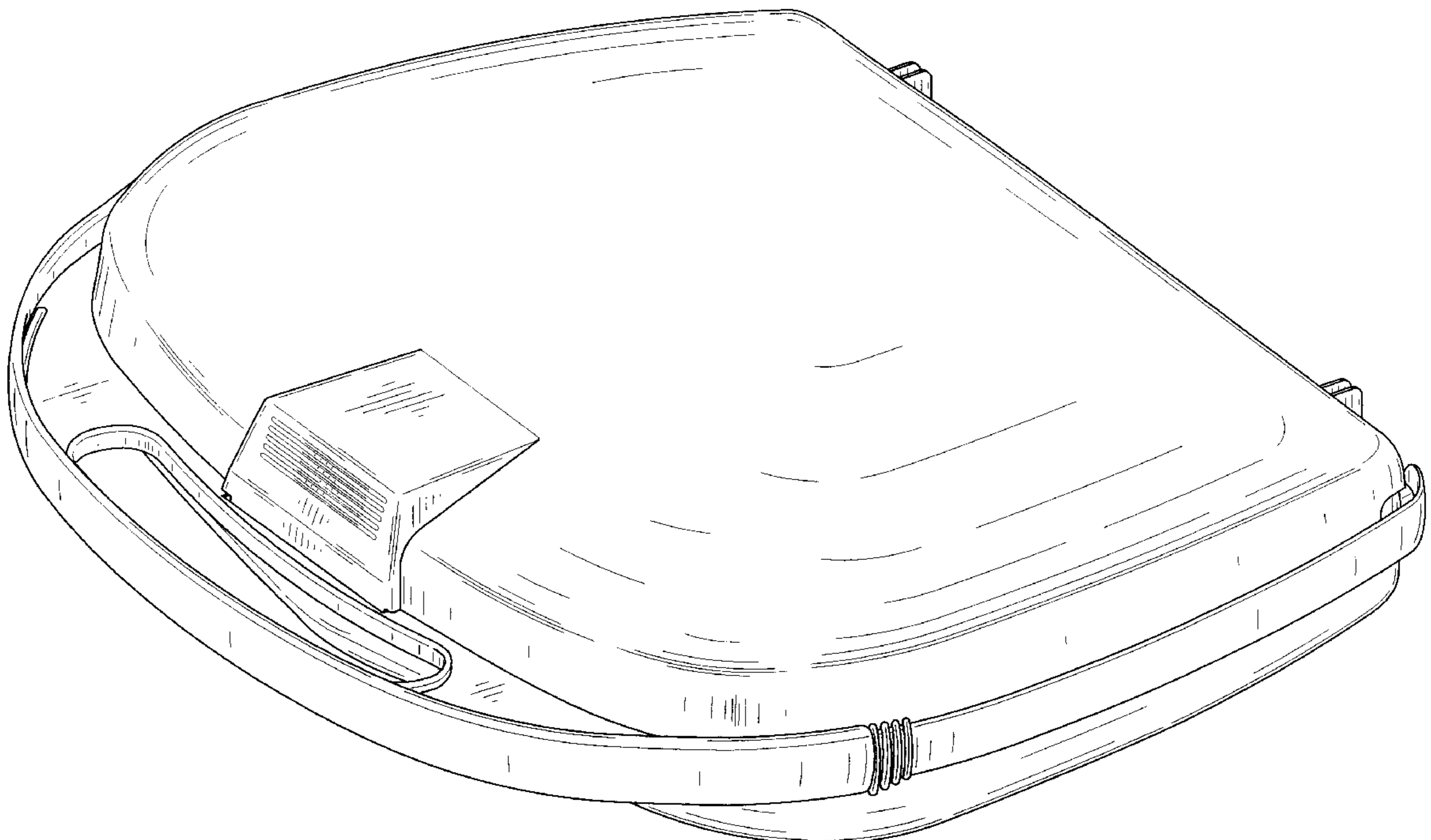

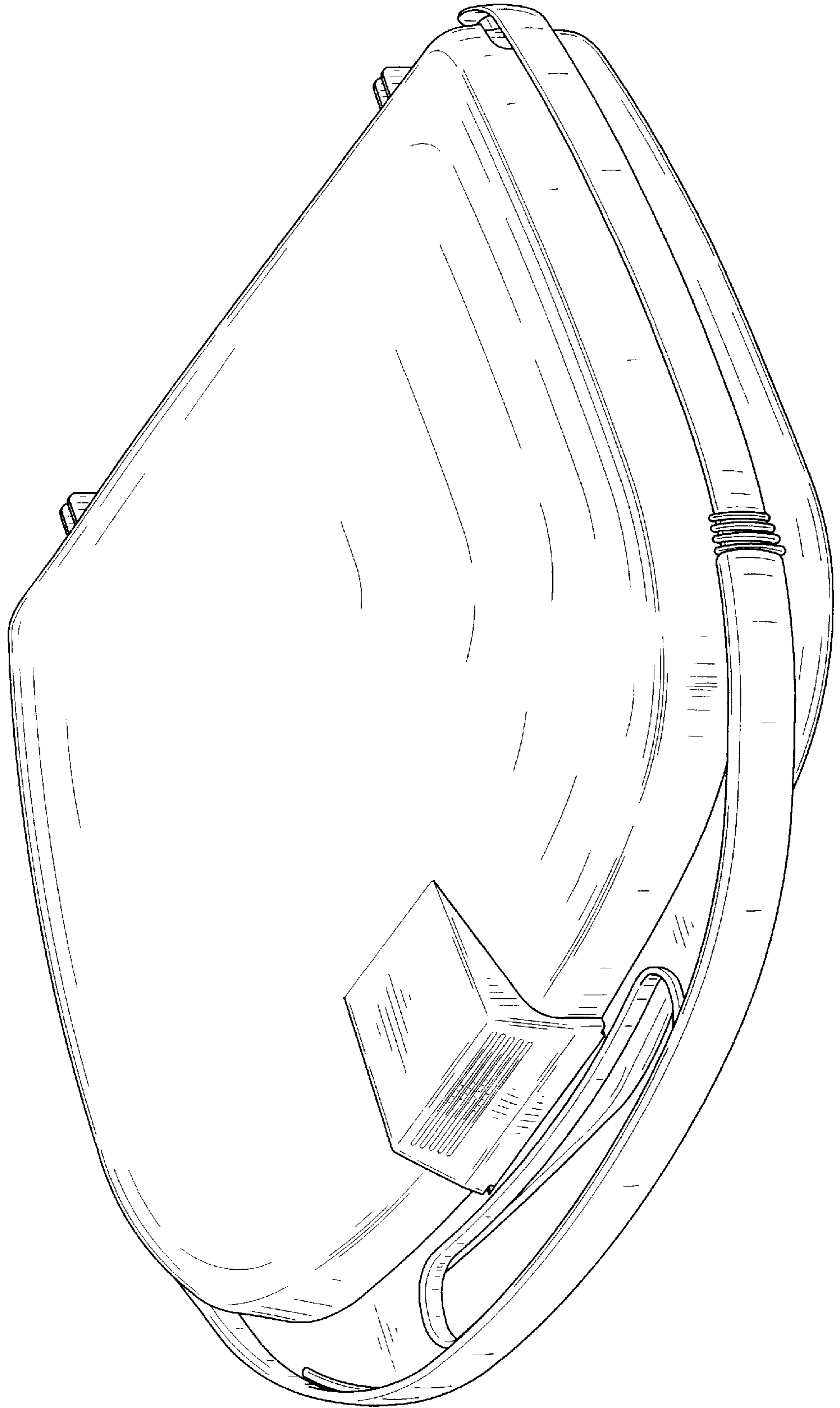

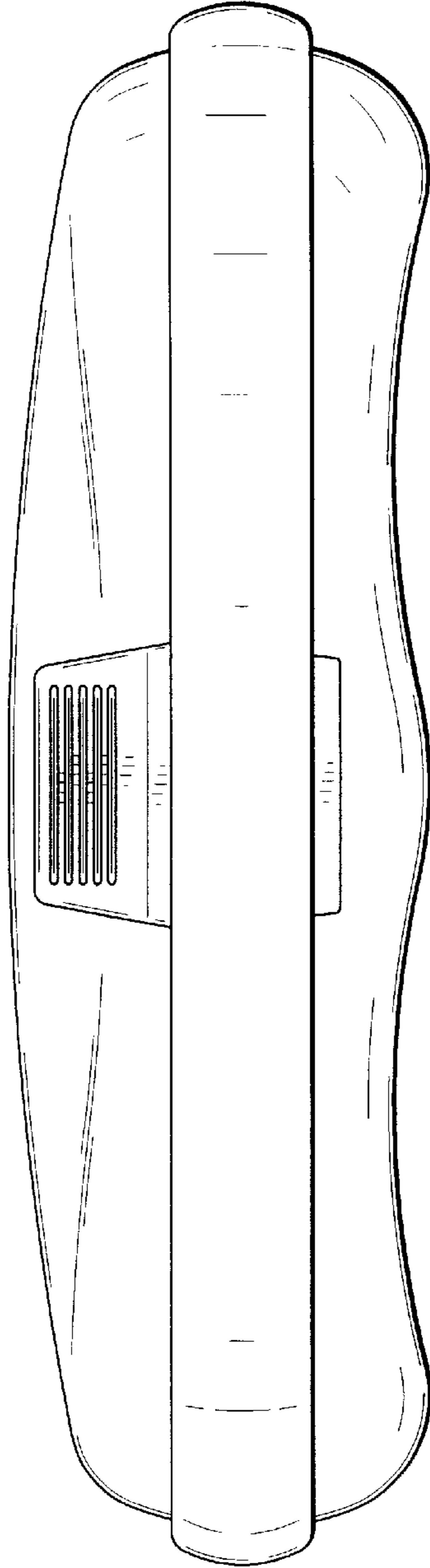

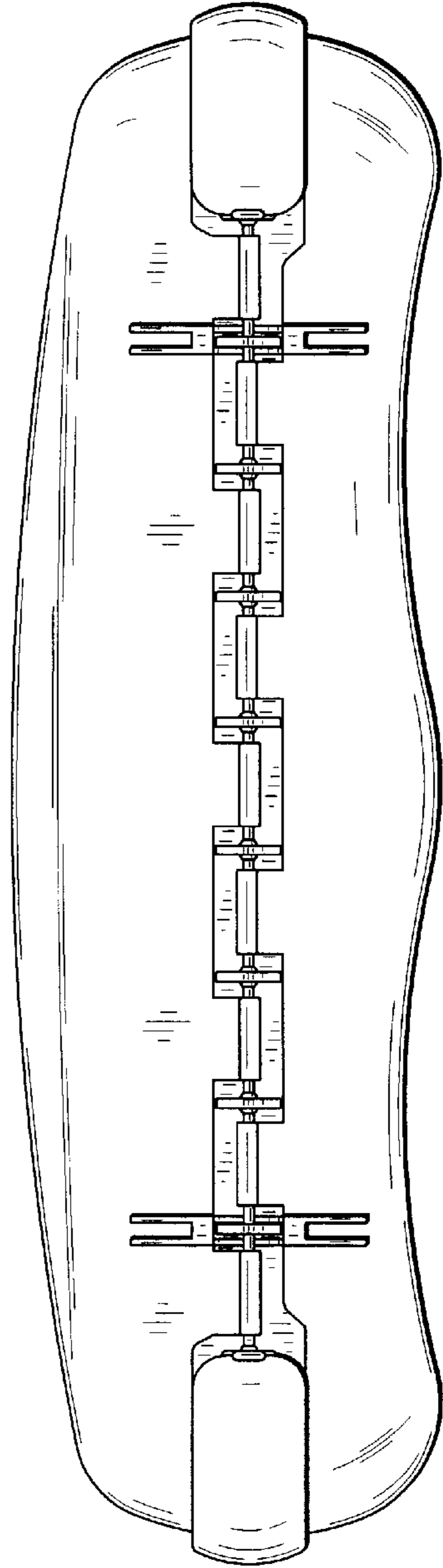

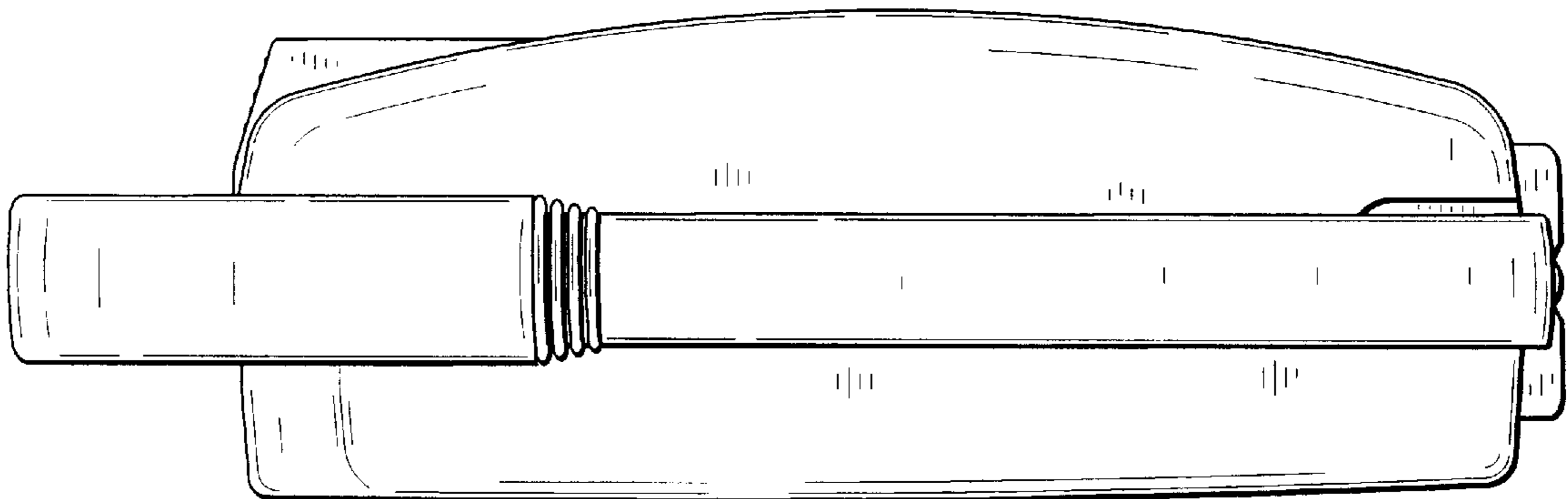

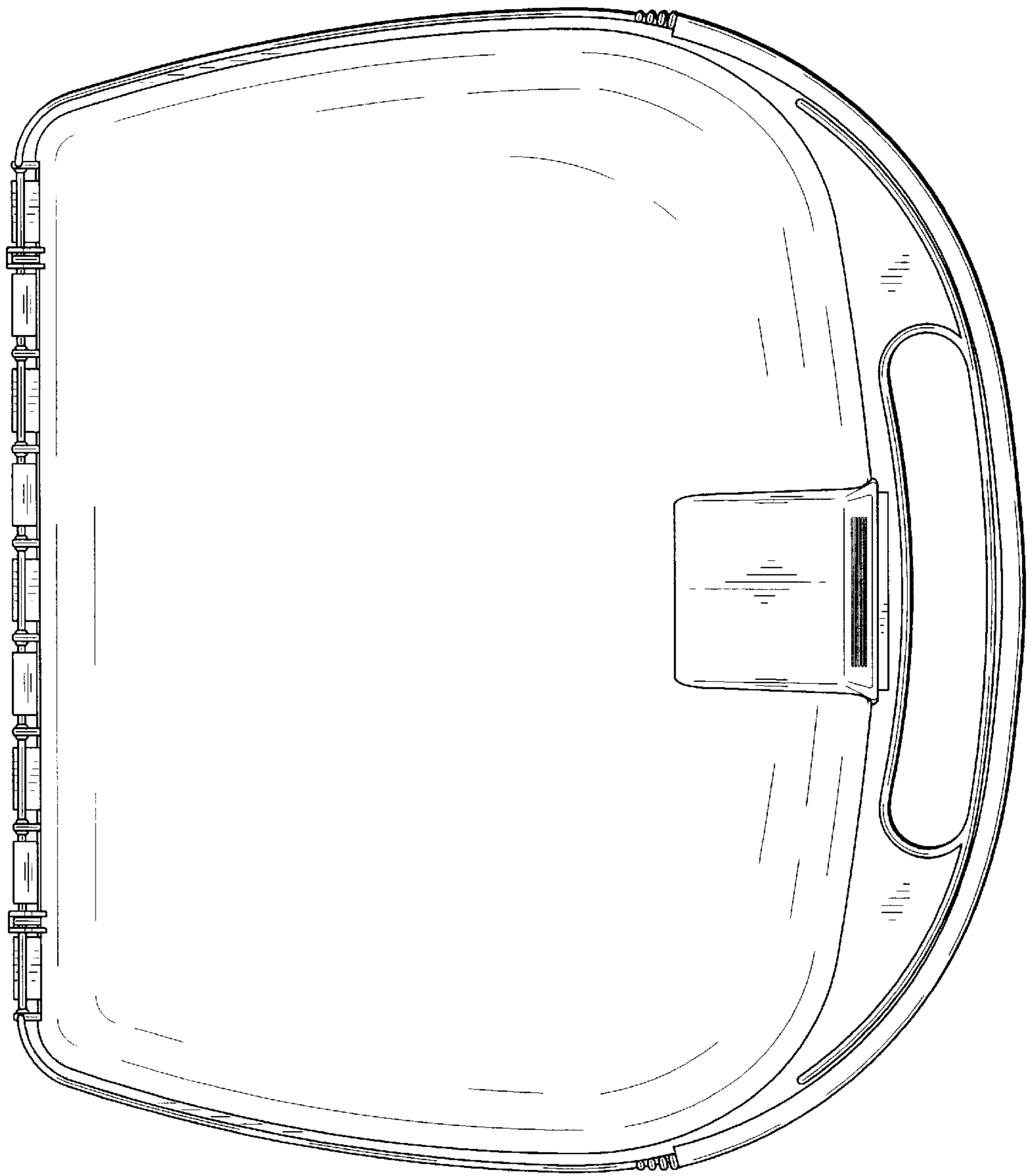

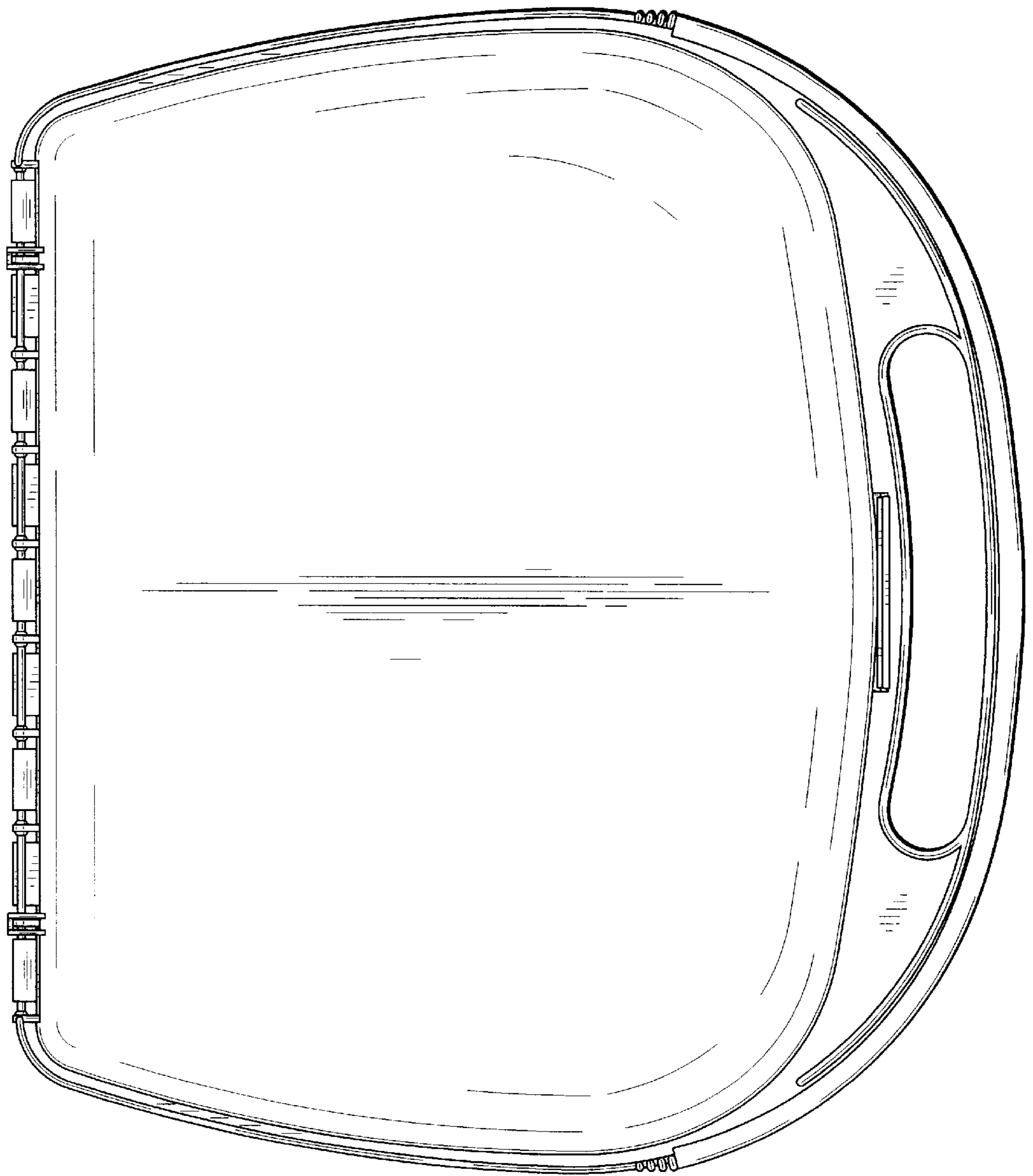

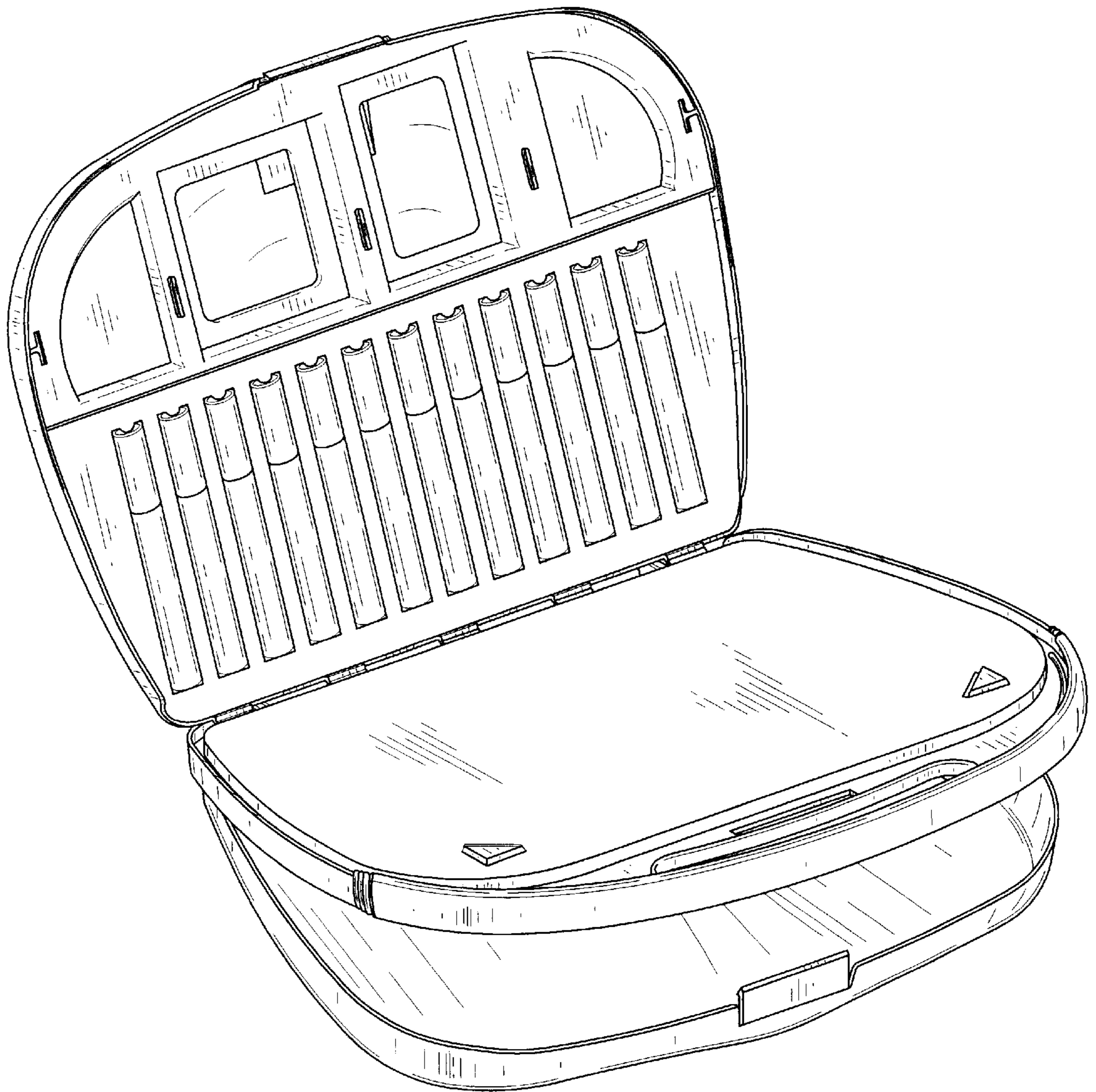
