(57) **CLAIM**

The ornamental design for a container for medicinal dosage forms, as shown and described.

DESCRIPTION

FIG. 1 is a rearward-looking perspective view of a first embodiment of a container for medicinal dosage forms showing our new design from above;

FIG. 2 is a frontward-looking perspective view thereof from below;

FIG. 3 is a top view thereof;

FIG. 4 is a side view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front view thereof;

FIG. 7 is a side view thereof;

FIG. 8 is a back view thereof;

FIG. 9 is a rearward-looking exploded perspective view thereof from above;

FIG. 10 is a frontward-looking exploded perspective view thereof from below;

FIG. 11 is a rearward-looking perspective view of a second embodiment of the container from above, the only difference with the design of FIG. 1 being the appearance of three parallel stripes on a portion of the container as shown;

FIG. 12 is a frontward-looking perspective view thereof from below;

FIG. 13 is a top view thereof;

FIG. 14 is a side view thereof;

FIG. 15 is a bottom view thereof;

FIG. 16 is a front view thereof;

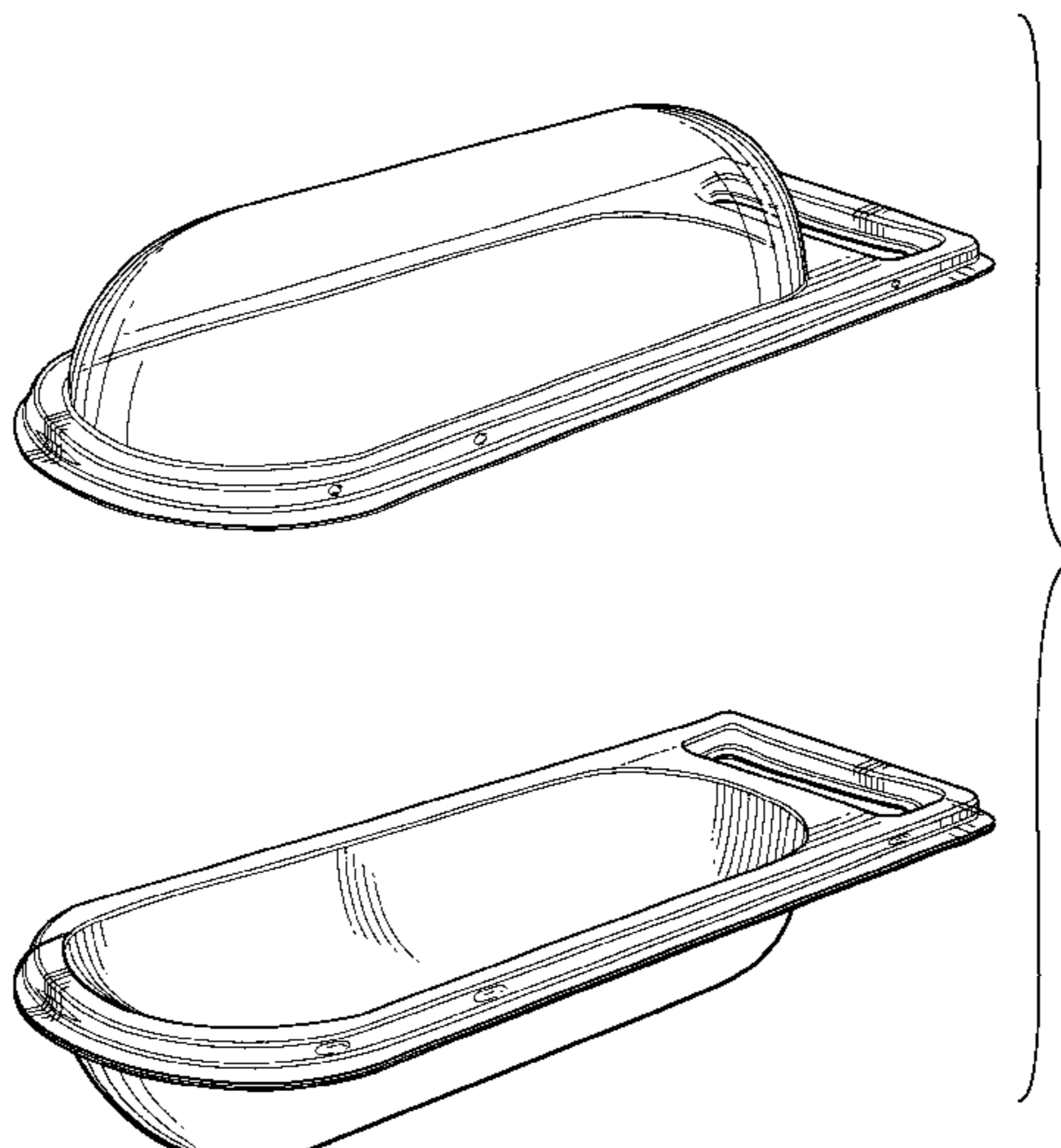
FIG. 17 is a side view thereof;

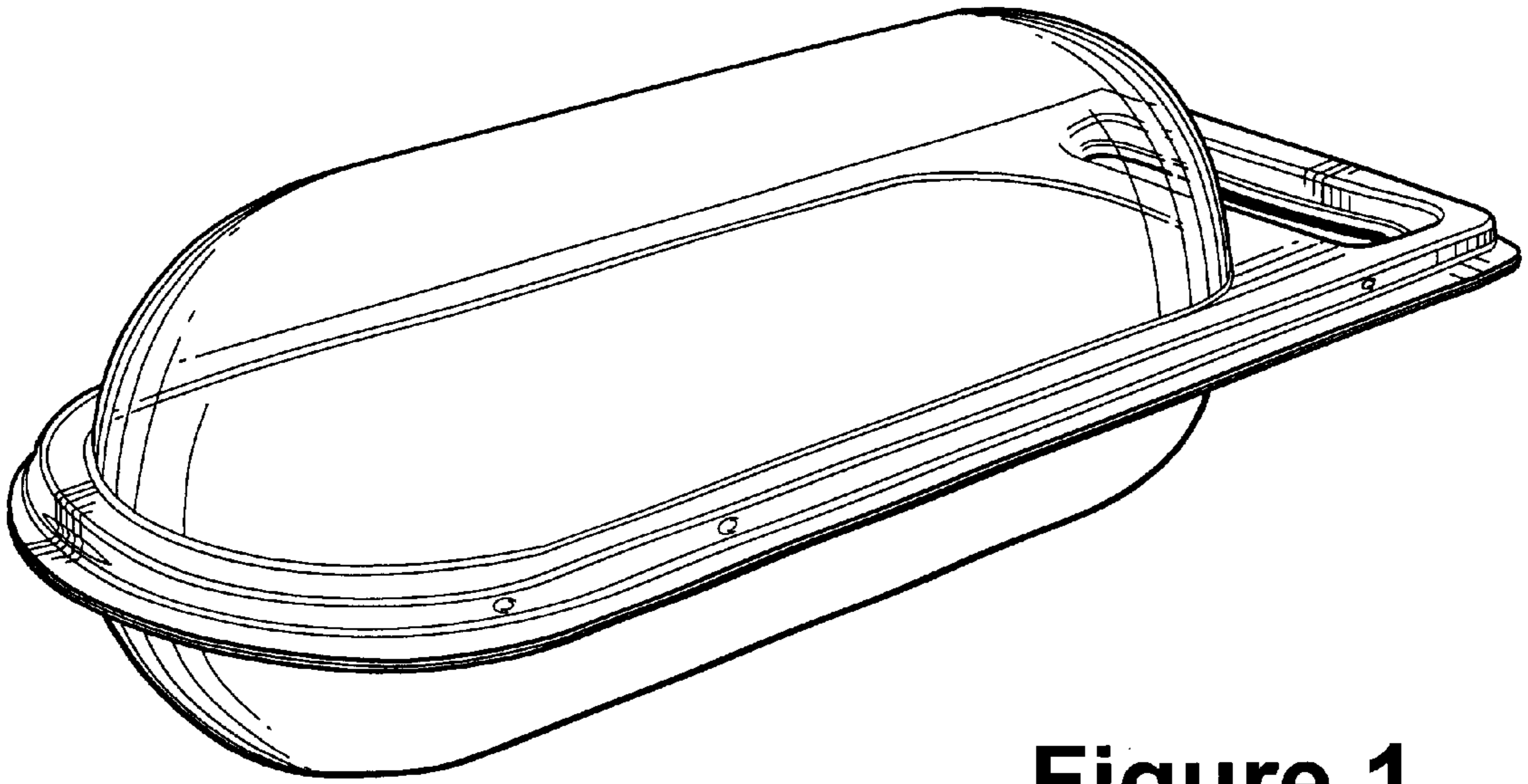

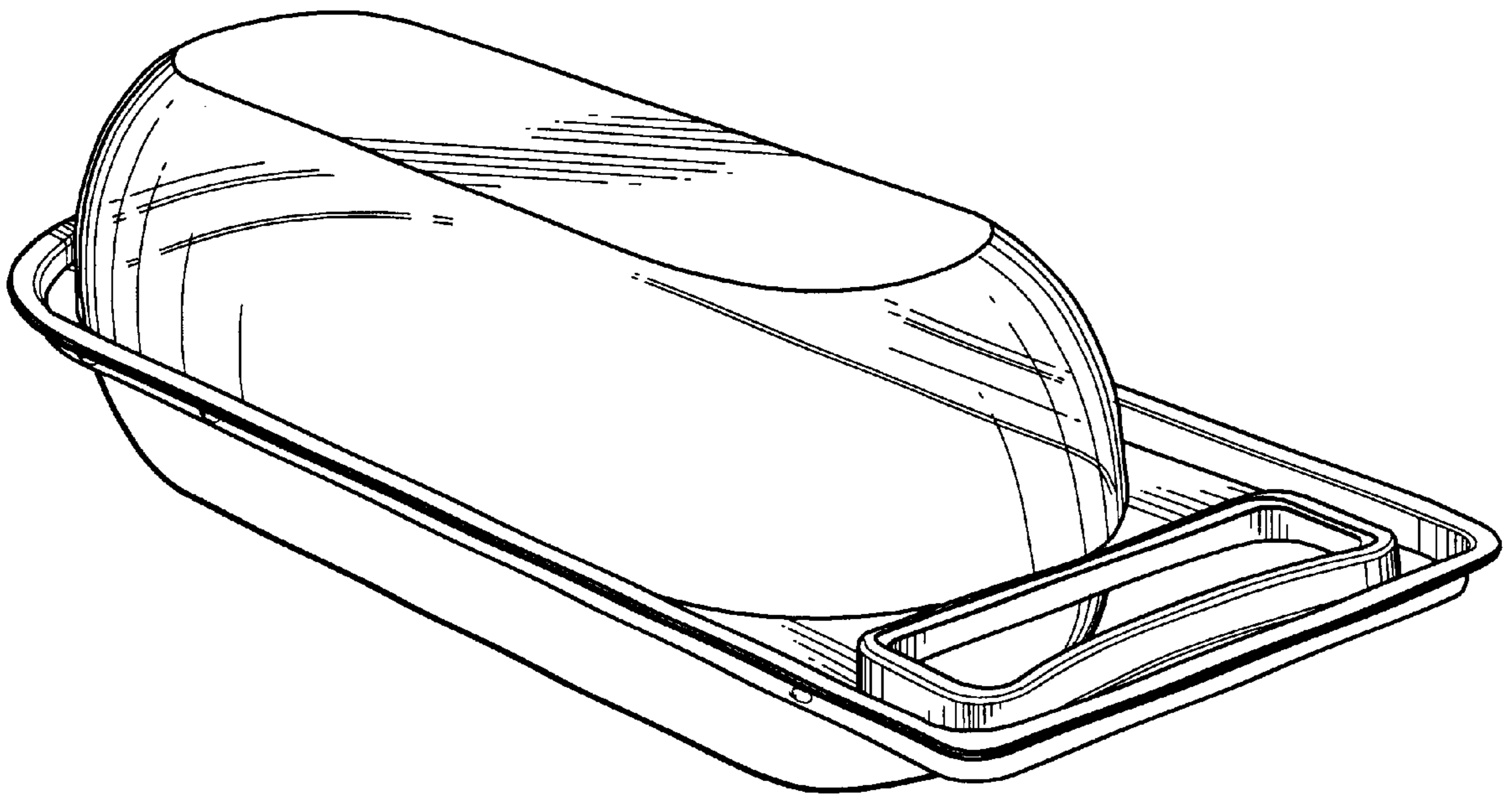

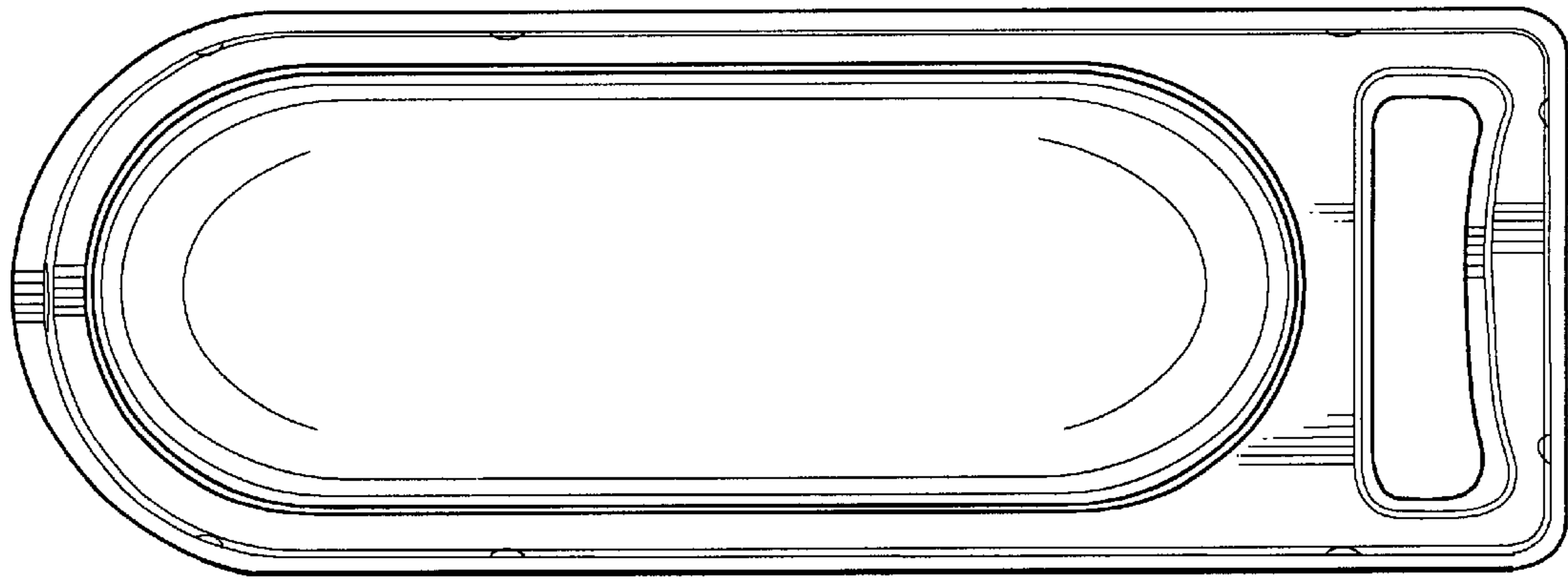

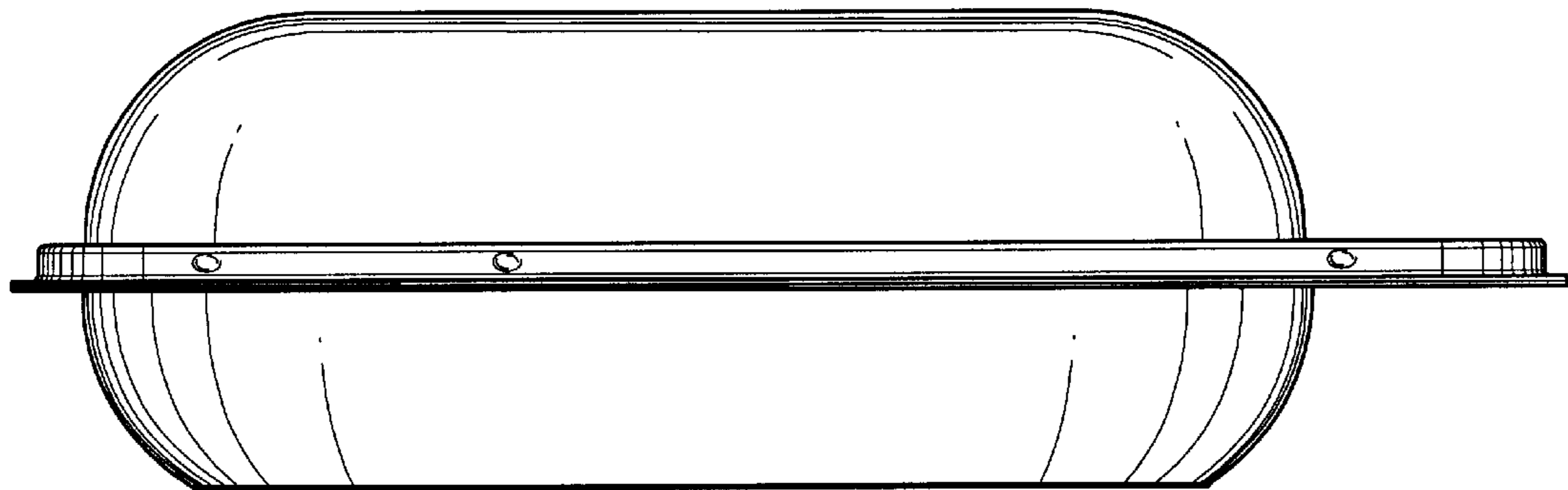

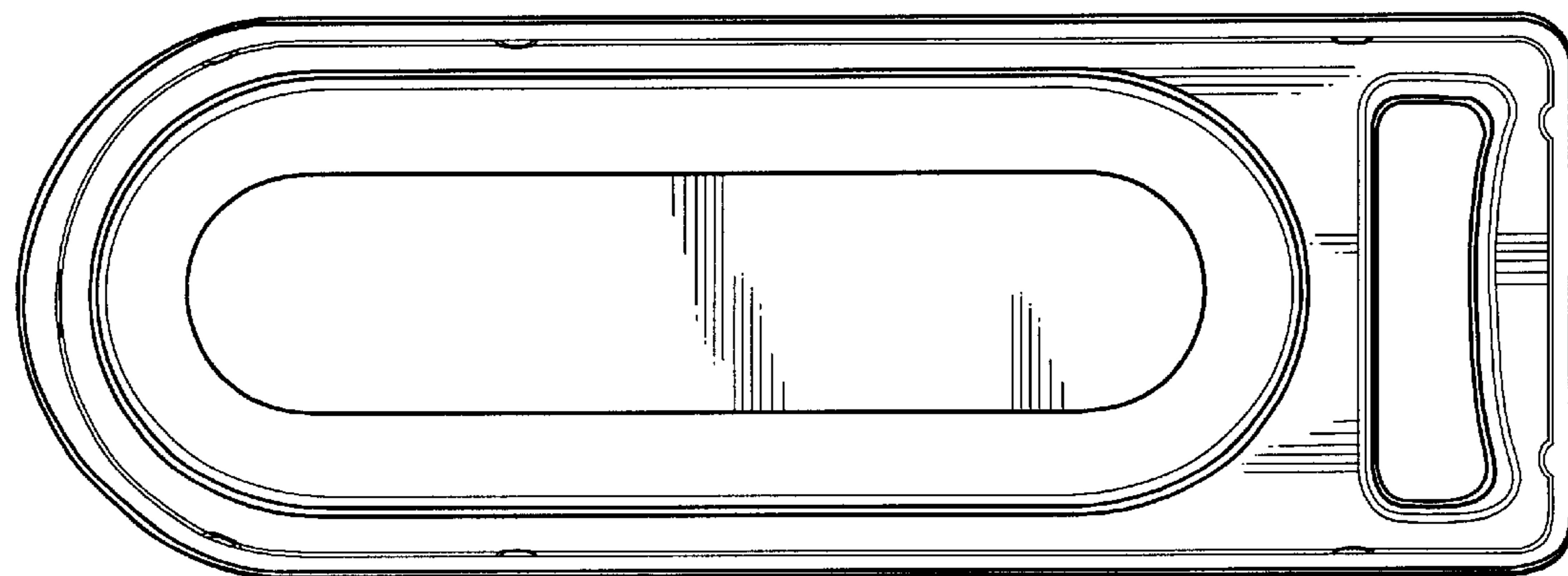

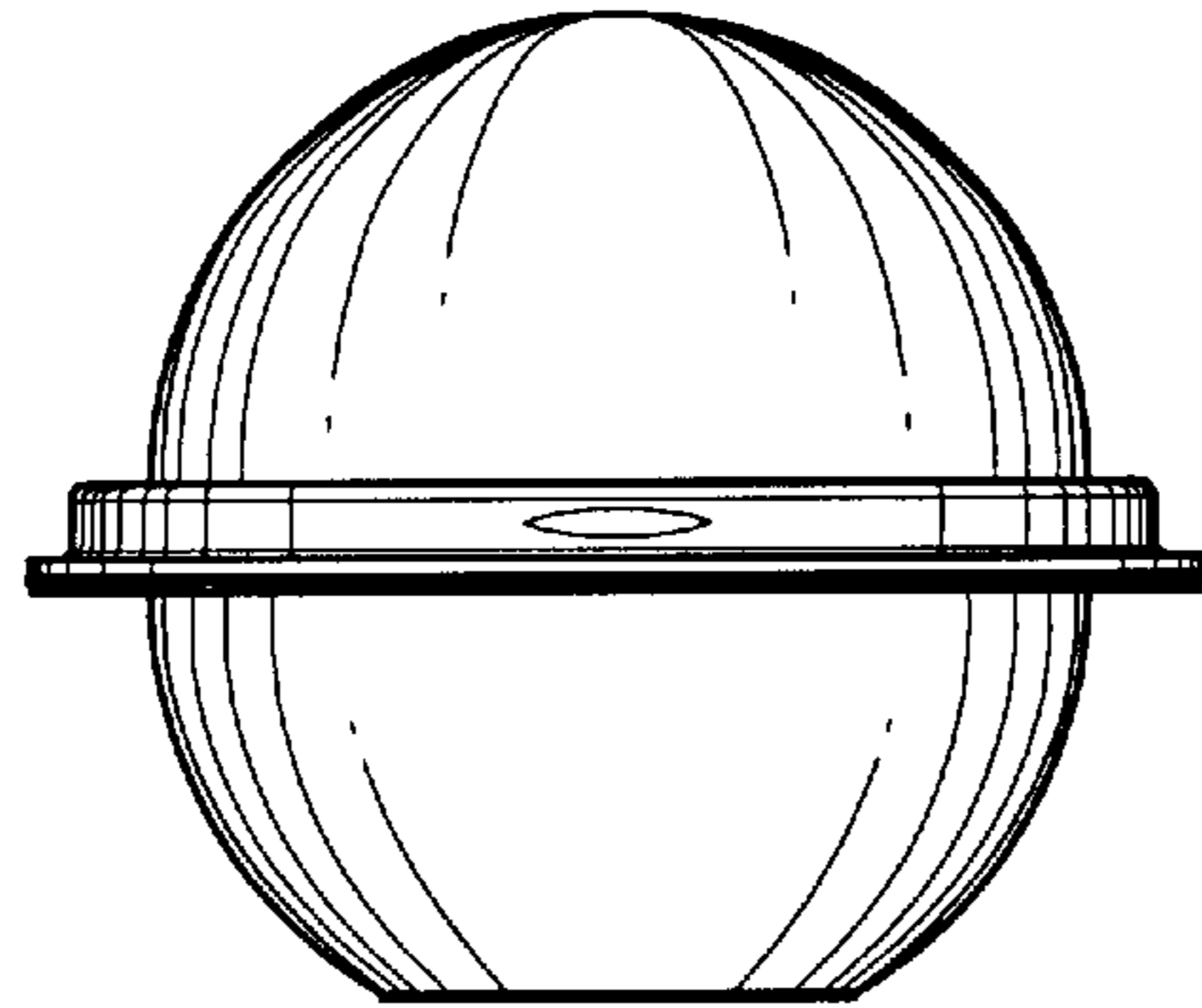

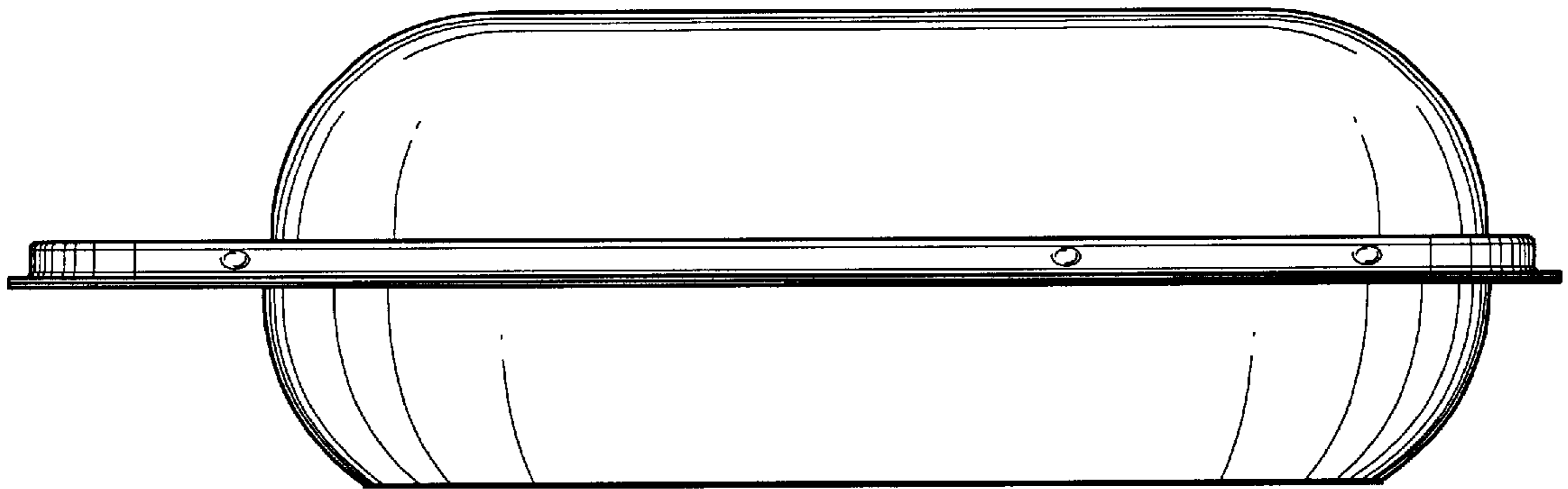

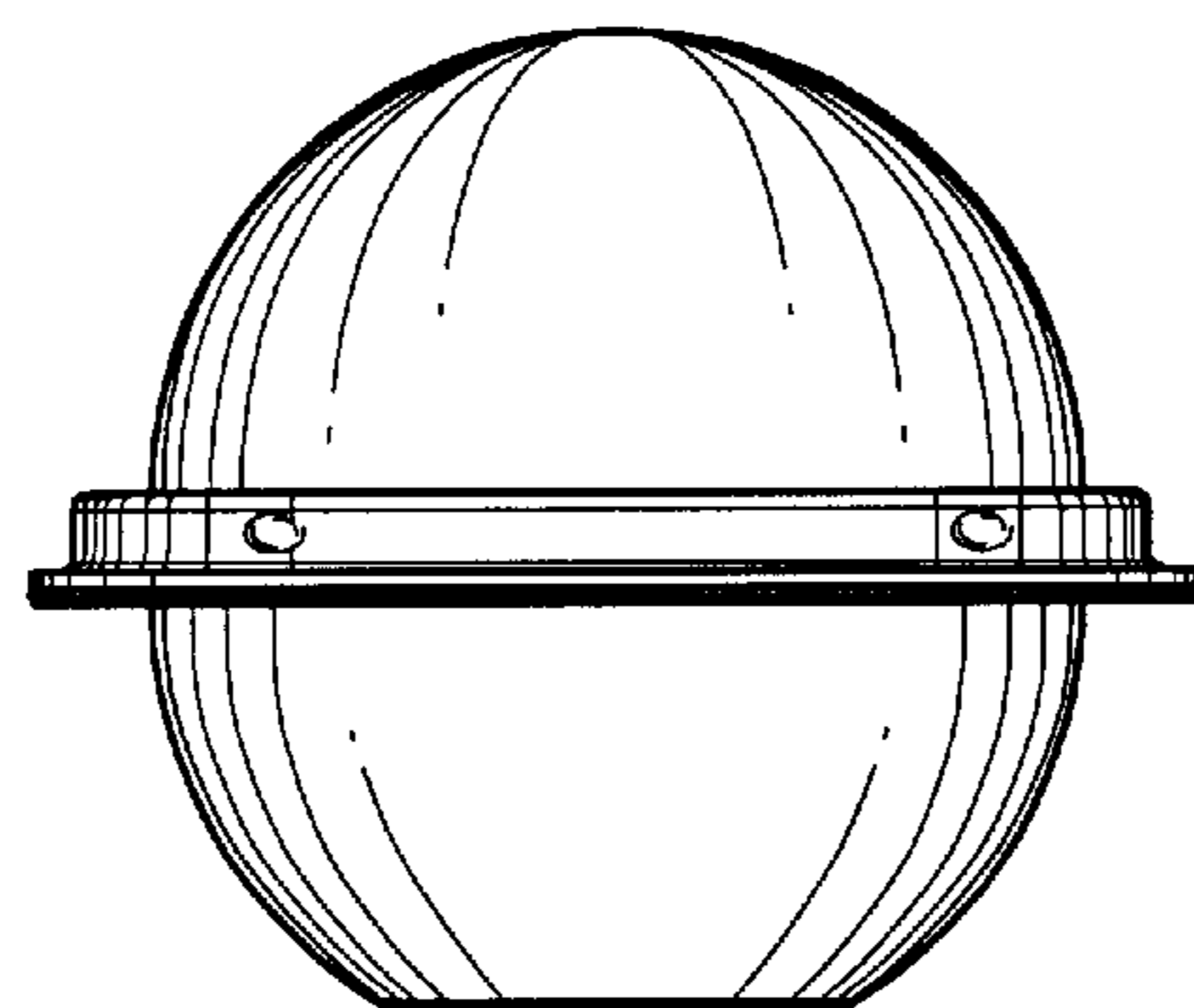

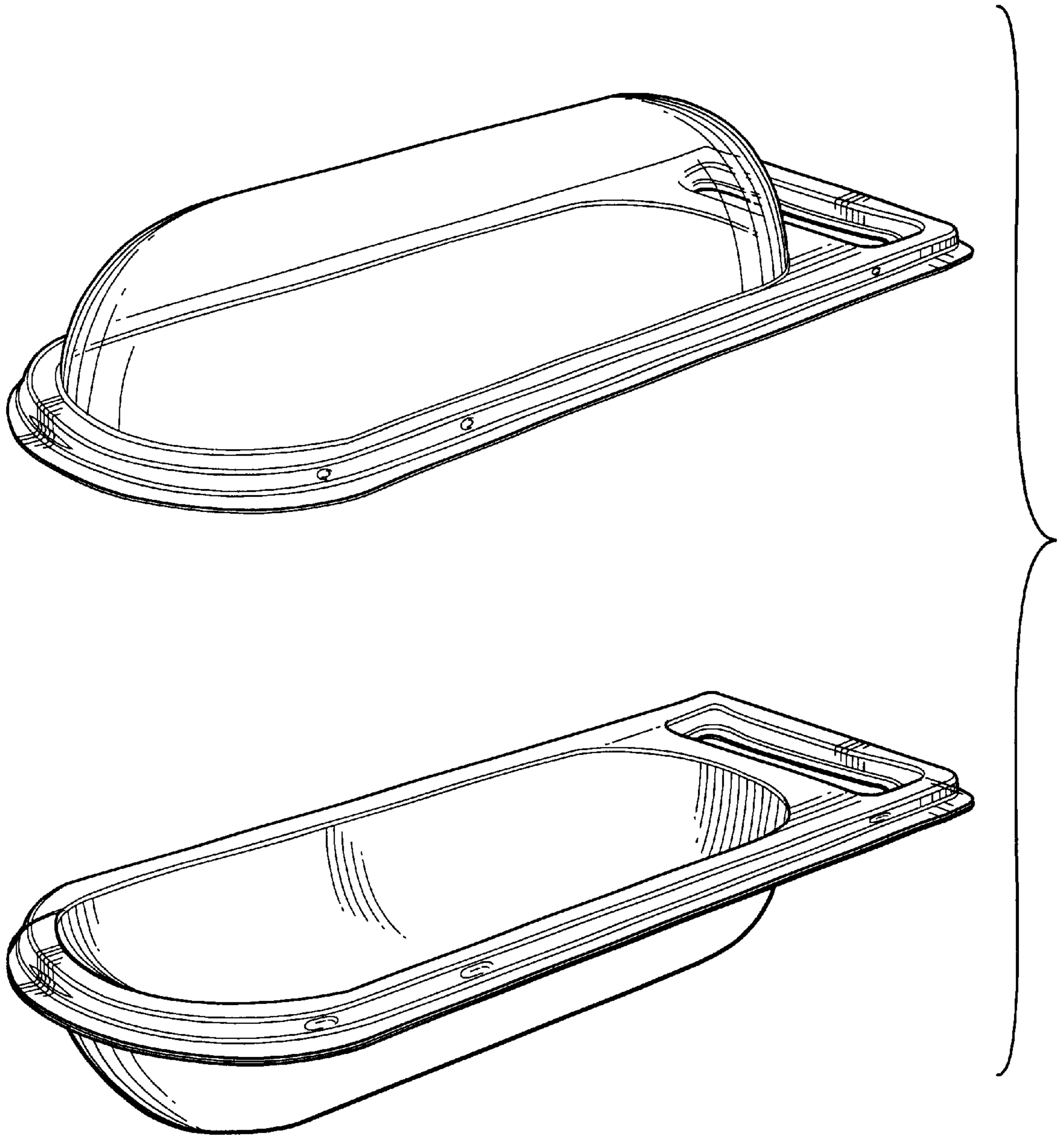

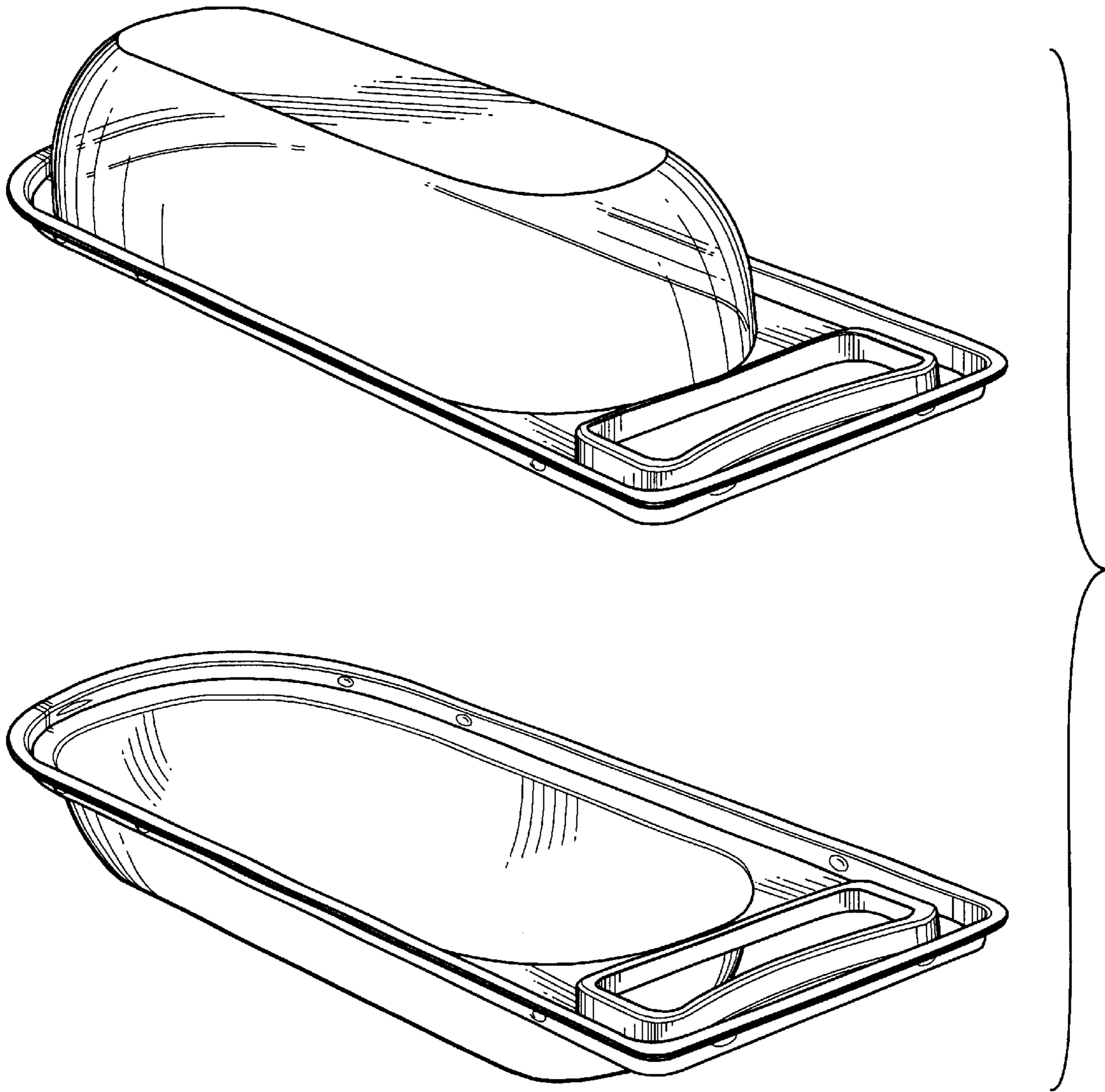

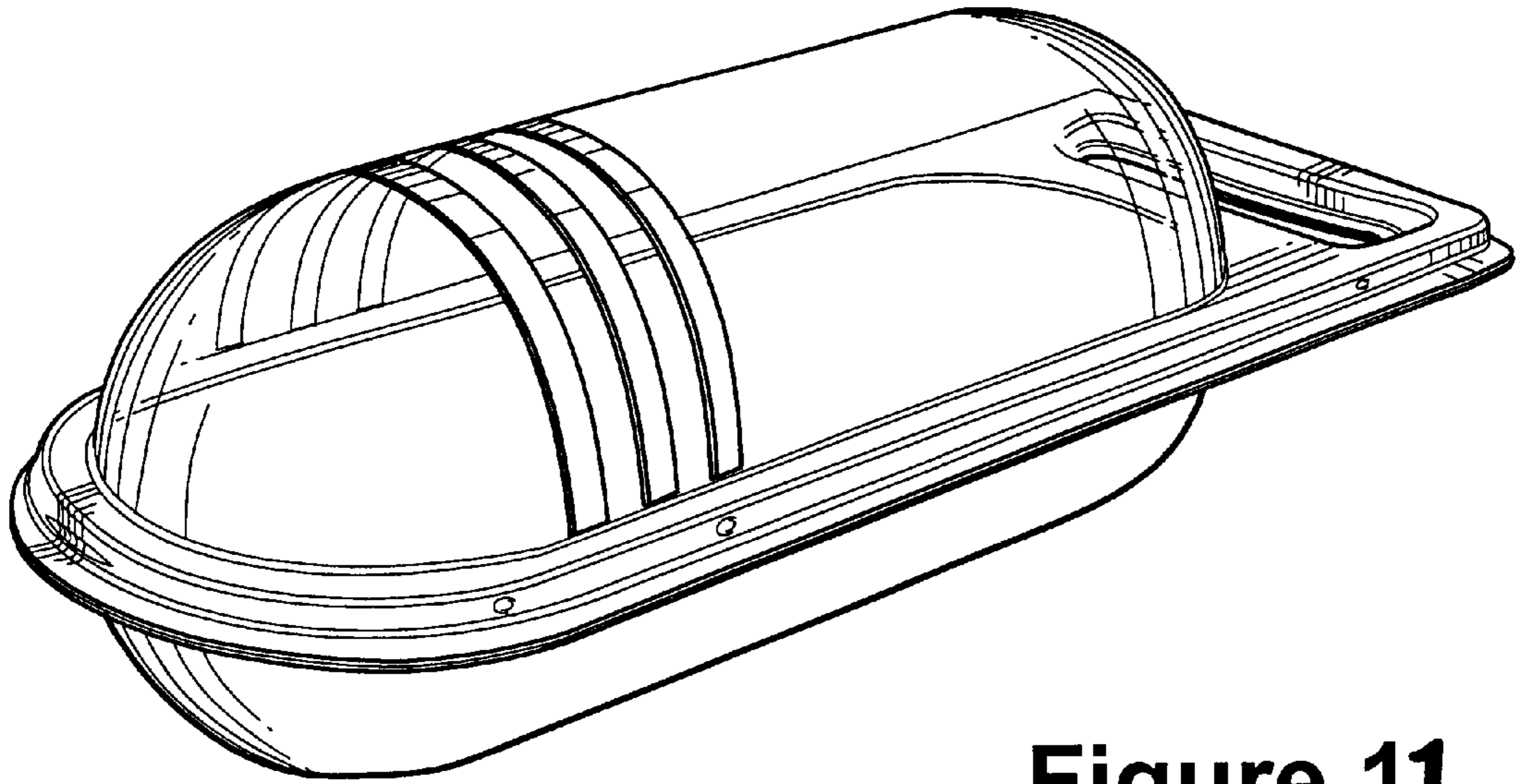

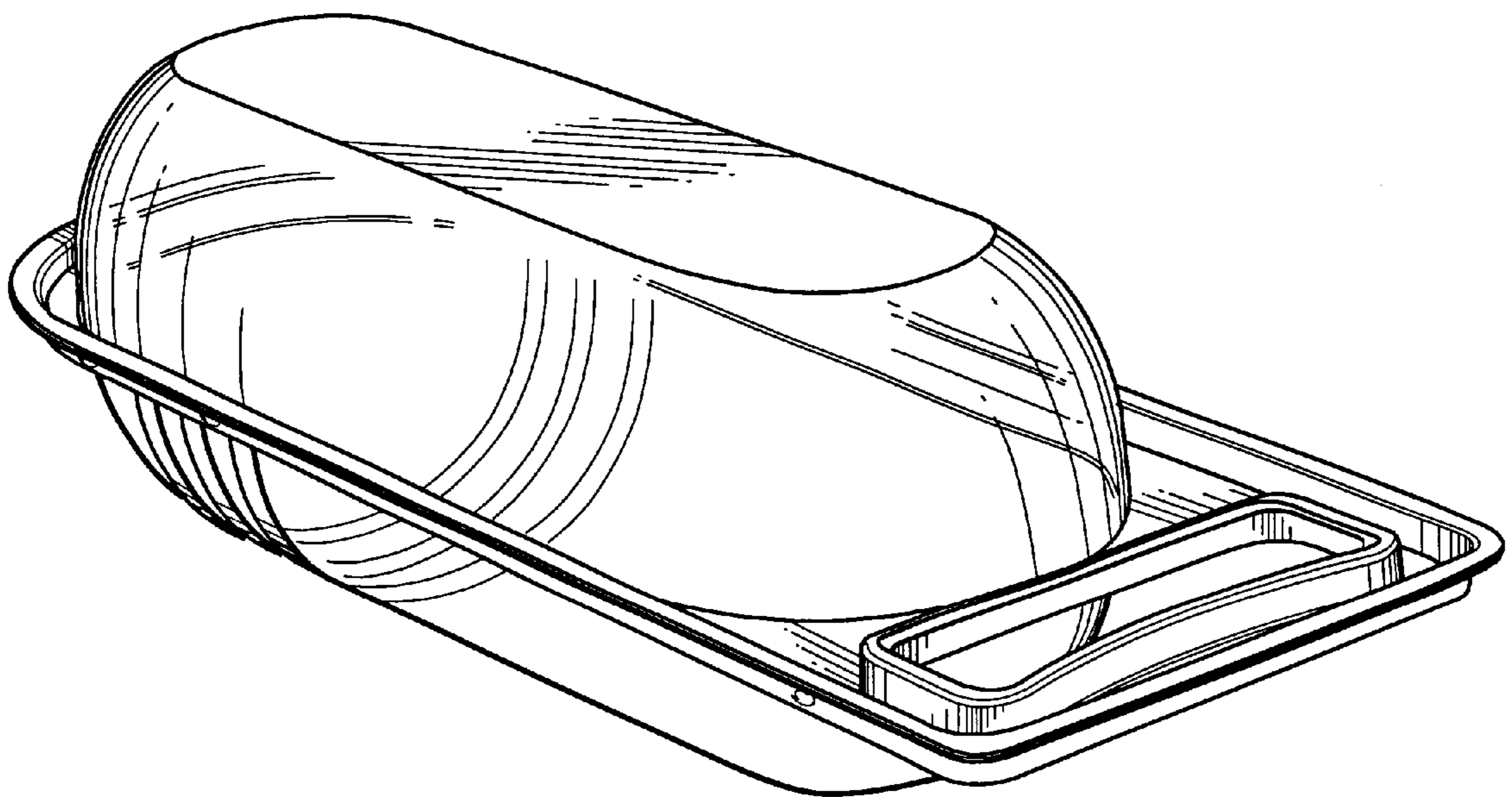

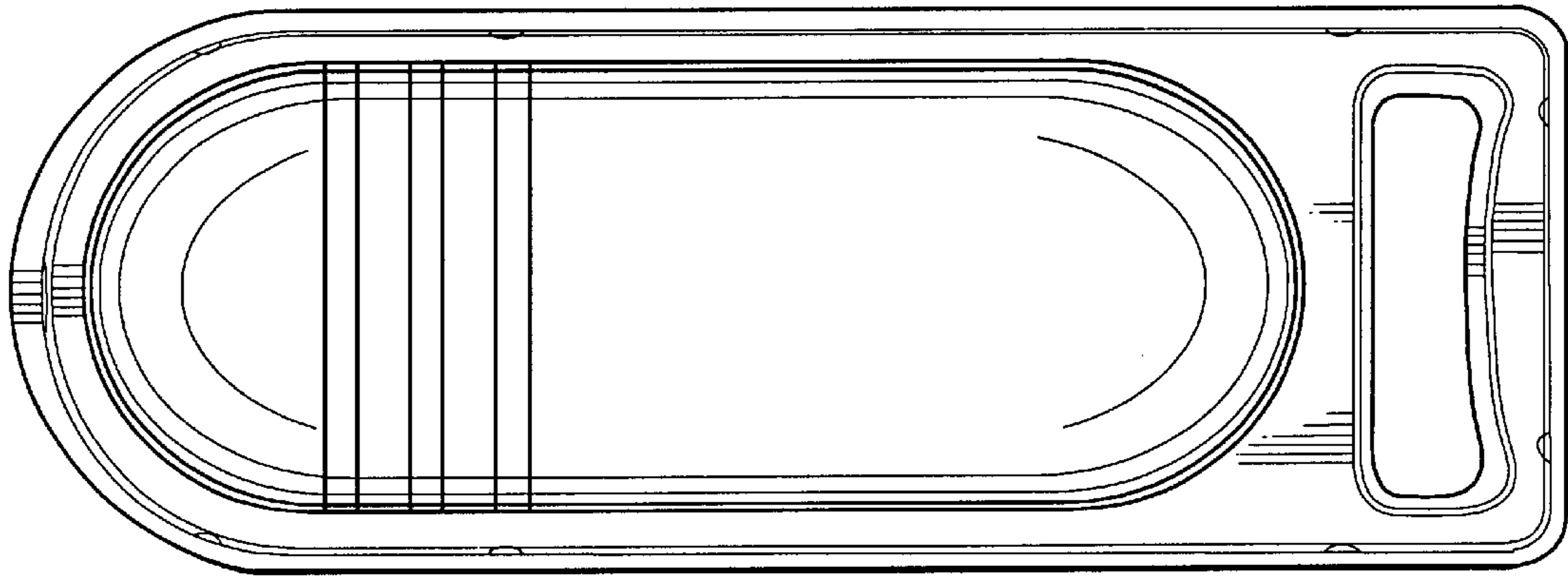

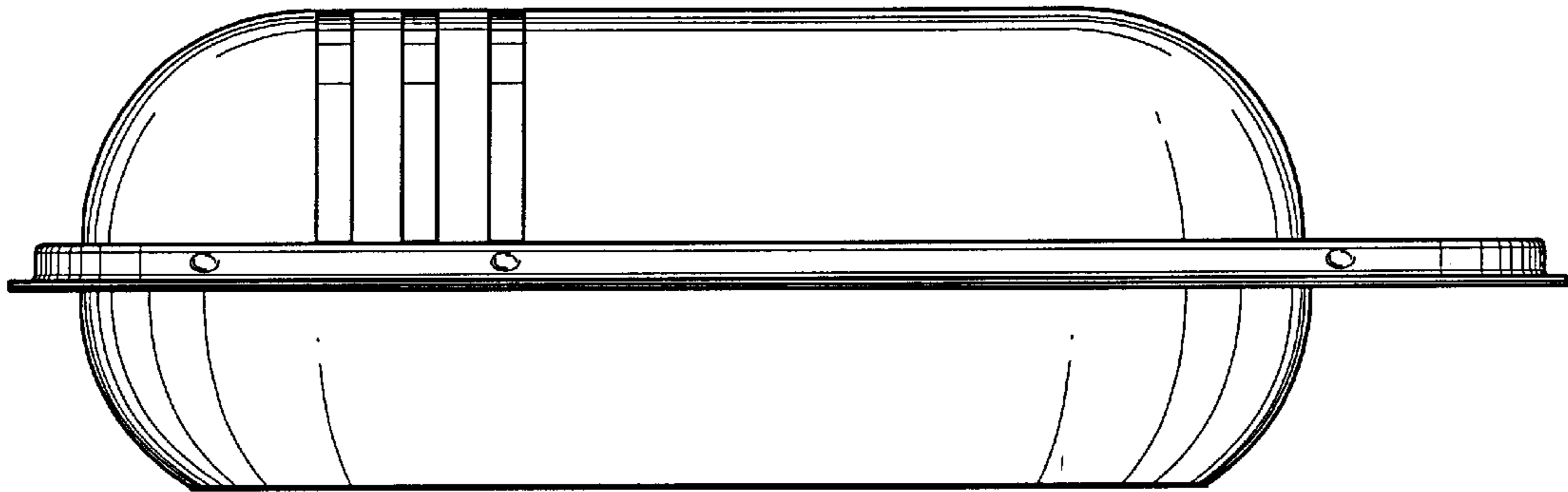

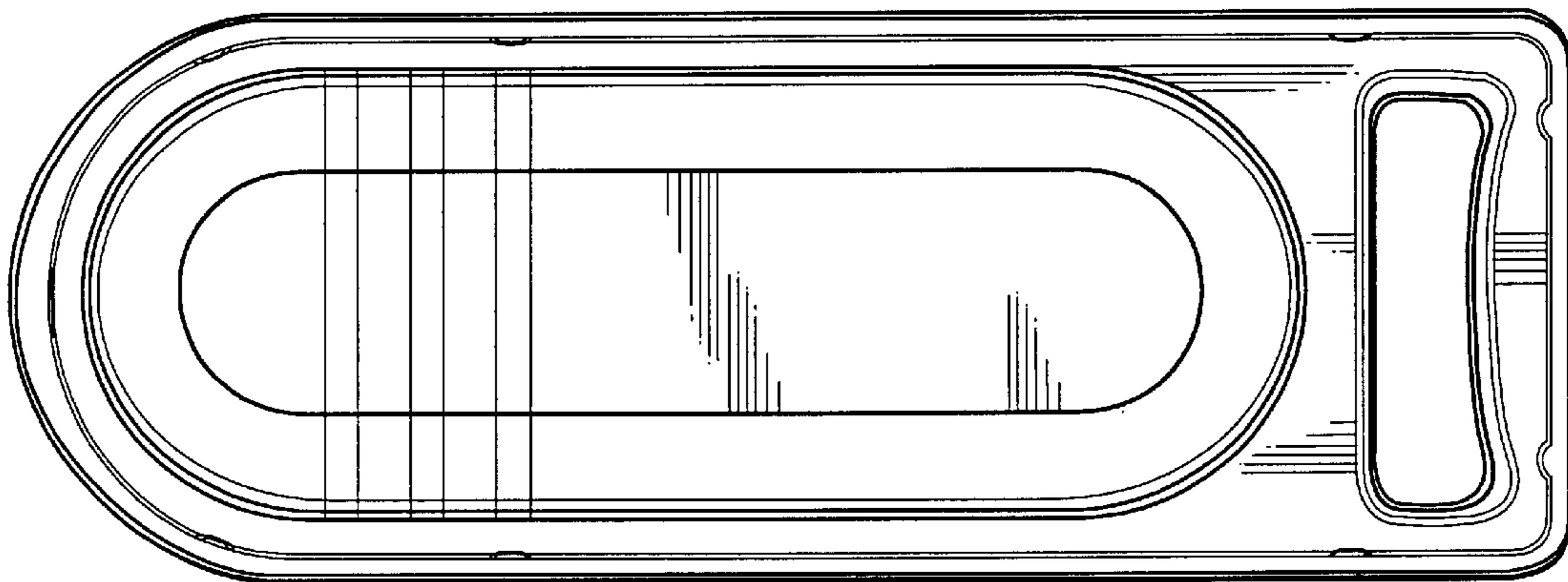

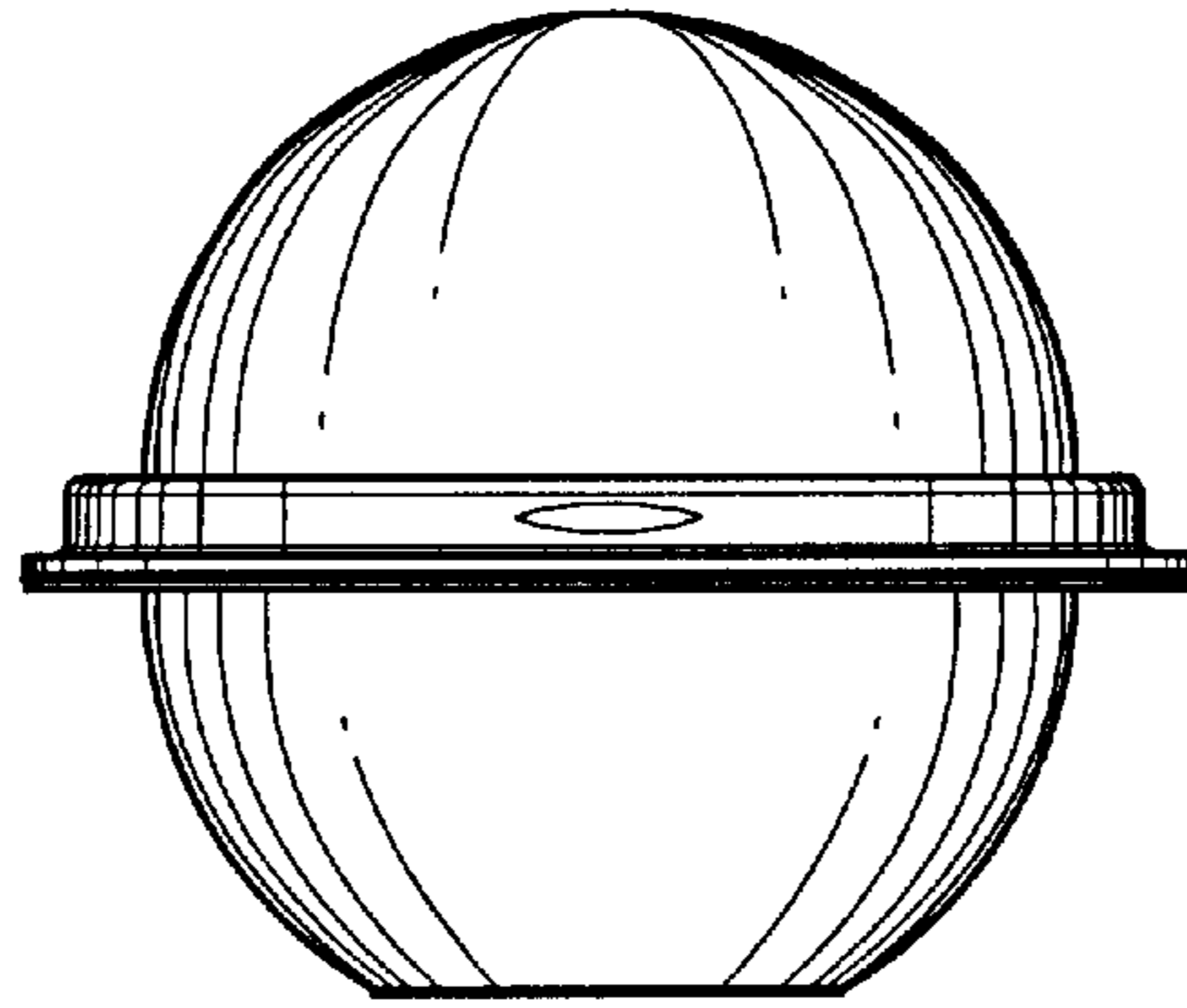

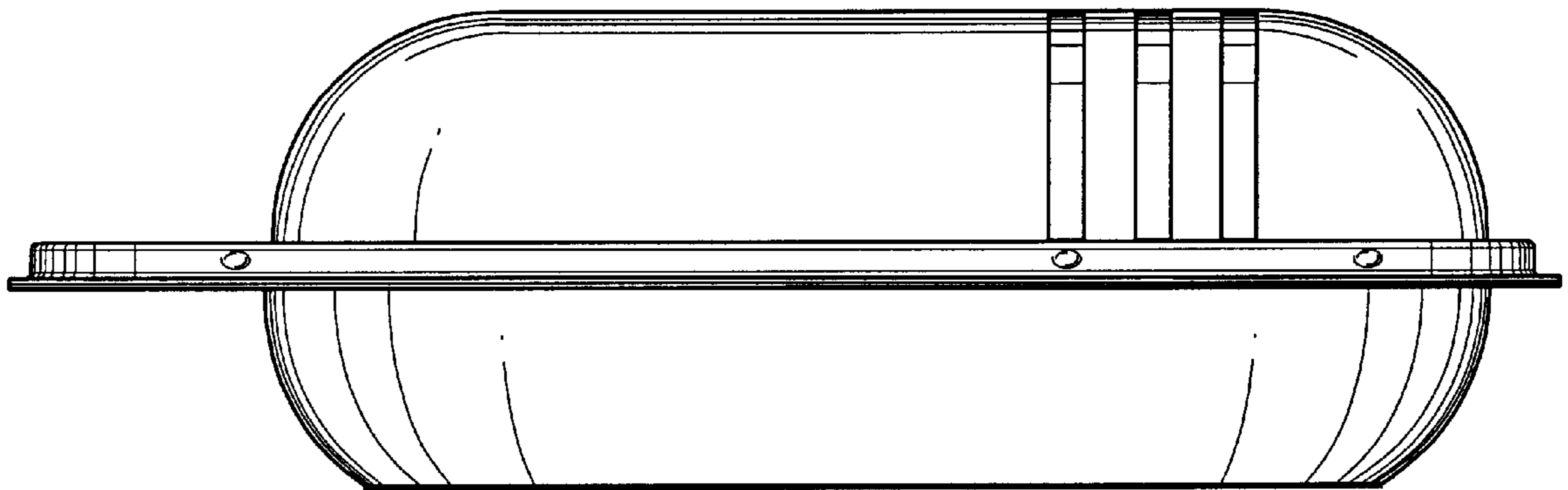

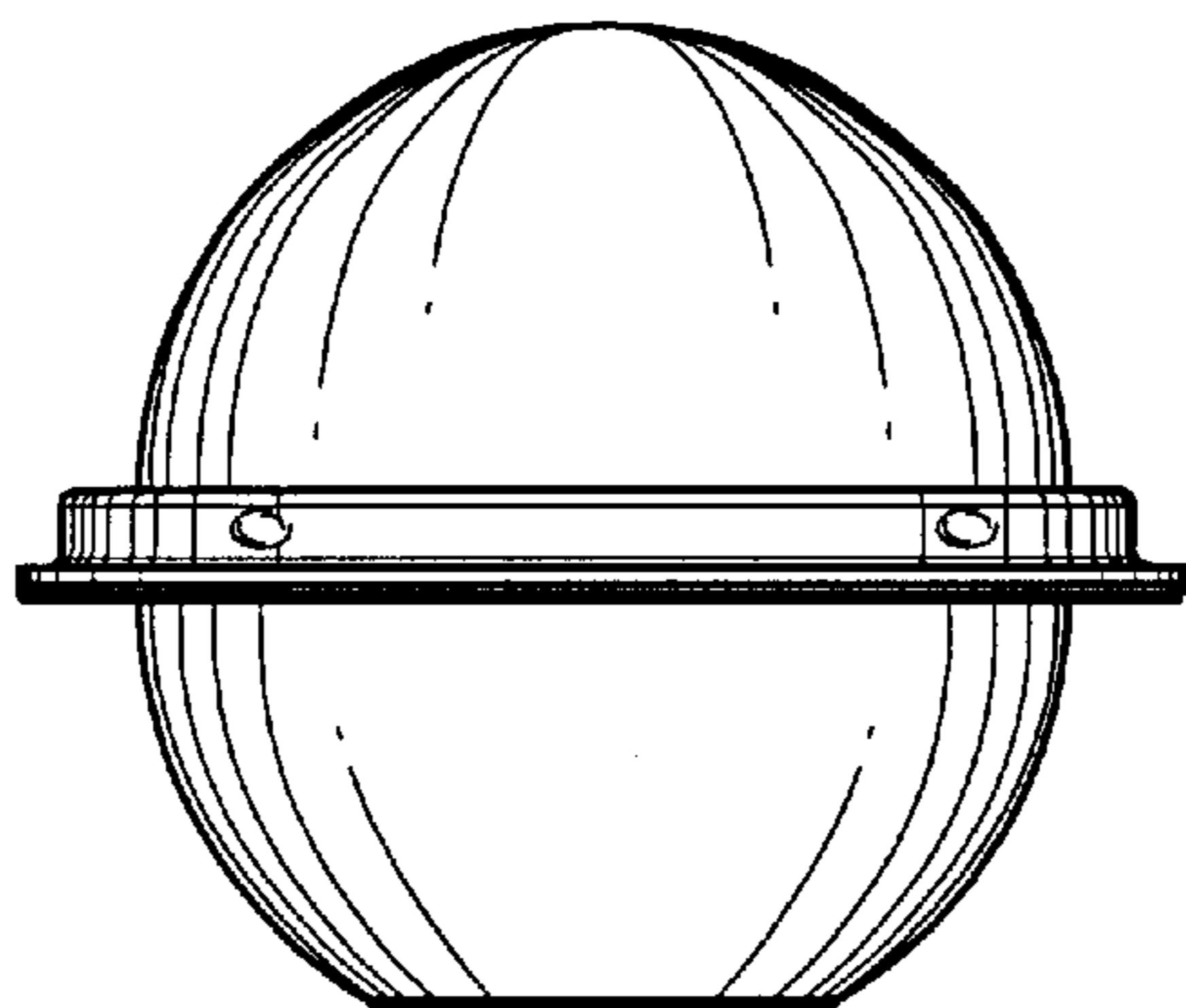

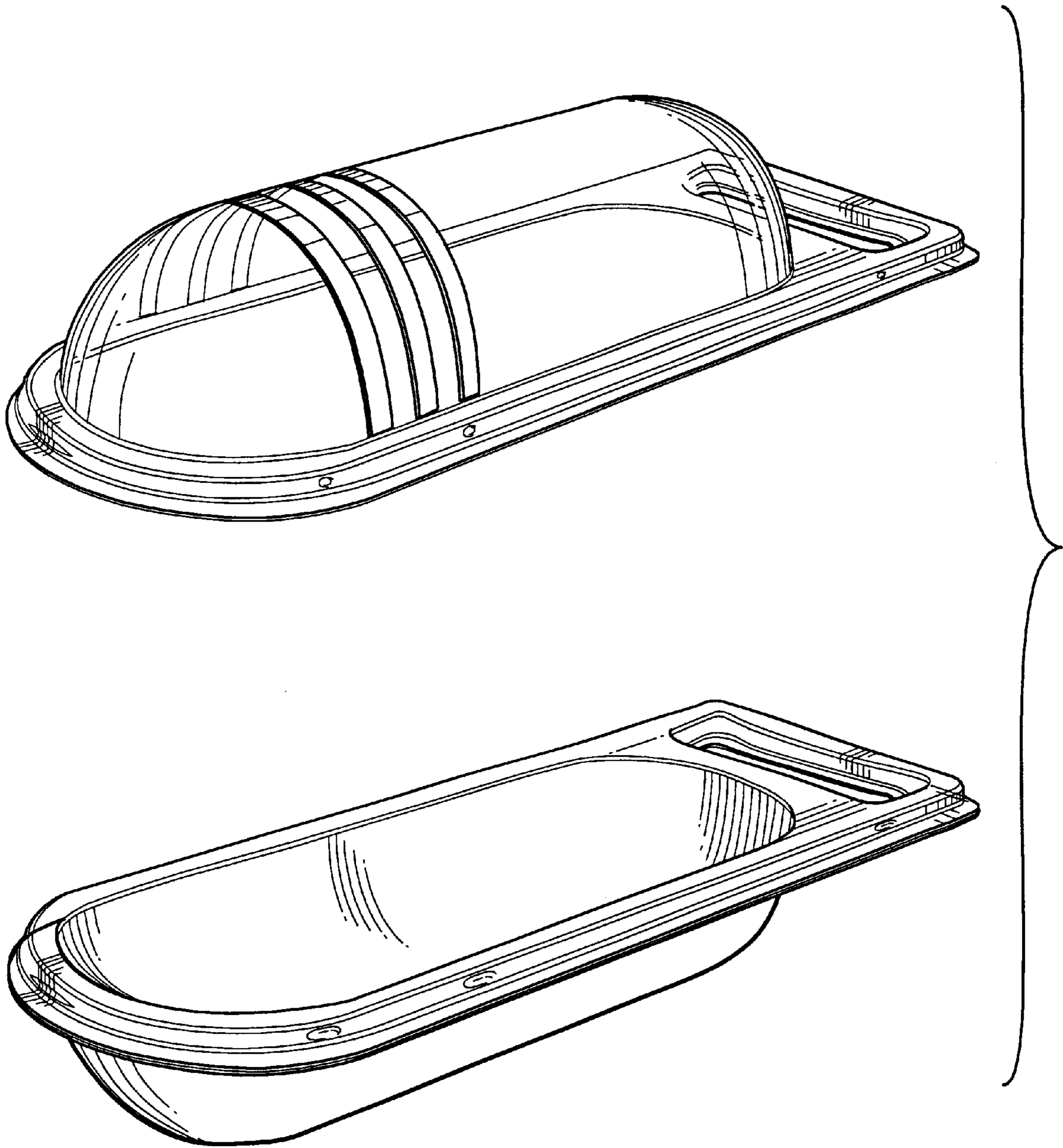

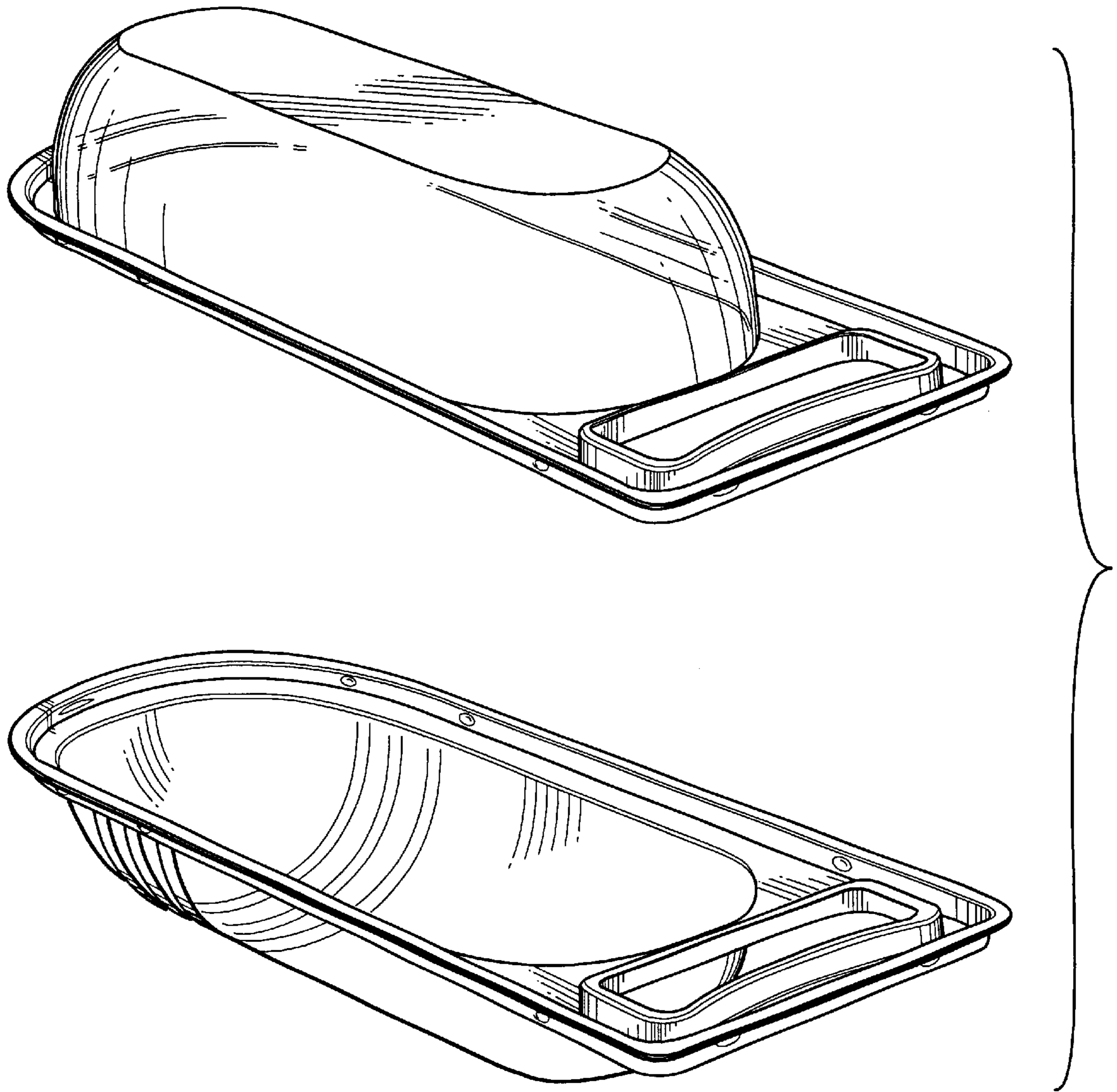
