#### (57) CLAIM

We claim the ornamental design for a tracked vehicle, as shown and described.

#### DESCRIPTION

FIG. 1 is a front perspective view of a first variant of bodywork of the tracked vehicle according to the present design;

tracked vehicle of FIG. 15; FIG. 18 is a right side elevation view of the bodywork of the tracked vehicle of FIG. 15; FIG. 19 is a front elevation view of the bodywork of the tracked vehicle of FIG. 15; FIG. 20 is a rear elevation view of the bodywork of the tracked vehicle of FIG. 15; and, FIG. 21 is a top plan view of the bodywork of the tracked vehicle of FIG. 15. The broken lines immediately adjacent to the cab represent the bounds of the design while all other broken lines represent environment. None of the broken lines form a part

of the claimed design.
