The ornamental design for the connector housing for a plug-connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the connector housing for a plug-connector, as viewed from top, front and right side, showing our new design;

FIG. 2 is a perspective view thereof, as viewed from top, rear and right side;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side view thereof, a right side view thereof being a mirror image;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

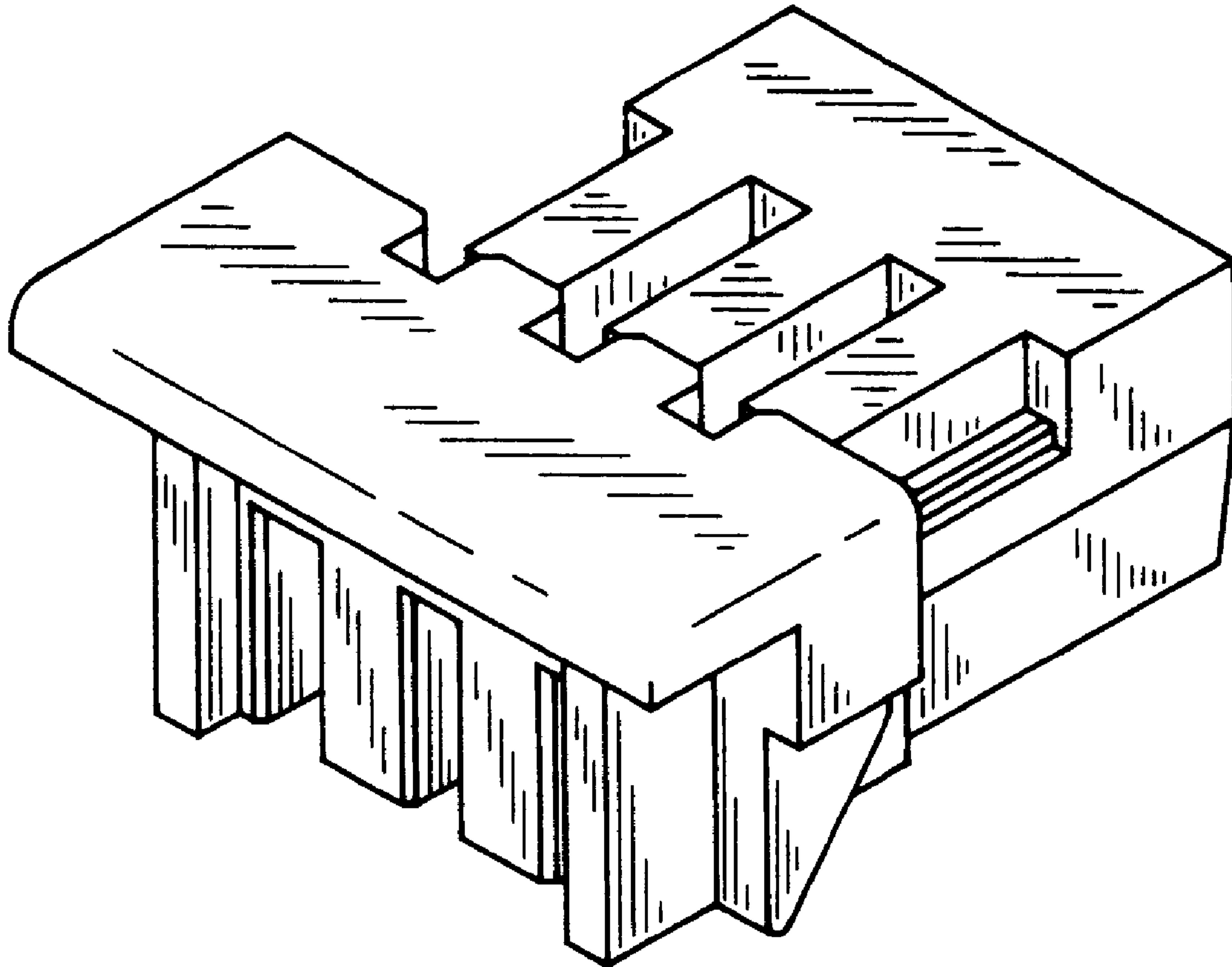

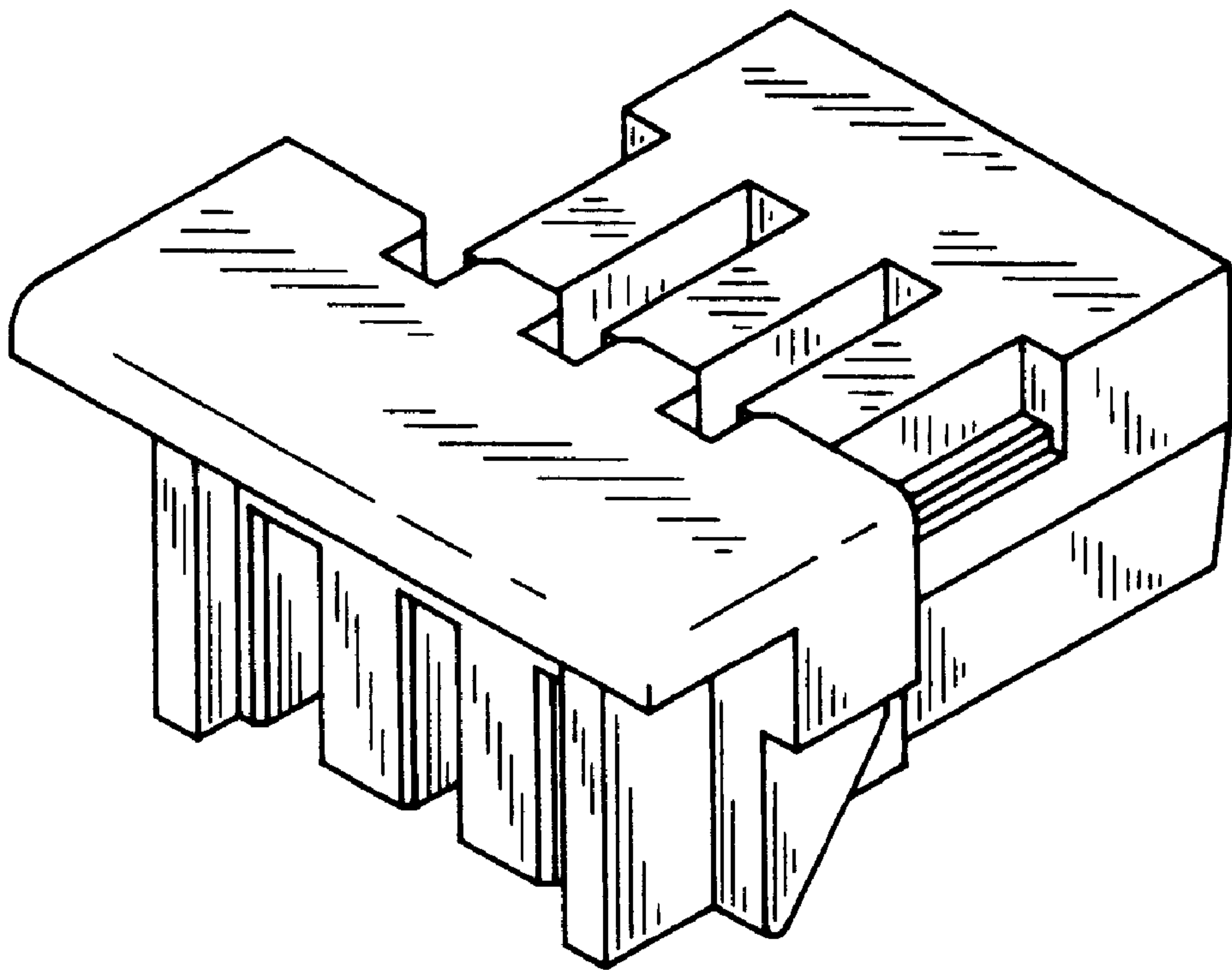

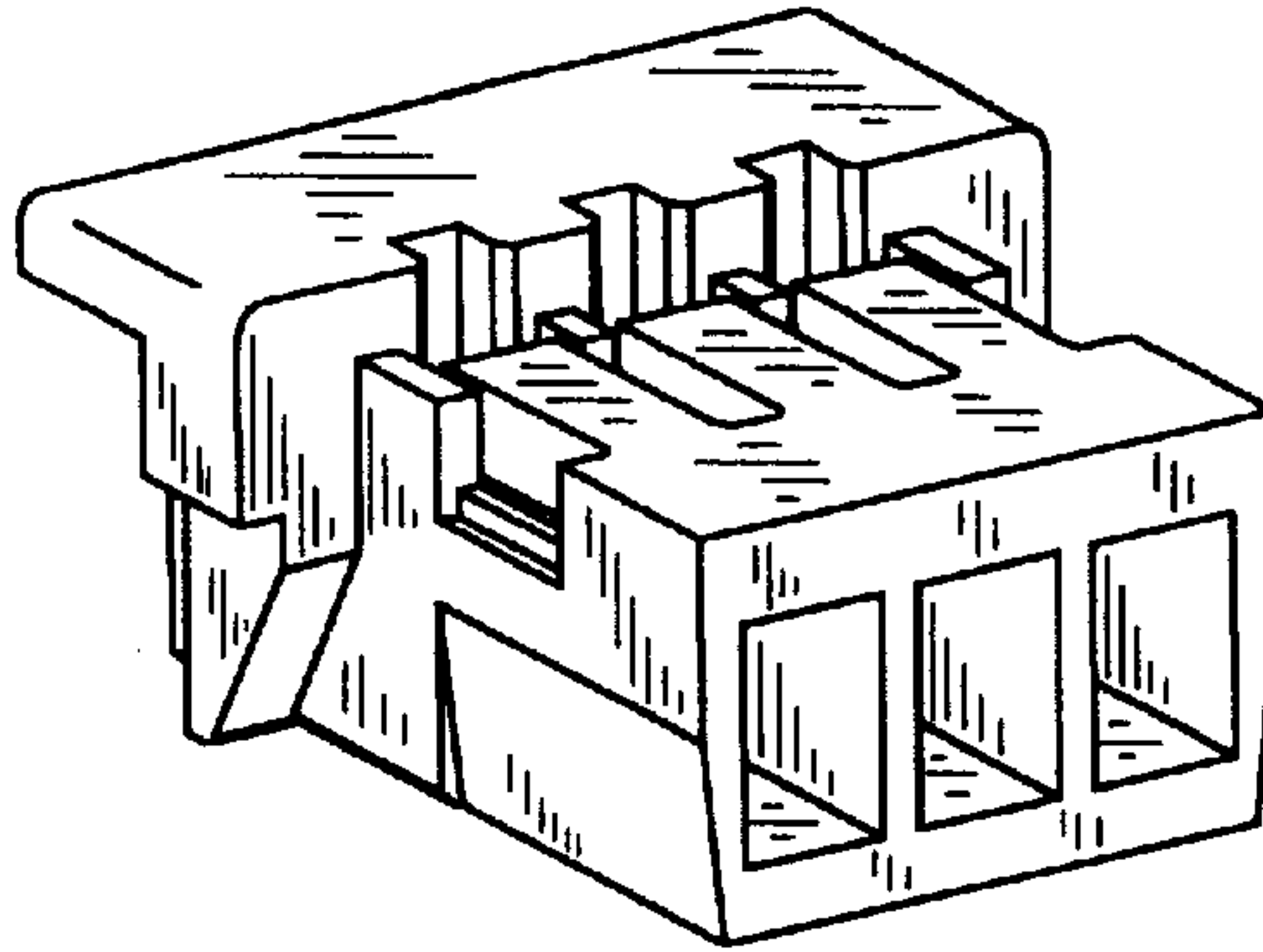

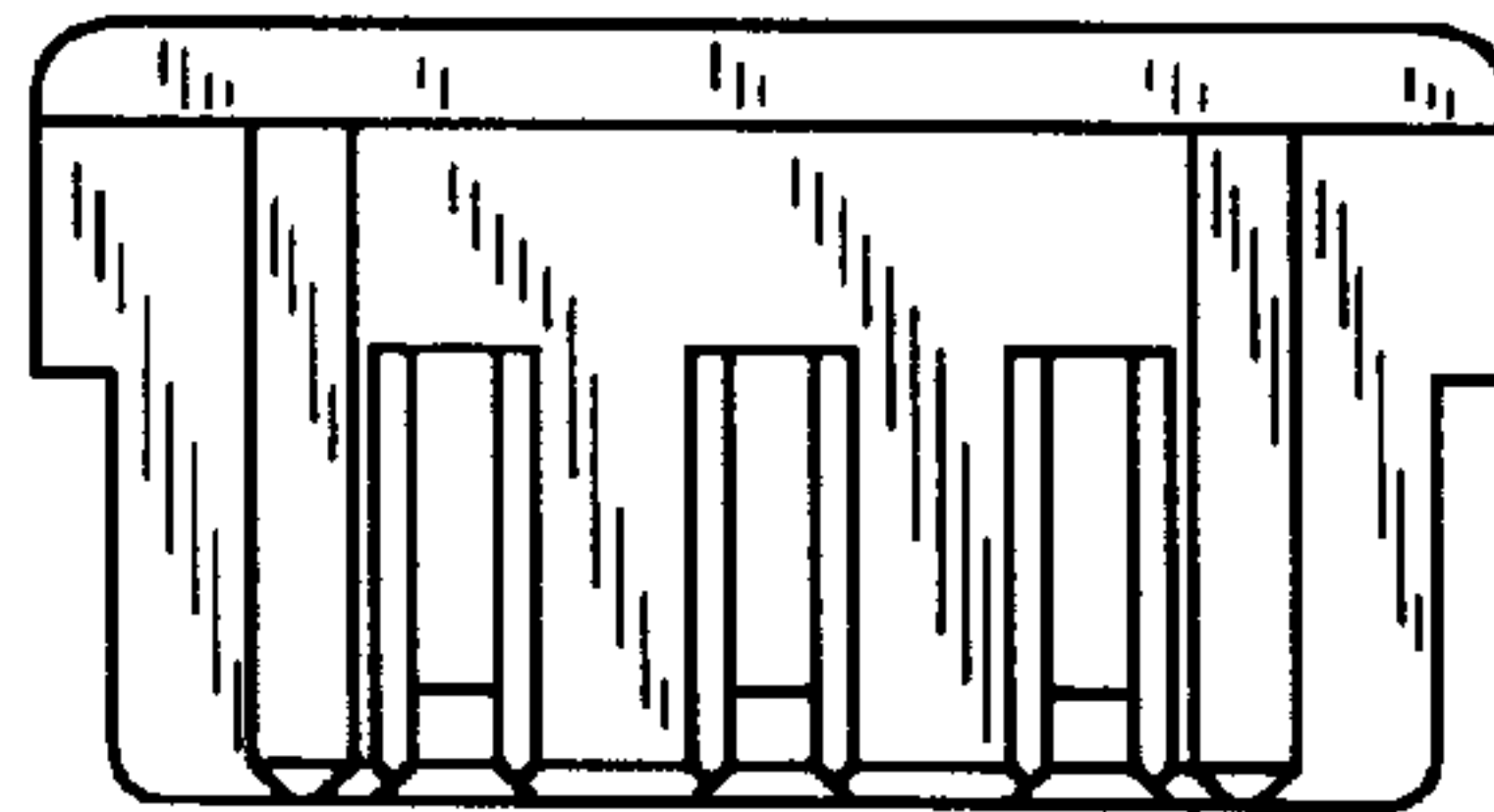

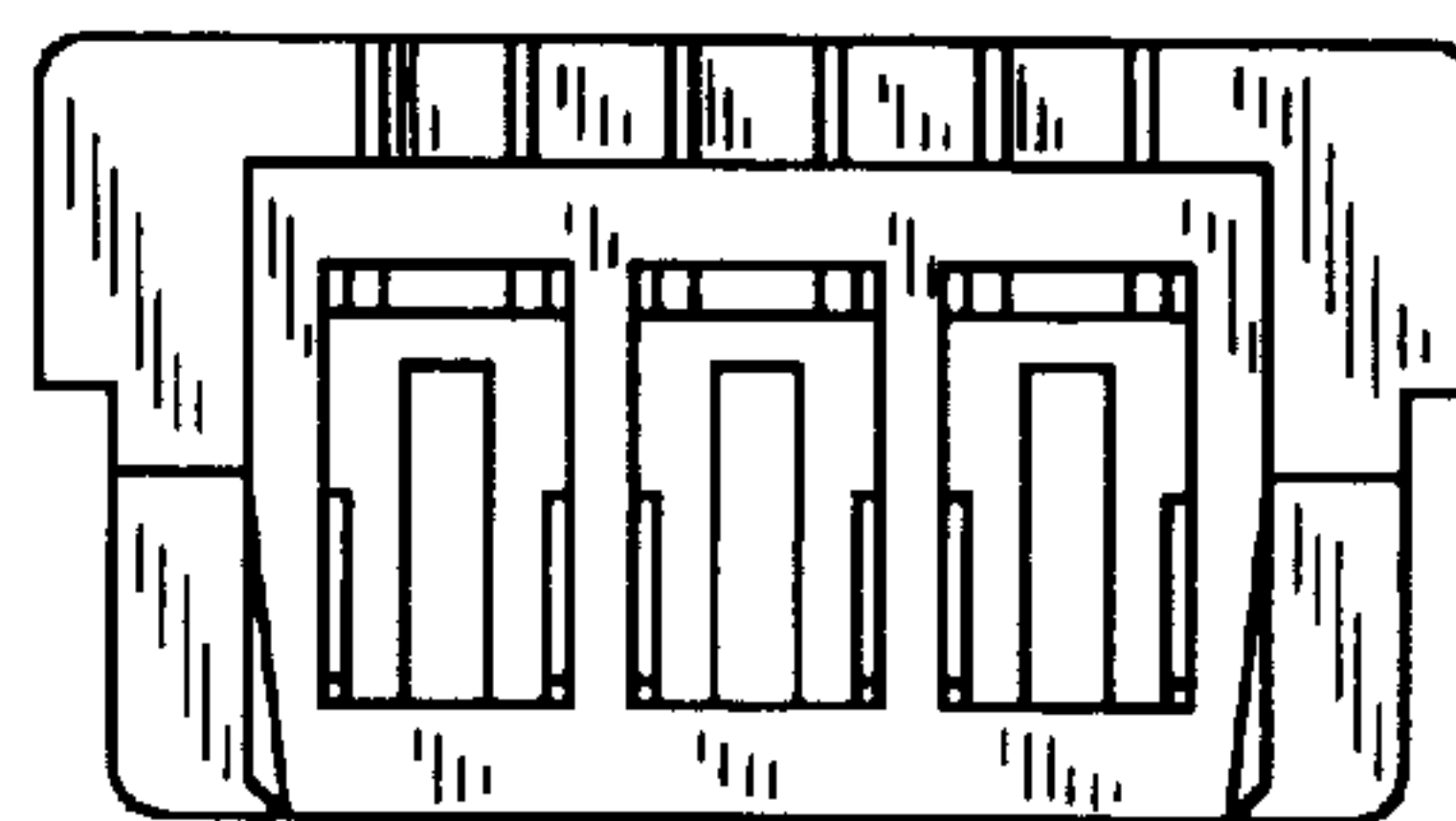

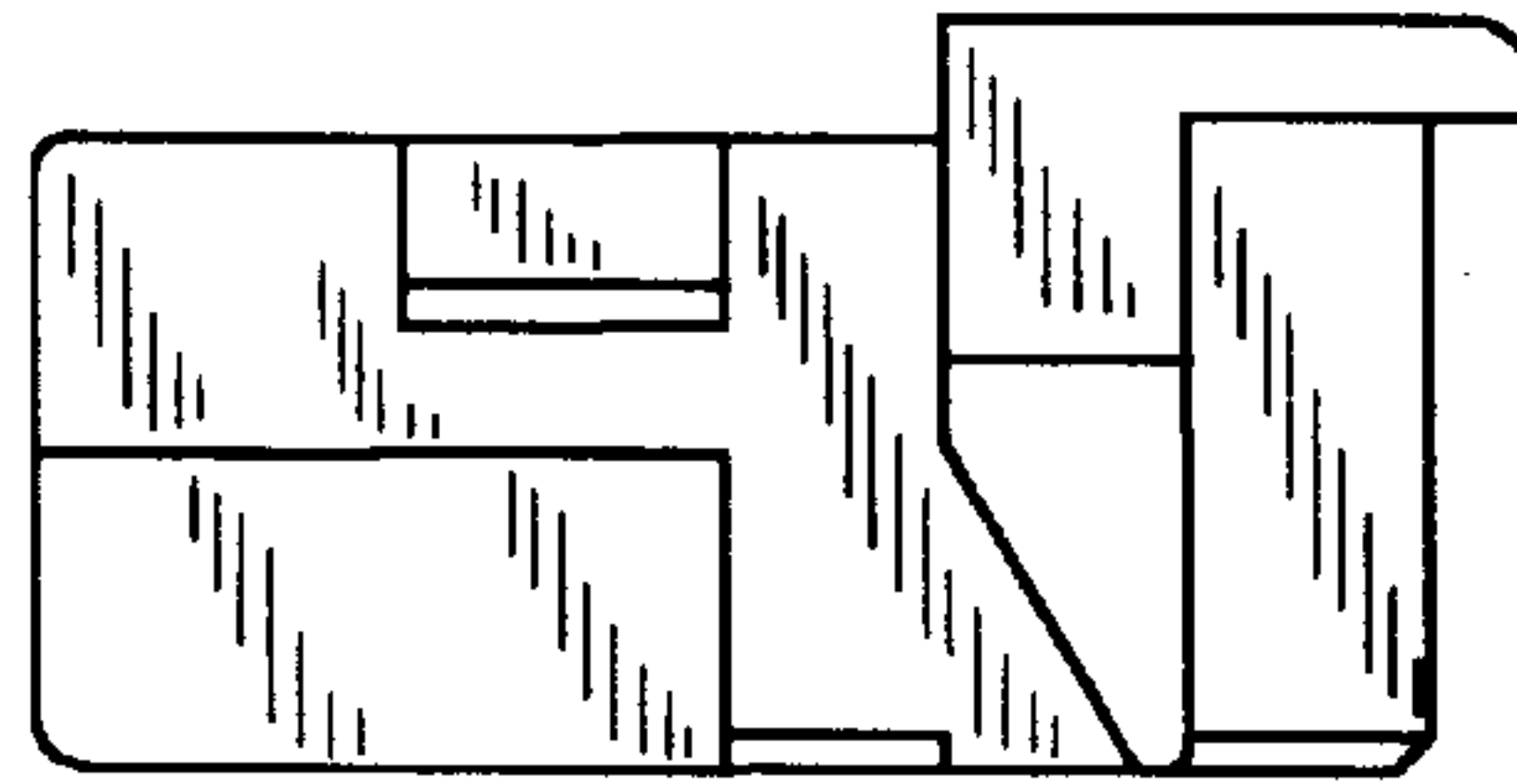

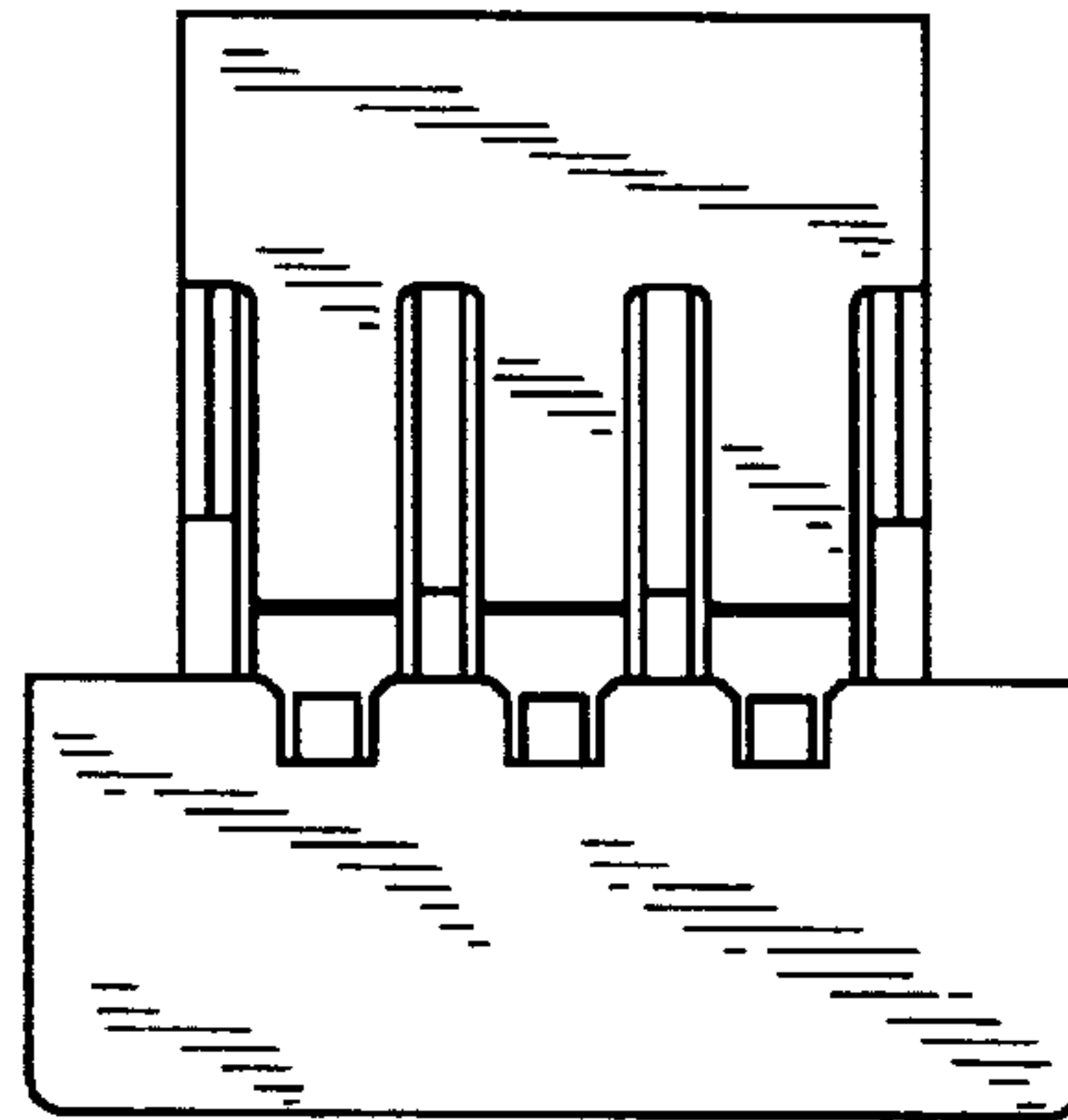
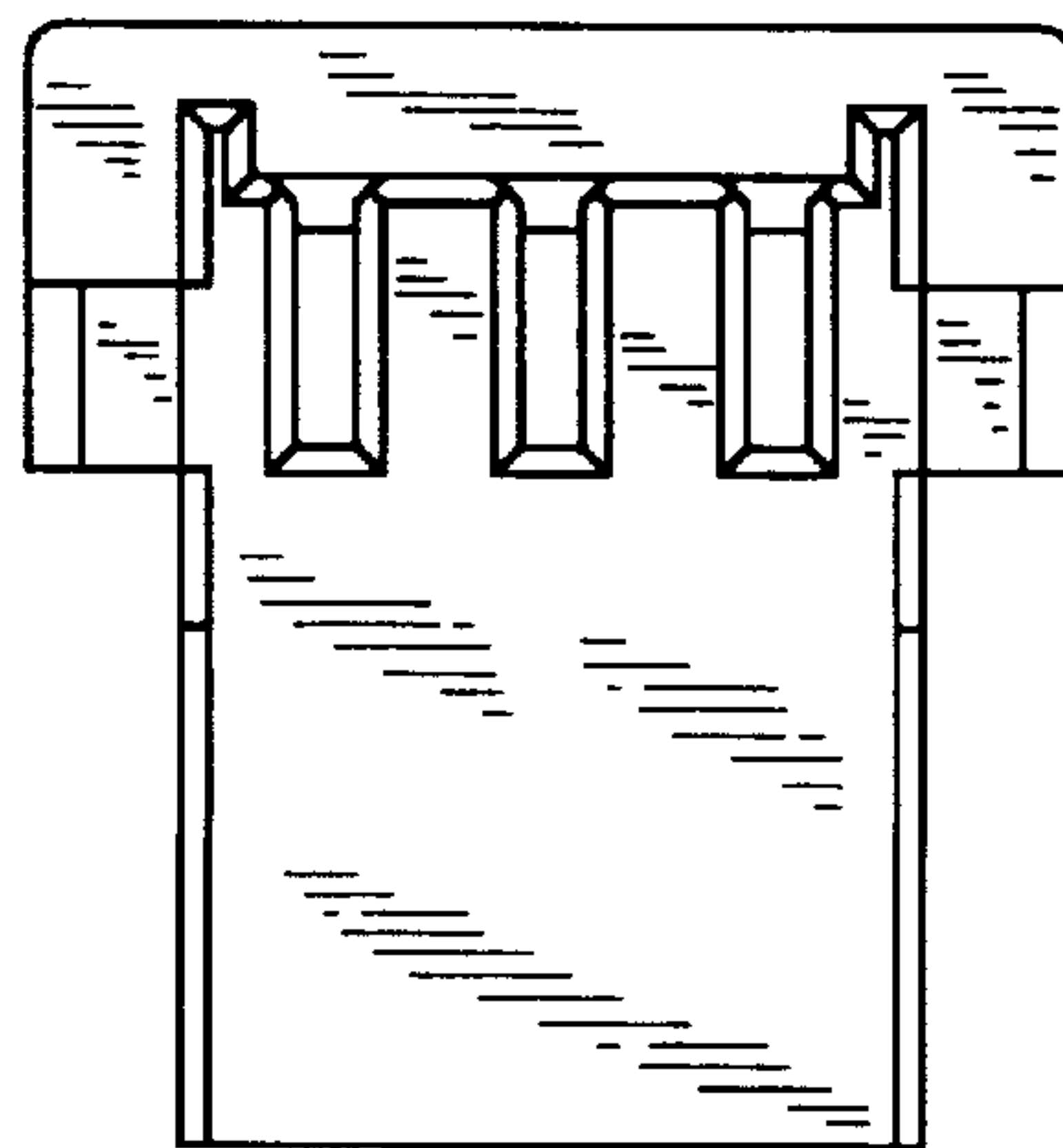
