The ornamental design for a sports theme amusement patch with universal warning symbol overlay.

**DESCRIPTION**

FIG. 14 is a front plan view of the tennis version thereof;

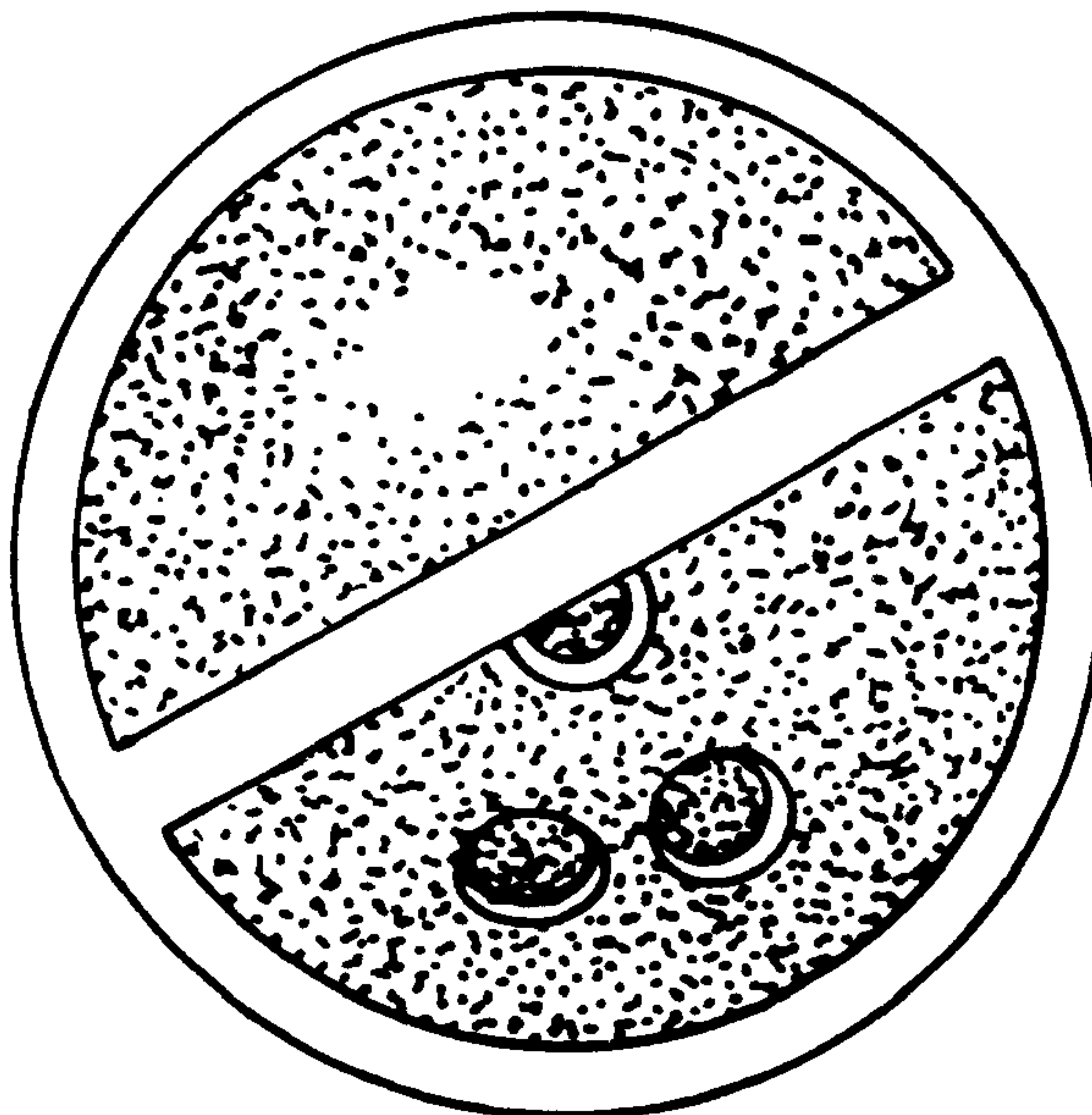
FIG. 15 is a front plan view of the cricket version thereof;

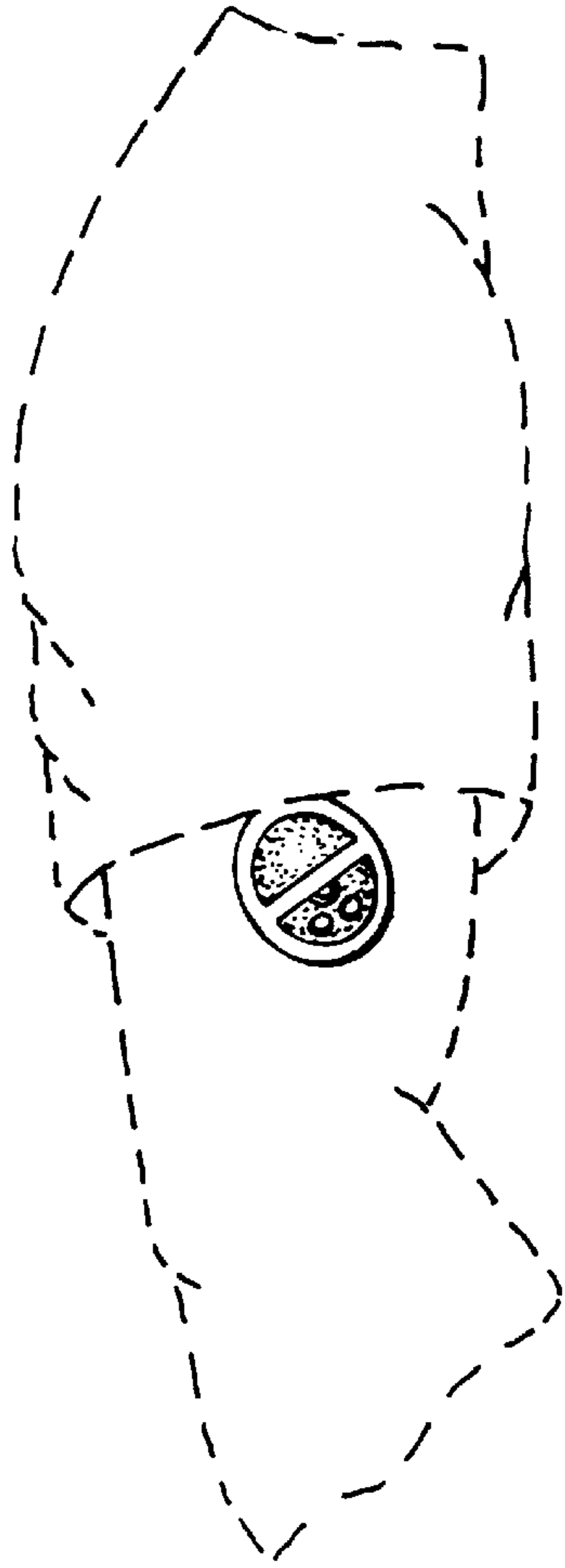

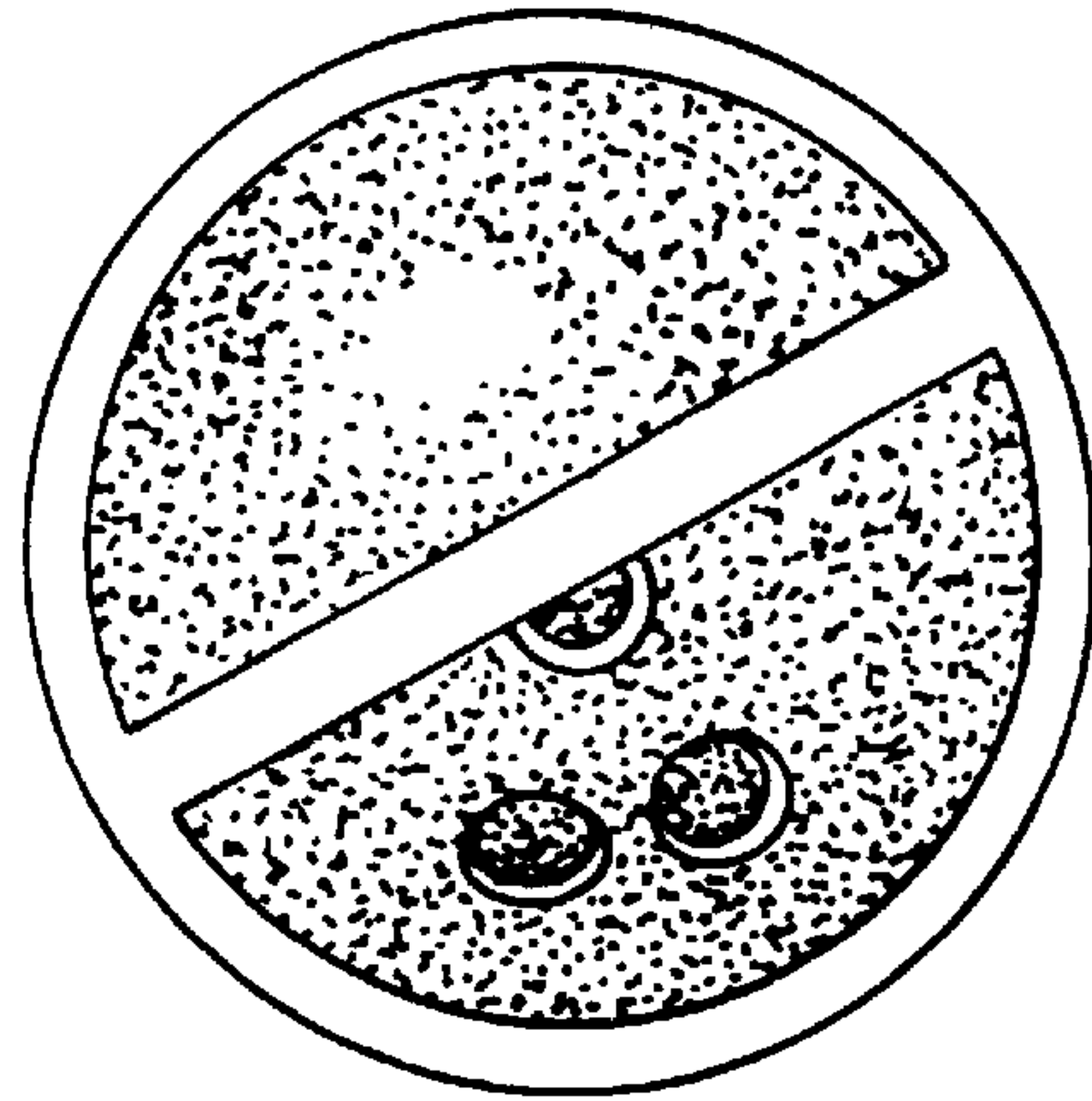

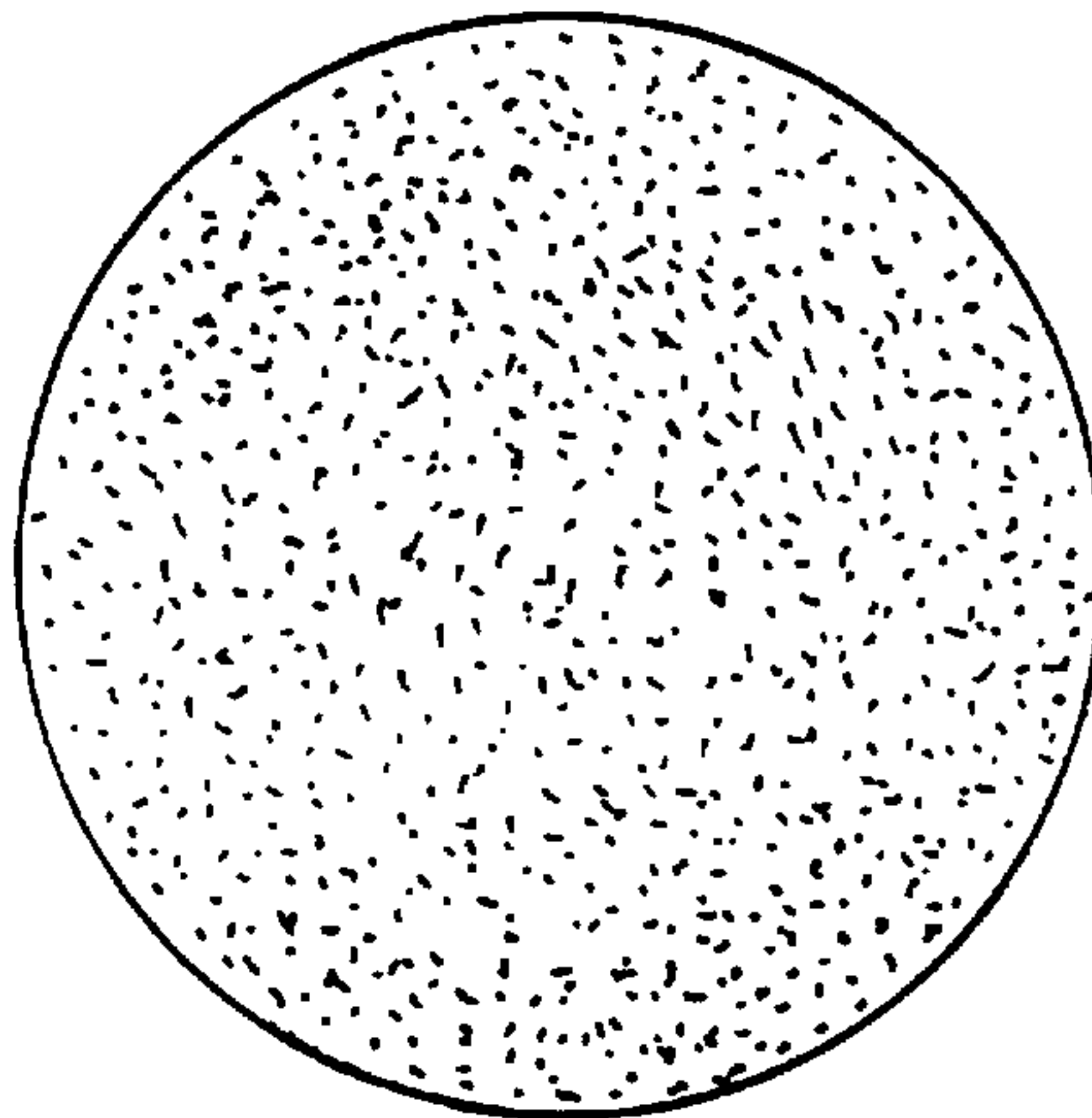

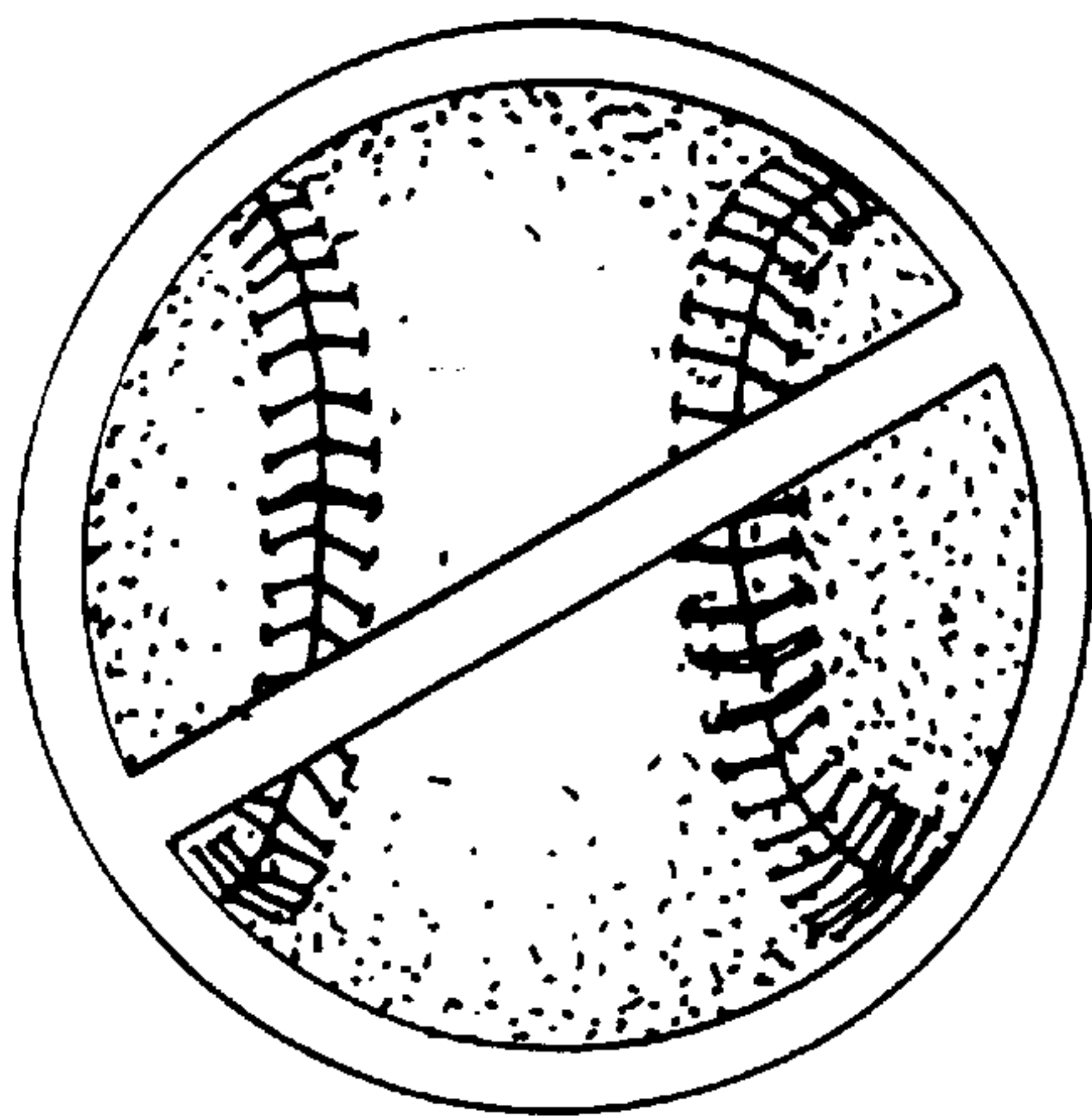

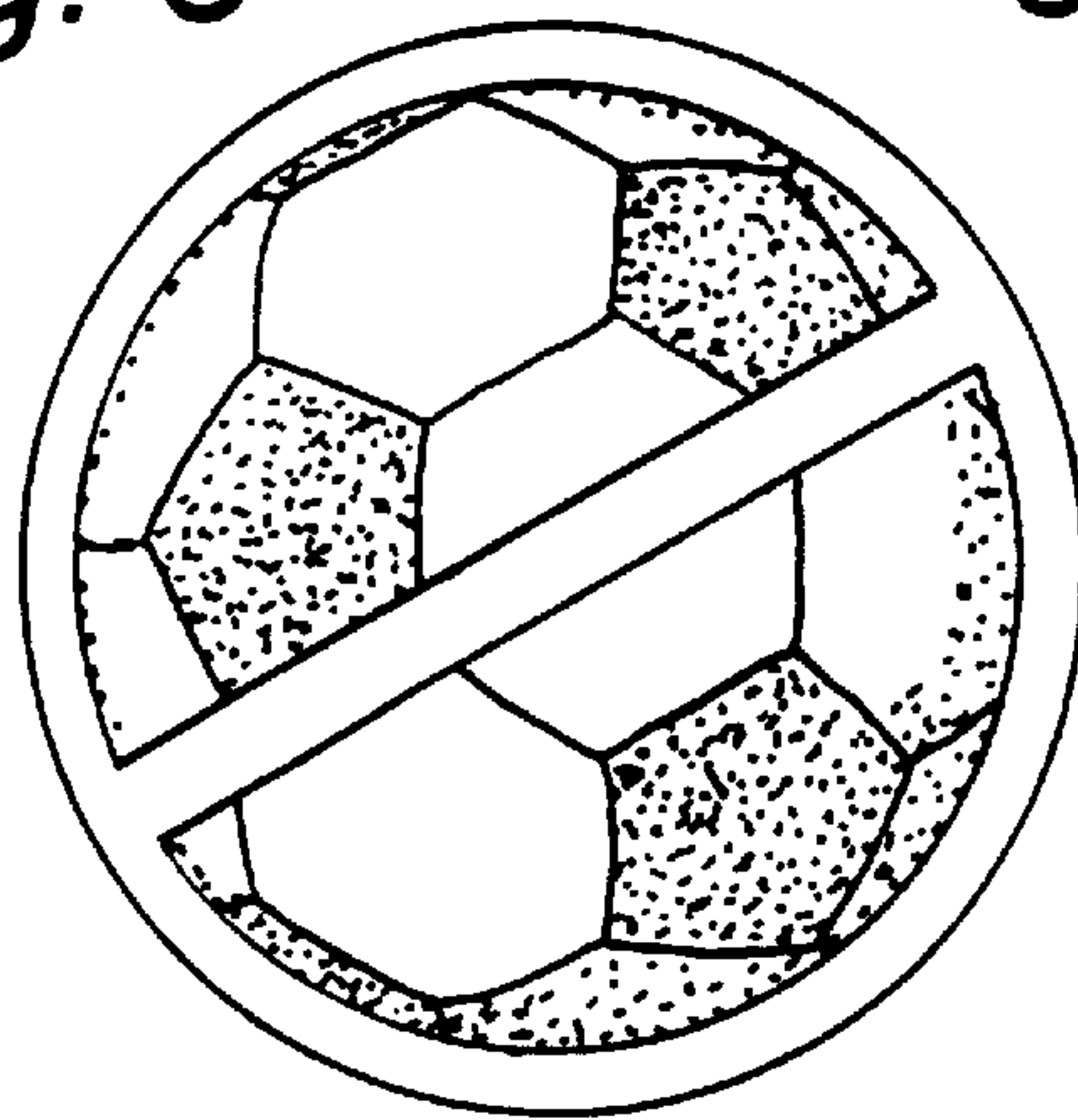
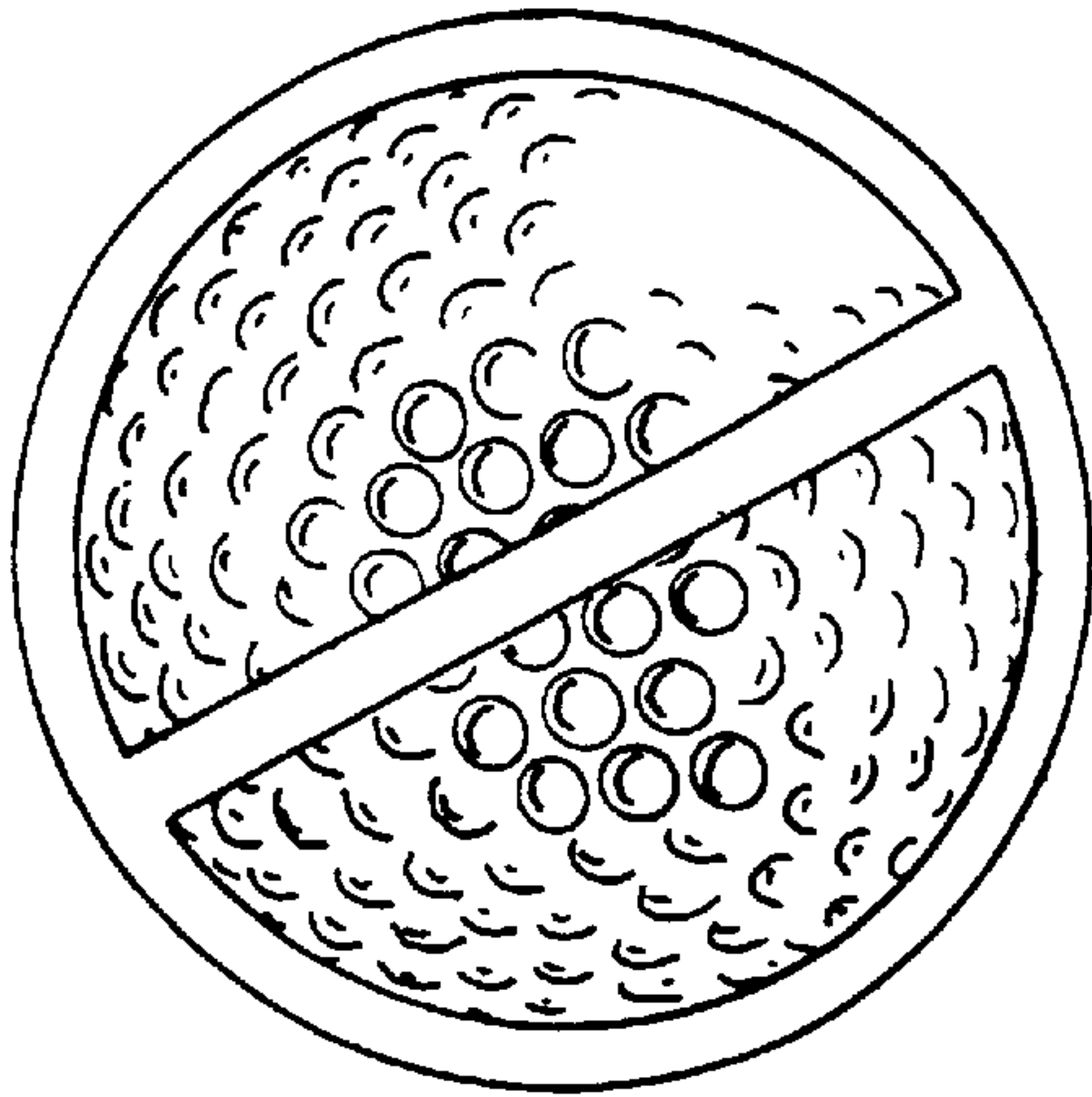
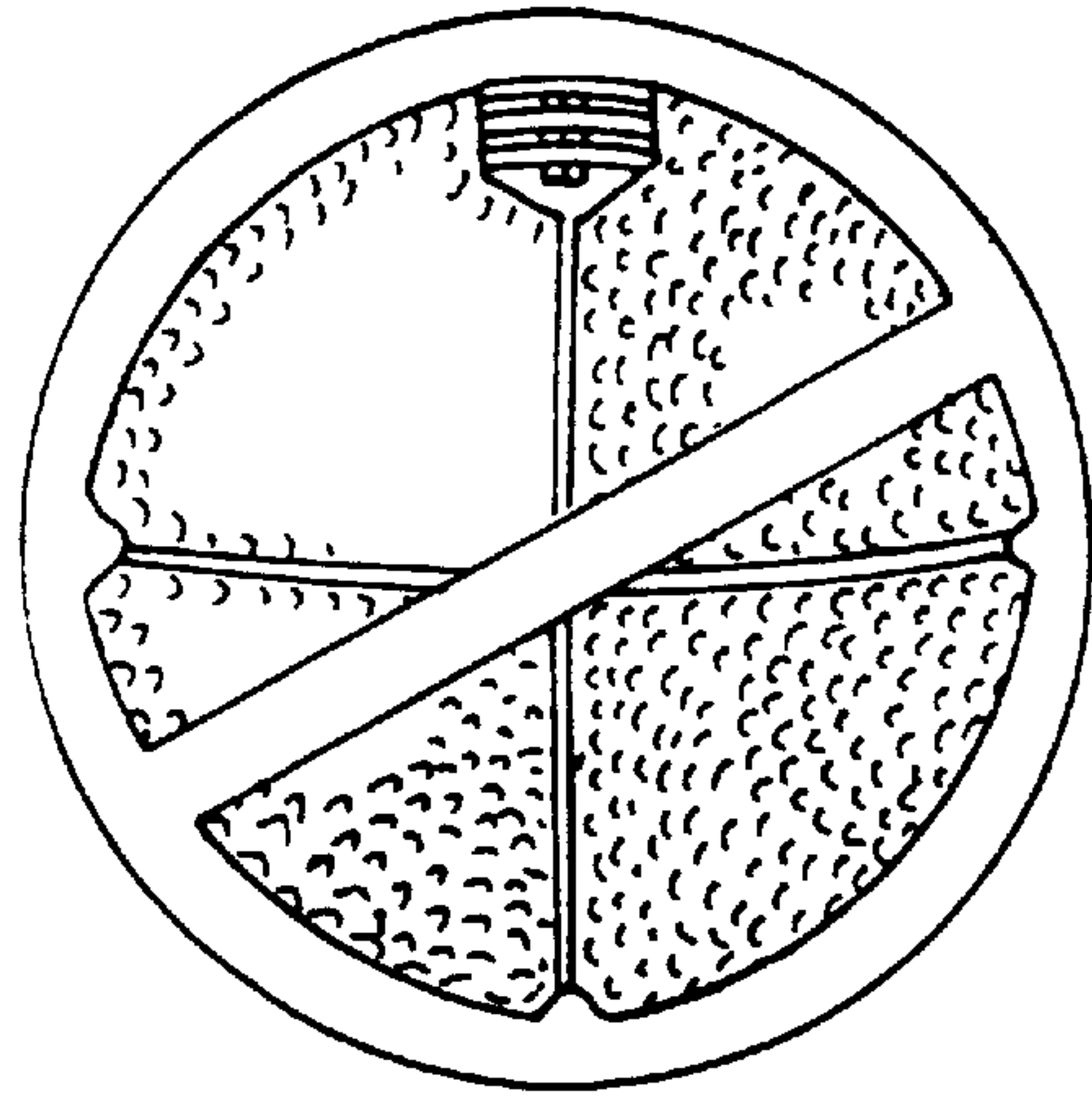

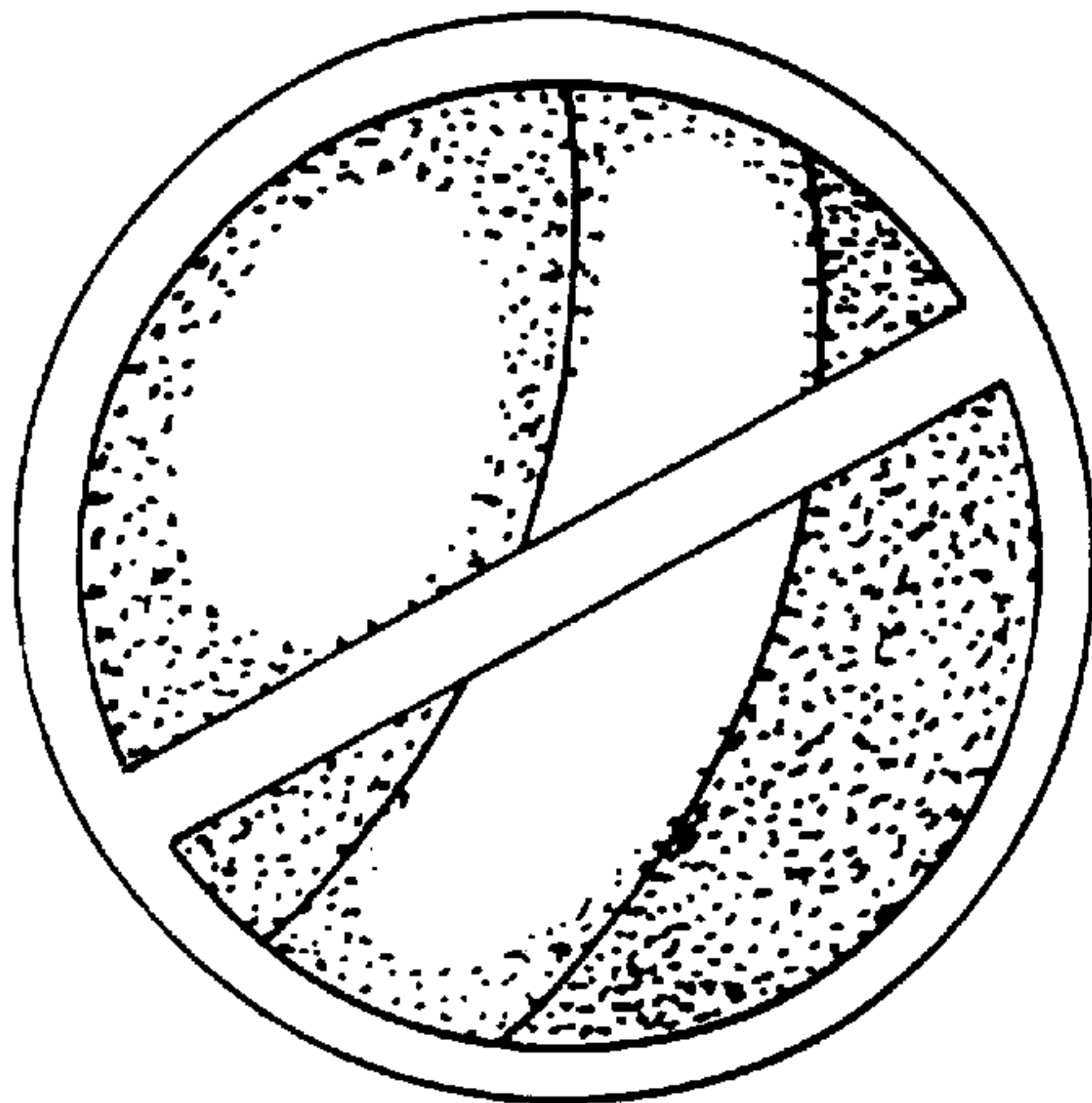




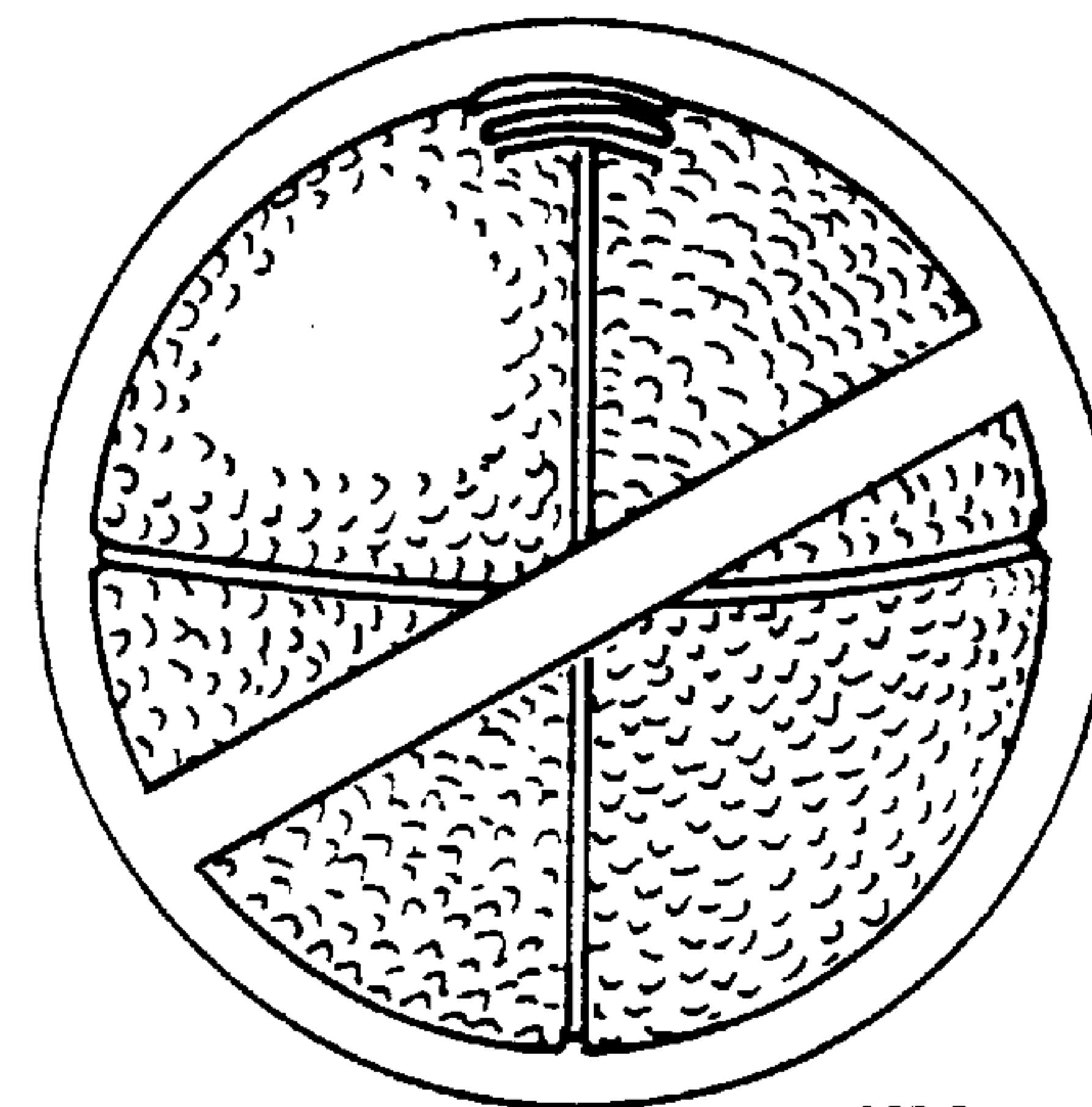

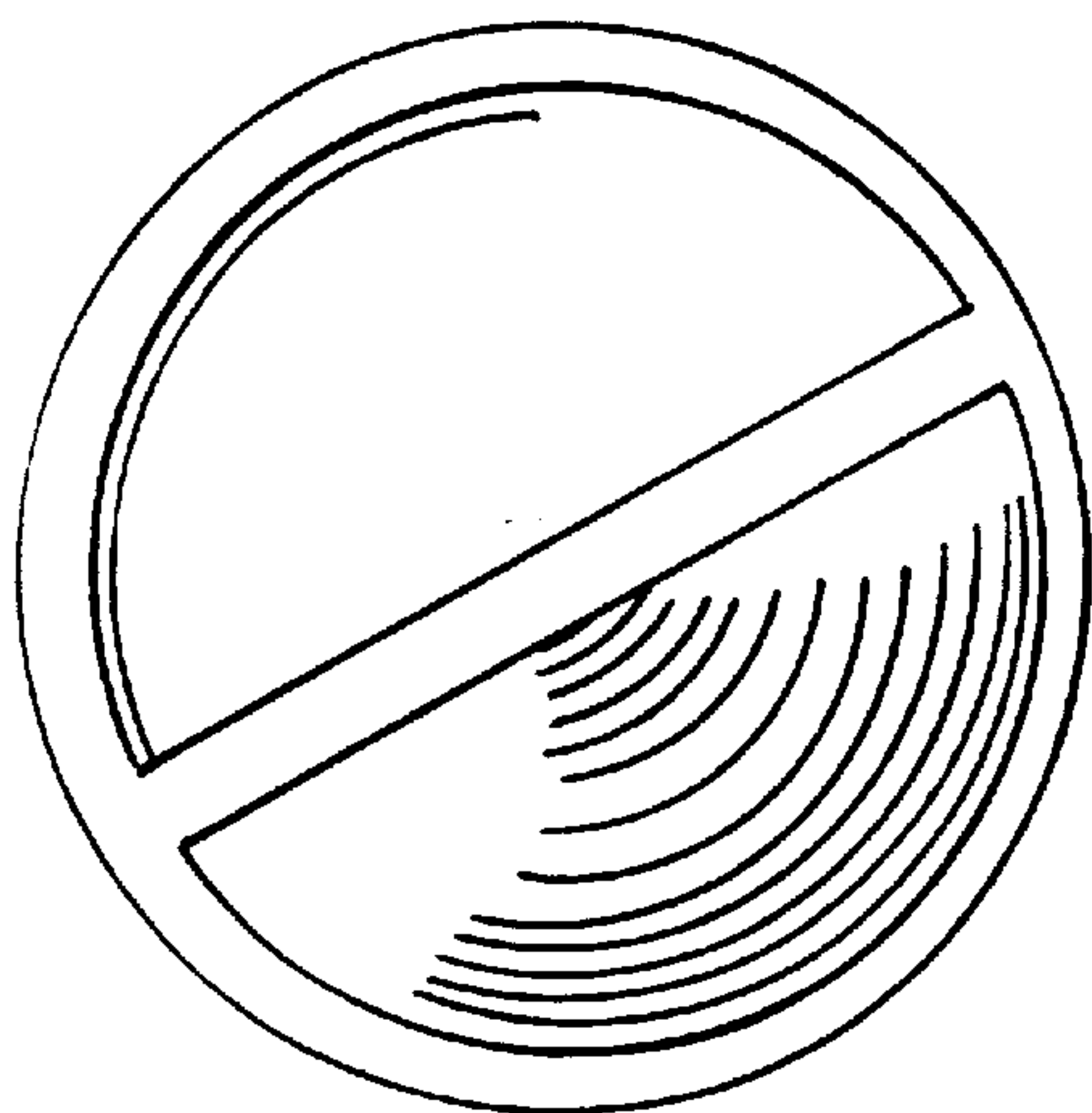

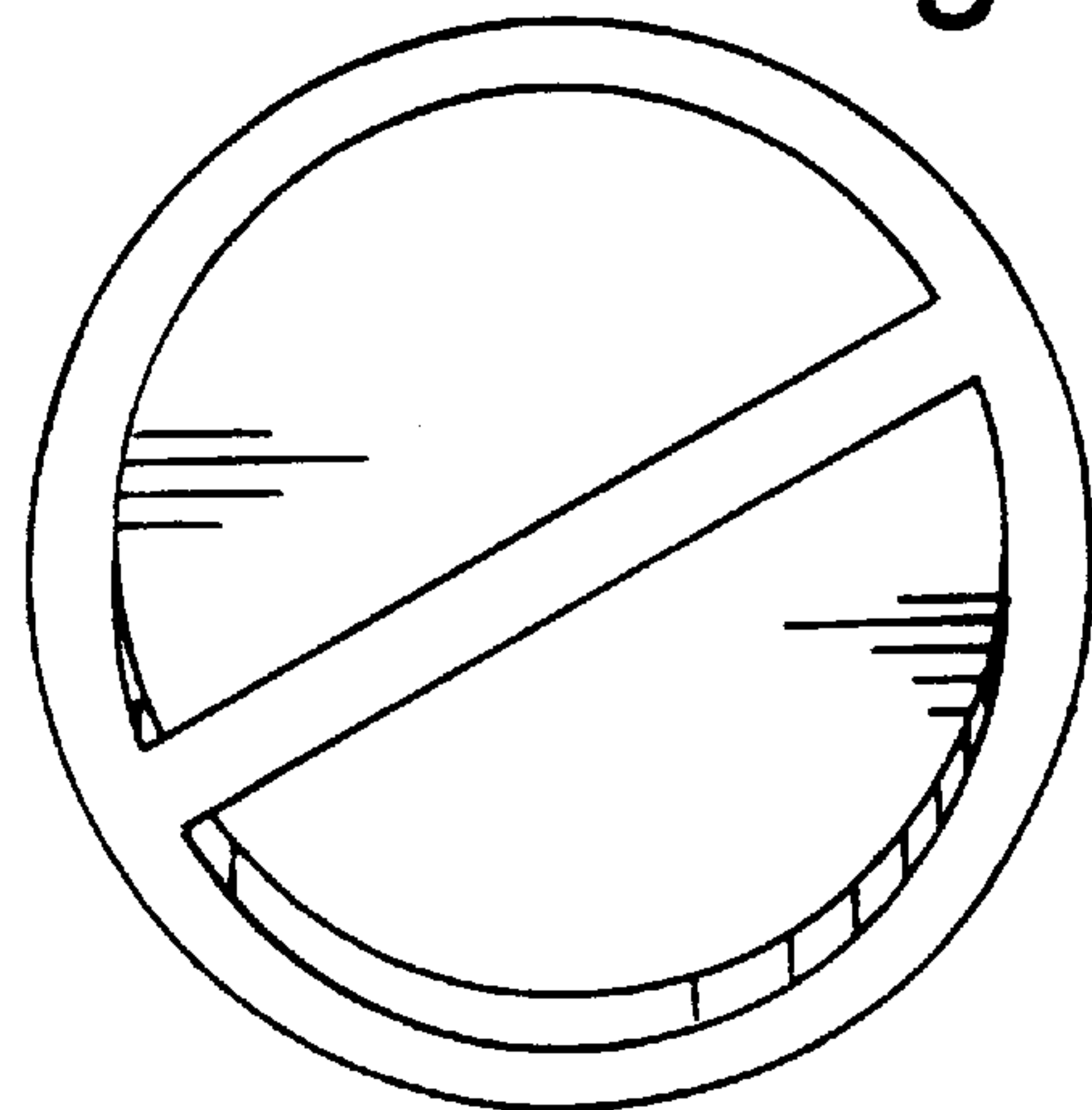

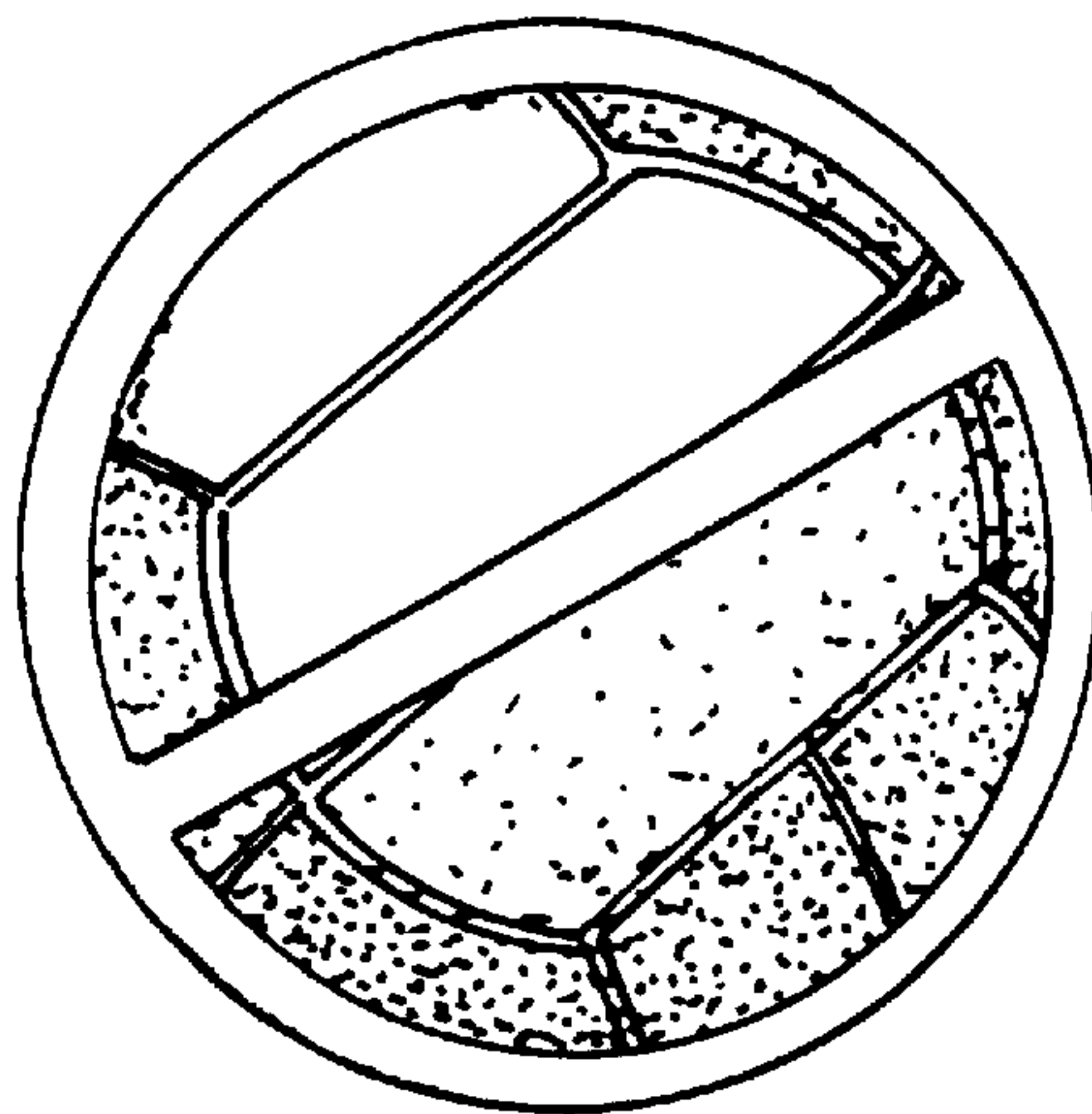

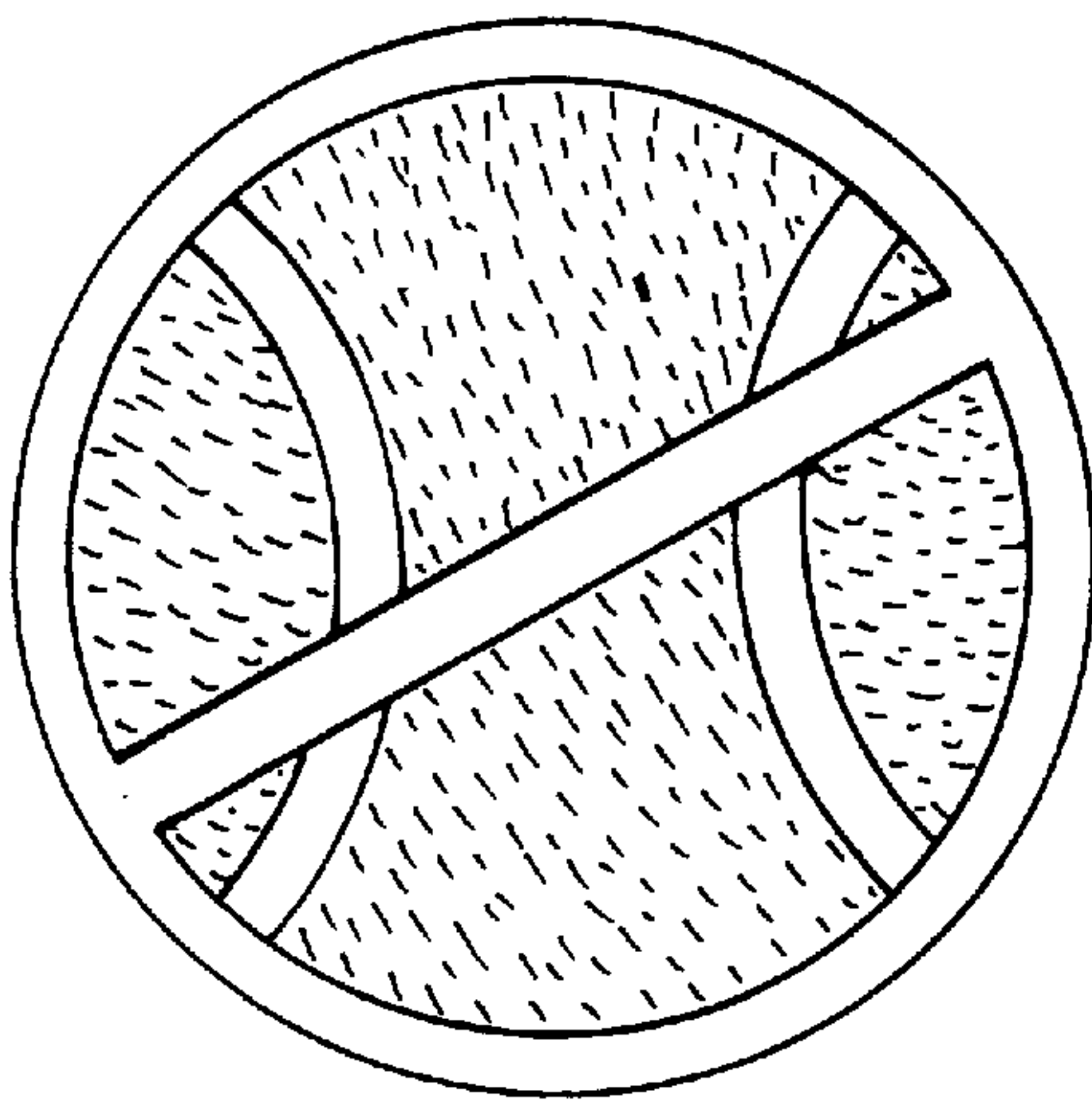

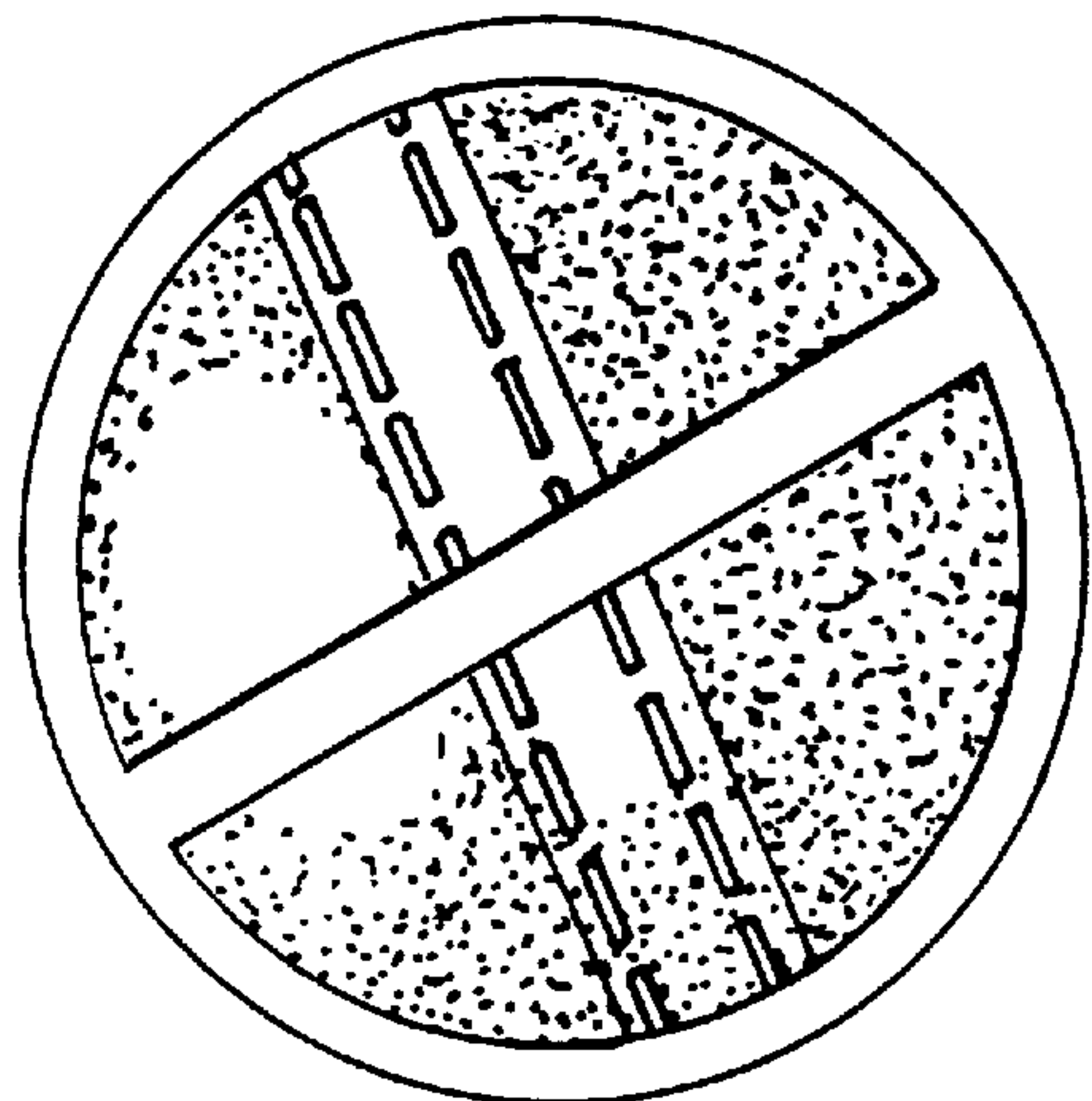

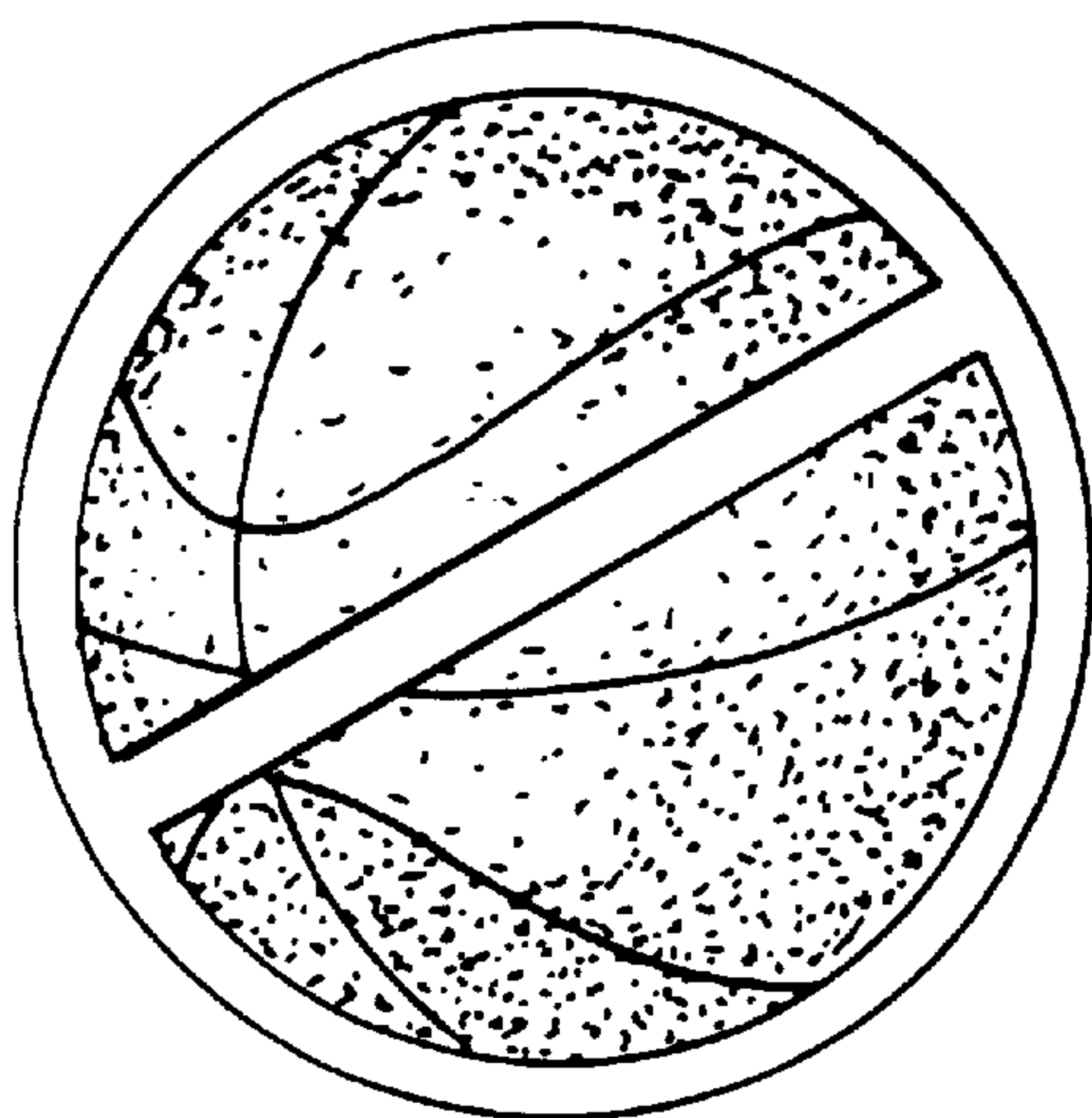

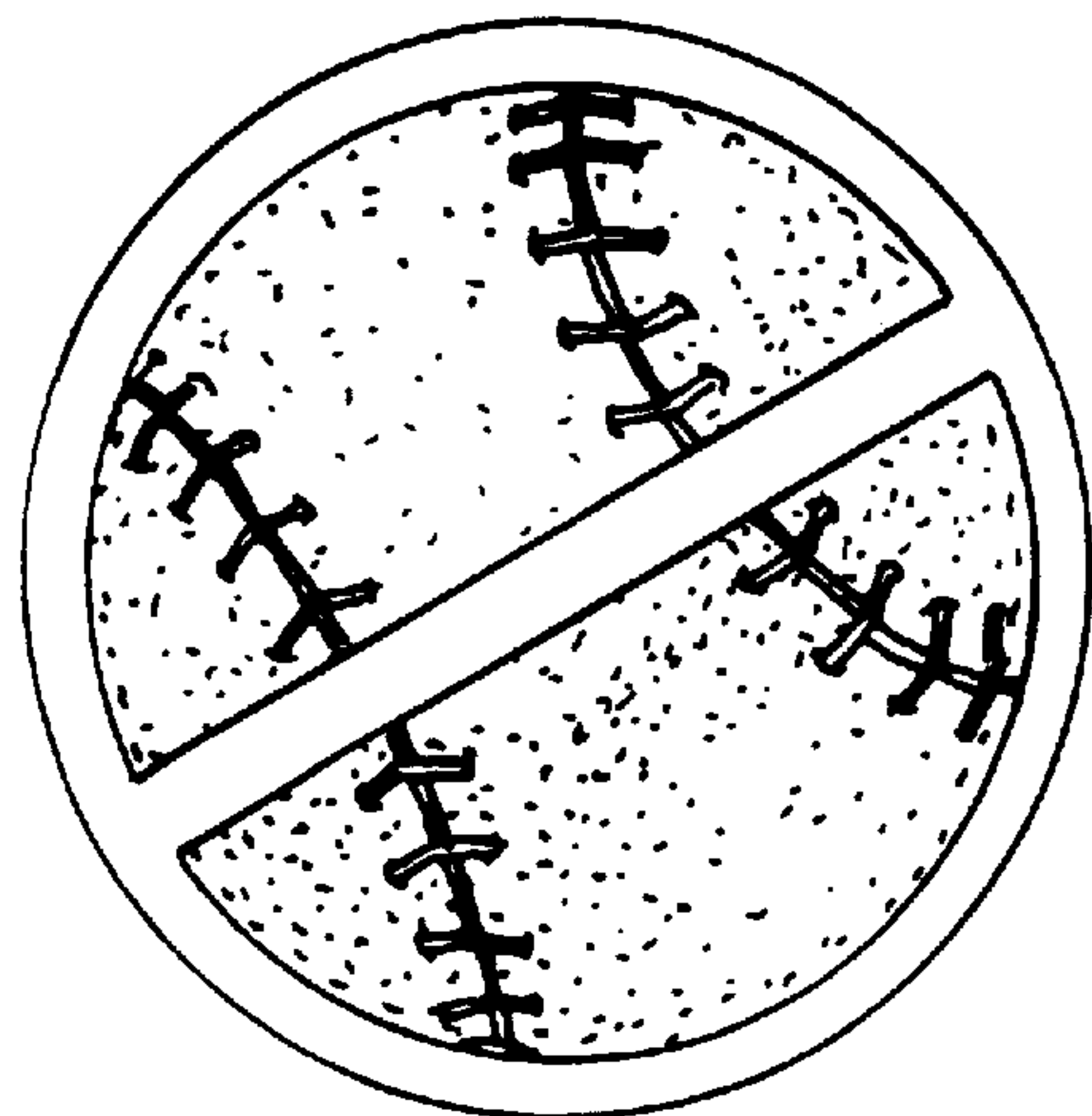
