(57) **CLAIM**

The ornamental design for a spa alcove, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view from the right hand corner of a spa alcove showing the new design, wherein the broken line depiction of the exterior surface is included merely for illustrative purpose and forms no part of the claimed design.

FIG. 2 is a top plan view of the spa alcove.

FIG. 3 is a cross-sectional view of the spa alcove taken along line 3—3 of FIG. 1 and shows contours of the side and bottom interior surfaces; and,

FIG. 4 is a cross-sectional view of the spa alcove taken along lines 4—4 of FIG. 1 and shows contours of the side and bottom interior surfaces.

The exterior surfaces of the spa alcove form no part of the claimed design.

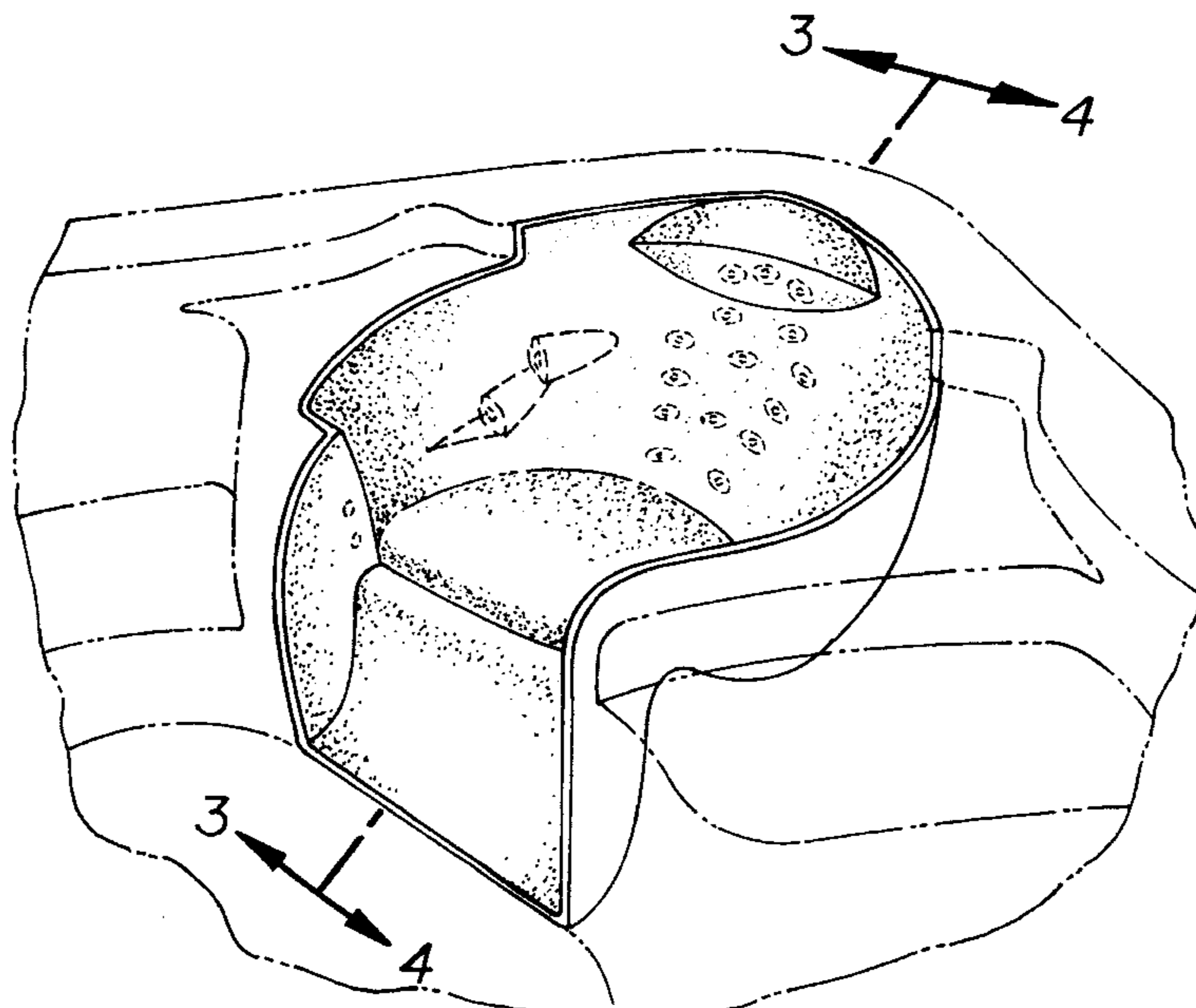

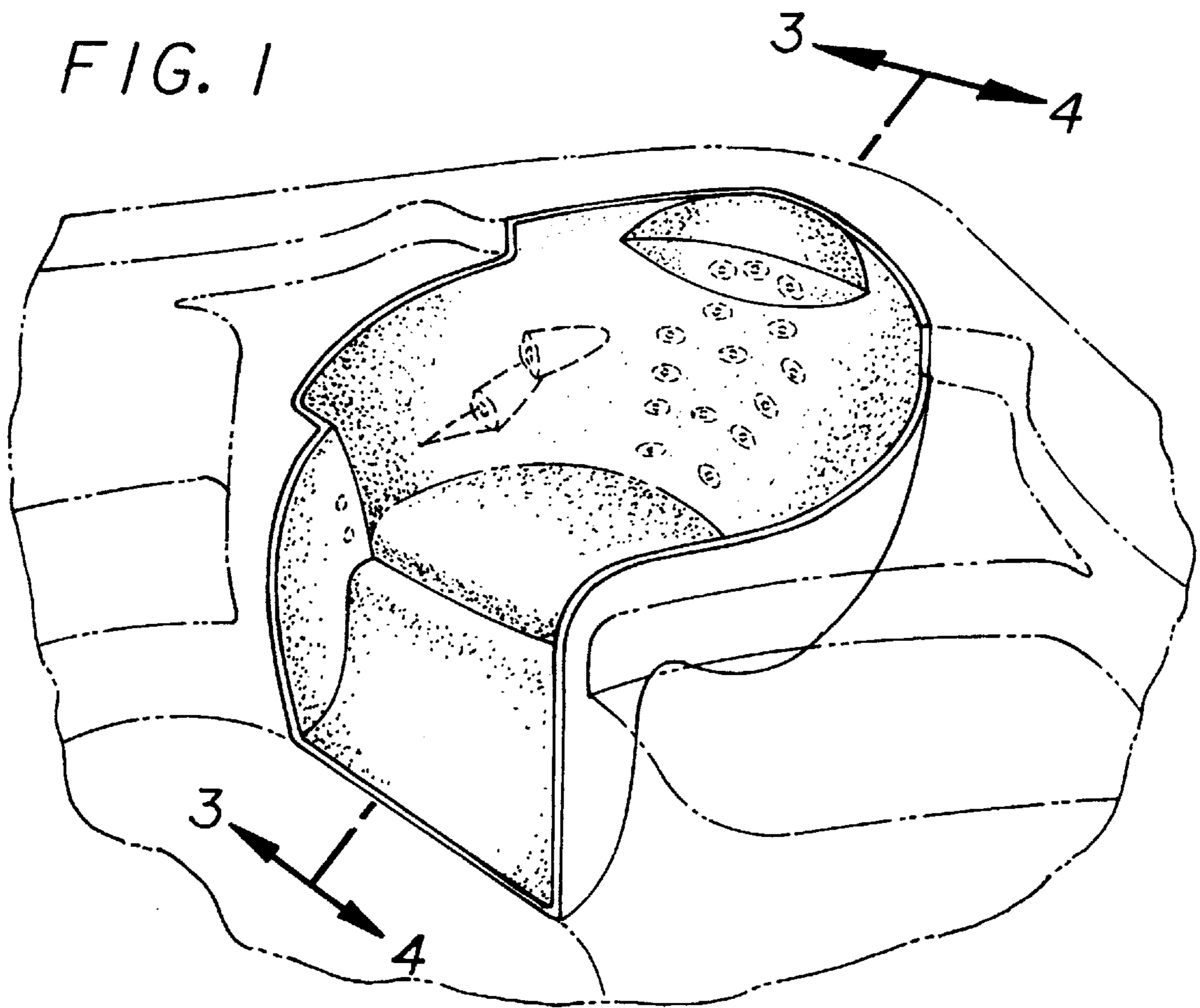

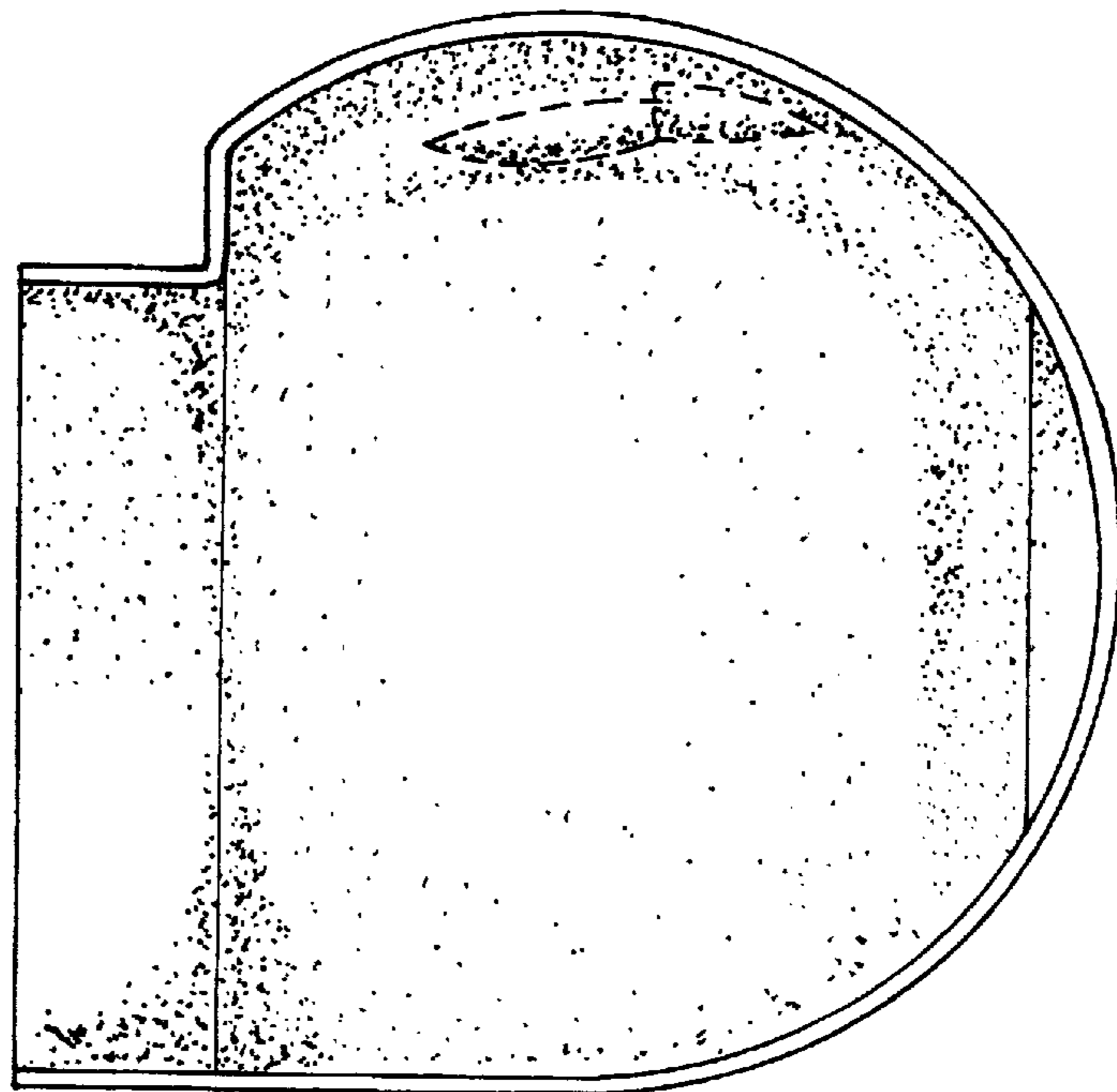

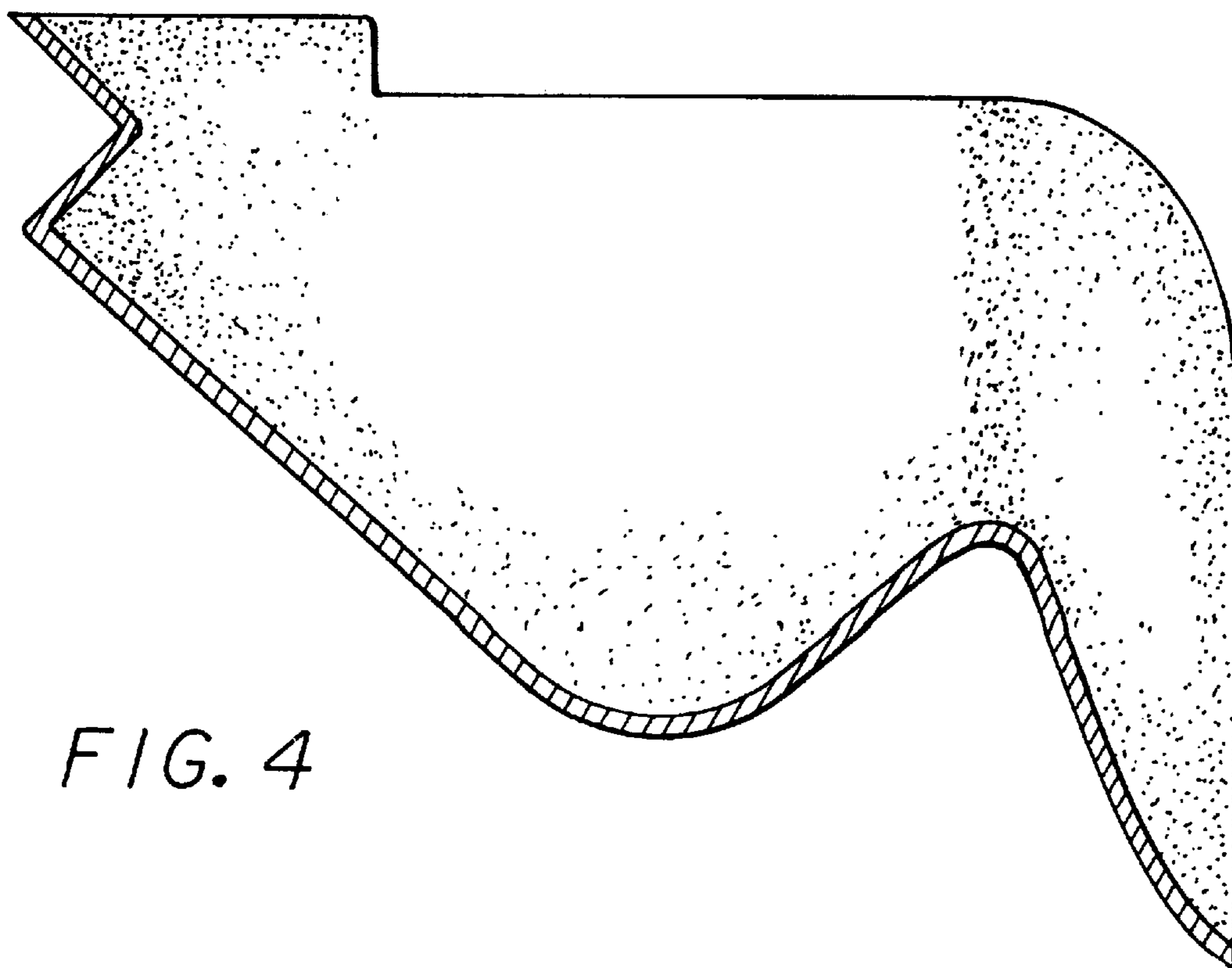
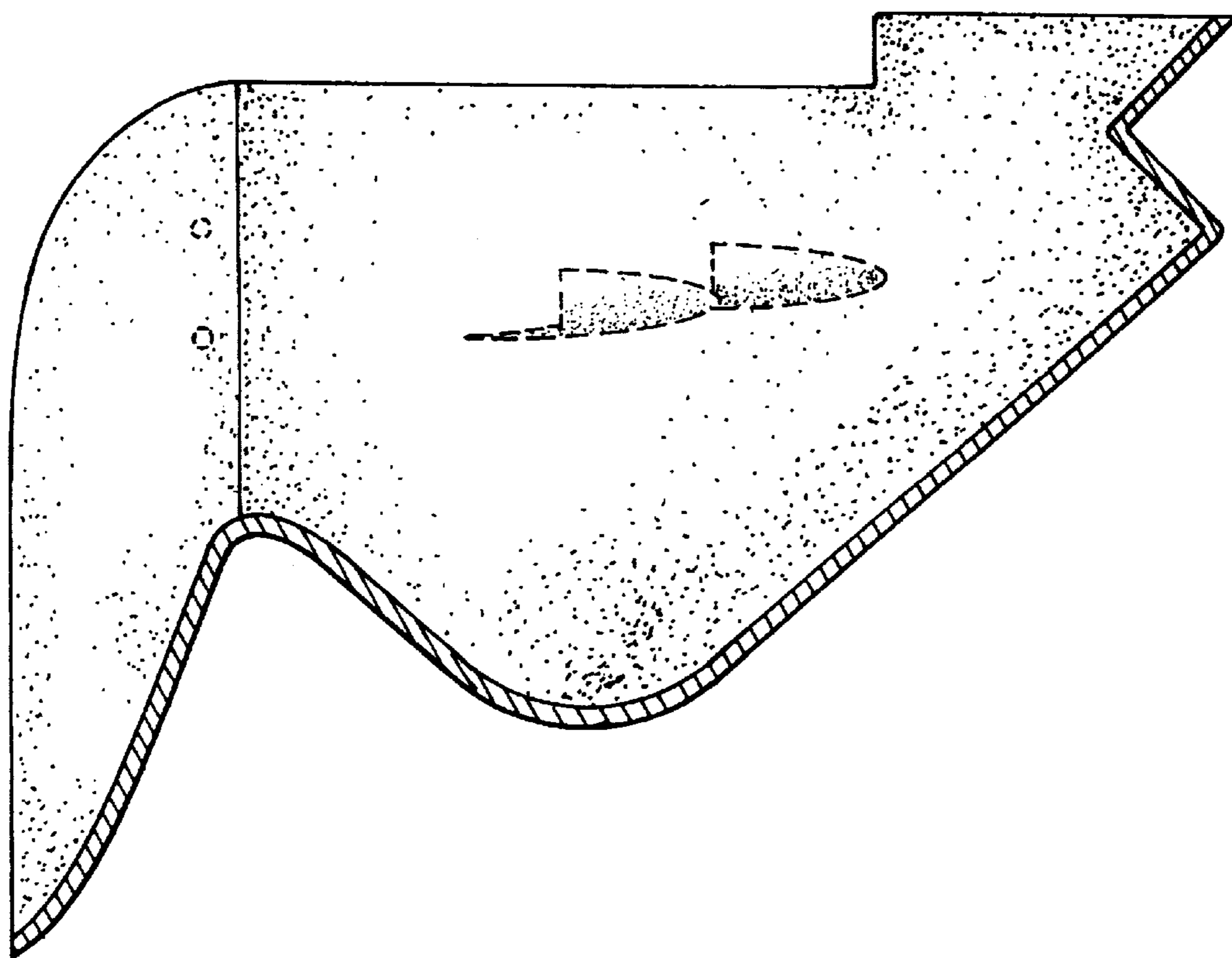
