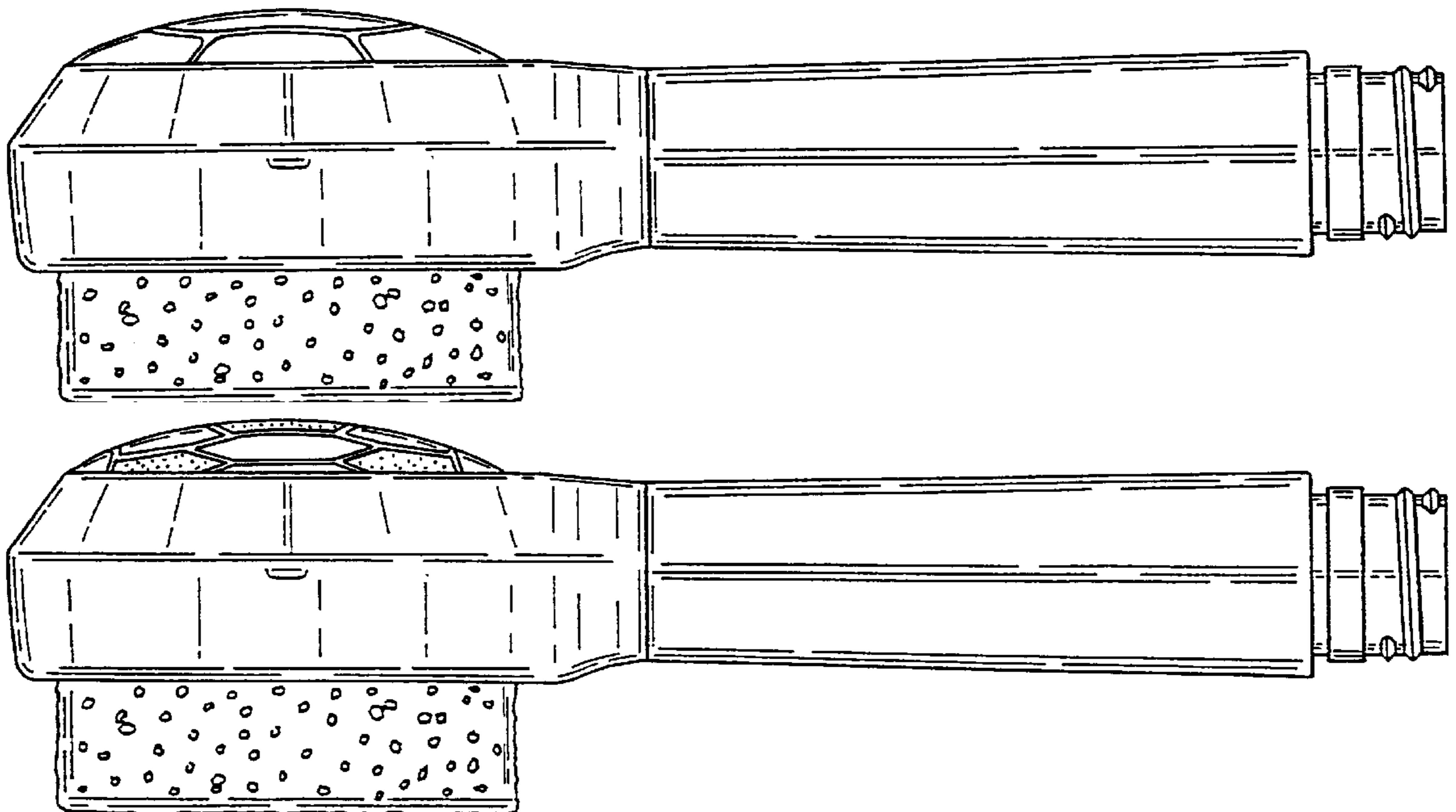
(57) **CLAIM**

The ornamental design for a liquid and lotion applicator, as
shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a liquid and lotion applicator
showing my new design;
FIG. 2 is an end elevational view of the closure cover drawn
separately for ease of illustration;
FIG. 3 is a side elevational view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a top plan view of FIG. 1;
FIG. 6 is a side elevational view of FIG. 1; and,
FIG. 7 is a top plan view of a second embodiment of a liquid
and lotion applicator showing my new design, the only
difference being the soccer ball design; and,
FIG. 8 is a side elevational view thereof.

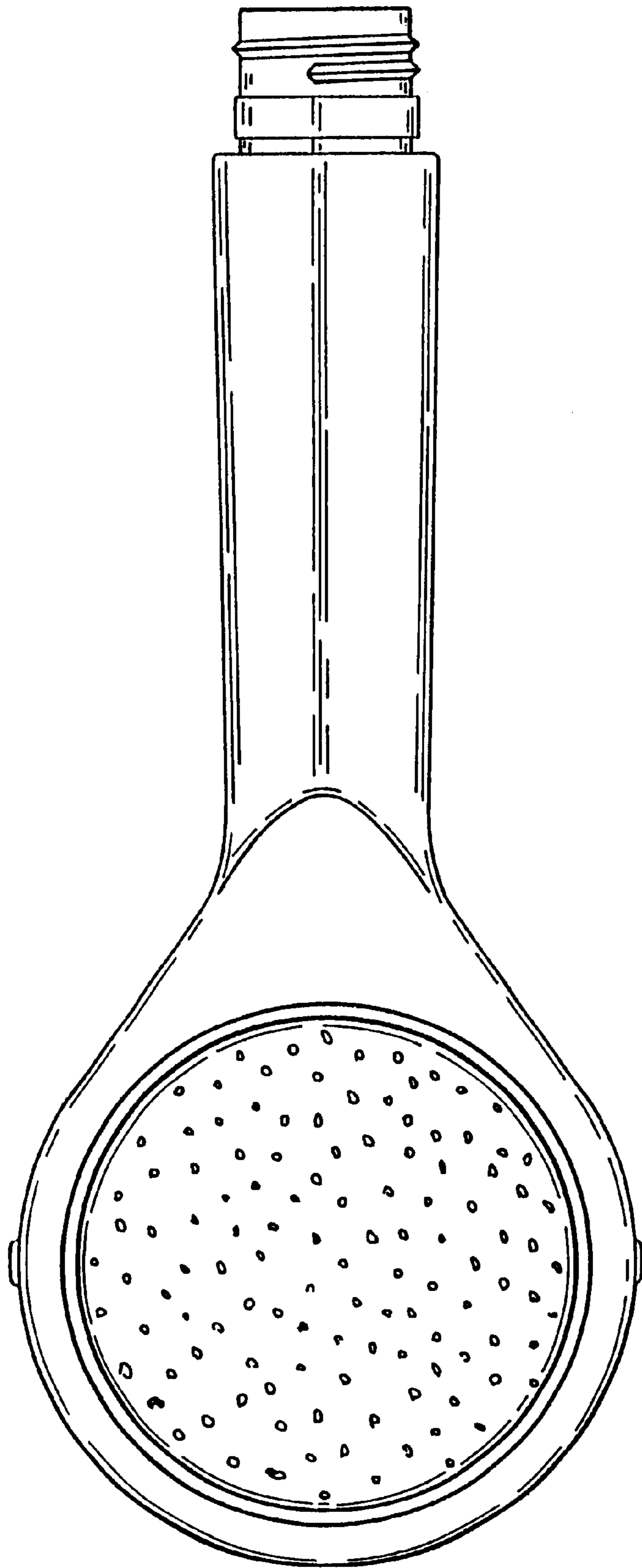

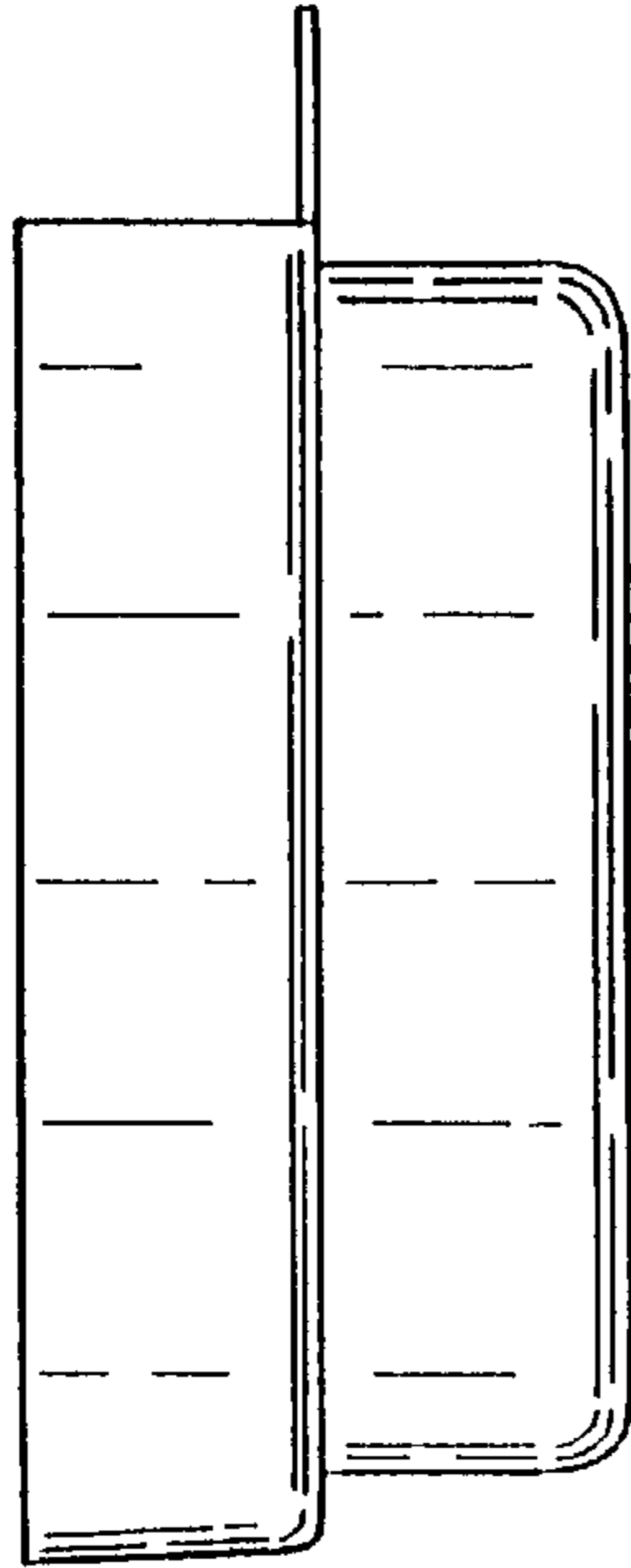

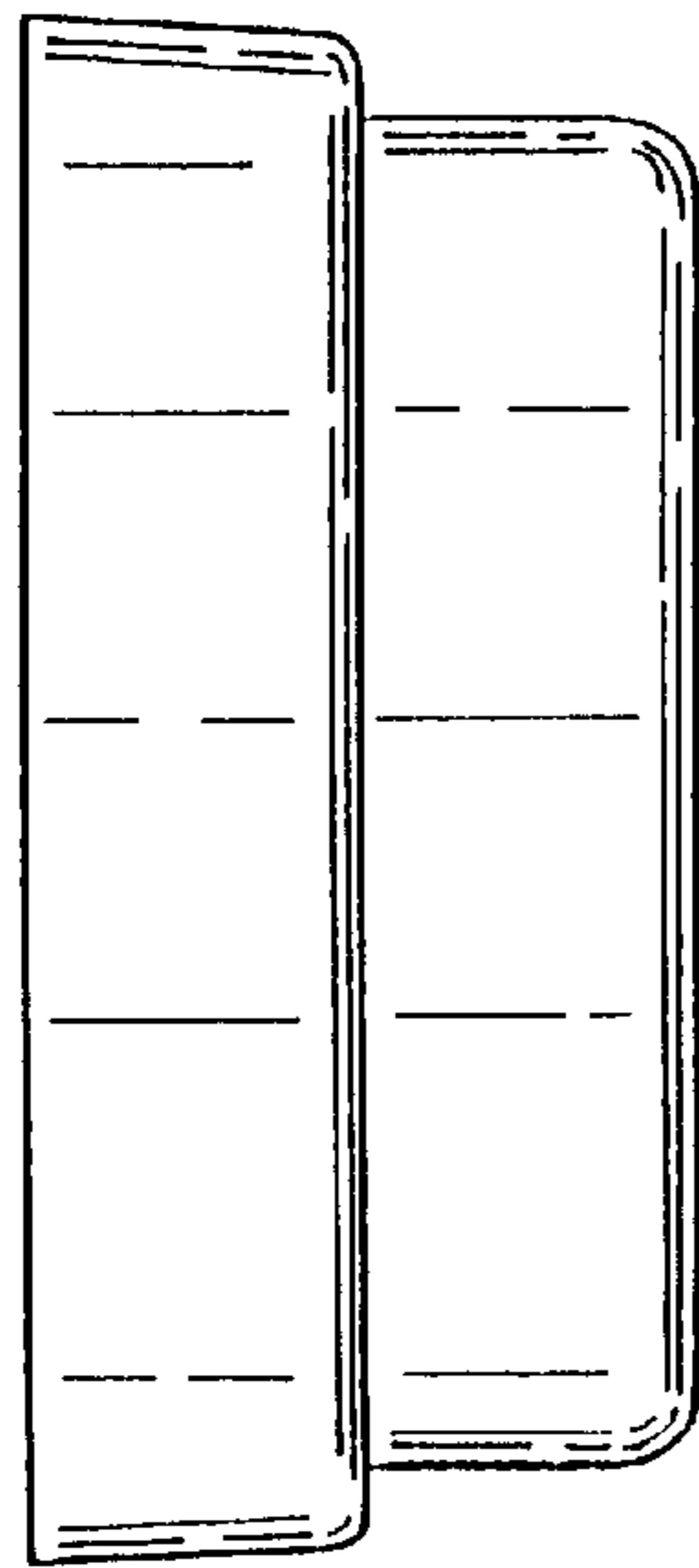

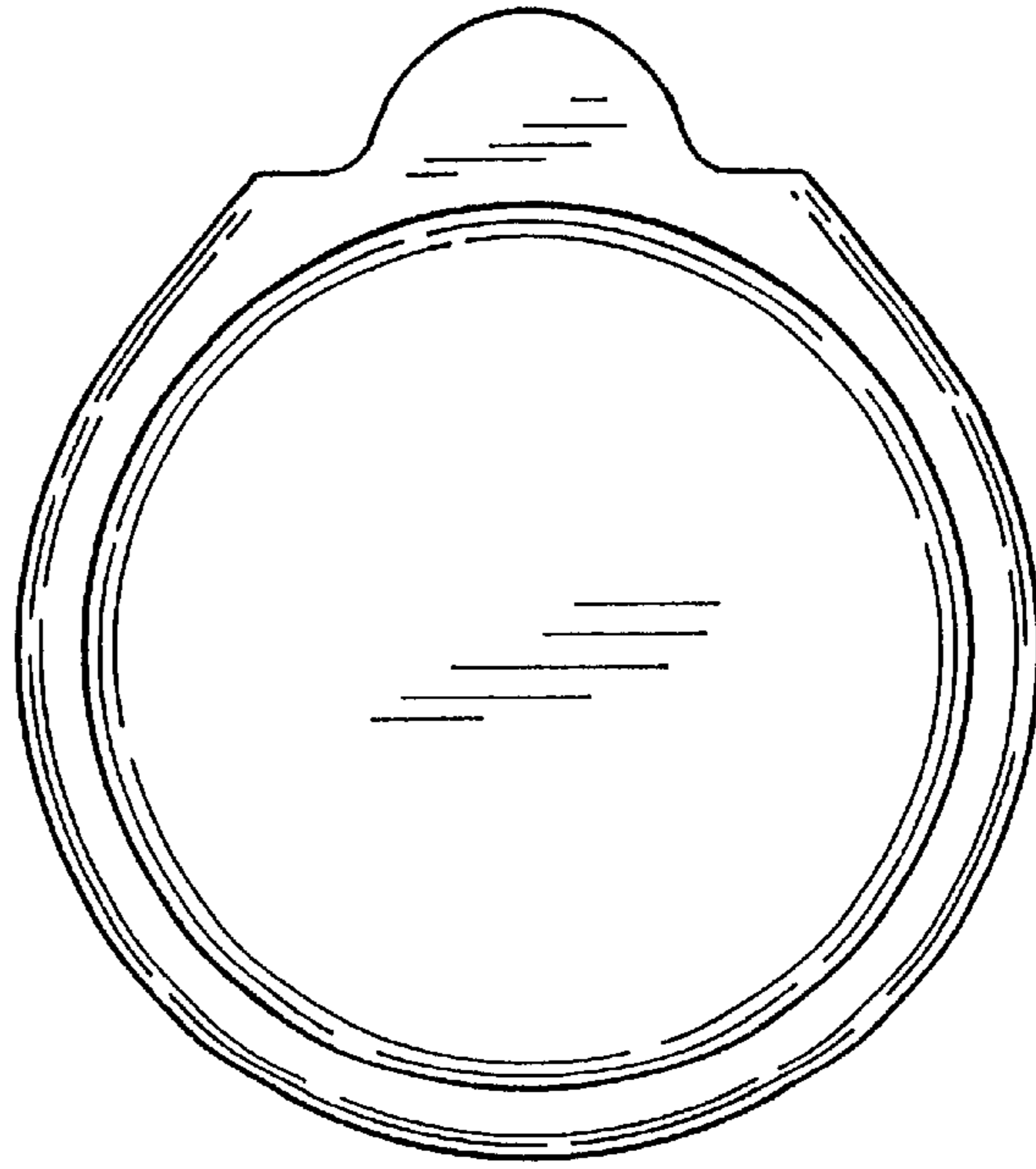

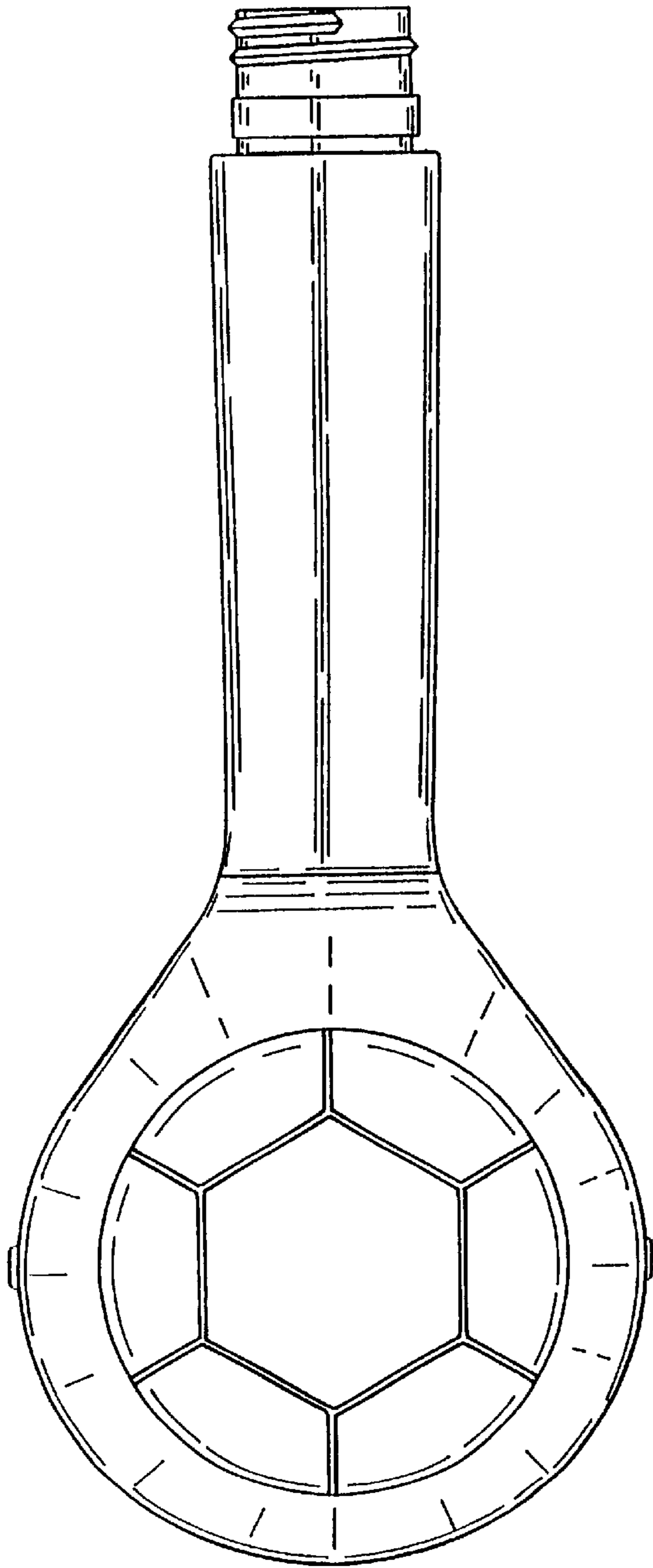

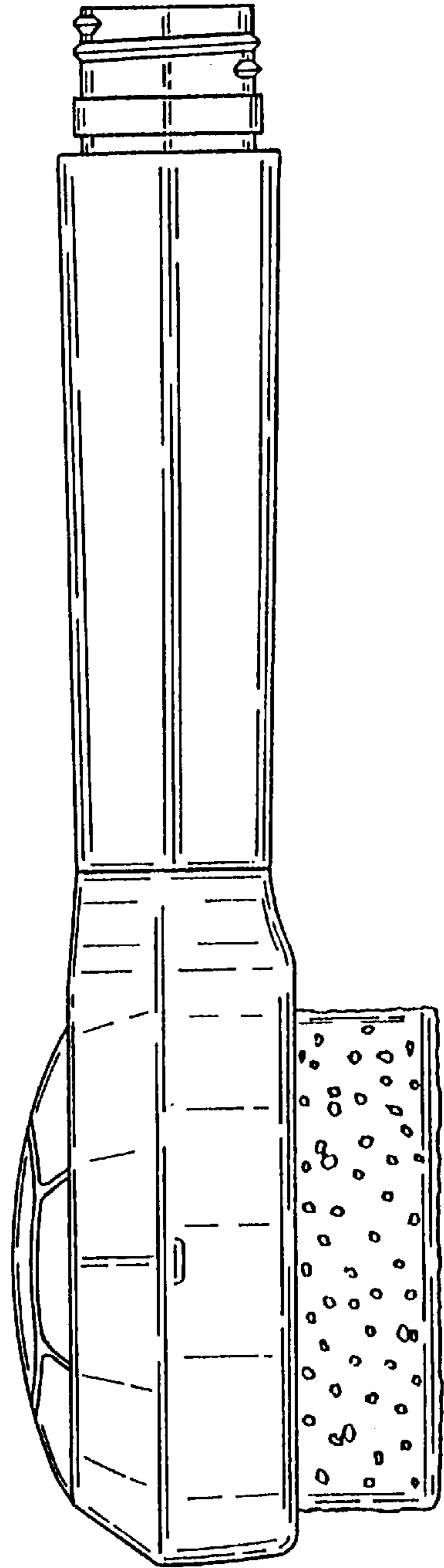

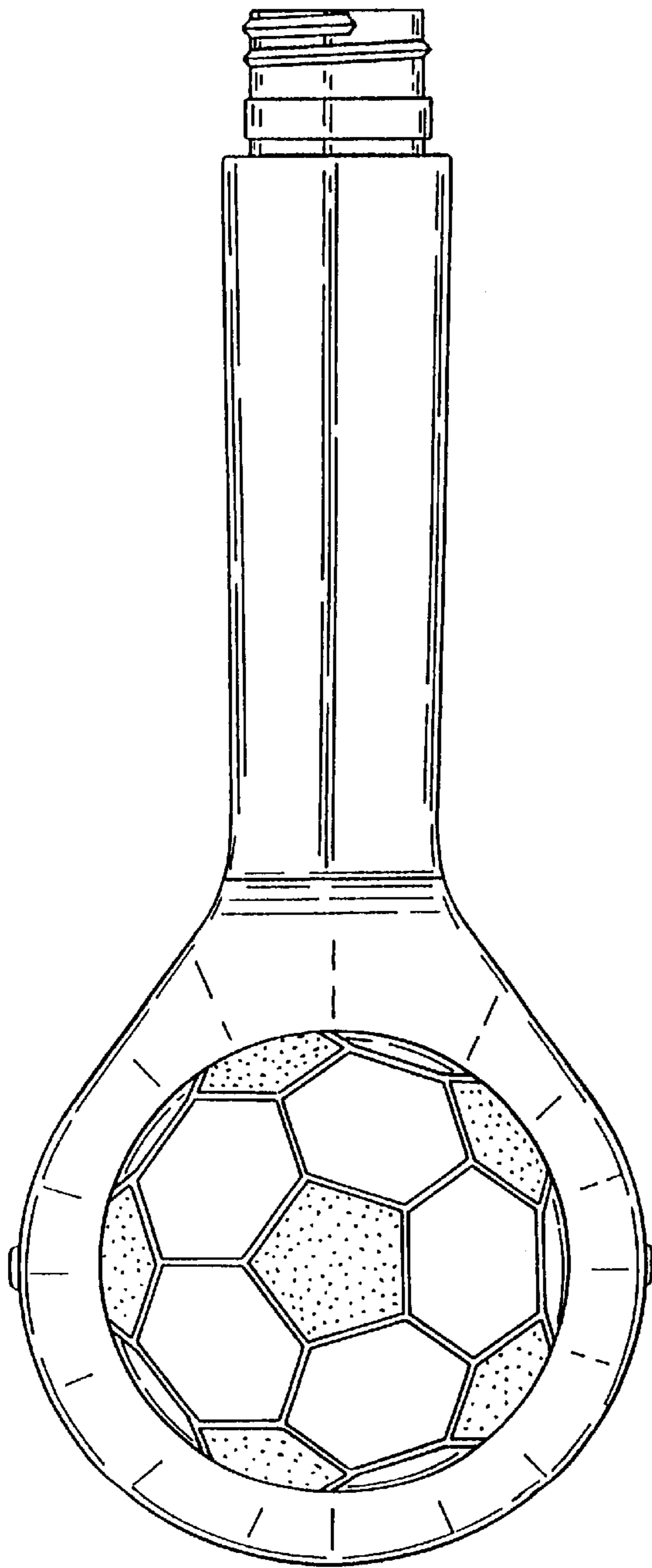

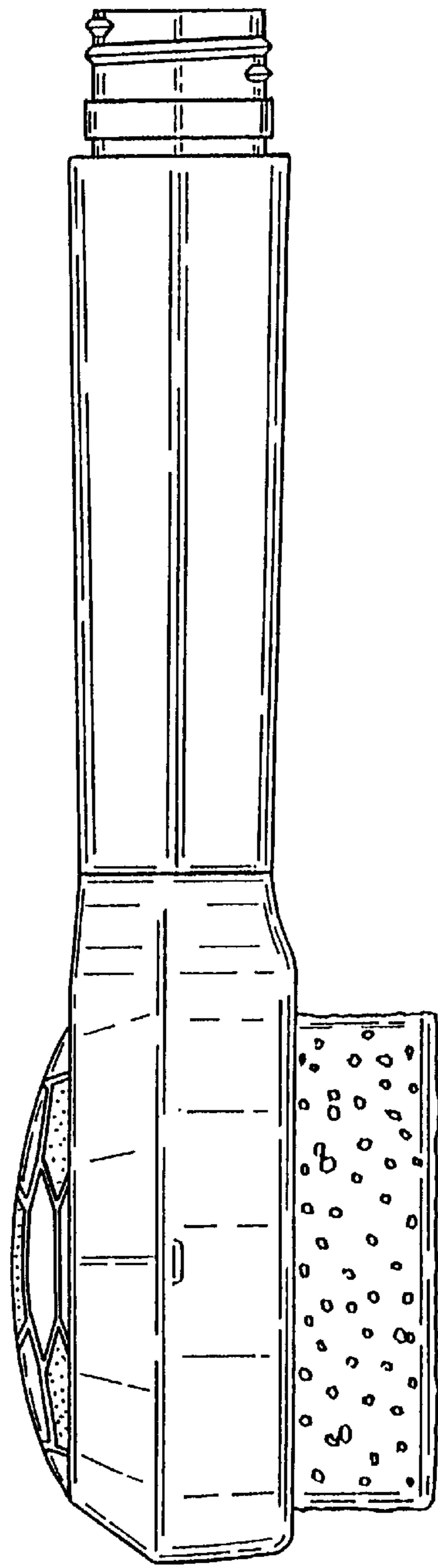
