(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole showing my new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a front elevational view thereof;

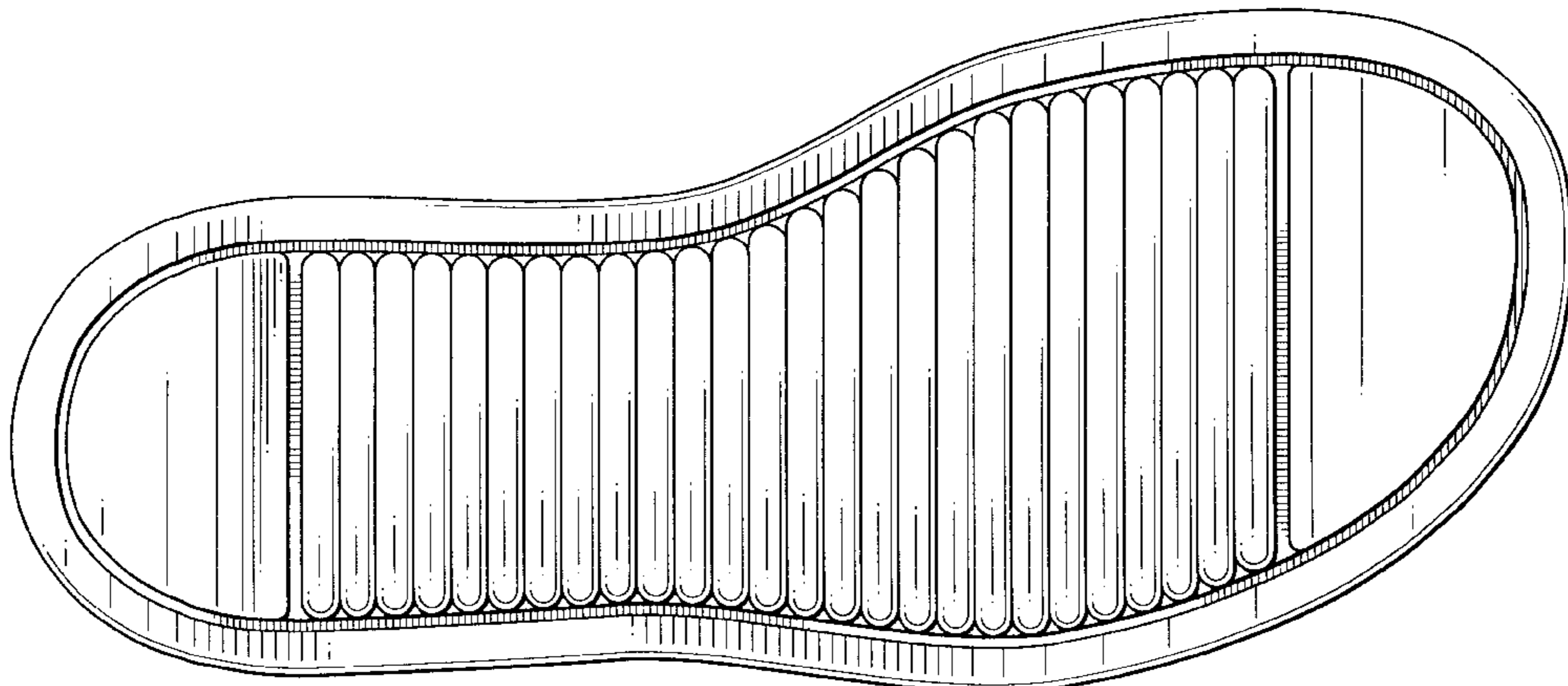
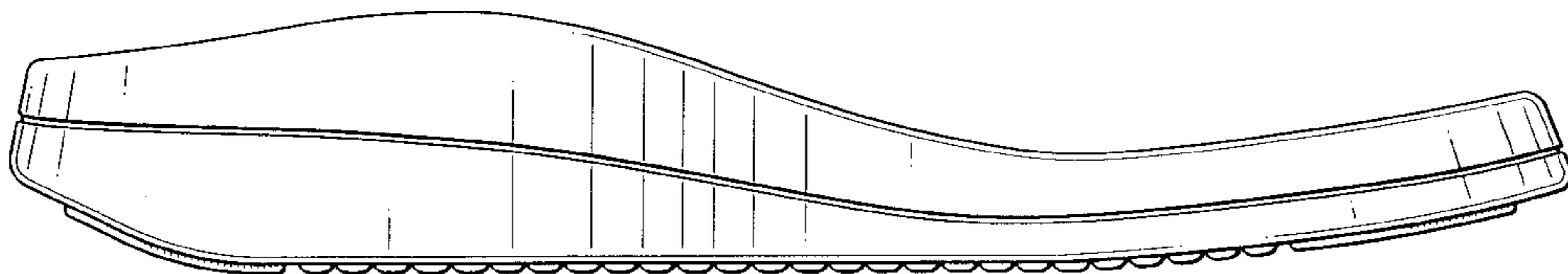
FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a top plan view thereof.

FIG. 4 shows additional broken lines for the purpose of illustrating the portion of the shoe sole that forms no part of the claimed design.

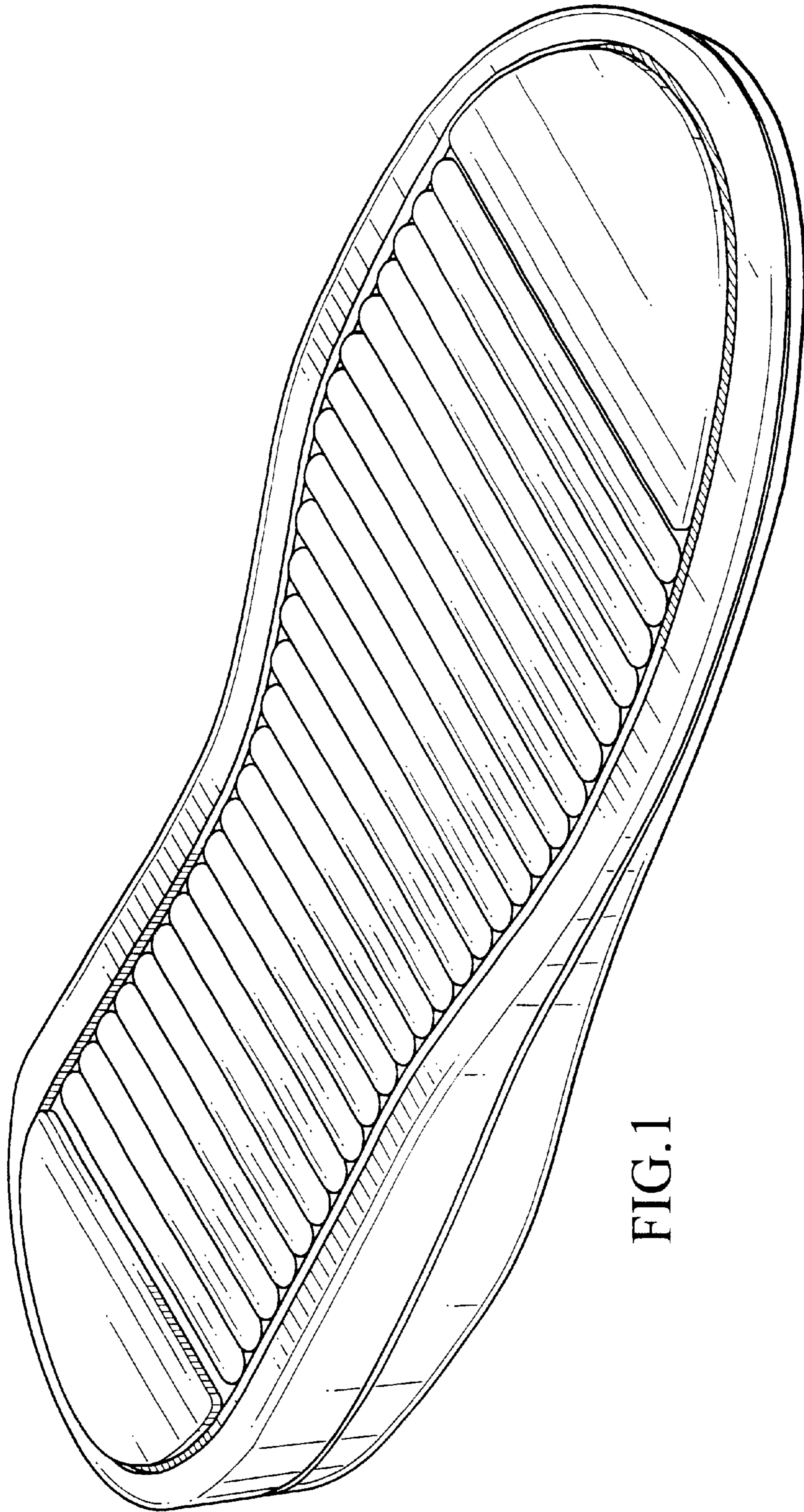

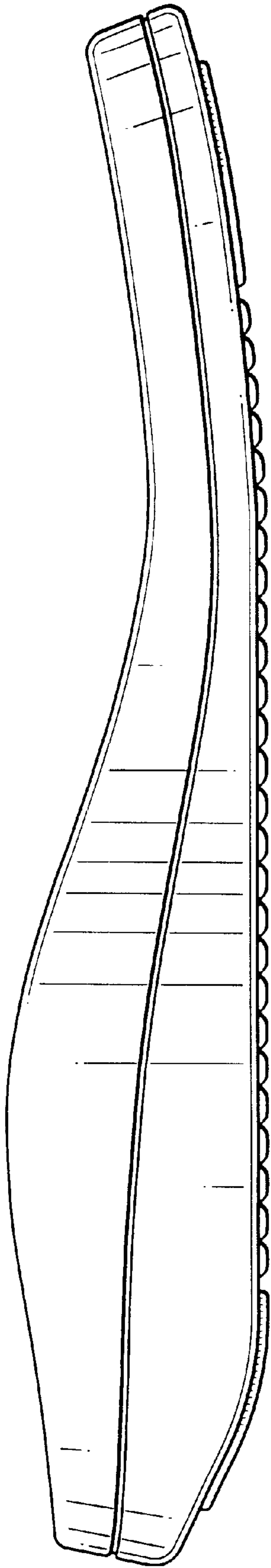

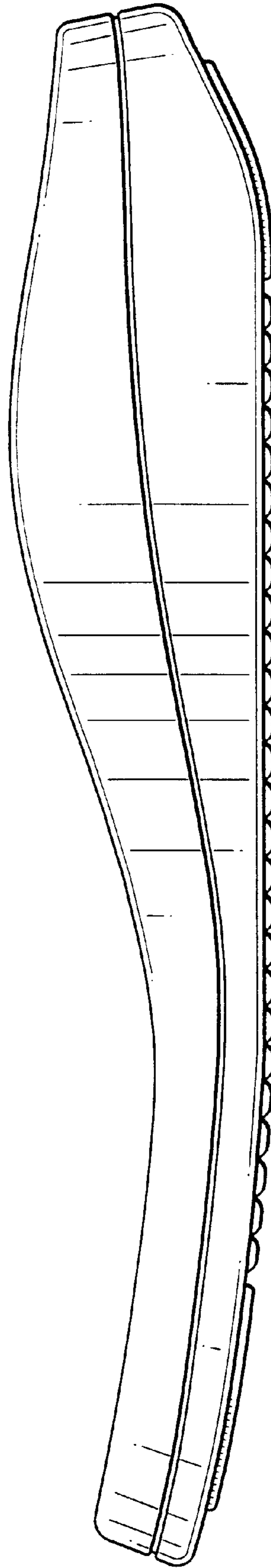

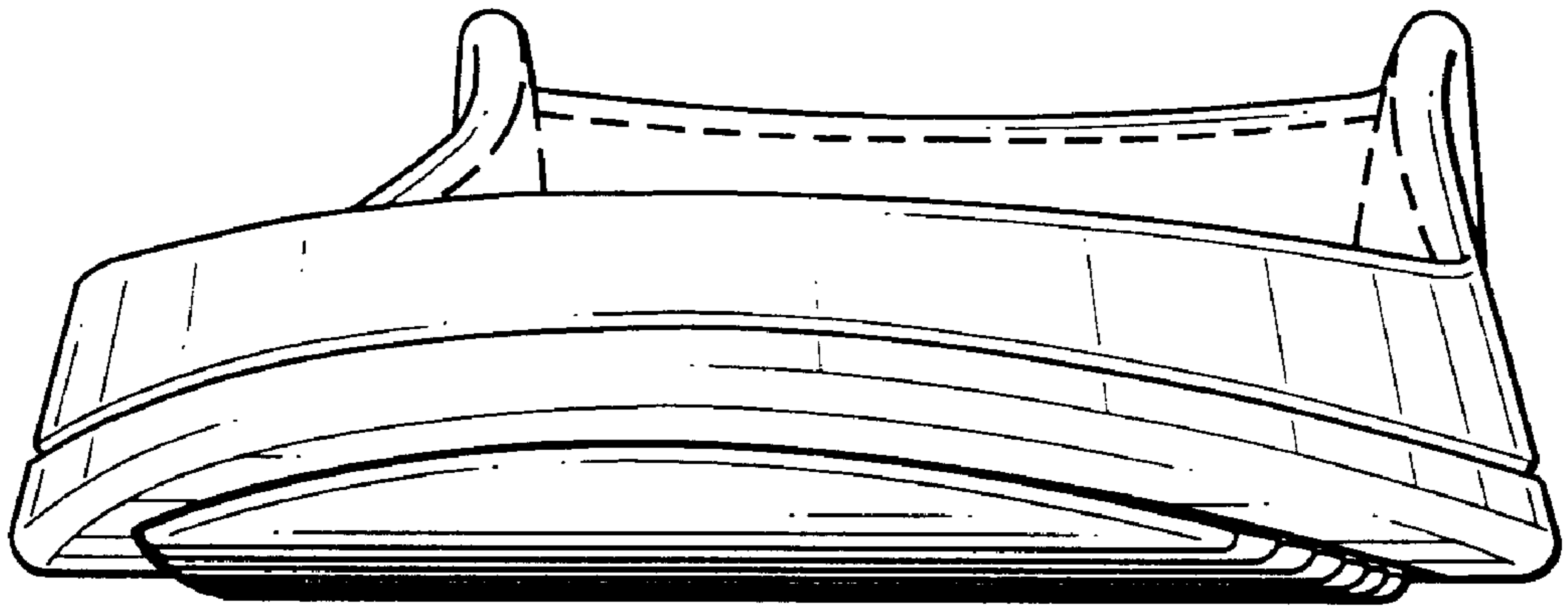

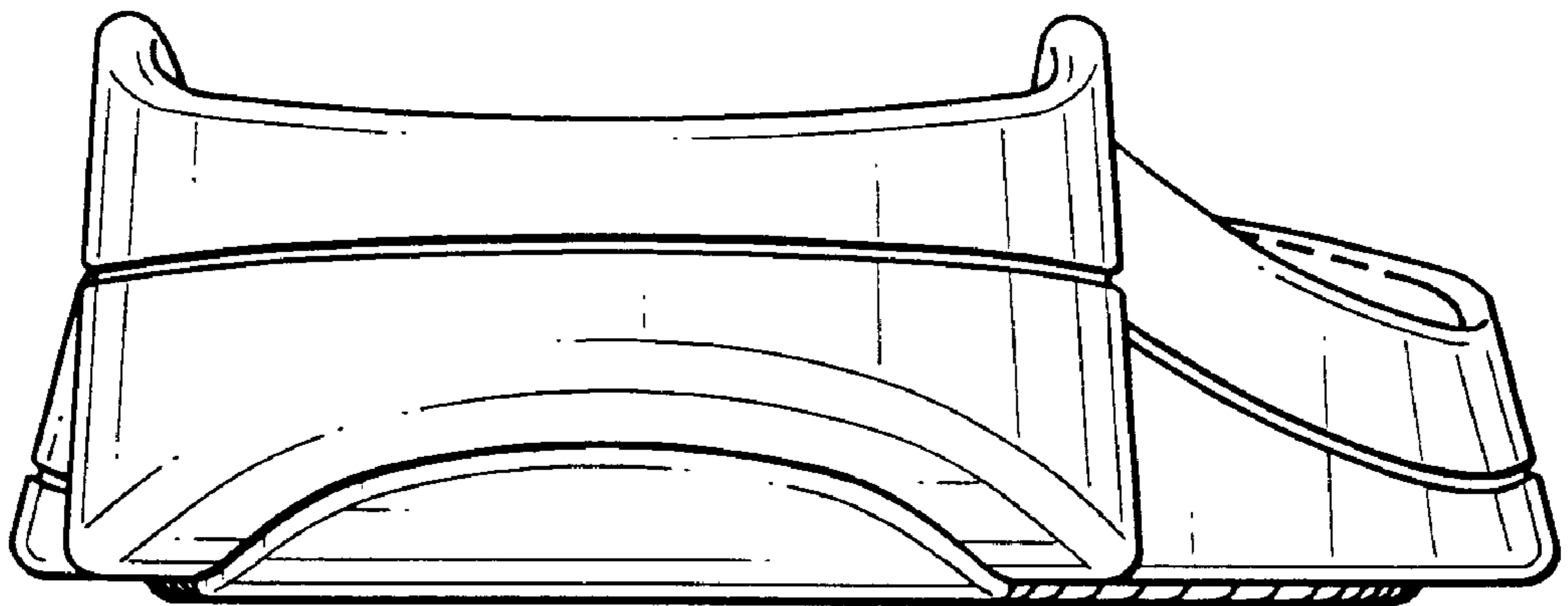

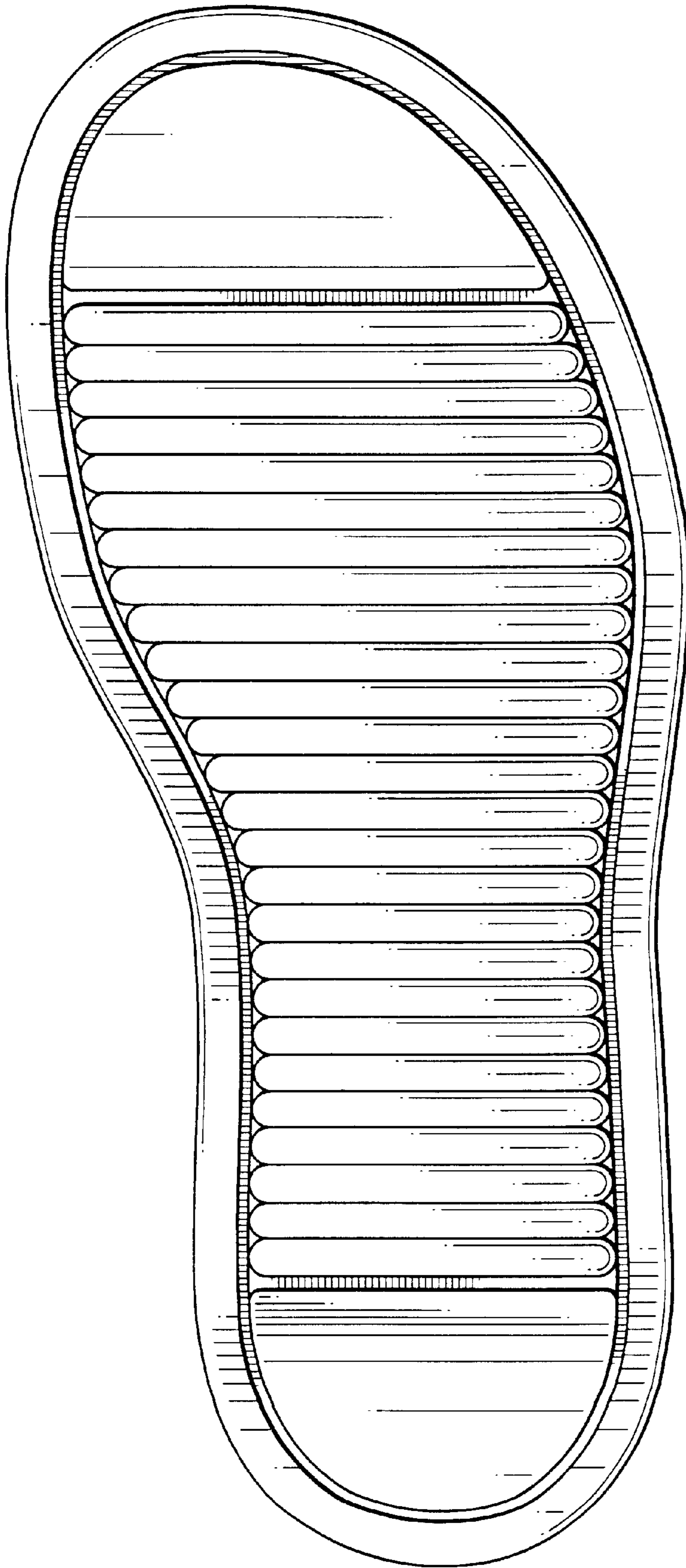

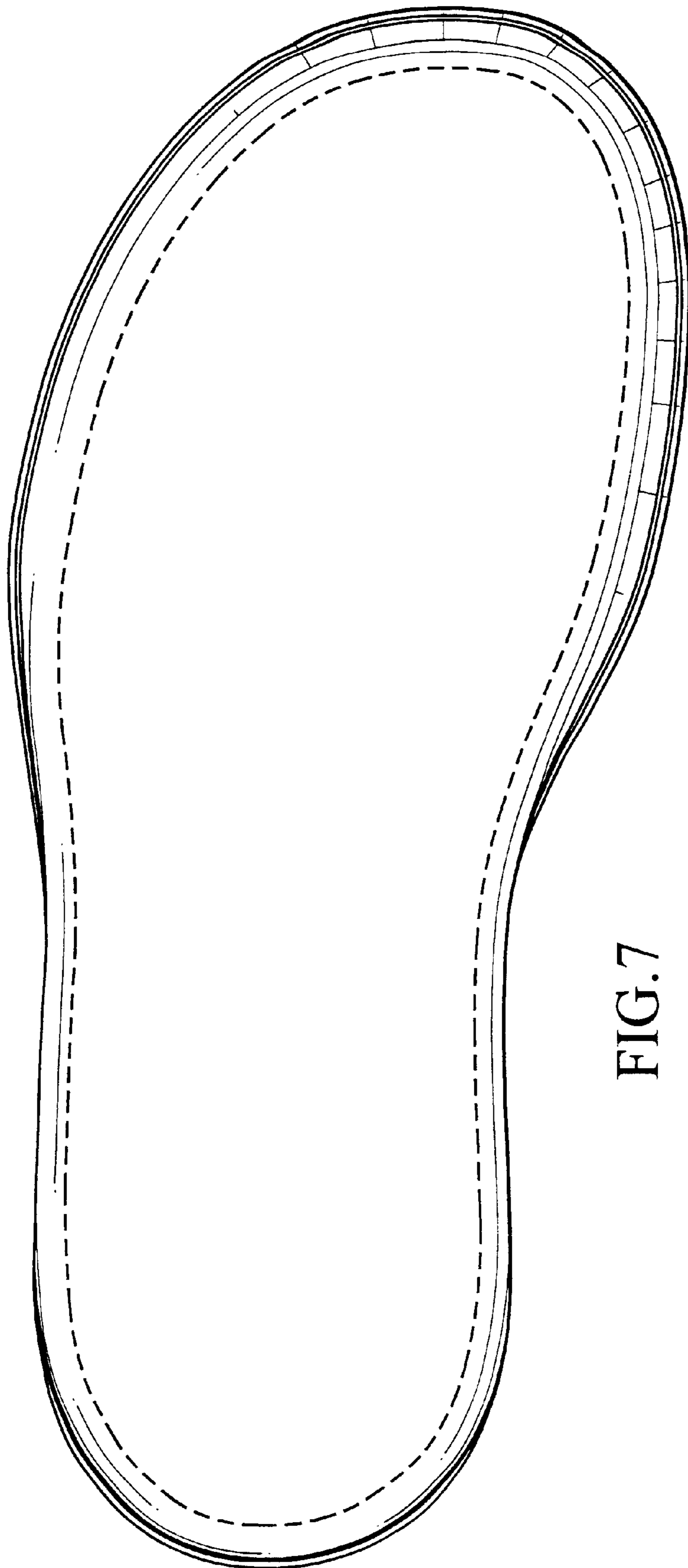
