The ornamental design for a container for tool bits, as shown and described.

DESCRIPTION

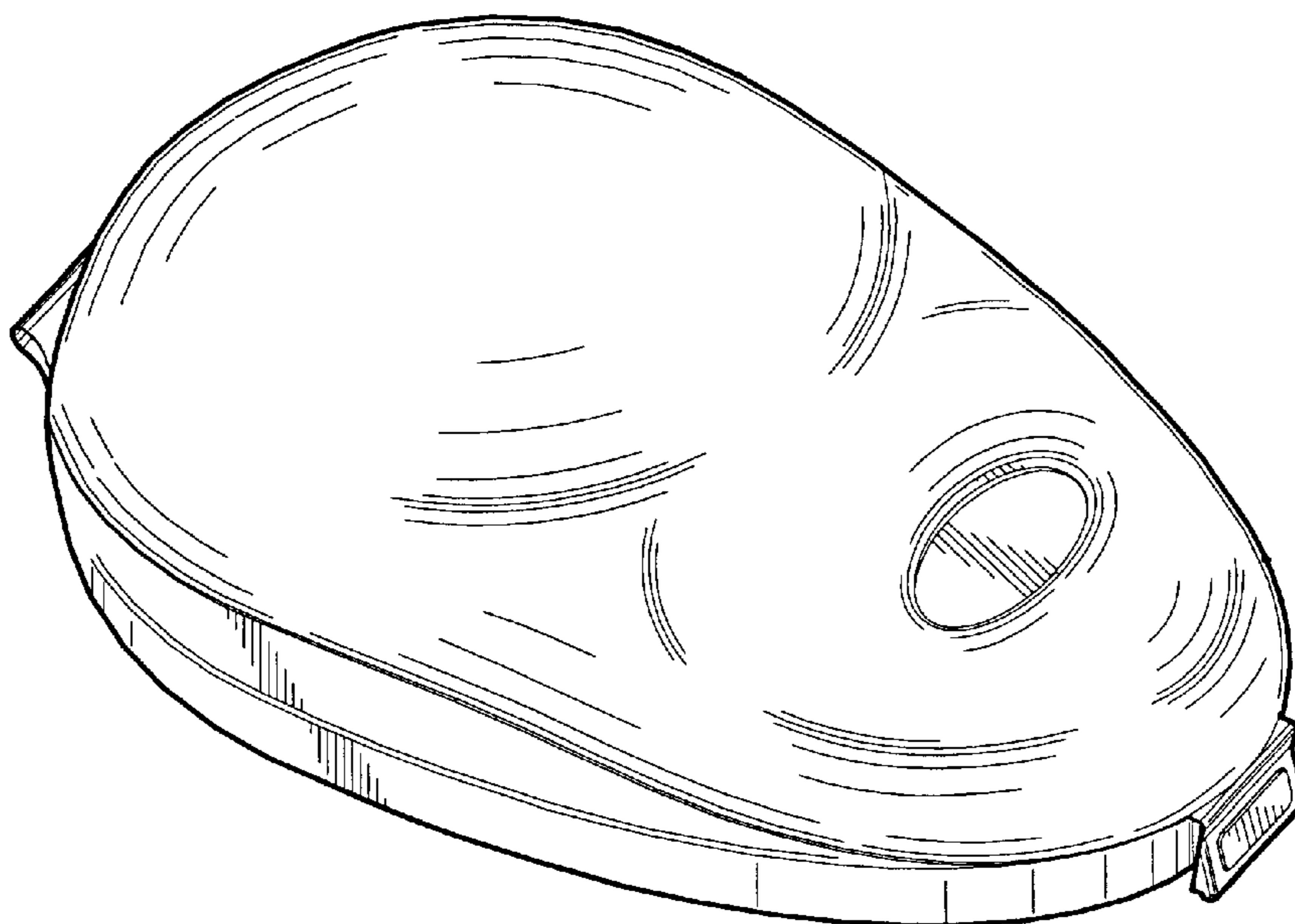
FIG. 1 is a front perspective view of a container for tool bits shown in the closed position;
 FIG. 2 is a top view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a left side view thereof (the right side is a mirror image of the left side);
 FIG. 5 is a rear view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a left side view of a container in an open position; and,
 FIG. 8 is an open view of the inside of the container (the broken lines showing bits and compartments for receiving bits is for illustrative purposes only and forms no part of the claim).

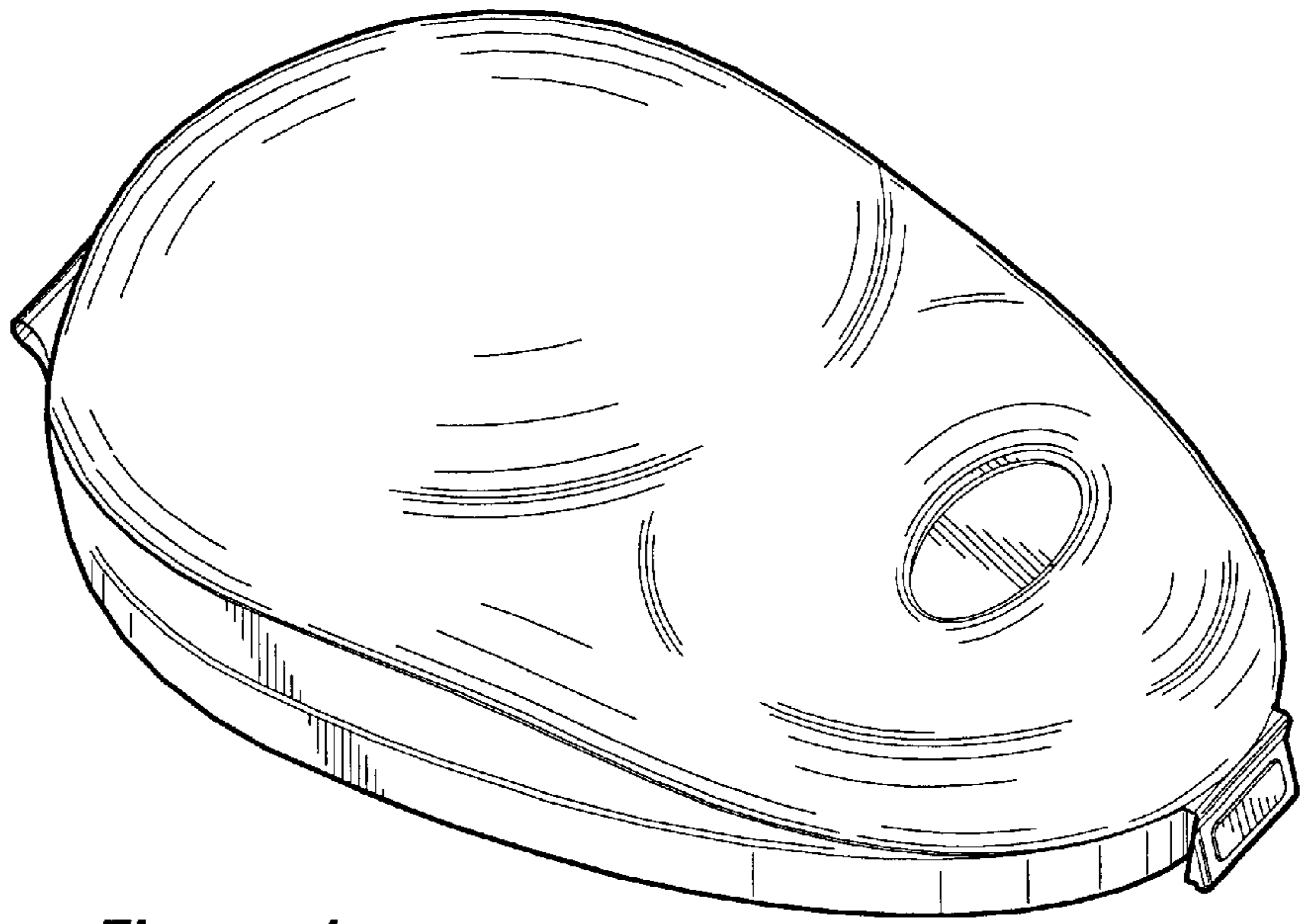

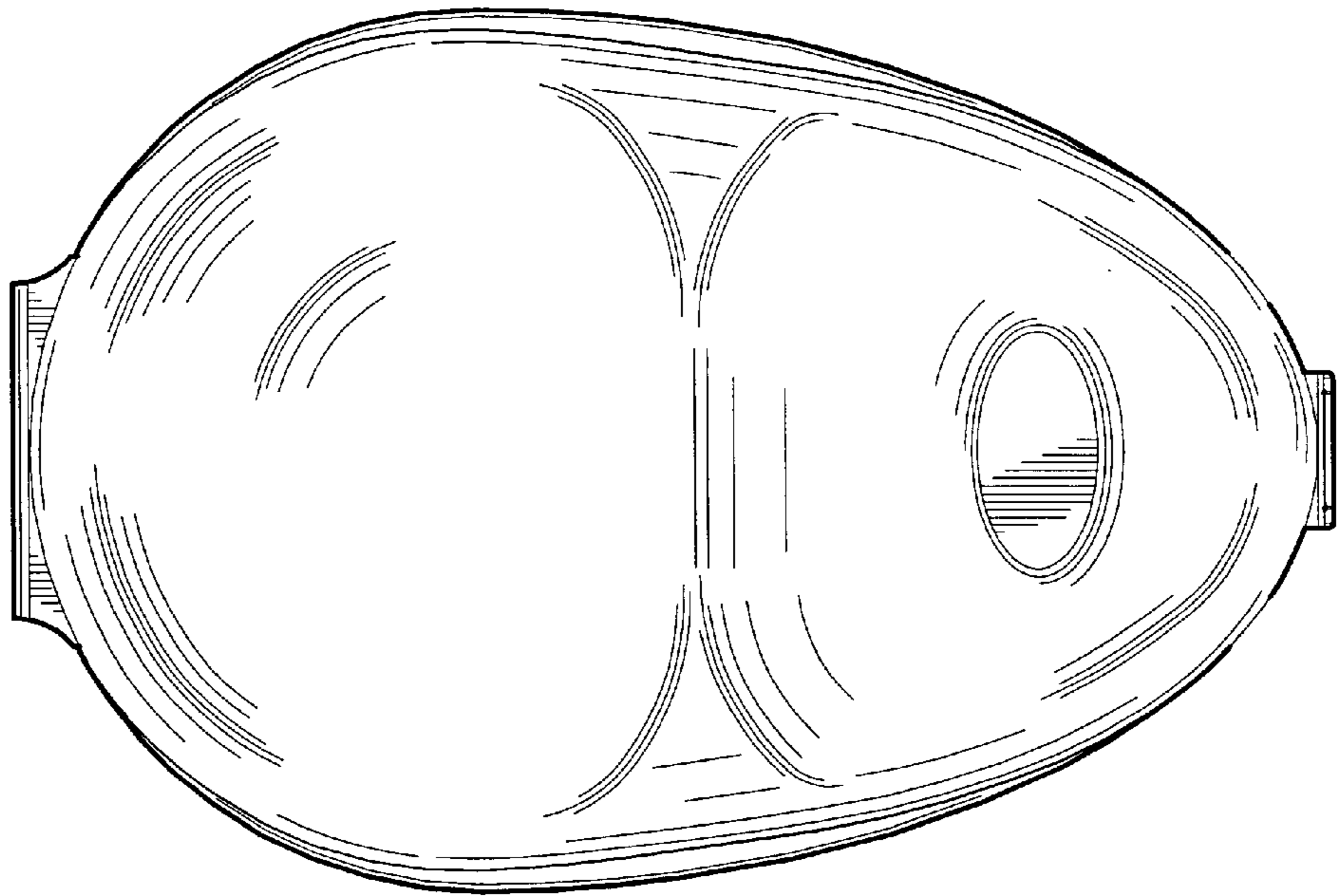

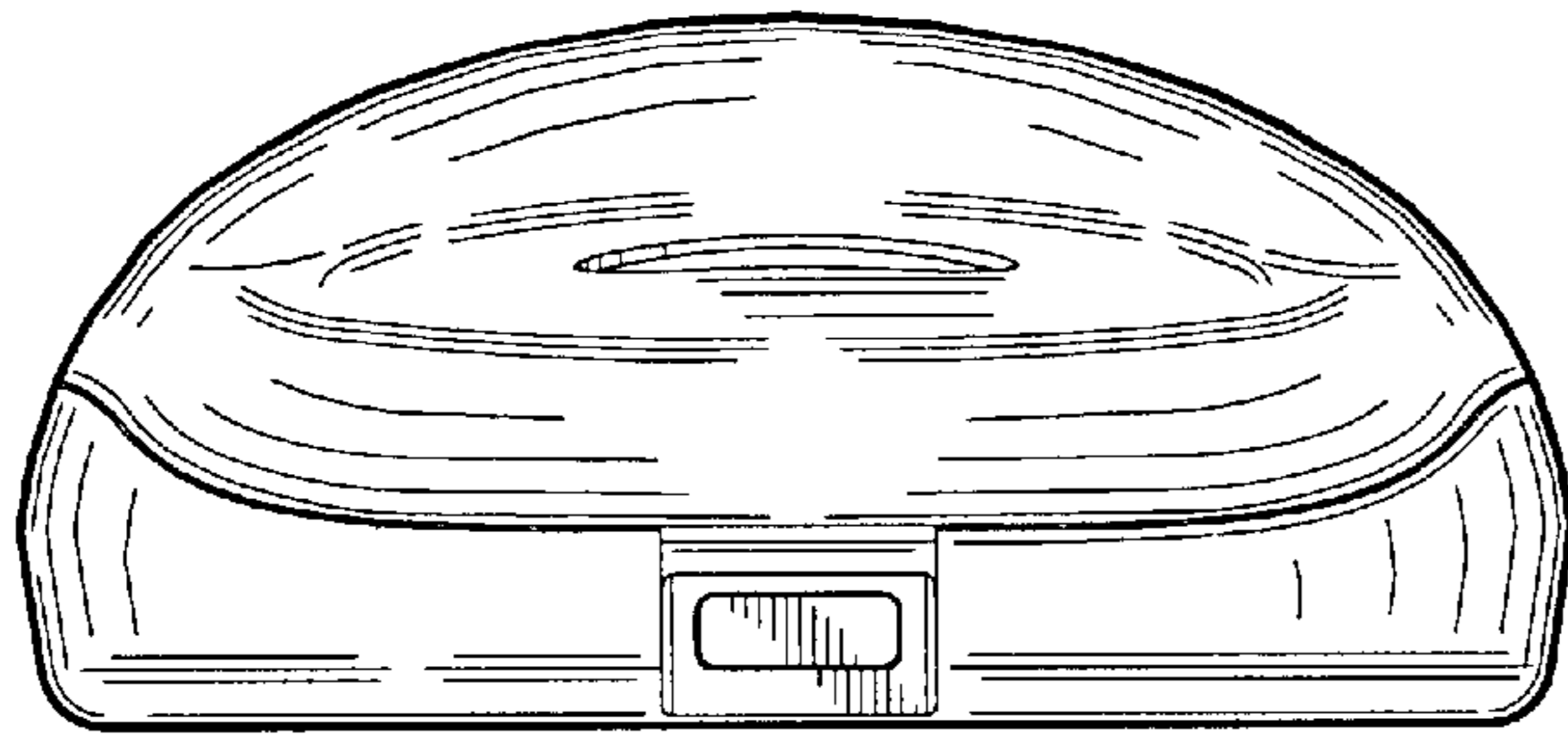

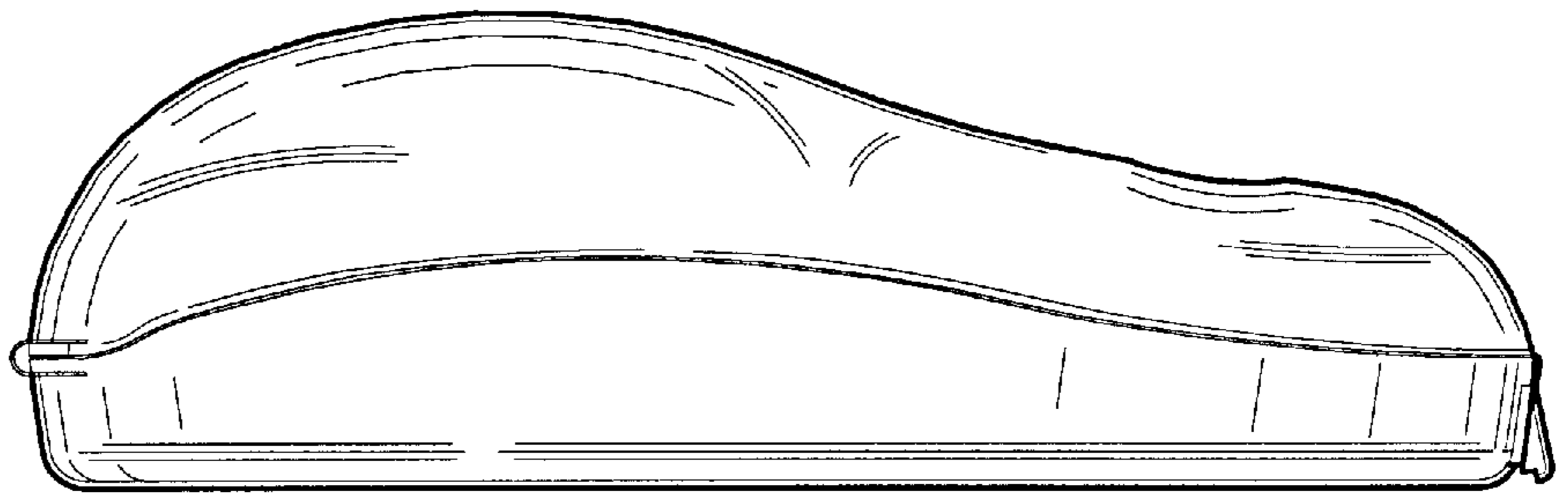

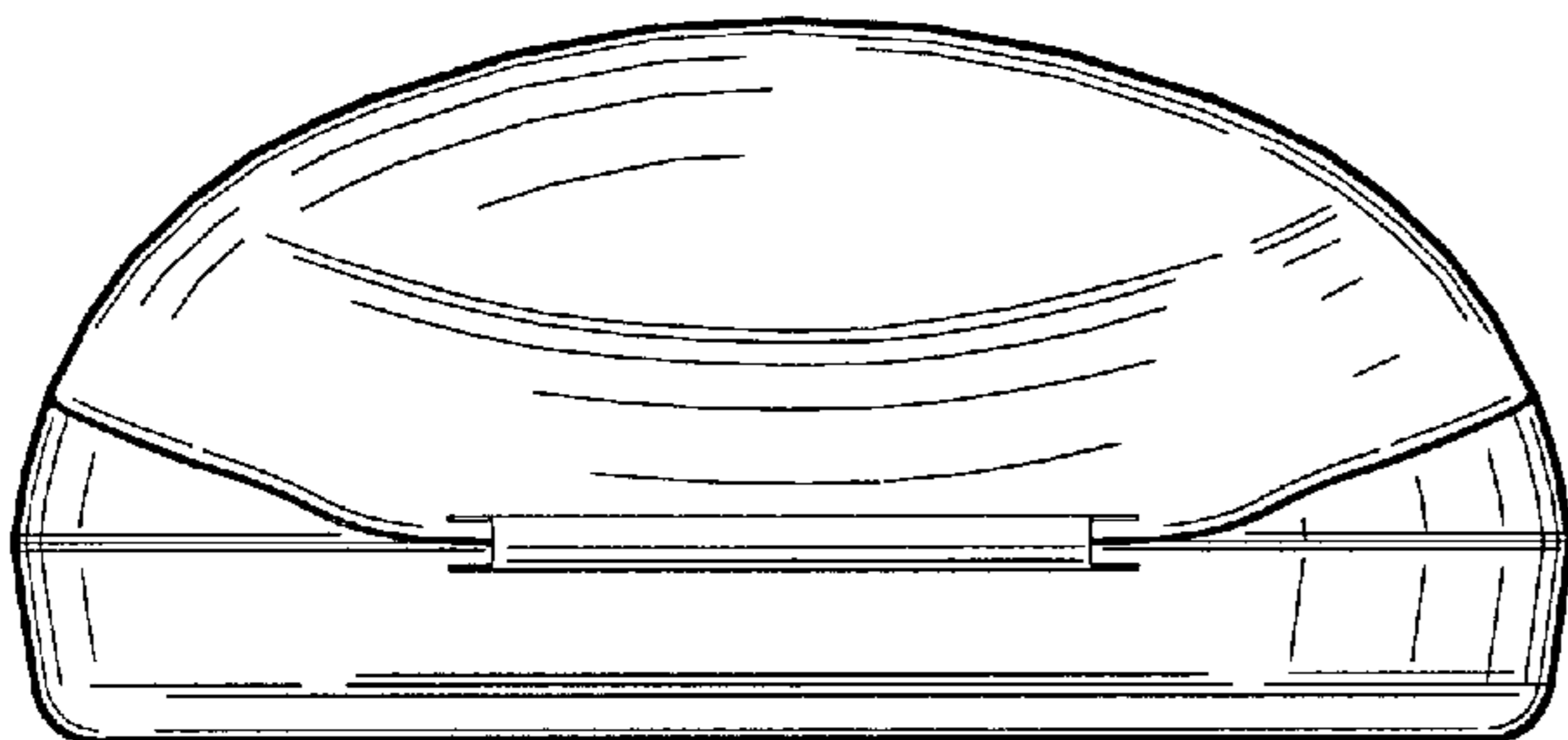

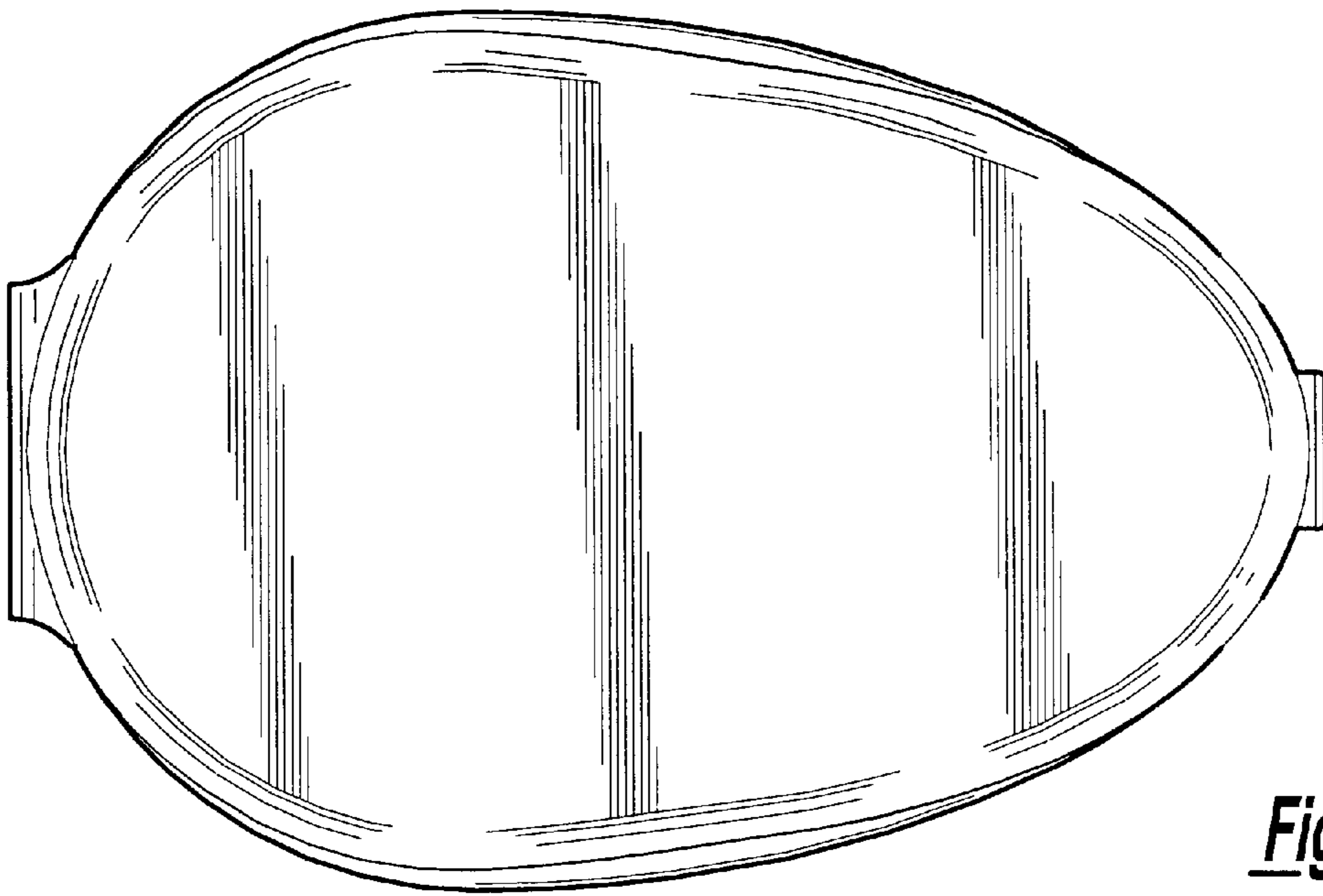

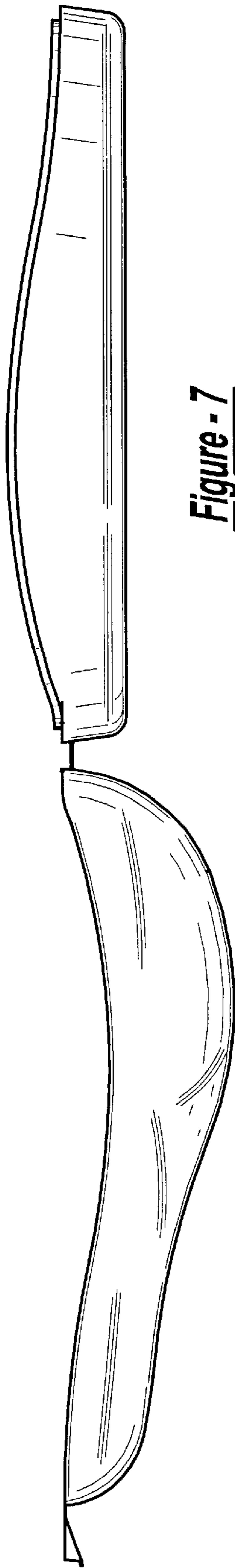

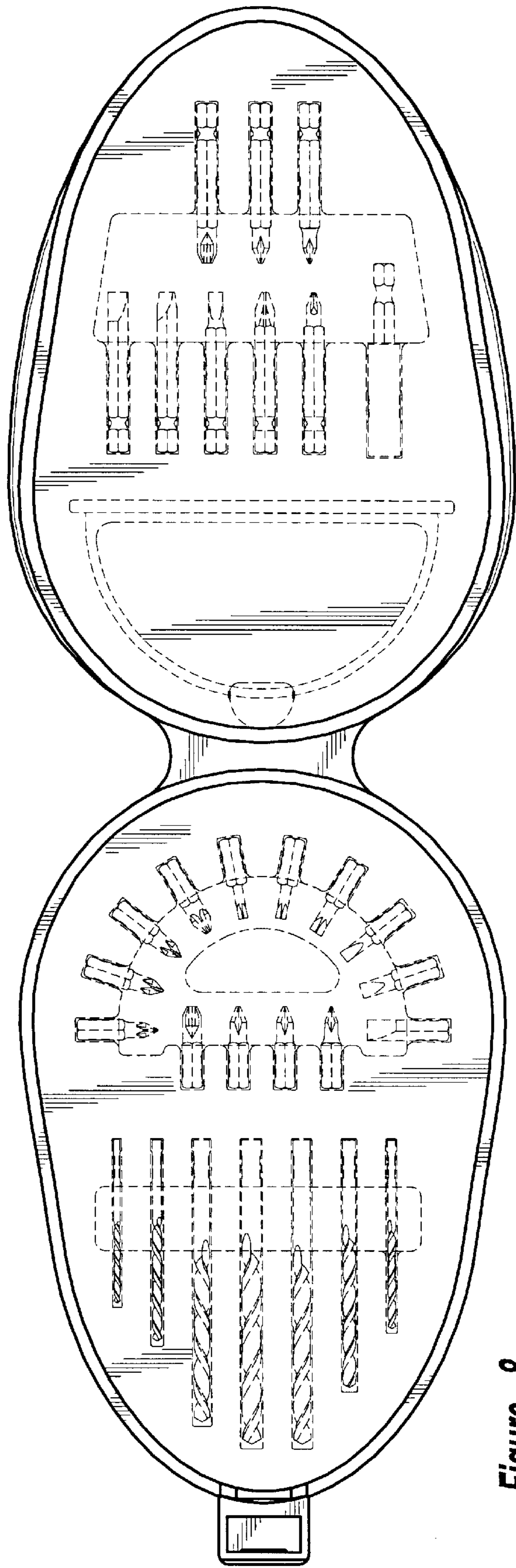
