in FIG. 1.

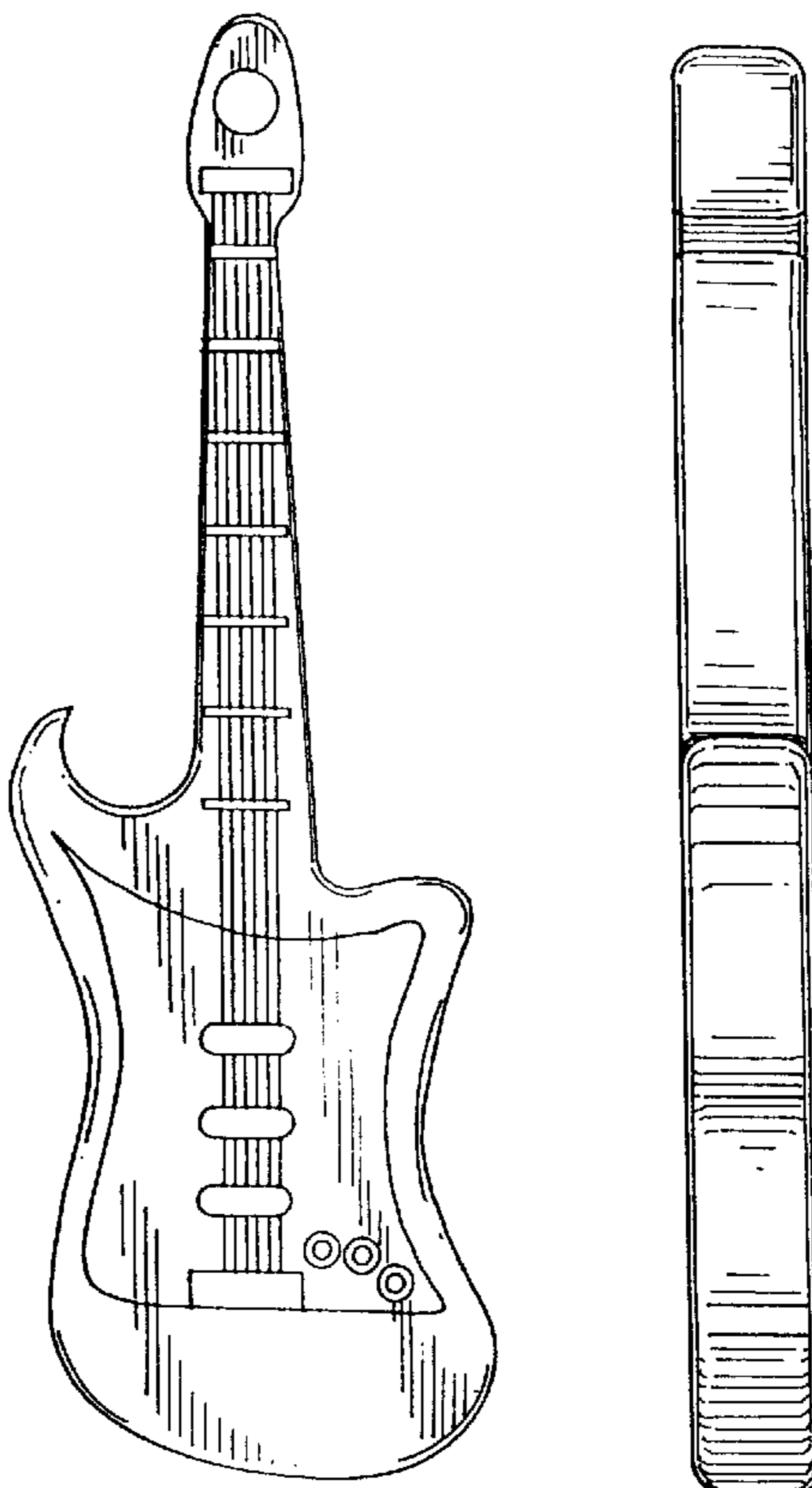
FIG. 3 is a front side plan view of the bottle opener shown

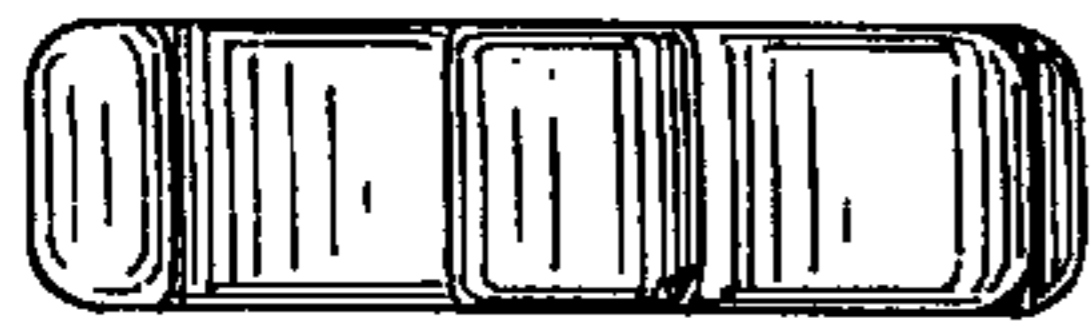

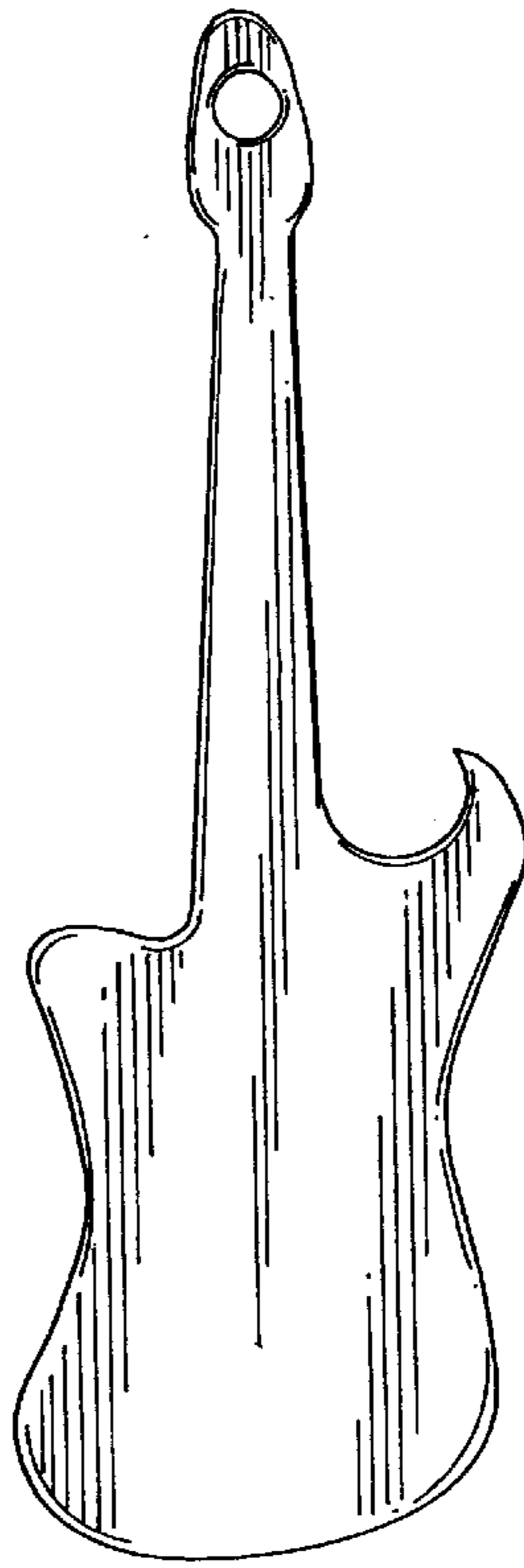

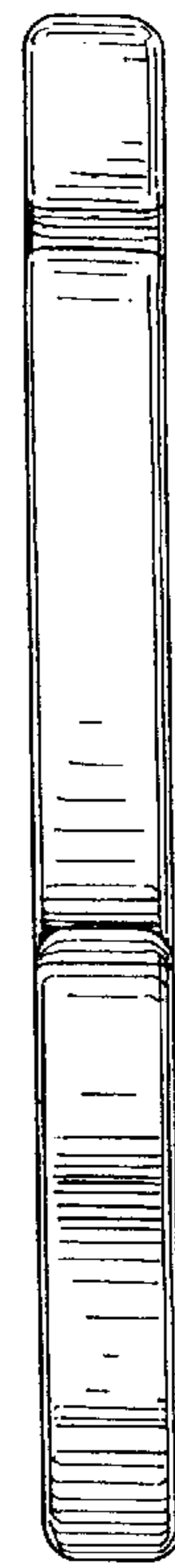
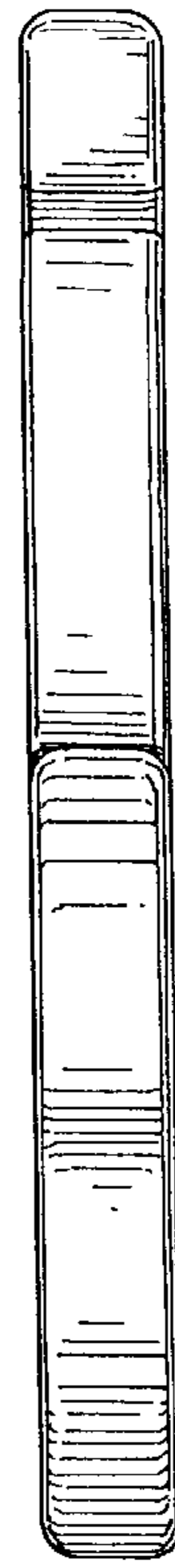


FIG. 5 FIG. 6

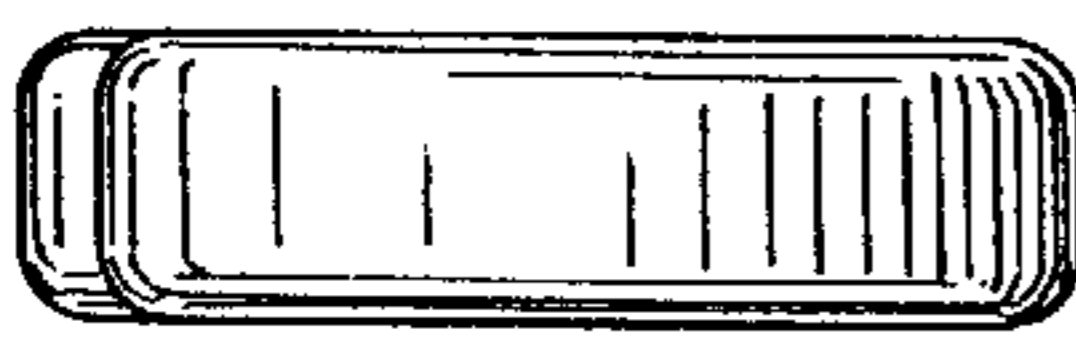

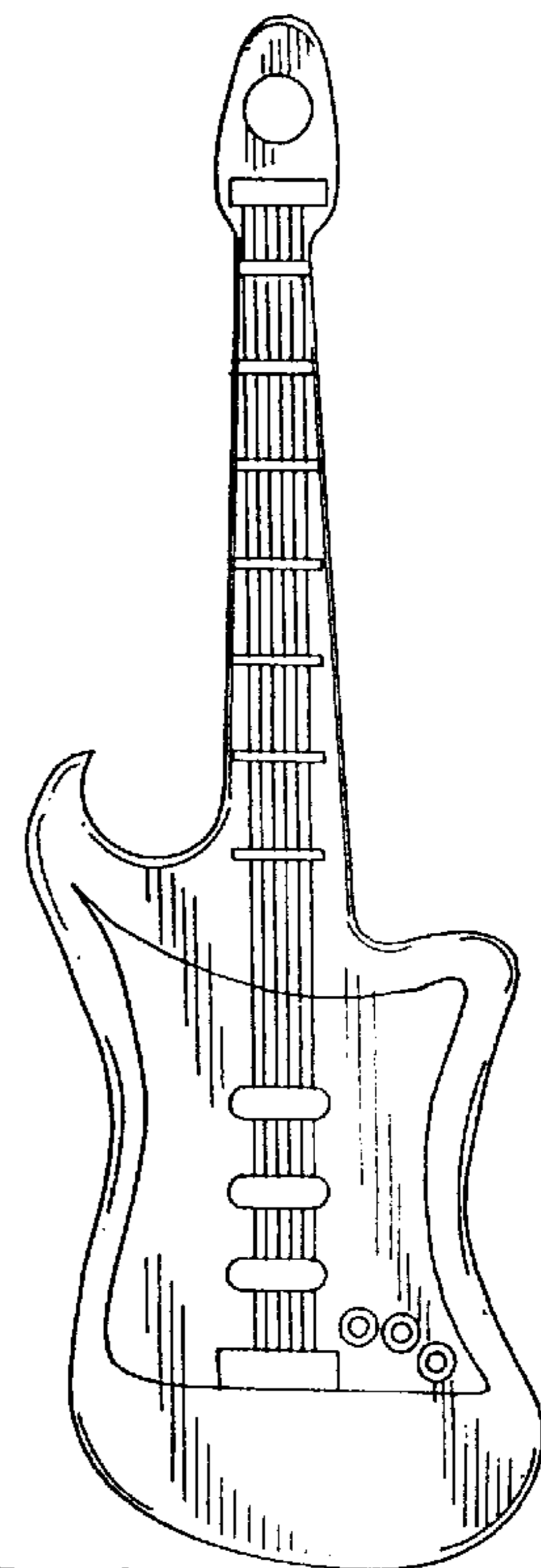
