**DESCRIPTION**

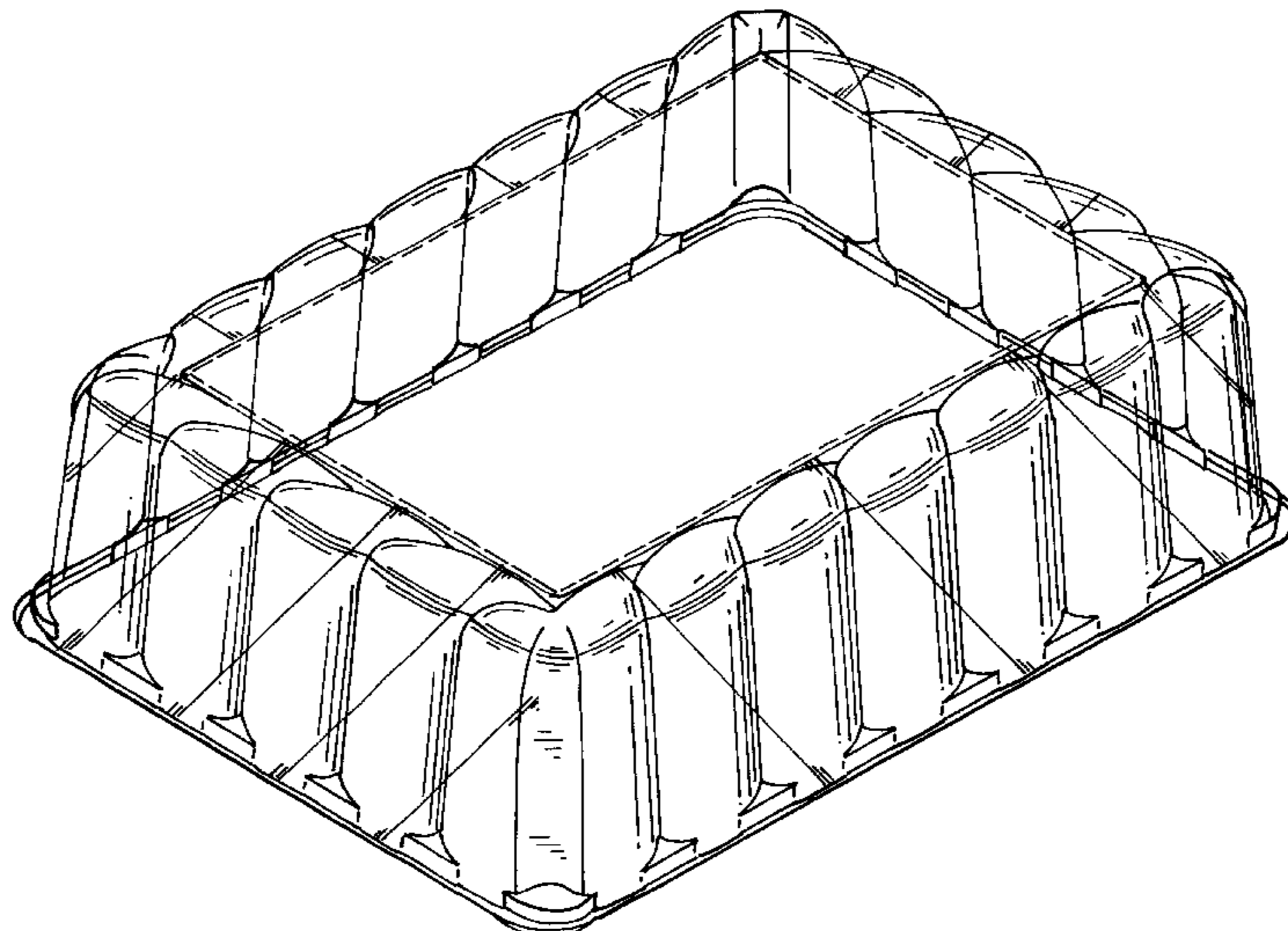
FIG. 1 is a perspective view of a package lid of the present invention;

FIG. 5 is a bottom plan view looking up into the package lid of FIG. 1.

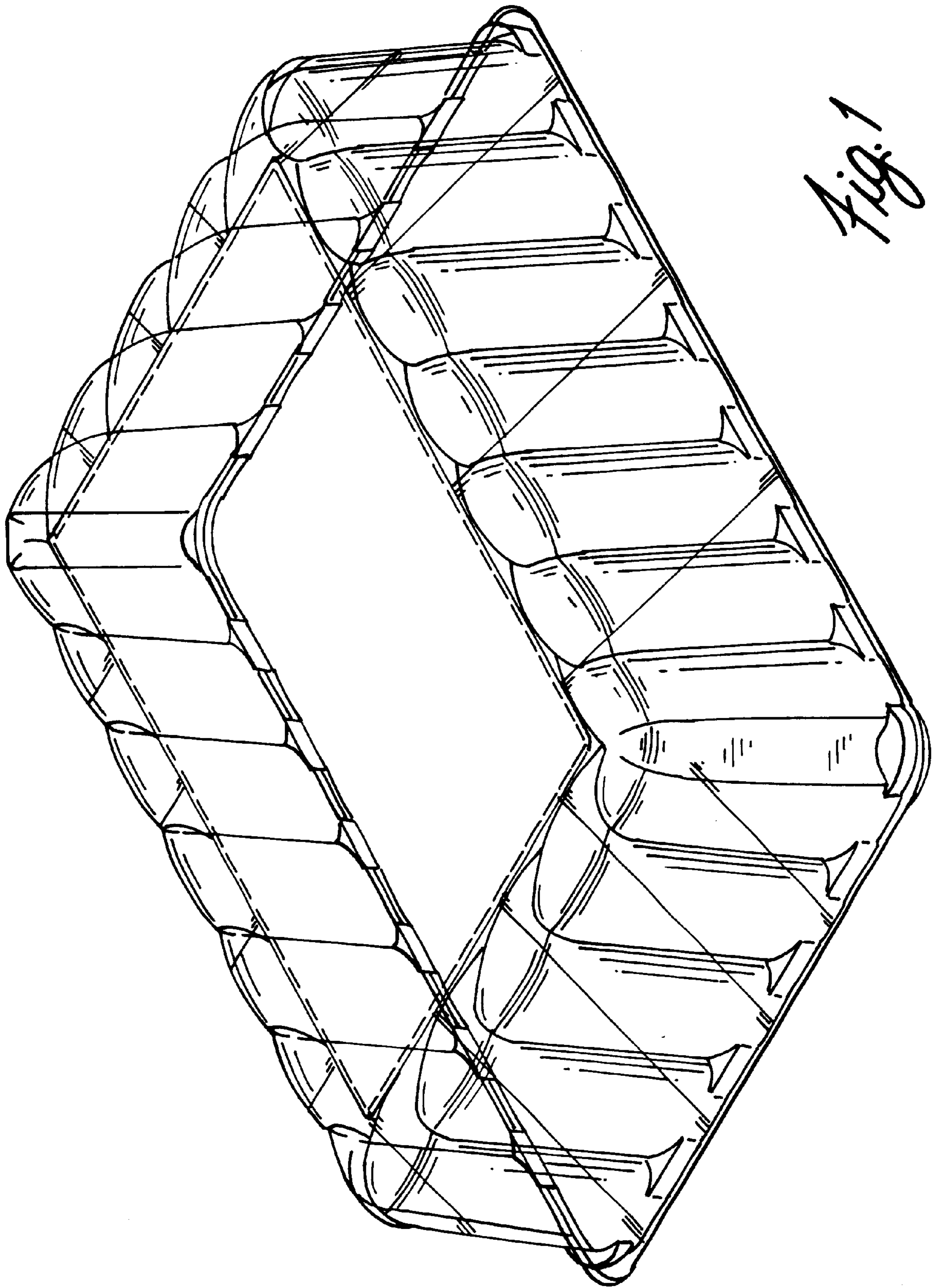

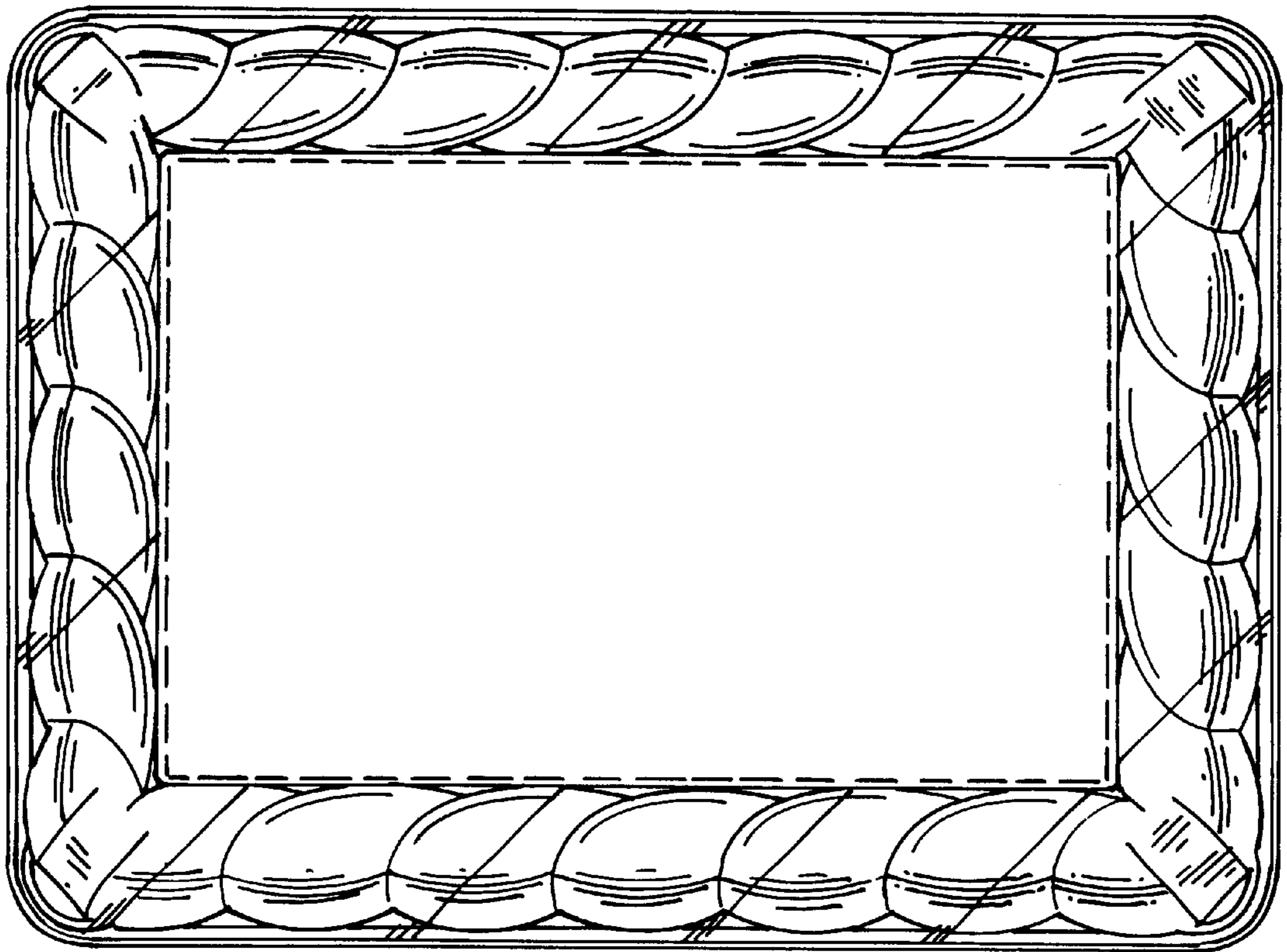

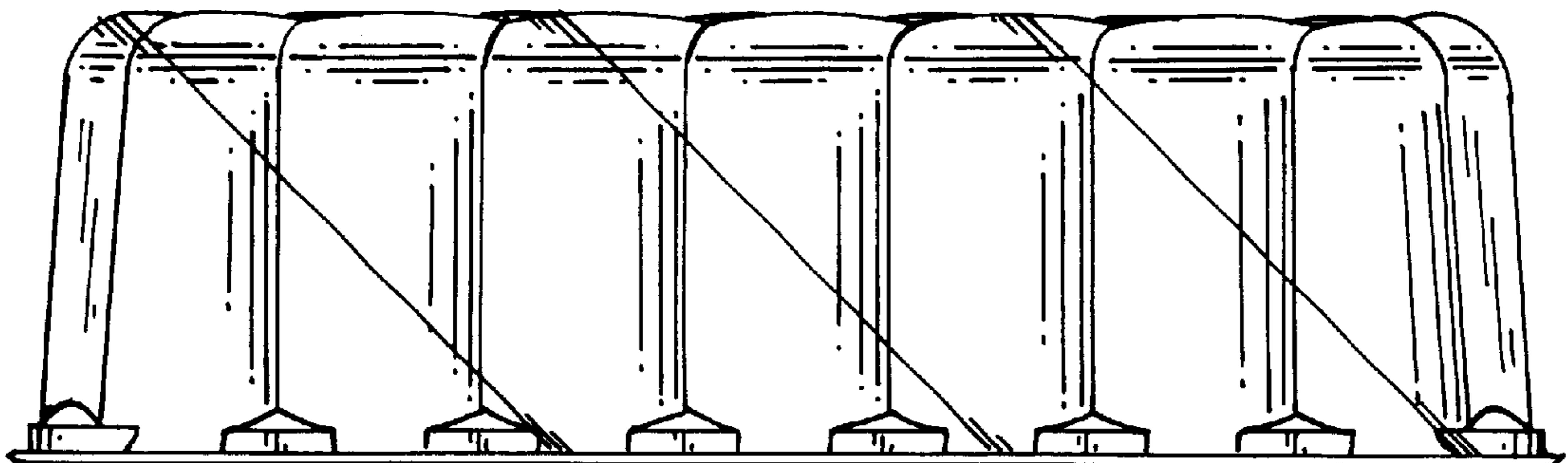

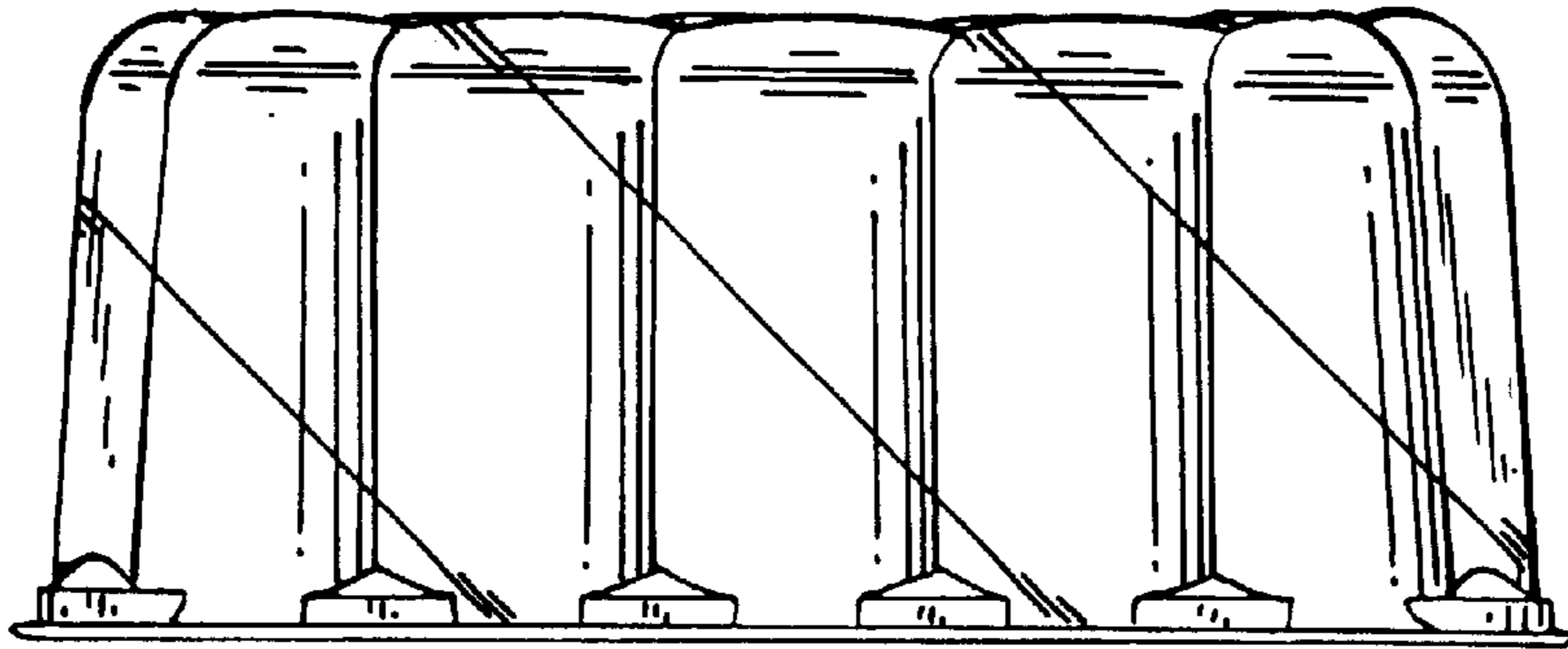




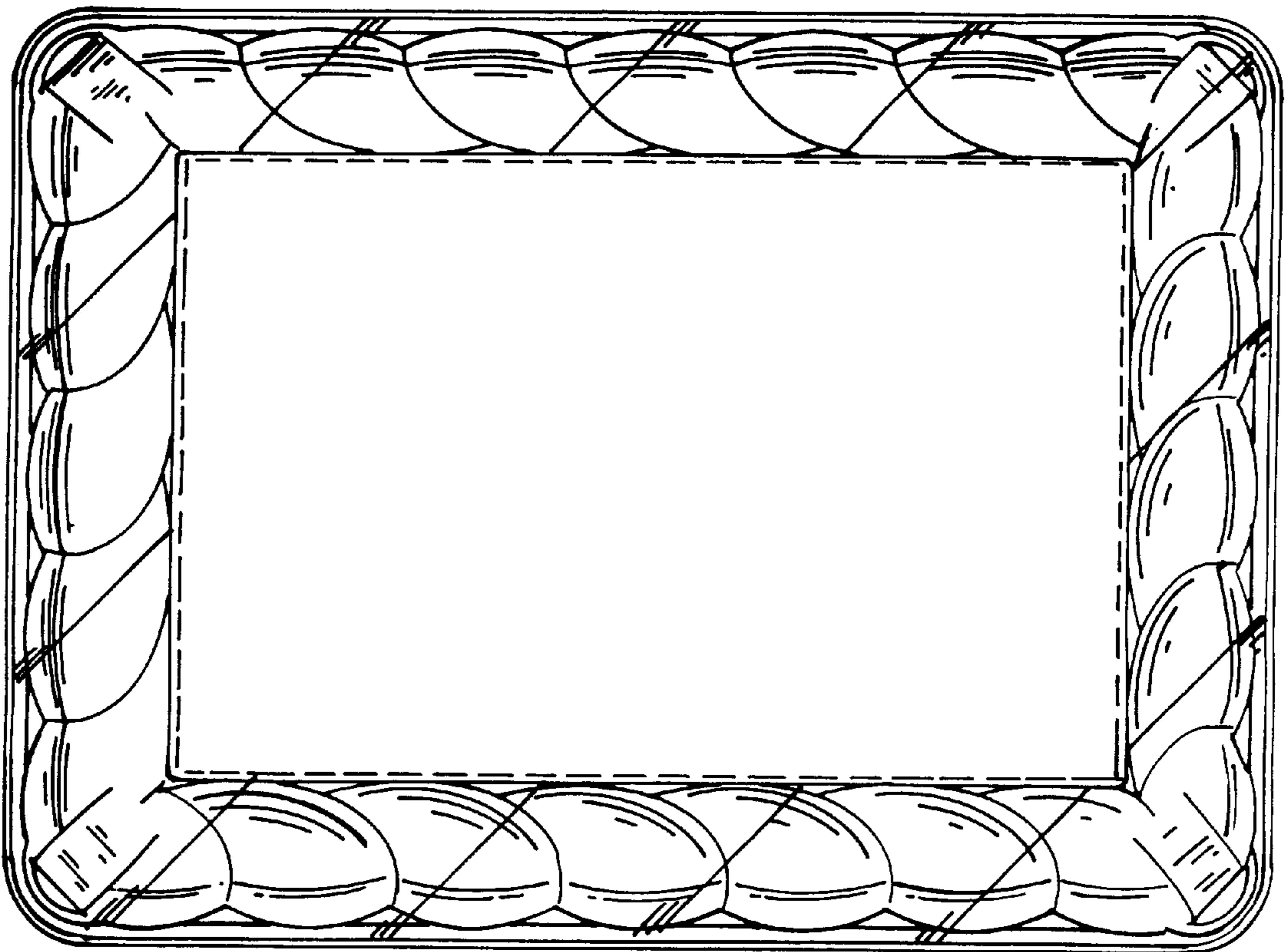
