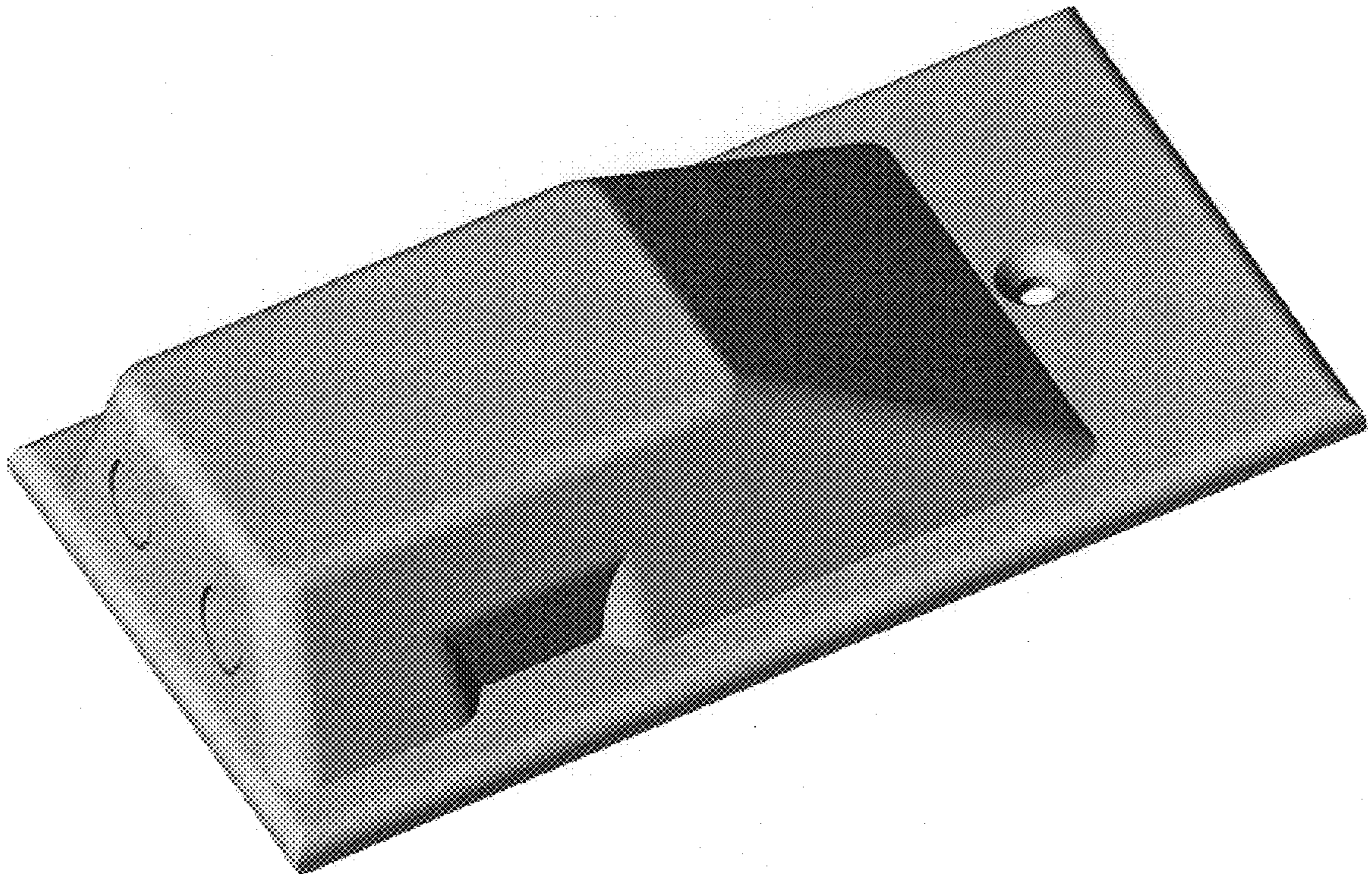
(57) **CLAIM**

The ornamental design for a wall plate for directional couplers, as shown and described.

DESCRIPTION

FIG. 1 is a top, left perspective view of an embodiment of a wall plate for directional couplers showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front view thereof; FIG. 5 is a back view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof.

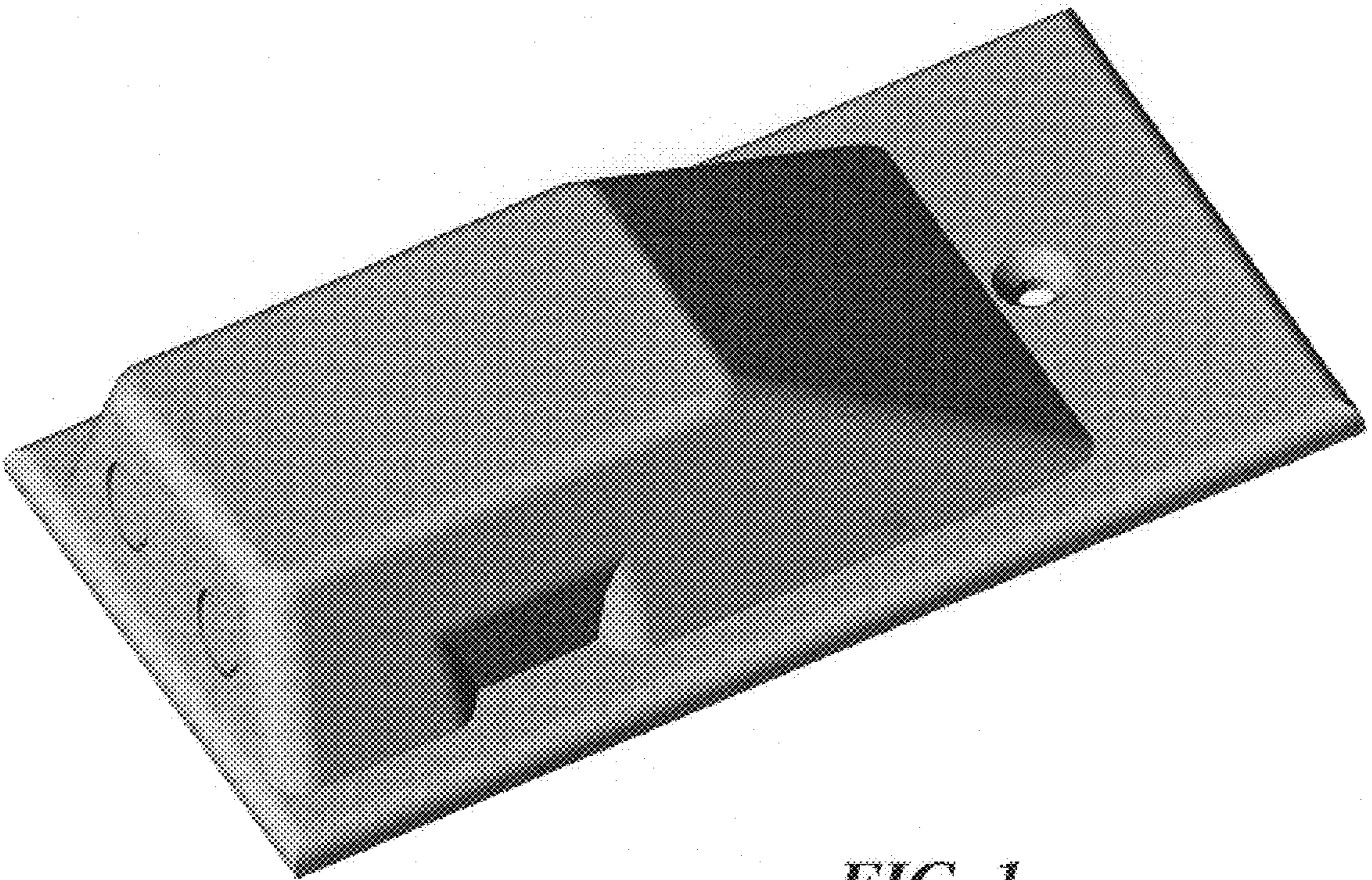

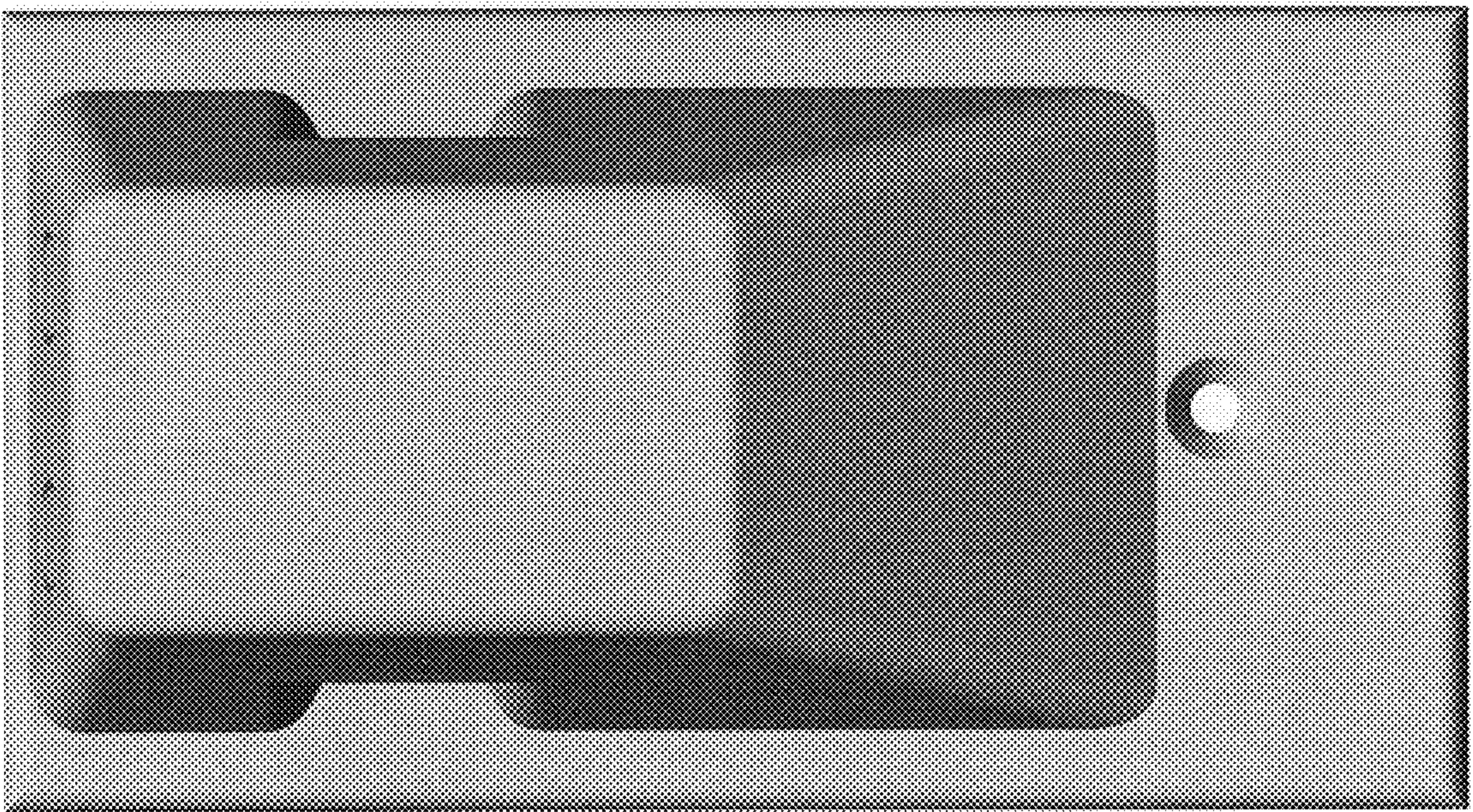

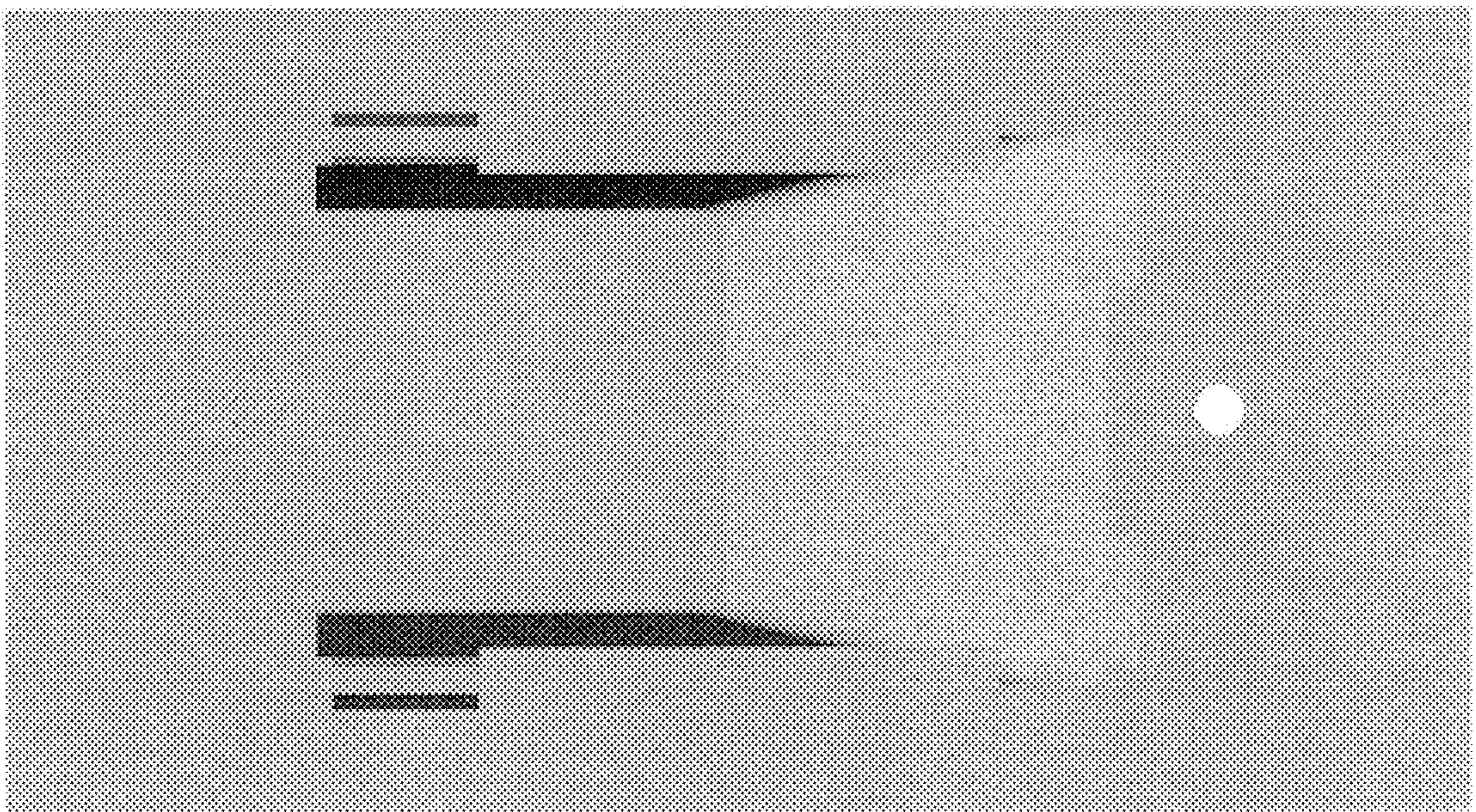

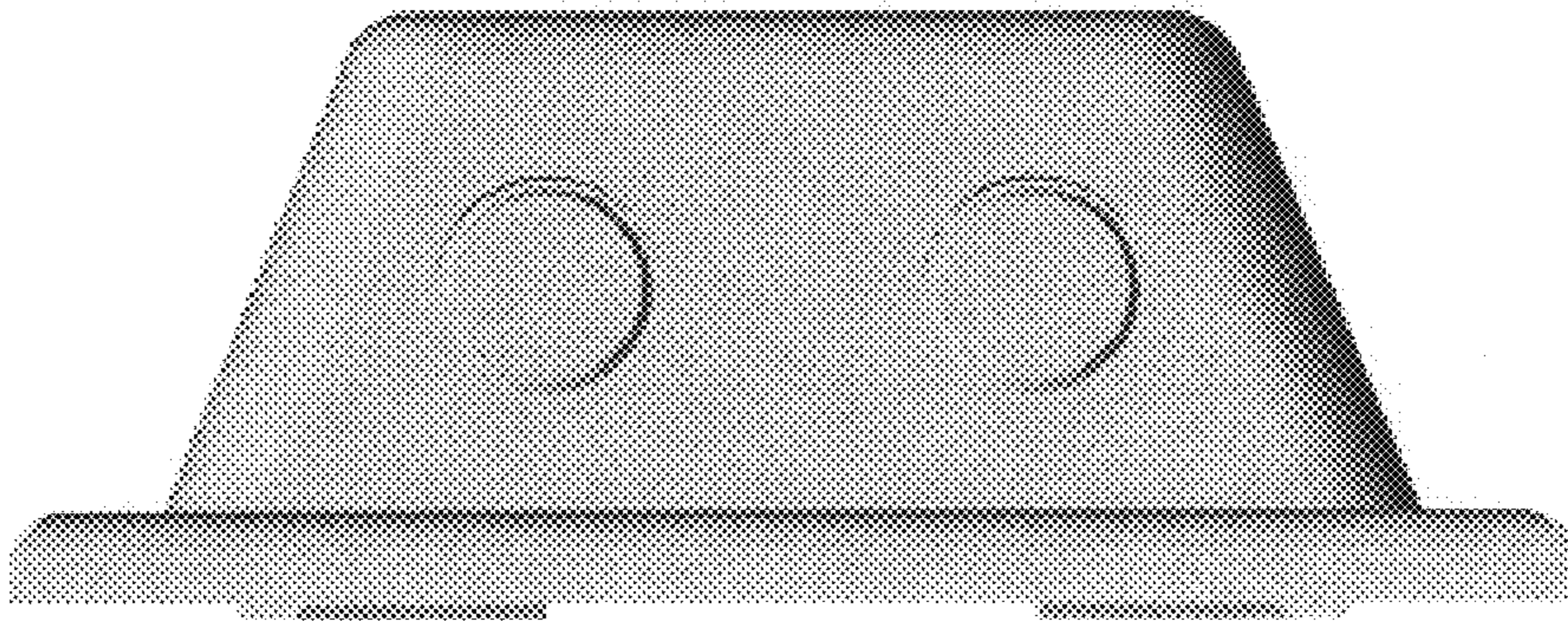

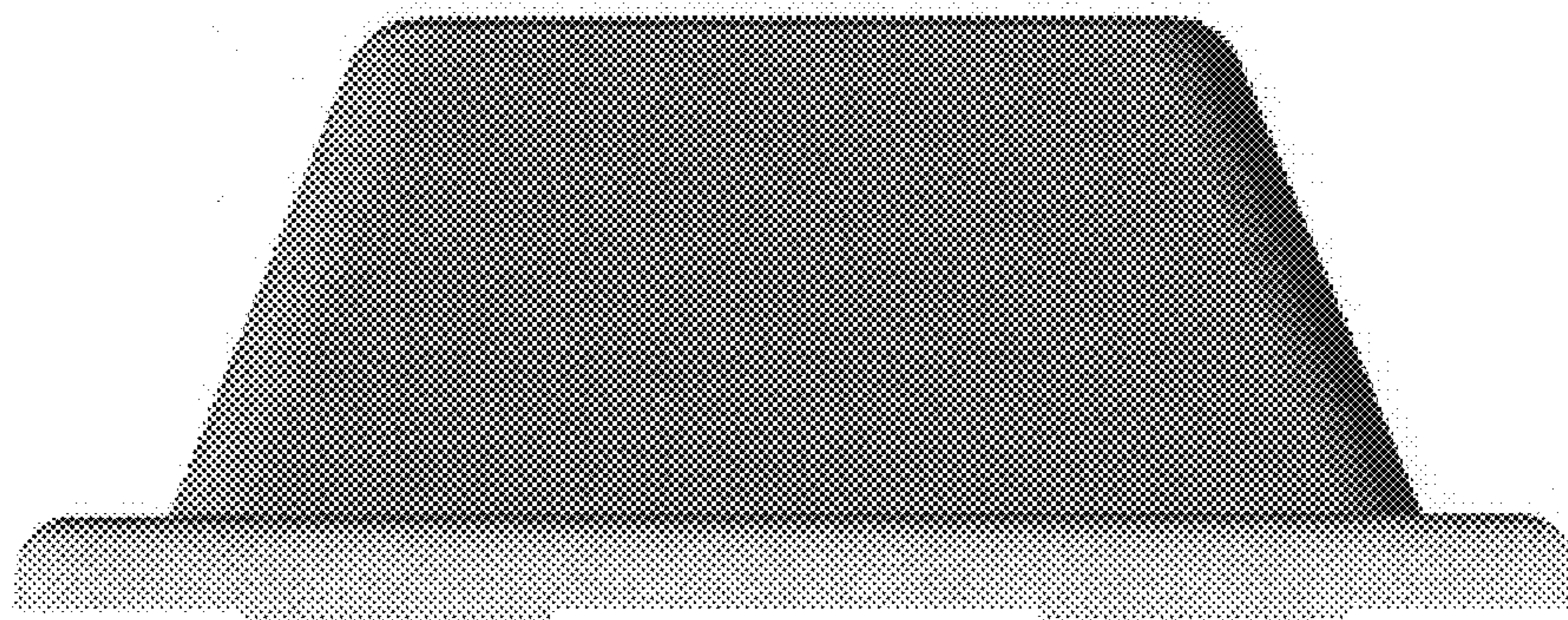

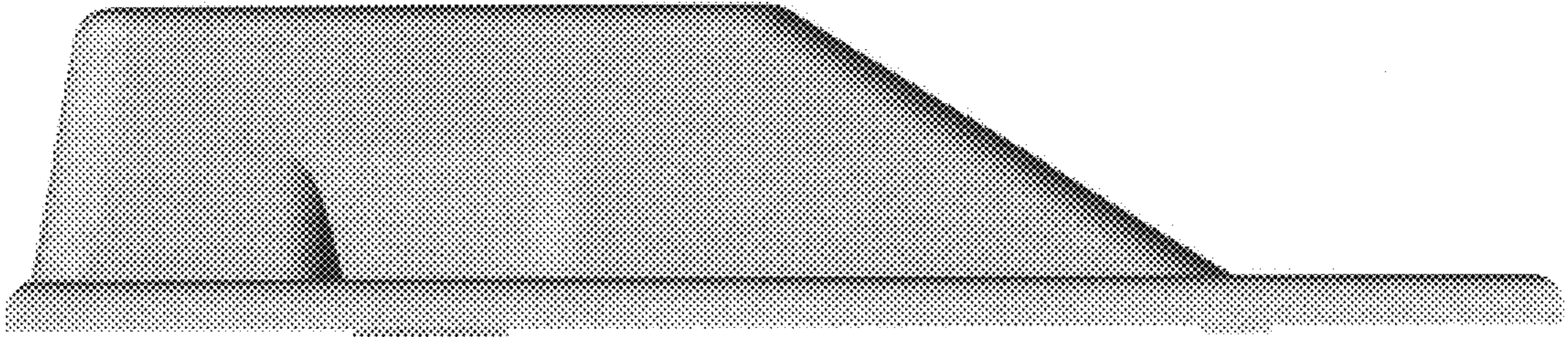

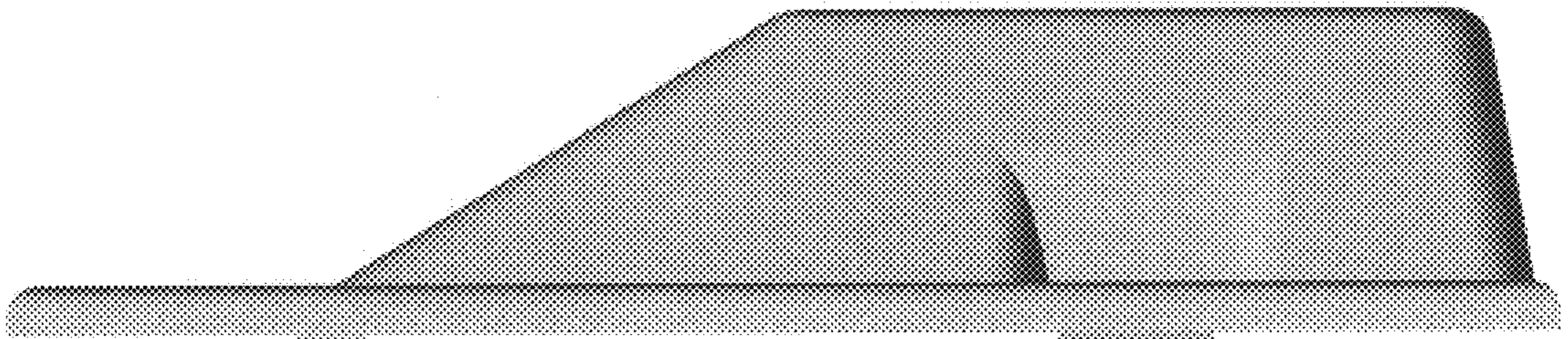
