The ornamental design for partially transparent IC card, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged top, front and right side perspective view of the partially transparent IC card showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

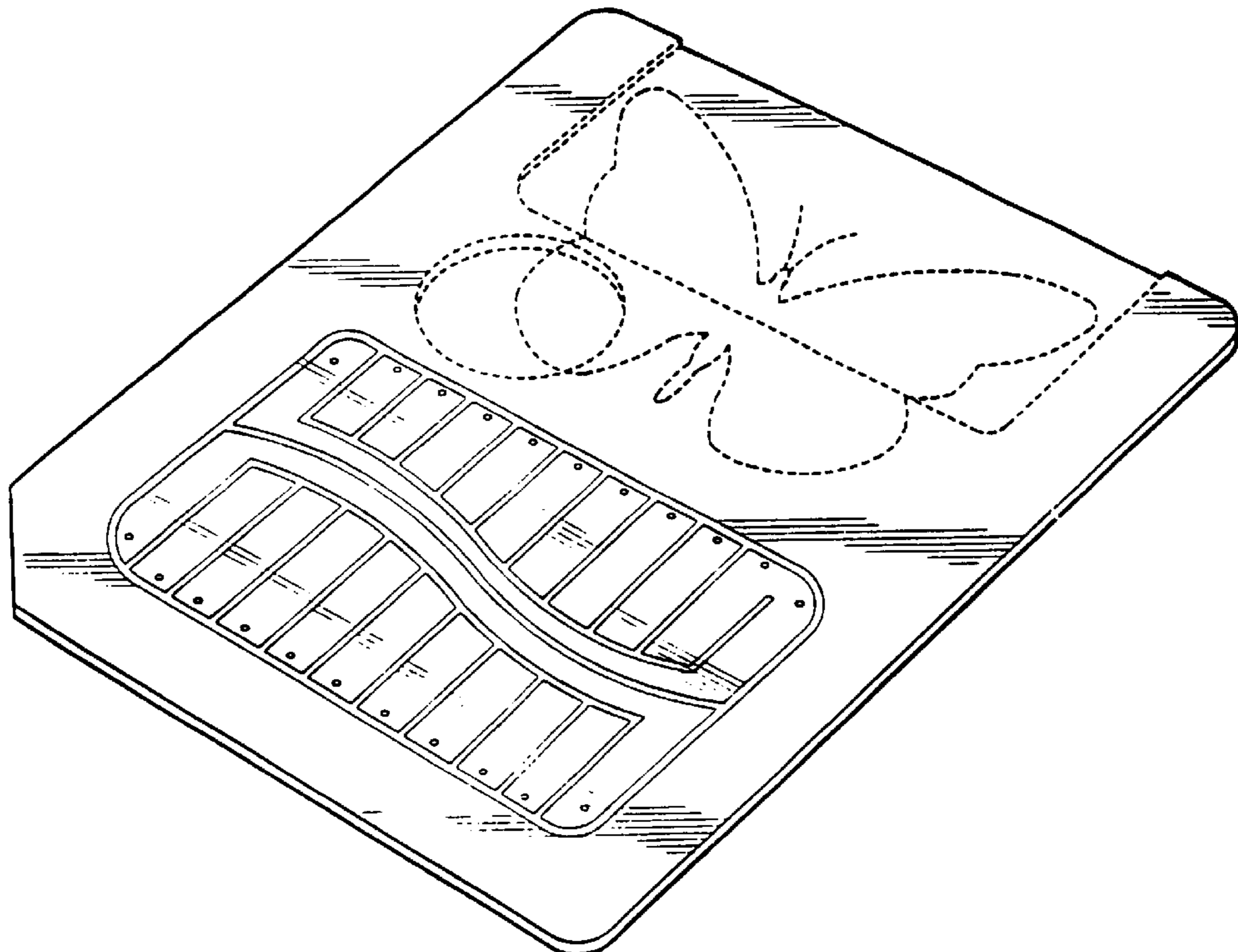
FIG. 6 is a left side elevational view thereof;

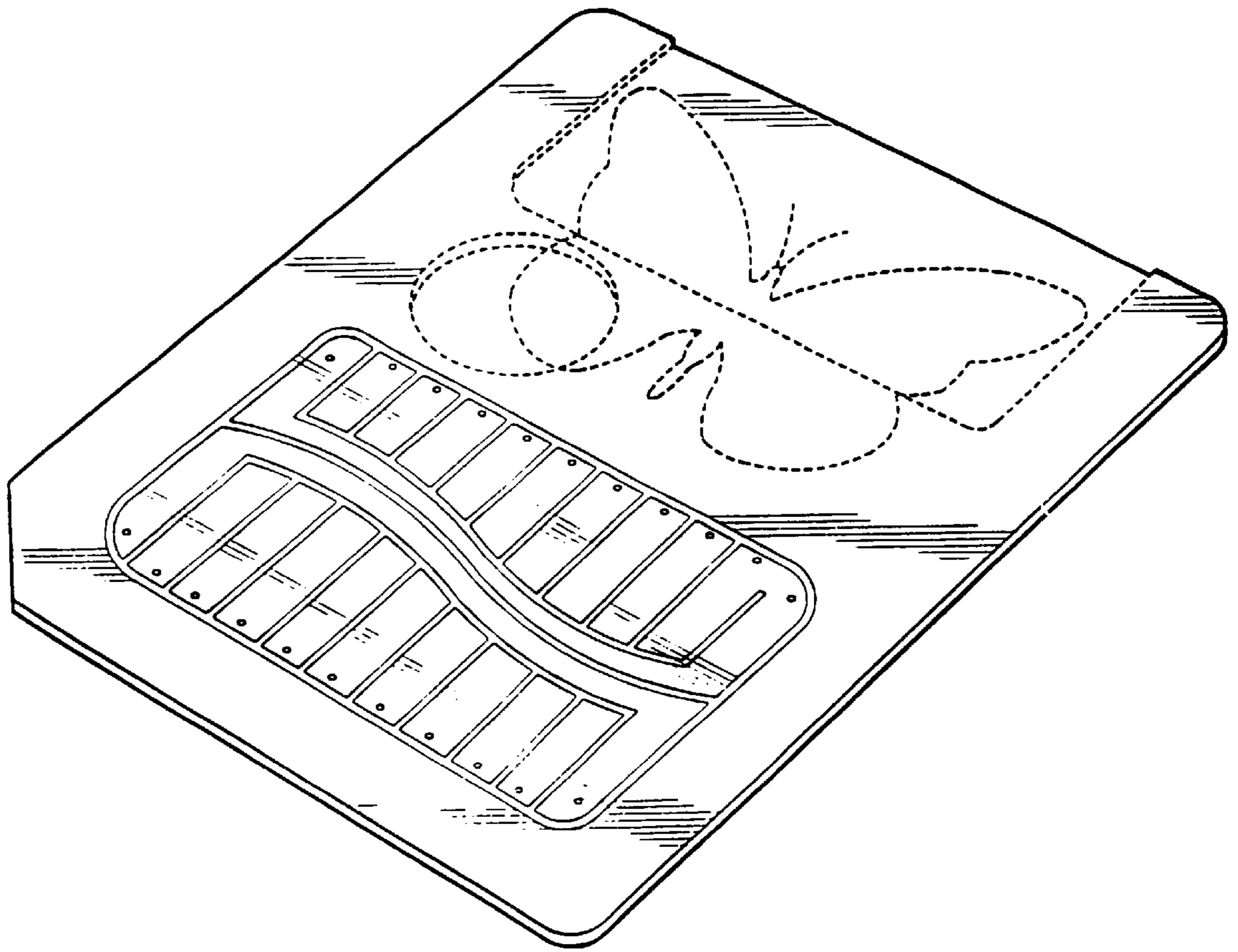
FIG. 7 is a bottom plan view thereof; and,

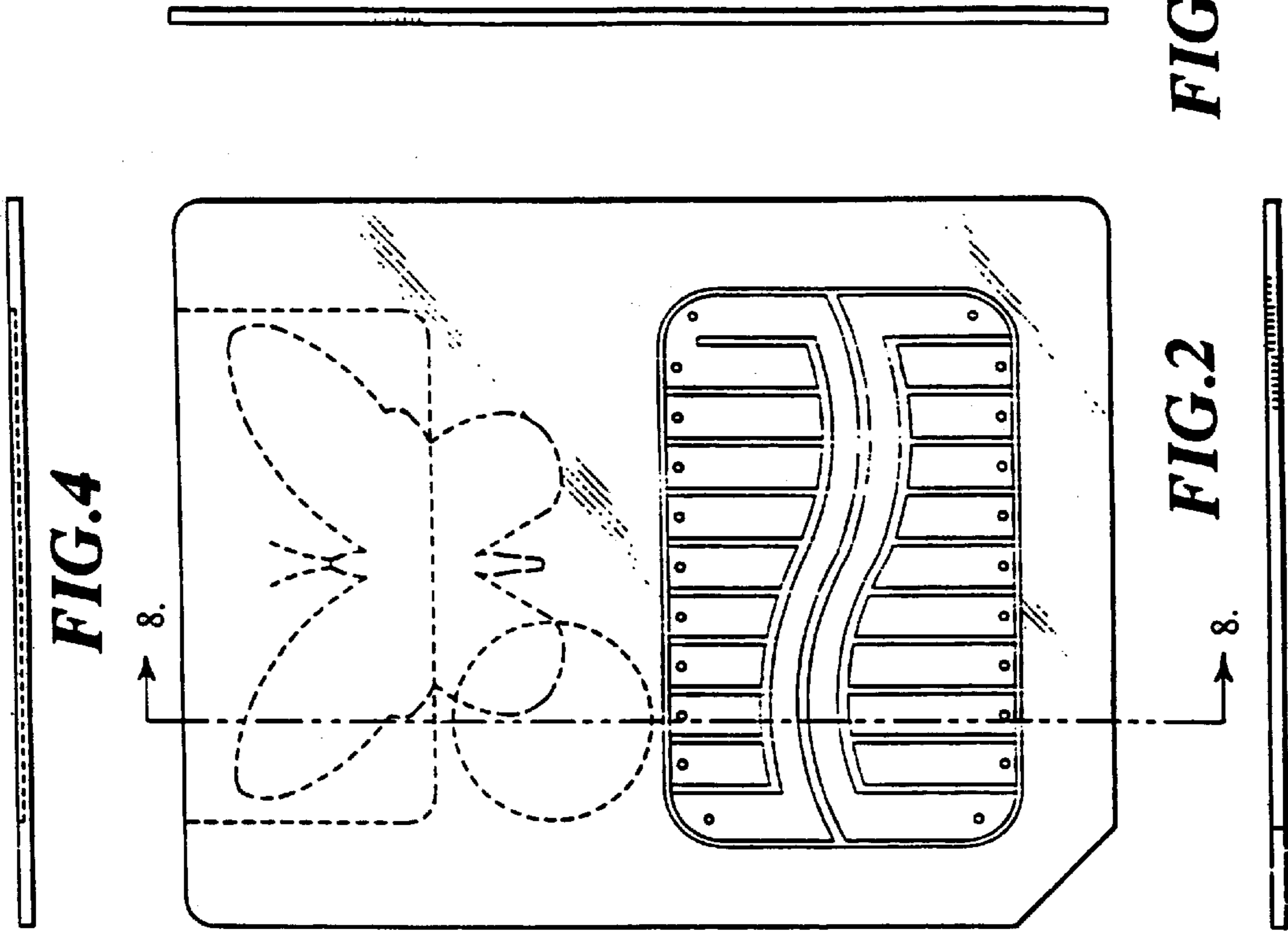


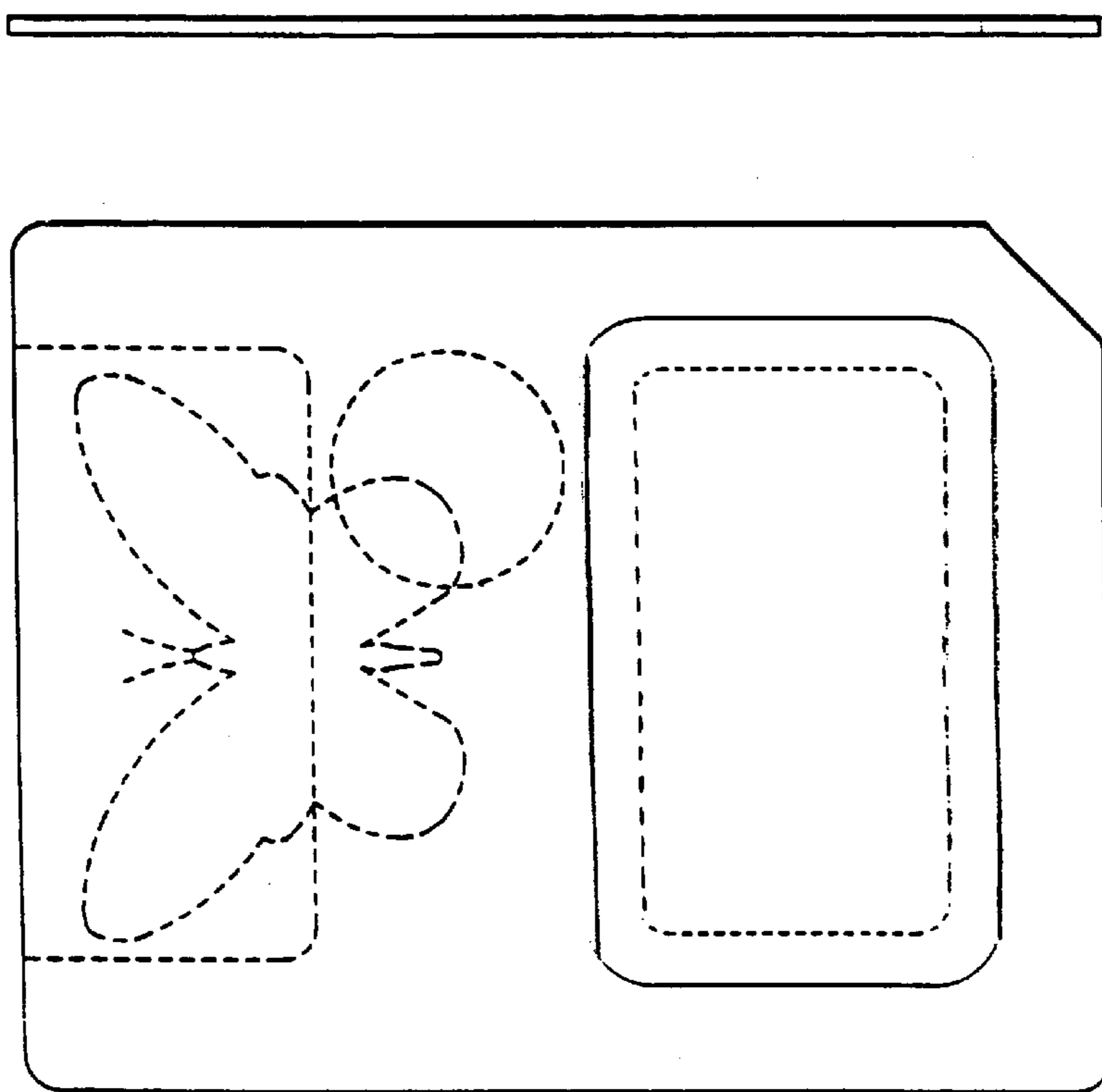
