DESCRIPTION

FIG. 1 is a front elevational view of a binder insert embodying my new design;

FIG. 2 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

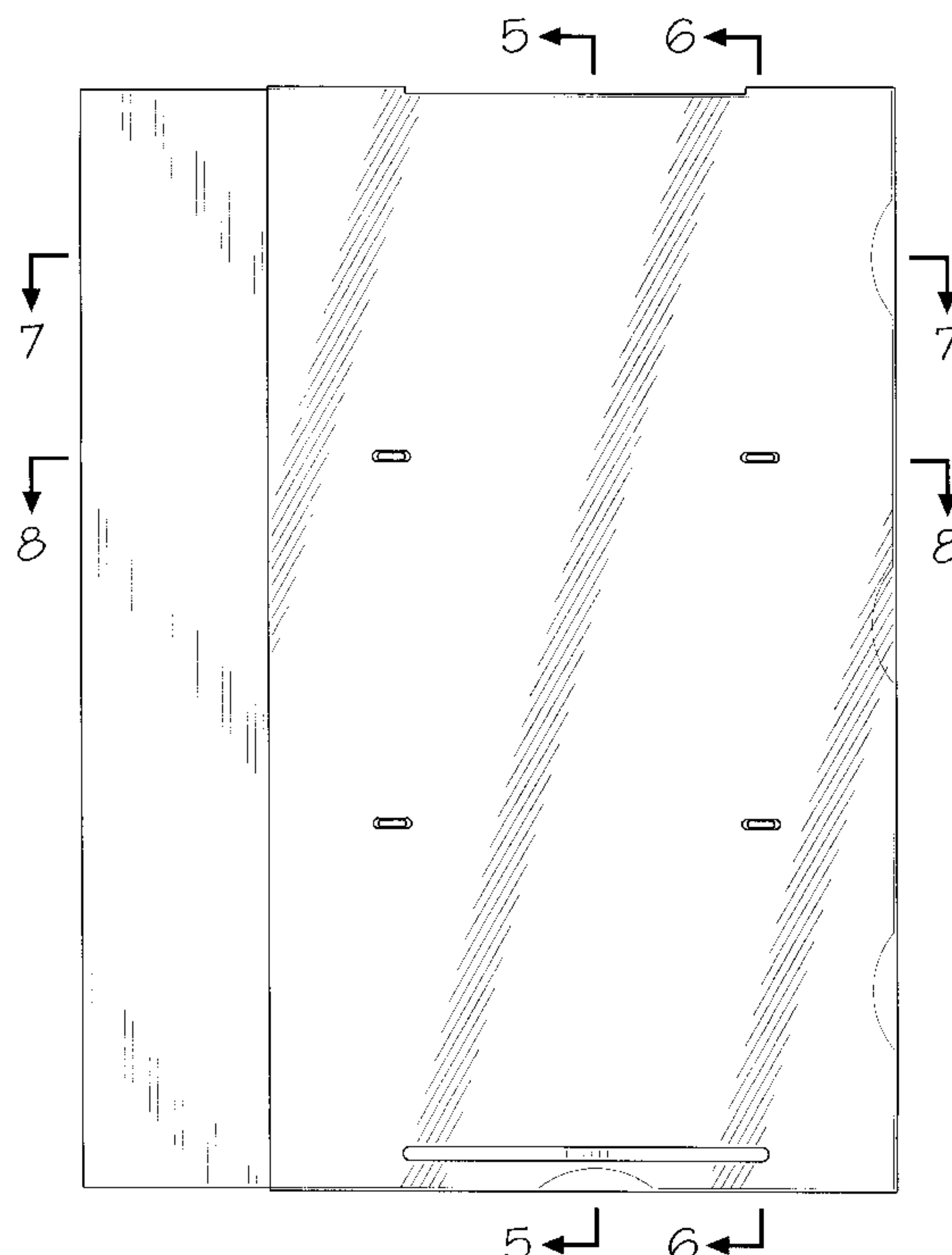
FIG. 5 is a cross sectional view taken along line 5—5;

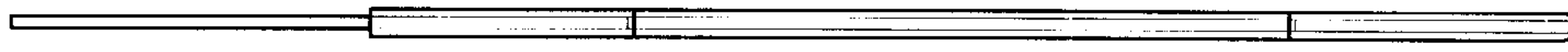

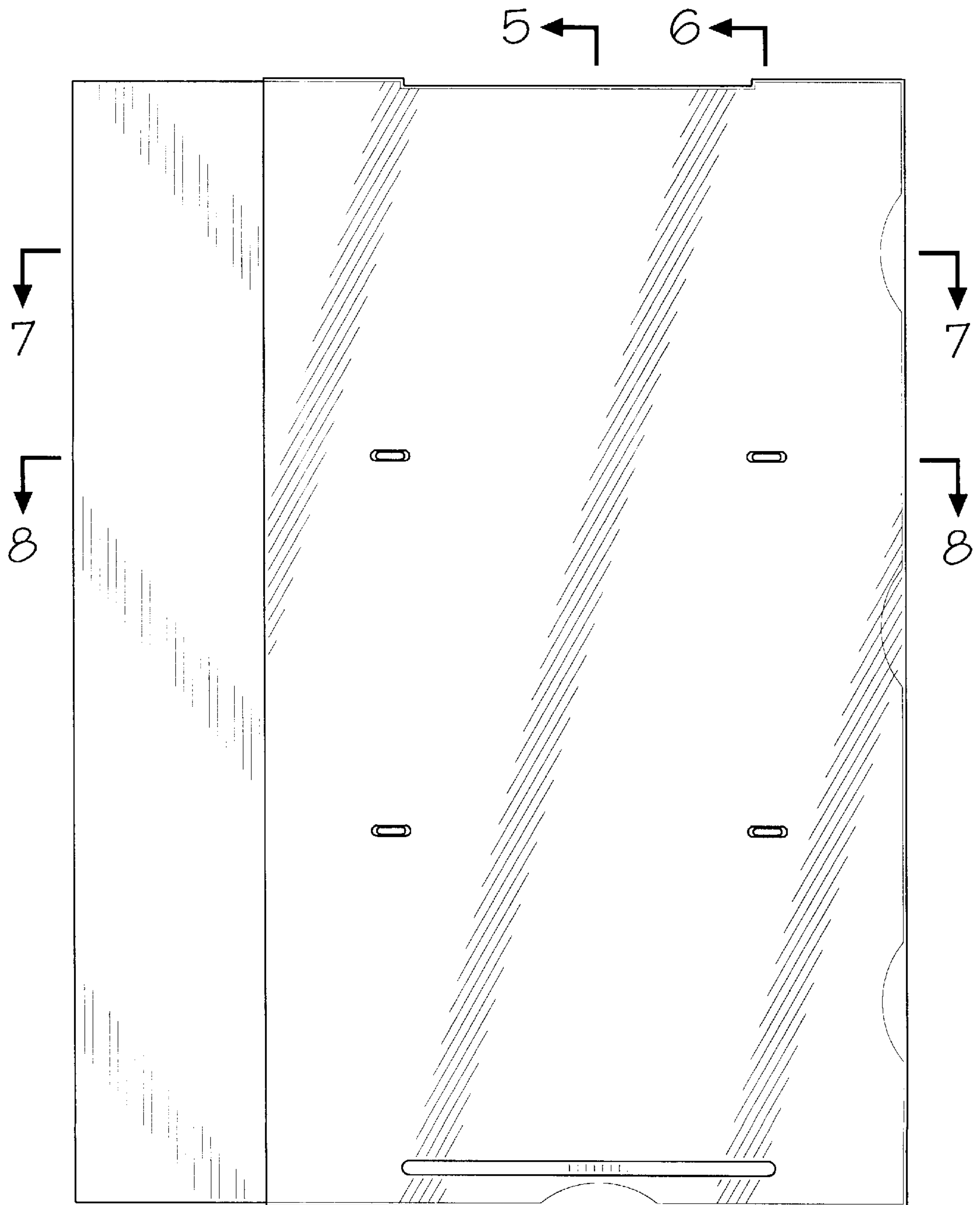

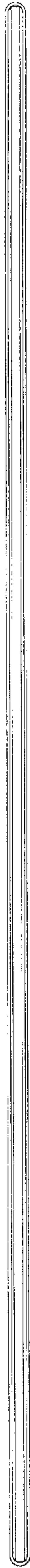

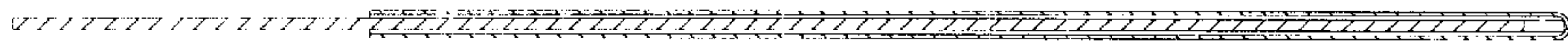

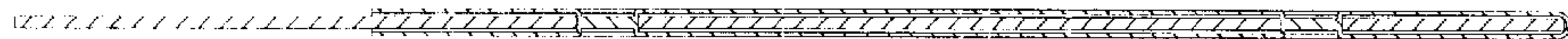
