FIG. 2 is a side elevational view, the opposite side being a mirror image thereof;

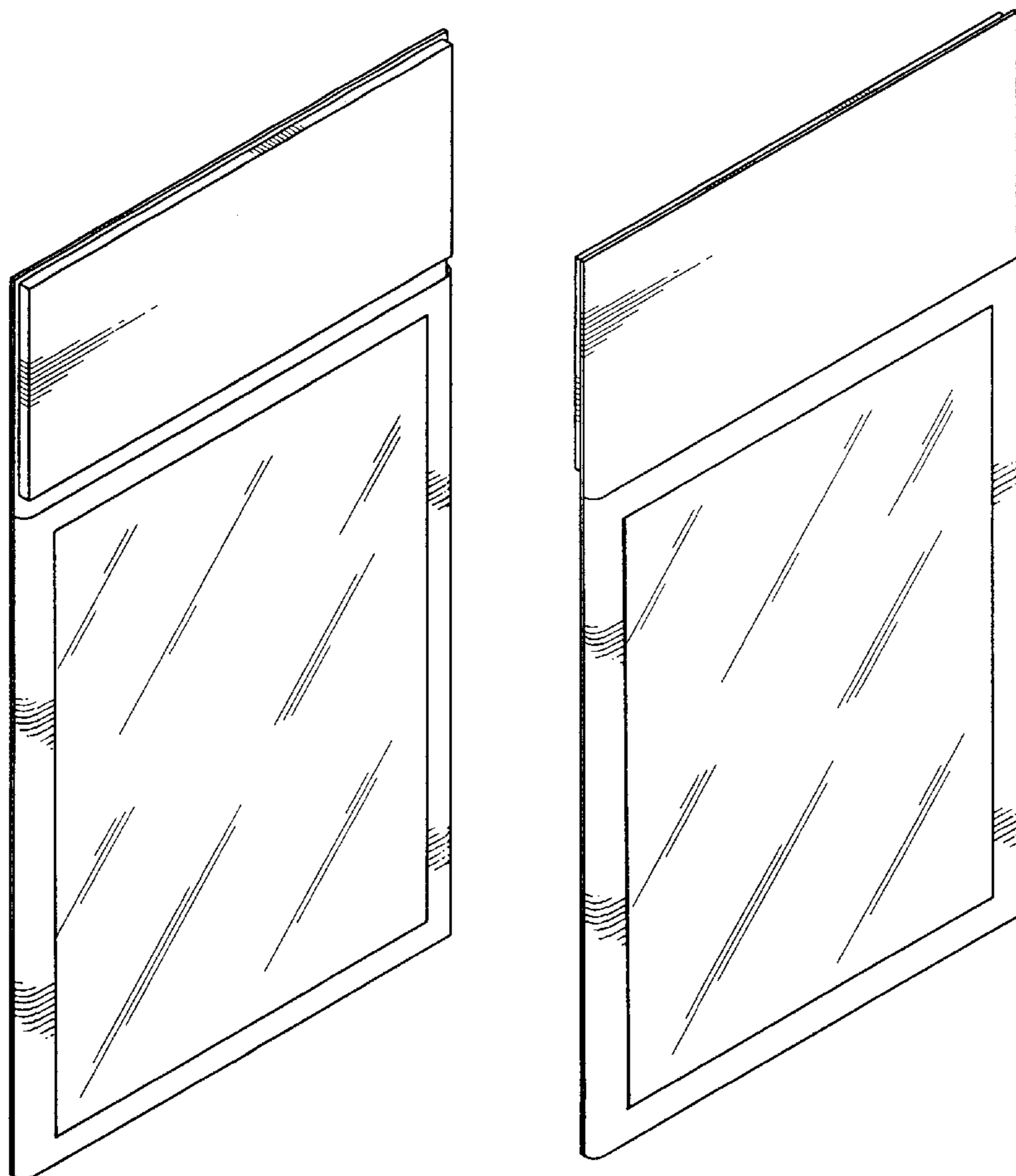
FIG. 3 is a top plan view thereof;

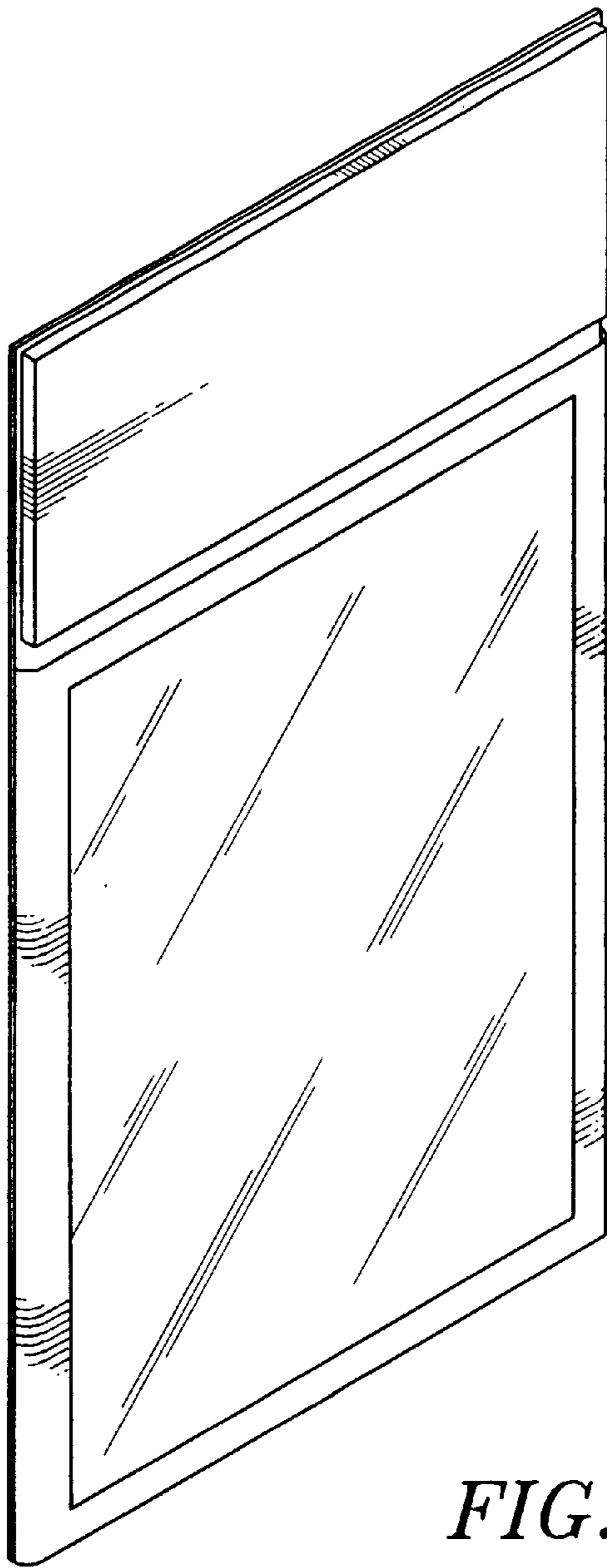
The rear view is plain and unornamental;

FIG. 4 is a side elevational view of a second embodiment thereof, the opposite side being a mirror image thereof; and,

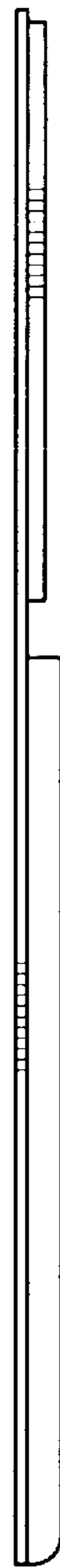
FIG. 5 is a front perspective view thereof.

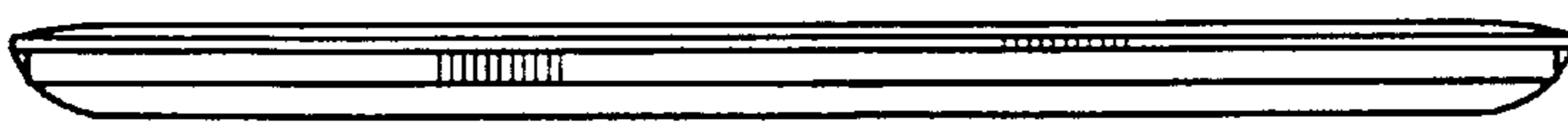

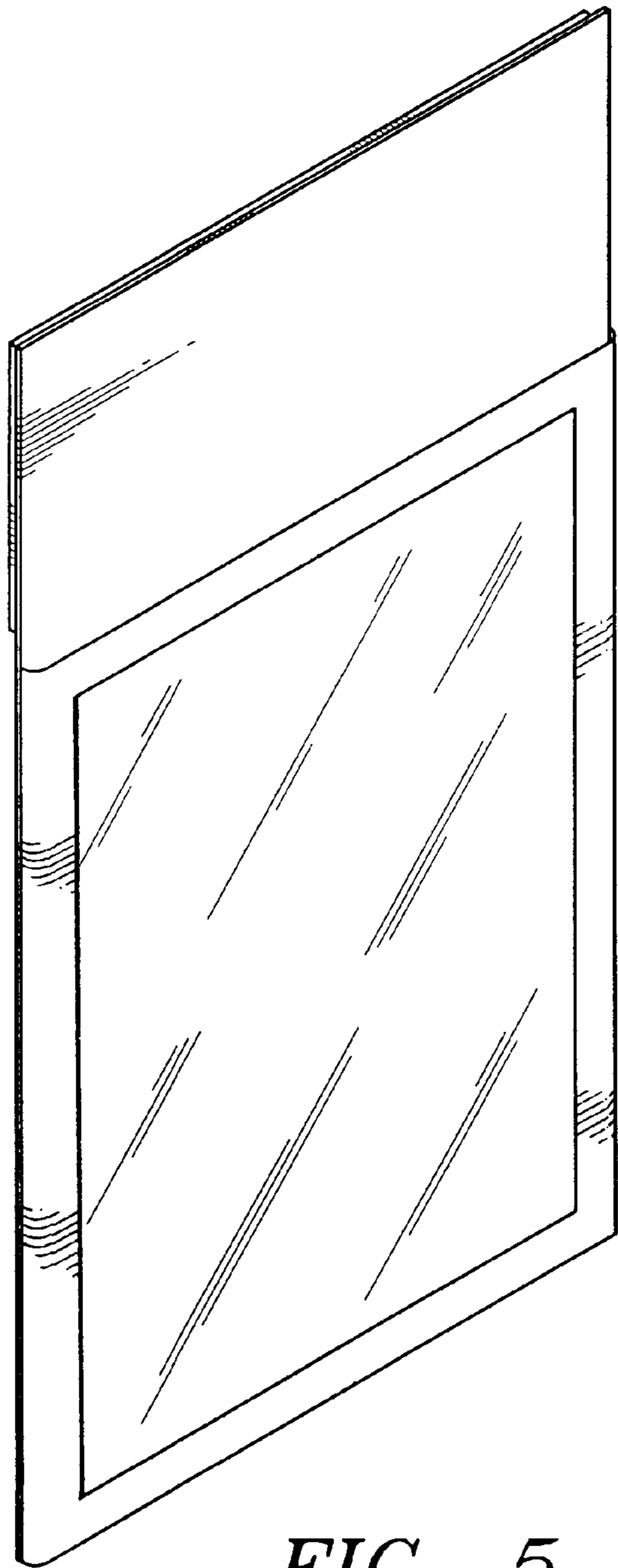
