The ornamental design for a children's riding toy, as shown.

DESCRIPTION

FIG. 1 is a front top perspective view of the design;
FIG. 2 is a top plan view of the design;
FIG. 3 is a front elevational view of the design;
FIG. 4 is a side elevational view of the design, the opposite
side of which is an identical mirror image;
FIG. 5 is a rear bottom perspective view of the design;
FIG. 6 is a rear elevational view of the design; and,
FIG. 7 is a bottom plan view of the design.

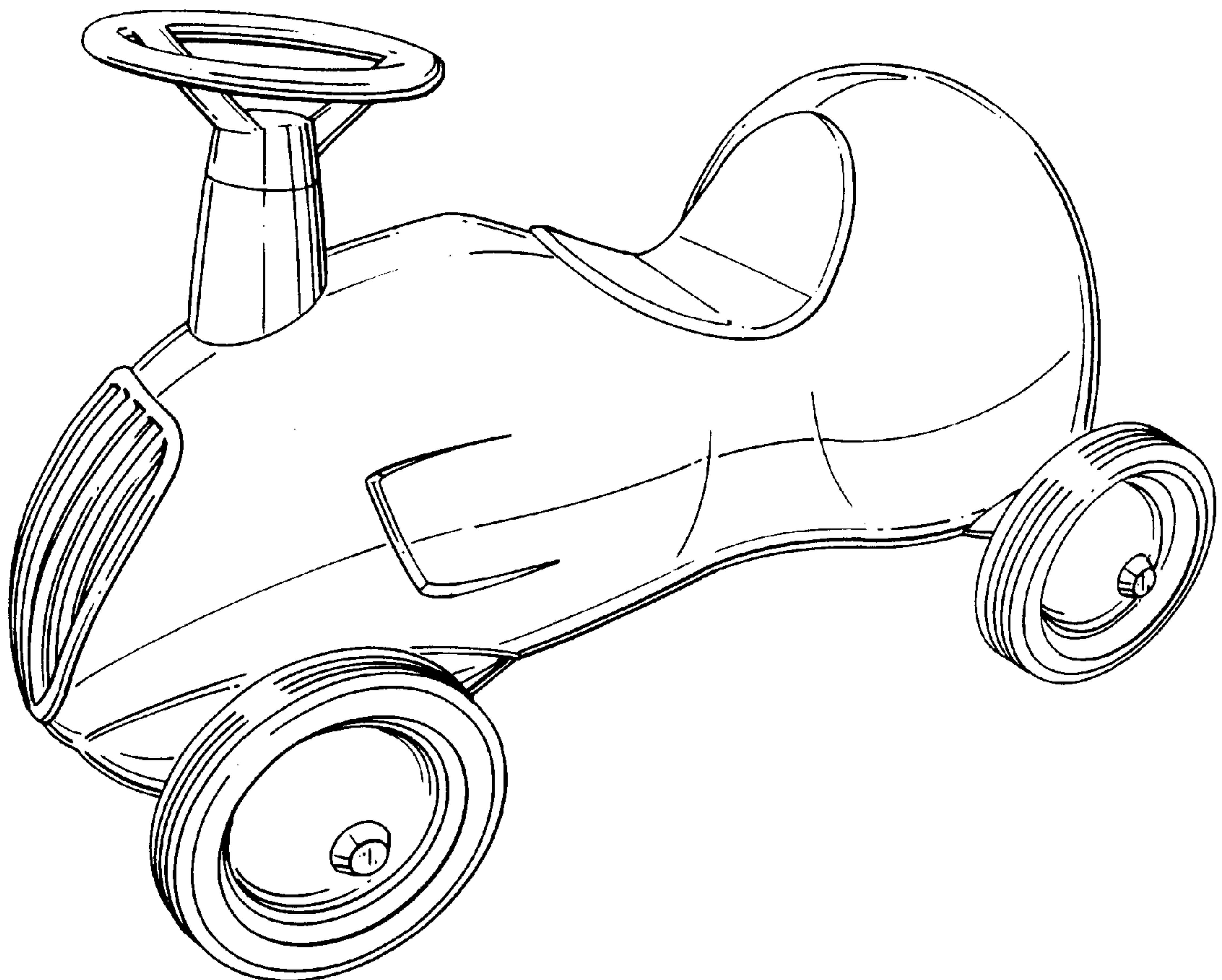

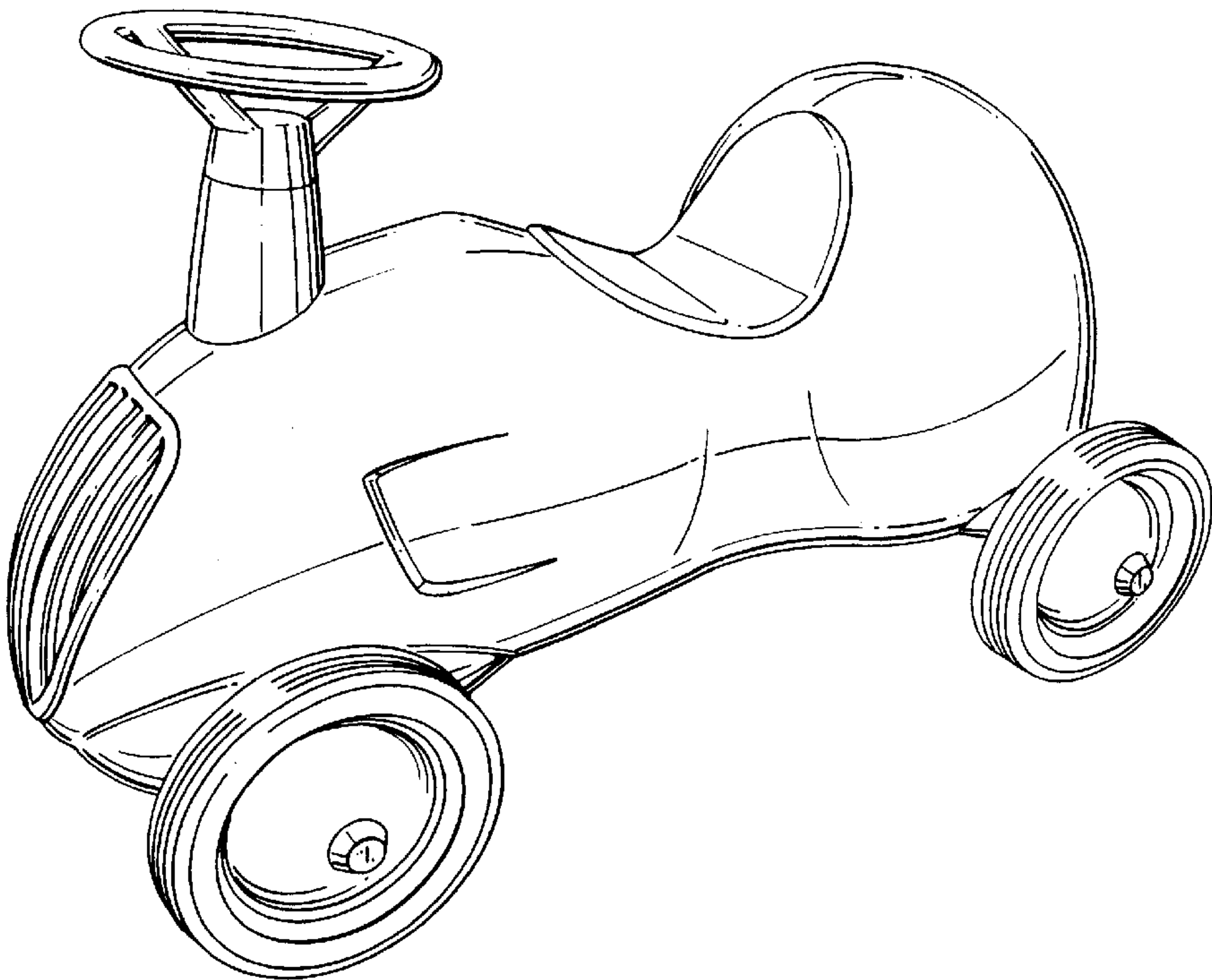

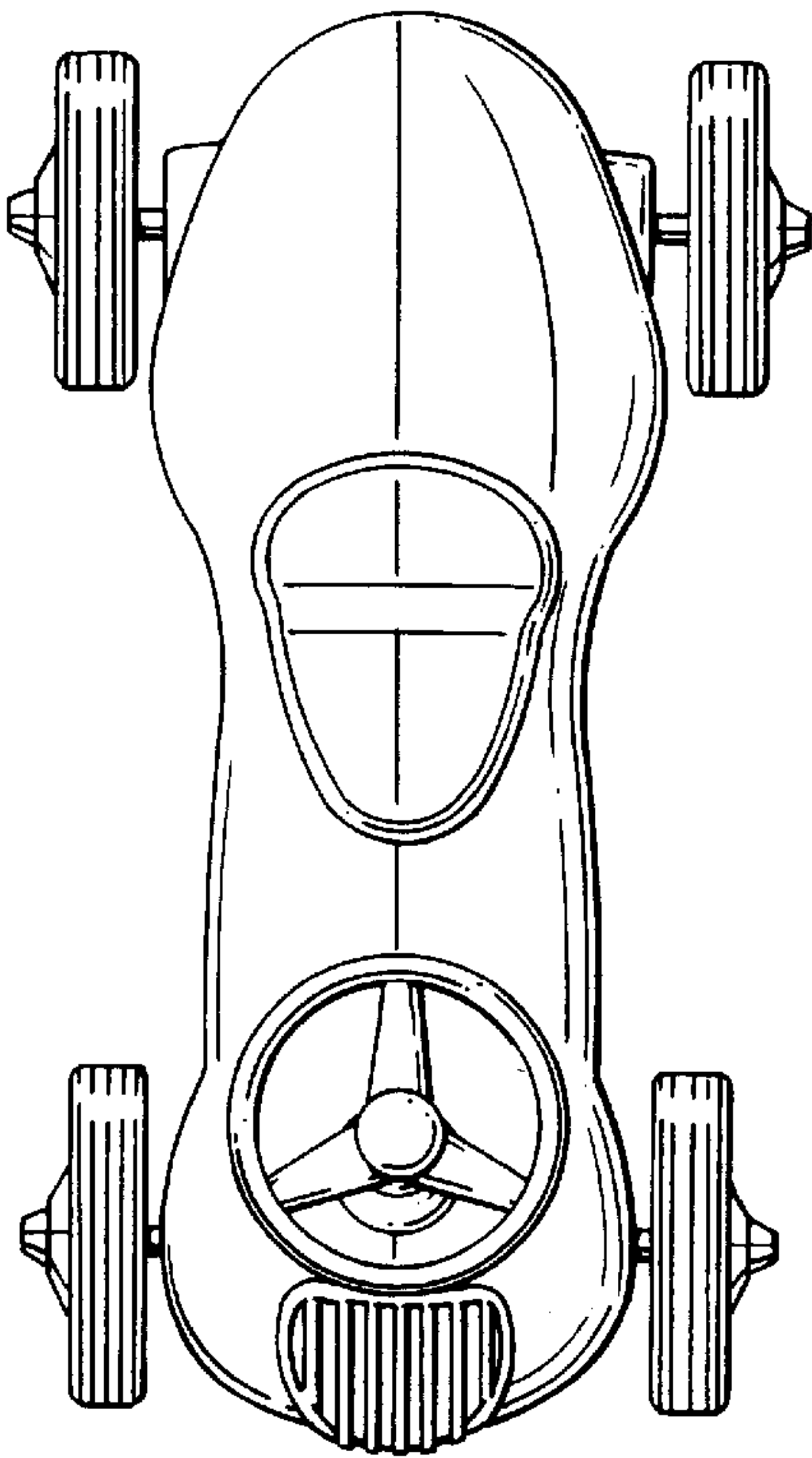

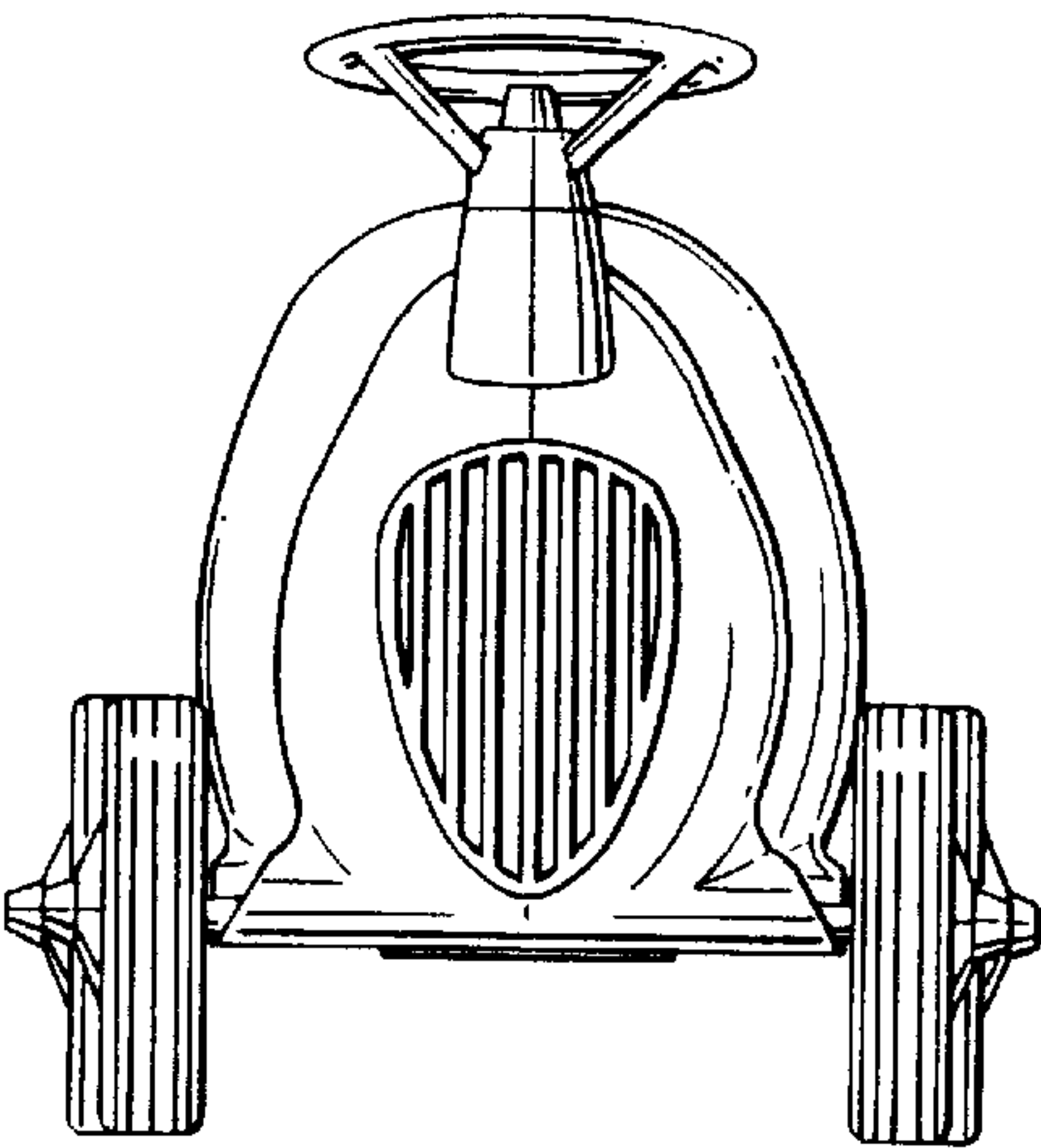

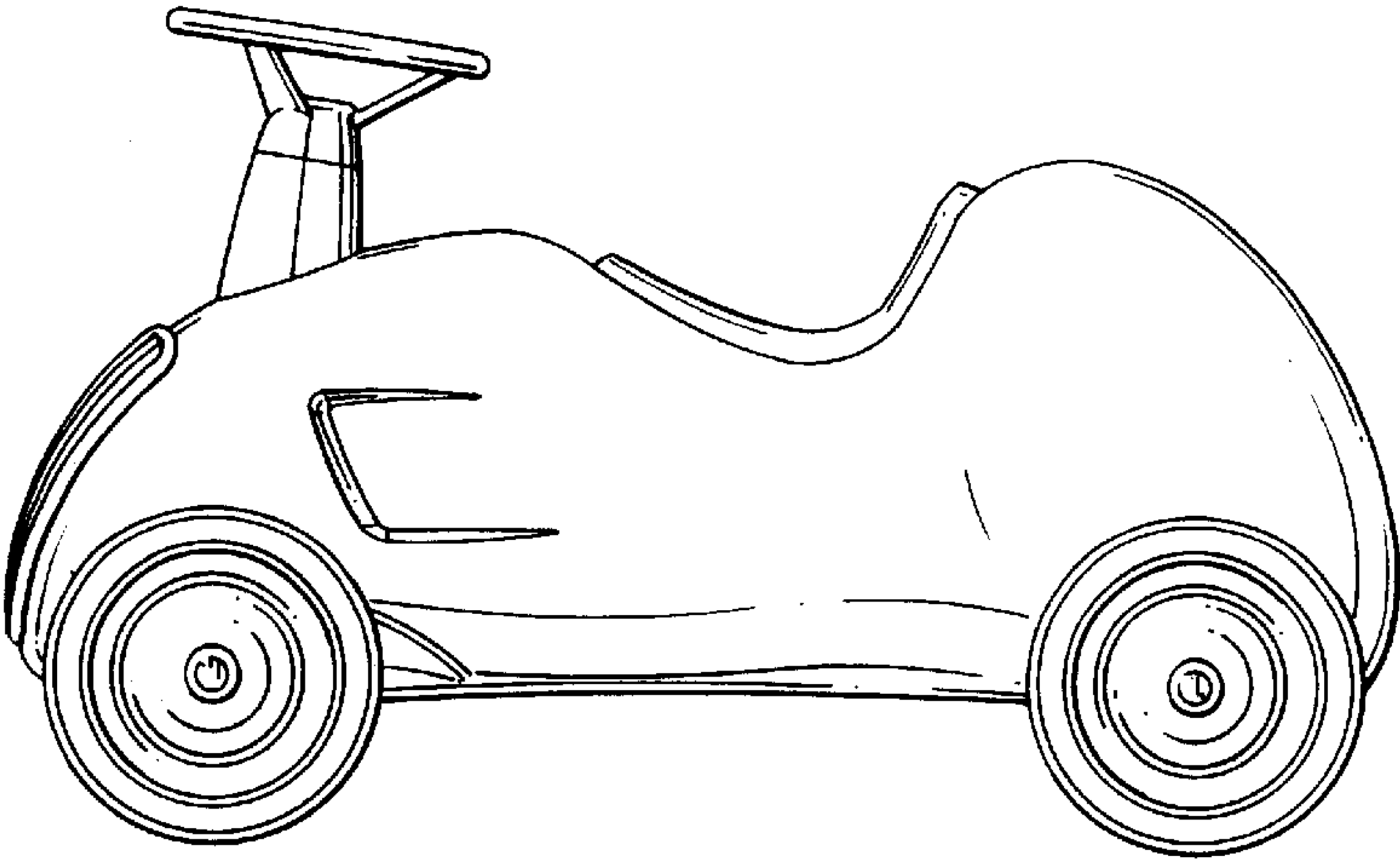

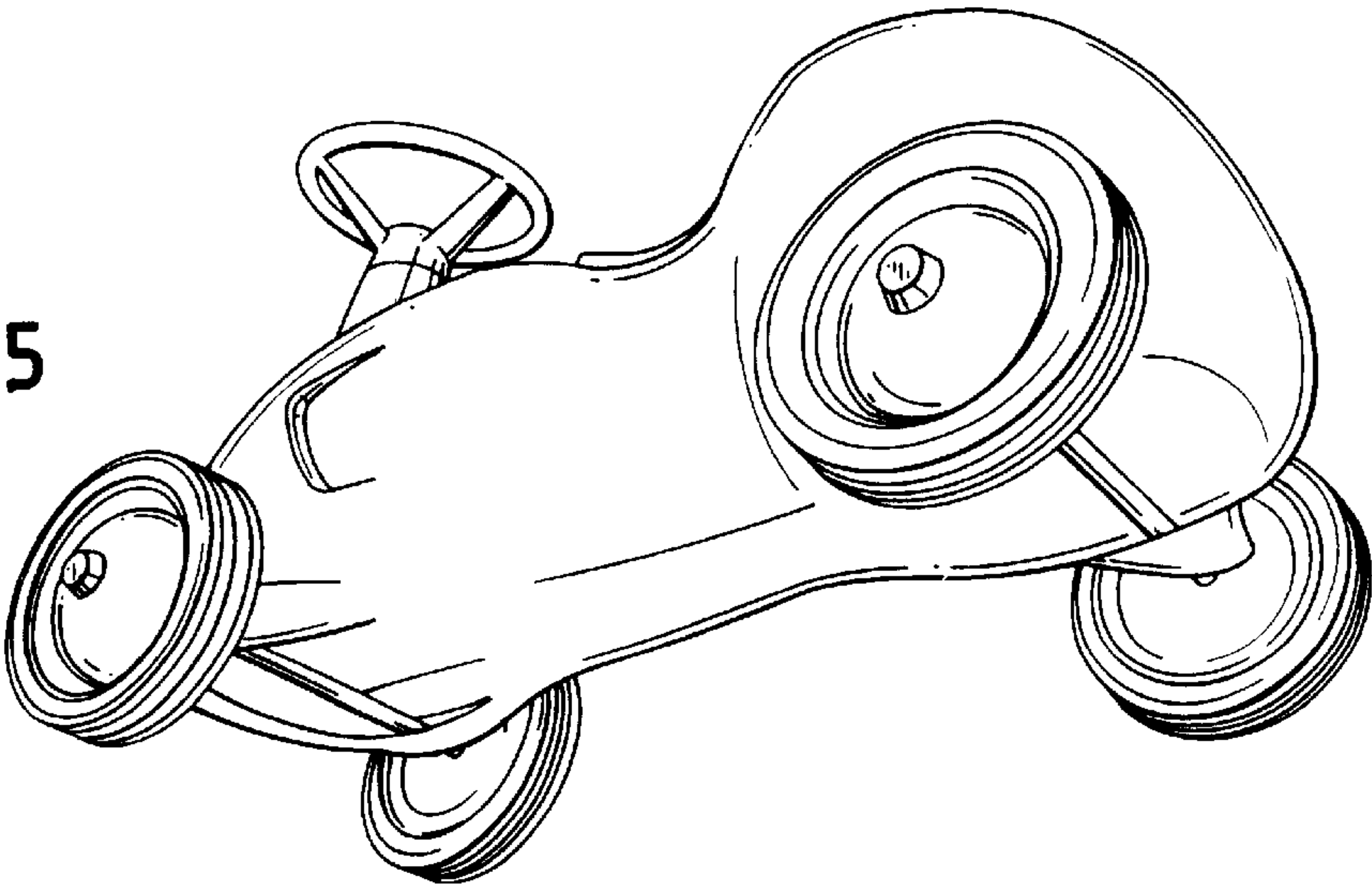

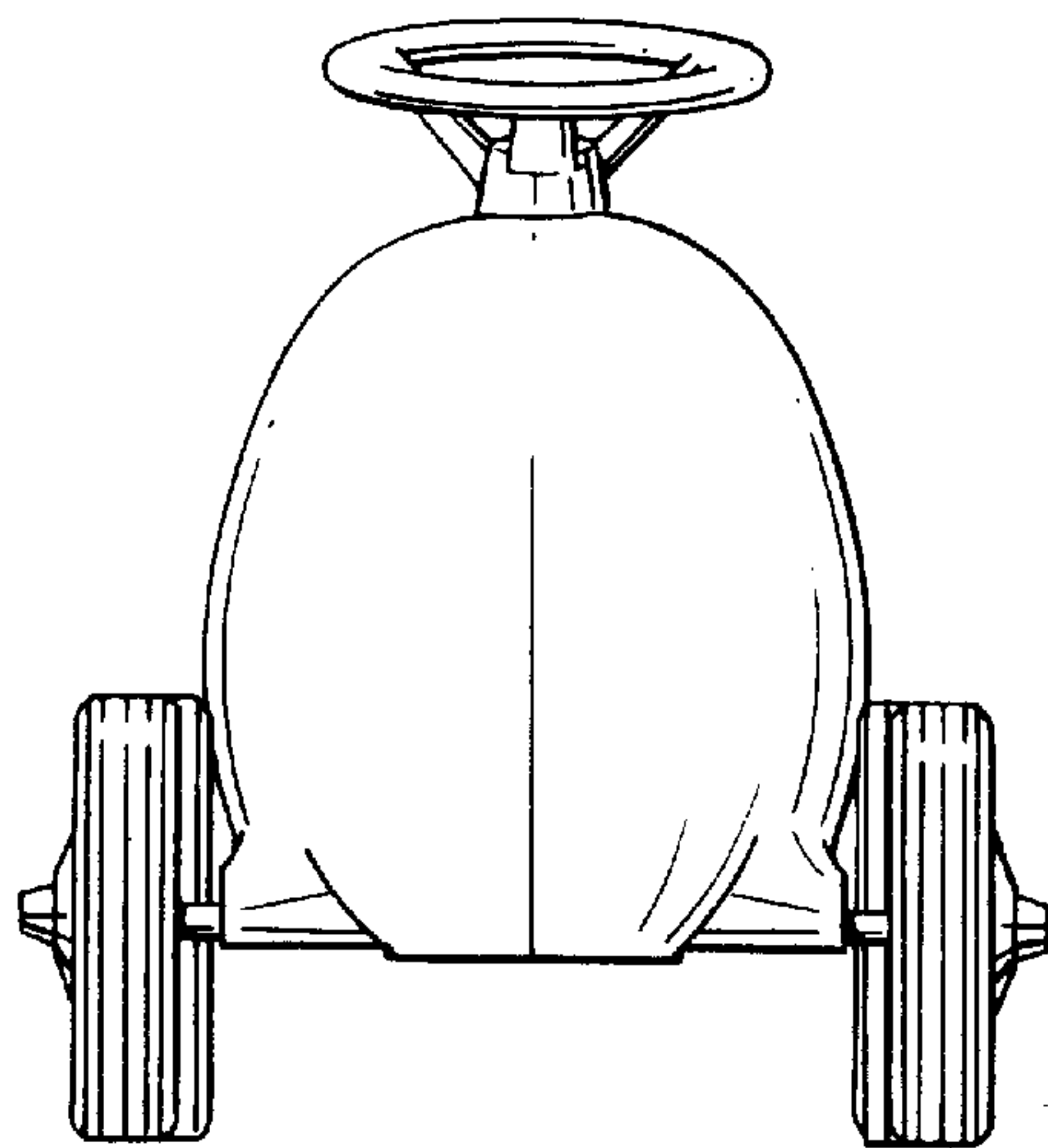
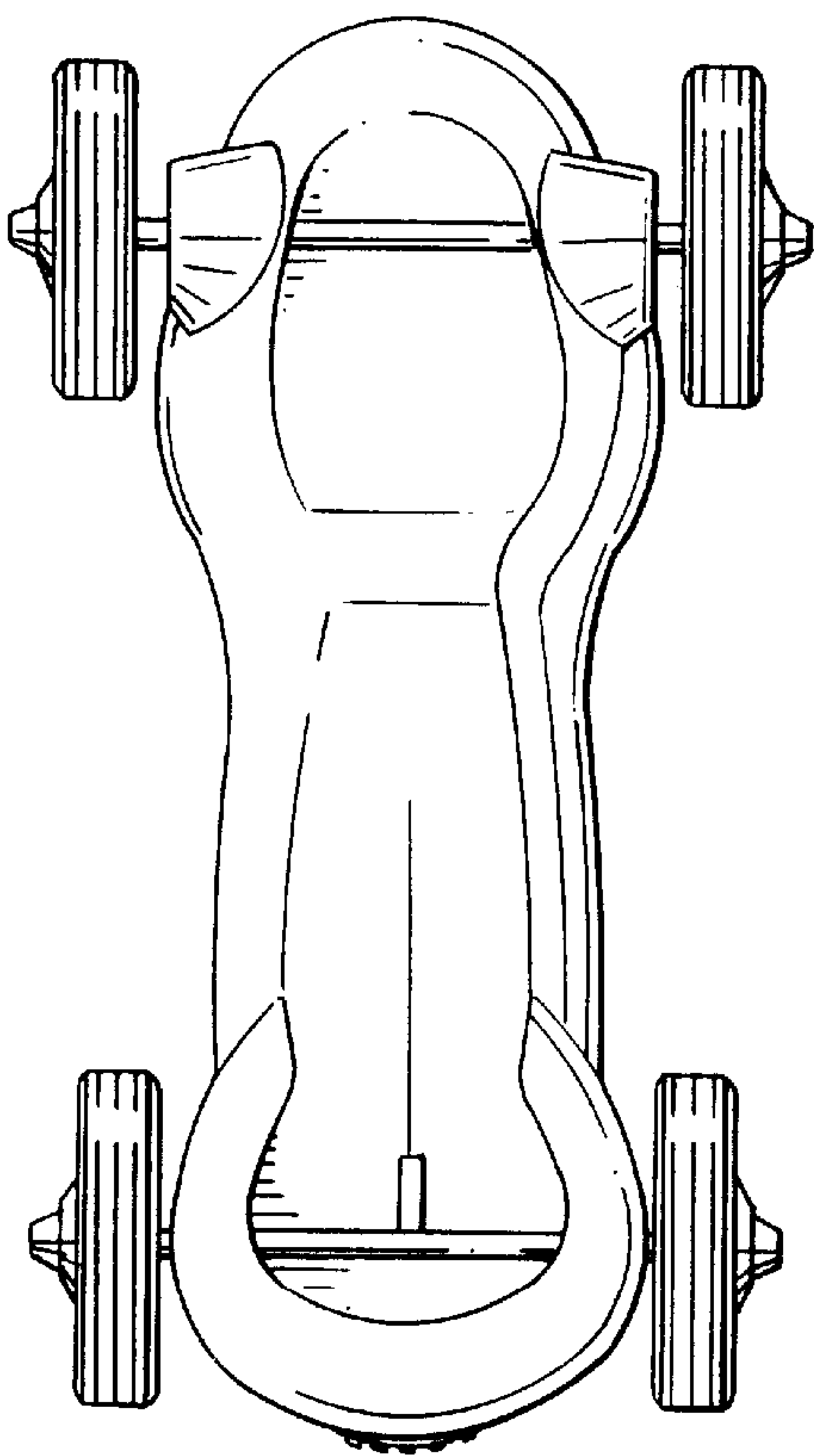
